FIG. 5 is a left side view of the necklace of FIG. 1;

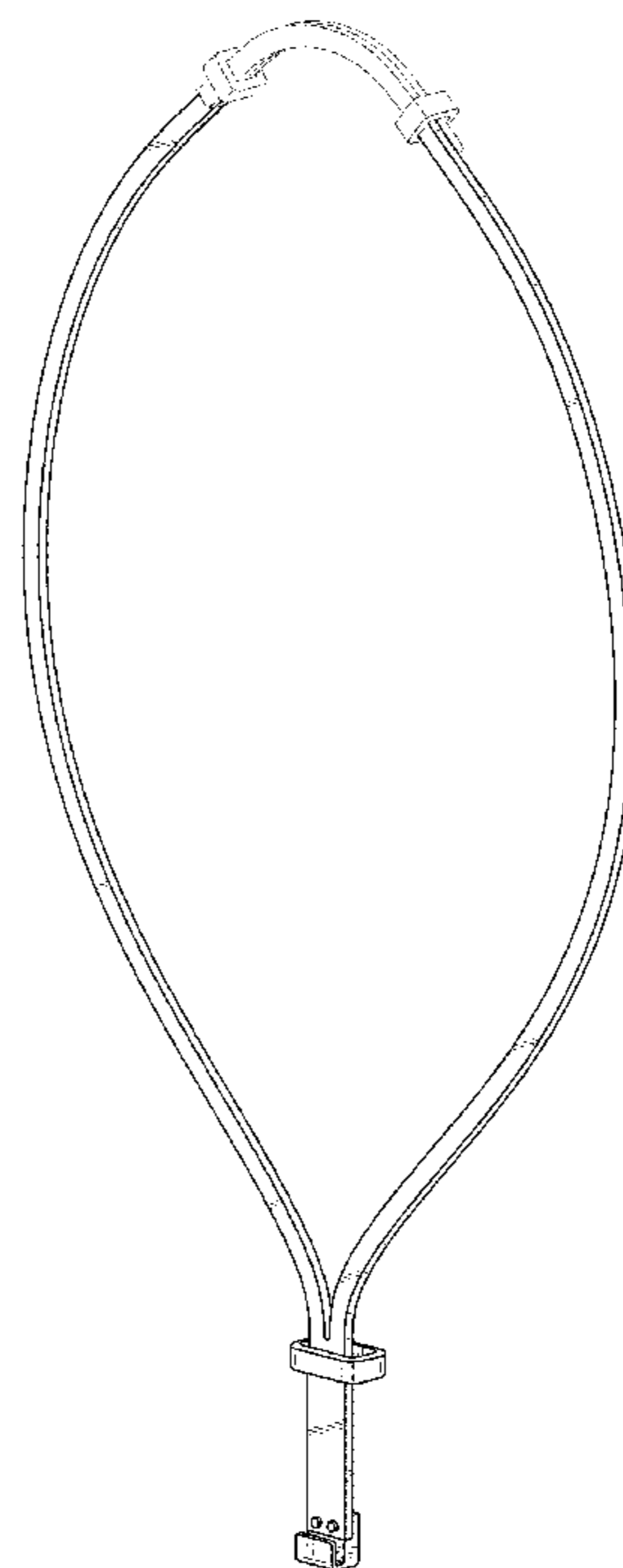
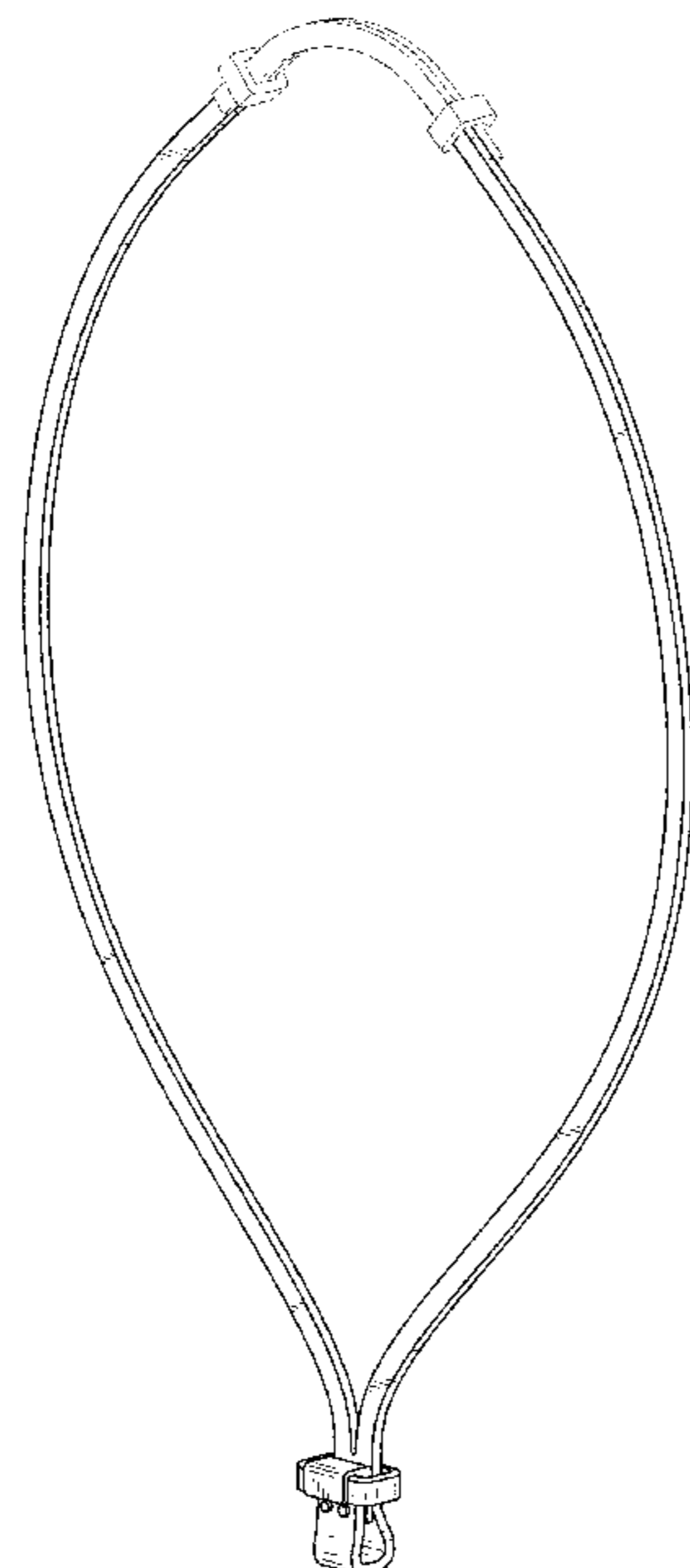
FIG. 6 is a top view of the necklace of FIG. 1;

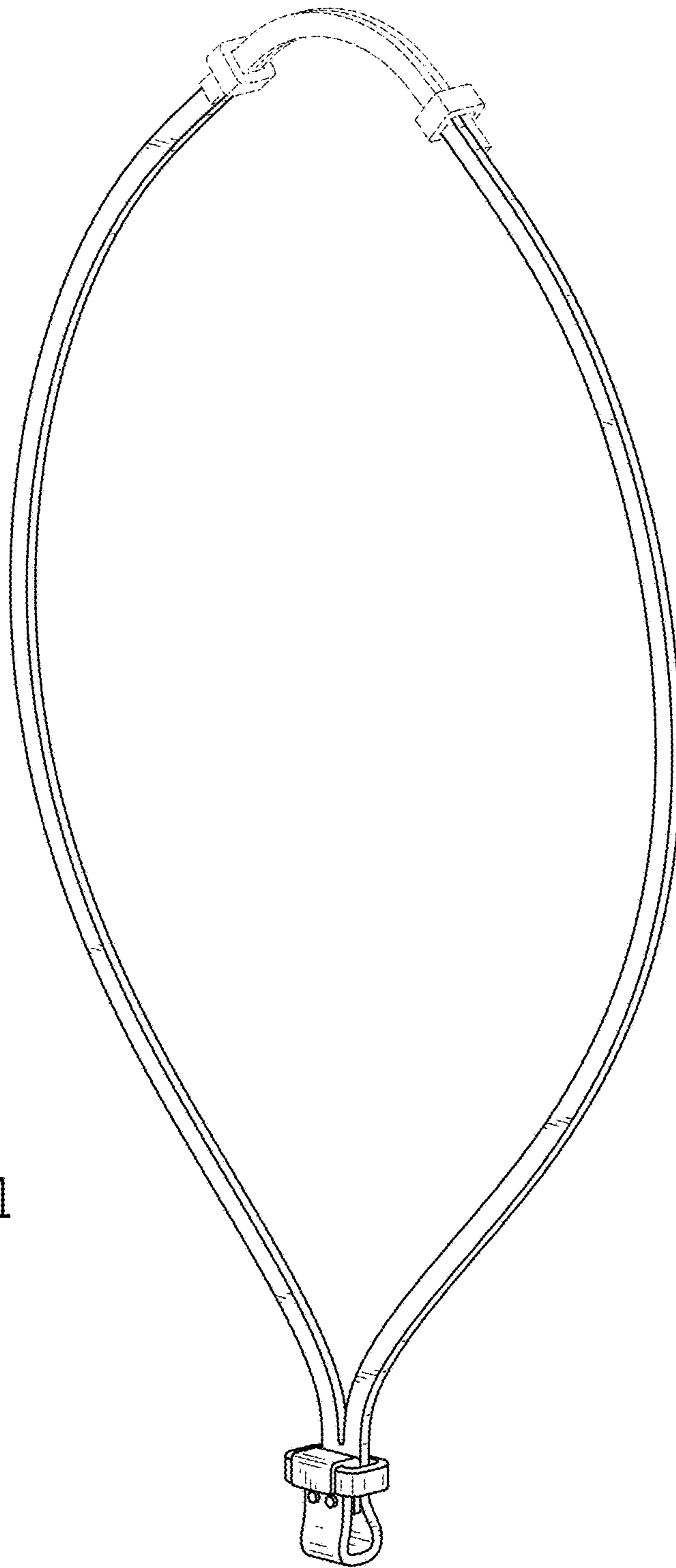

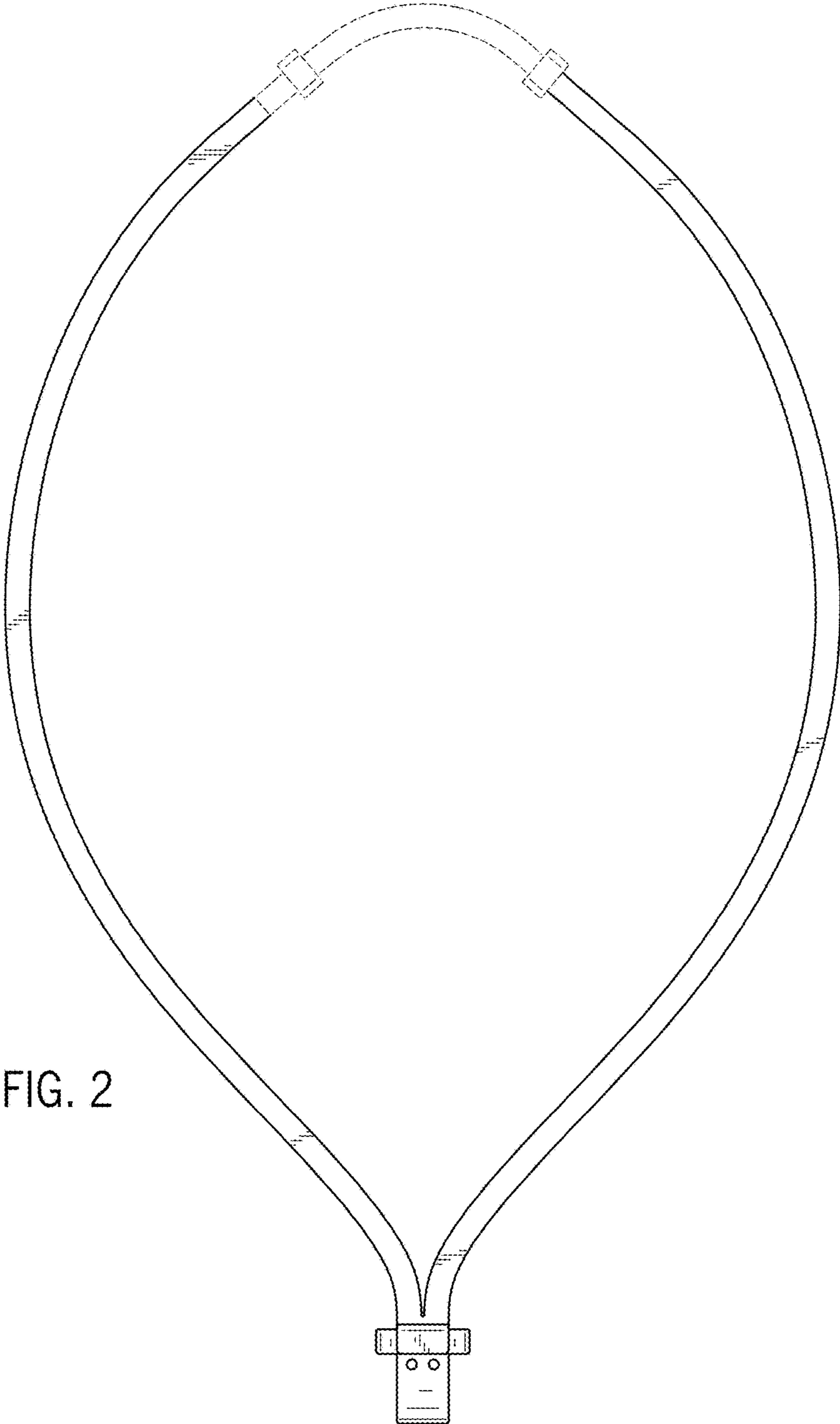

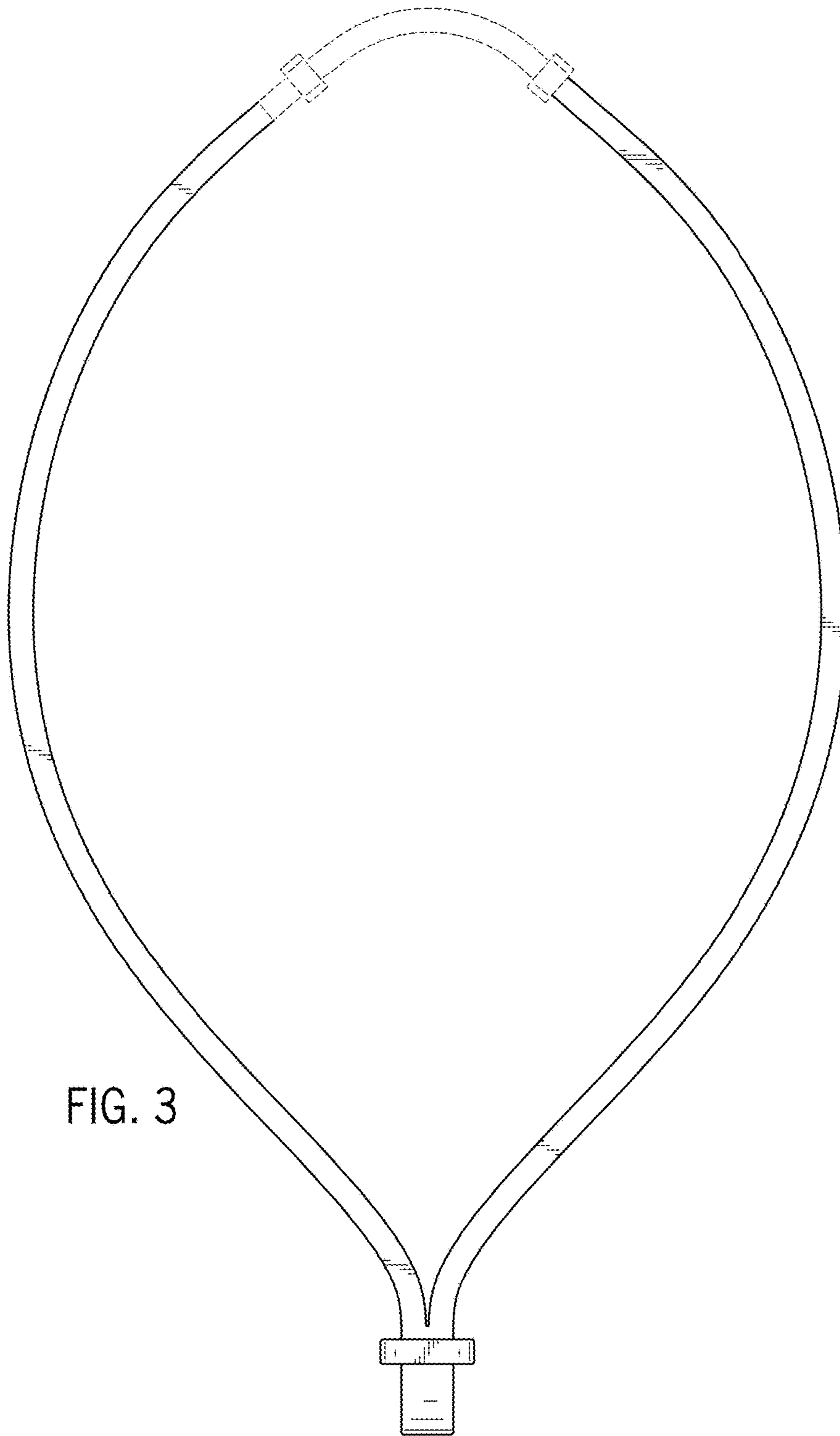

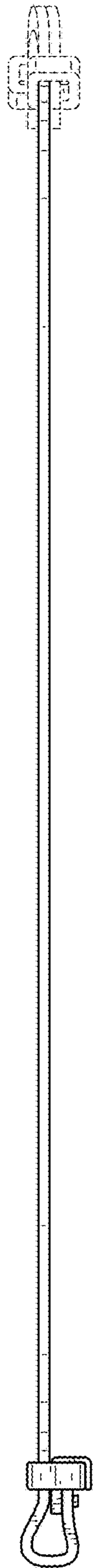

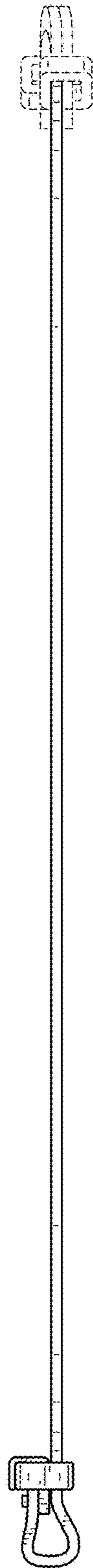

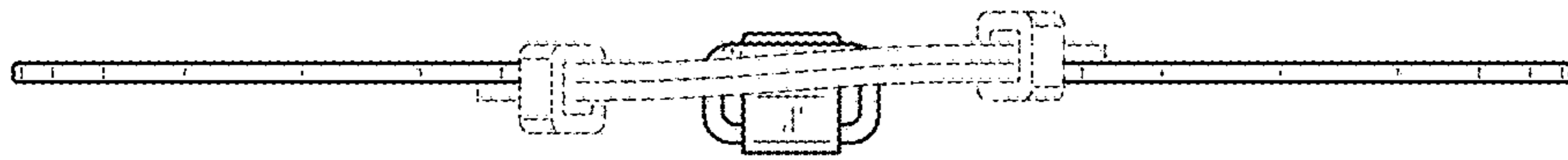

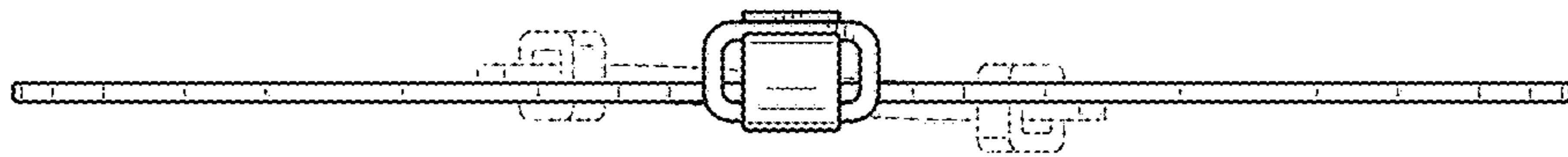

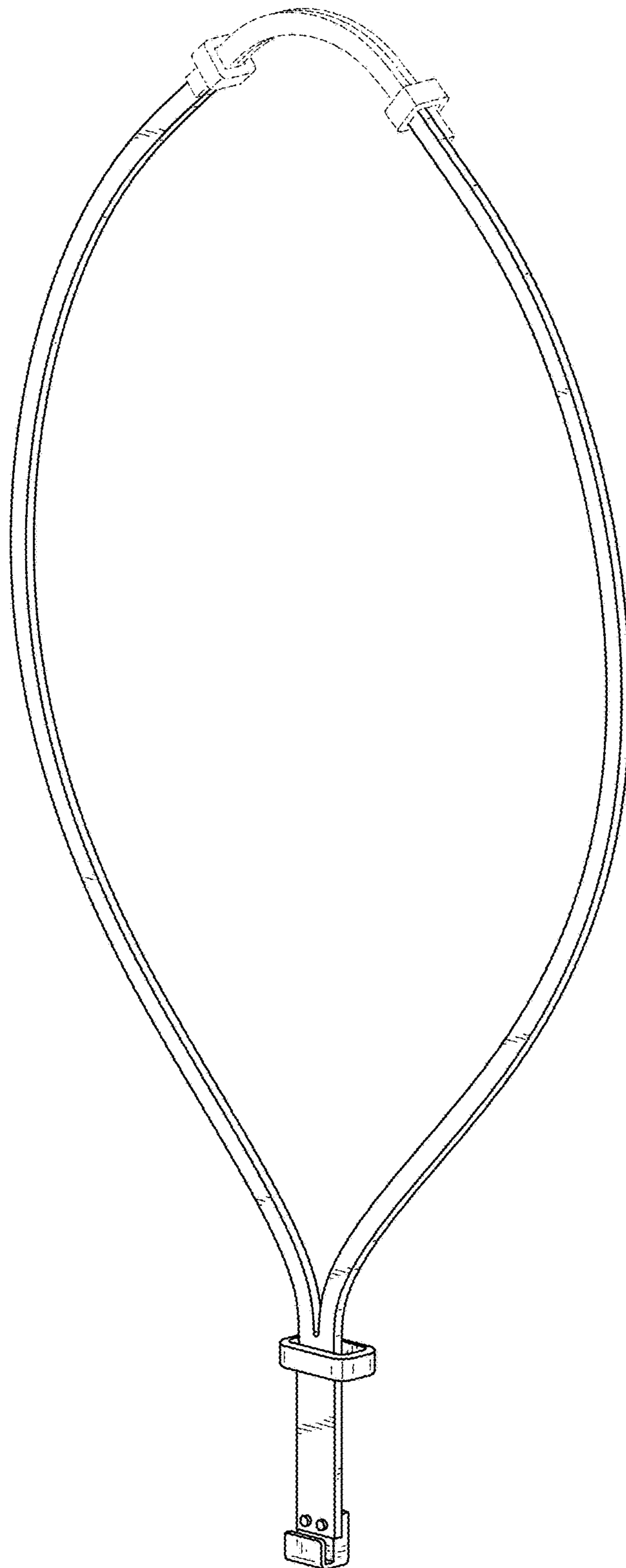
