(57) **CLAIM**

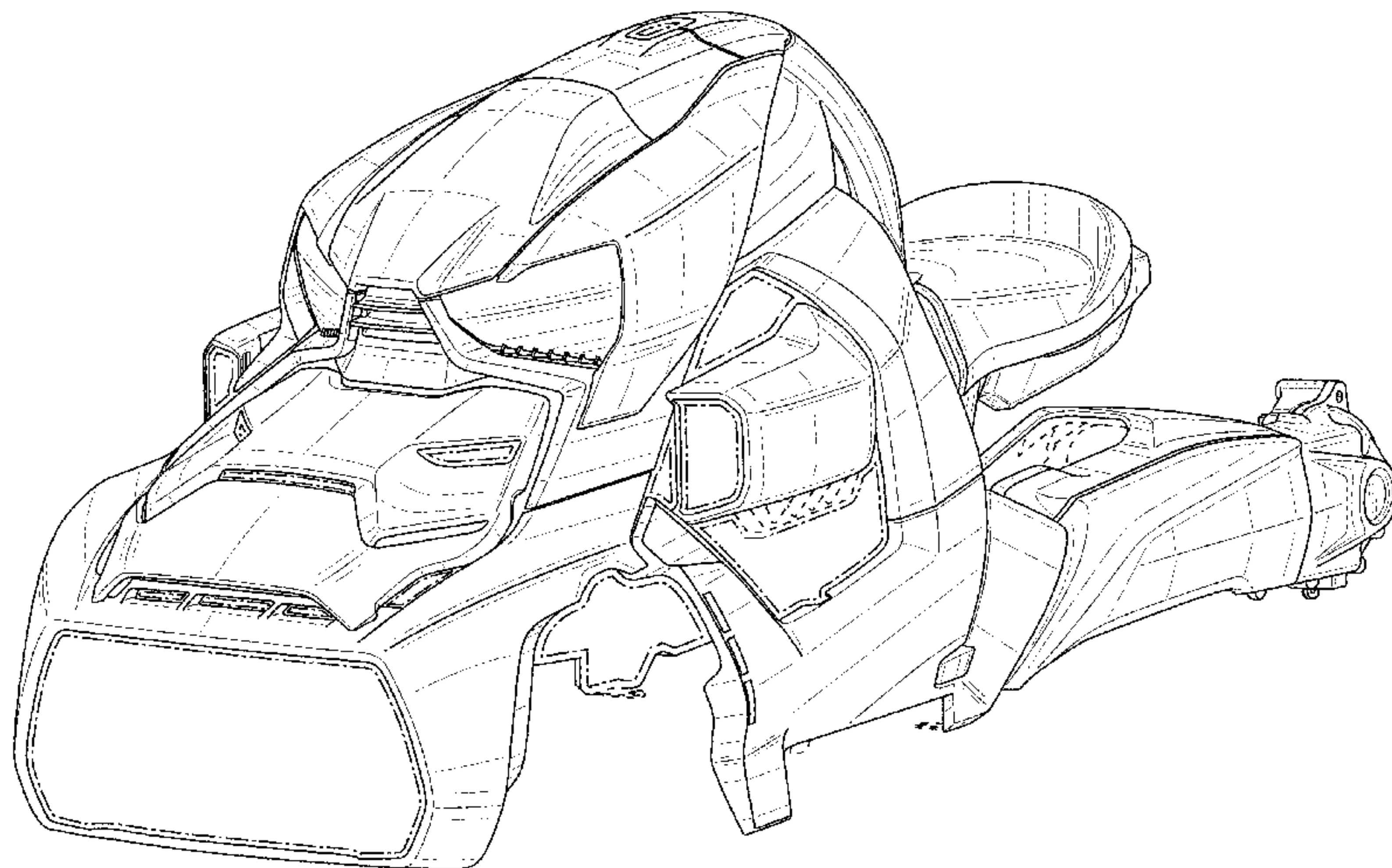
The ornamental design for a three-wheeled vehicle body, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from a front and left side of a three-wheeled vehicle body embodying our design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken line in the drawings illustrate portions of the three-wheeled vehicle body that form no part of the claimed design.

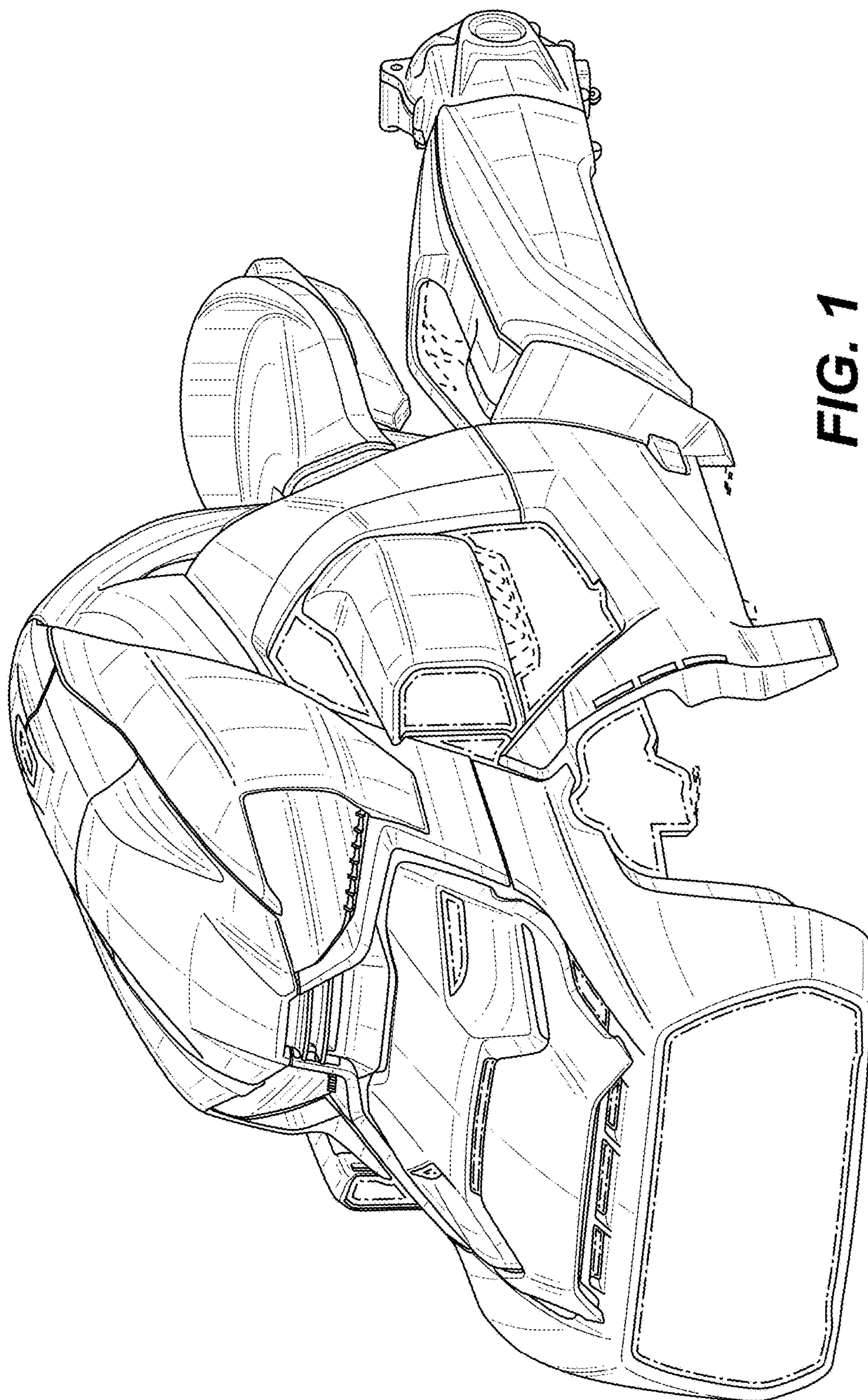

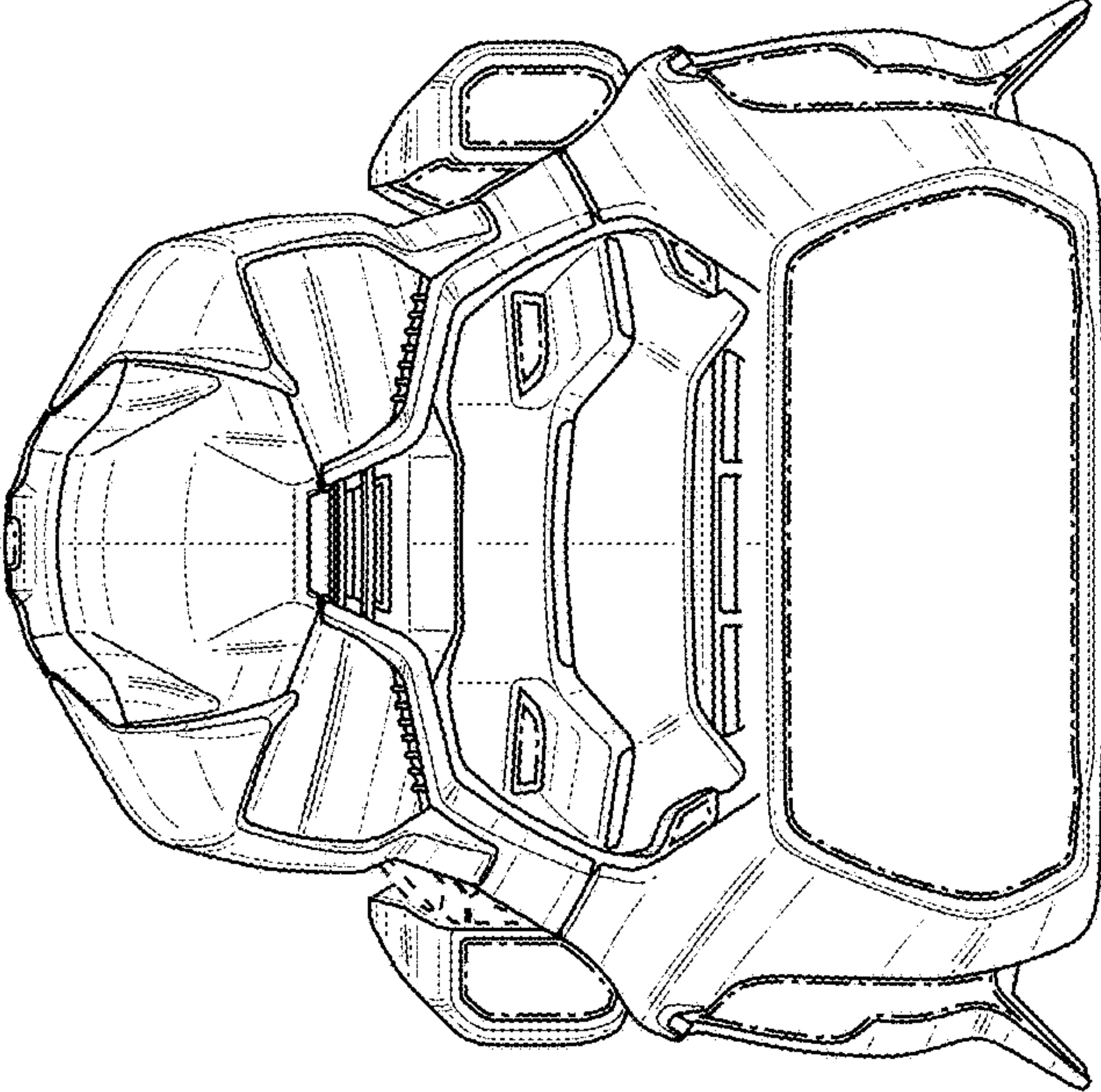

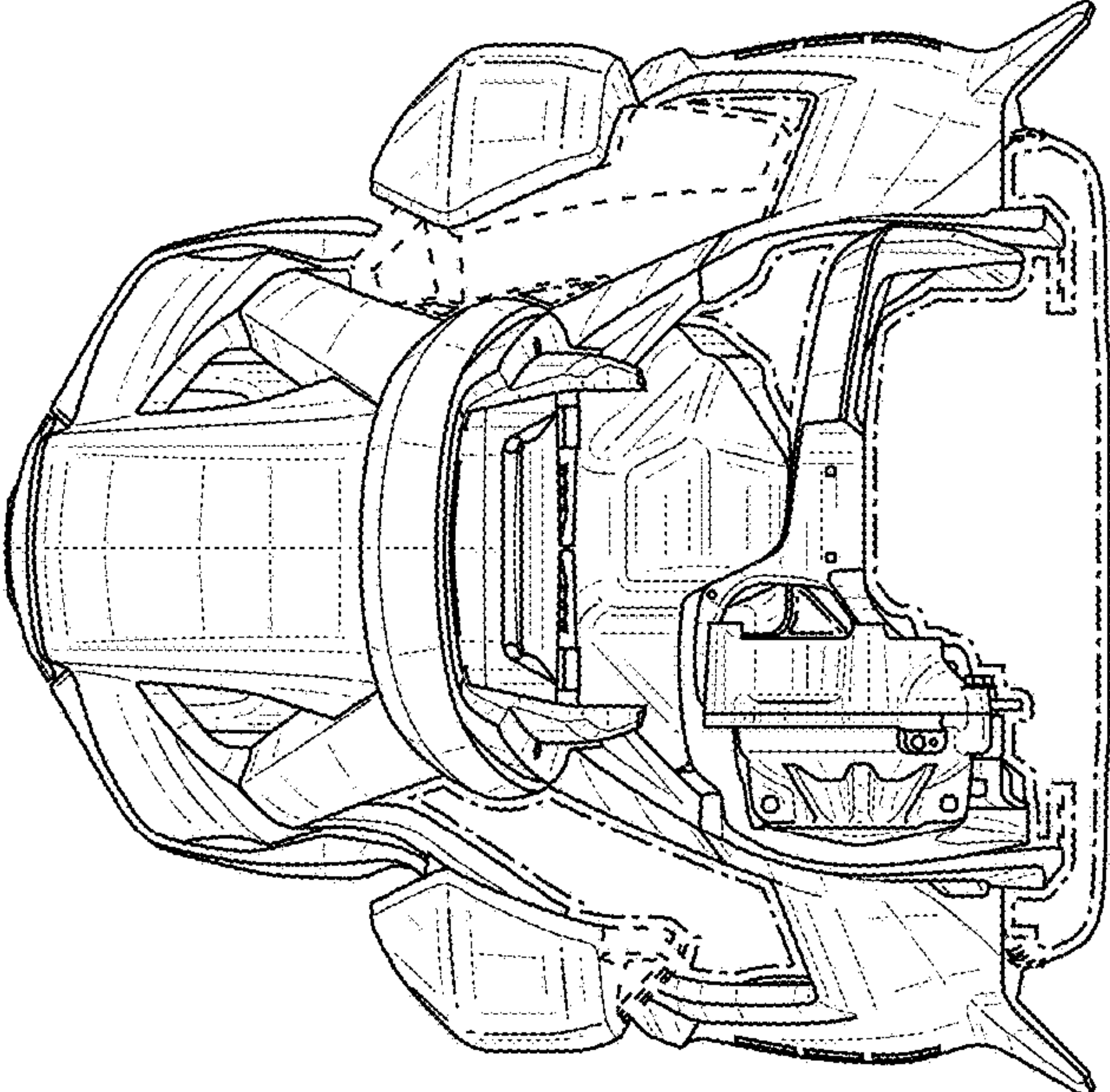

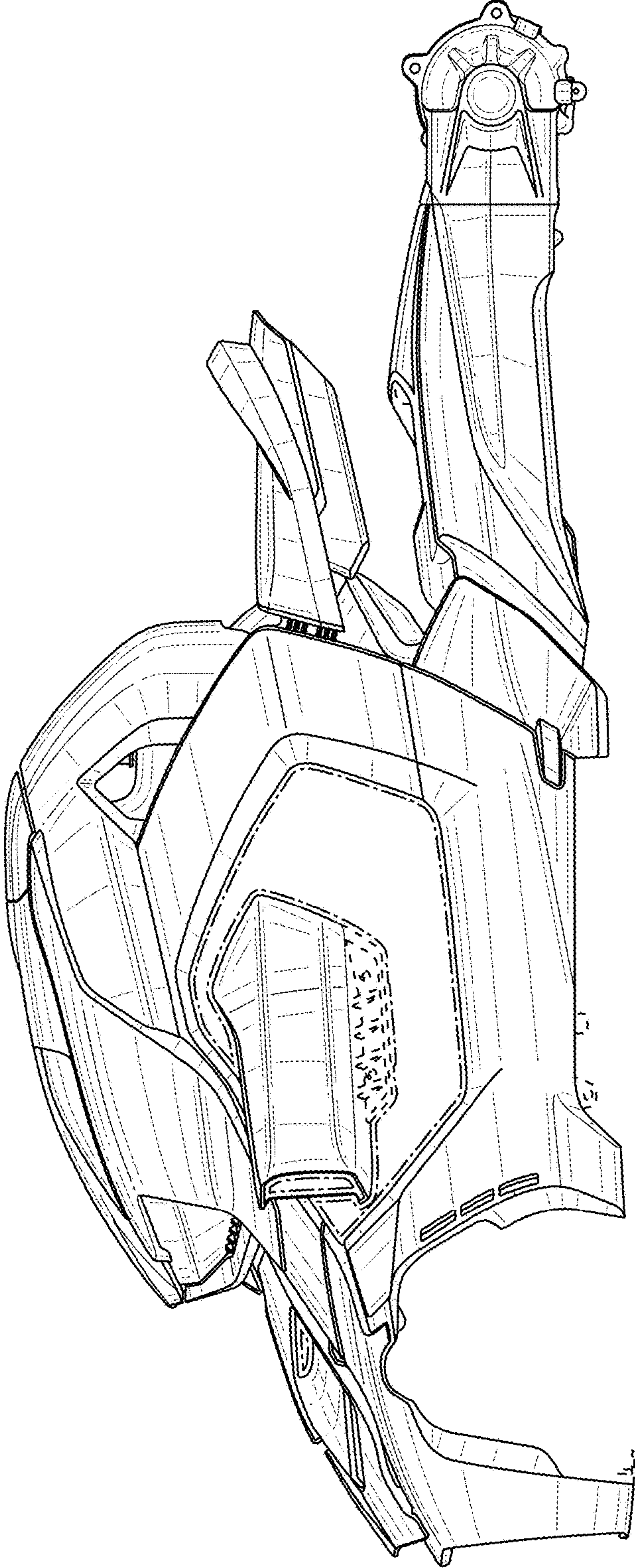

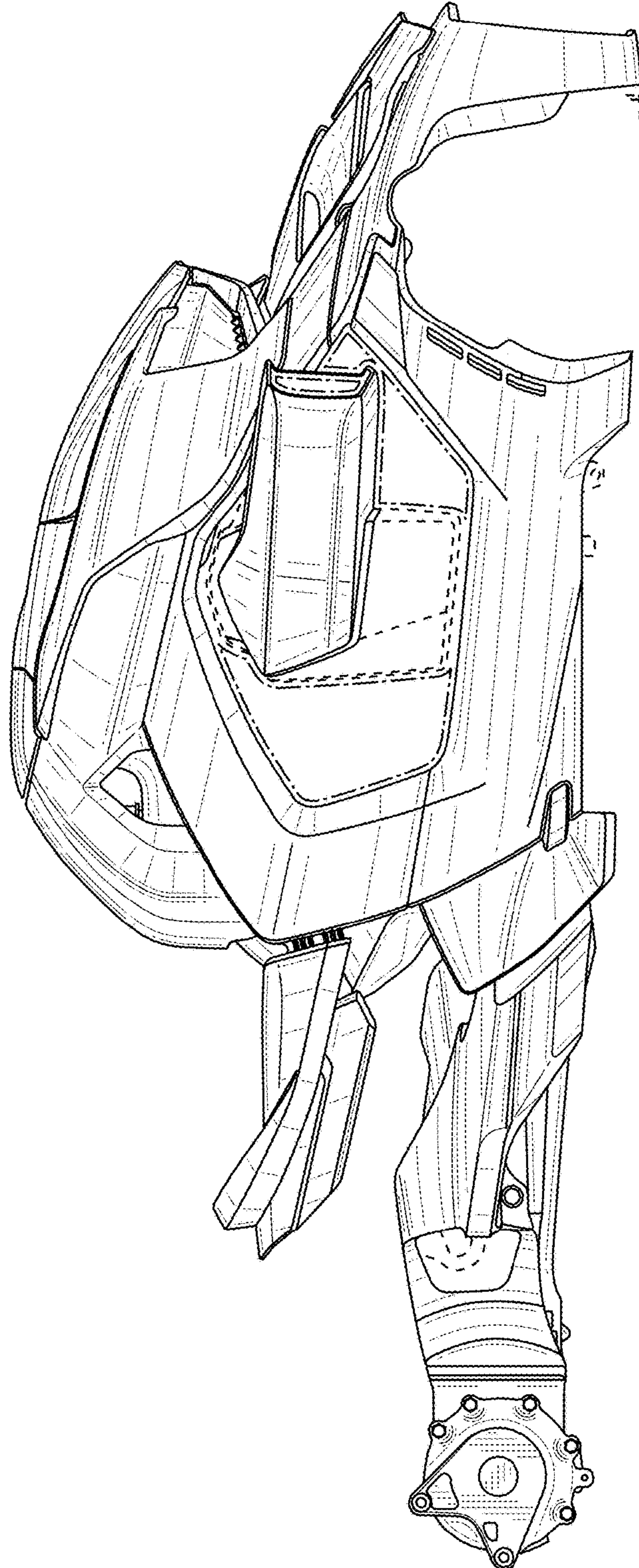

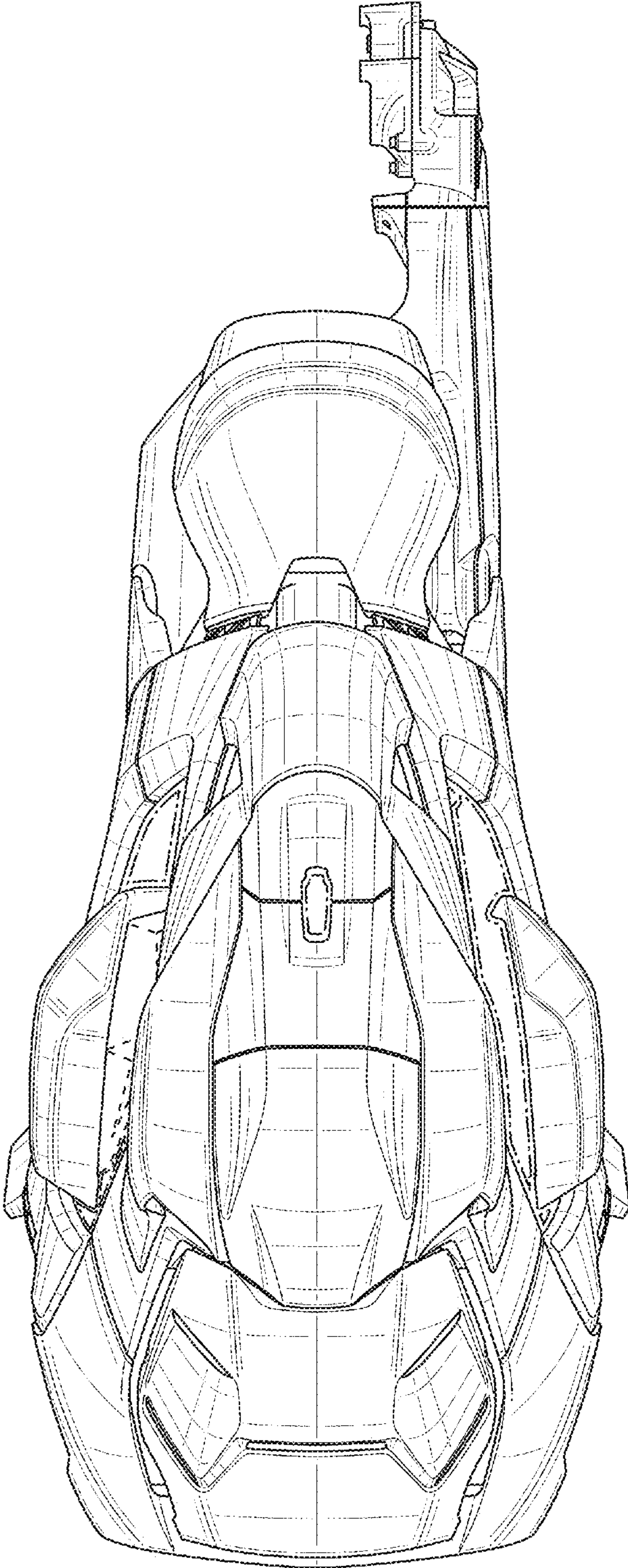

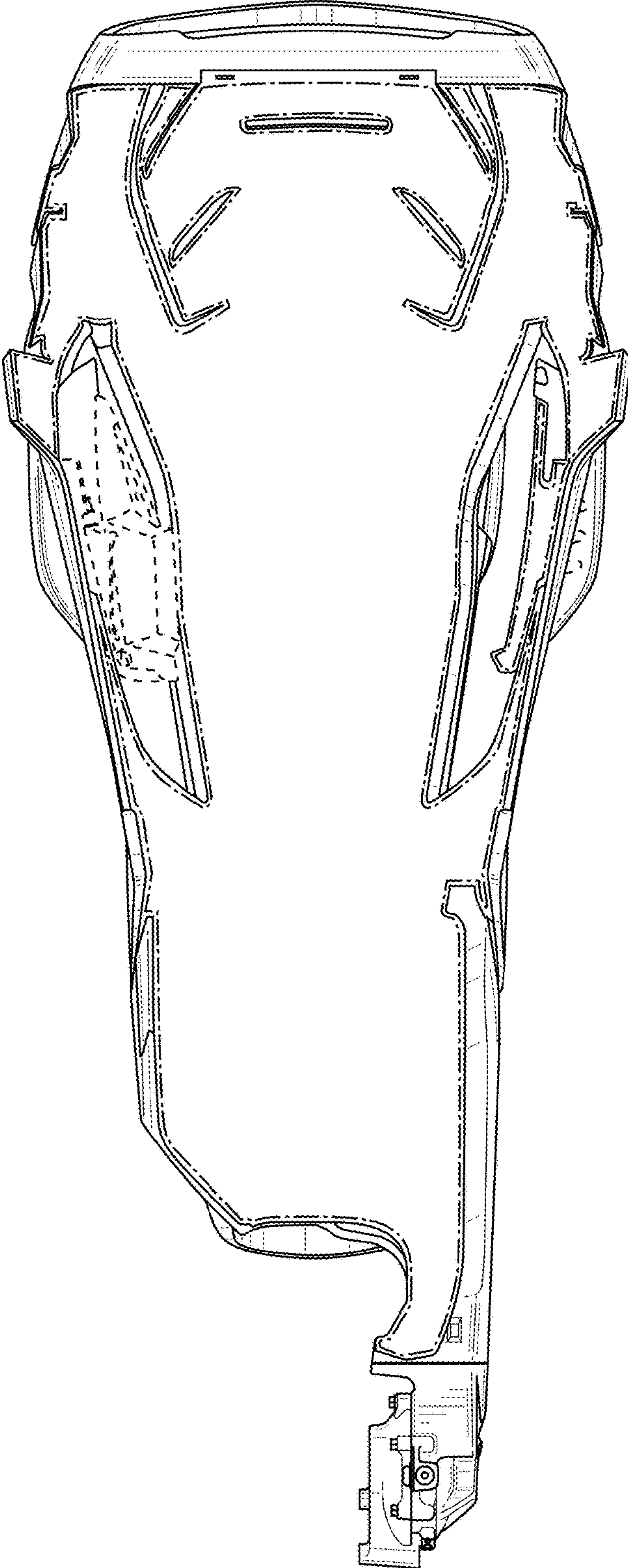
