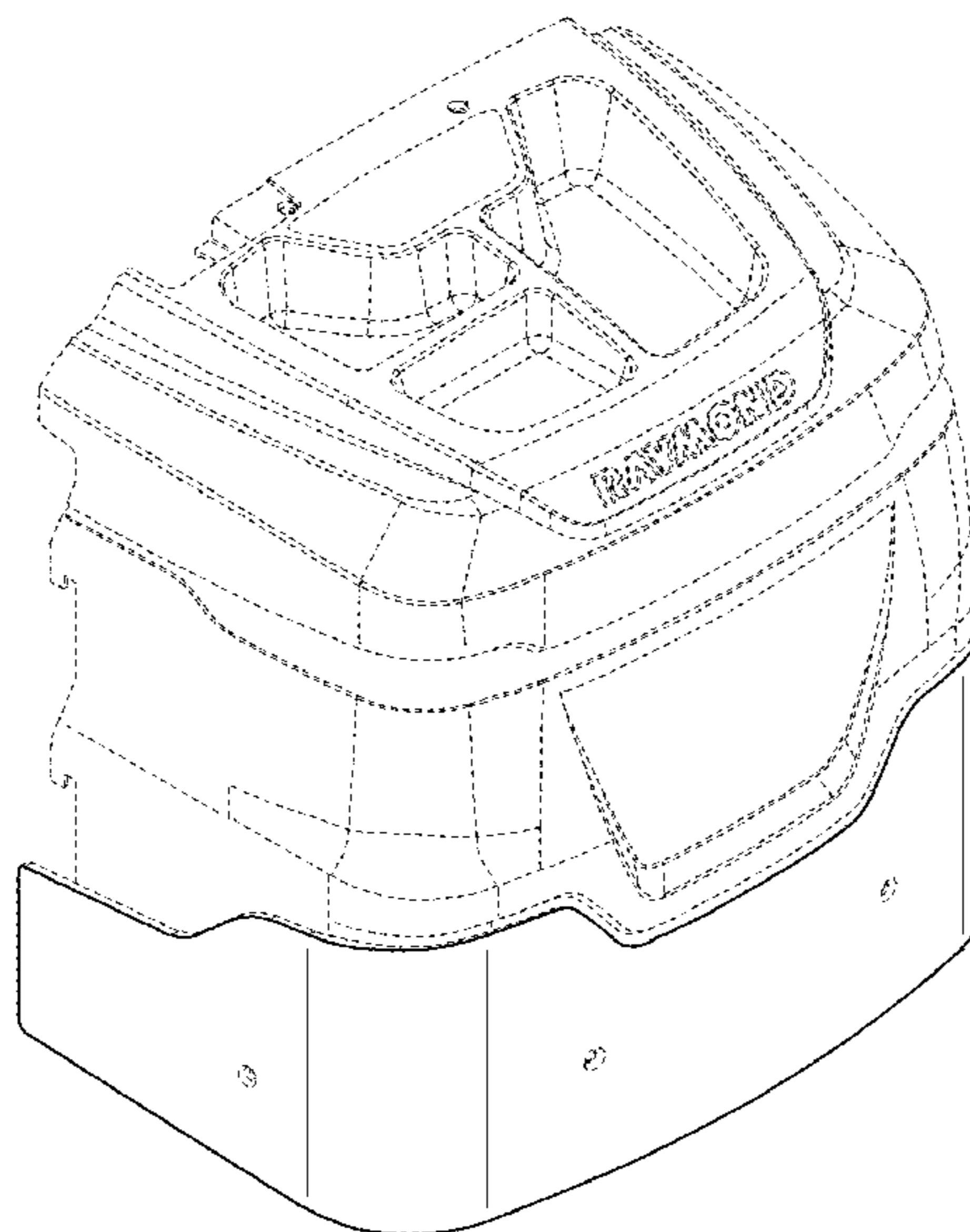
(57) **CLAIM**

The ornamental design for a bumper, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a top, left, and front side of an ornamental design for a bumper;
FIG. 2 is an isometric view of a bottom, right, and rear side of the bumper of FIG. 1;
FIG. 3 is a front elevational view of the bumper of FIG. 1;
FIG. 4 is a rear elevational view of the bumper of FIG. 1;
FIG. 5 is a right side elevational view of the bumper of FIG. 1;
FIG. 6 is a left side elevational view of the bumper of FIG. 1;
FIG. 7 is a top plan view of the bumper of FIG. 1;
FIG. 8 is a bottom plan view of the bumper of FIG. 1;
FIG. 9 is an isometric view of a top, left, and front side of the bumper of FIG. 1 with environmental portions removed for clarity;
FIG. 10 is an isometric view of a bottom, right, and front side of the bumper of FIG. 9;
FIG. 11 is a front elevational view of the bumper of FIG. 9;
FIG. 12 is a rear elevational view of the bumper of FIG. 9;
FIG. 13 is a right side elevational view of the bumper of FIG. 9;
FIG. 14 is a left side elevational view of the bumper of FIG. 9;
FIG. 15 is a top plan view of the bumper of FIG. 9; and,
FIG. 16 is a bottom plan view of the bumper of FIG. 9.

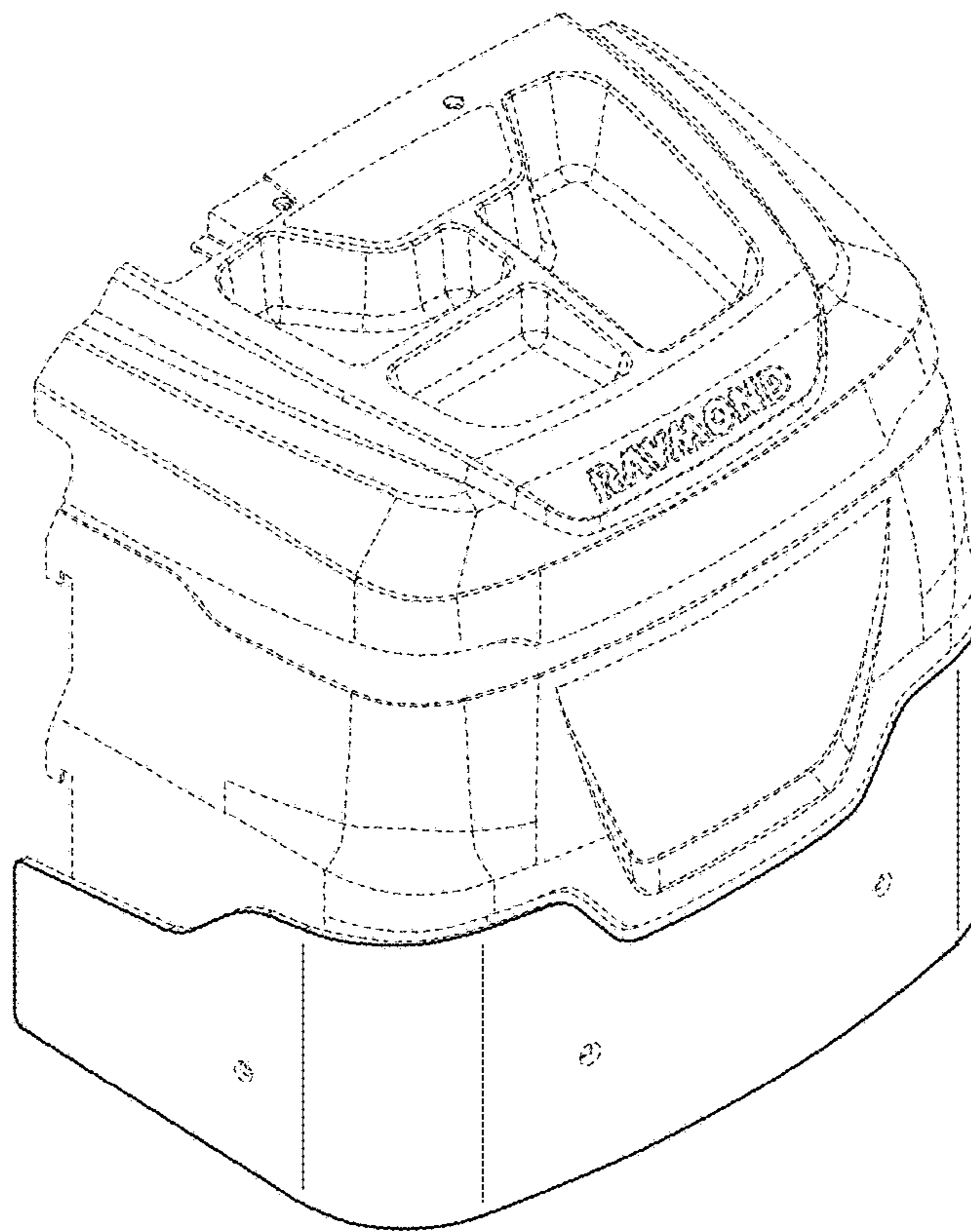

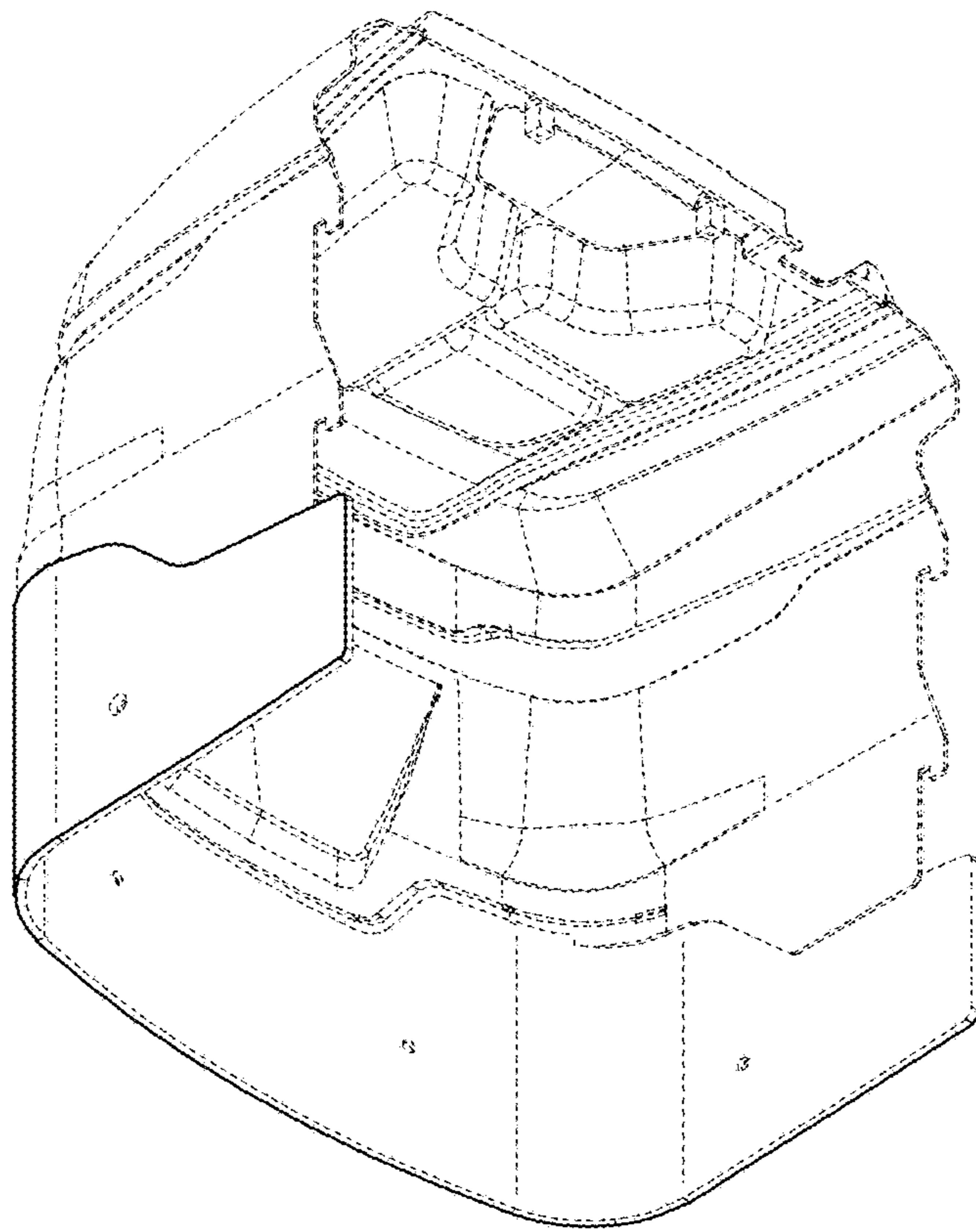

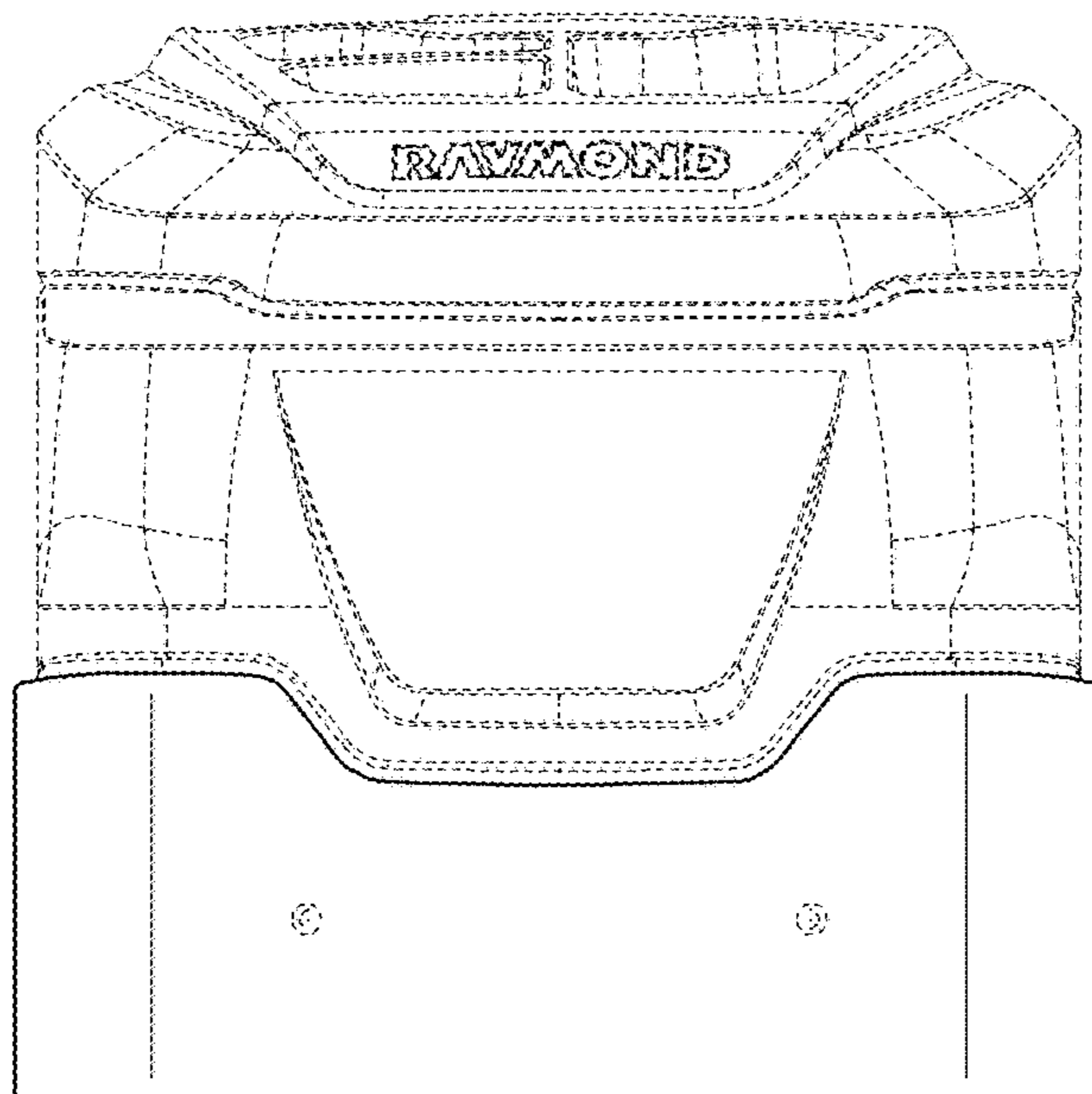

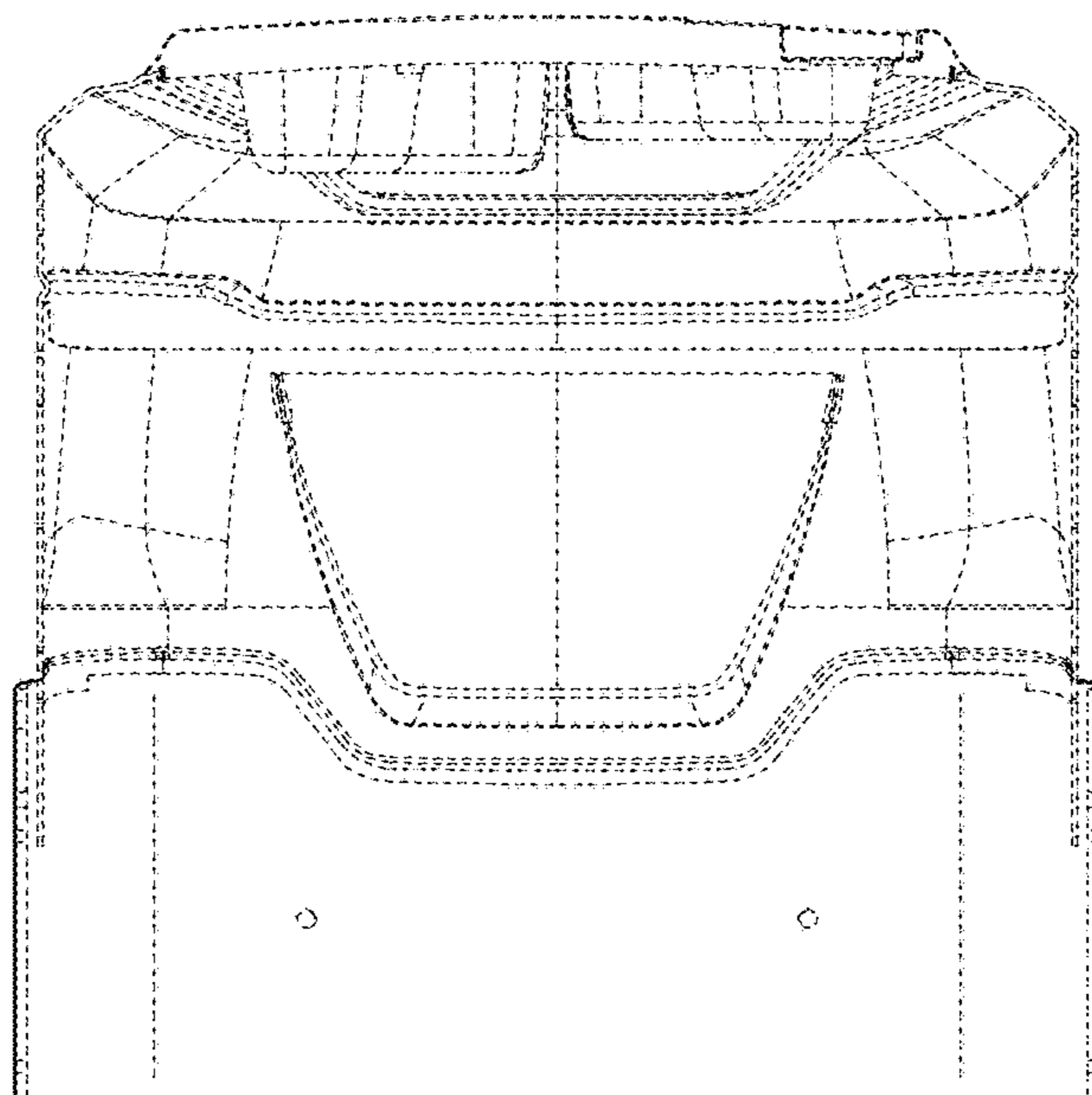

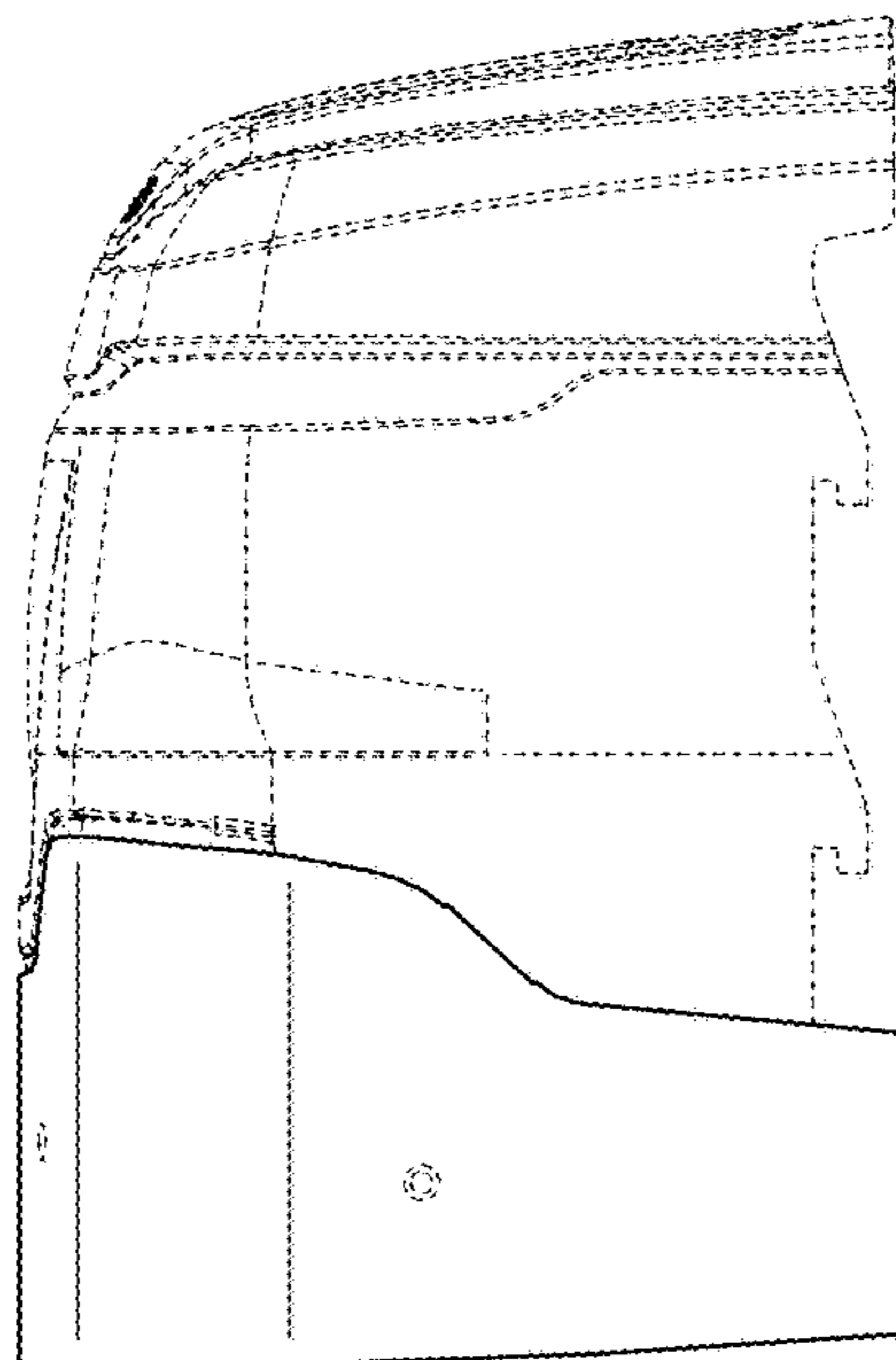

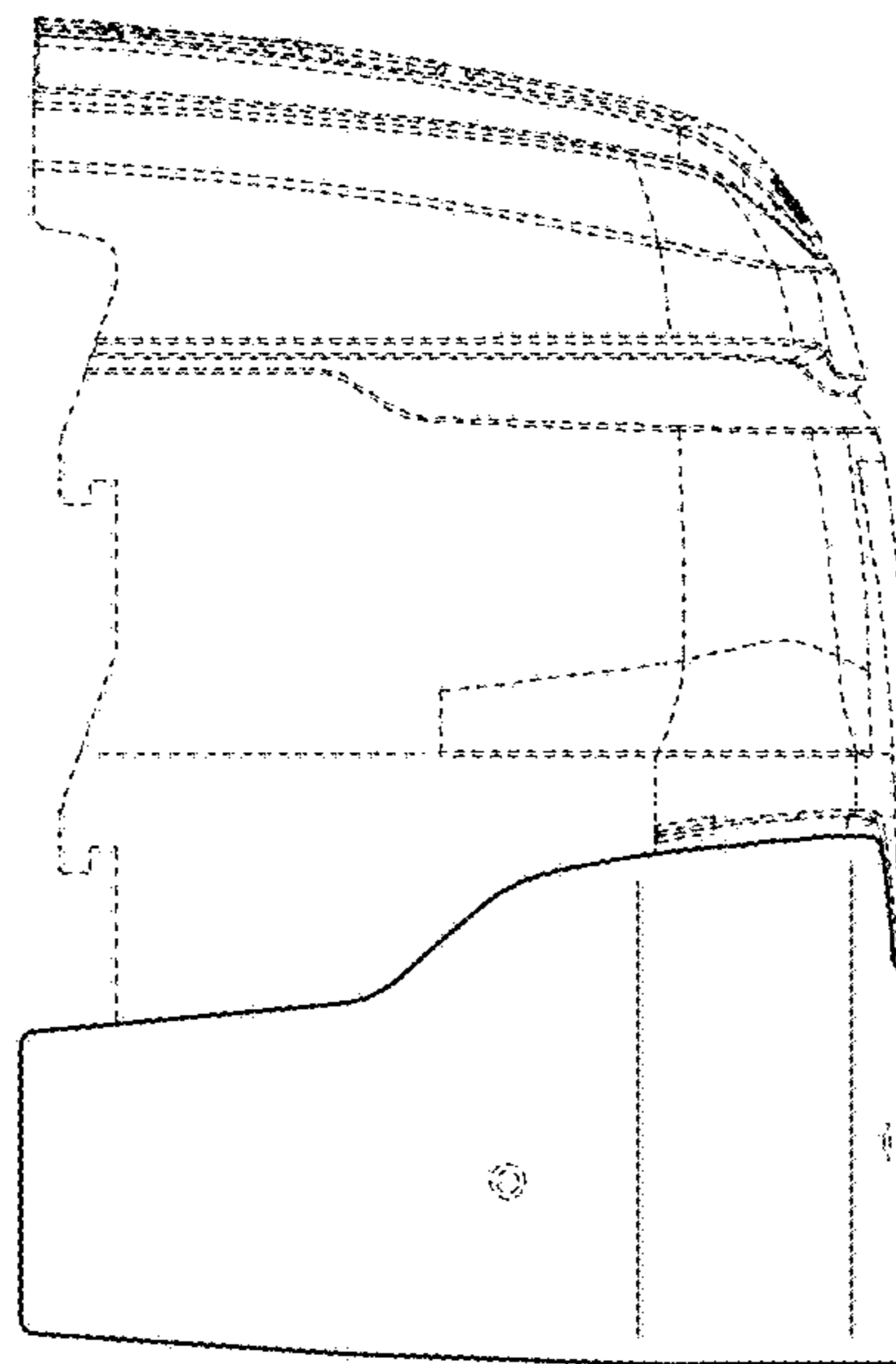

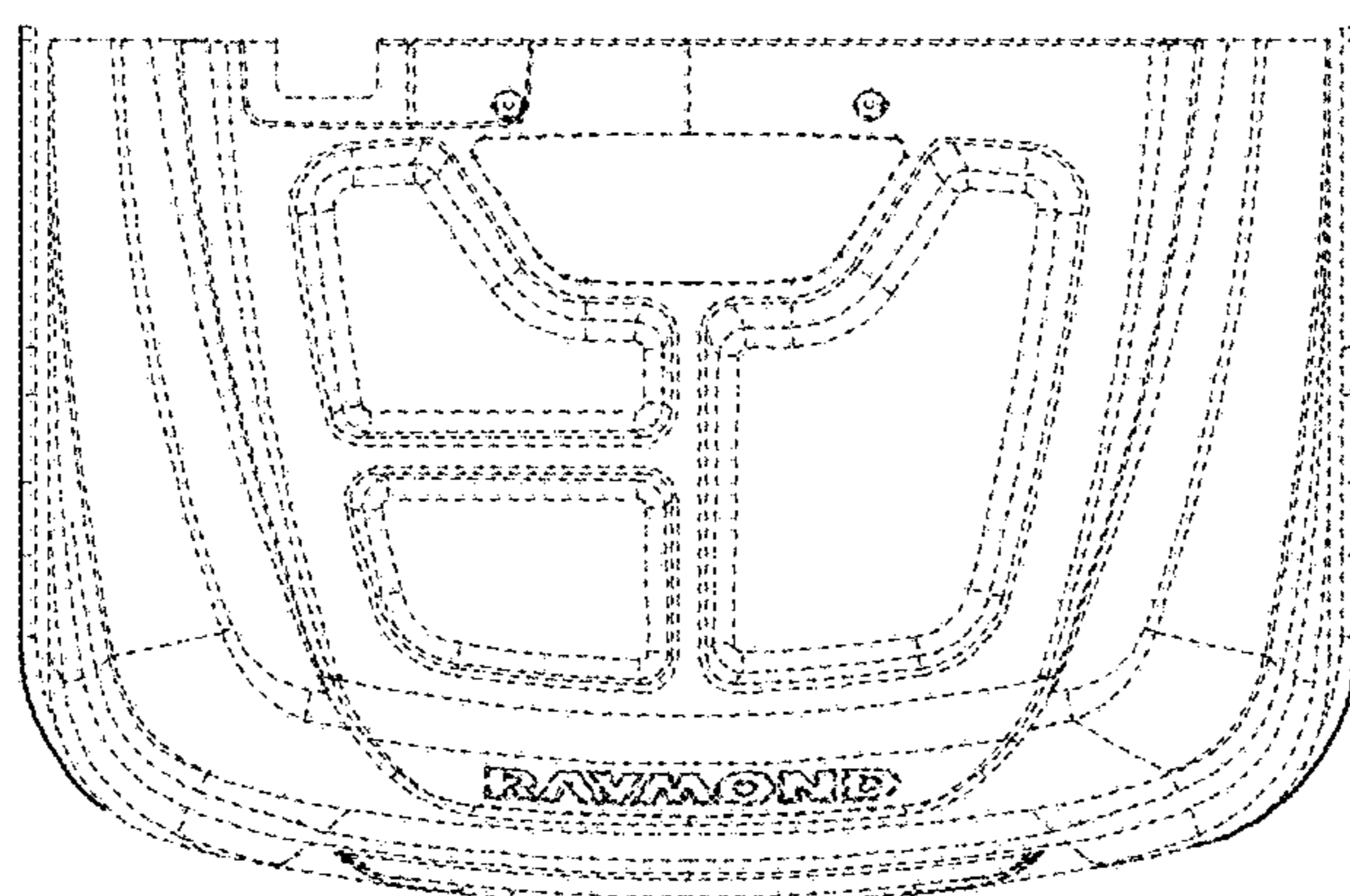

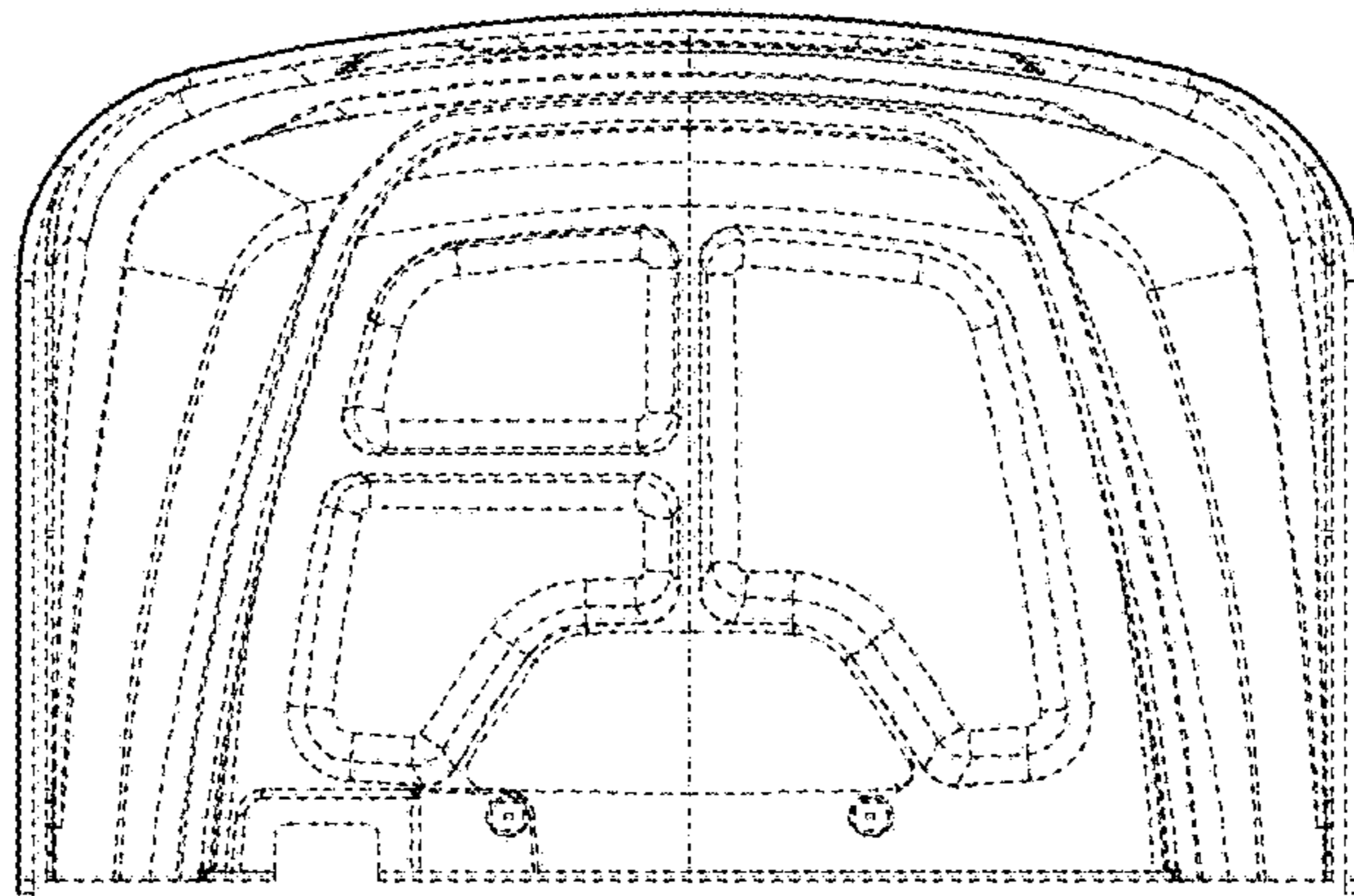

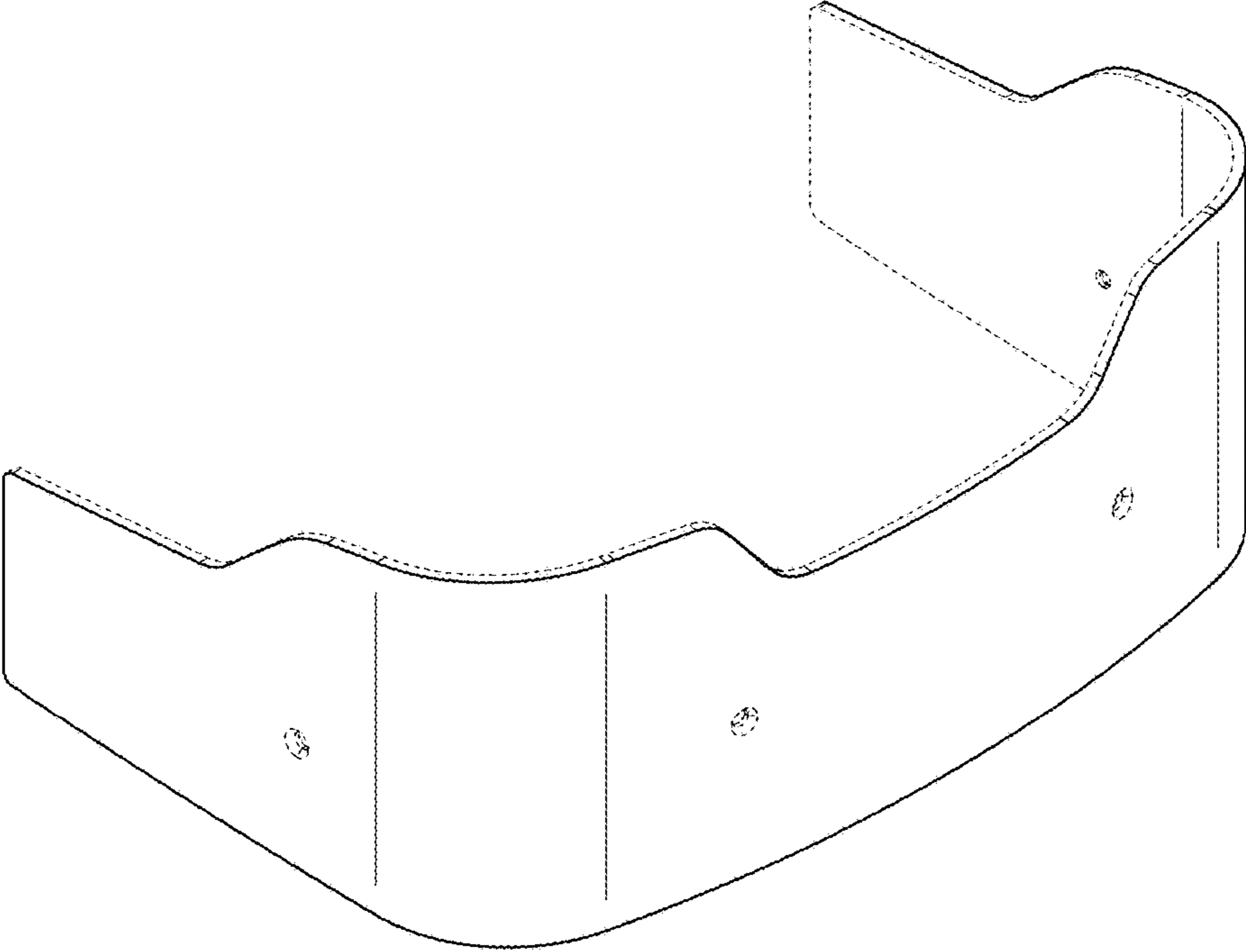

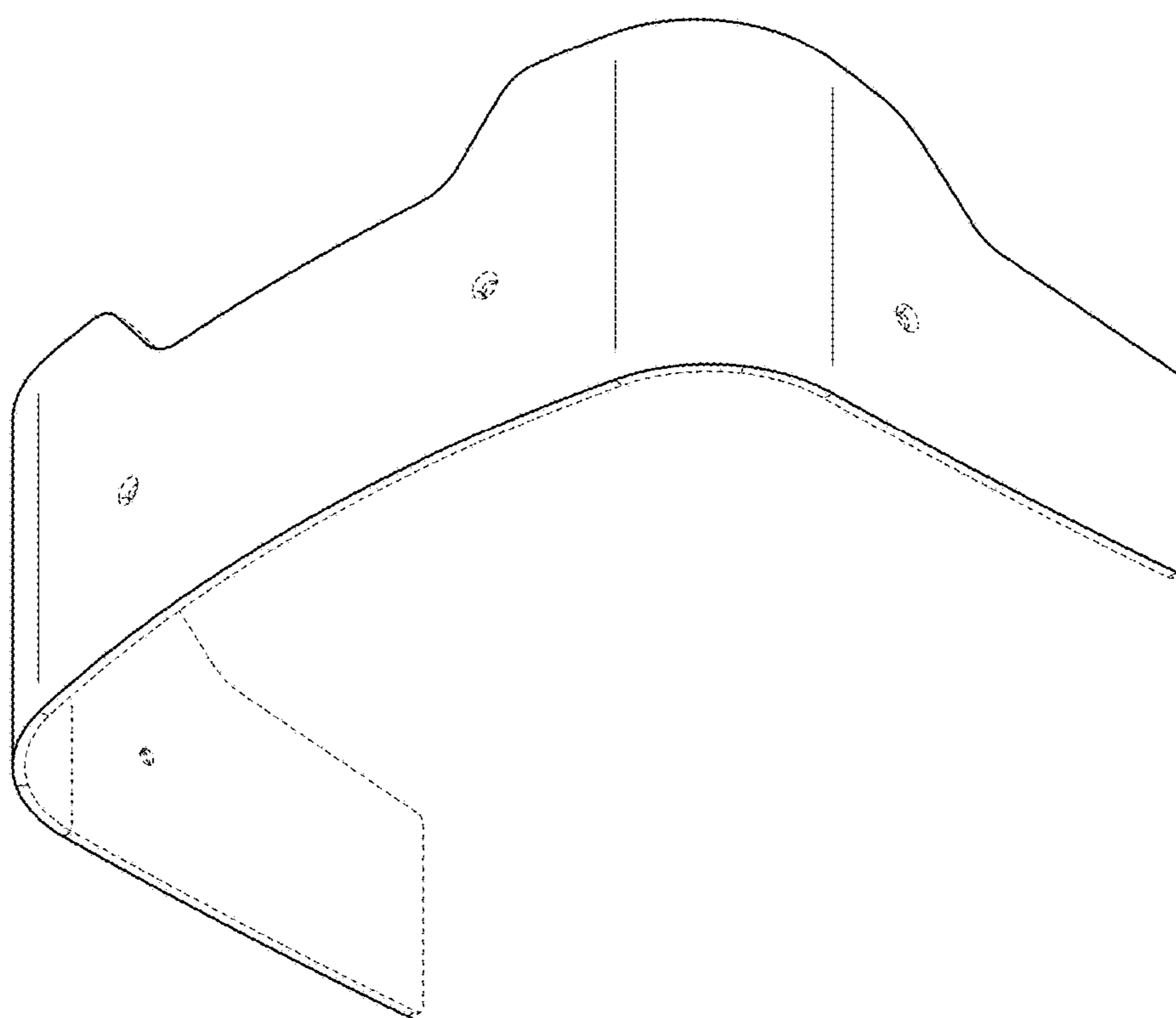

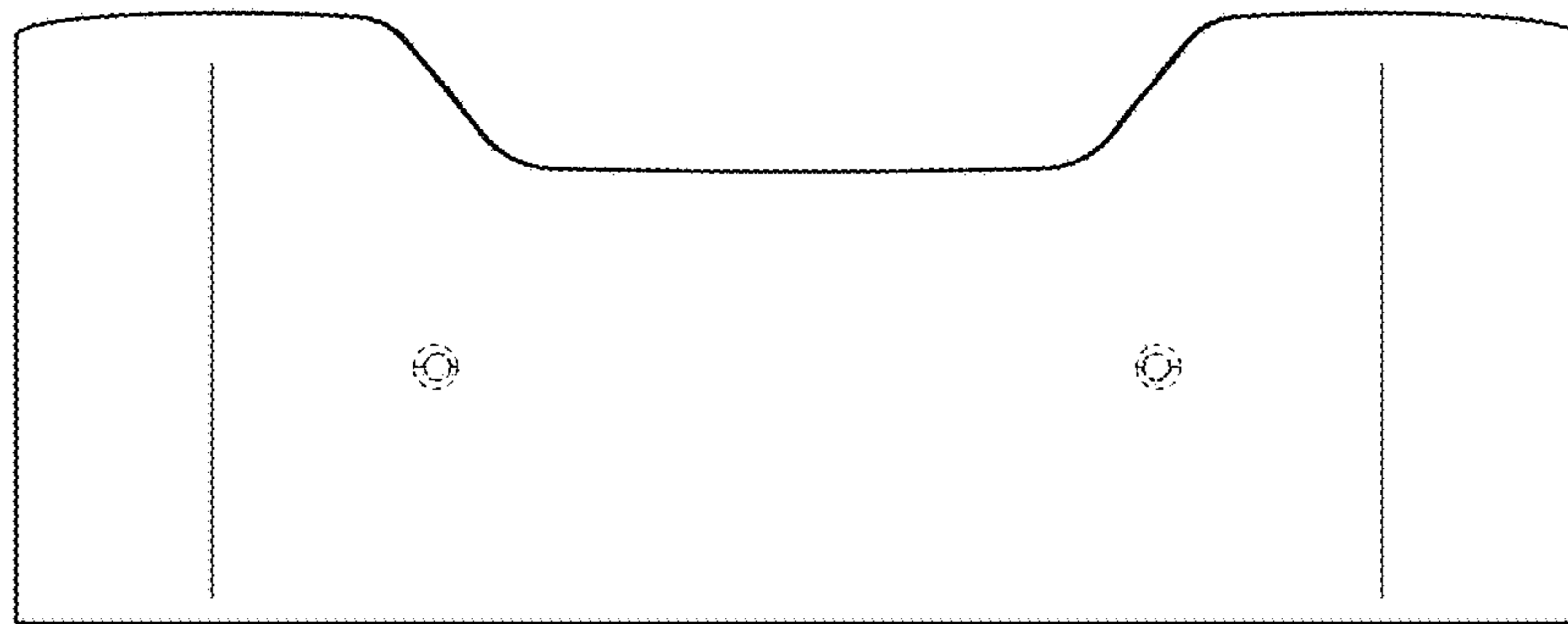

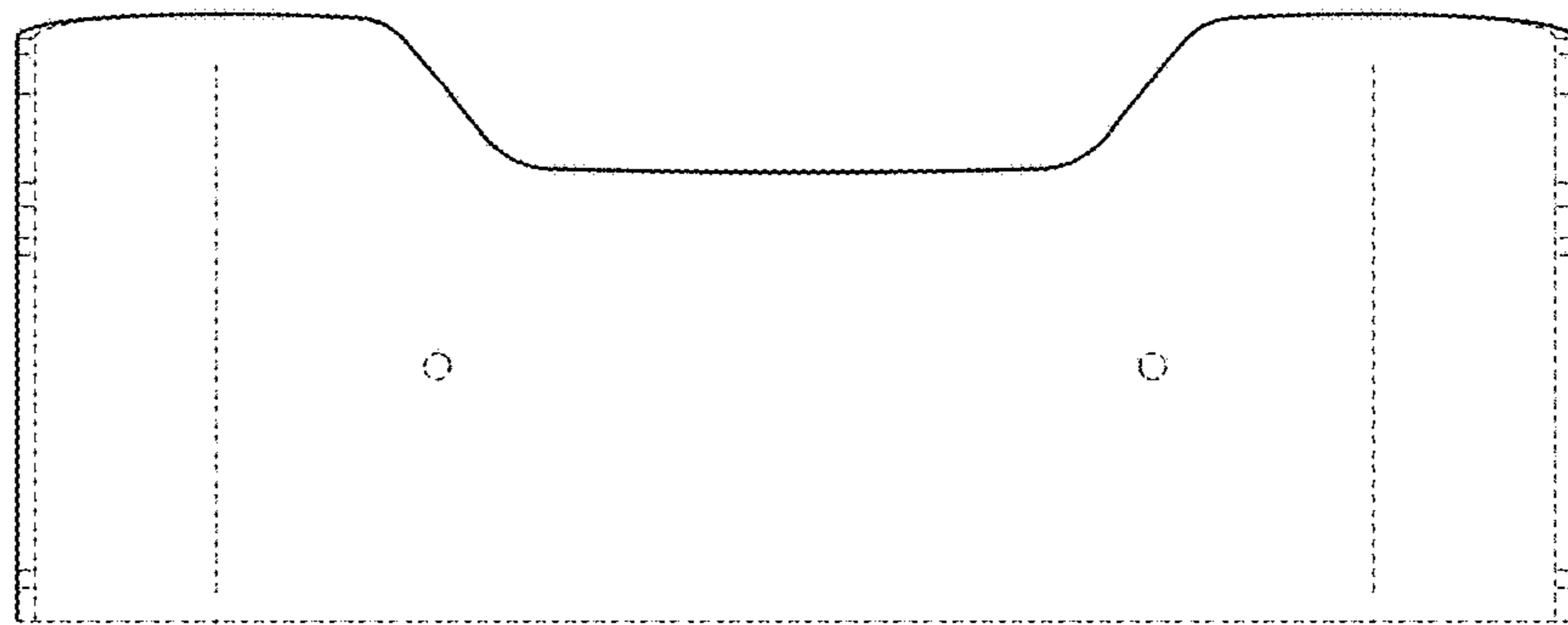

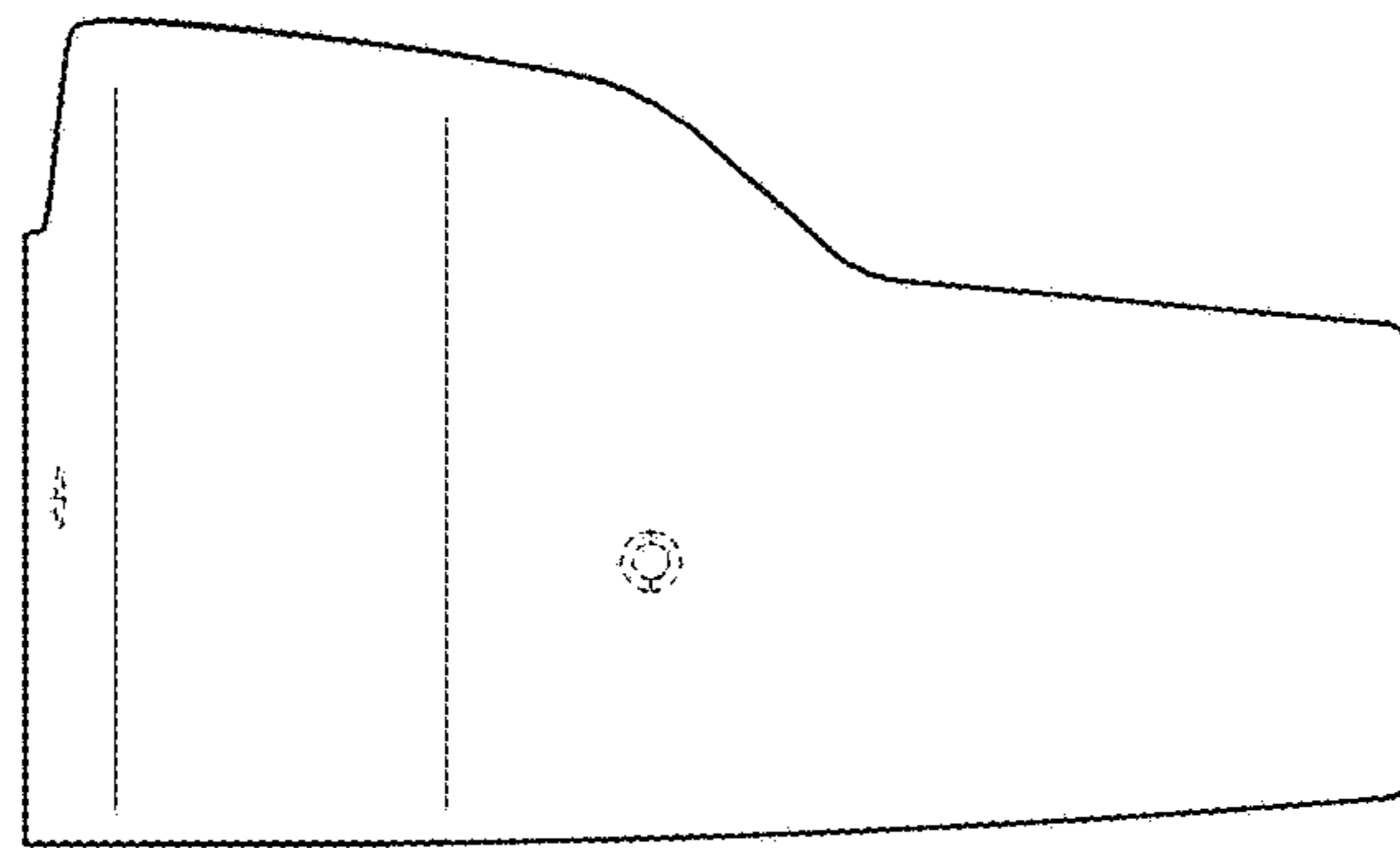

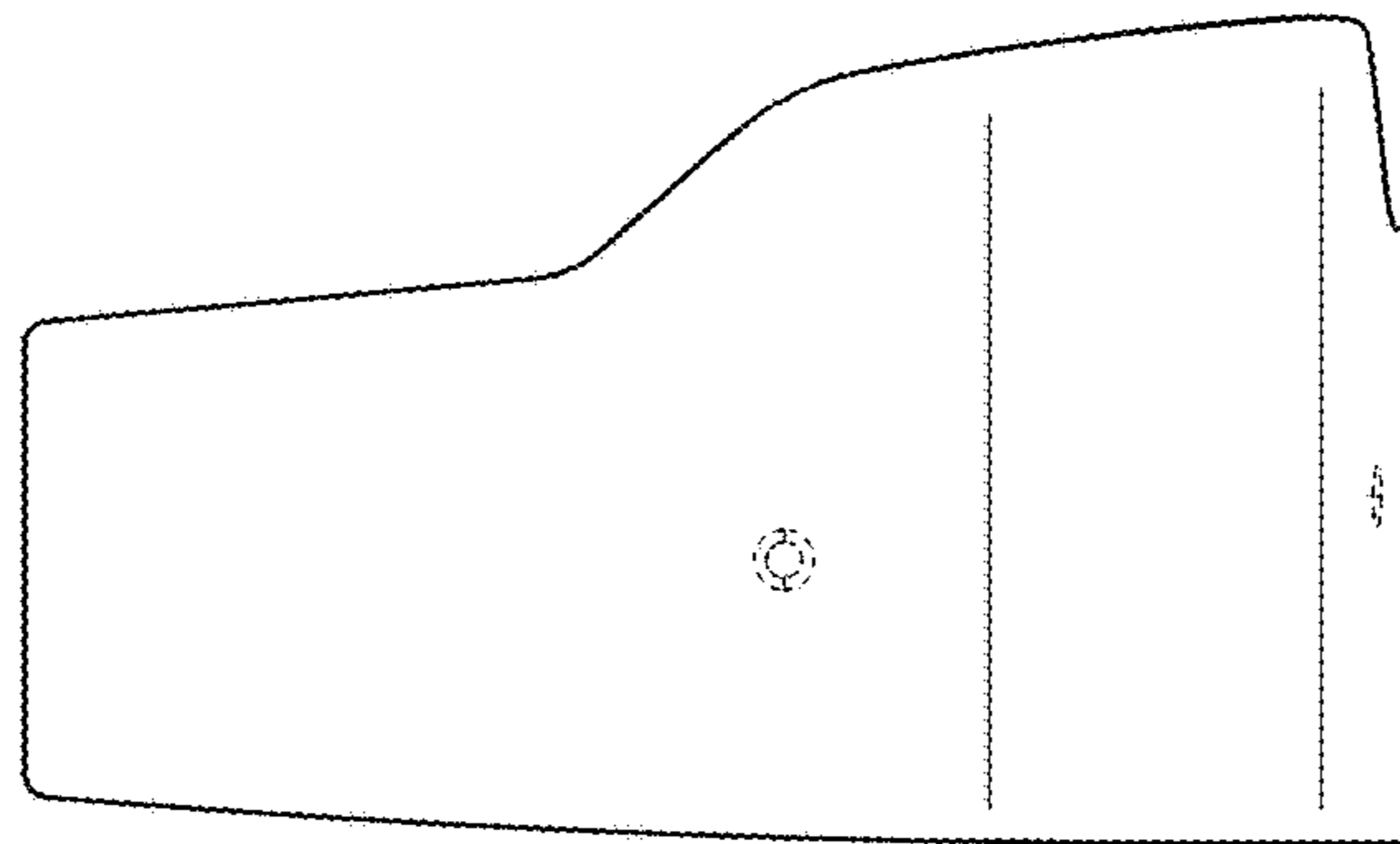

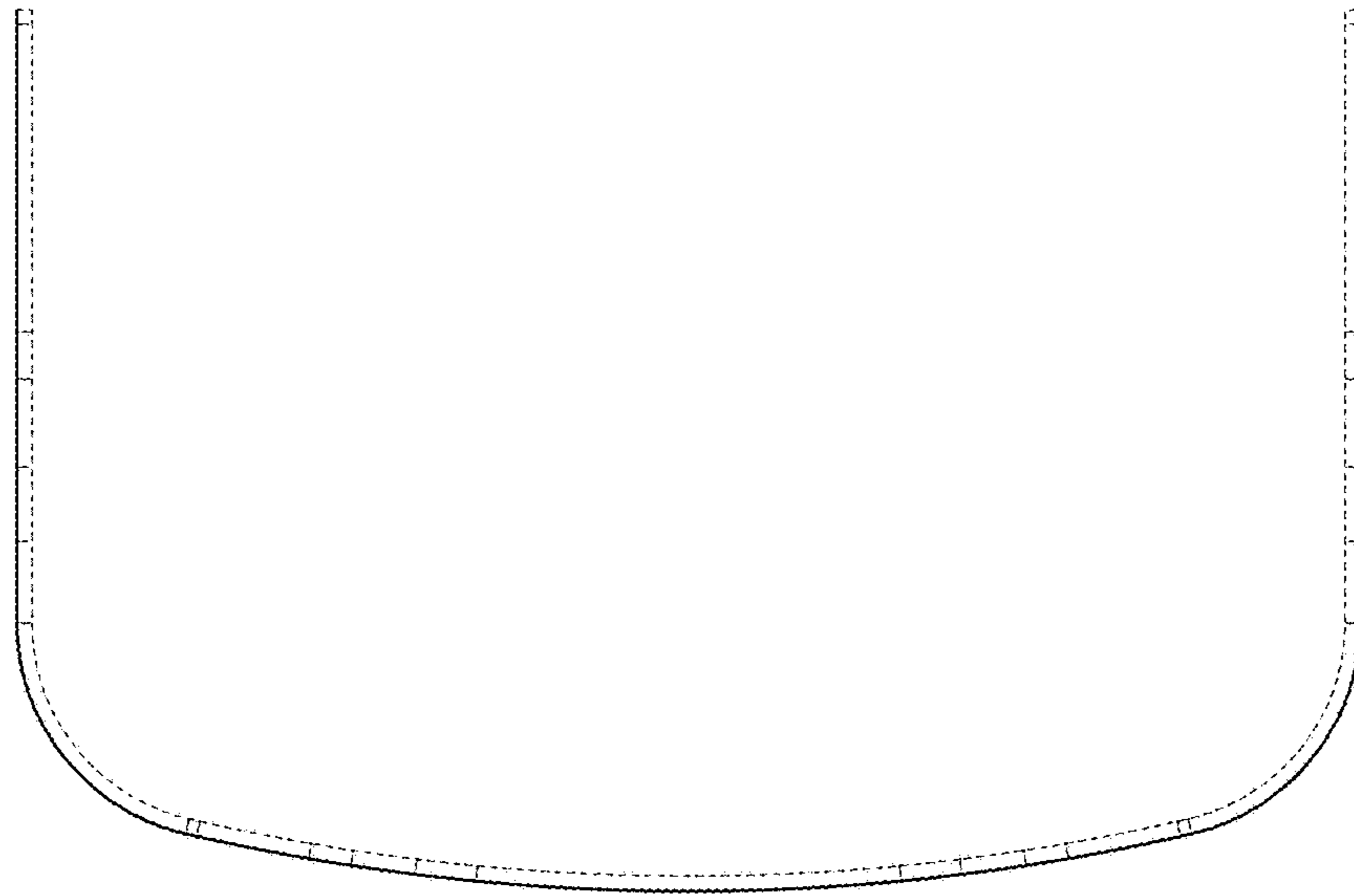

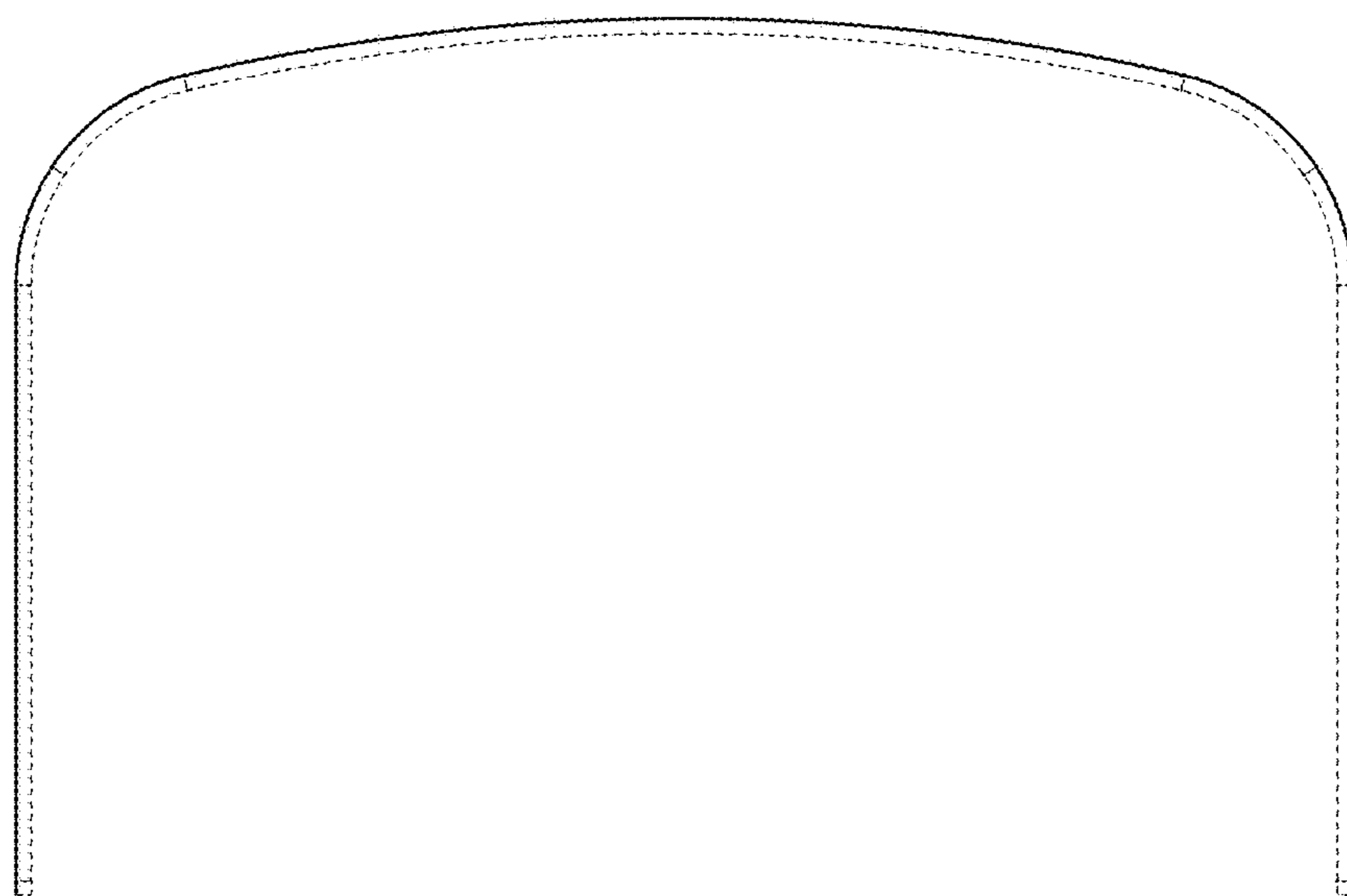
