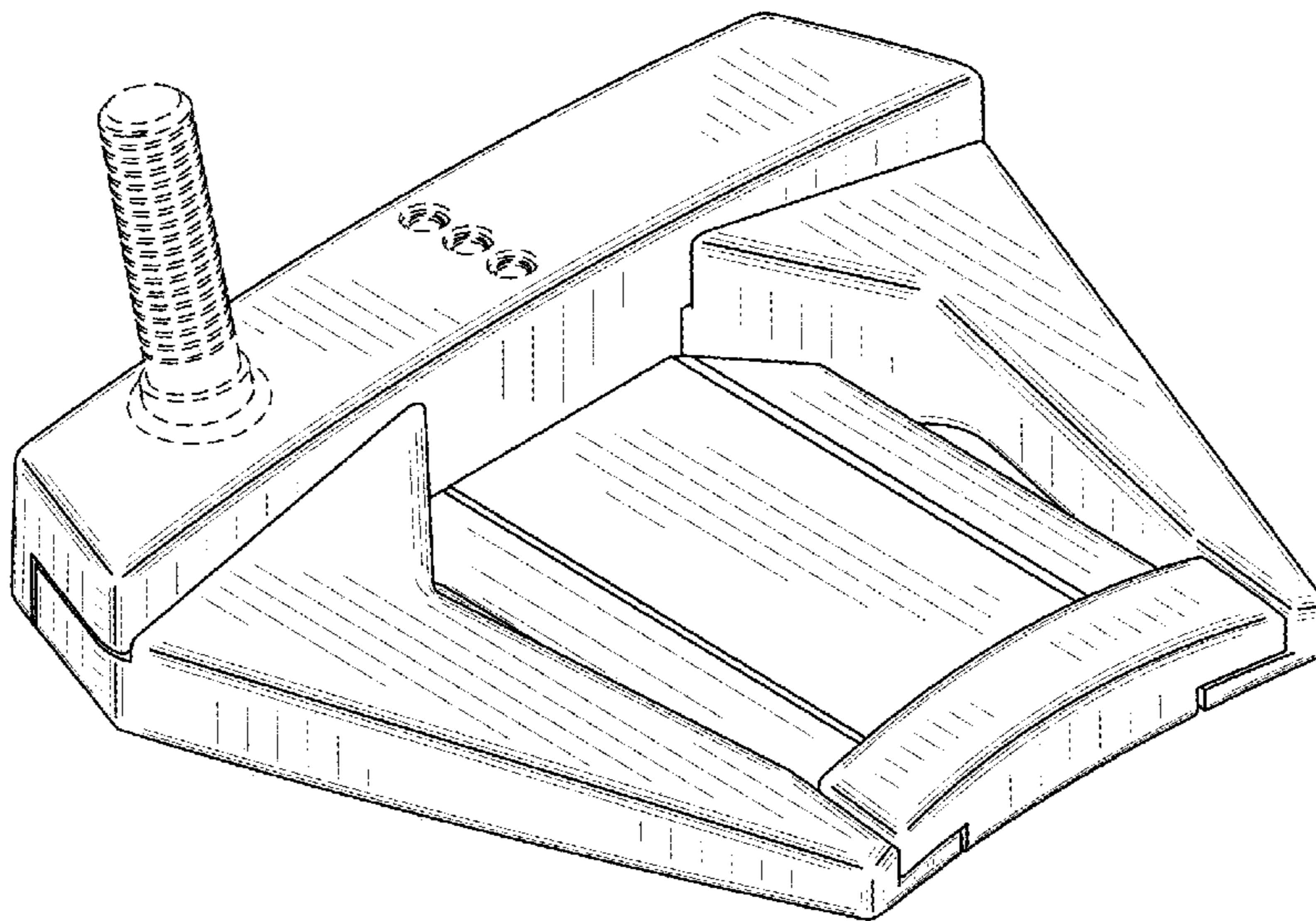
The ornamental design for golf club head, as shown and described.

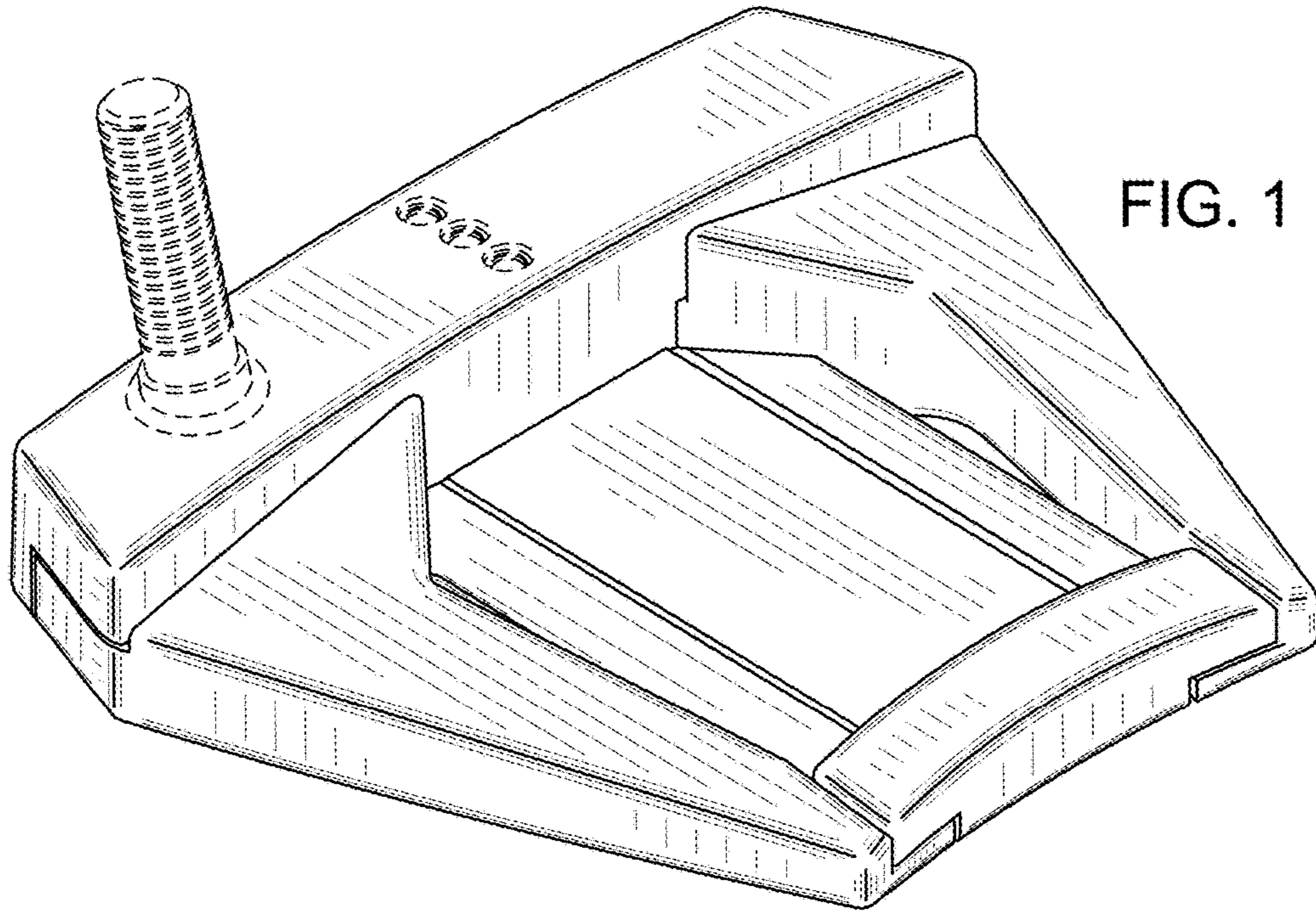

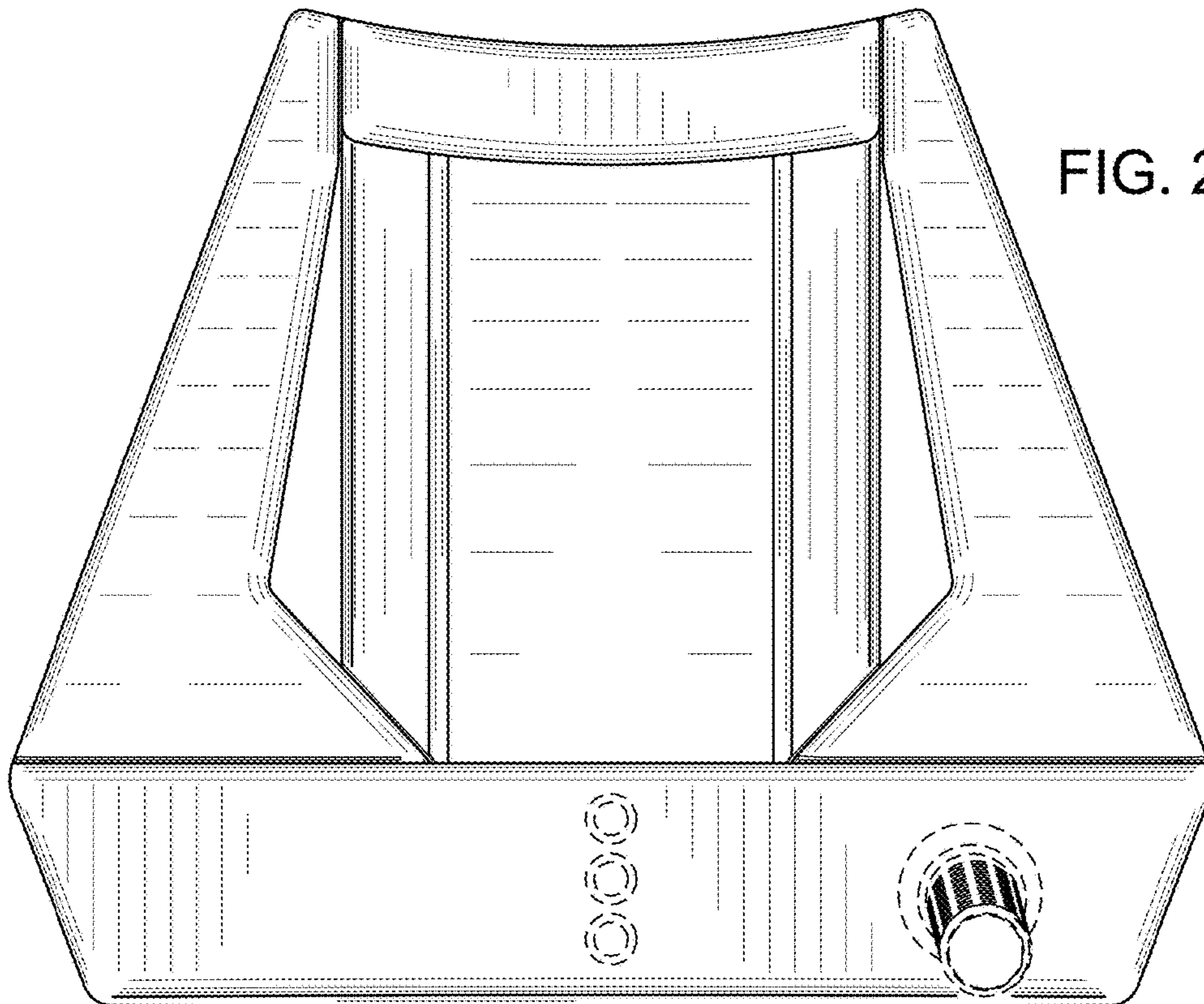

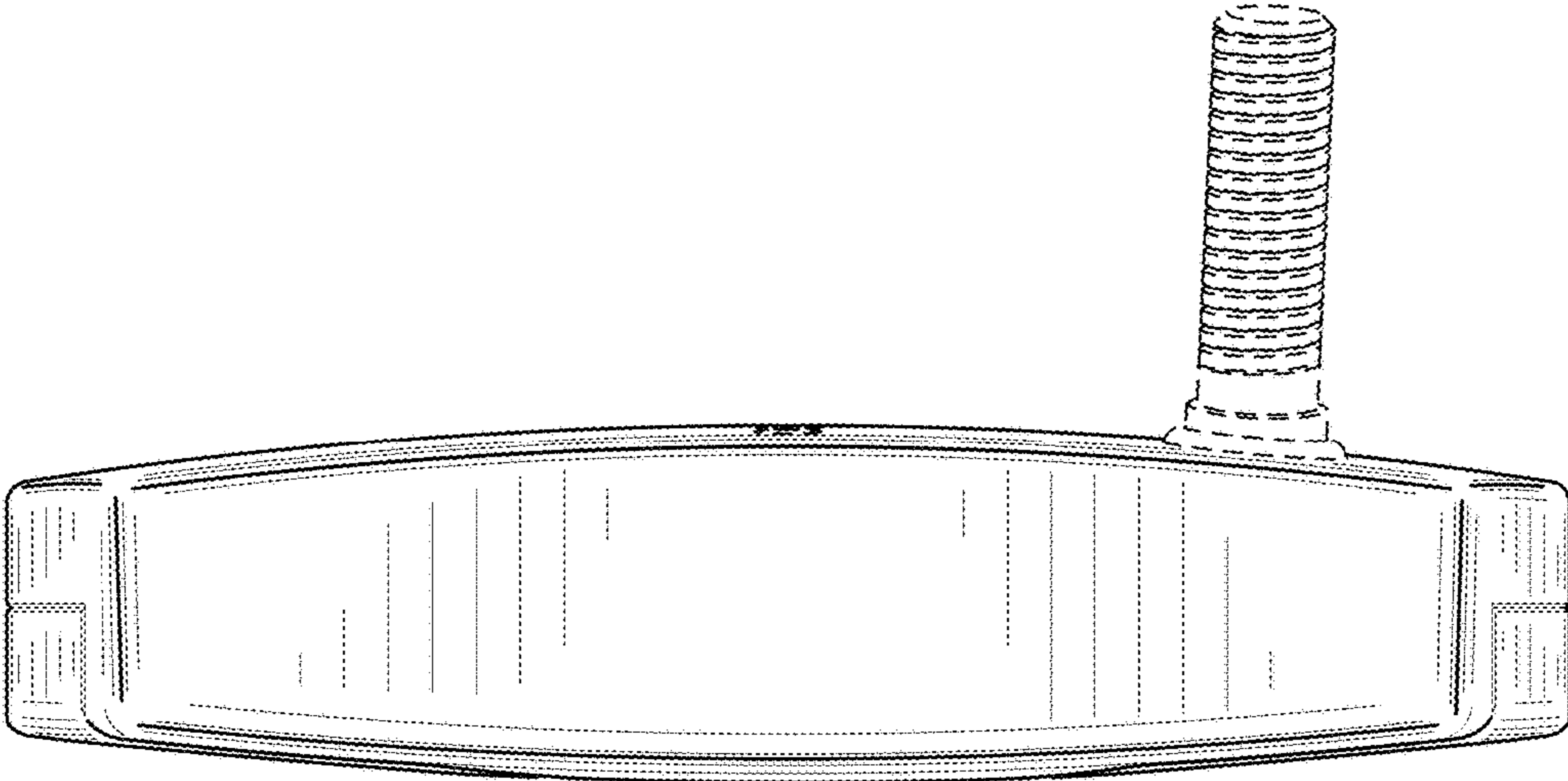

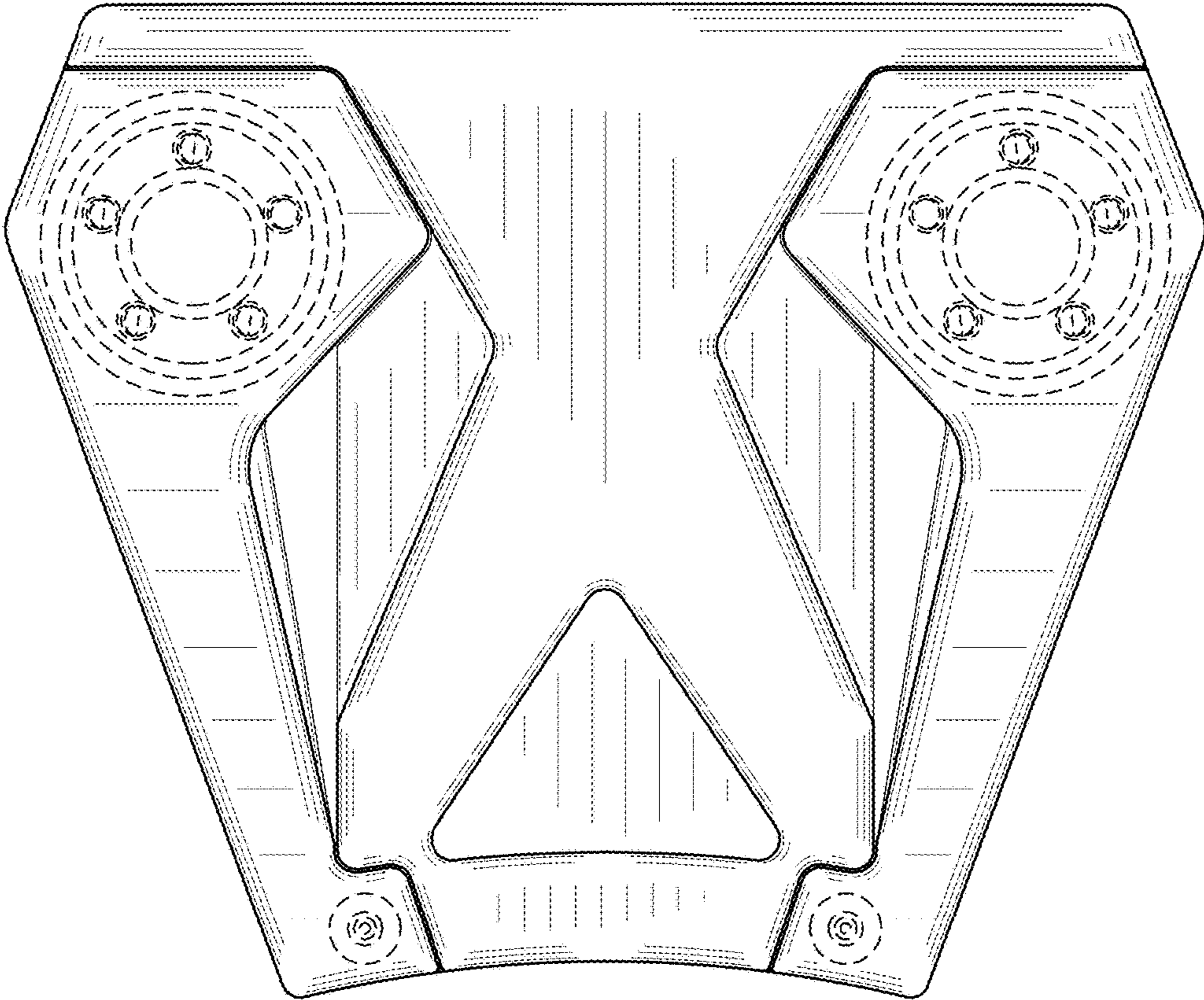

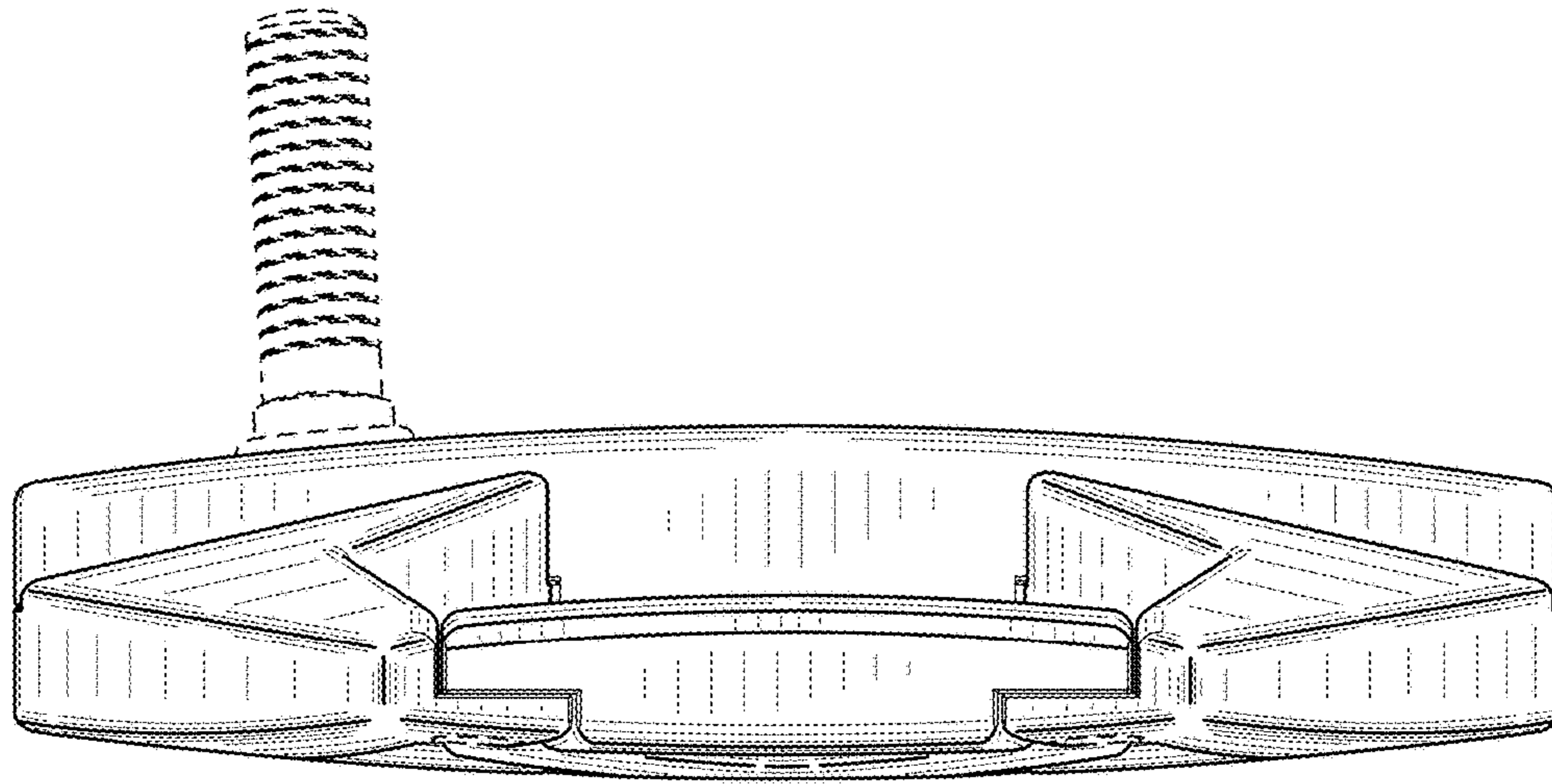

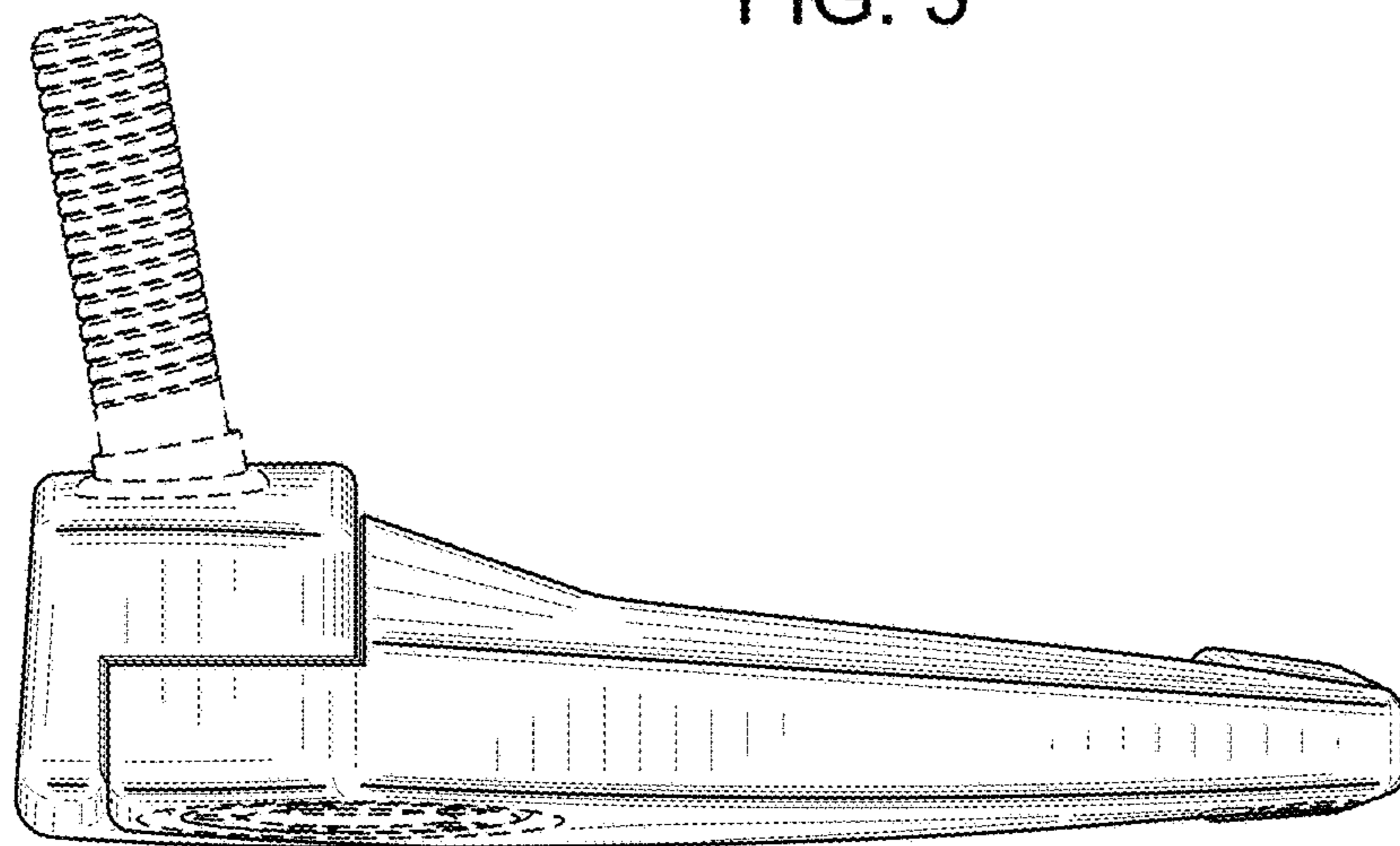

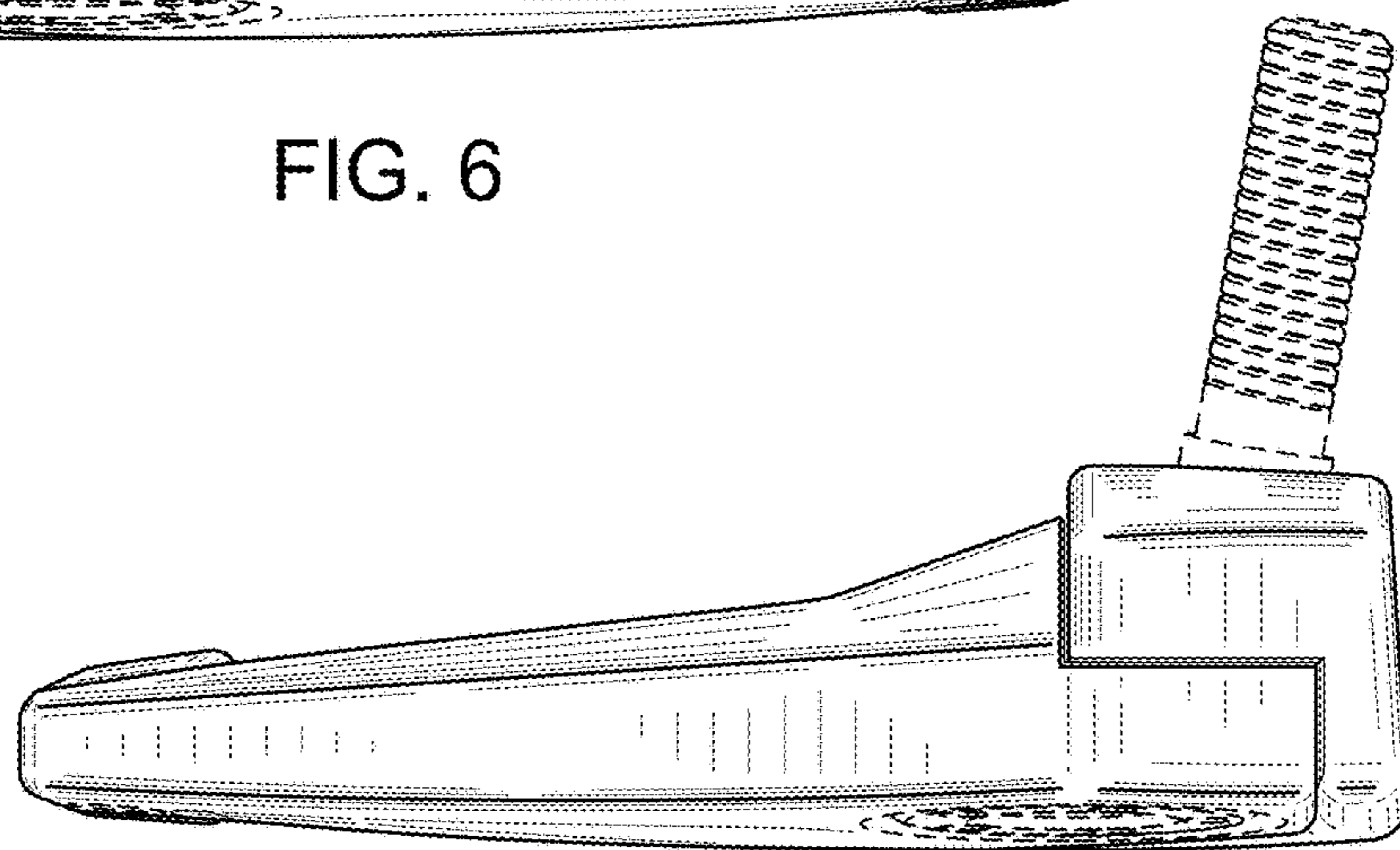
