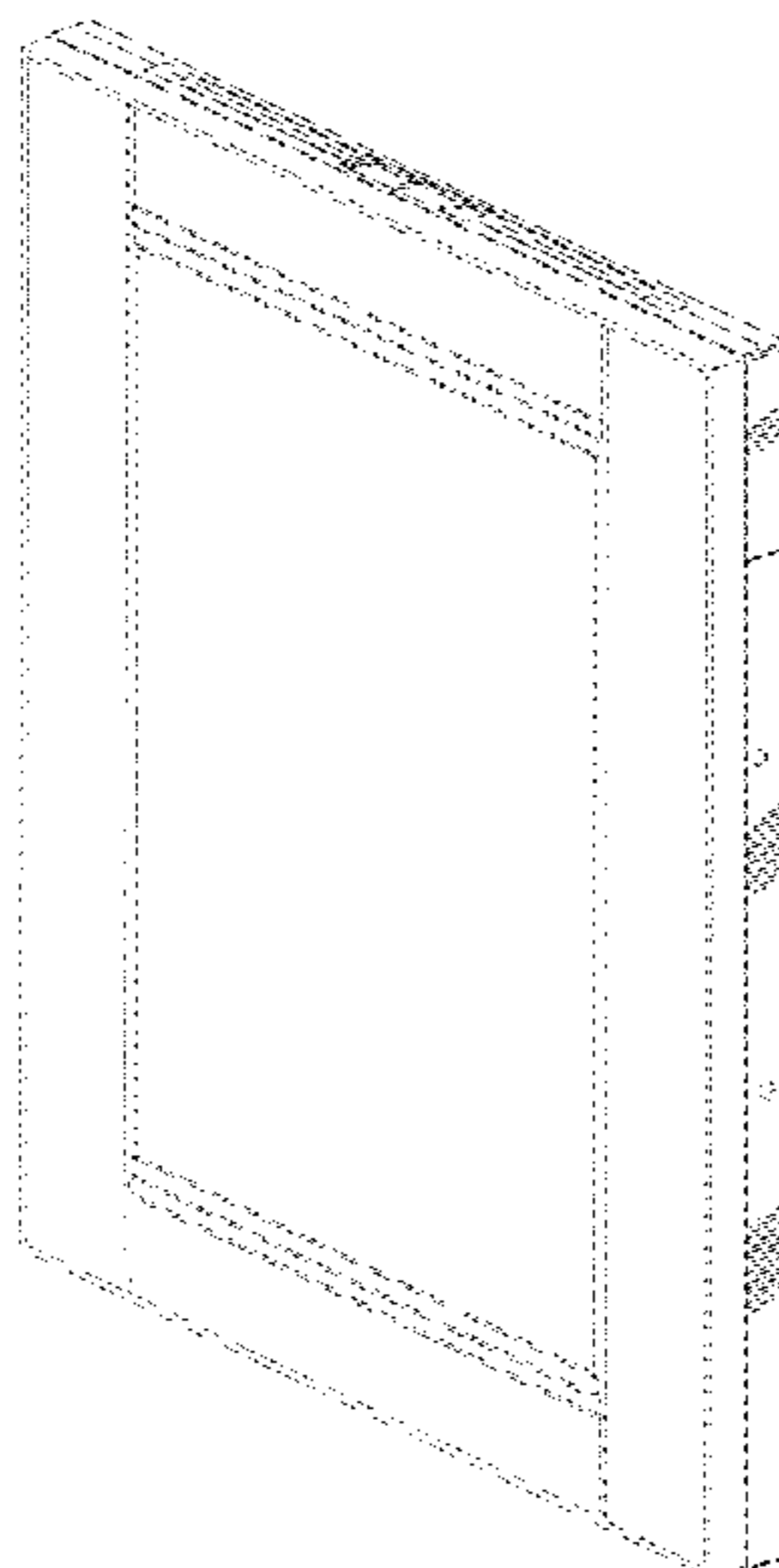
The sole FIGURE is a perspective view of a dishwasher door with a sample decorative panel according to our new ornamental design.
