**DESCRIPTION**

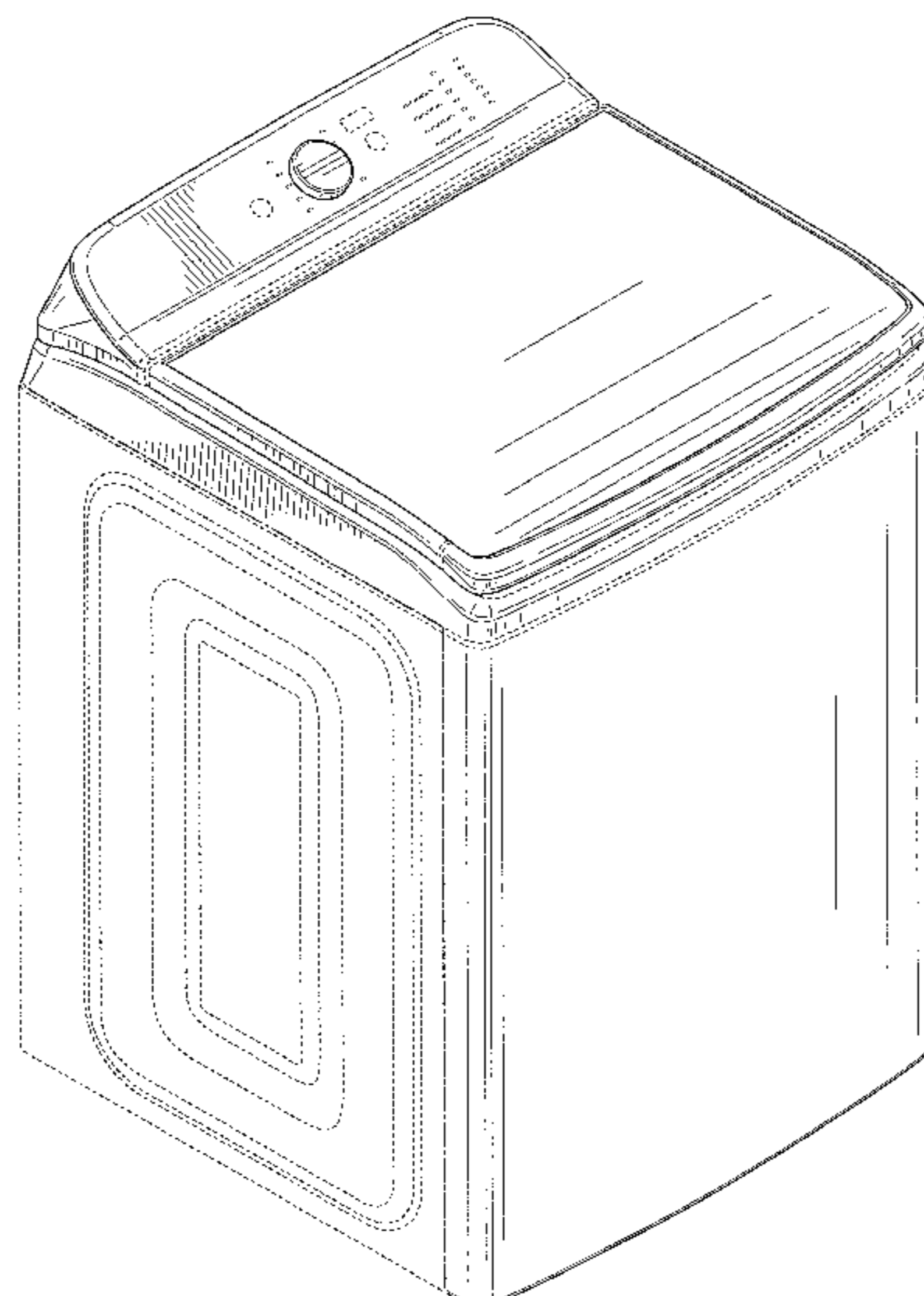
FIG. 1 is a front perspective view of a washing machine according to the design;

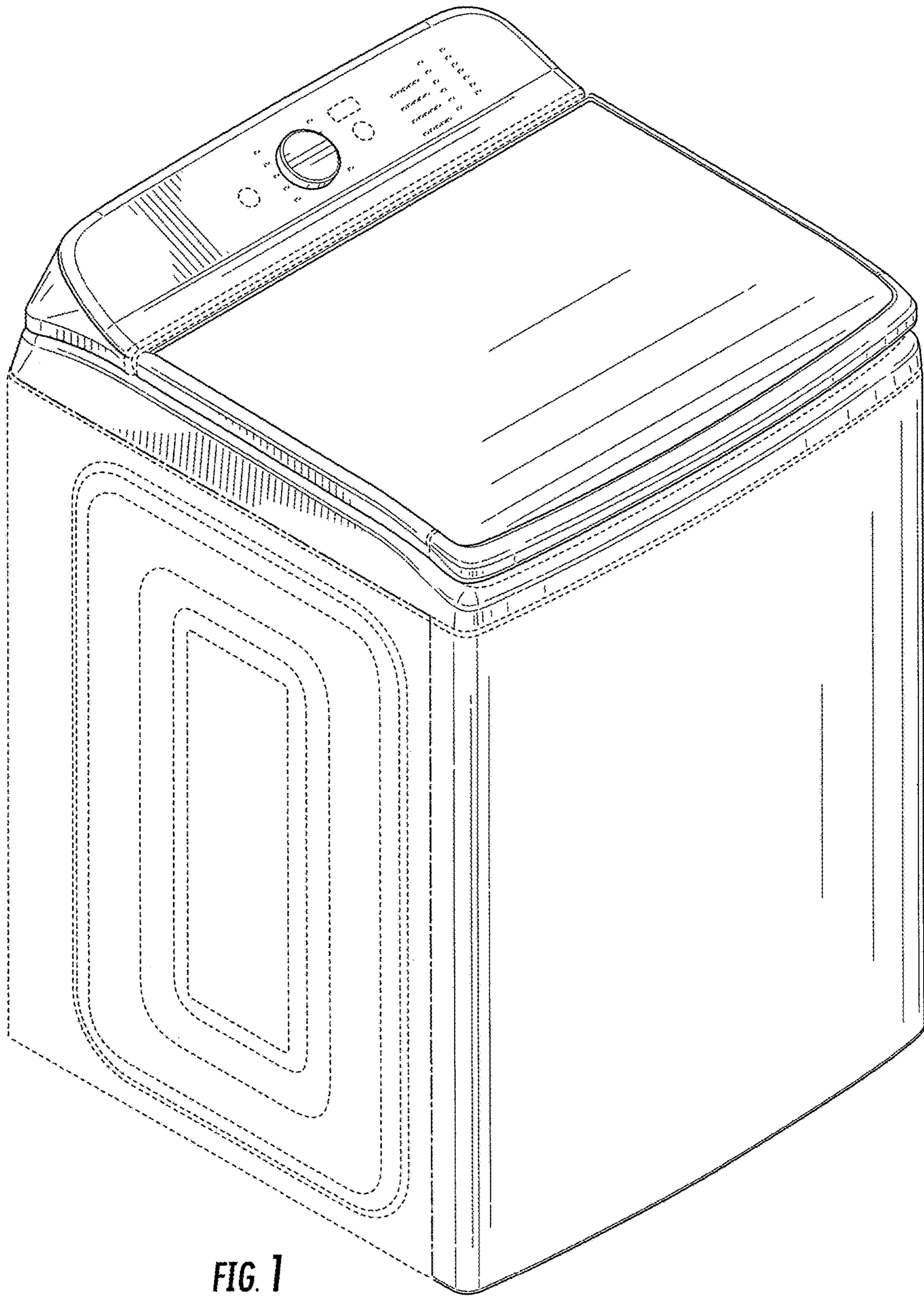

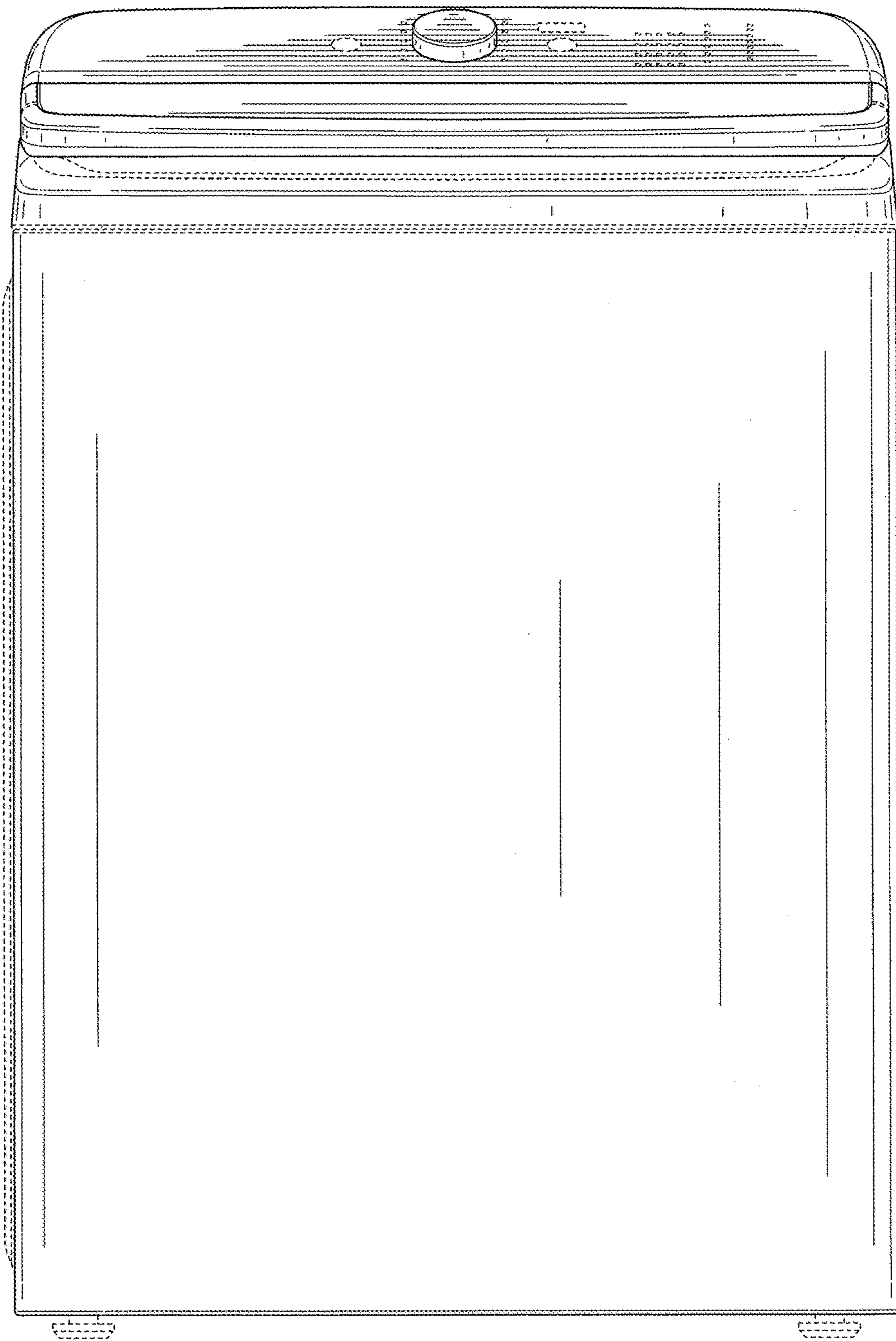

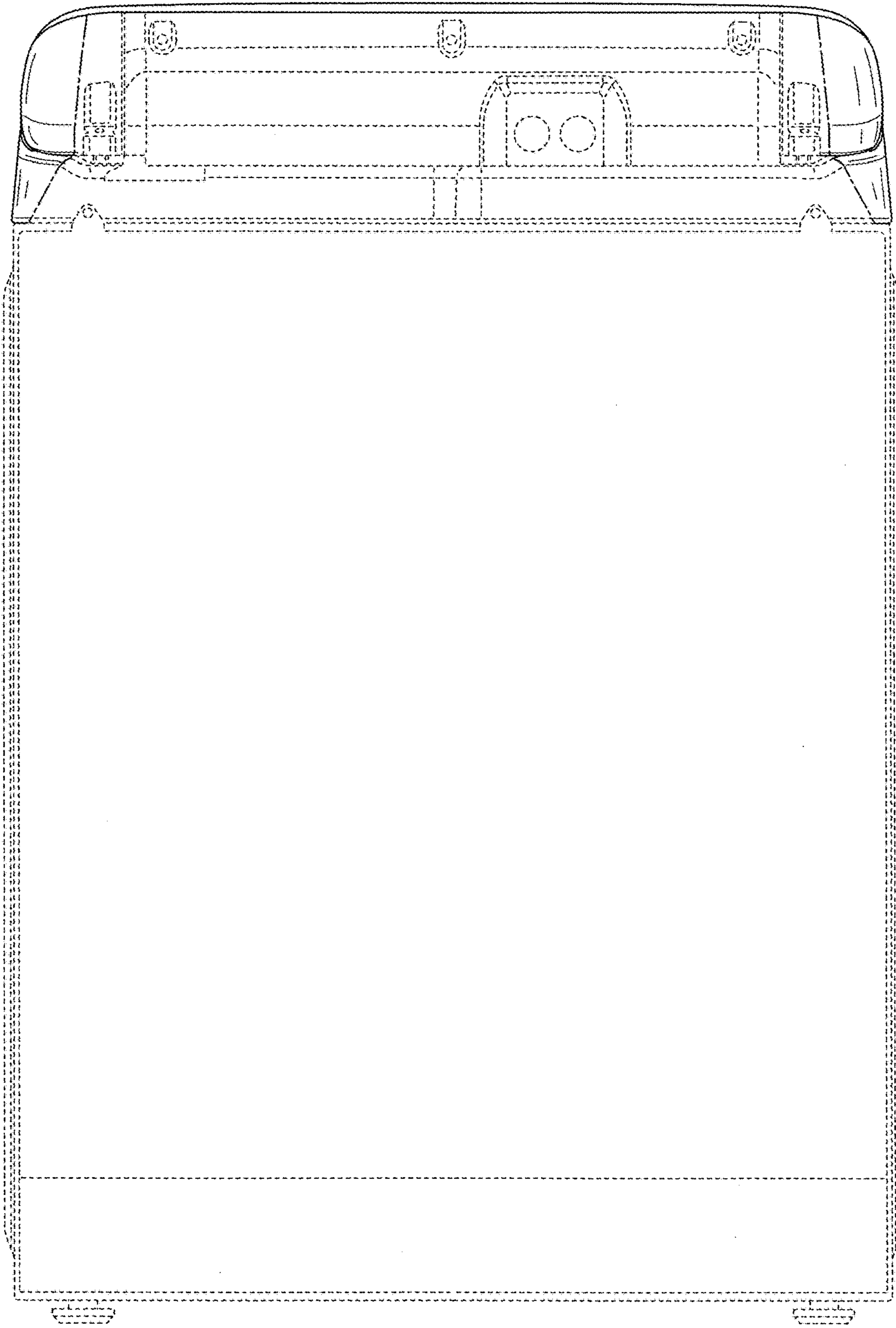

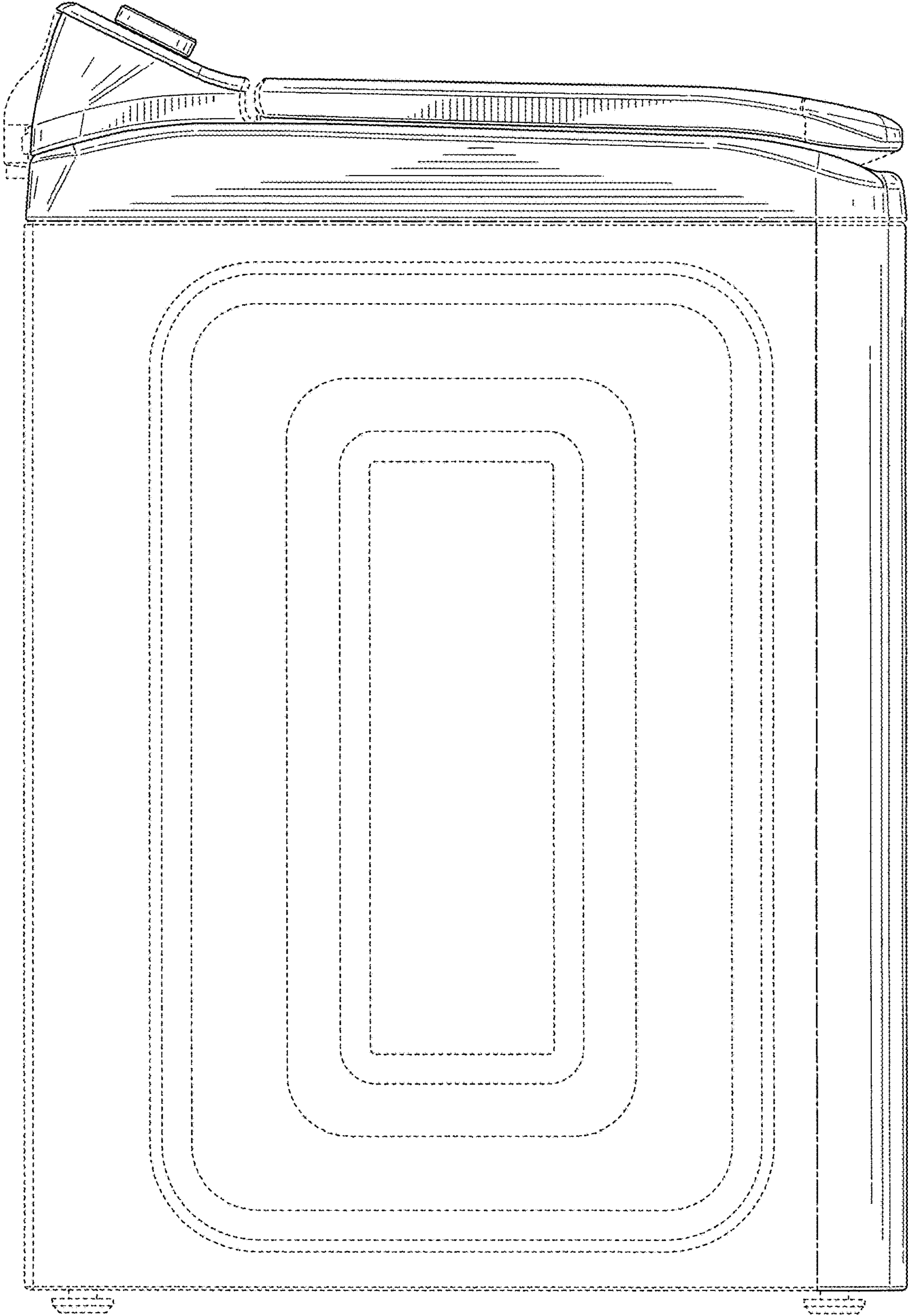

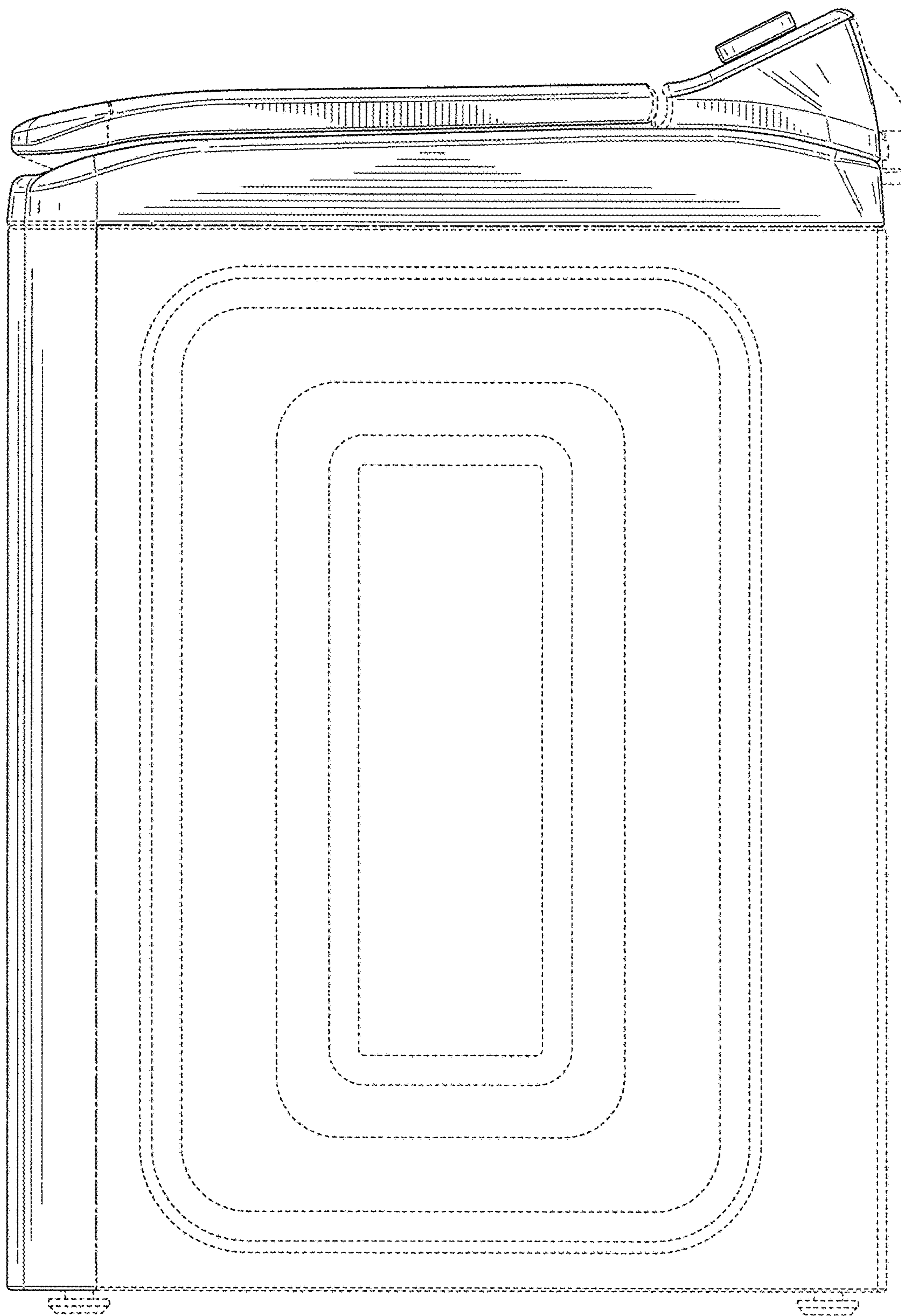

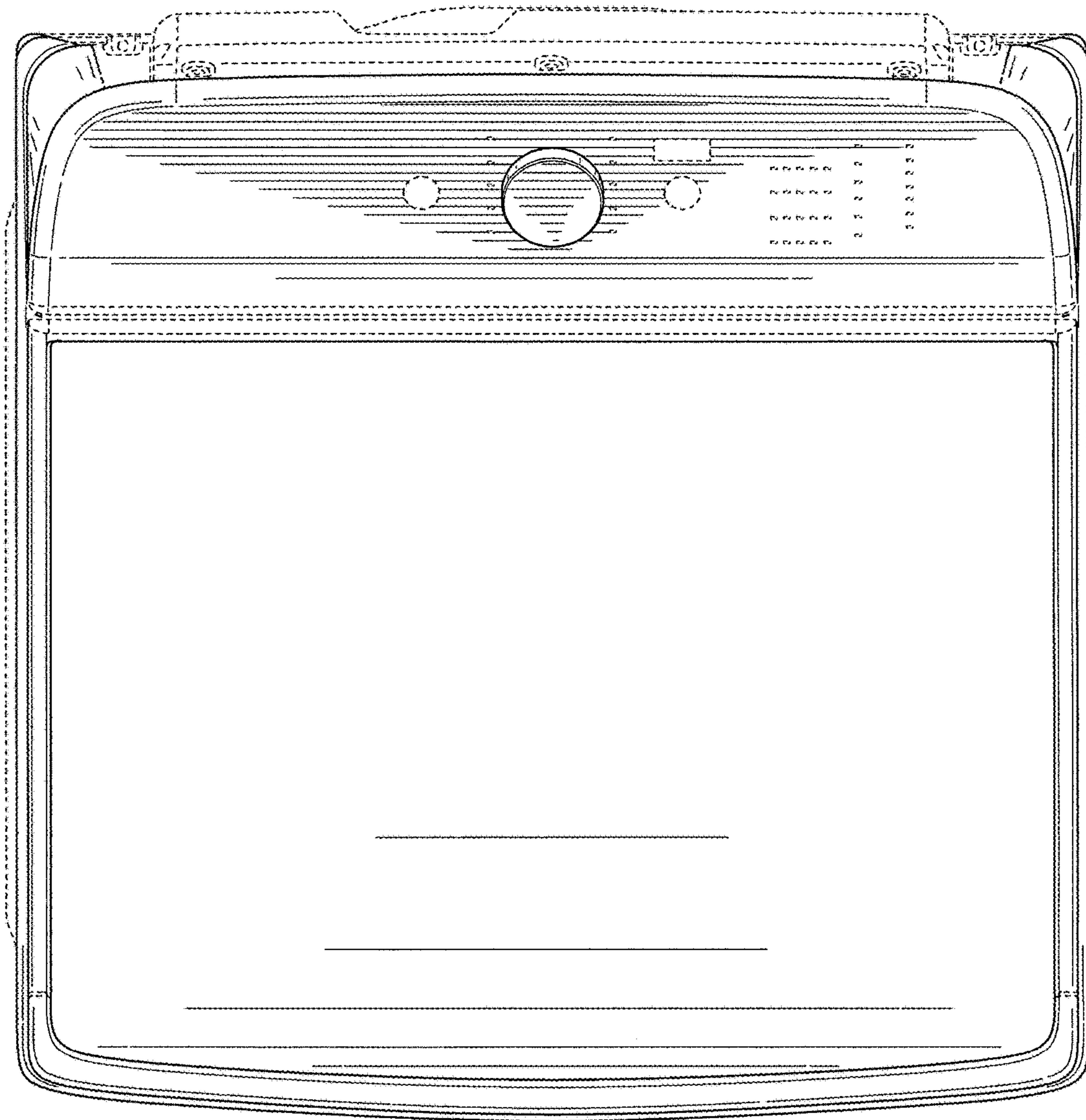
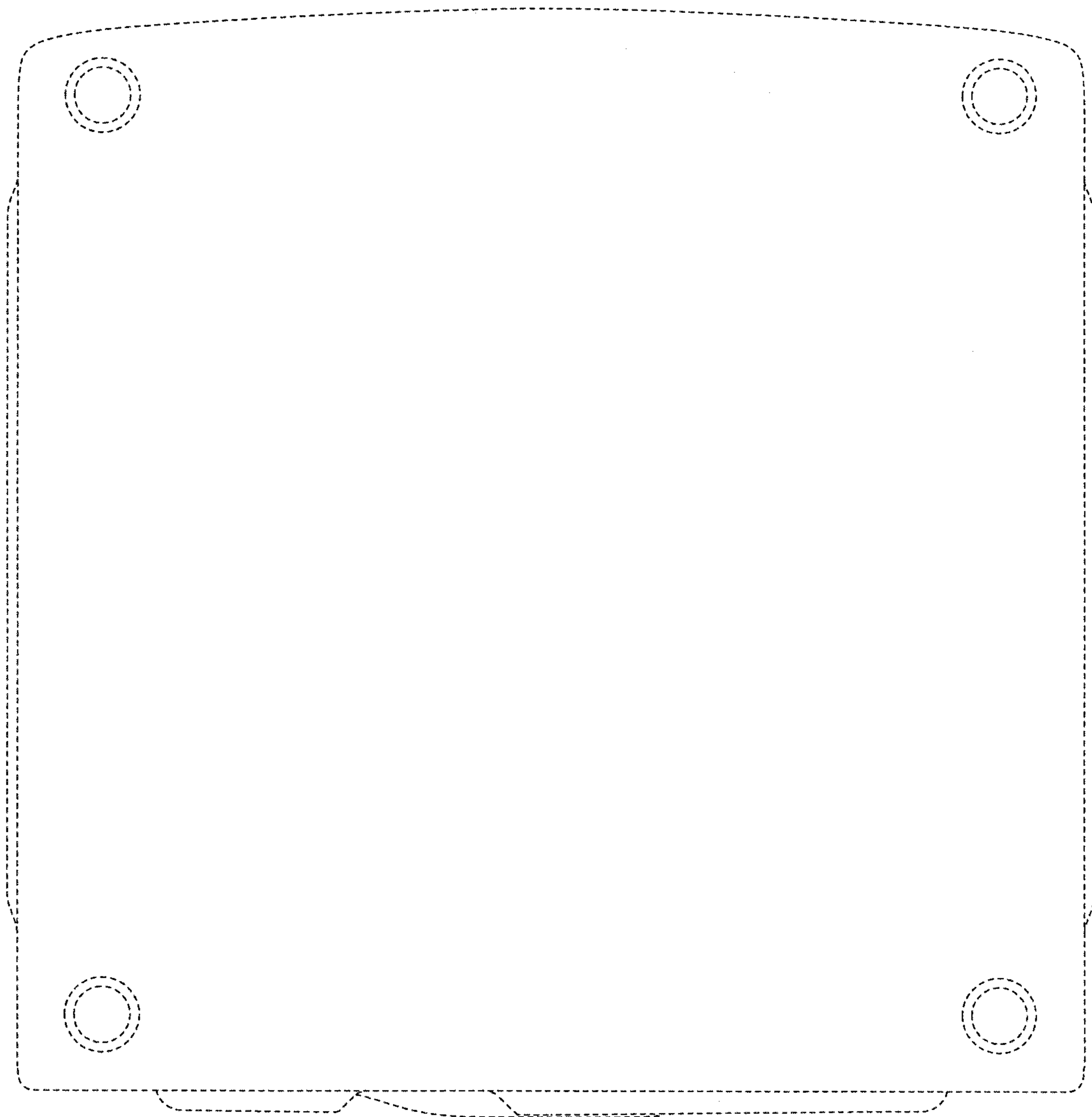
