(57) **CLAIM**

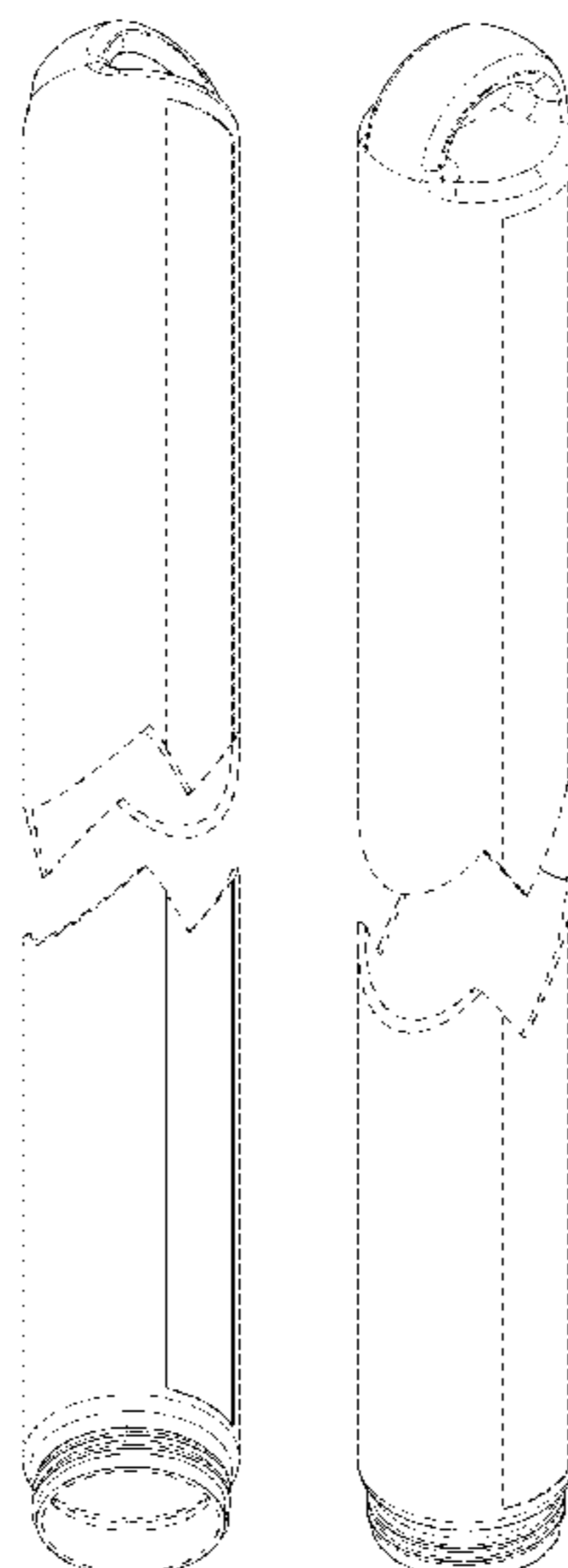
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bottle according to the present disclosure;
 FIG. 2 is a bottom perspective view of the bottle of FIG. 1;
 FIG. 3 is a first side view of the bottle of FIG. 1, the opposite side being identical thereto;
 FIG. 4 is a second side view of the bottle of FIG. 1, the opposite side being identical thereto;
 FIG. 5 is a top view of the bottle of FIG. 1; and,
 FIG. 6 is a bottom view of the bottle of FIG. 1.
 The bottle is shown in FIGS. 1-6 with symbolic break lines in the vertical dimension. The appearance of any portion of the article between the break lines forms no part of the claimed design. The remaining broken lines illustrate portions of the bottle that form no part of the claimed design.

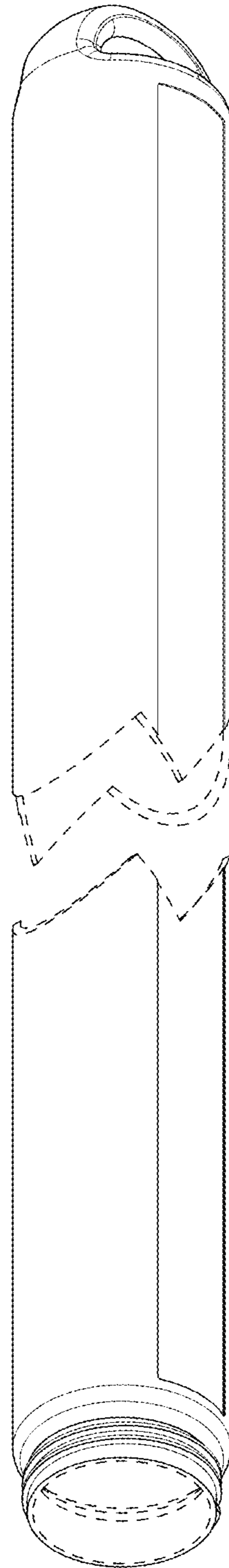

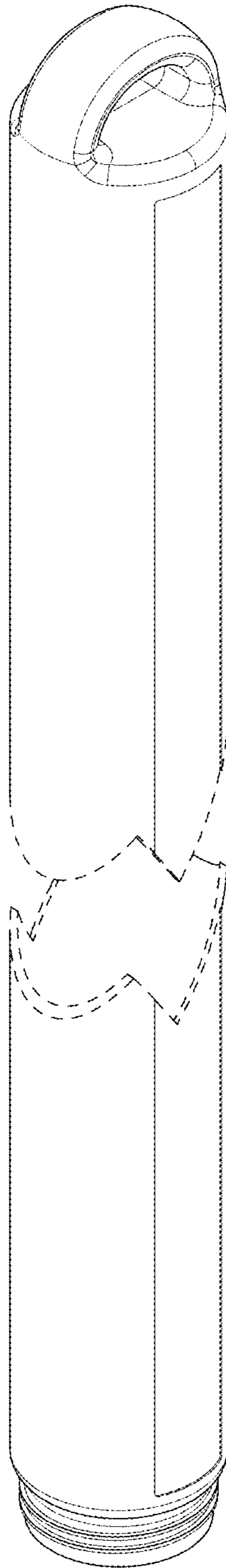

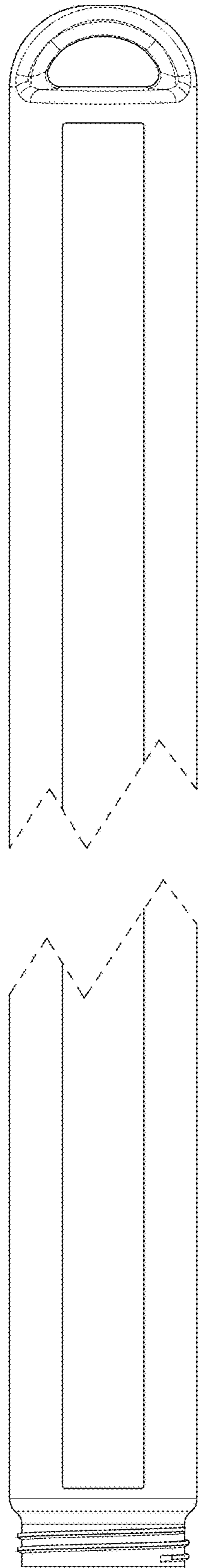
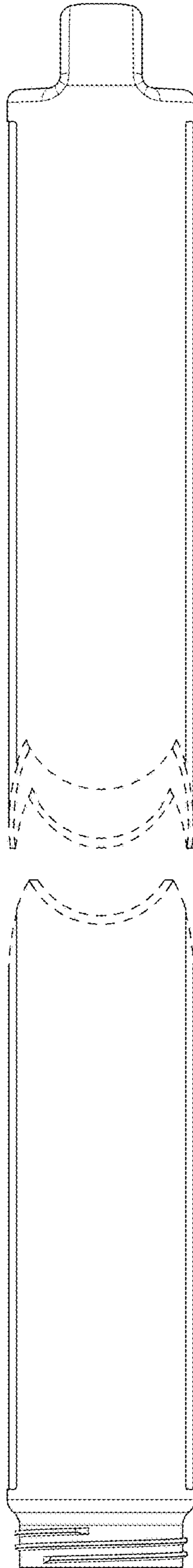

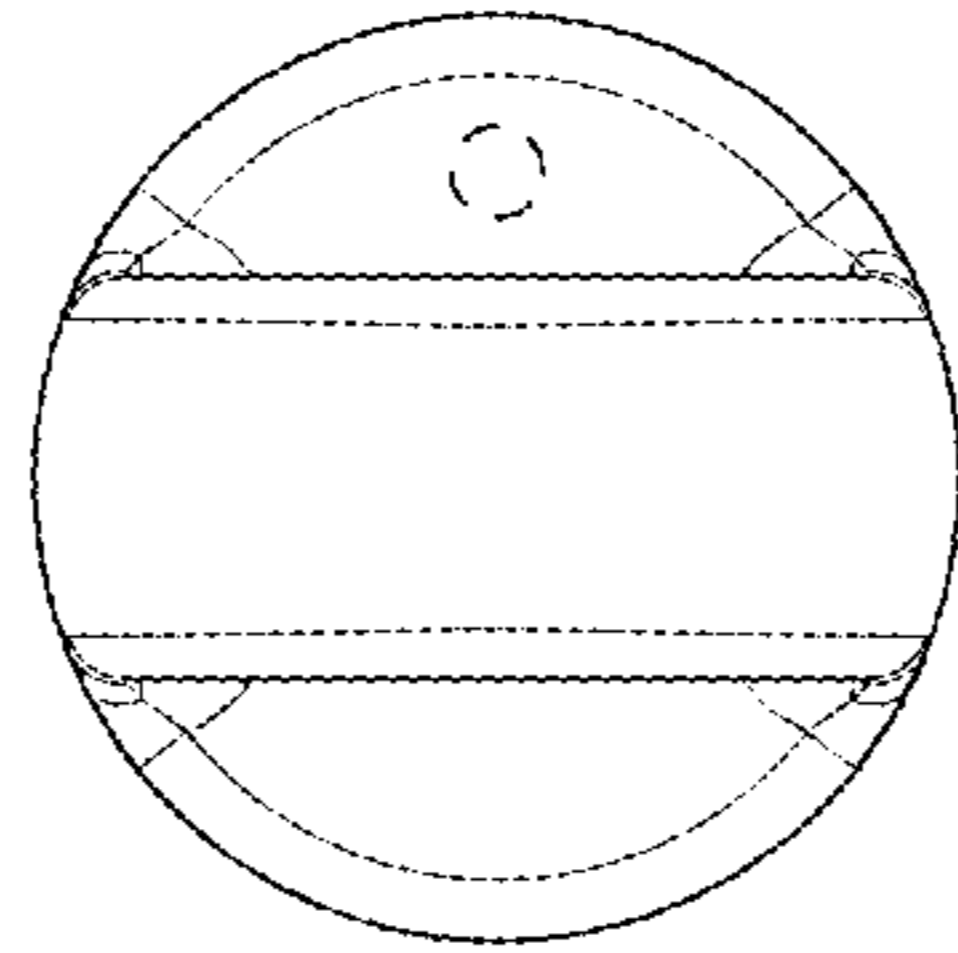

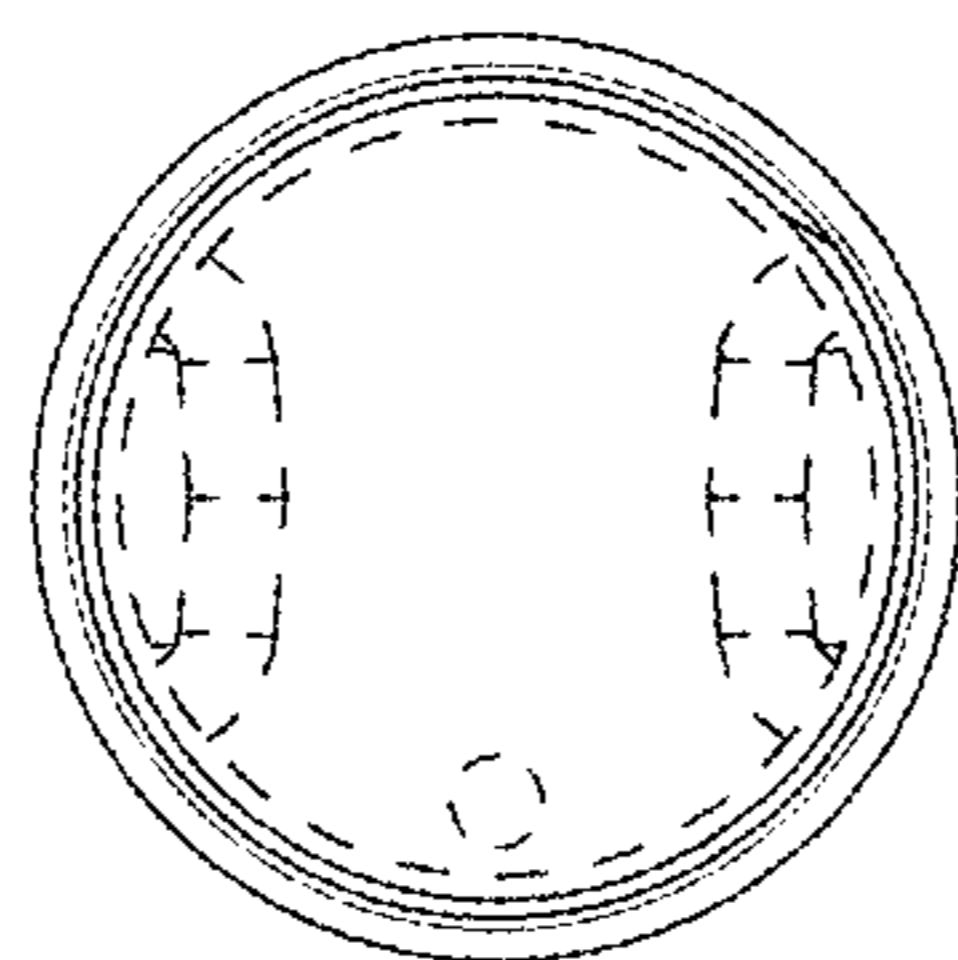
