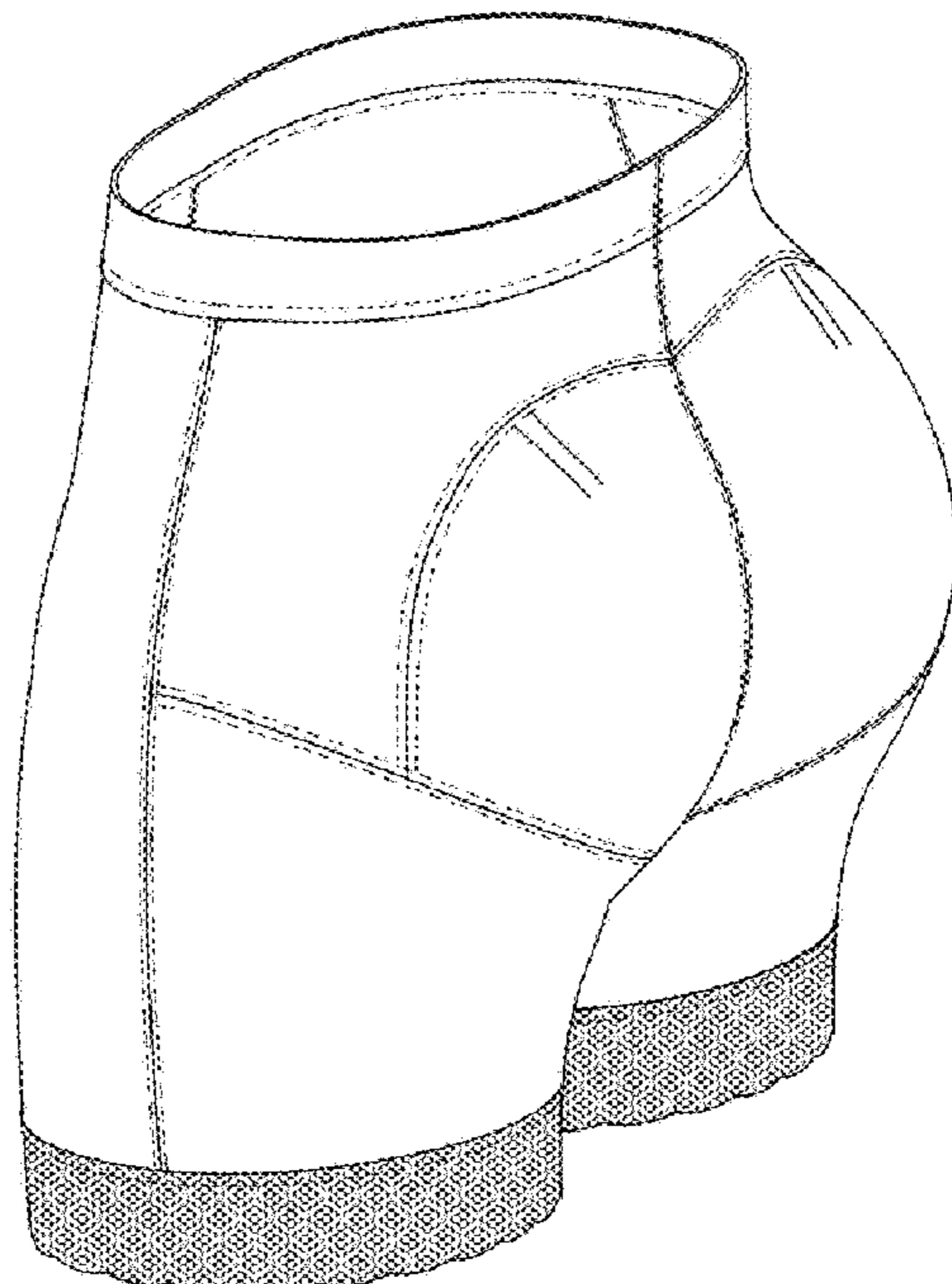
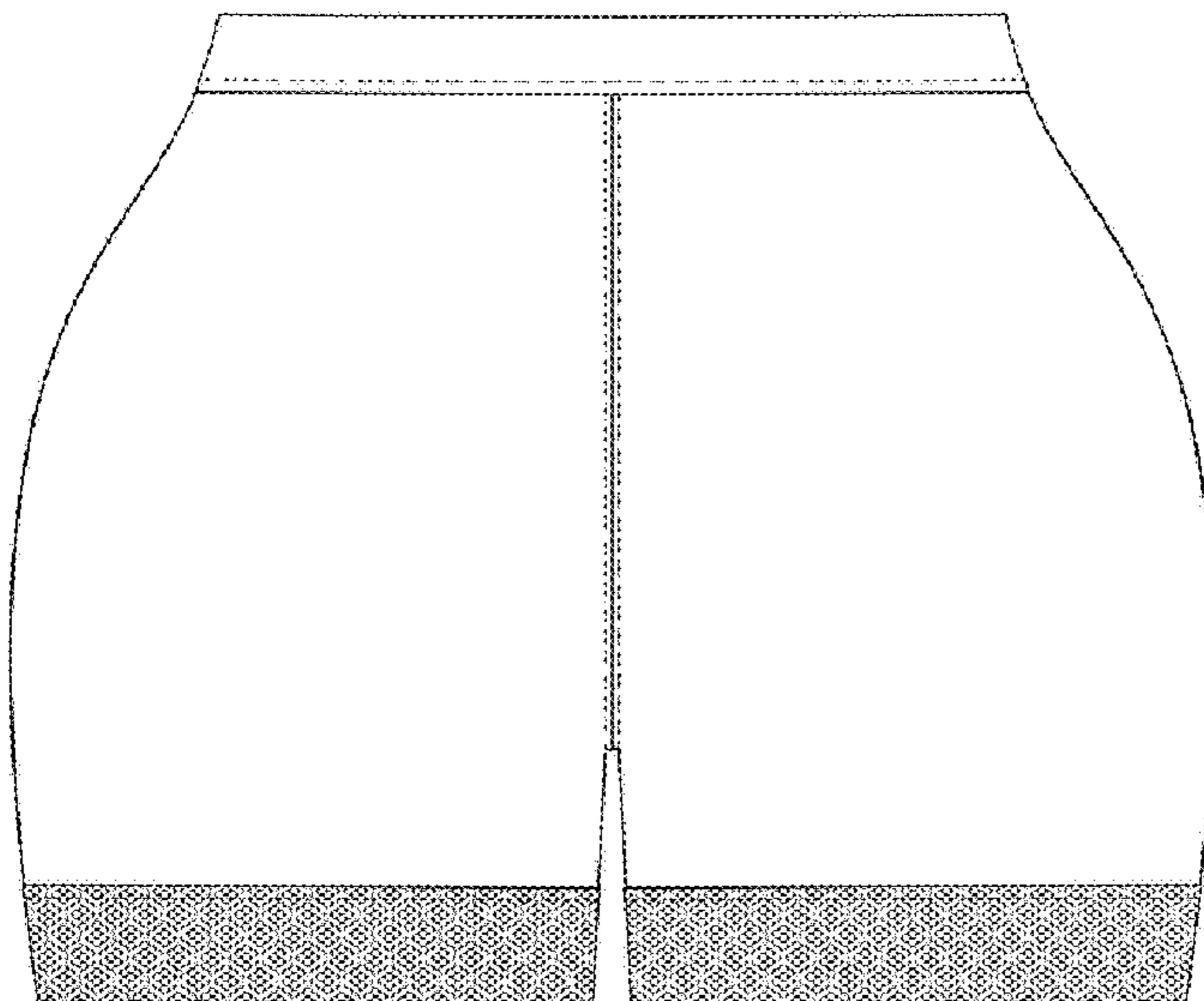
(57) **CLAIM**

The ornamental design for a buttocks shaper garment, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a buttocks shaper garment, showing the new design;

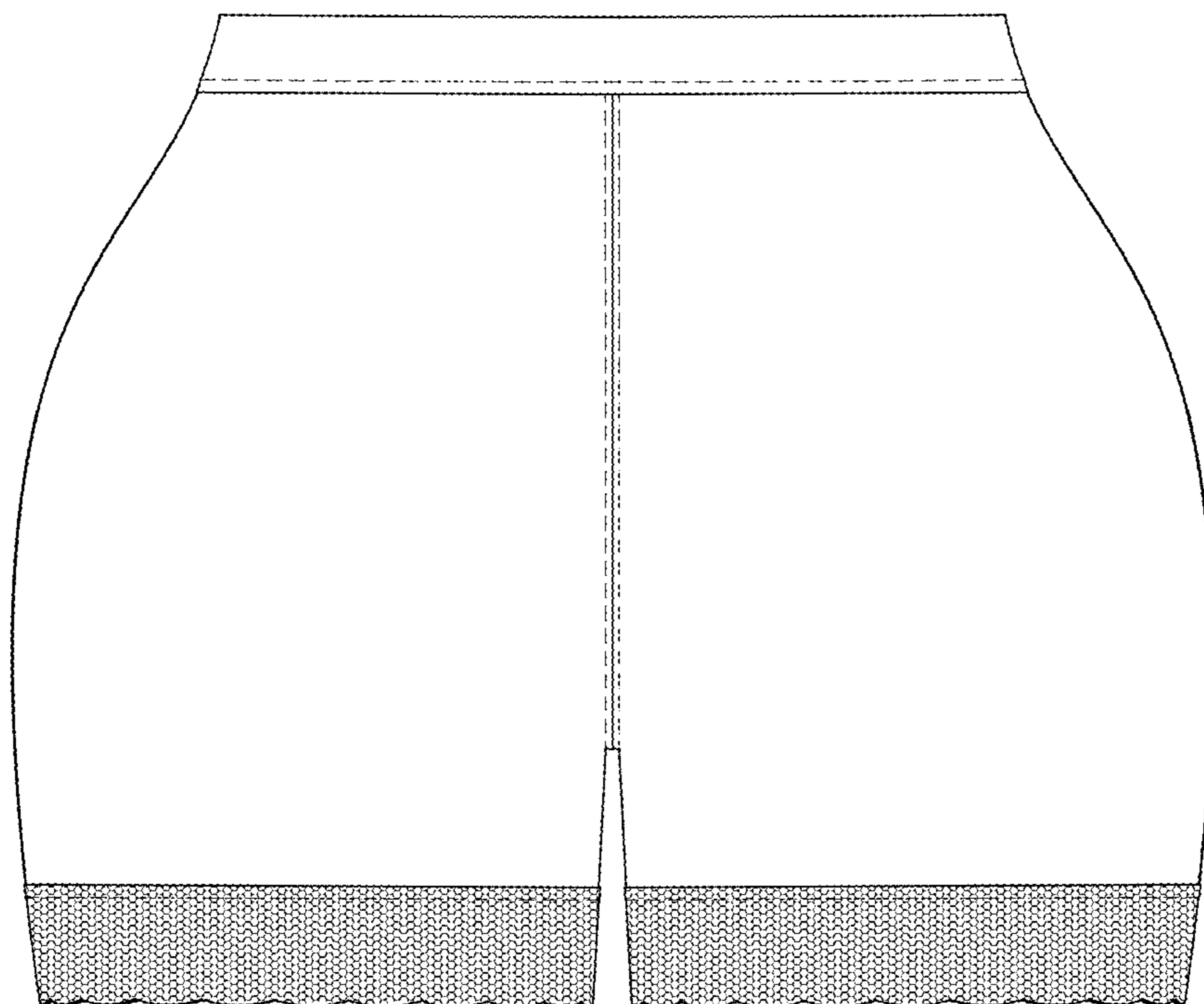

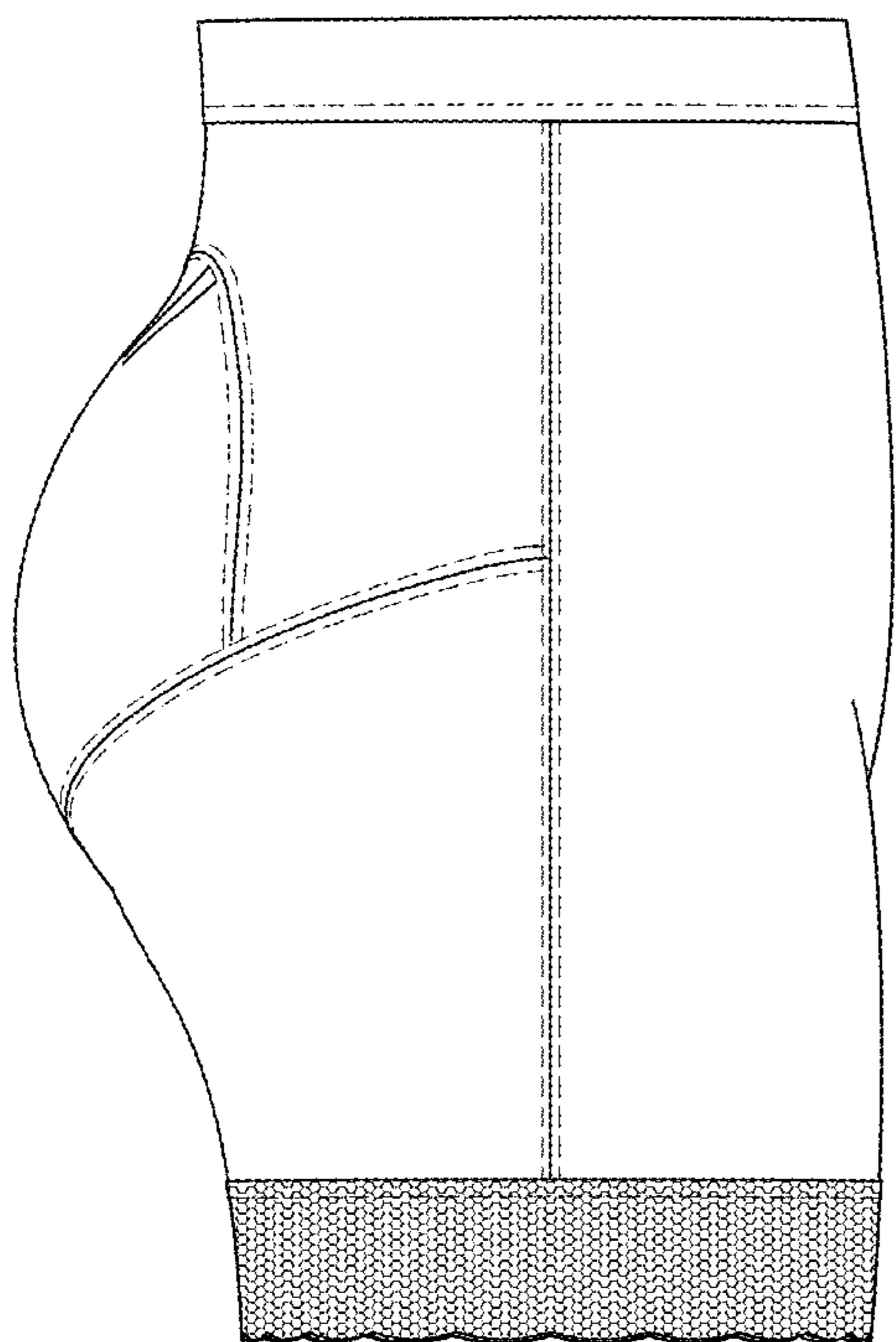

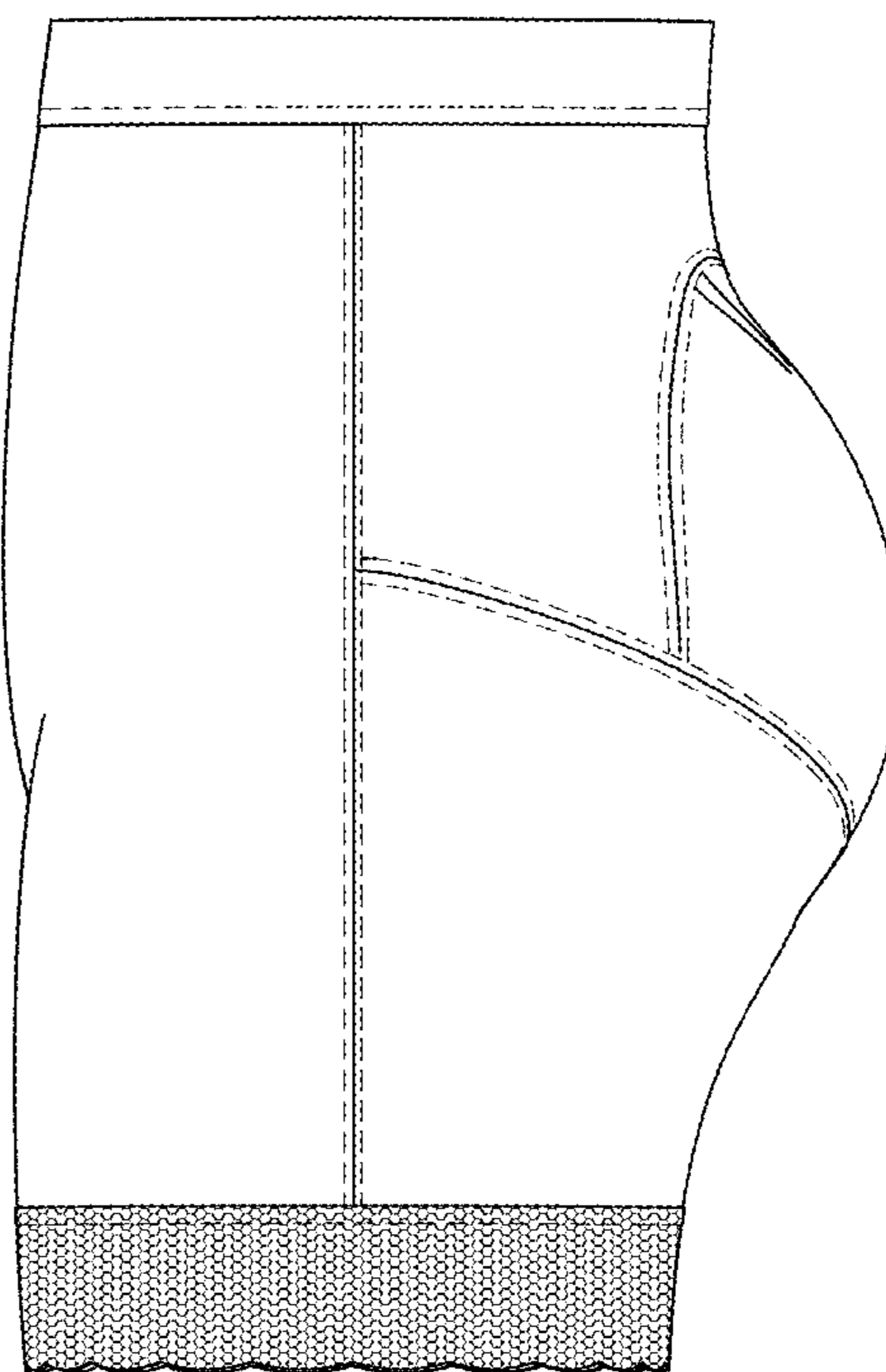

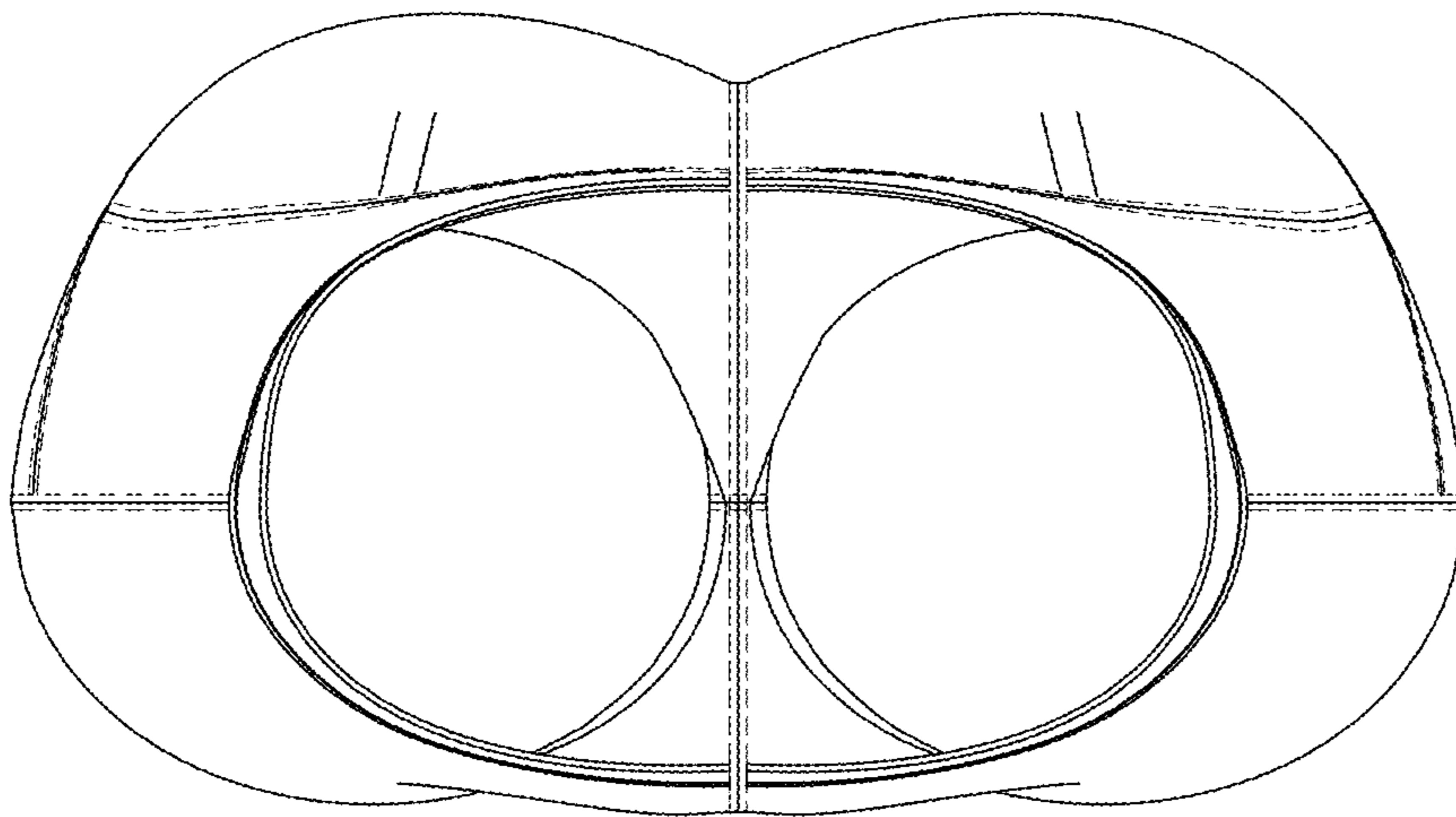

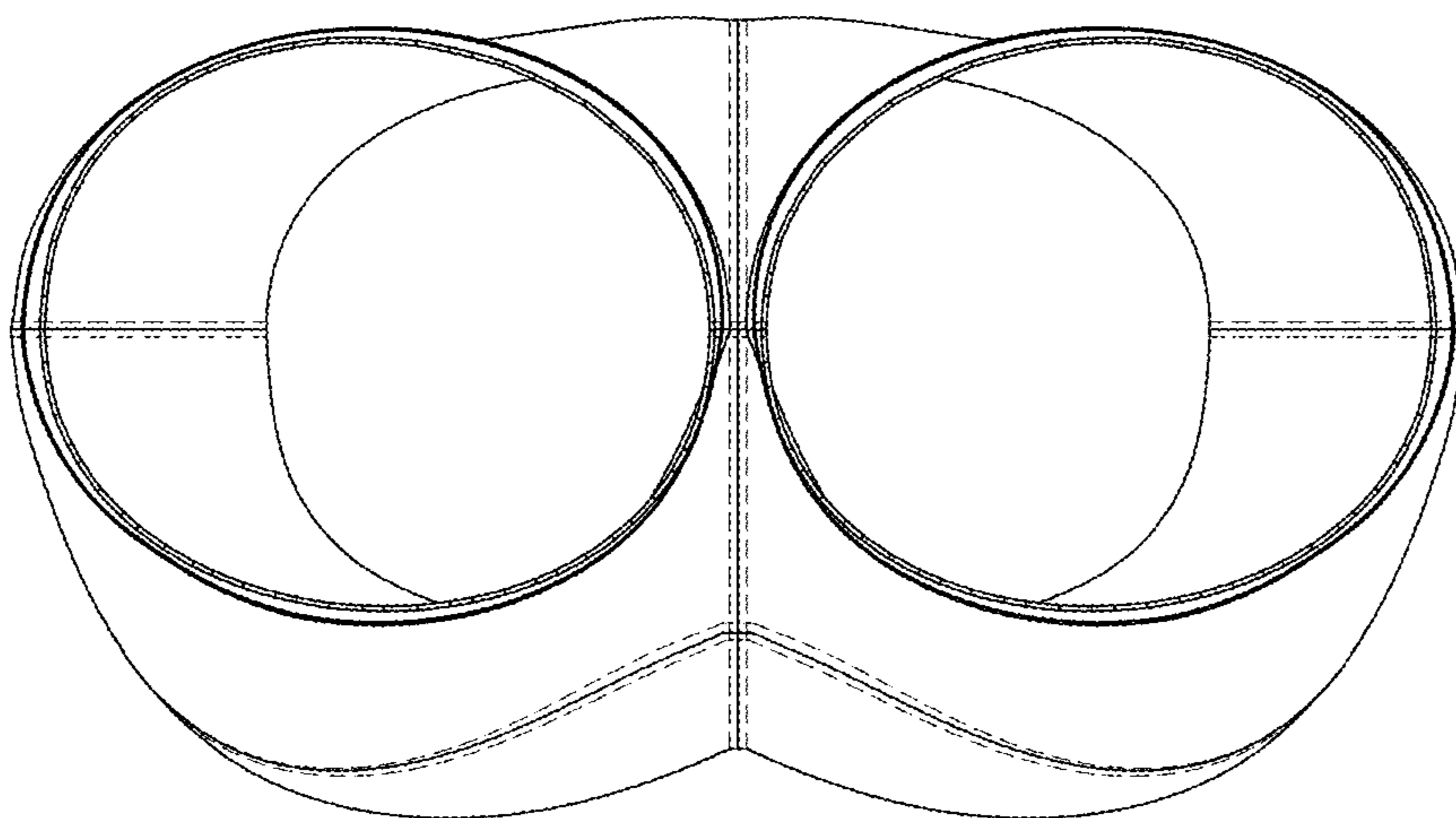

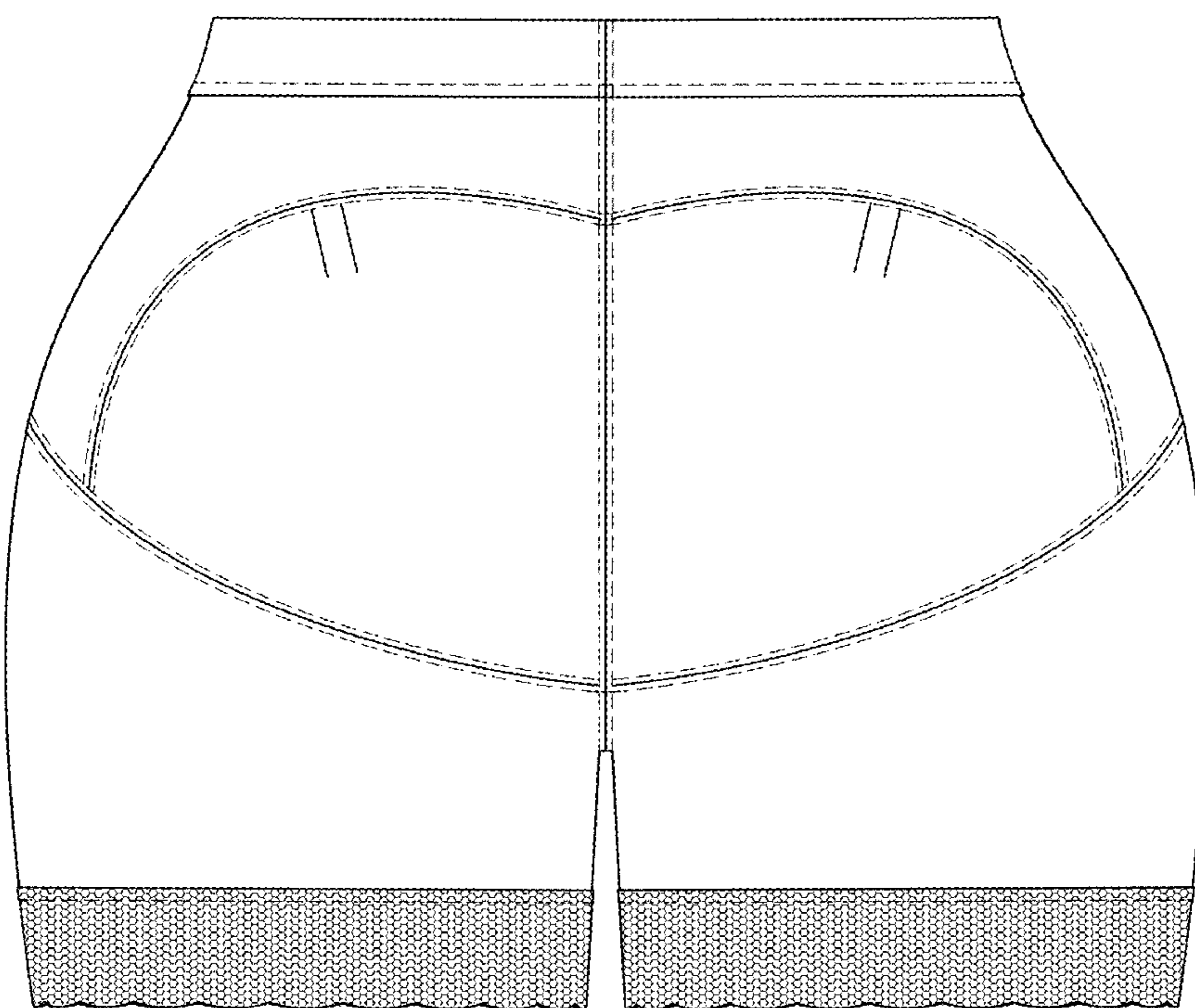

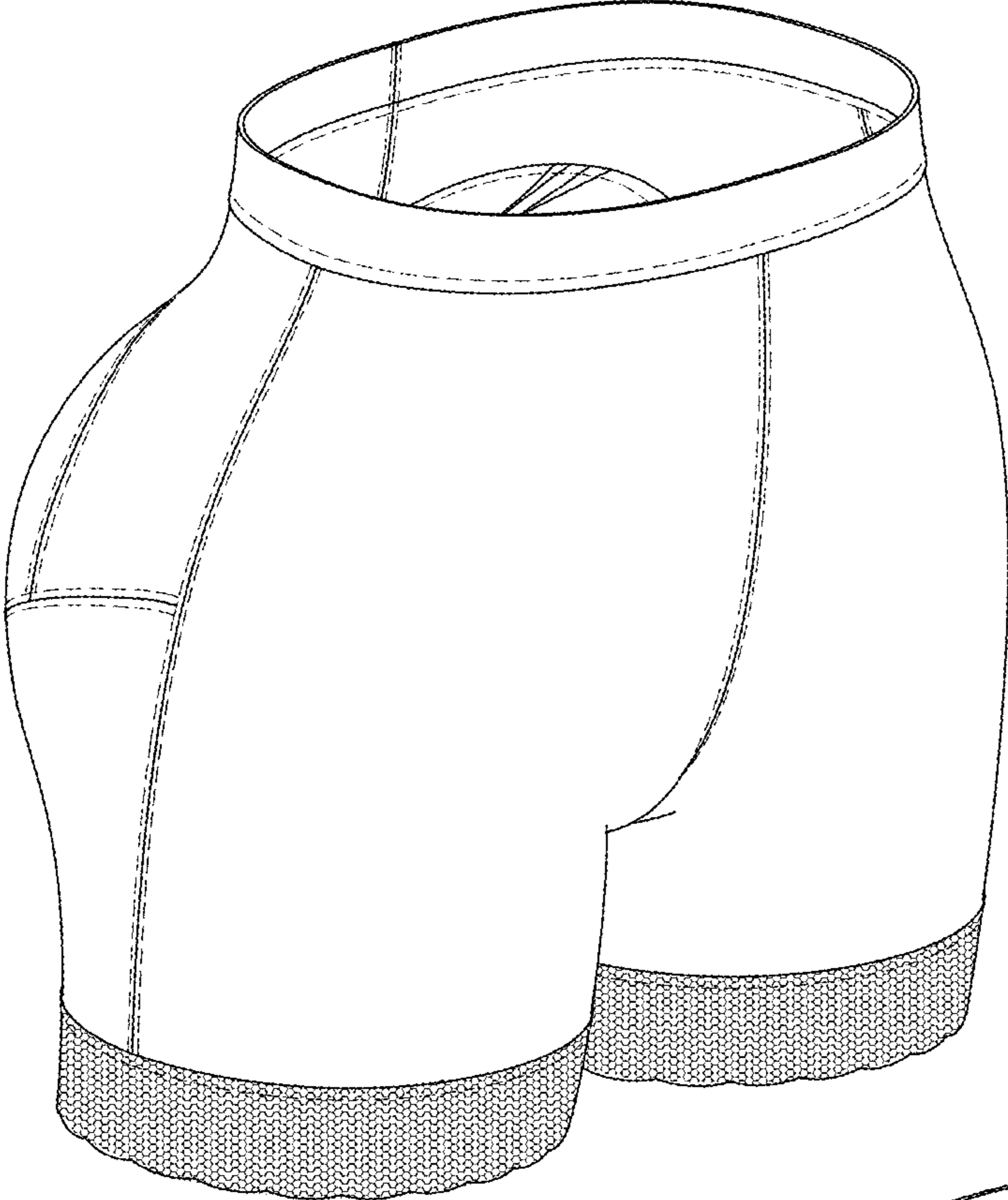

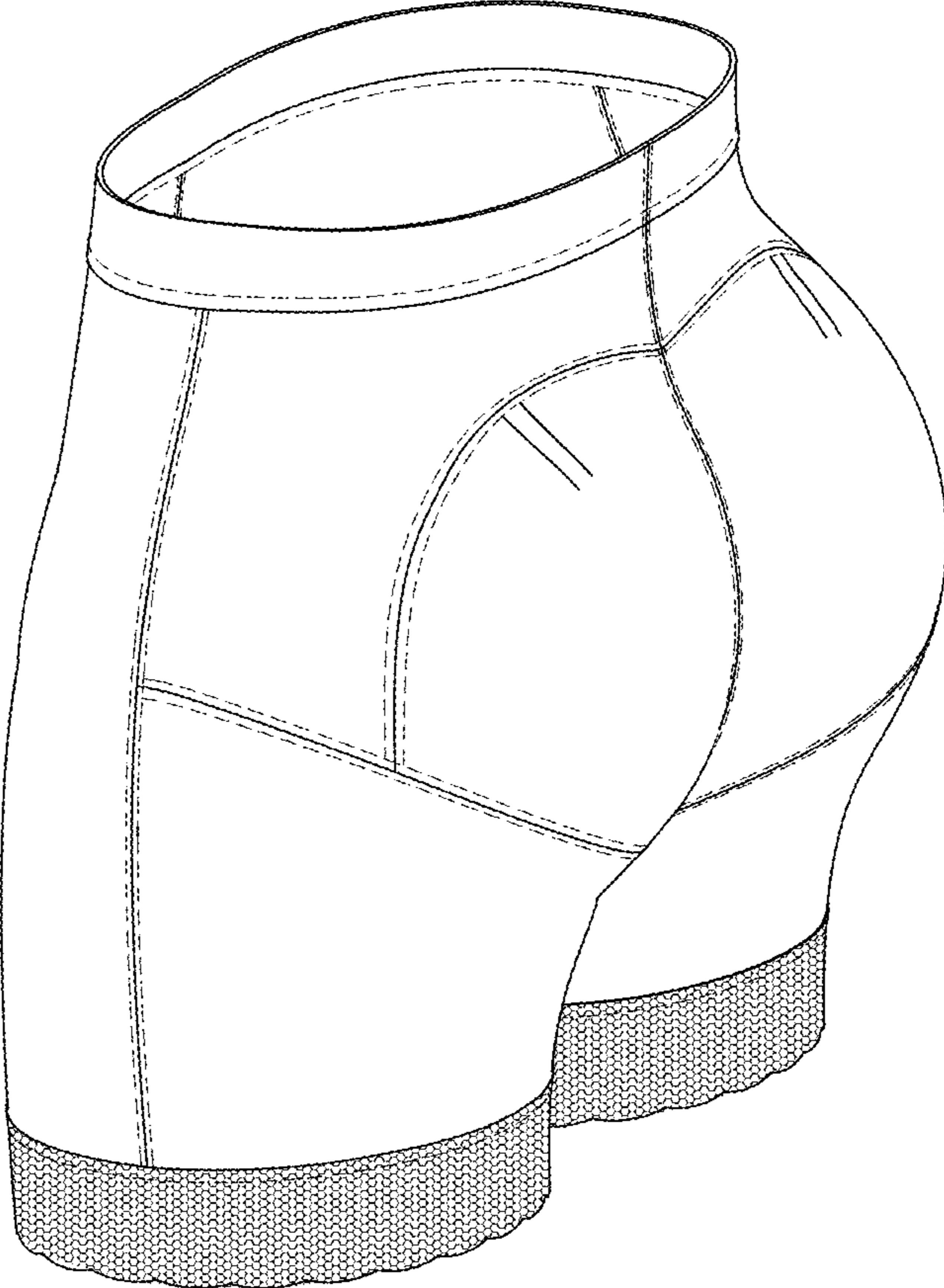
