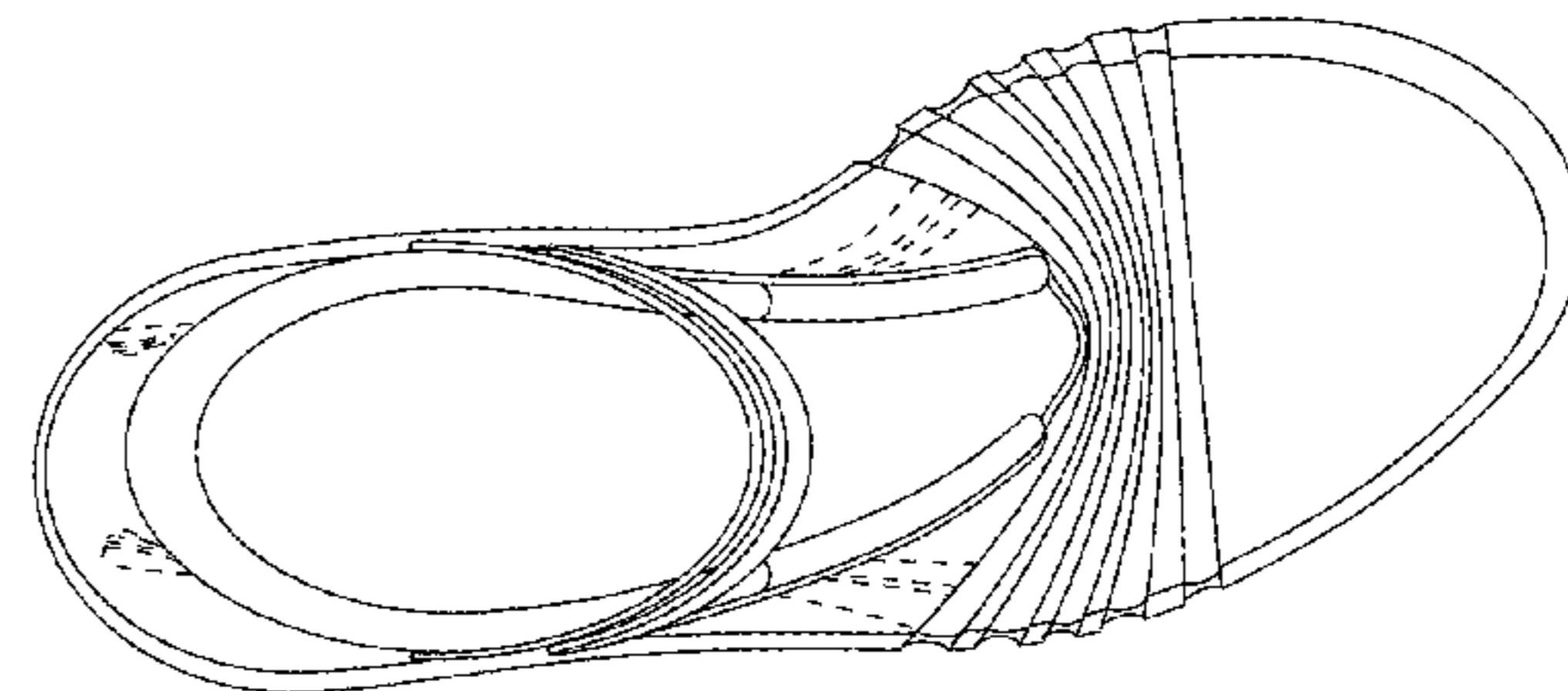
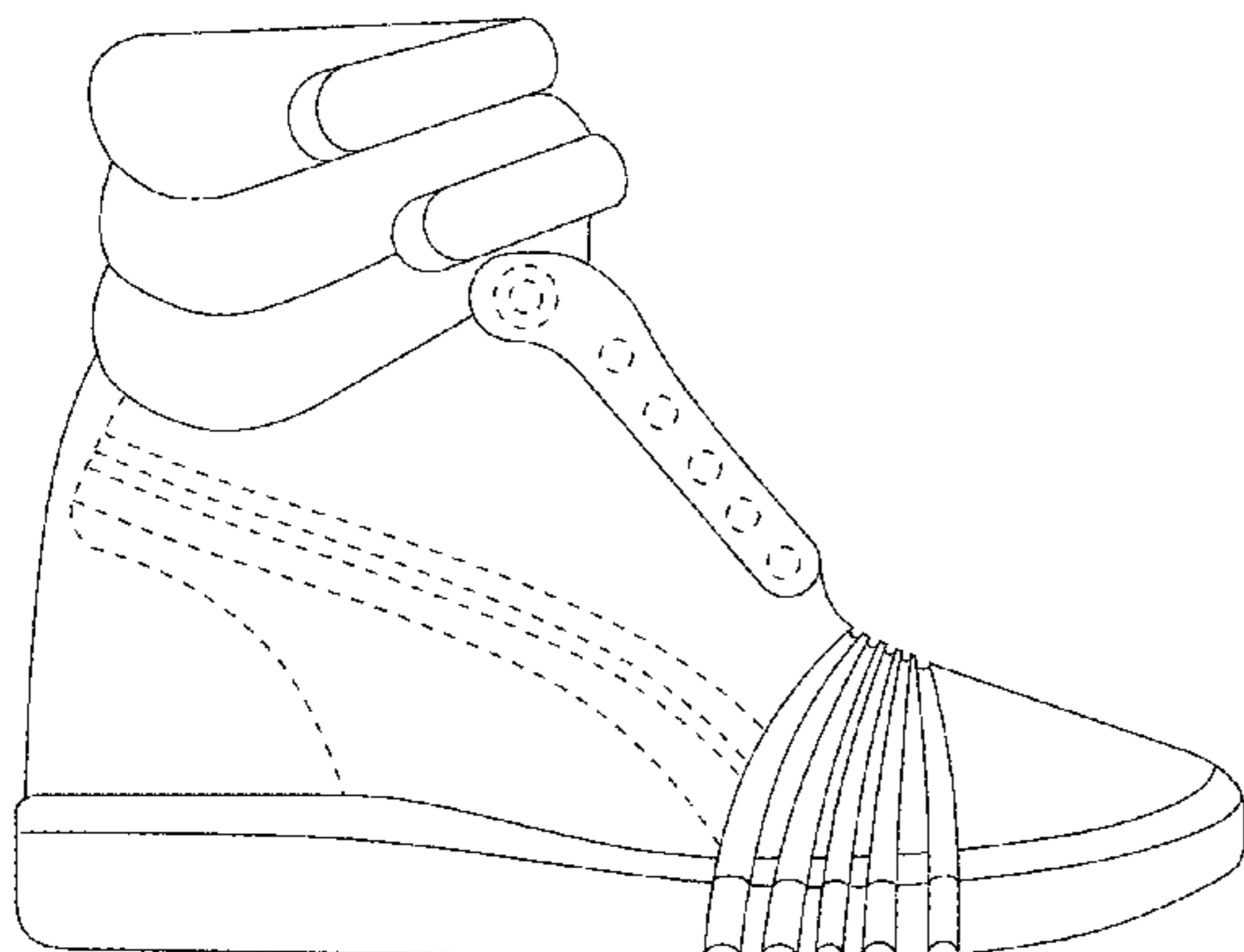
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a right-side, elevation view of the sport shoe, showing my new design;  
FIG. 2 is a left-side elevation view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.

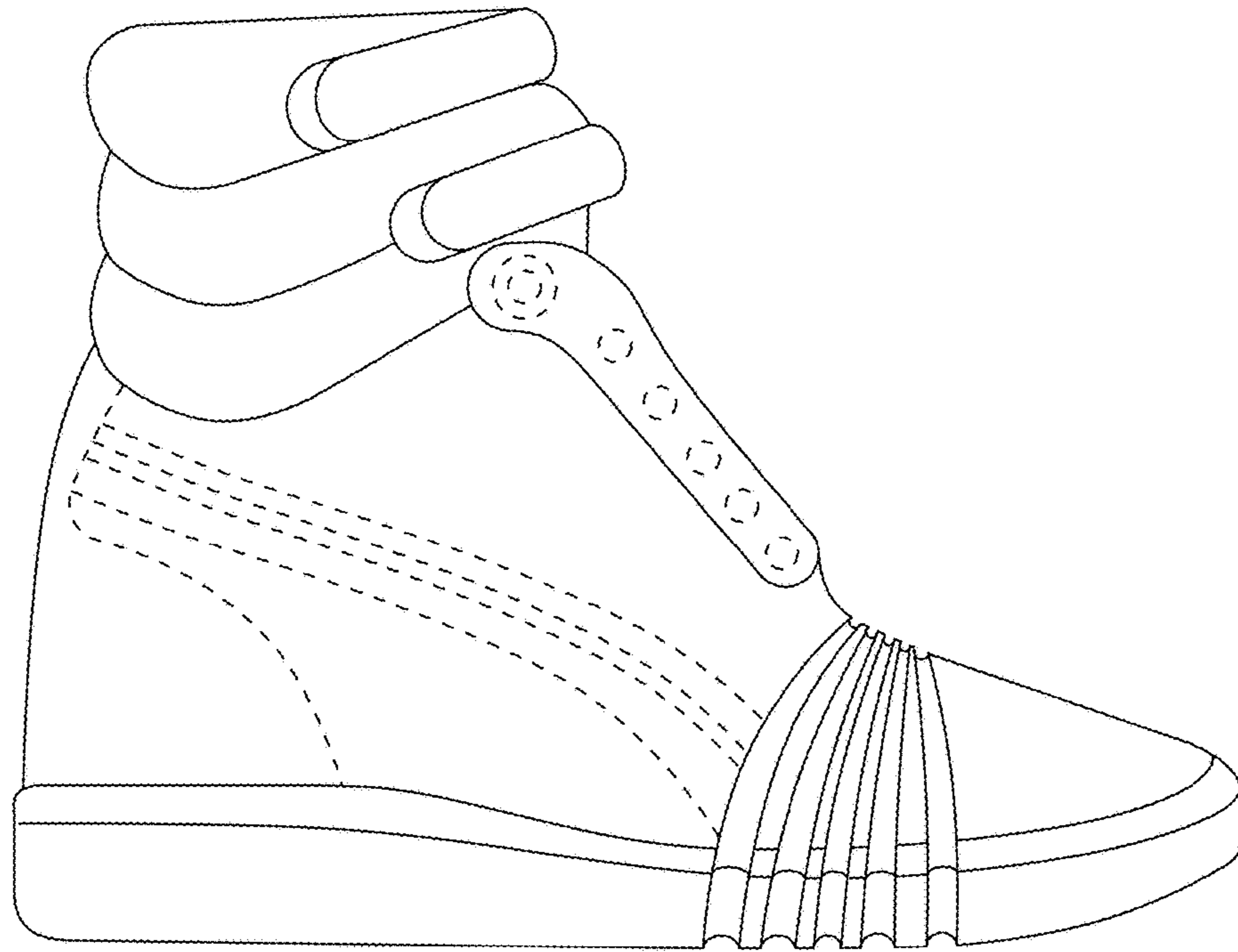

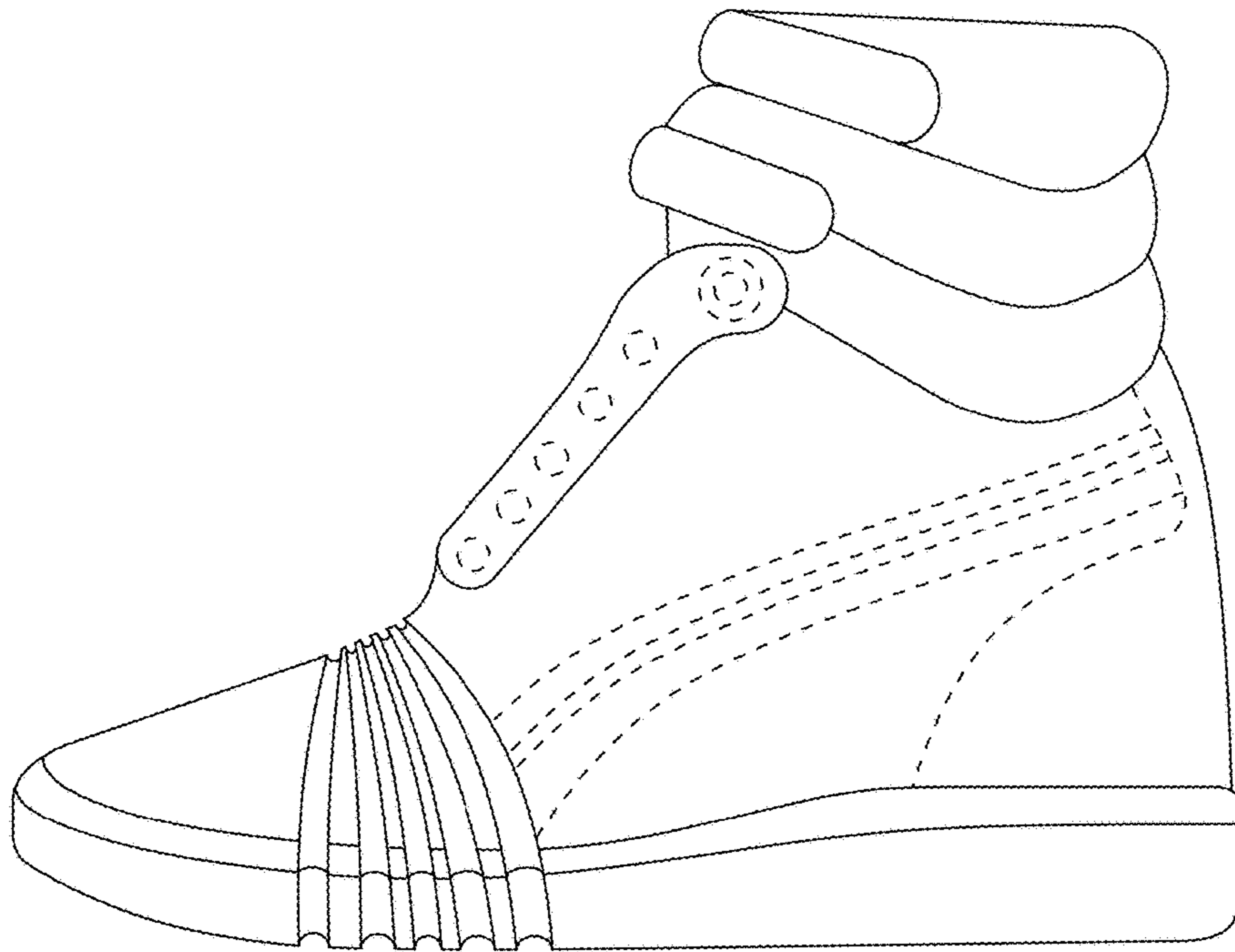

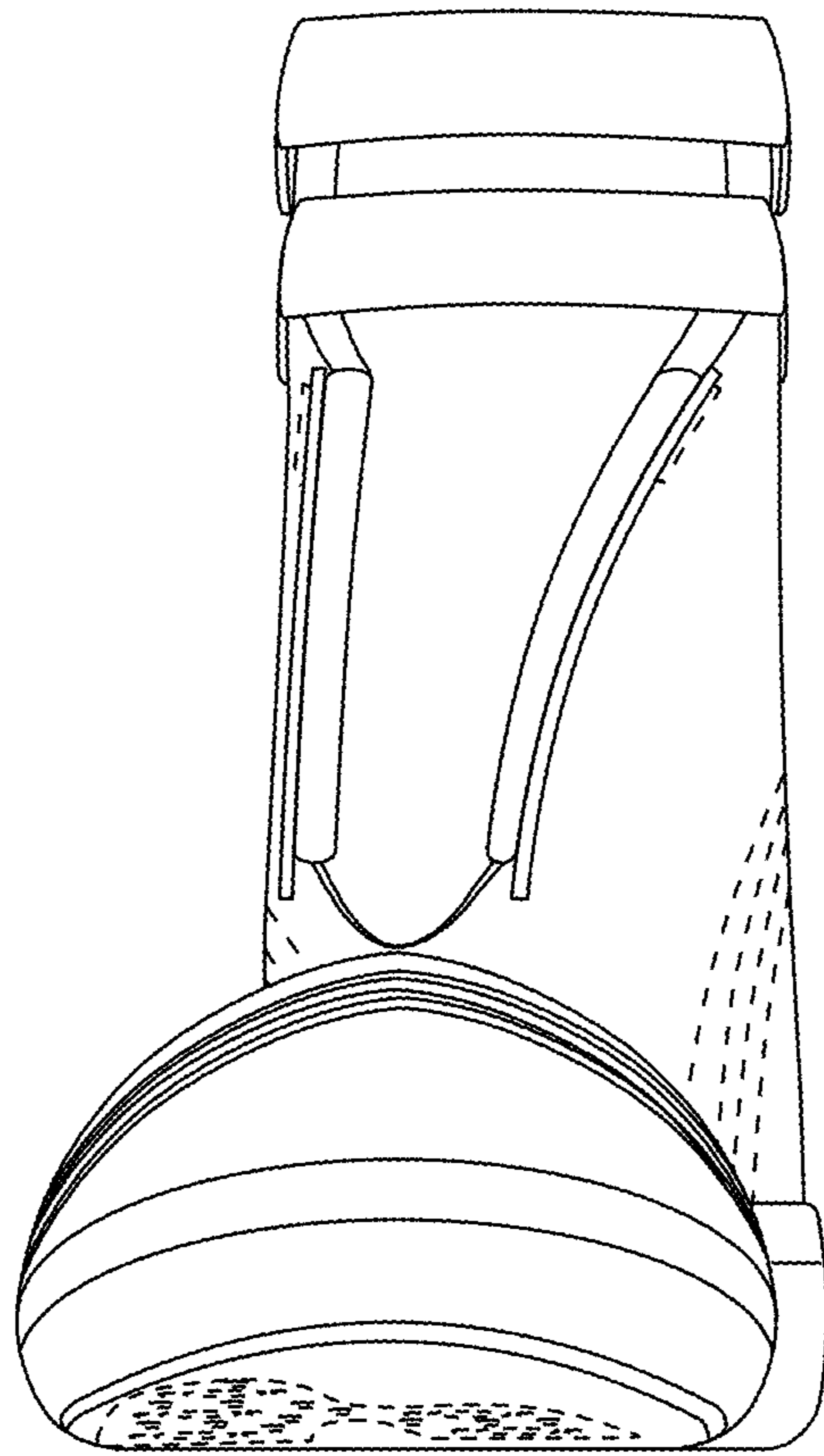

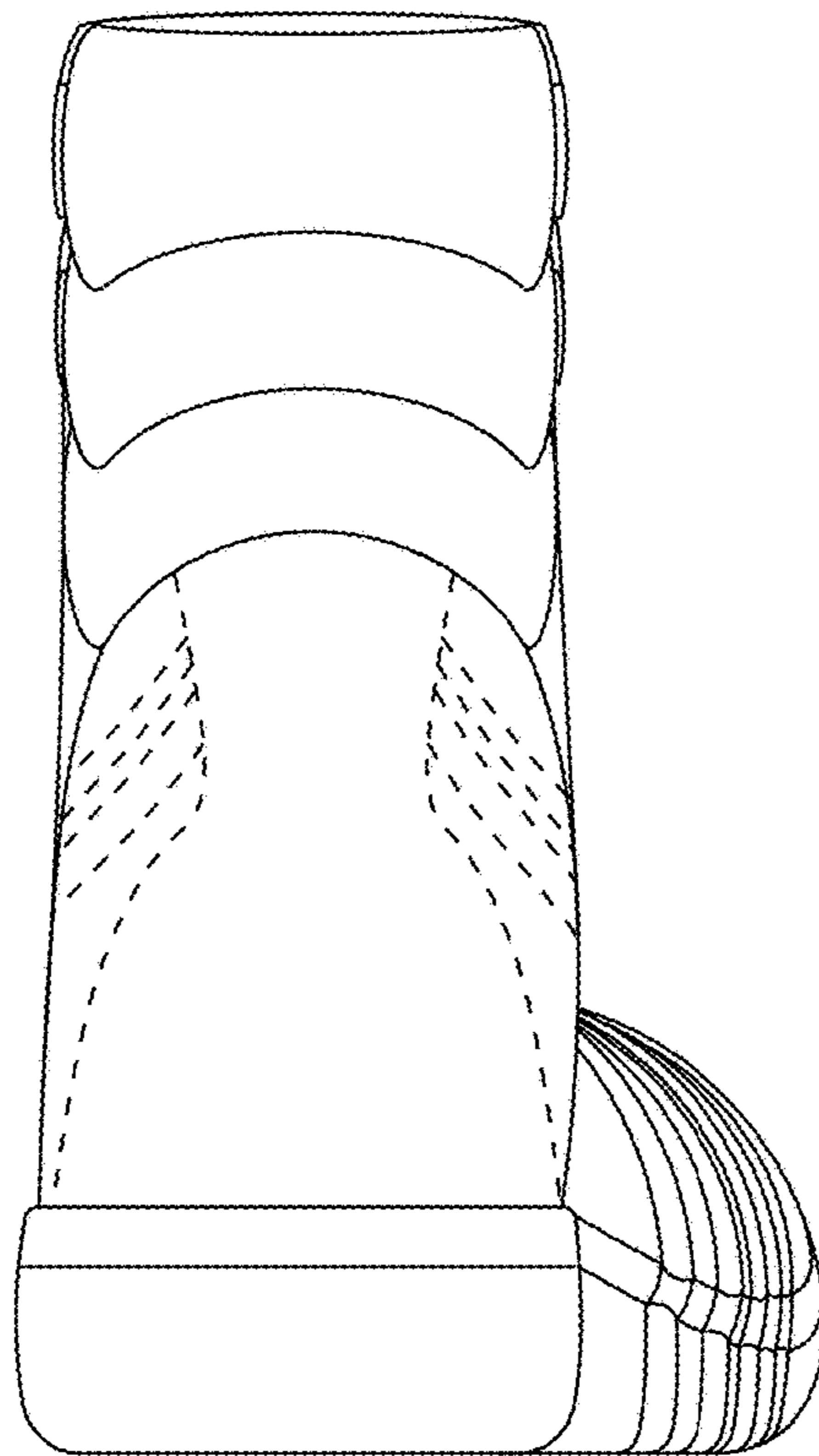

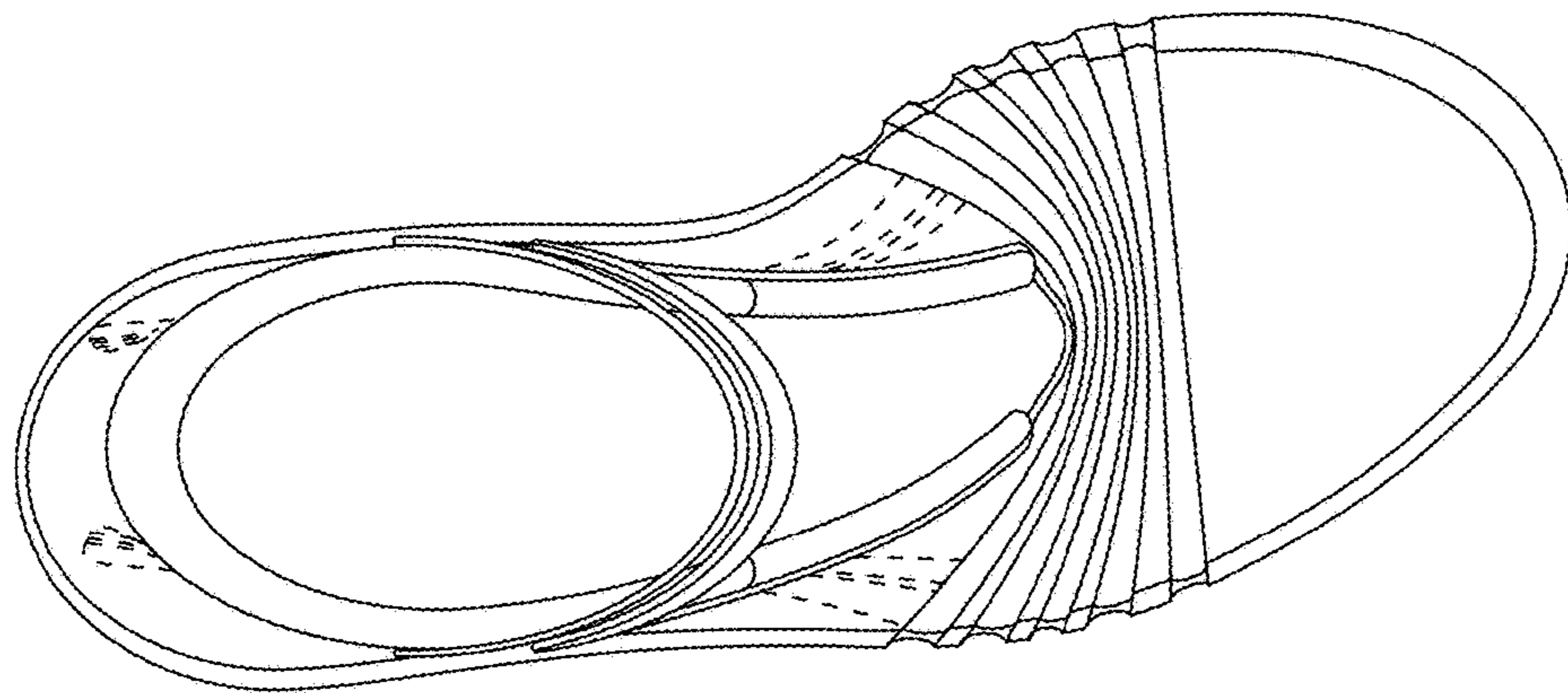

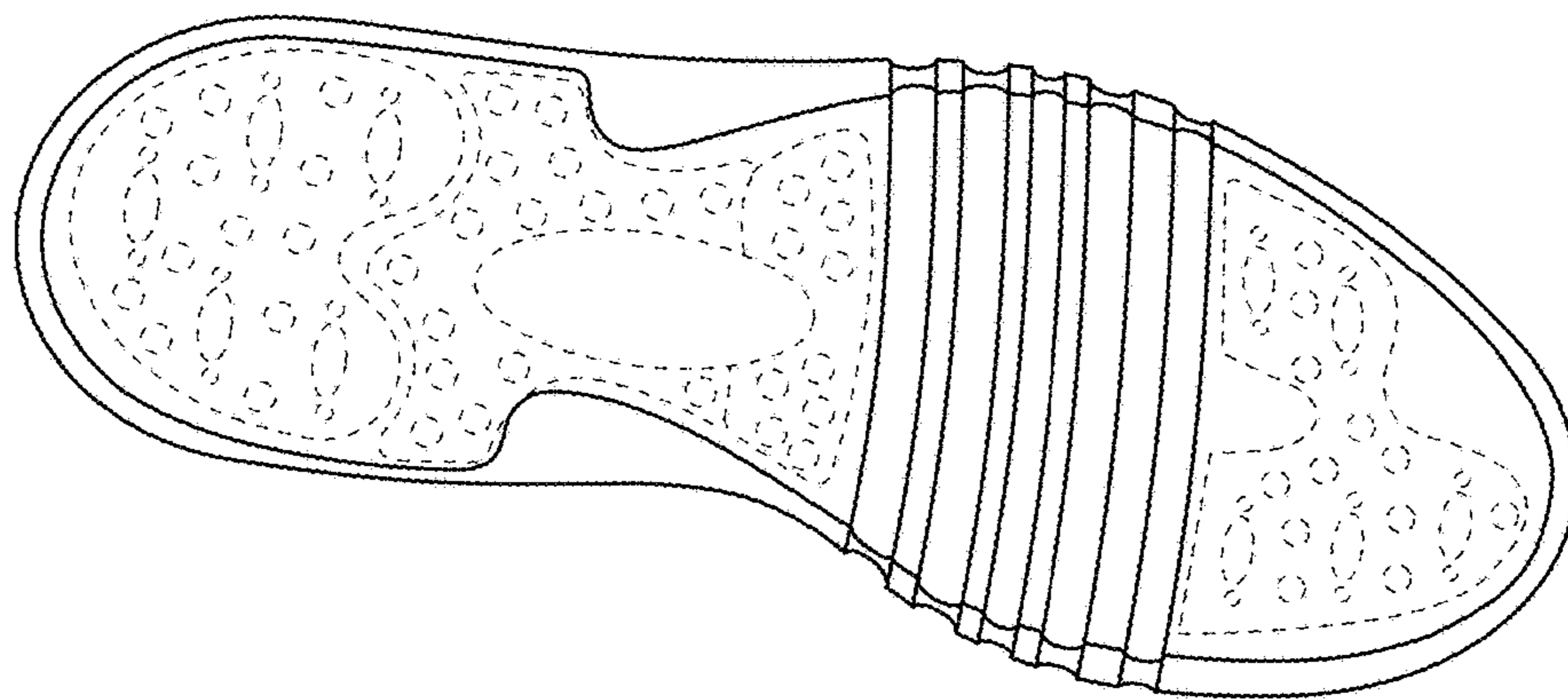
