(57) **CLAIM**

I claim the ornamental design for a medical shoe sole for children, as shown and described.

DESCRIPTION

FIG. 1 is a right medial side view of a medical shoe sole for children showing my new design.

FIG. 2 is a bottom view thereof.

FIG. 3 is a left lateral side view thereof.

FIG. 4 is a cross sectional view taken along the section line marked 4-4 in FIG. 2 of the sole as seen from the left lateral side.

FIG. 5 is a top view thereof.

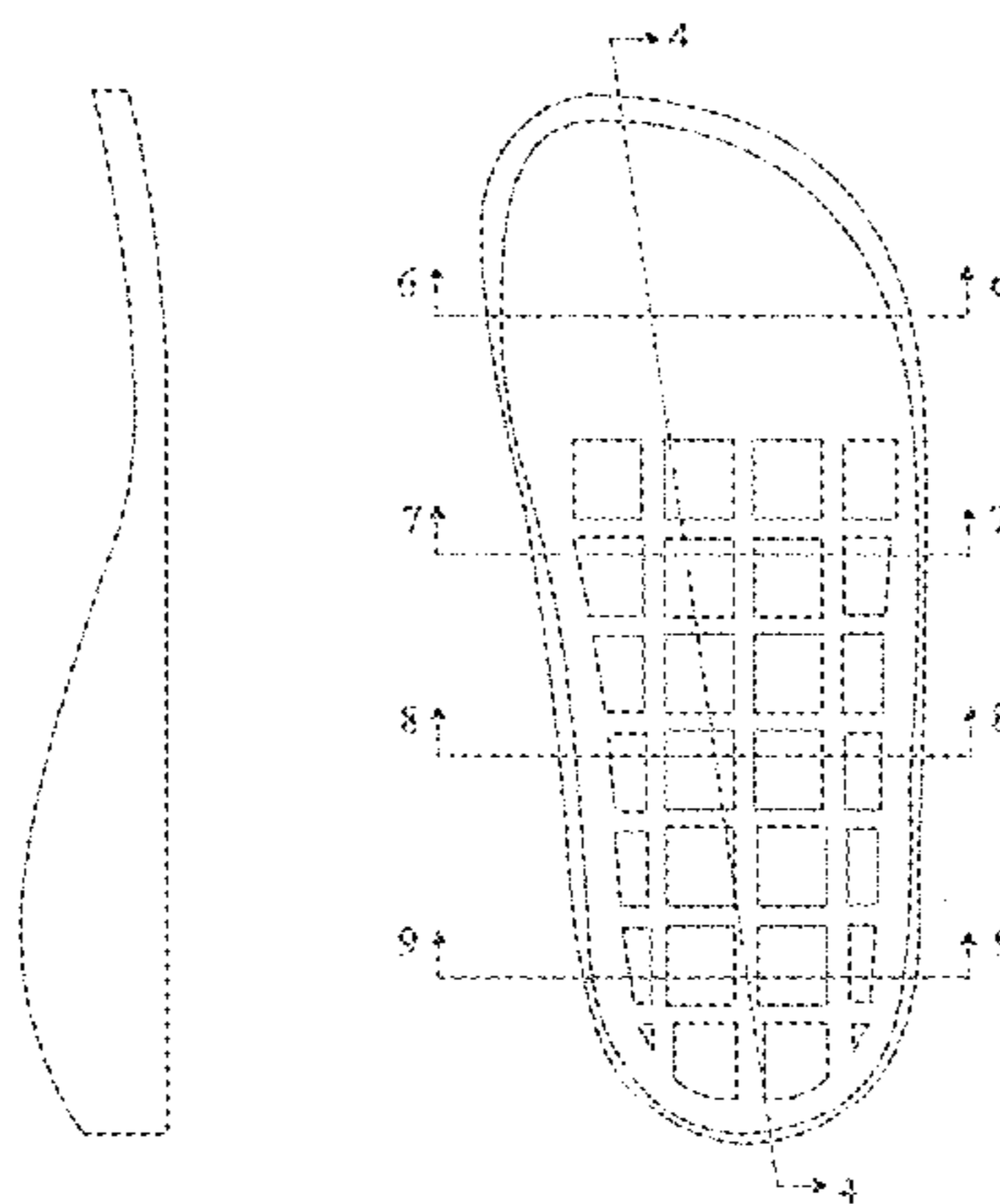
FIG. 6 is a cross sectional view taken along the section marked 6-6 in FIG. 2 at the level of the toes.

FIG. 7 is a cross sectional view taken along the section marked 7-7 in FIG. 2 at the level of metatarsal base.

FIG. 8 is a cross sectional view taken along the section marked 8-8 in FIG. 2 at the level of sub-talar joint; and,

FIG. 9 is a cross sectional view taken along the section marked 9-9 in FIG. 2 at the mid-heel.

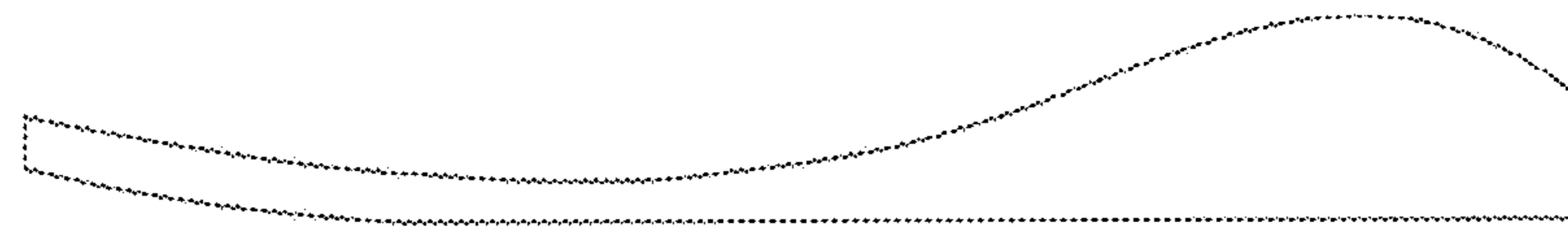

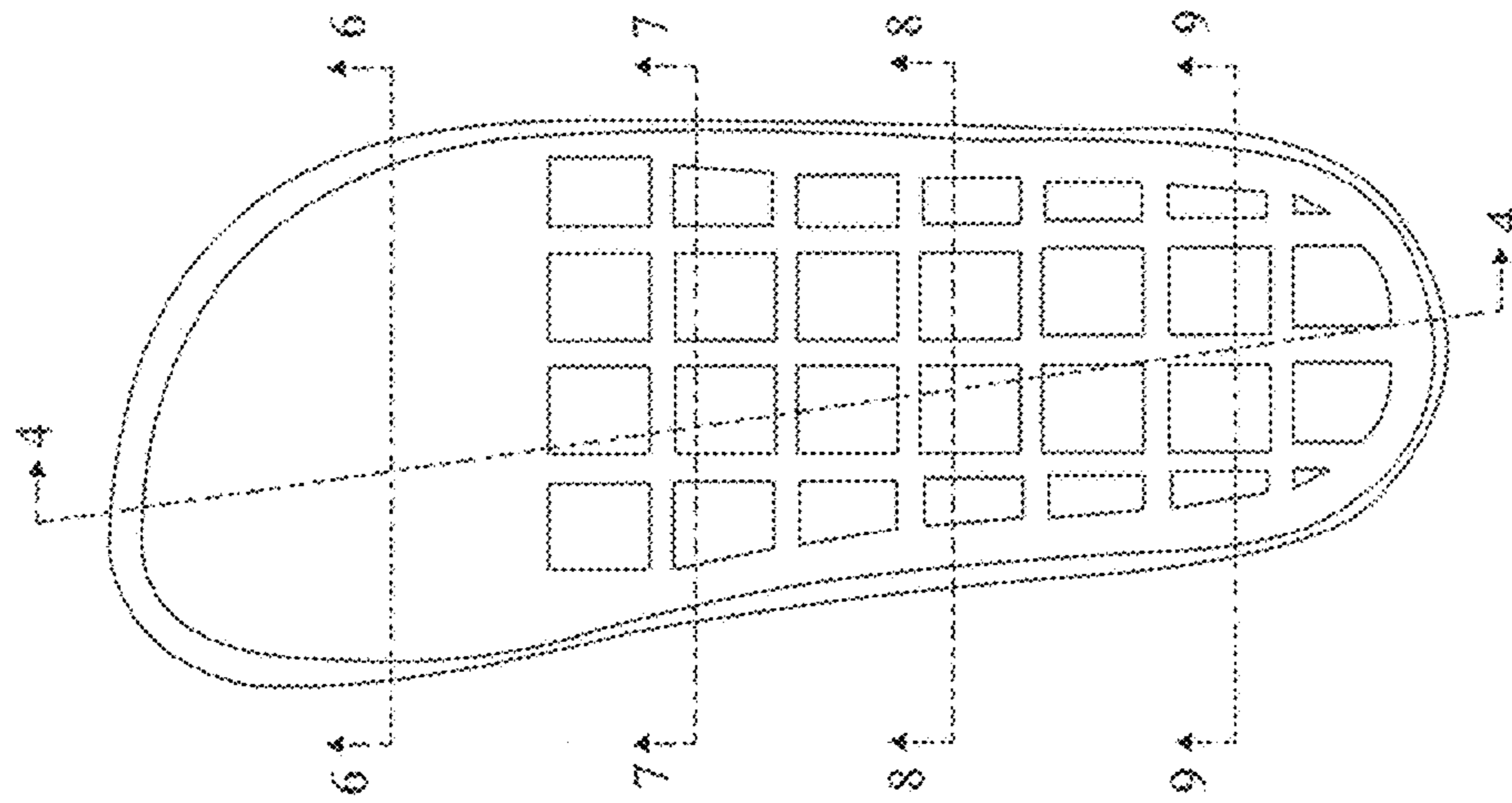

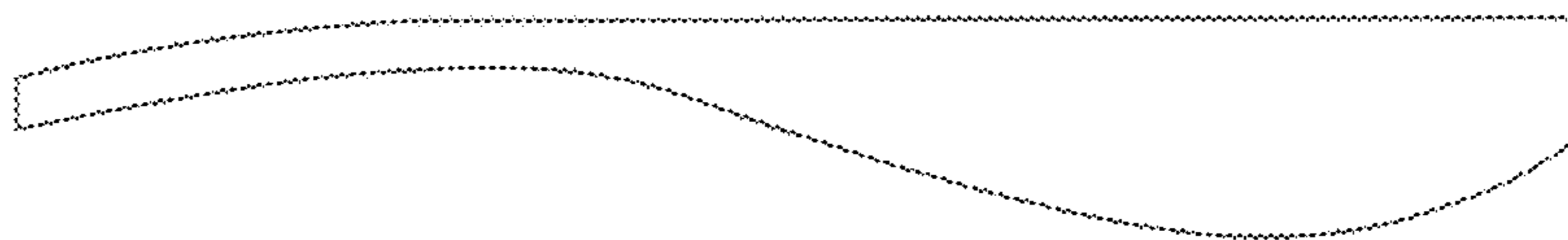

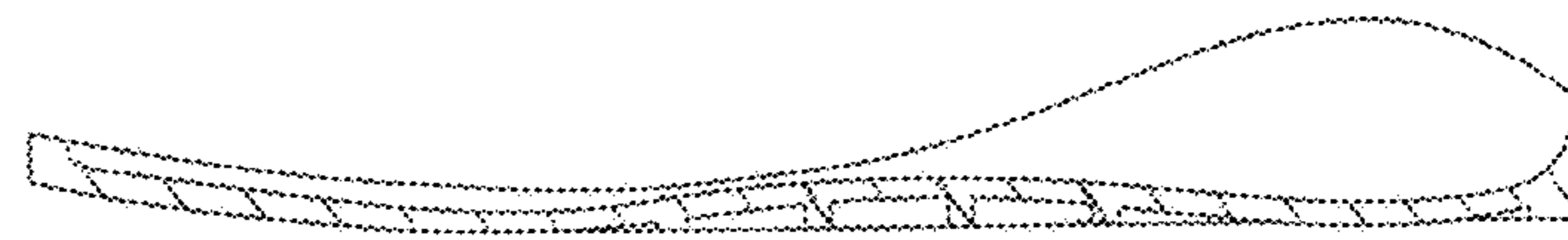

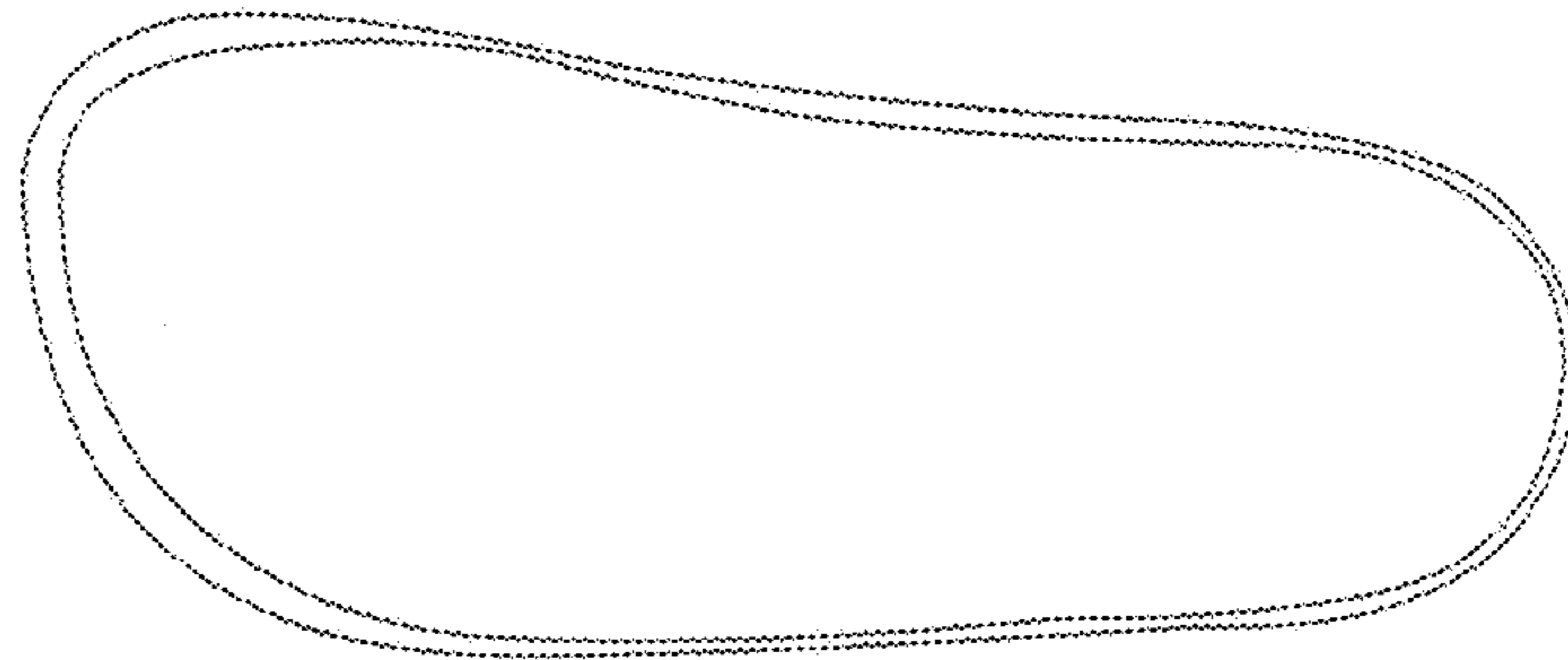
