(57) **CLAIM**

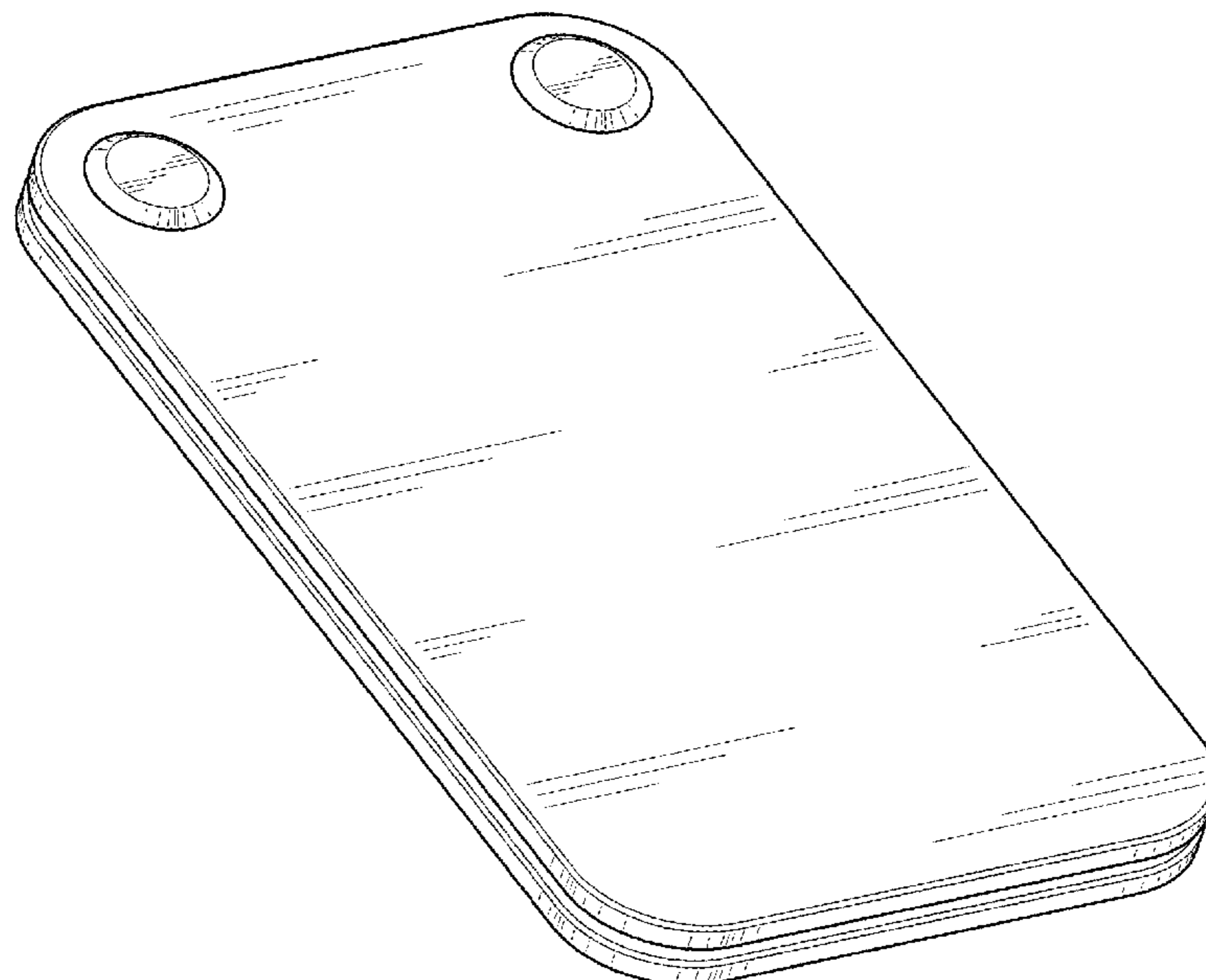
The ornamental design for a magnetic wallet, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the claimed magnetic wallet, embodying the present design;
FIG. 2 is a front side view thereof;

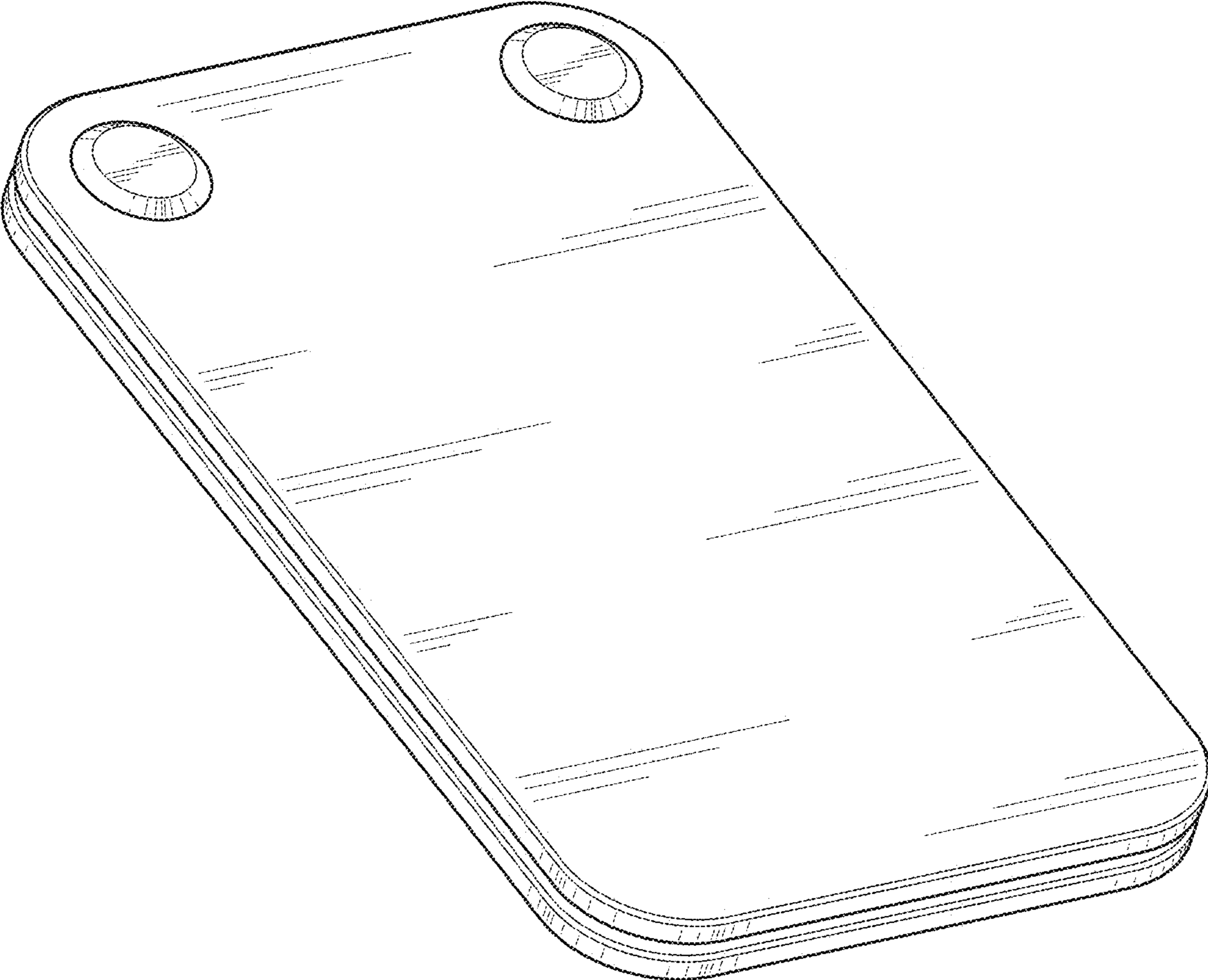

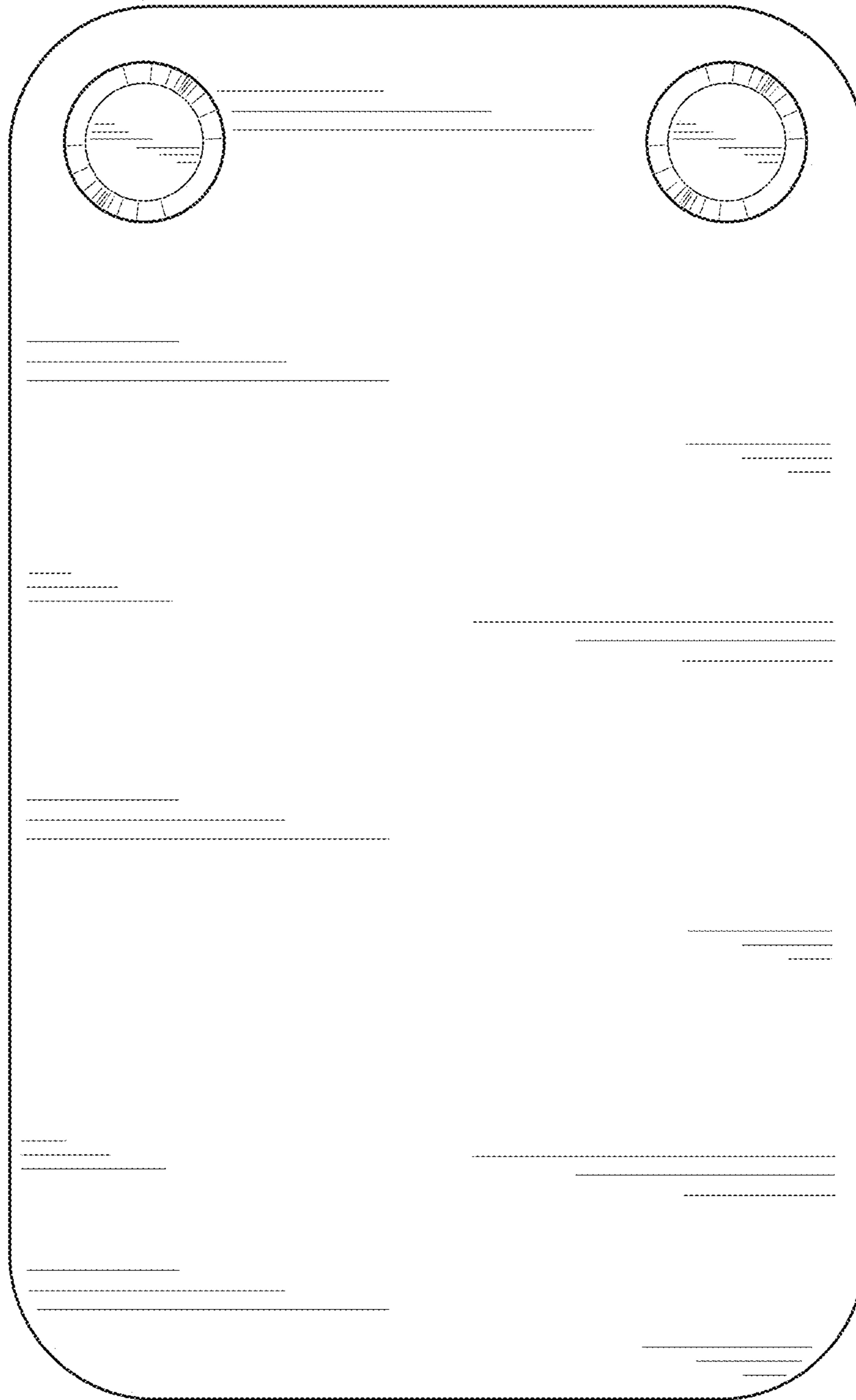

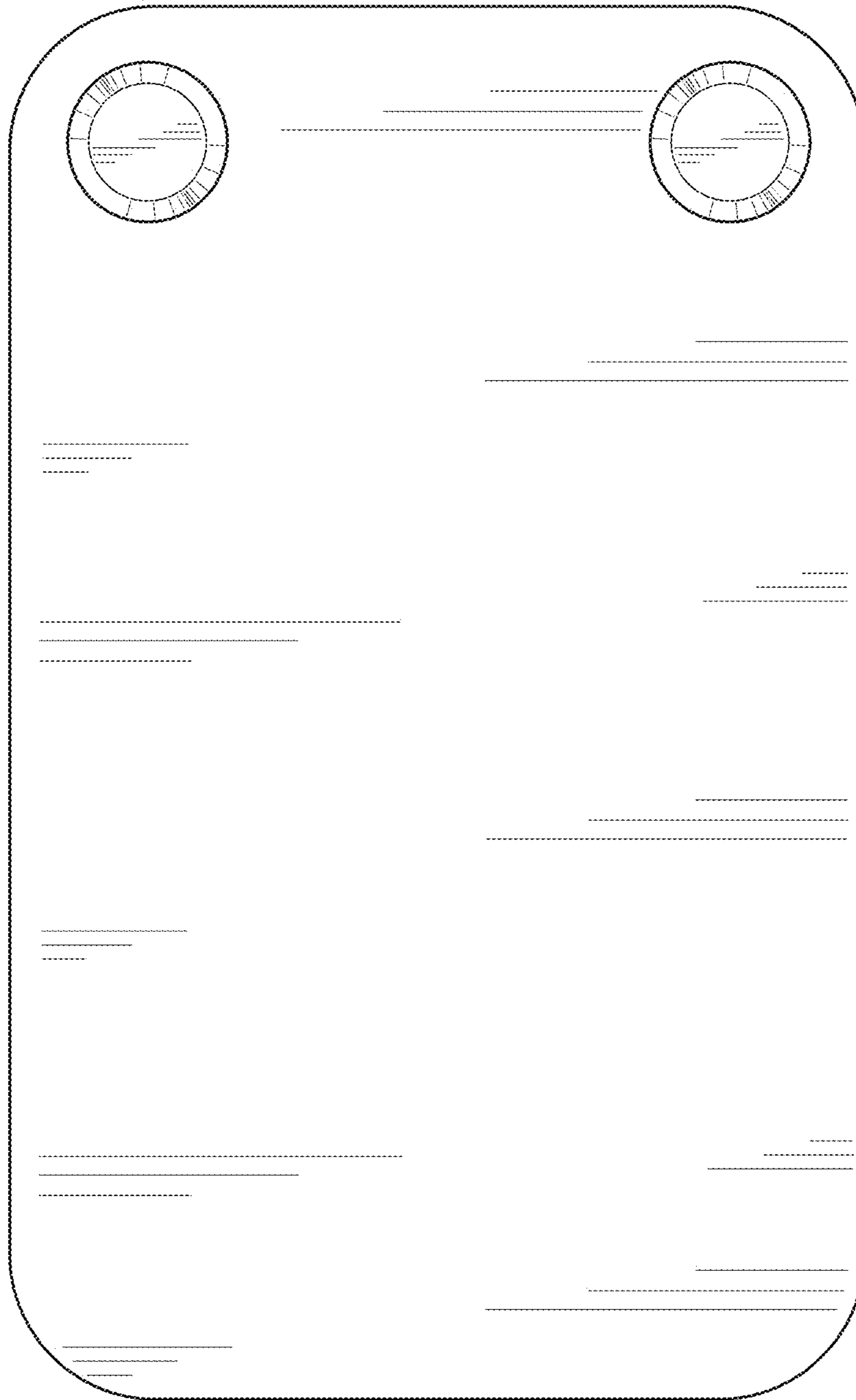

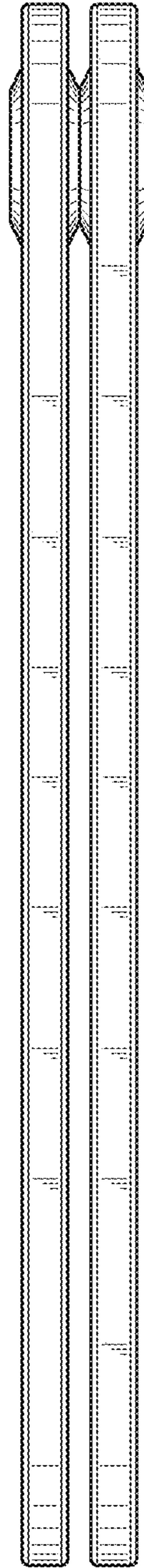

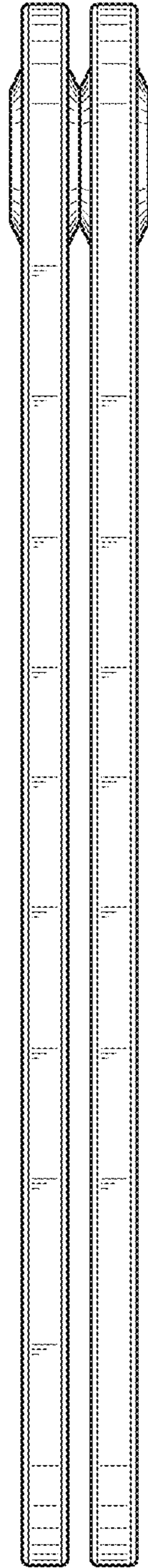

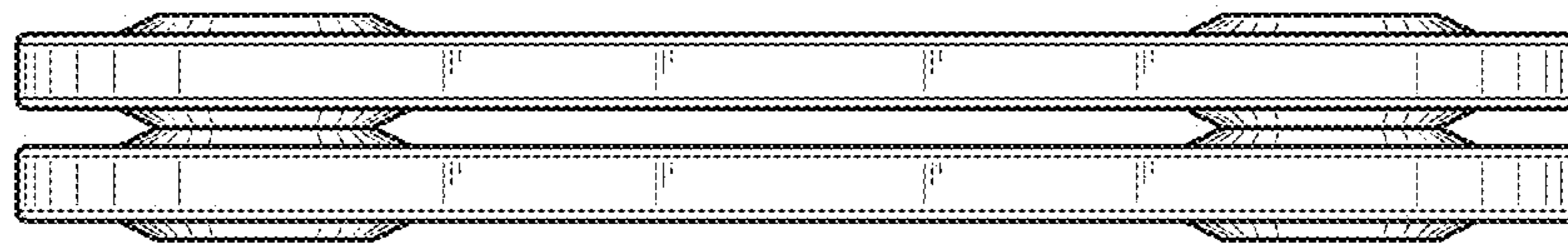

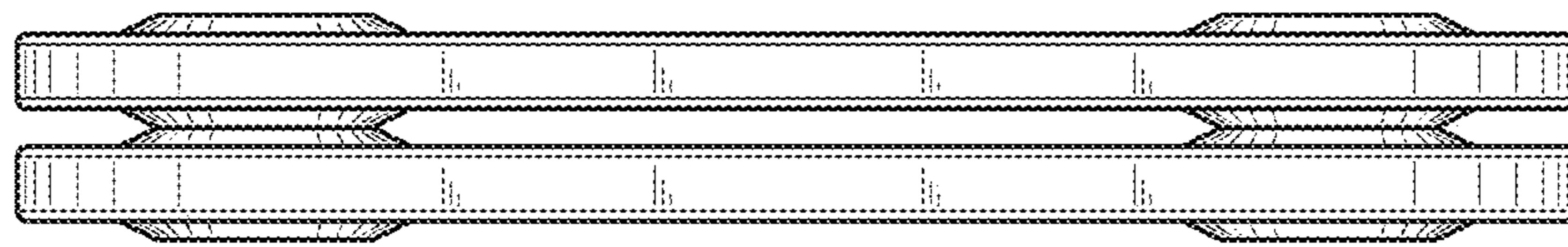

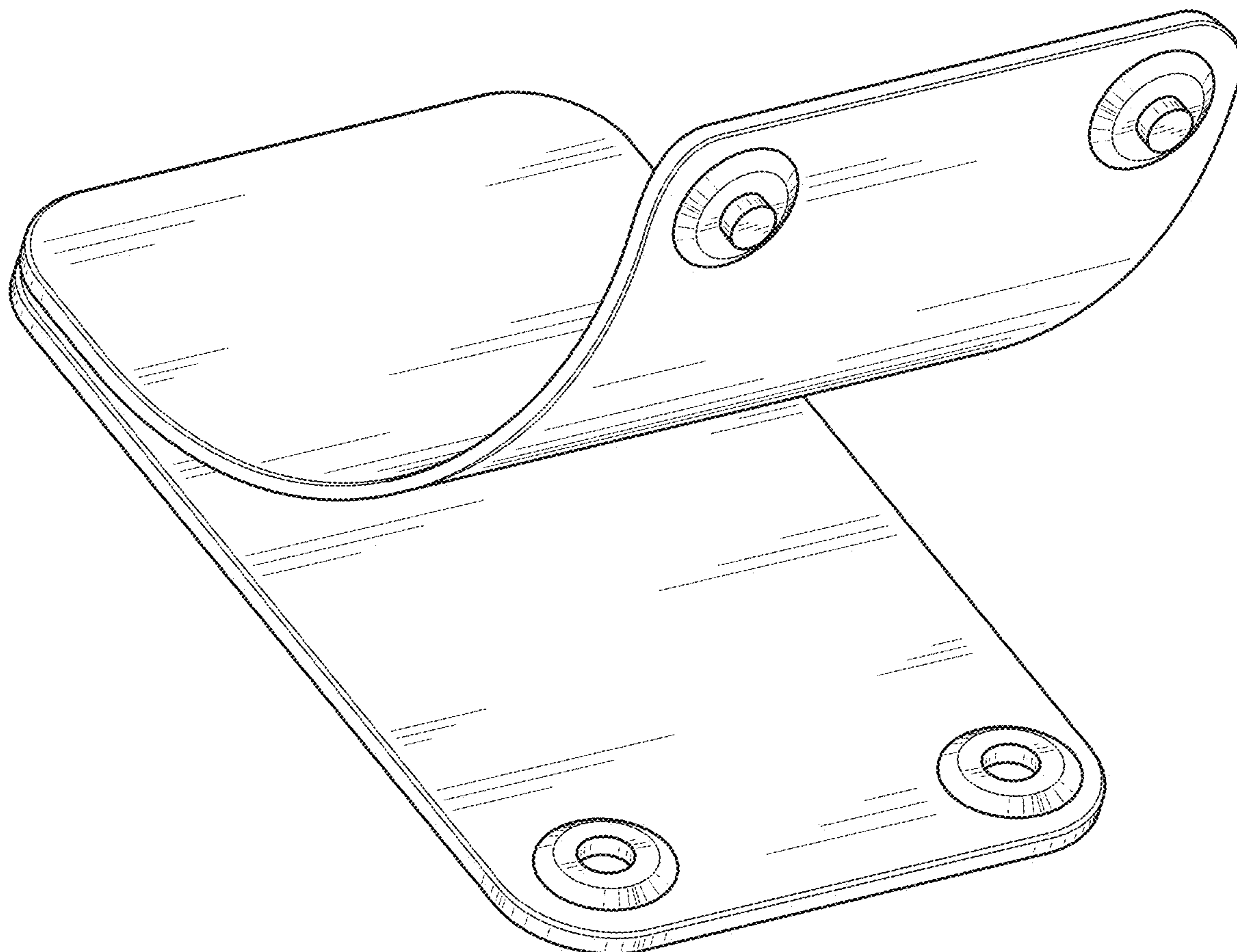
