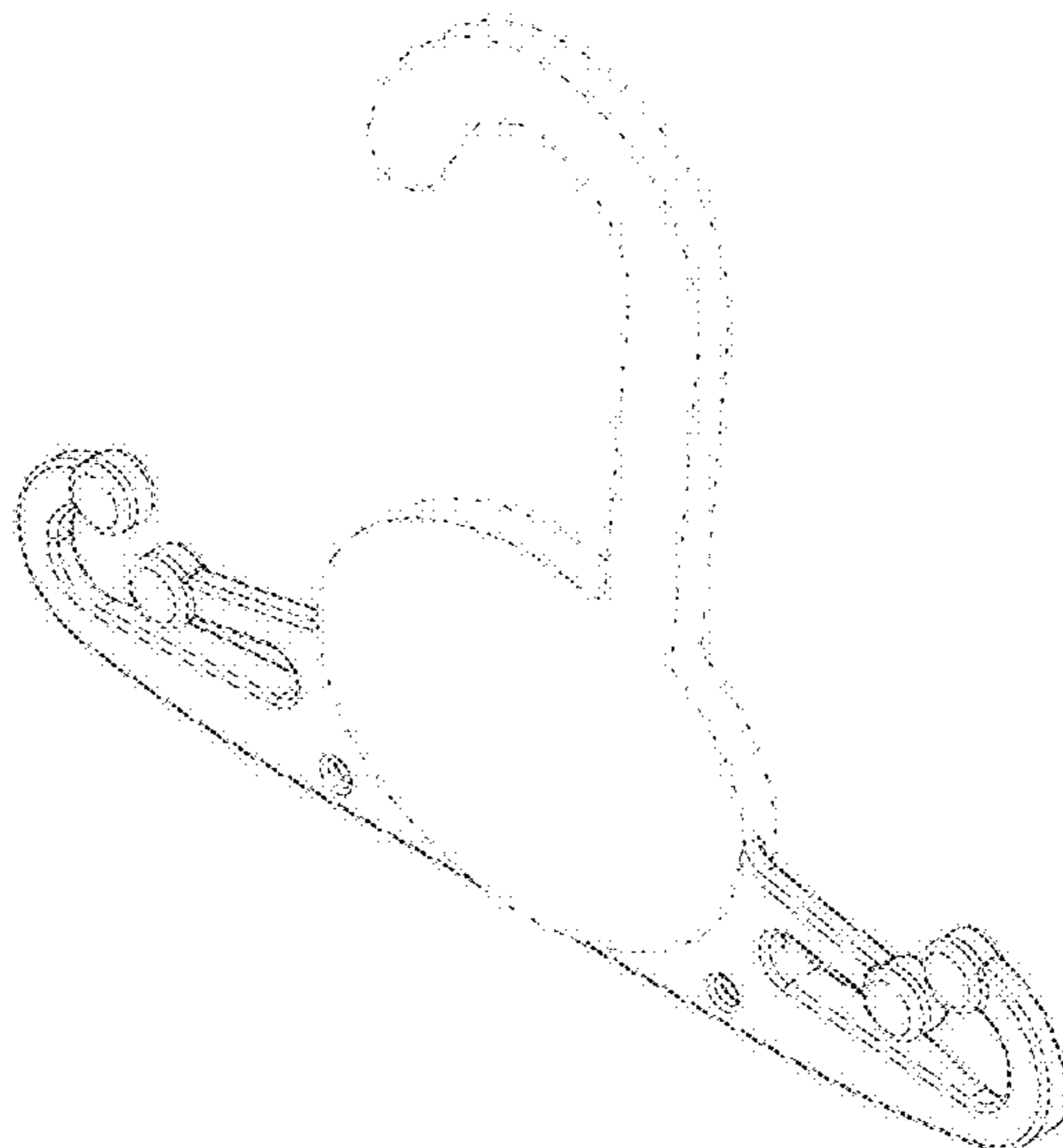
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a footwear hanger showing my new design;

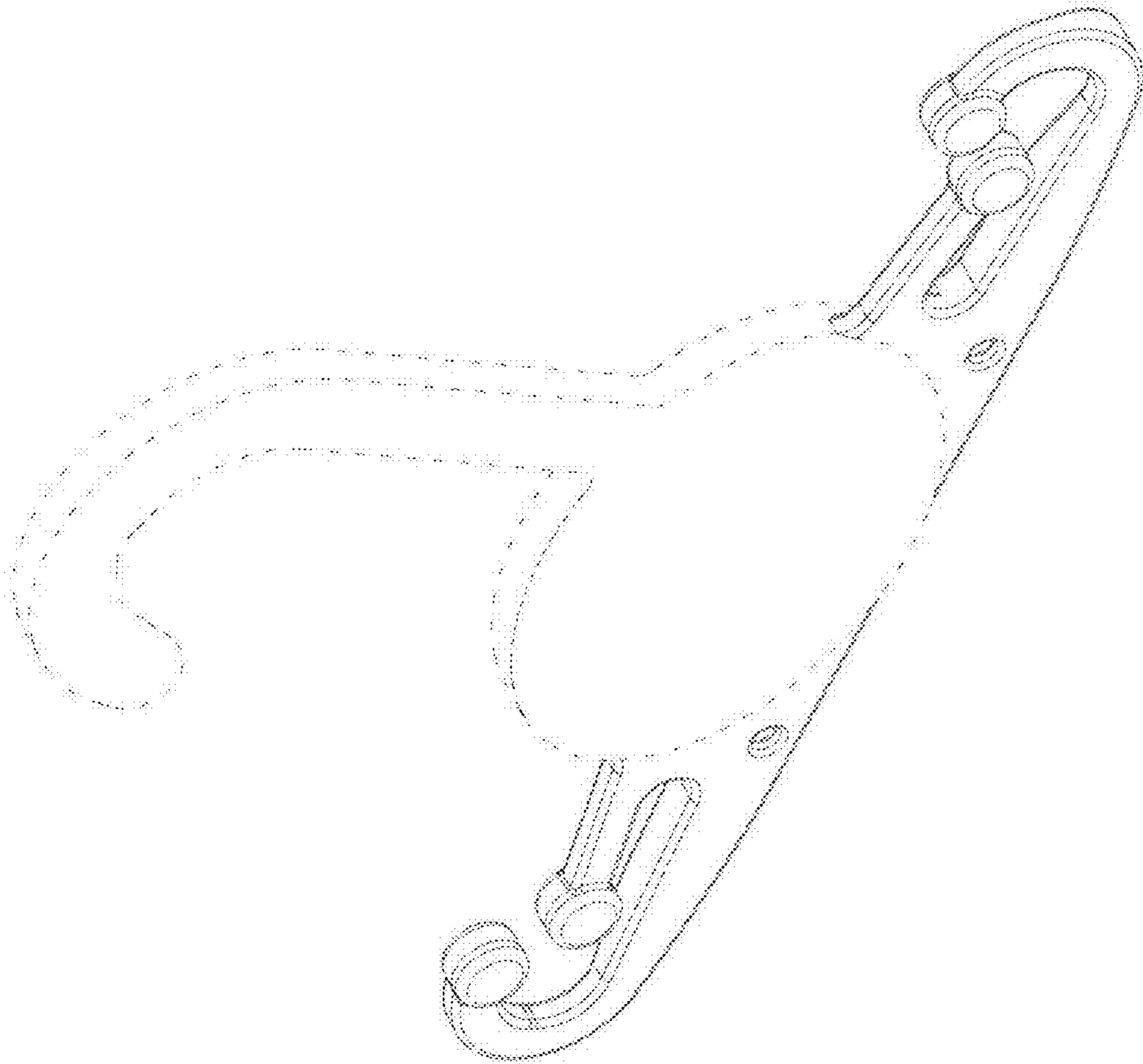

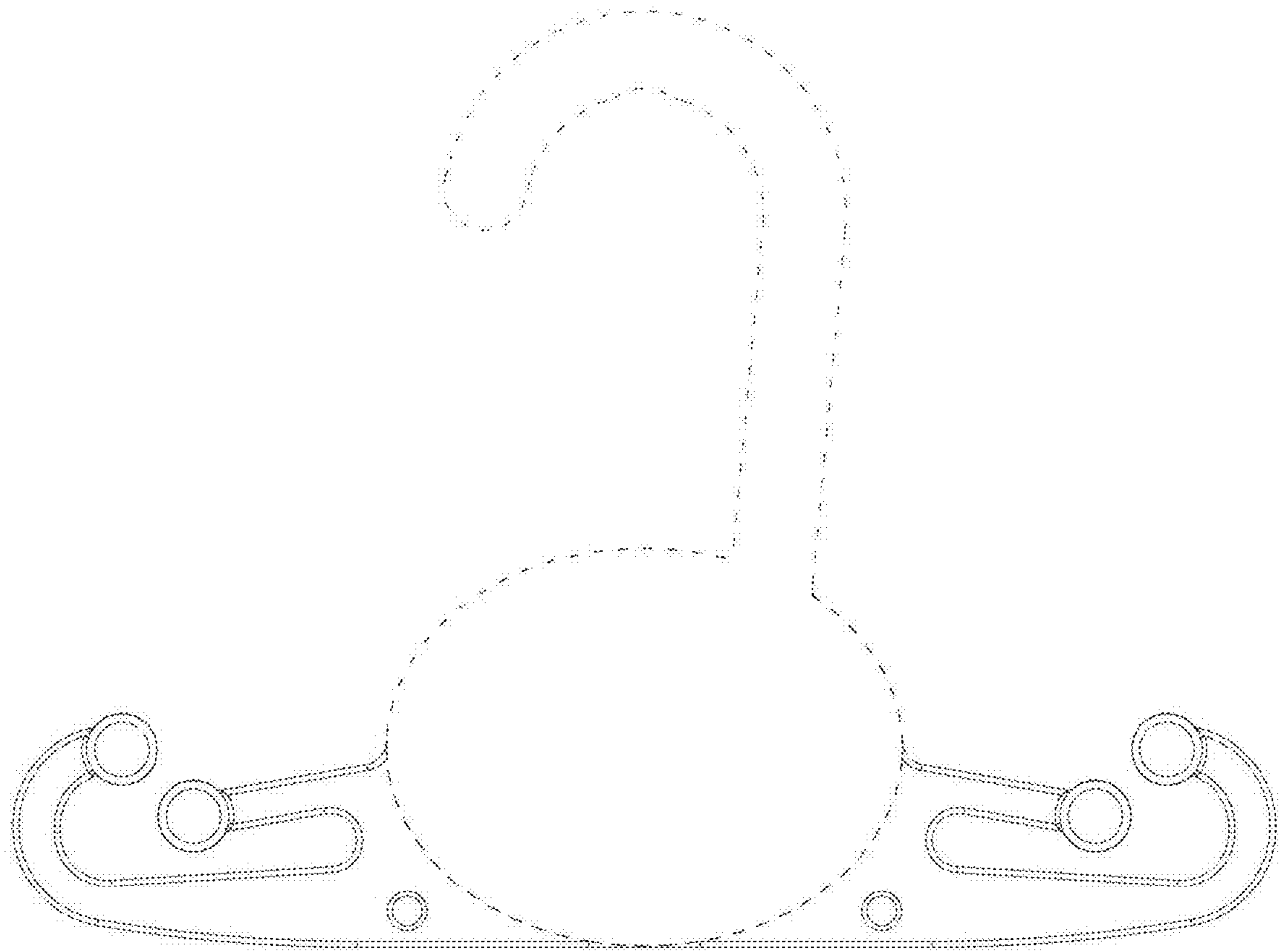

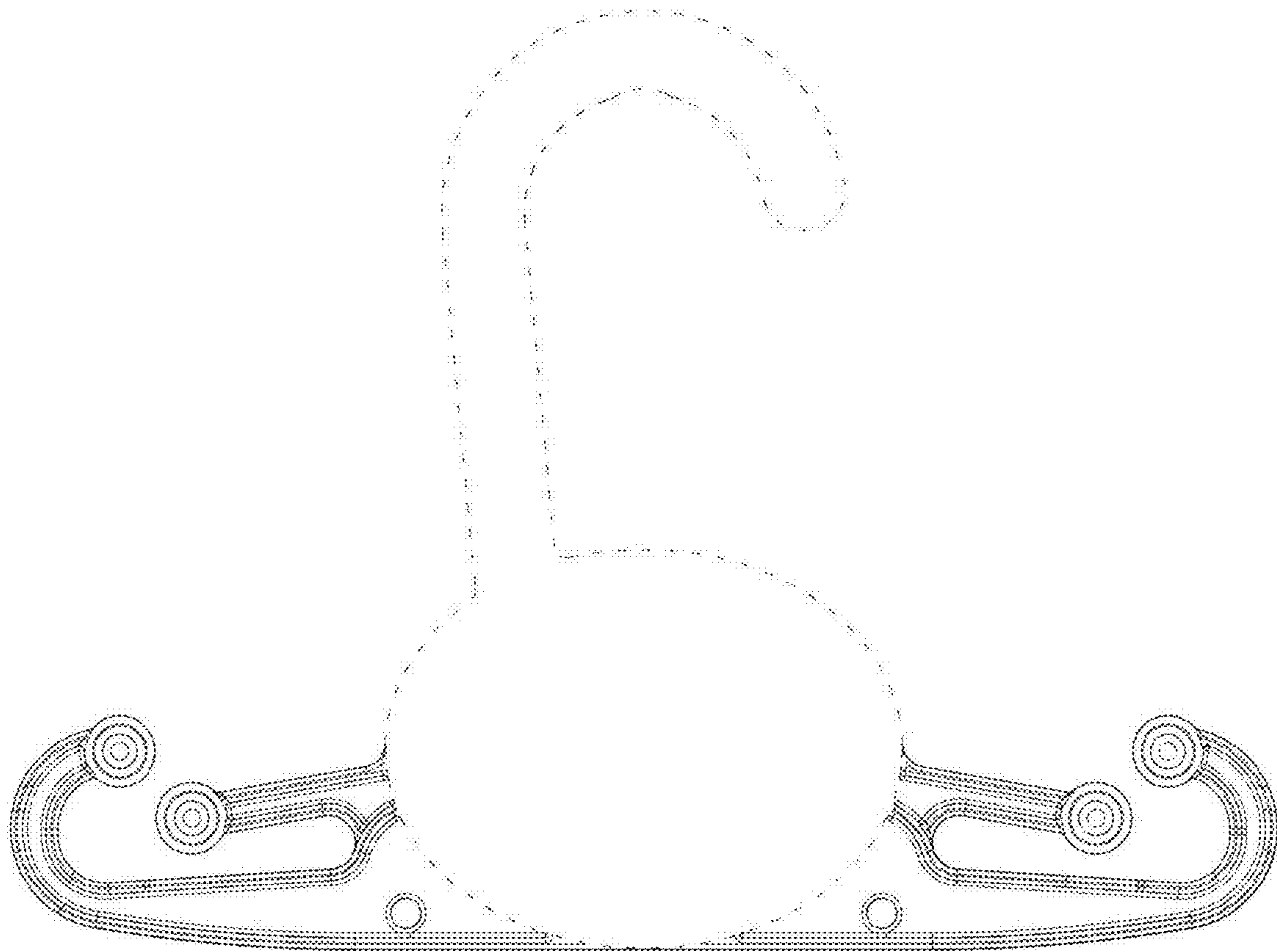

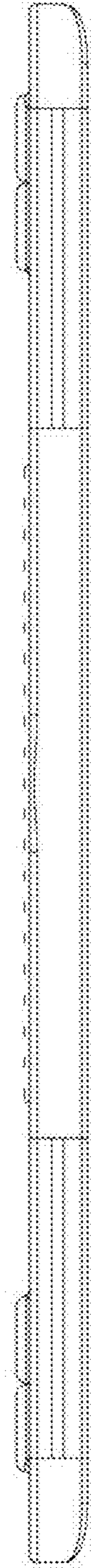

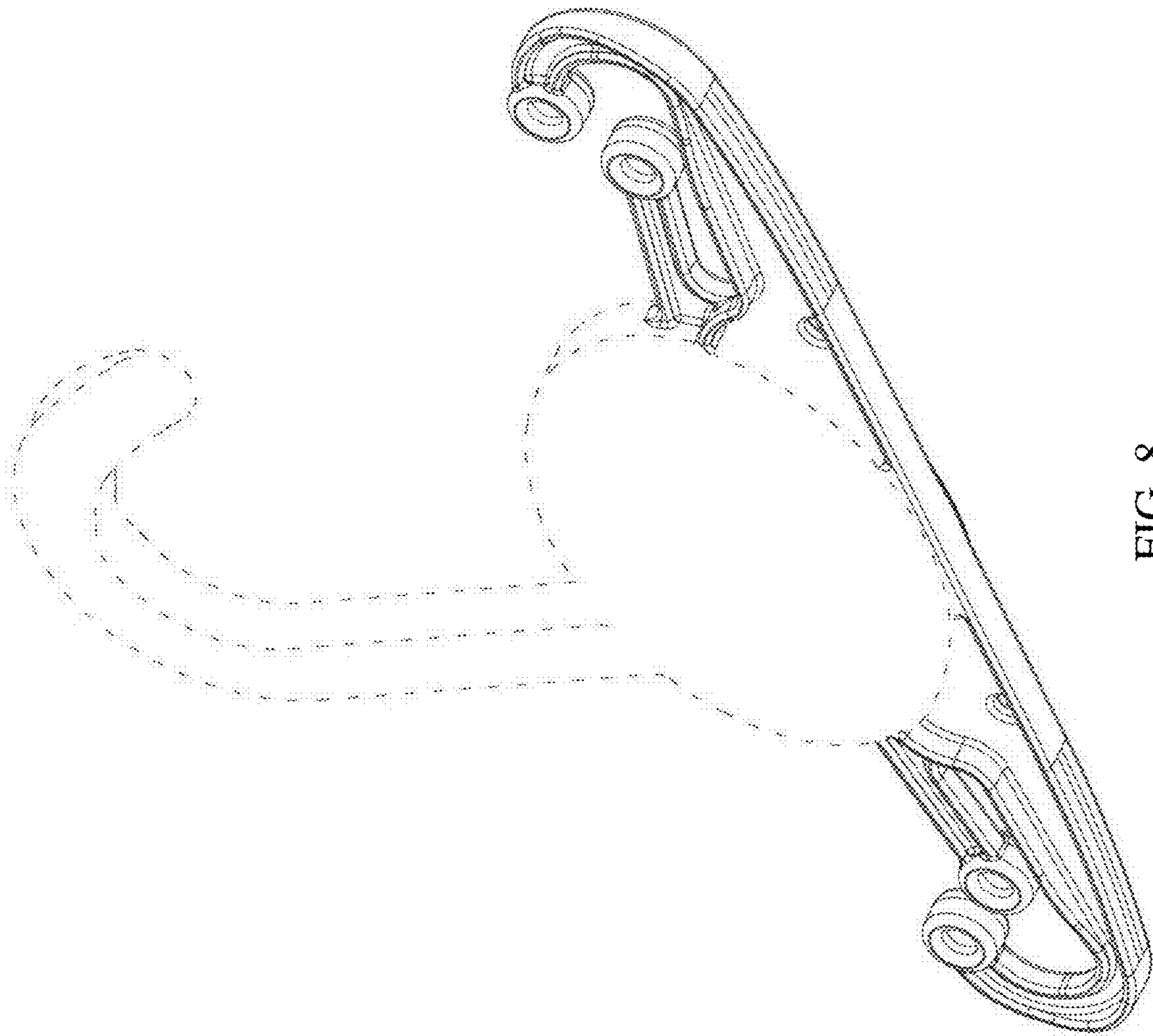
