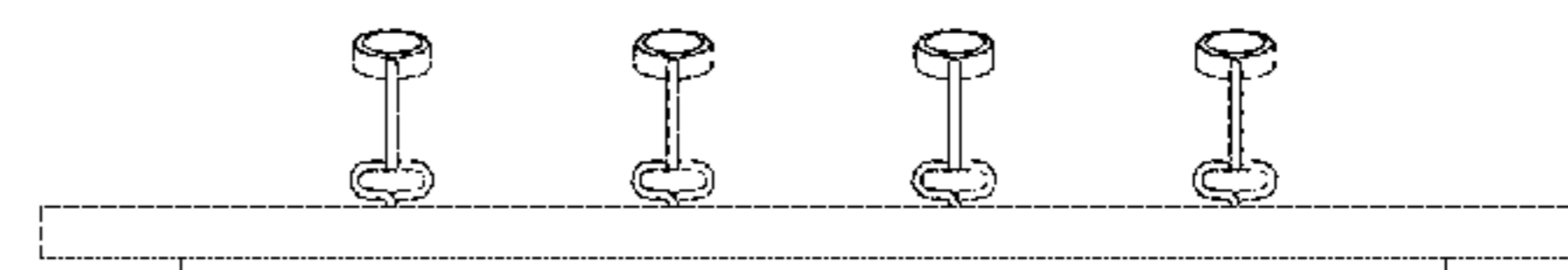
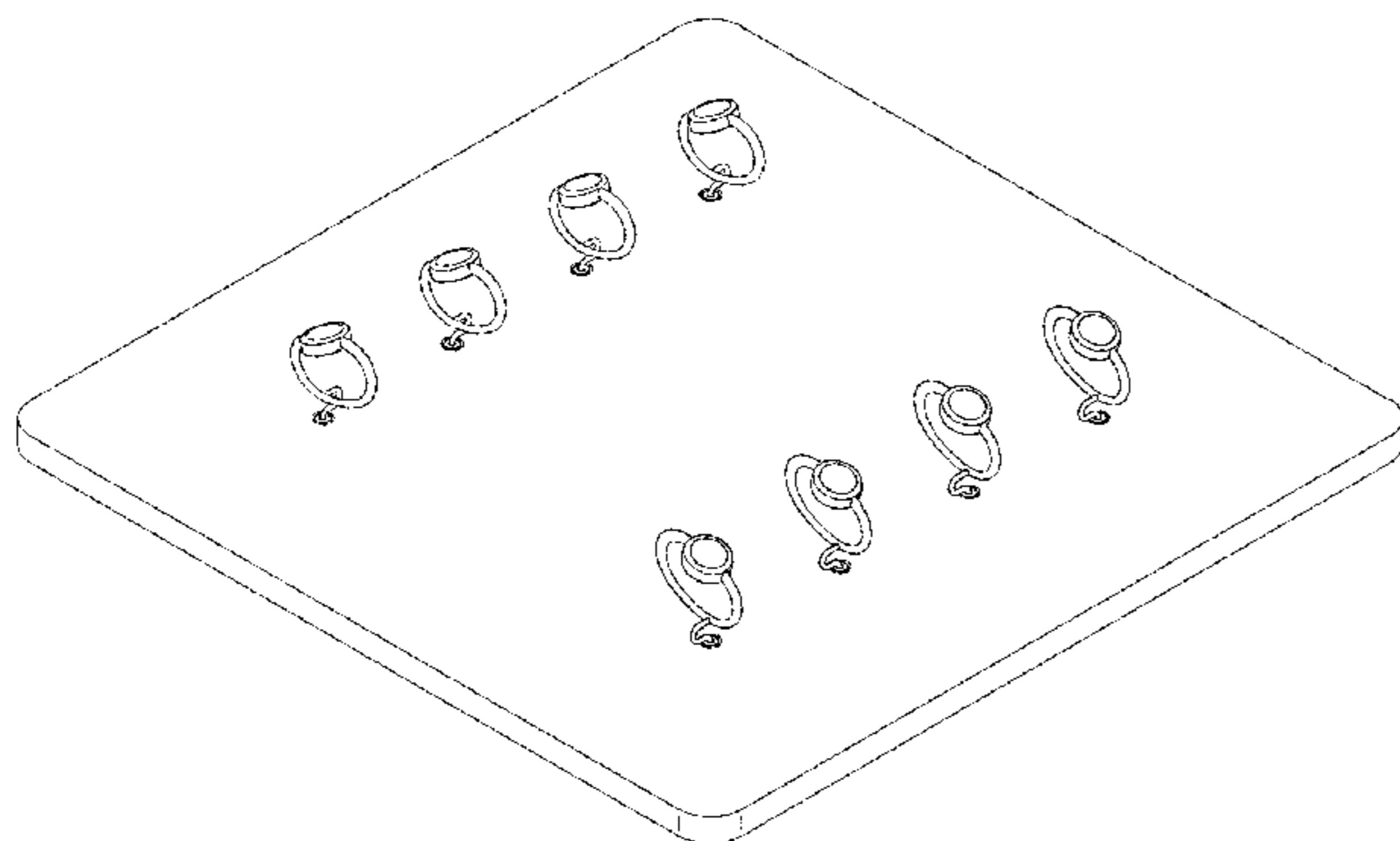
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a display stand showing the claimed design;

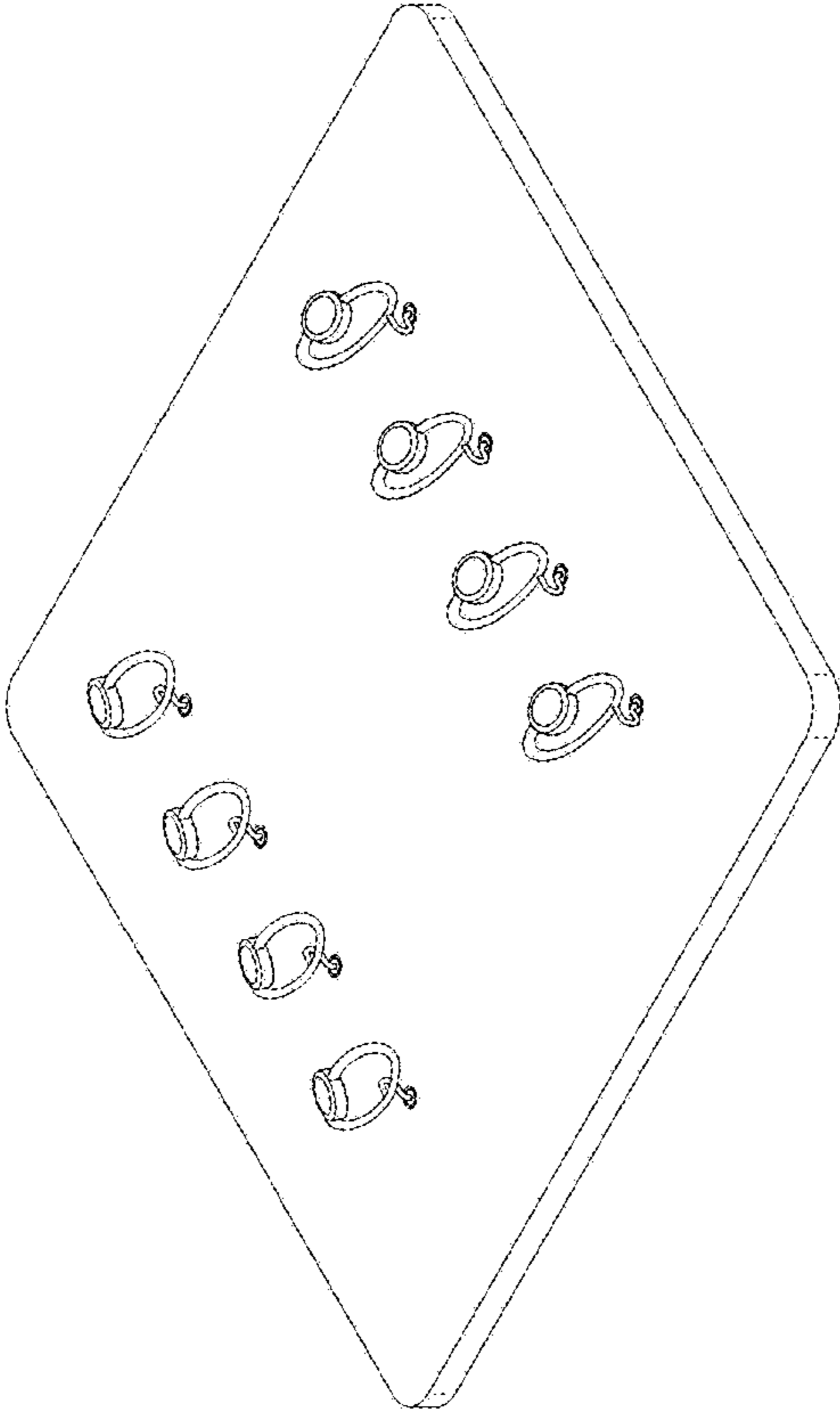

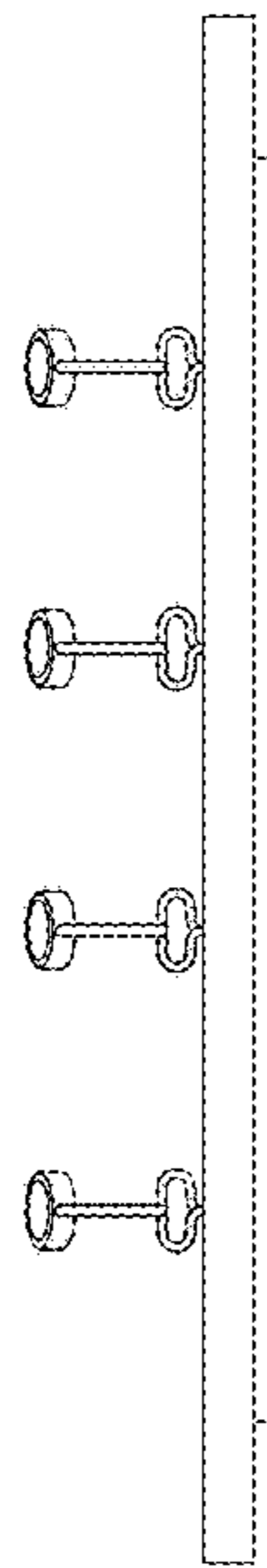

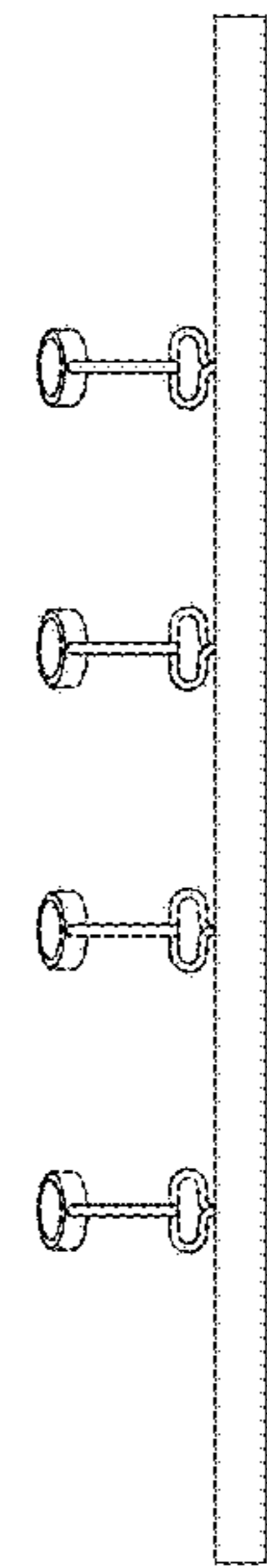

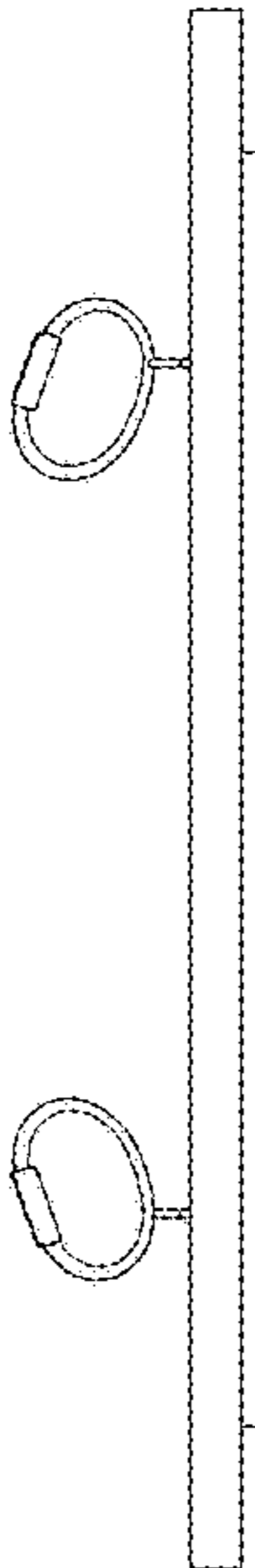

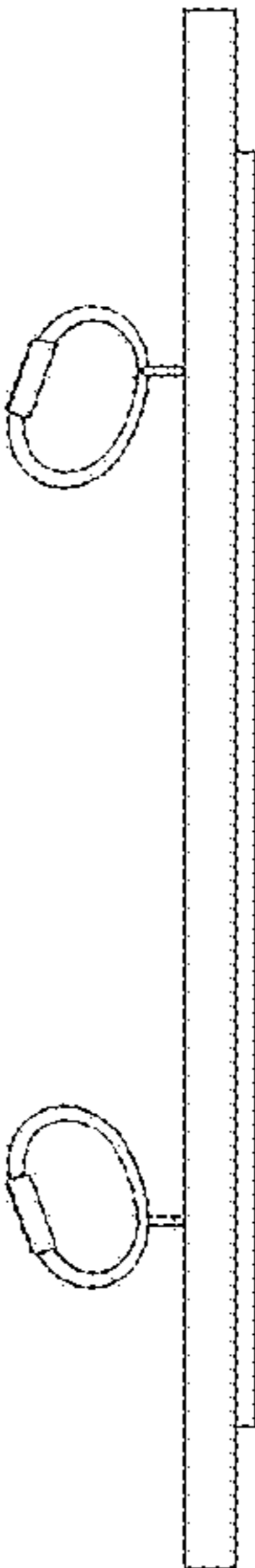

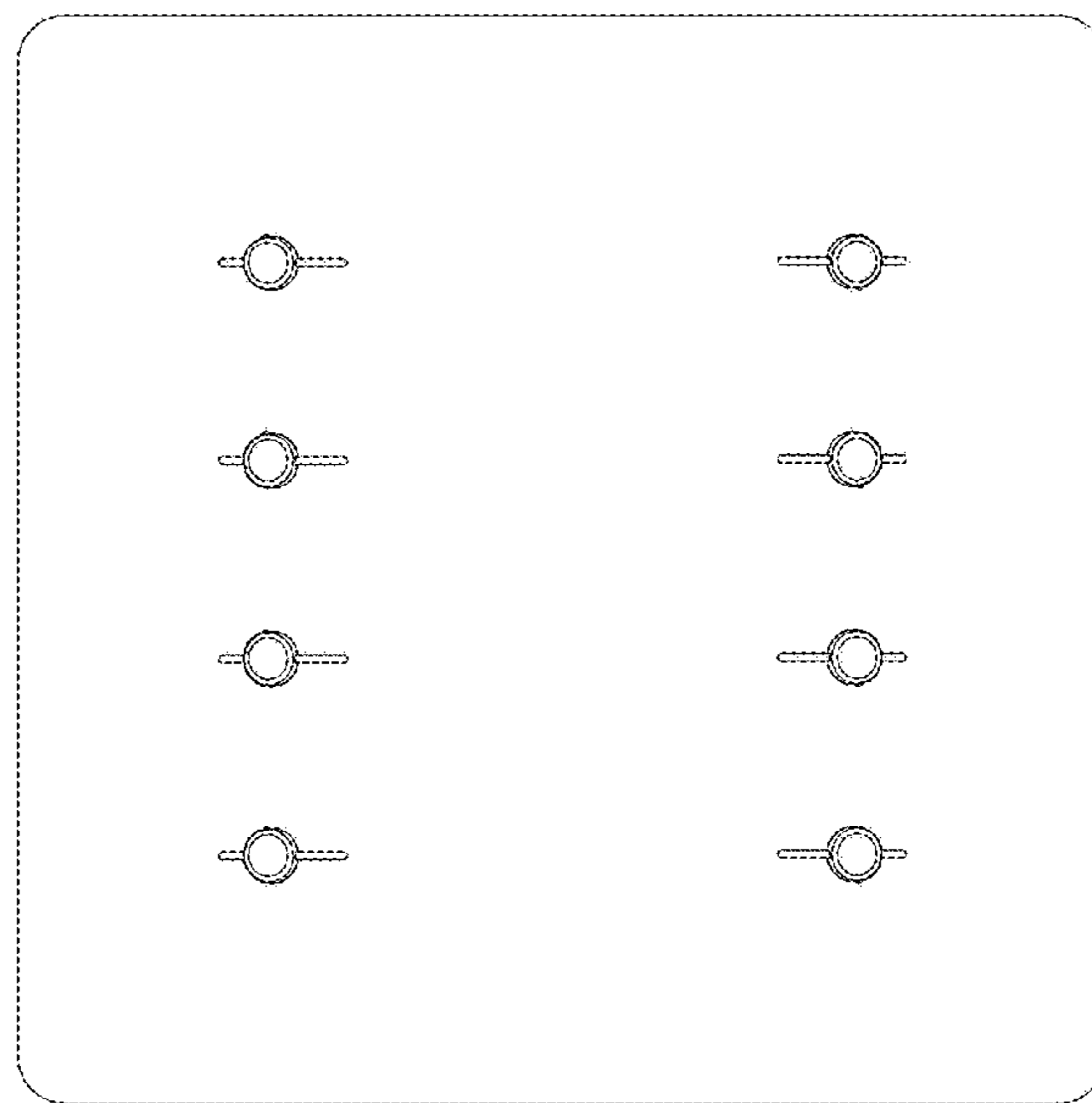

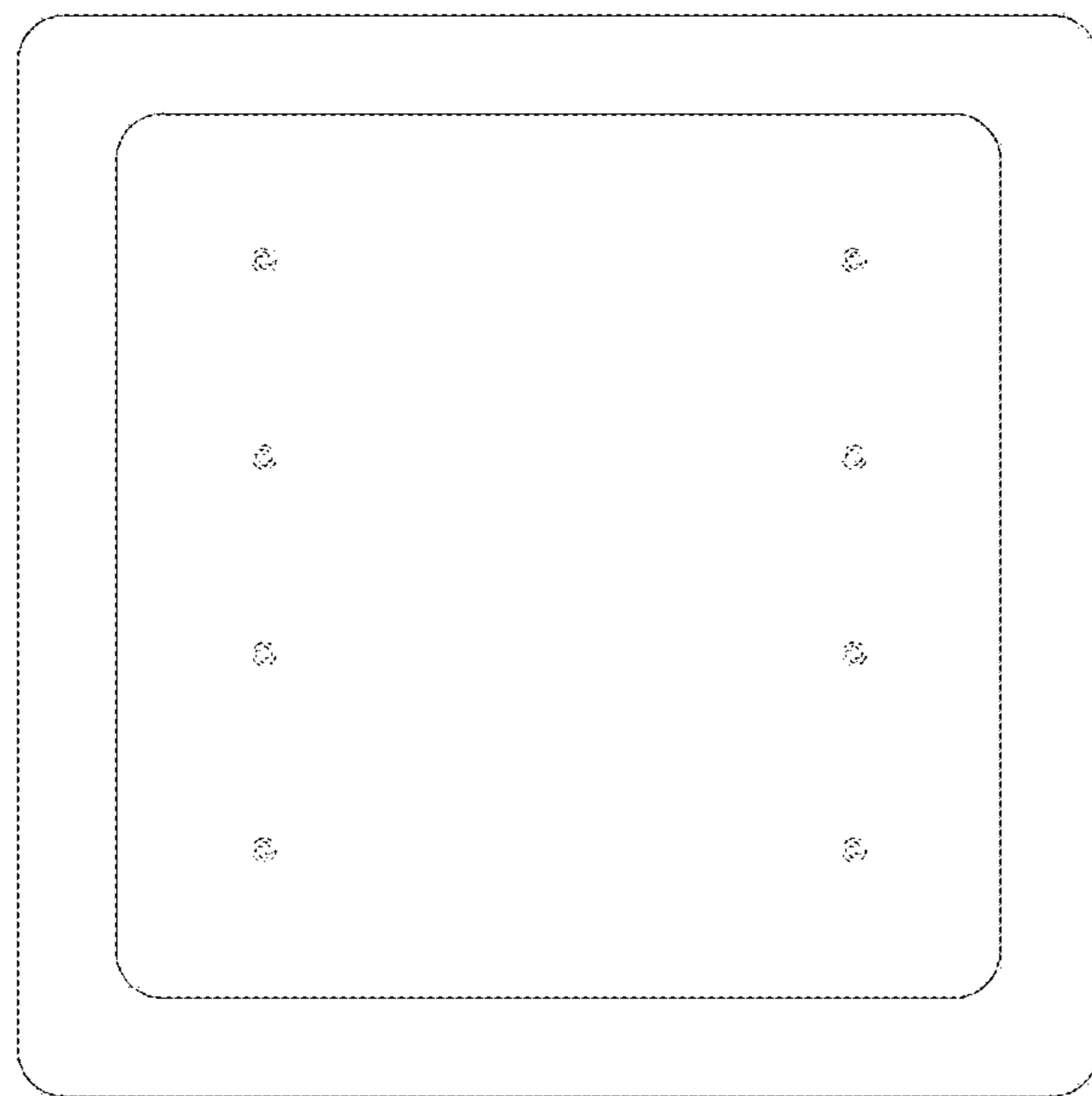
