FIG. 3 is a side view thereof, the opposite side view being a mirror image thereof.

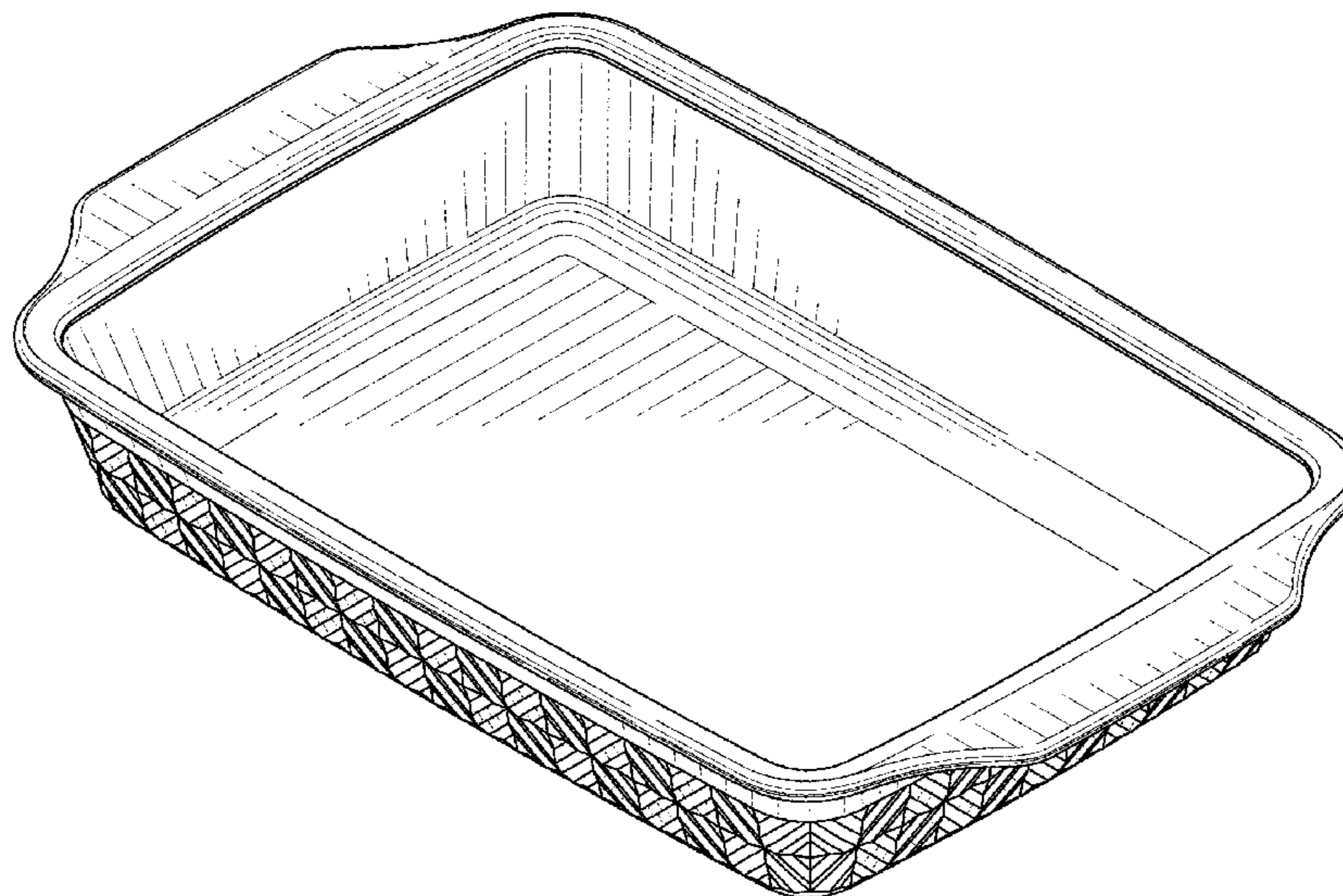
FIG. 4 is a top view thereof.

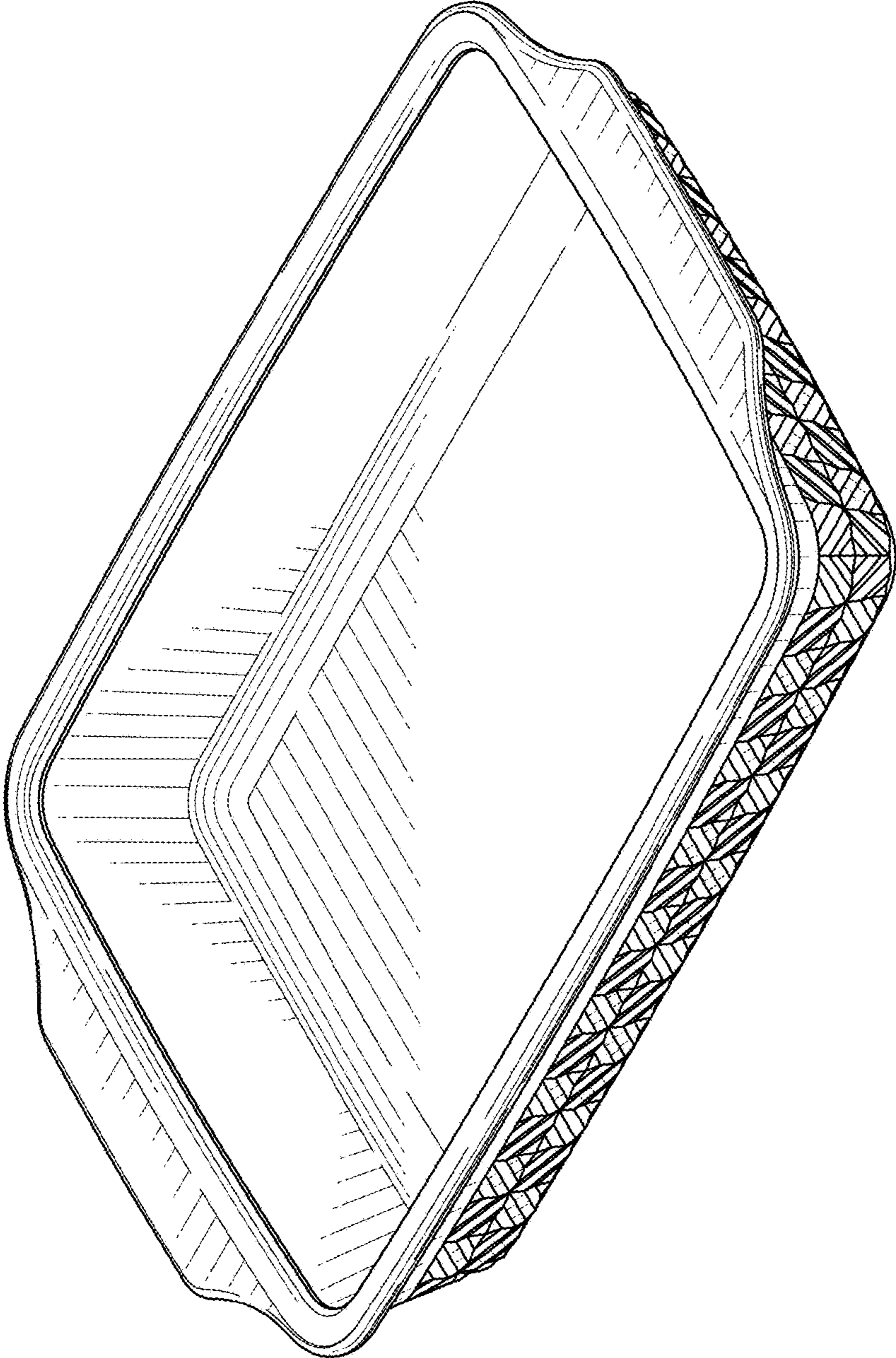

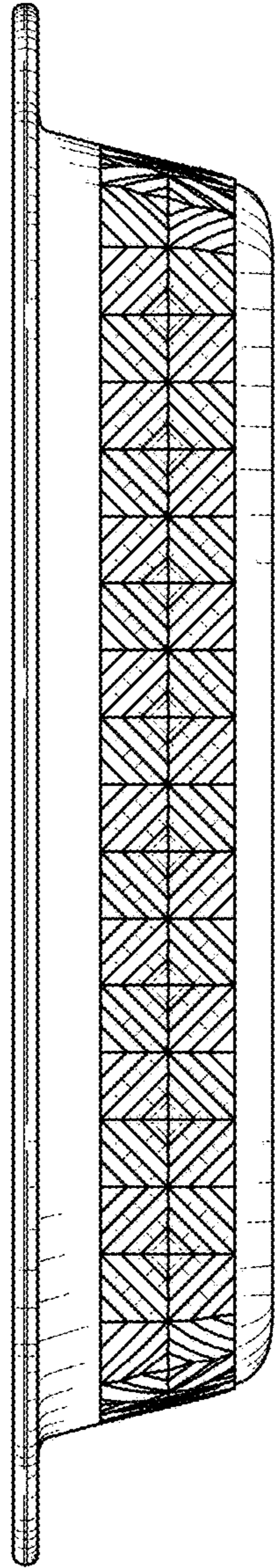

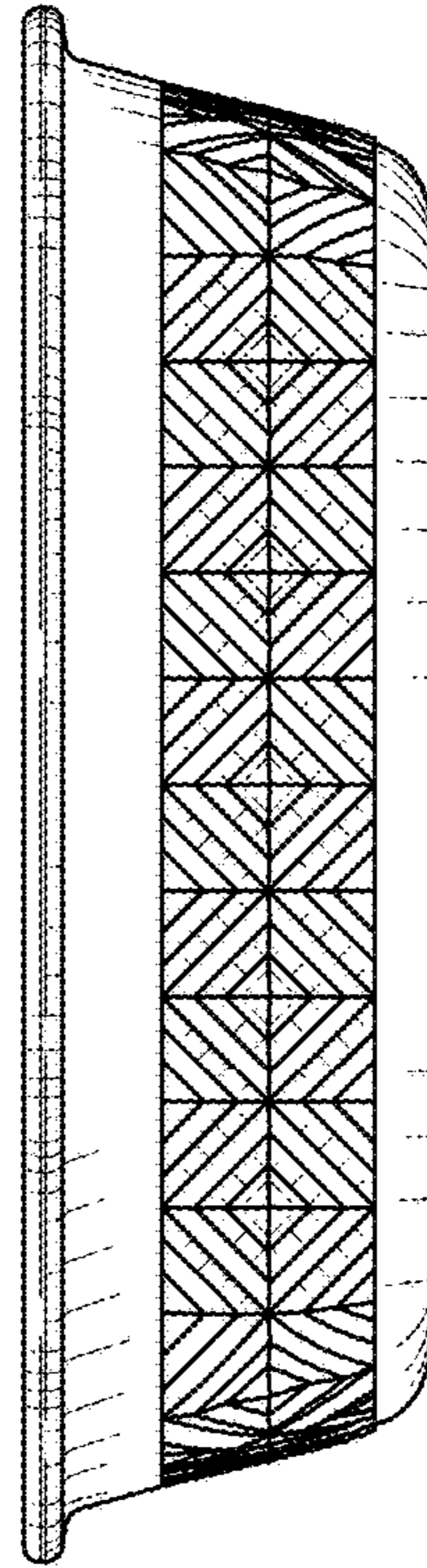

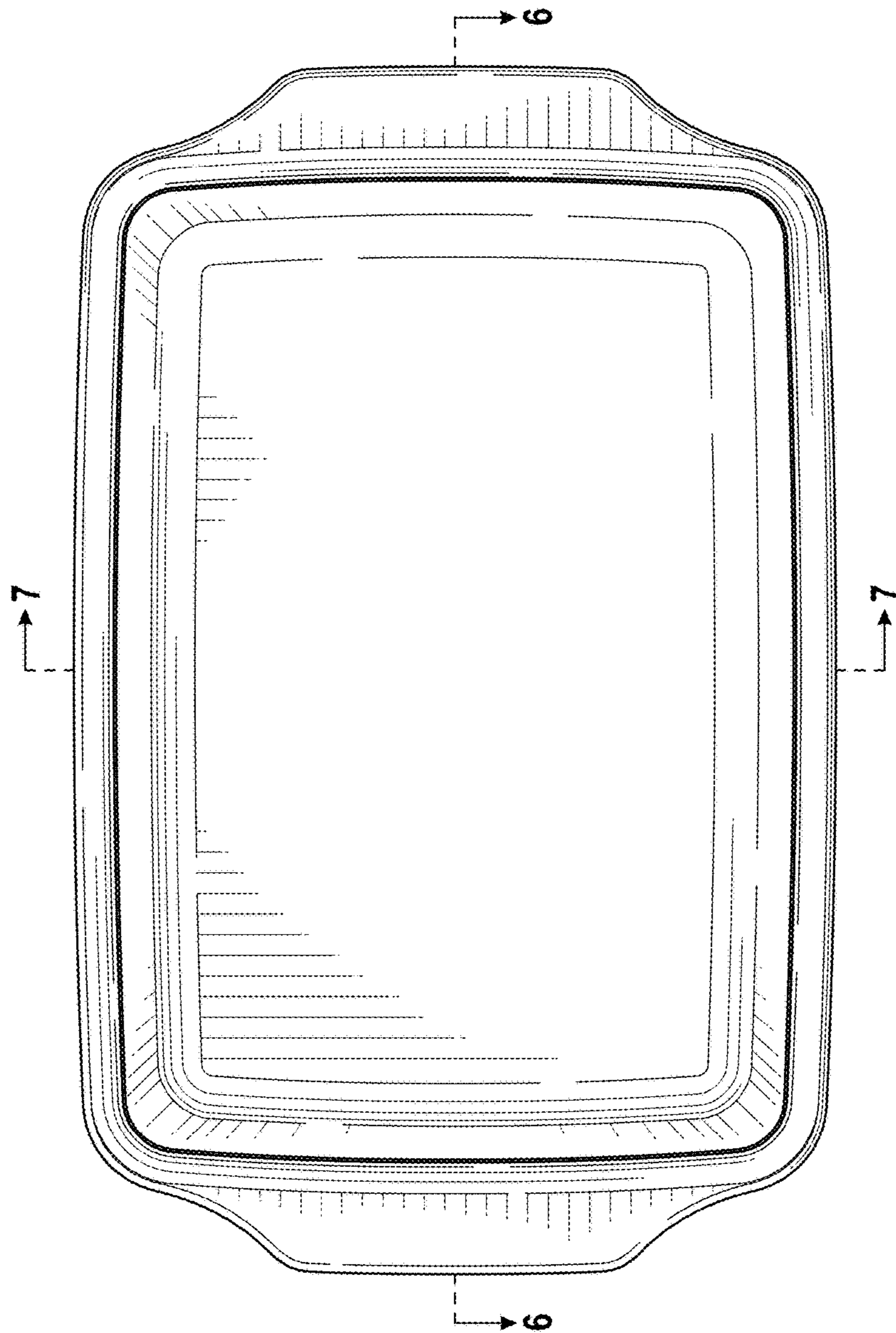

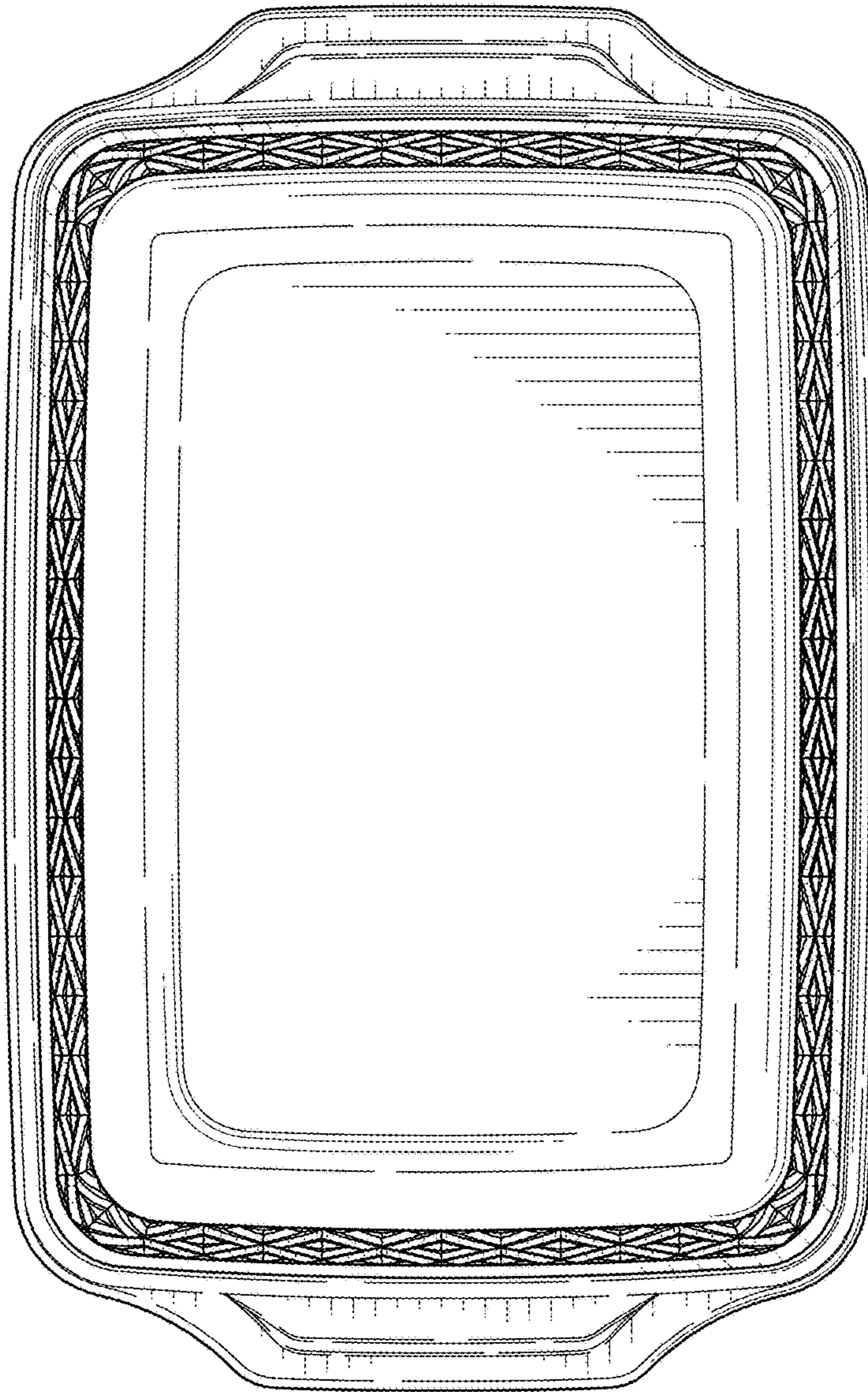

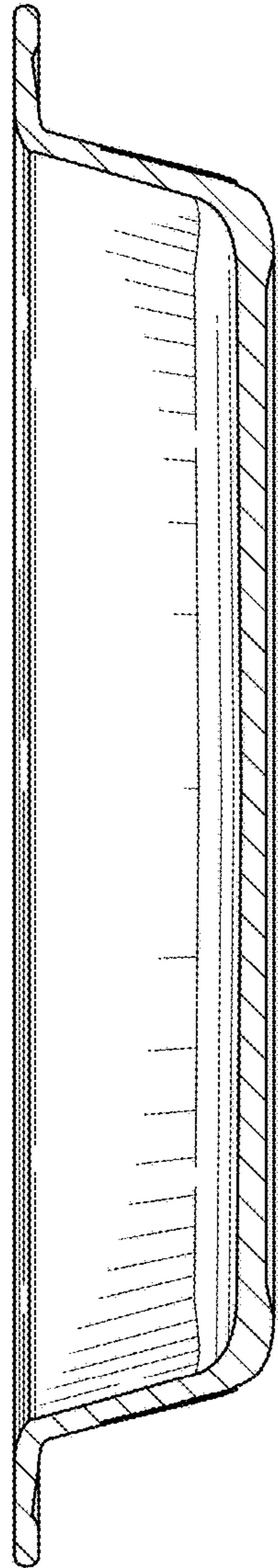

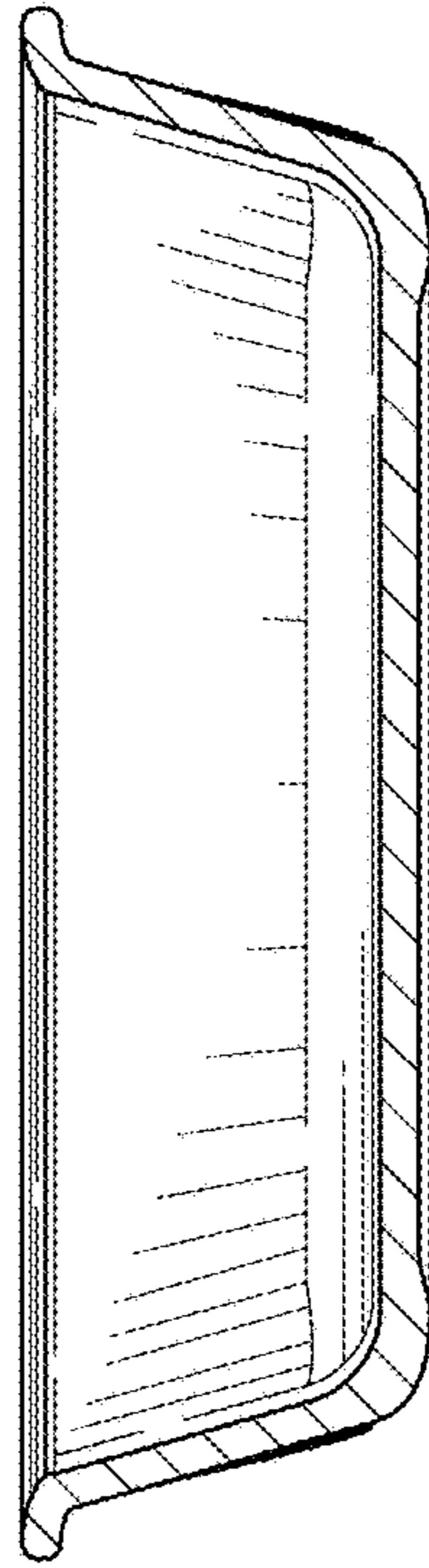
