FIG. 7 is a front view thereof;

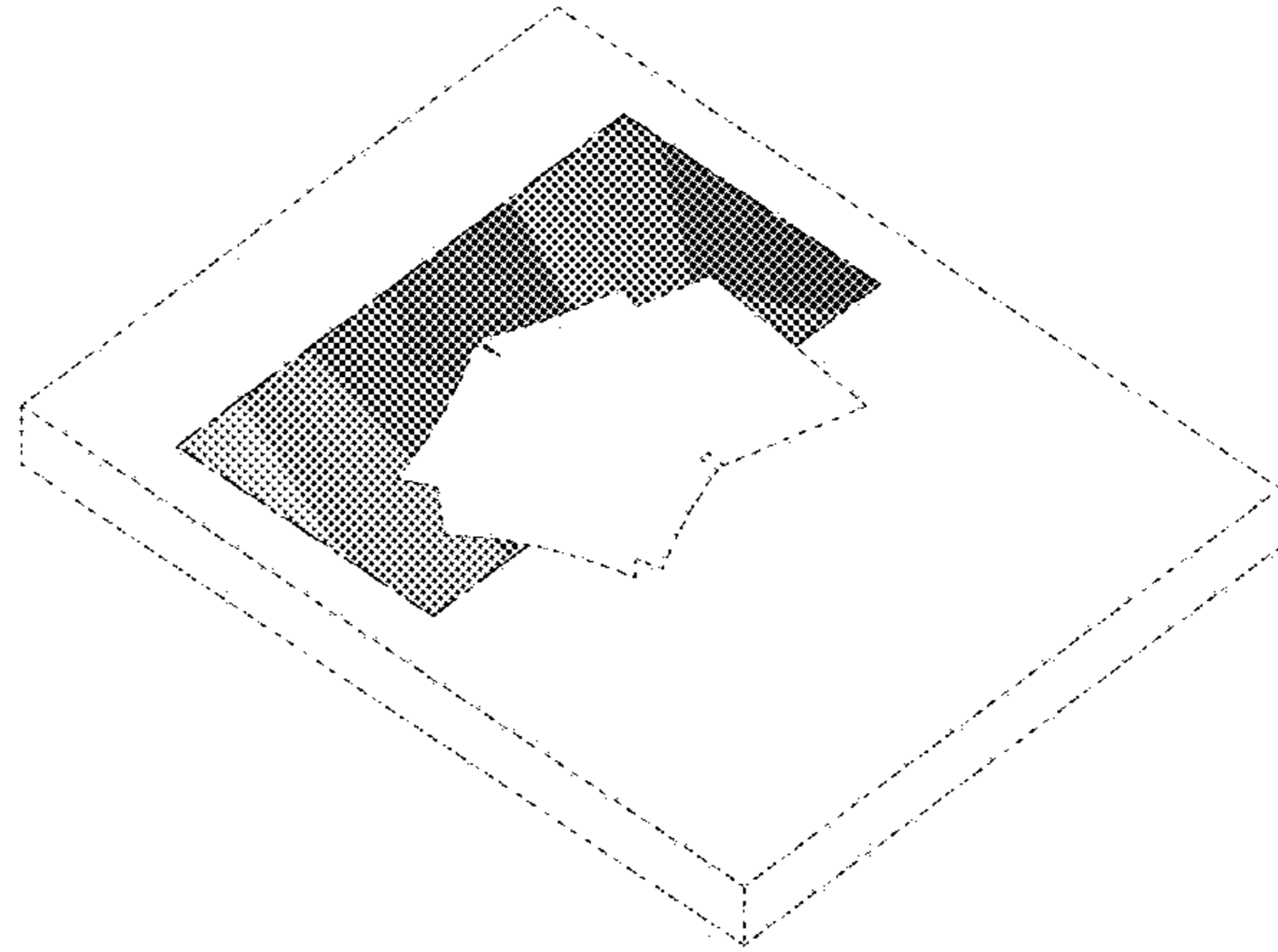
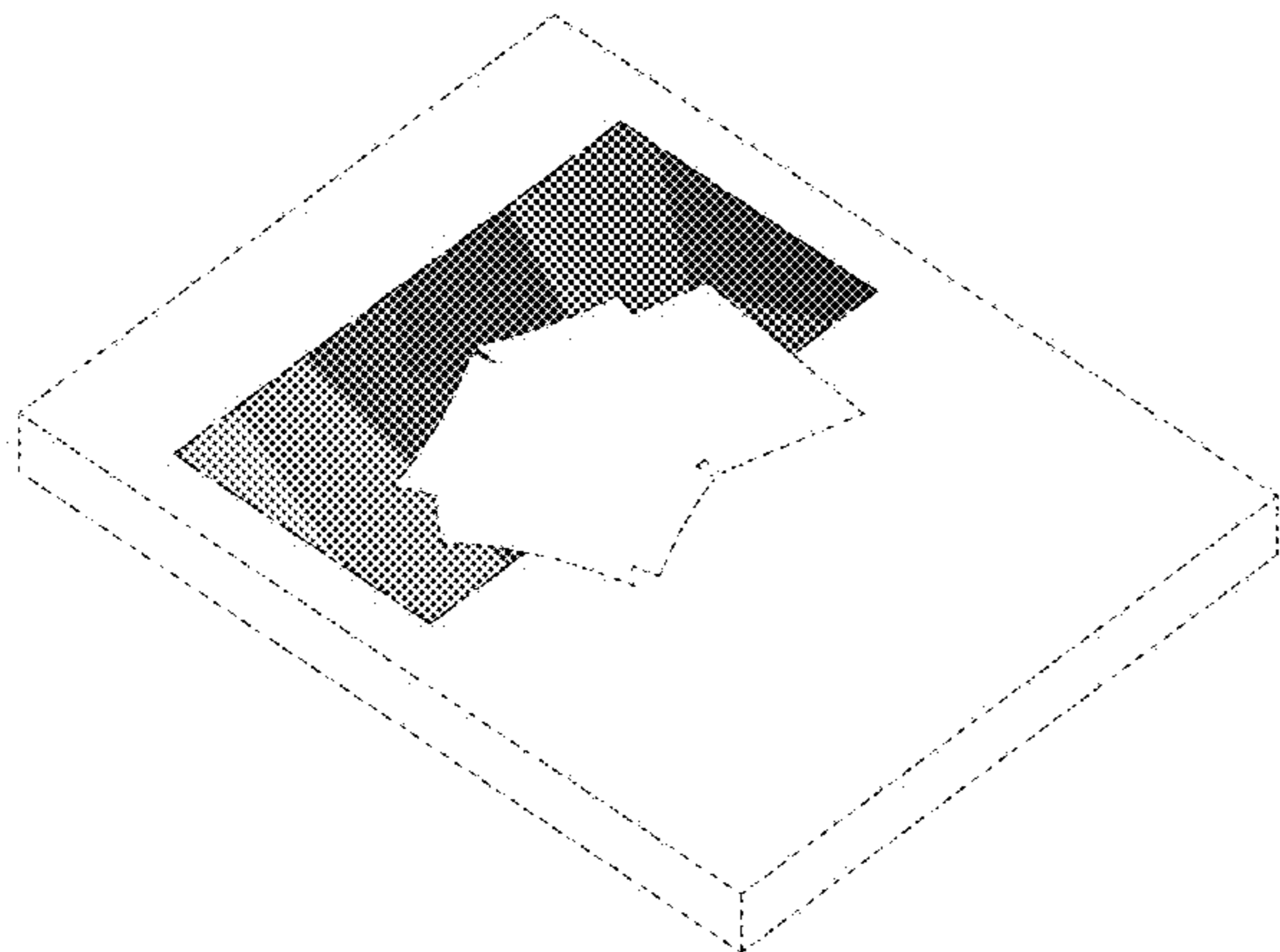
FIG. 8 is a rear view thereof;

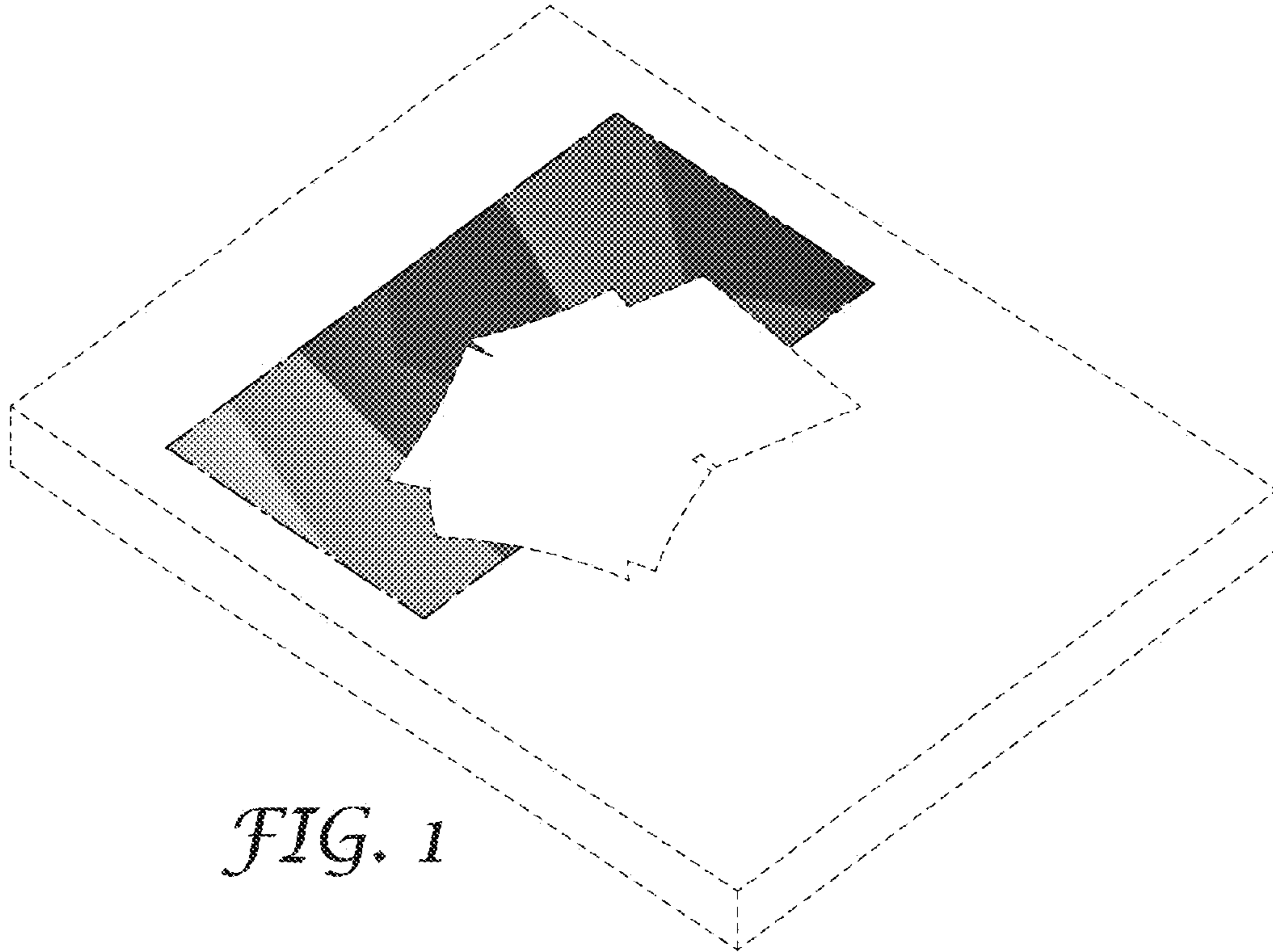

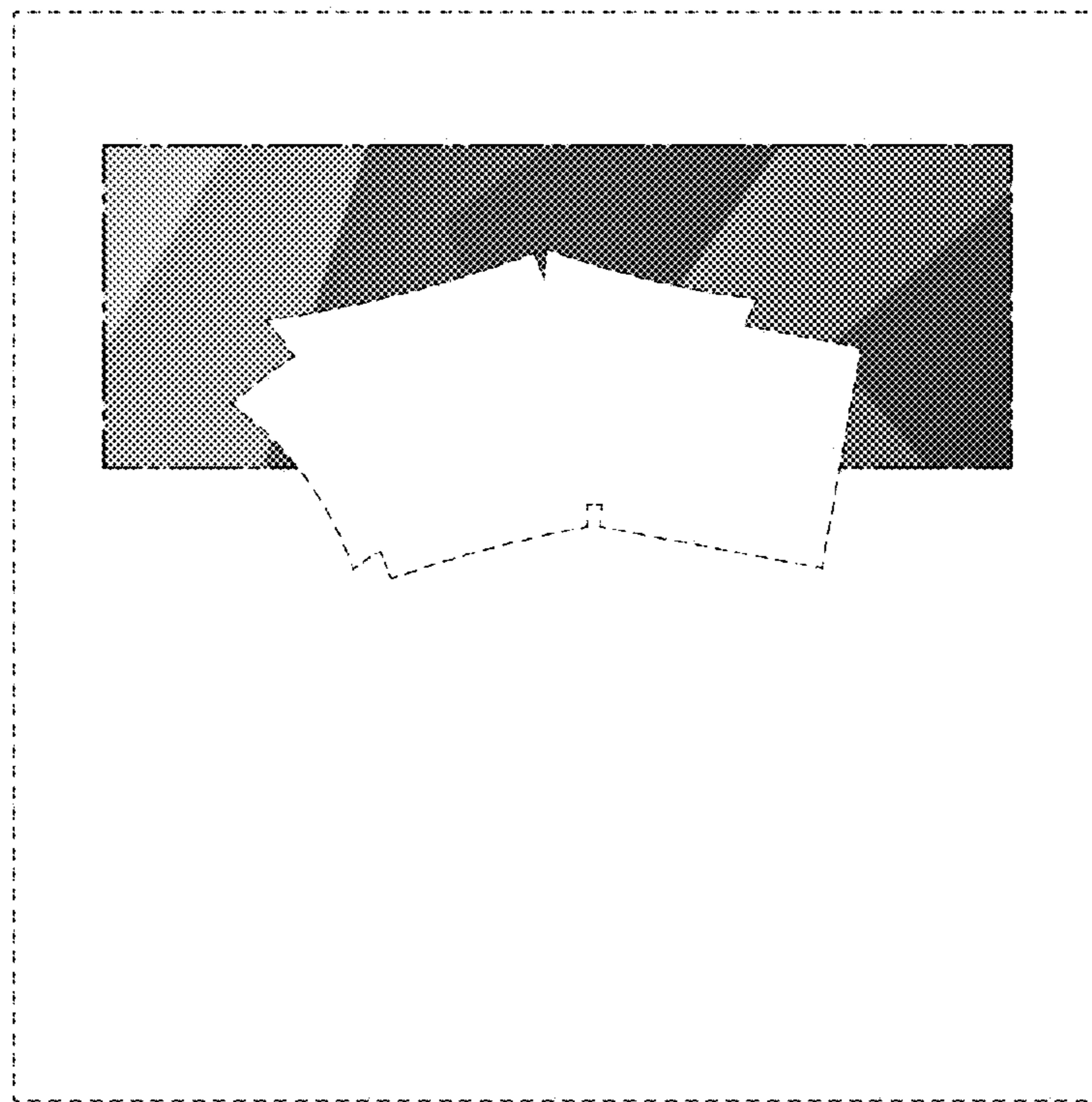

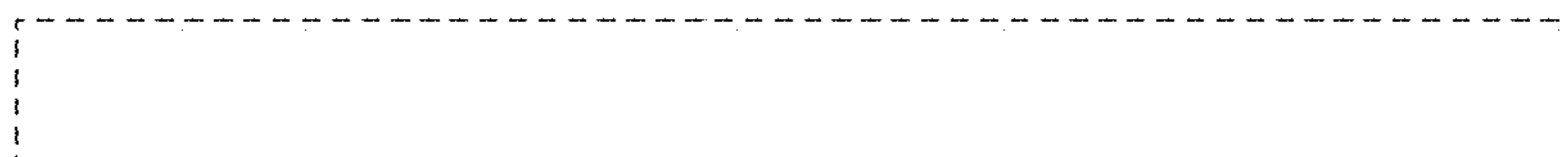

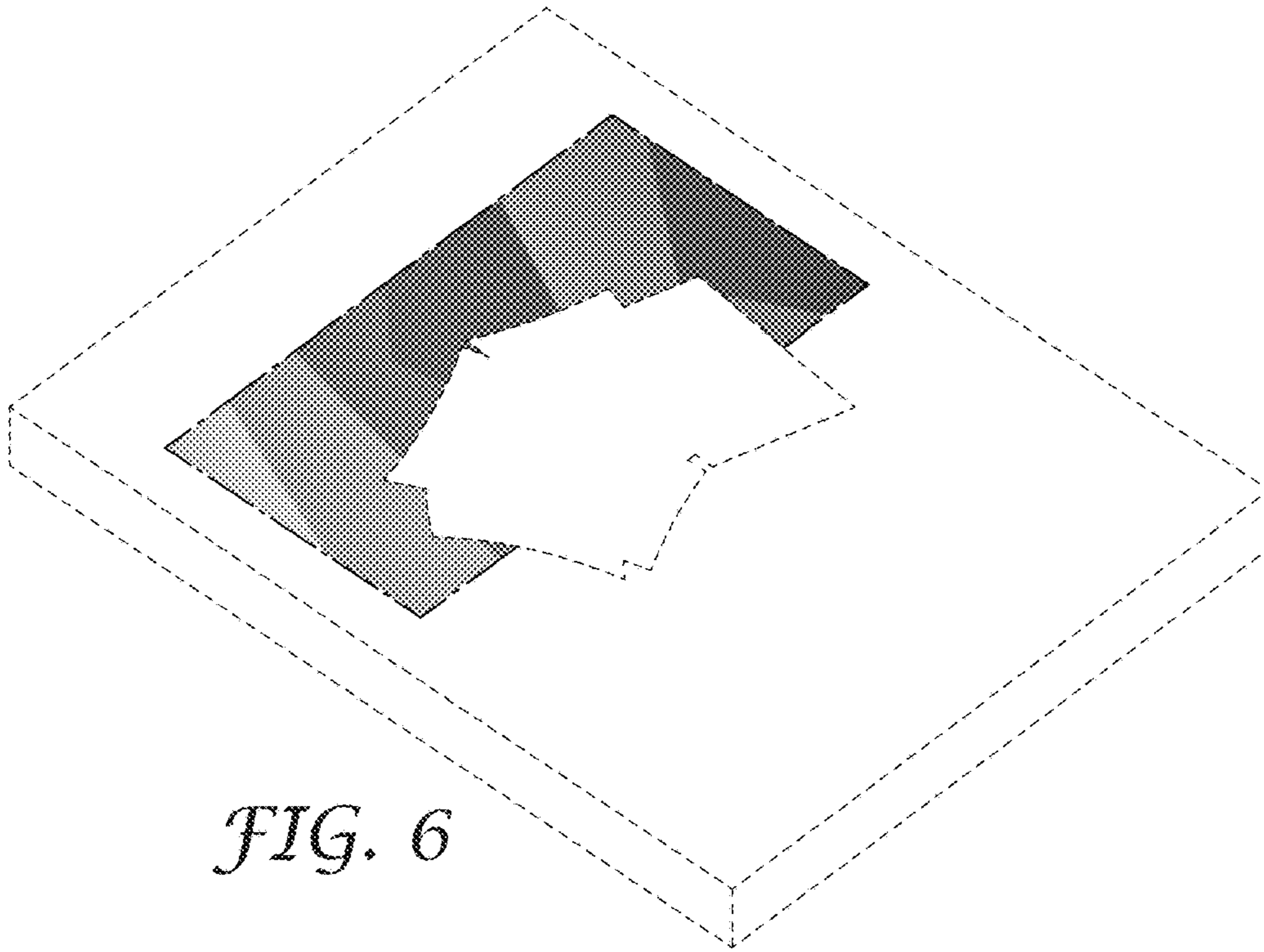

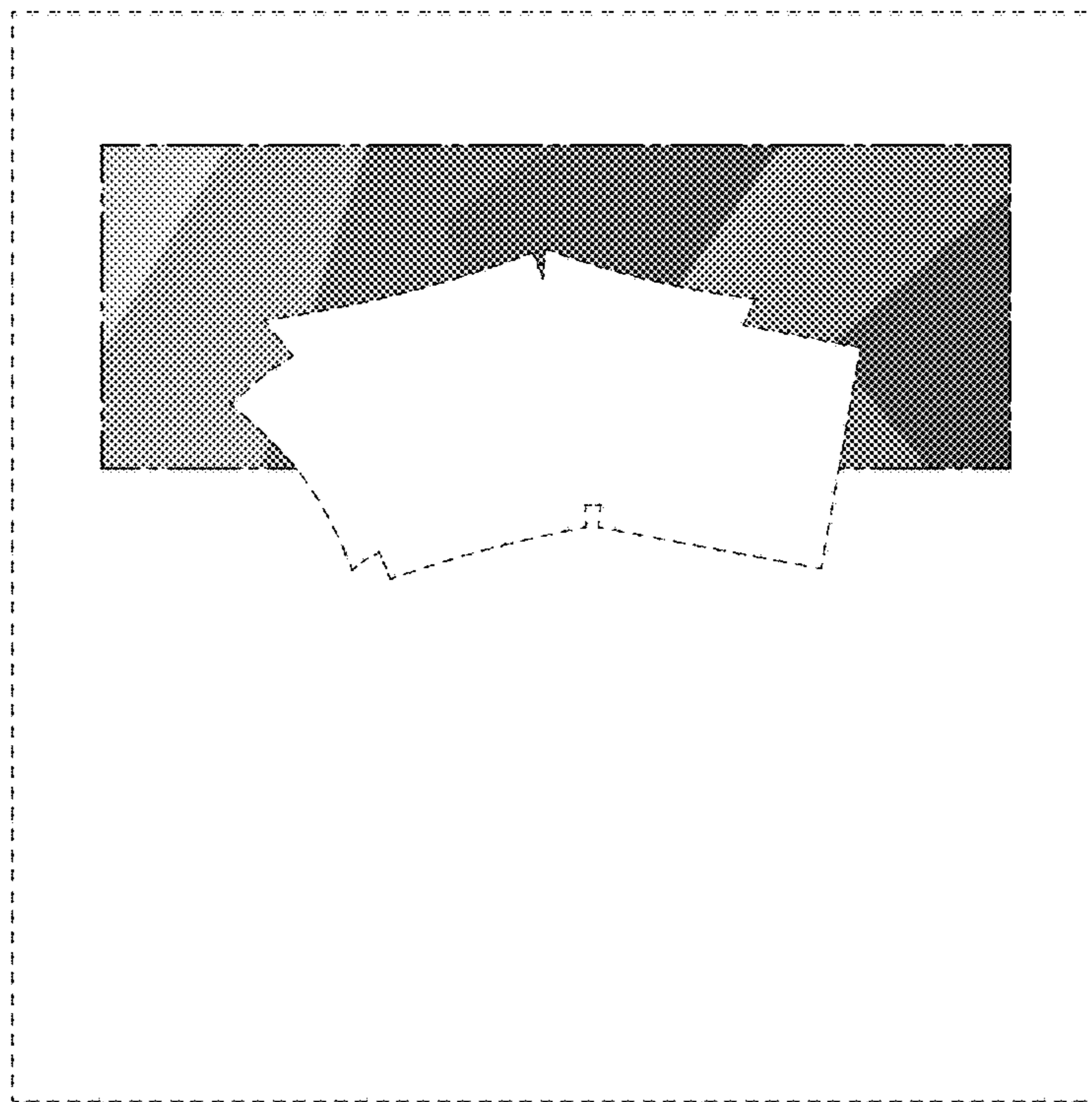

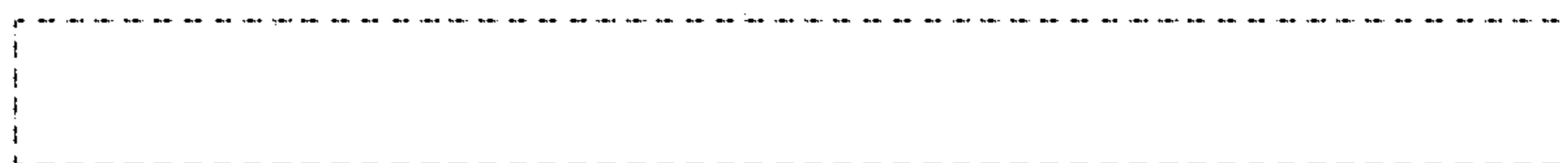

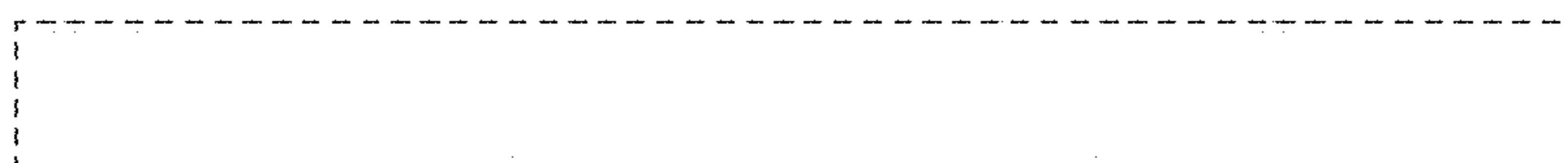
