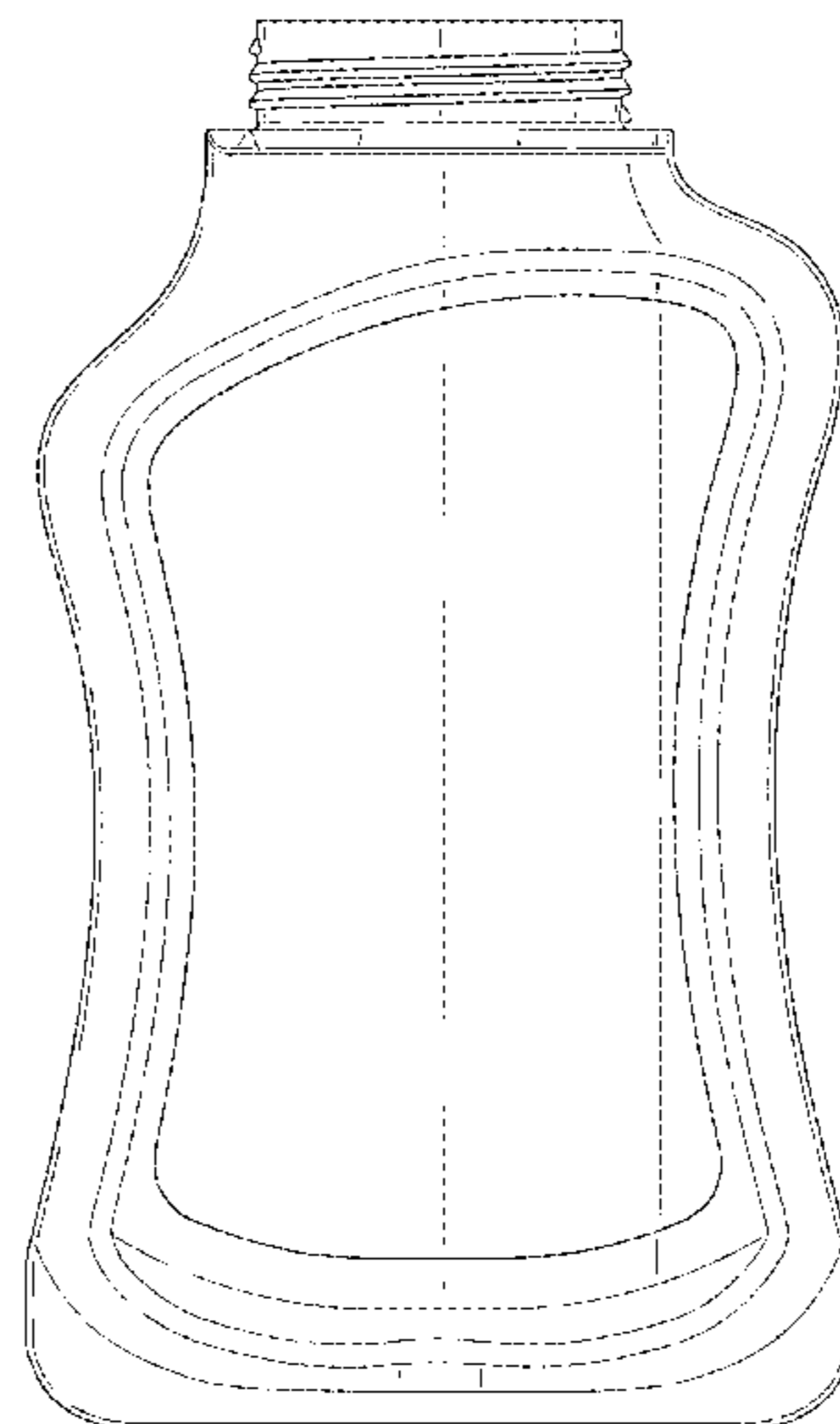
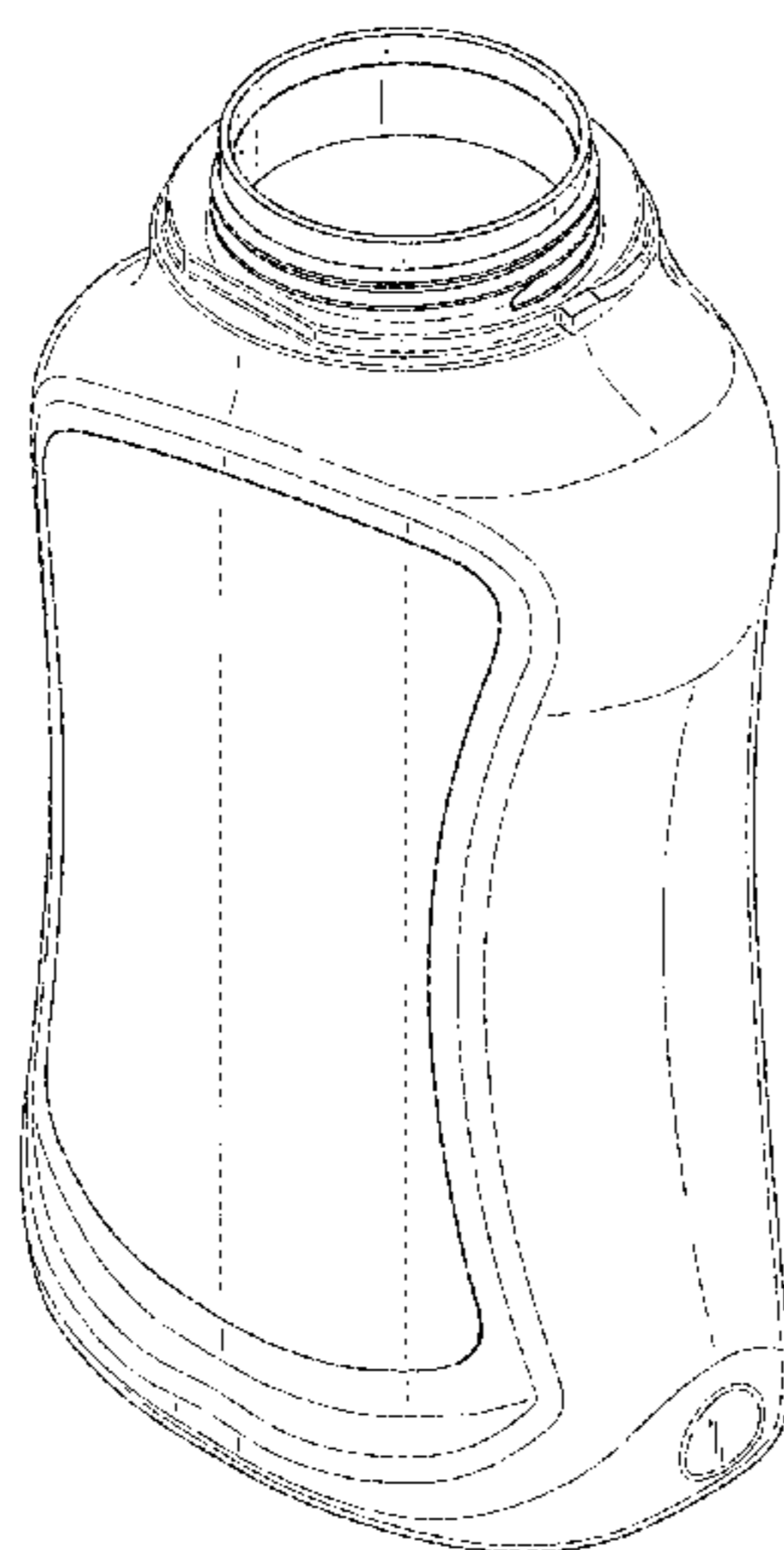
The ornamental design for the bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of front and a side of the bottle; FIG. 2 is a plan view of a side of the bottle; FIG. 3 is plan view of another side of the bottle; FIG. 4 is a plan view of a further side of the bottle; FIG. 5 is a plan view of another side of the bottle; FIG. 6 is a plan view of the top of the bottle; and, FIG. 7 is a plan view of the bottom of the bottle.

The dot-dash broken line illustrates the boundary of the design and forms no part of the claim. The remaining broken lines illustrate portions of the bottle that form no part of the claimed design.

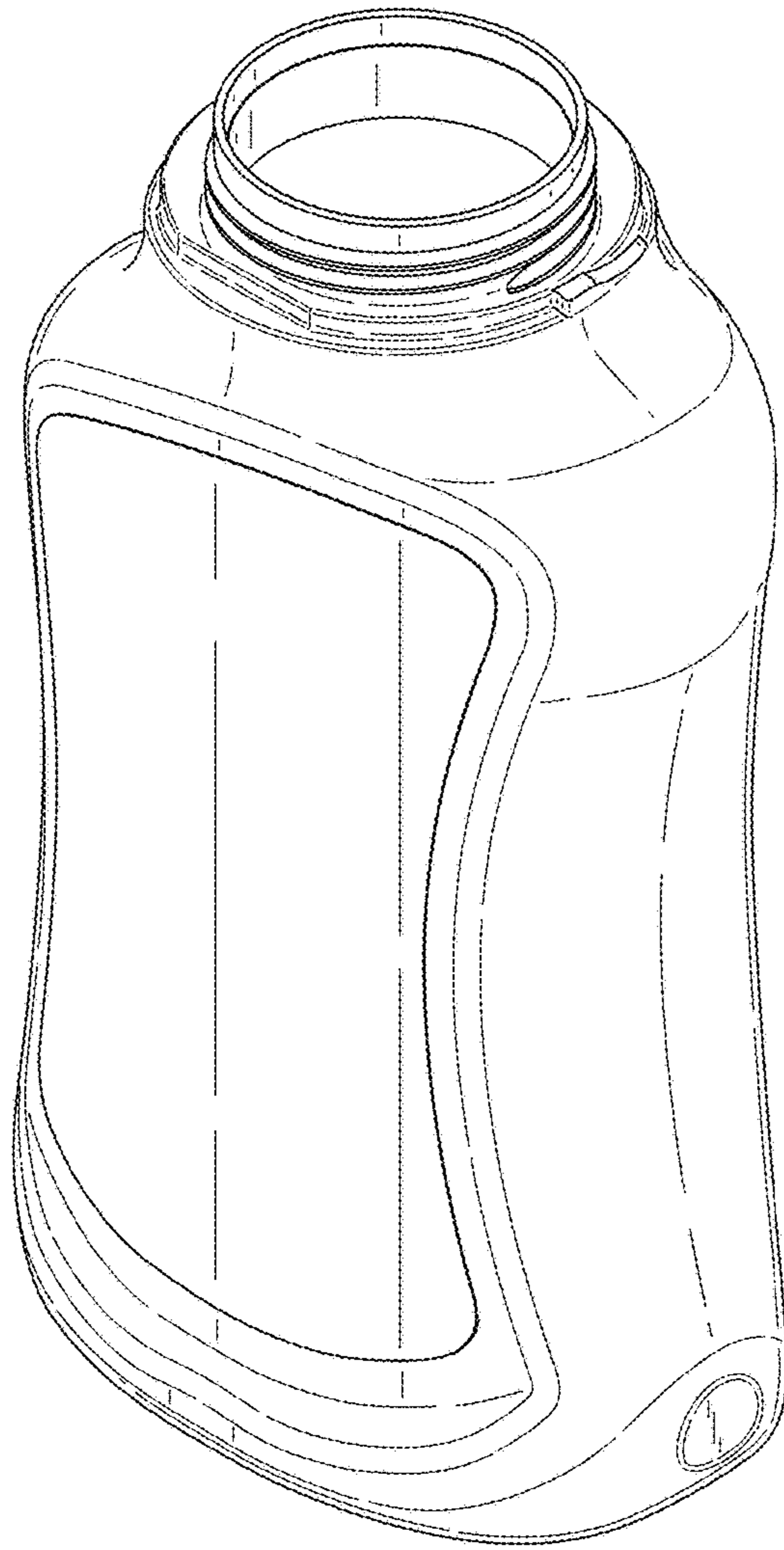

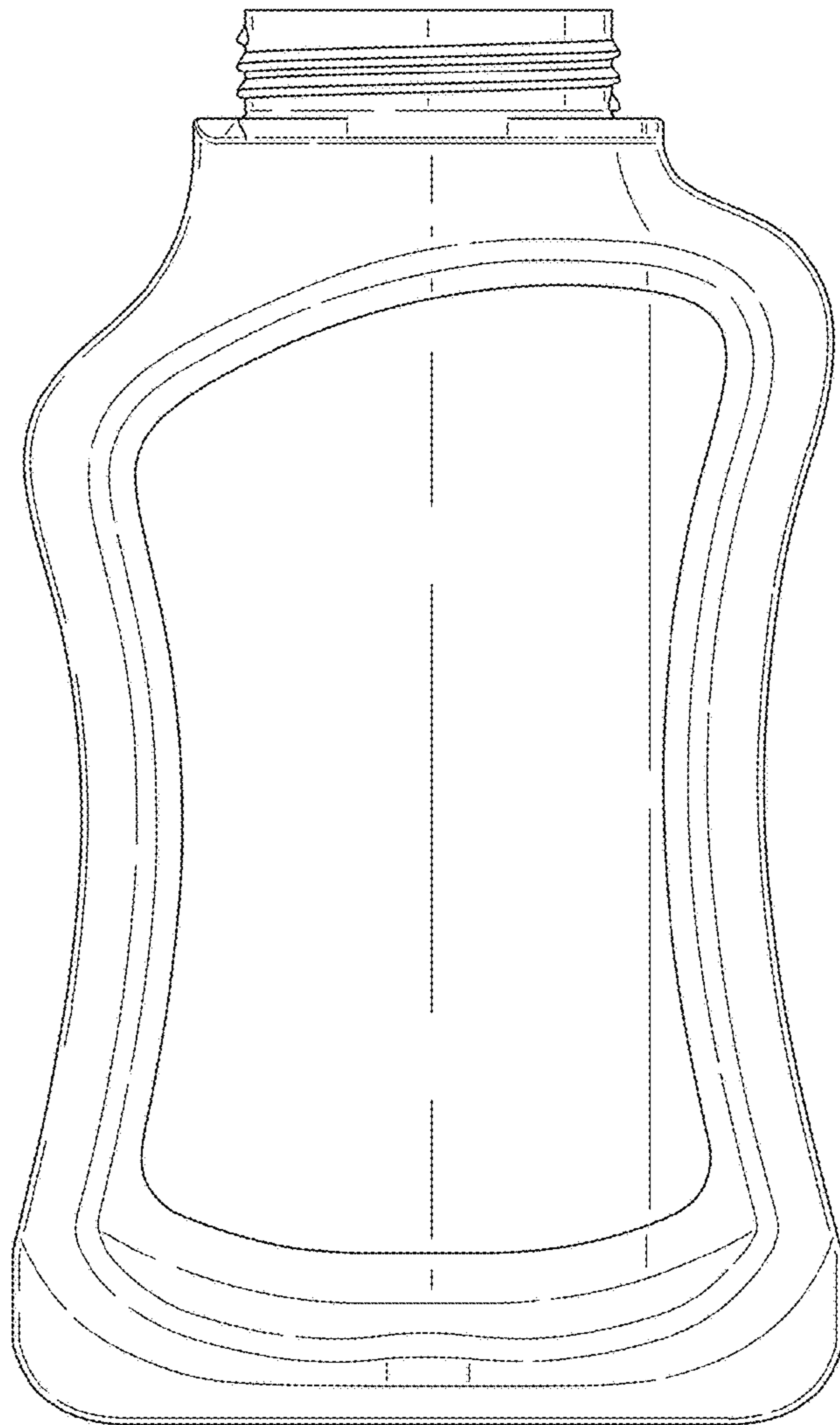

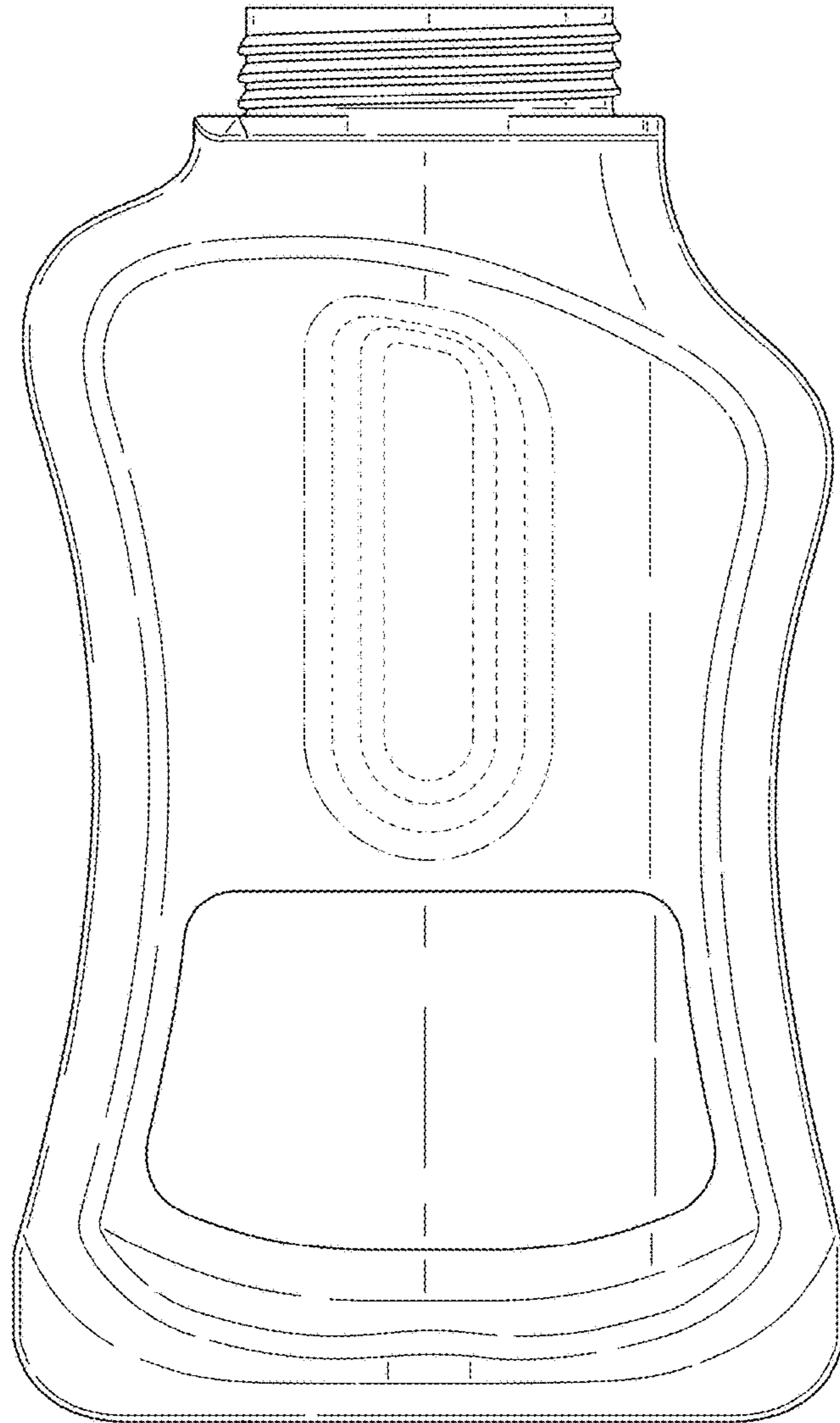

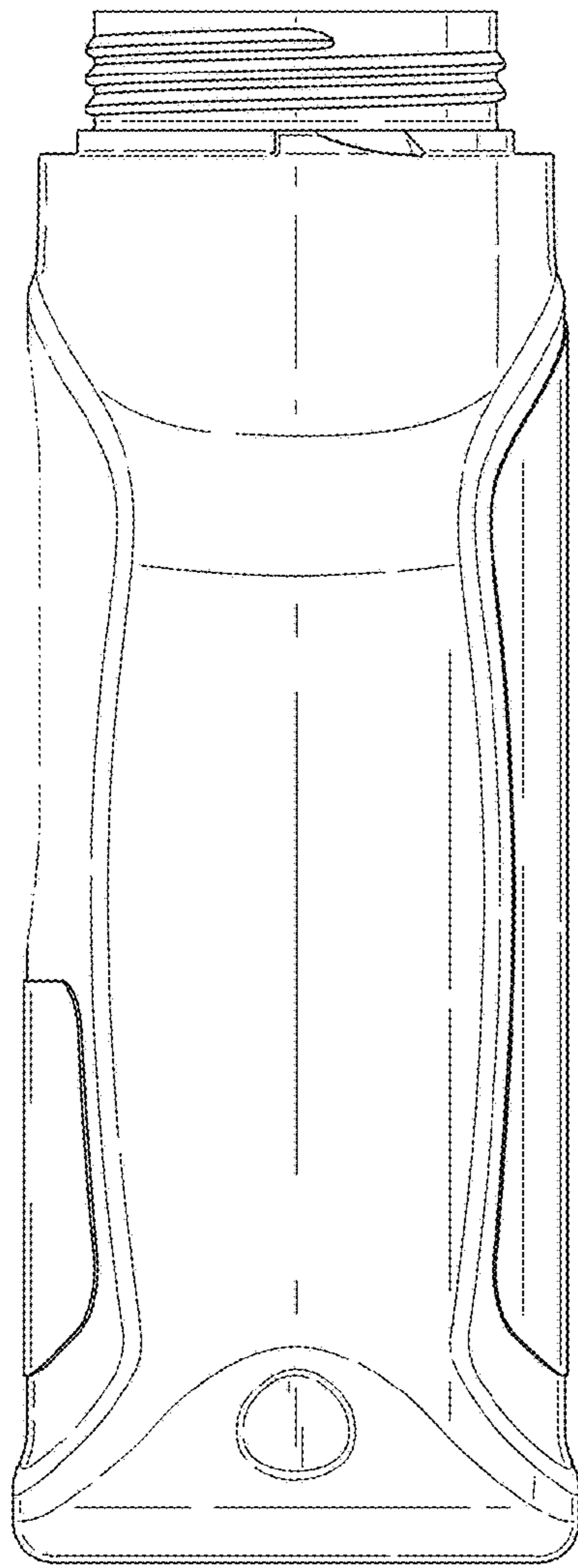

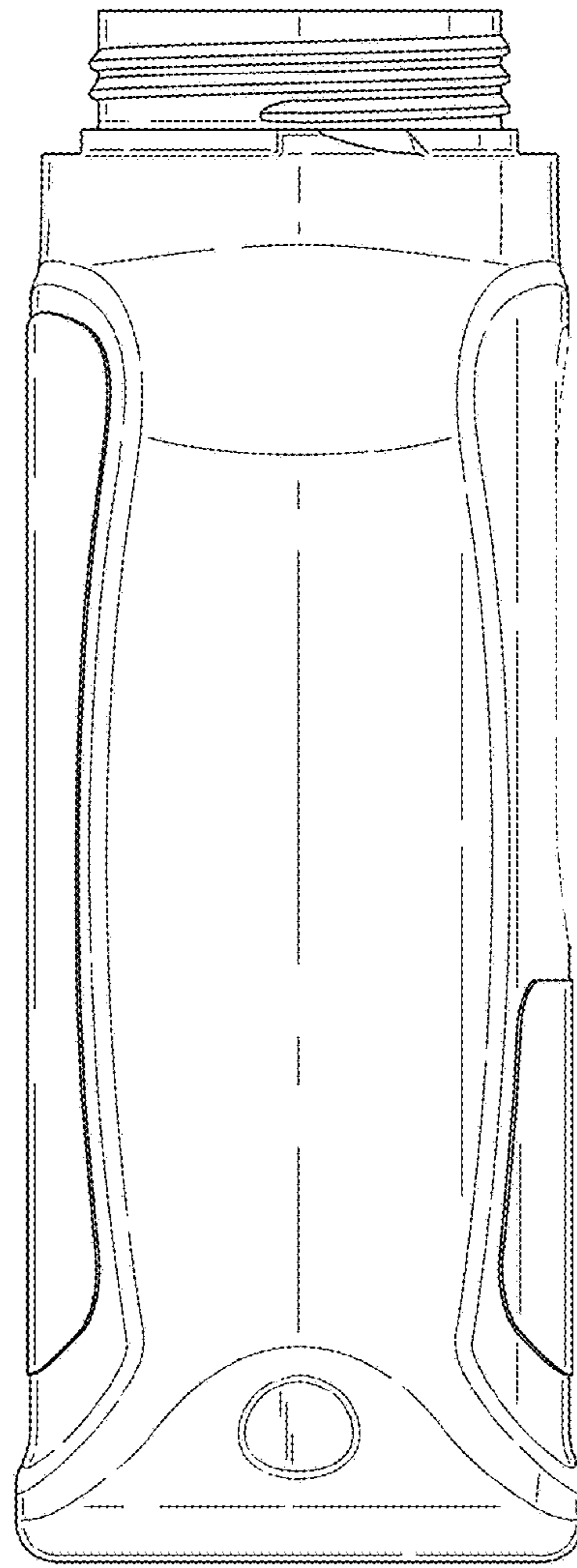

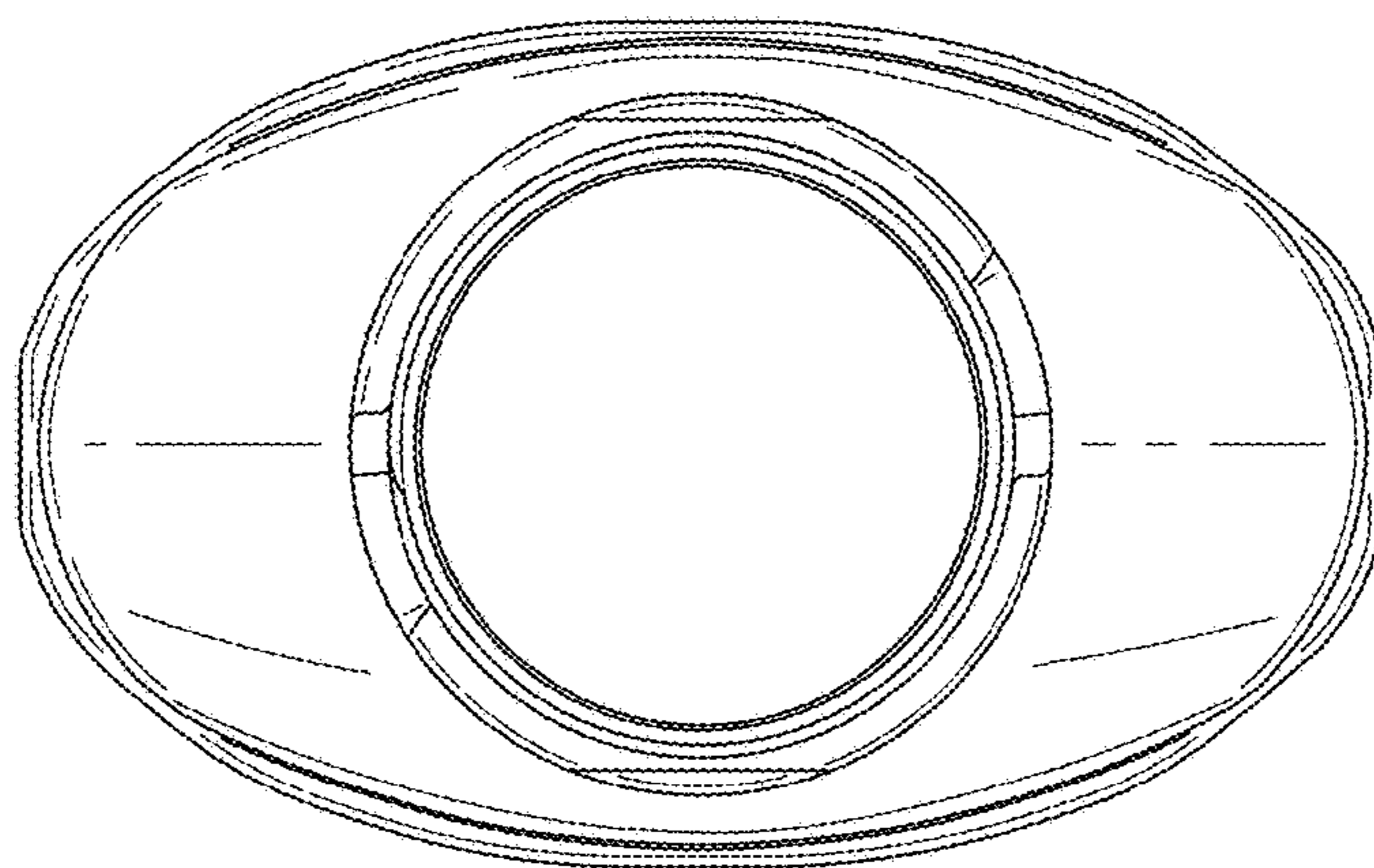

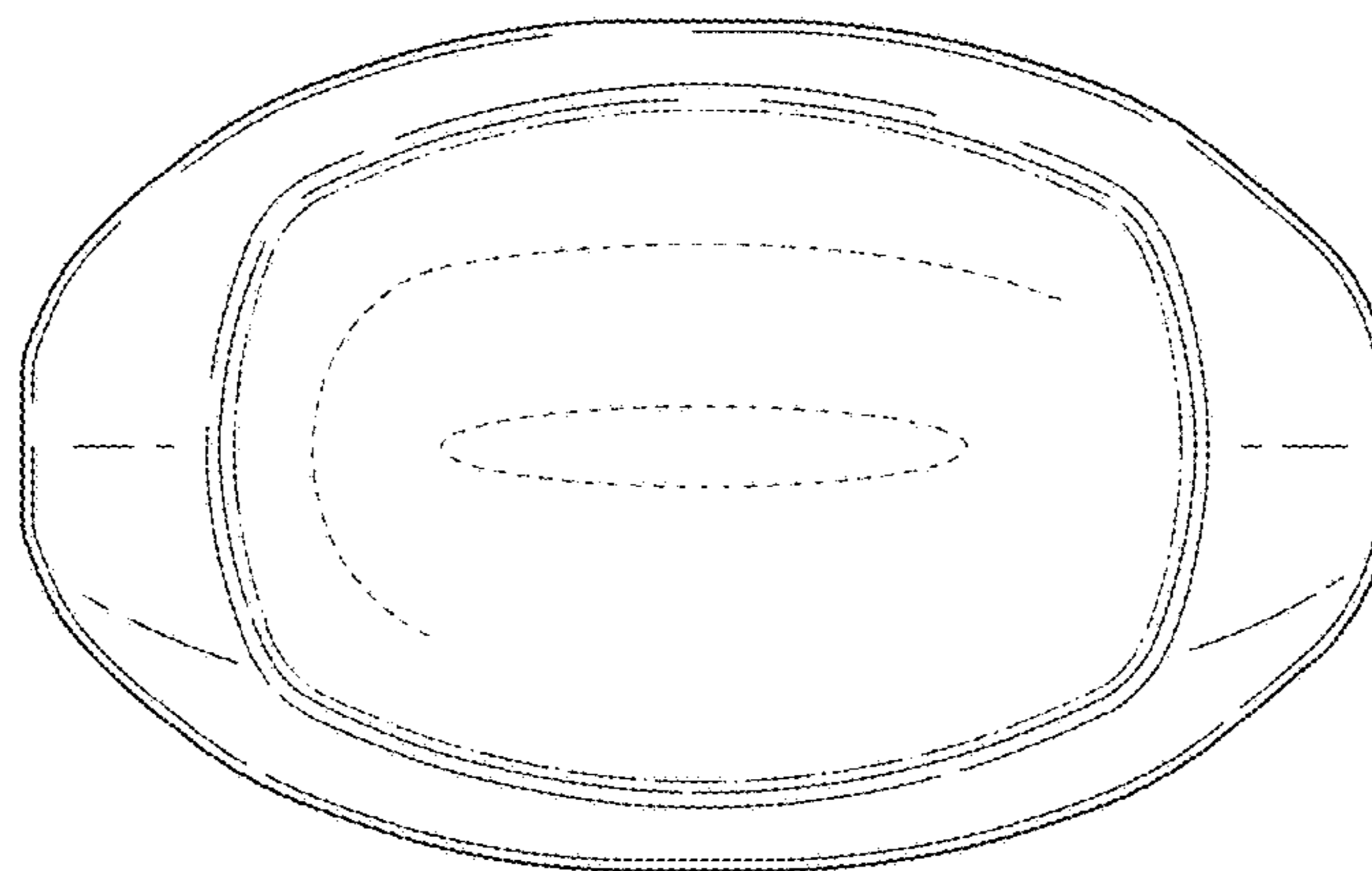
