DESCRIPTION

FIG. 1 is a front left perspective view of a wheel for a vehicle
according to the present invention.

FIG. 5 is a rear view thereof.

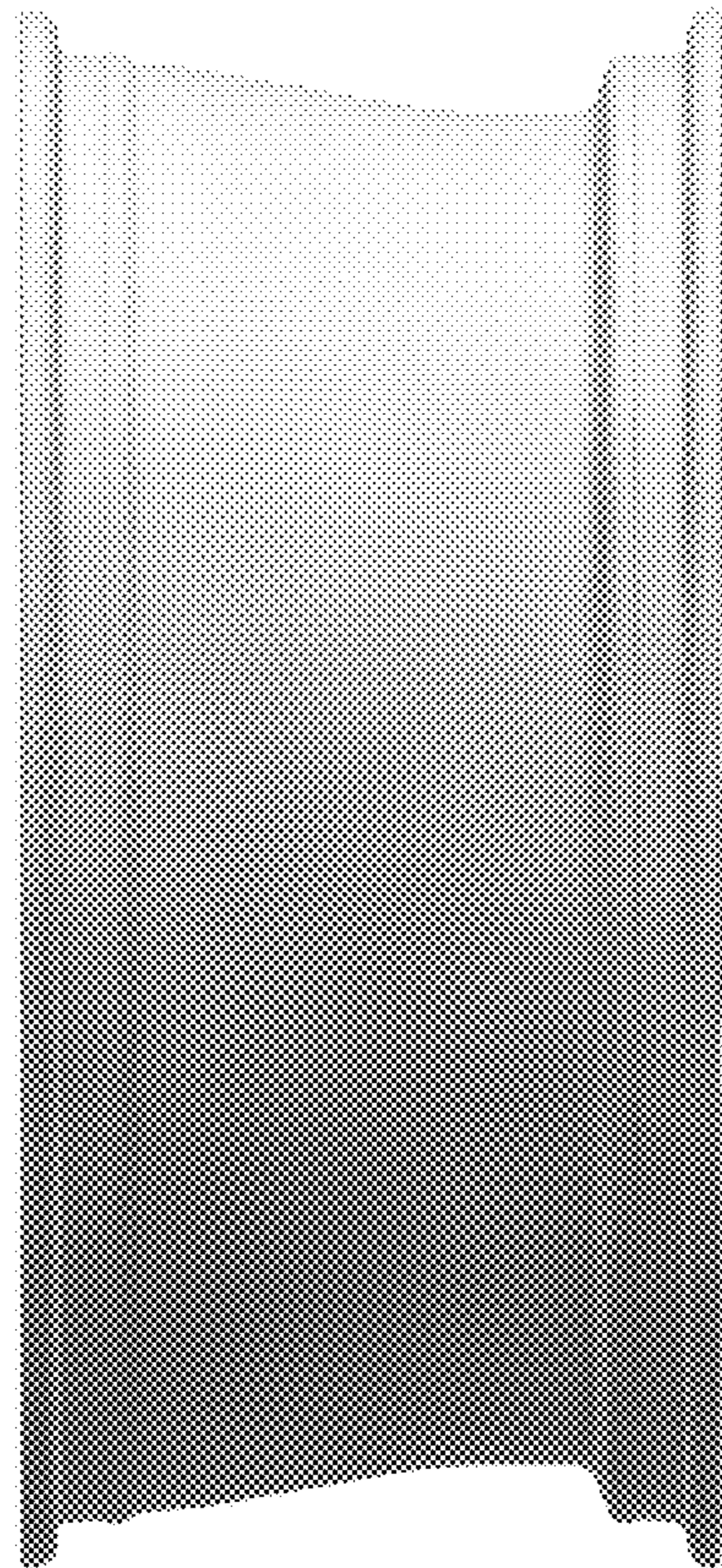
