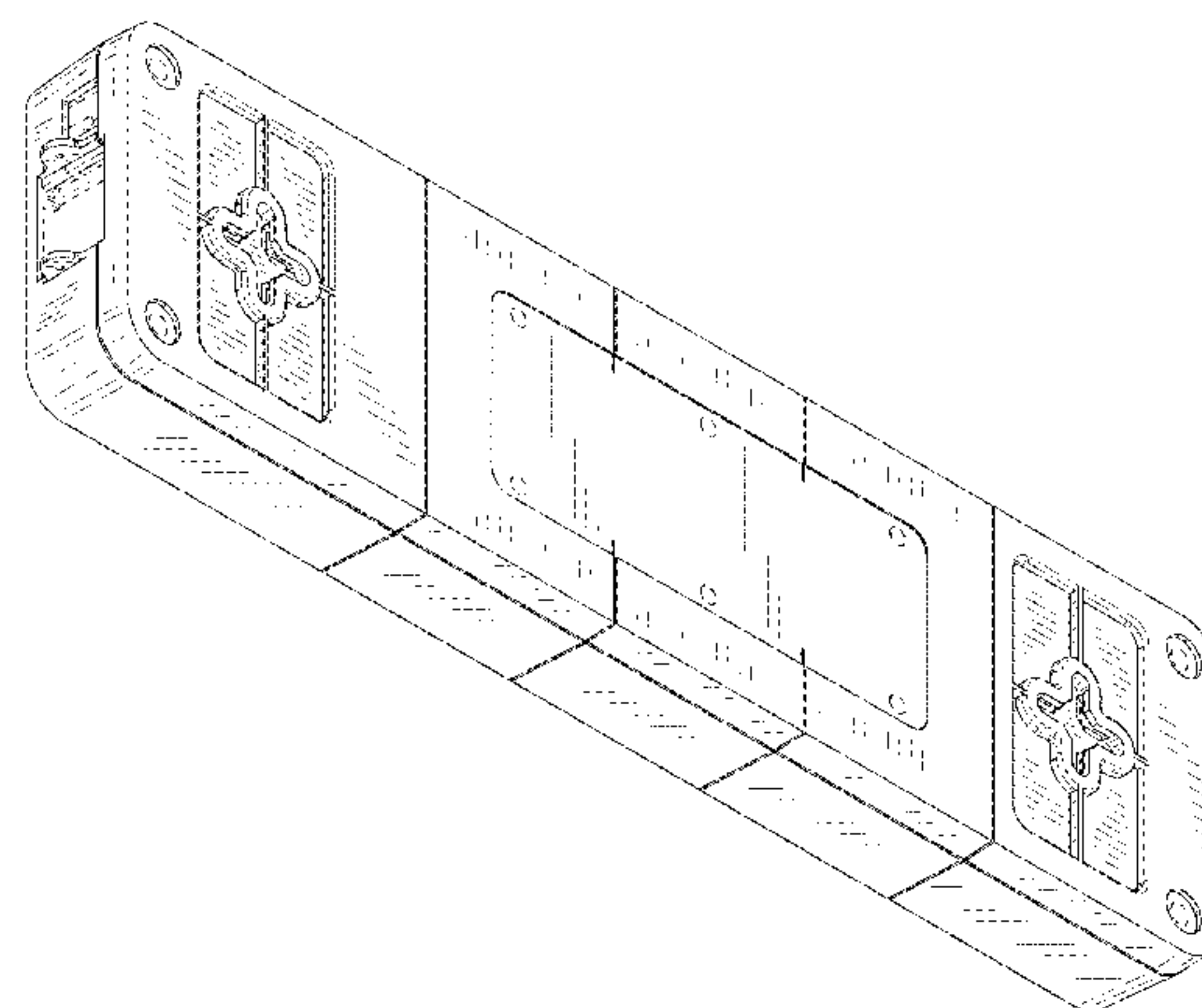
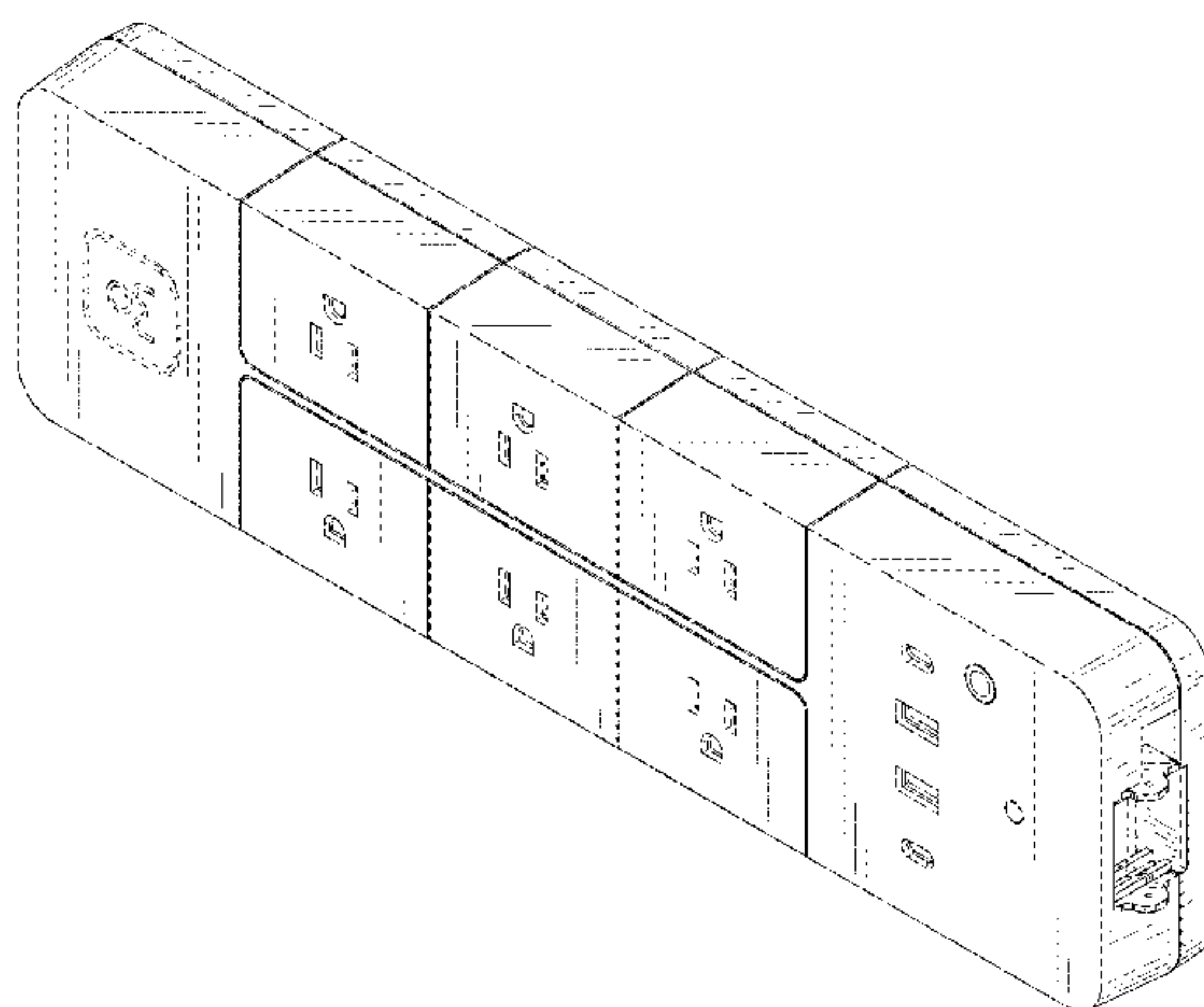
The ornamental design for a power strip, as shown and described.

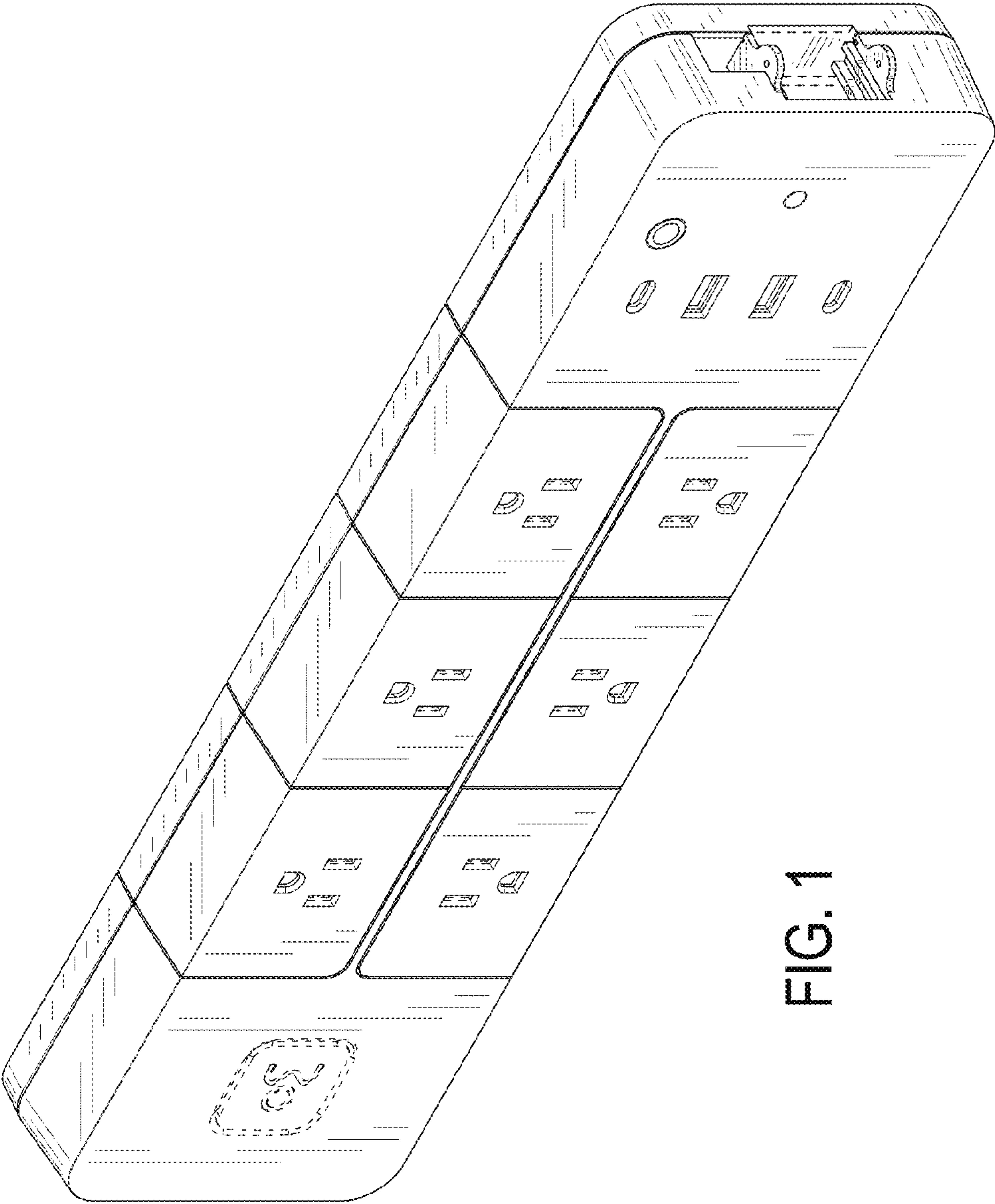

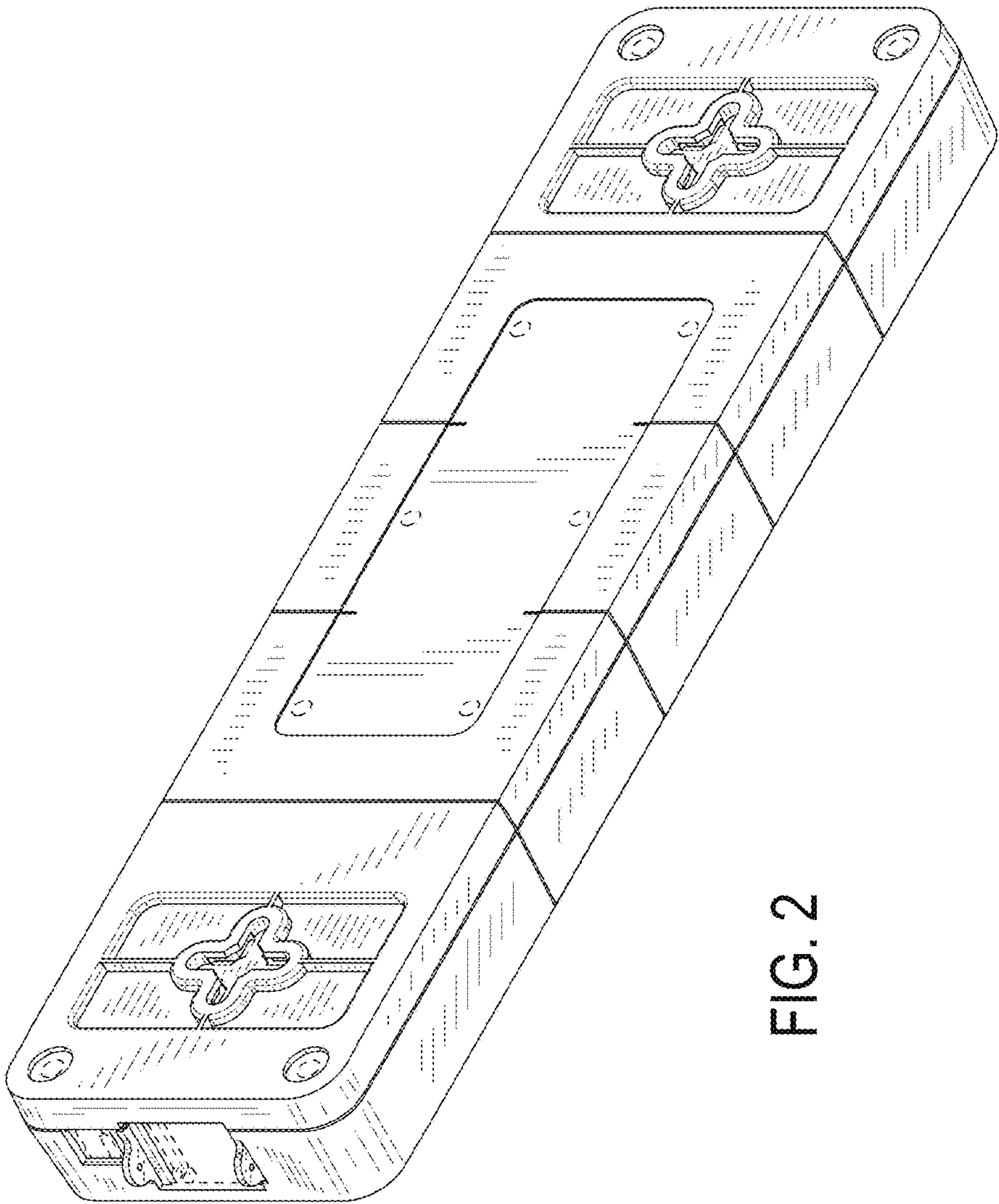

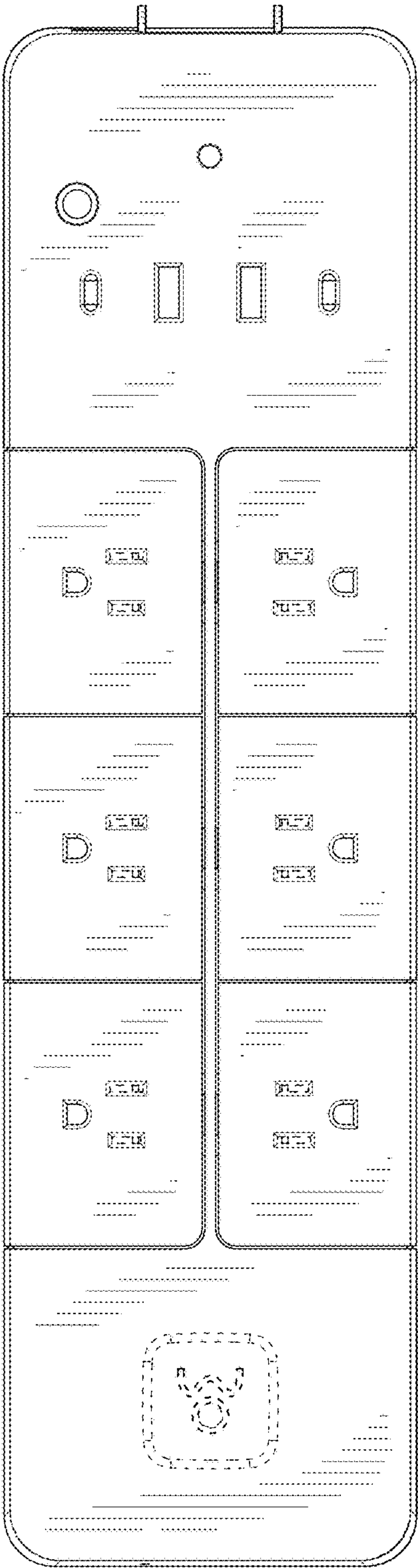

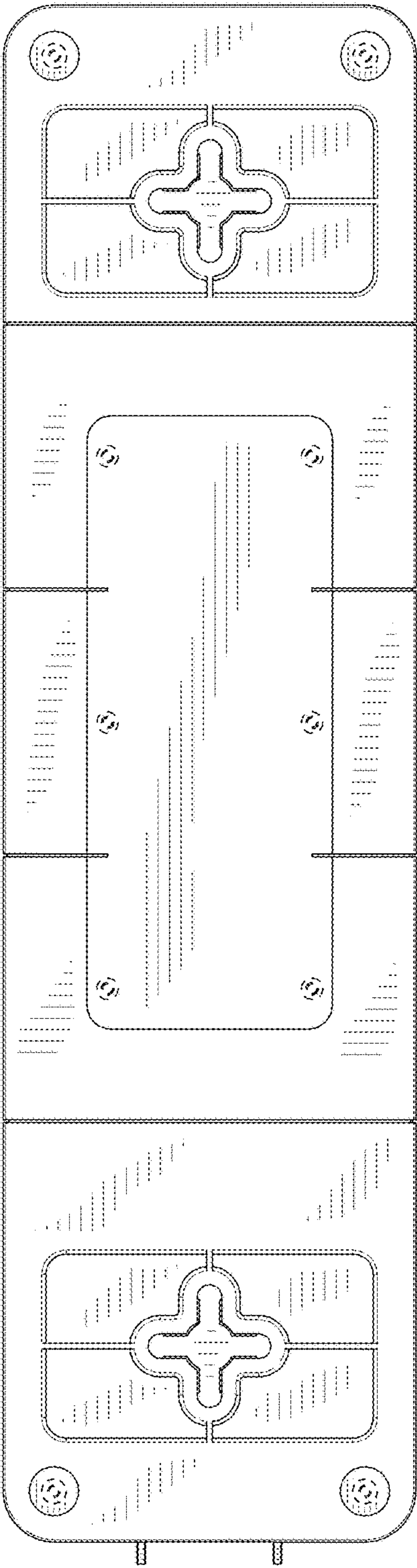

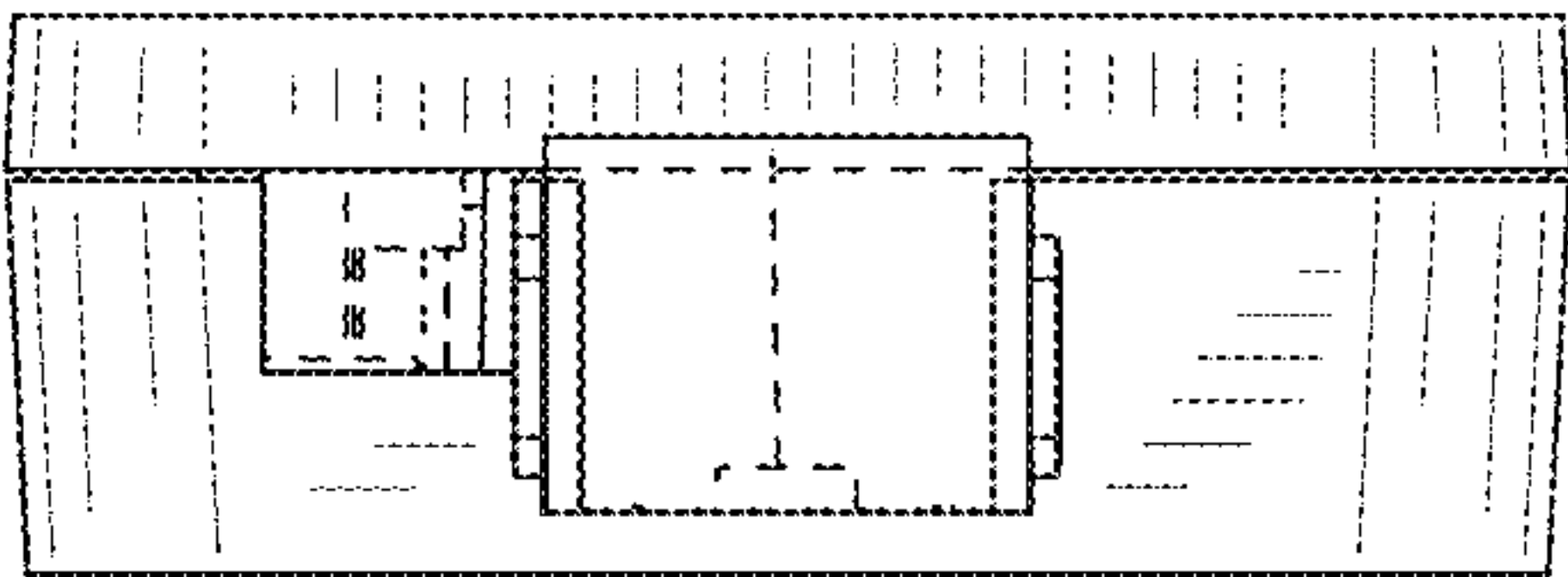

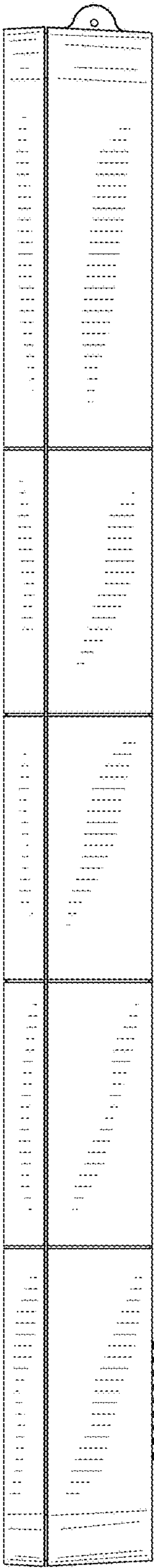

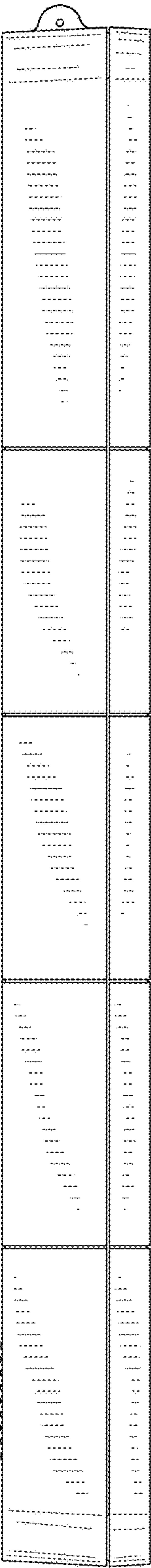
