The ornamental design for a socket connector, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a socket showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a bottom perspective view thereof; and,

FIG. 9 is a cross-section taken through line 9-9 of FIG. 6 thereof.

The broken lines in depicting the terminal connector and internal structure of the socket connector form no part of the claimed design. The grey-fill shading is used as an aid to represent surface contour and to distinguish the surfaces from one another; and no contrast in appearance is hereby claimed.



















