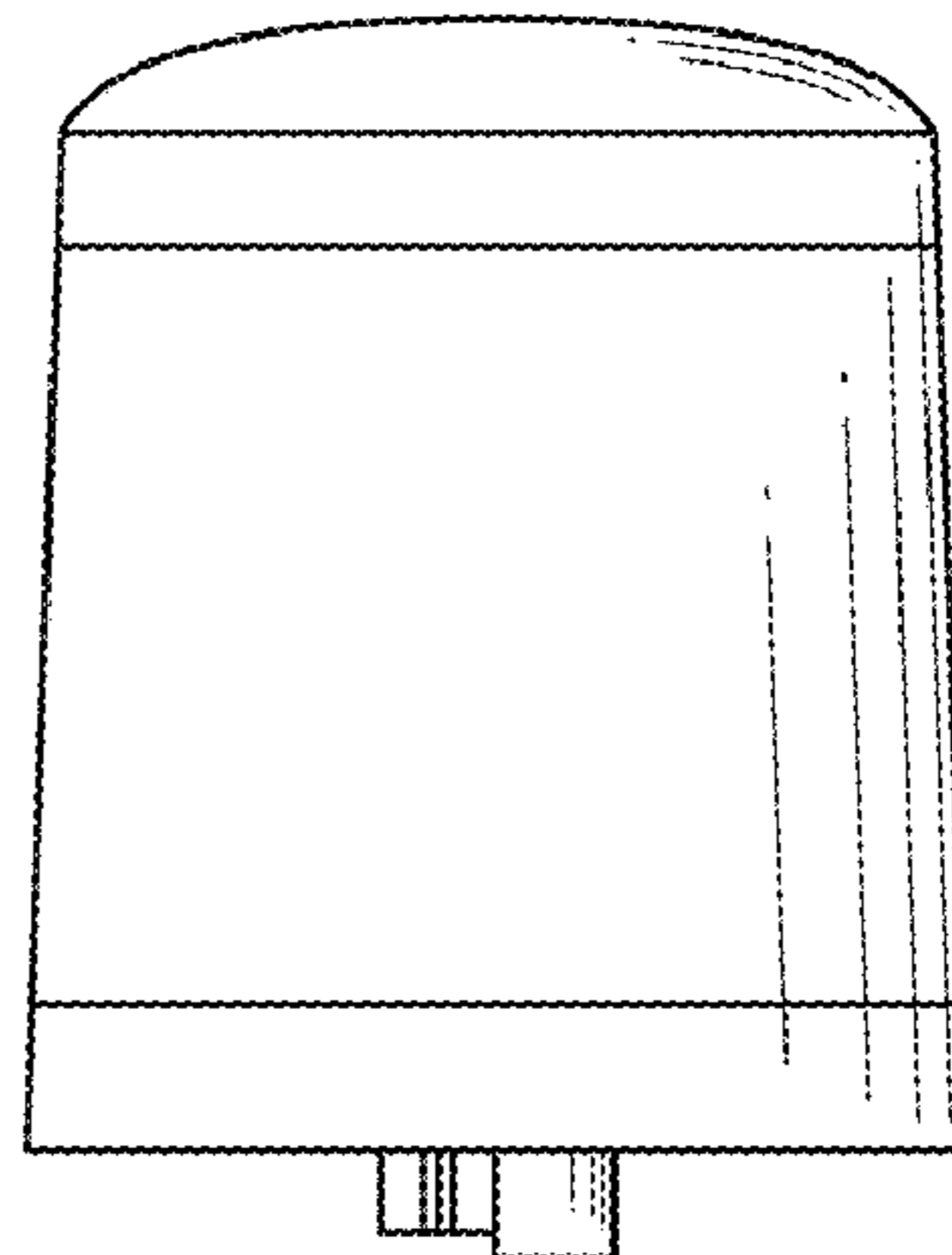
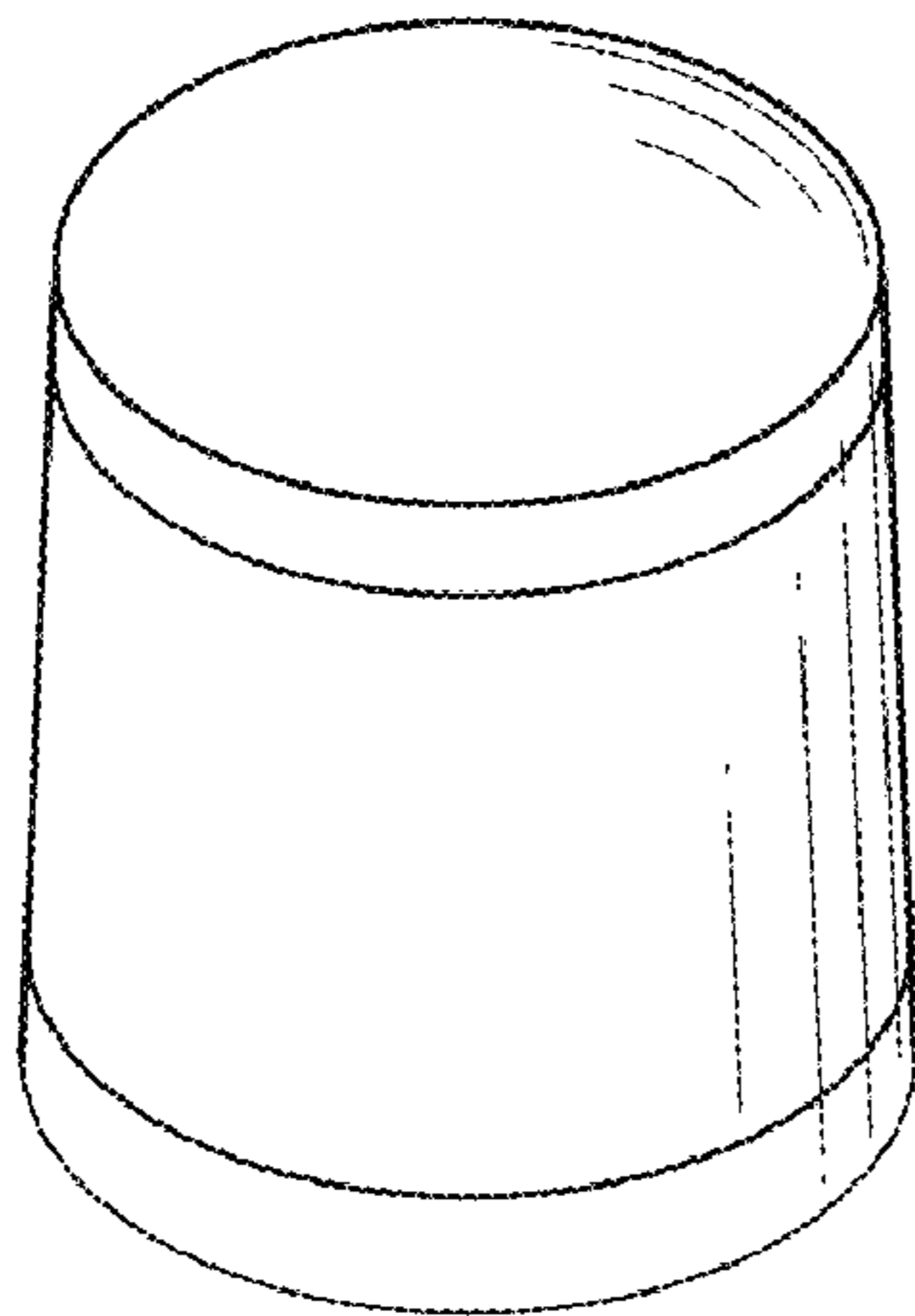
(57) **CLAIM**

The ornamental design for a wireless networking cell for mounting on an aerial lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wireless networking cell for mounting on an aerial lighting fixture showing a first embodiment of our new design.
FIG. 2 is a top plan view thereof.
FIG. 3 is a bottom plan view thereof.
FIG. 4 is an enlarged scale partial cross-sectional view thereof taken along line 4-4 of FIG. 3.
FIG. 5 is a front elevational view thereof.
FIG. 6 is a rear elevational view thereof.
FIG. 7 is a left side elevational view thereof.
FIG. 8 is a right side elevational view thereof.
FIG. 9 is a perspective view of a wireless networking cell for mounting on an aerial lighting fixture showing a second embodiment of our new design.
FIG. 10 is a top plan view thereof.
FIG. 11 is a bottom plan view thereof.
FIG. 12 is an enlarged scale partial cross-sectional view thereof taken along line 12-12 of FIG. 11.
FIG. 13 is a front elevational view thereof.
FIG. 14 is a rear elevational view thereof.
FIG. 15 is a left side elevational view thereof; and,
FIG. 16 is a right side elevational view thereof.
The dot-dash and the dash-dash broken lines, adjacent to the shaded surfaces in FIGS. 3 and 11, define the boundary of the claim, which extends to the boundary but does not include the boundary, while all other broken lines depict portions of the wireless networking cell for mounting on an aerial lighting fixture that form no part of the claimed design. Shading lines shown in the drawings are intended to represent the approximate three-dimensional contour of the design and are not intended to indicate surface decoration.

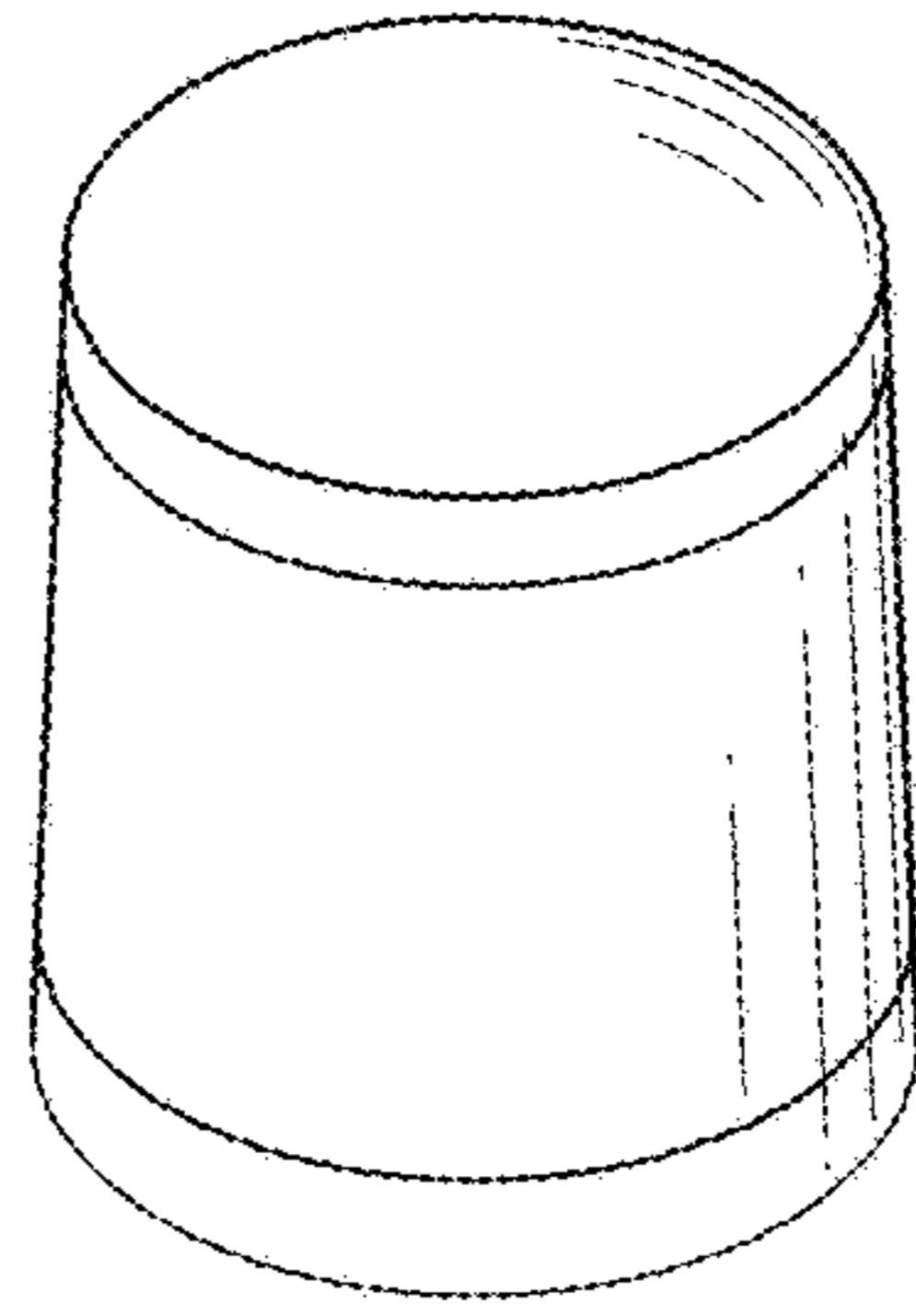

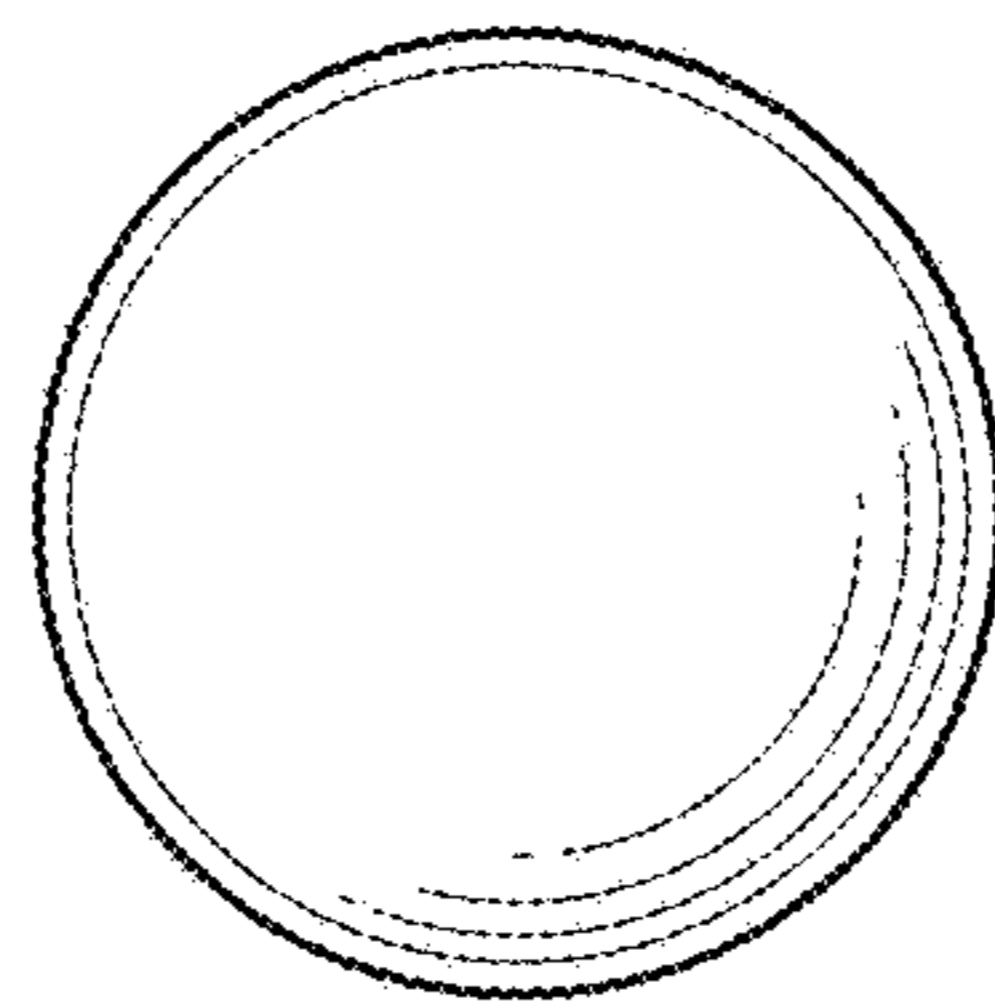

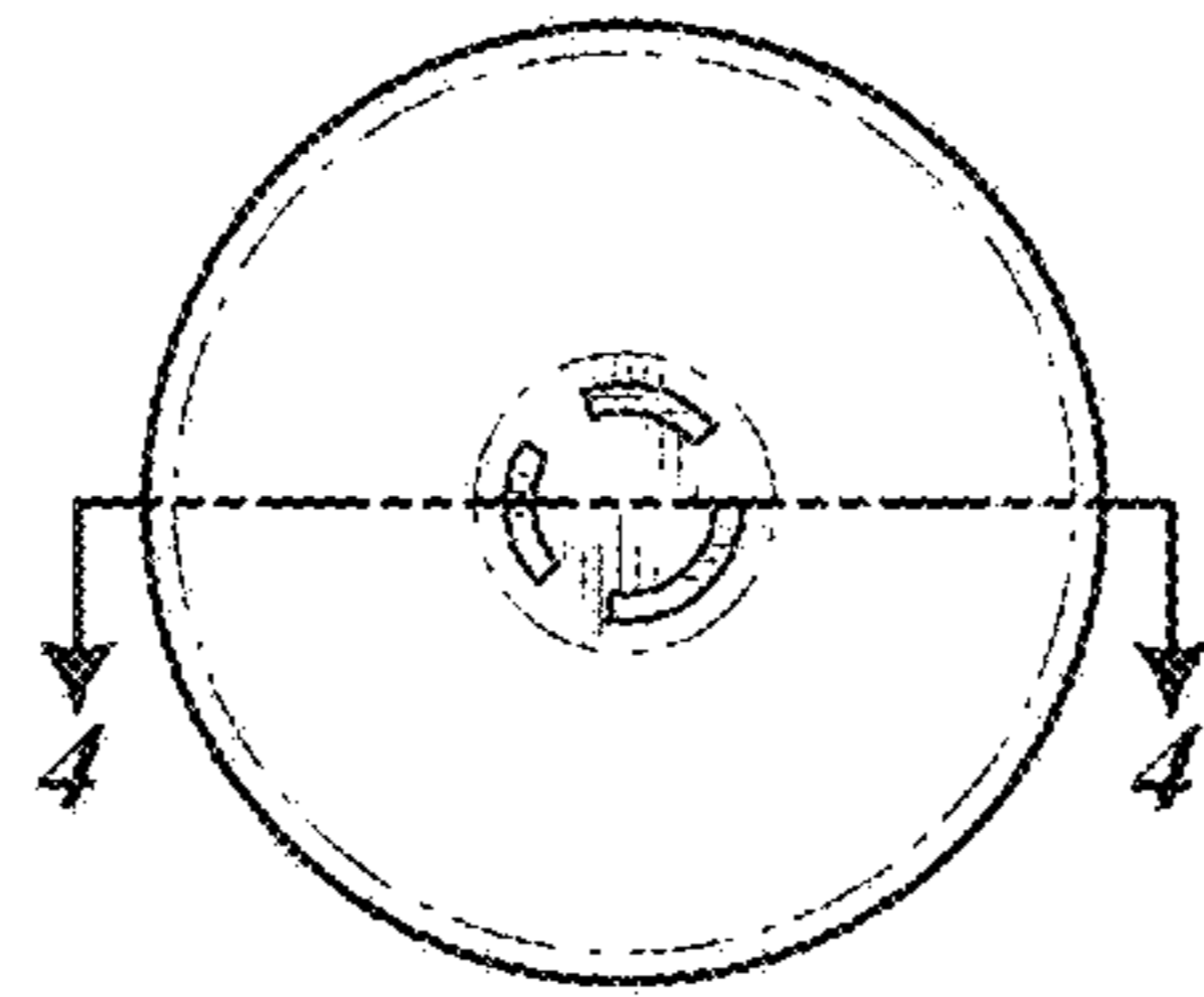

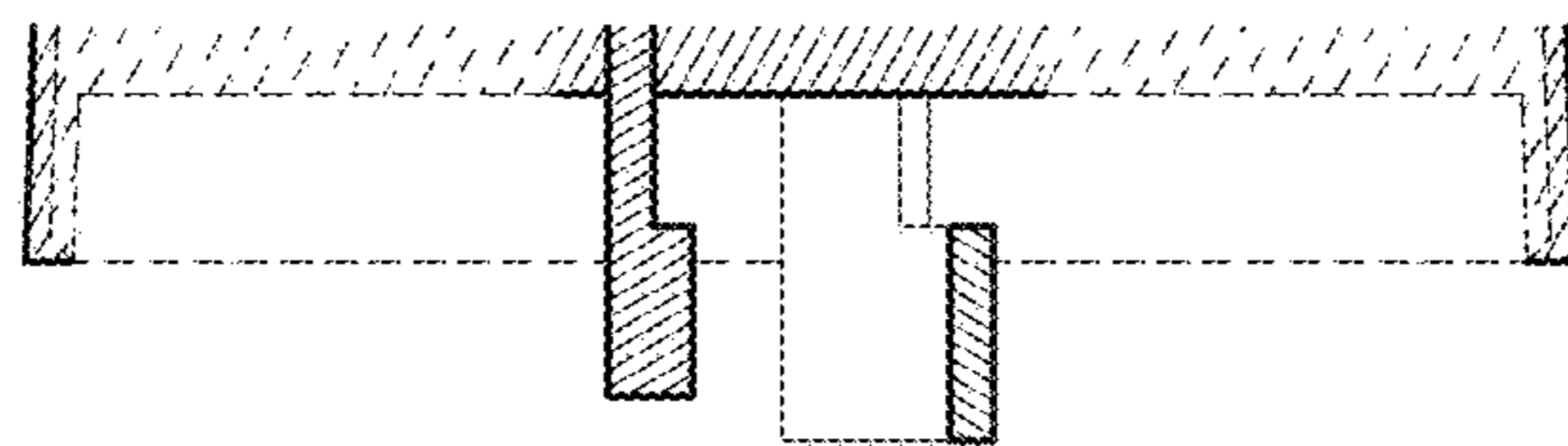

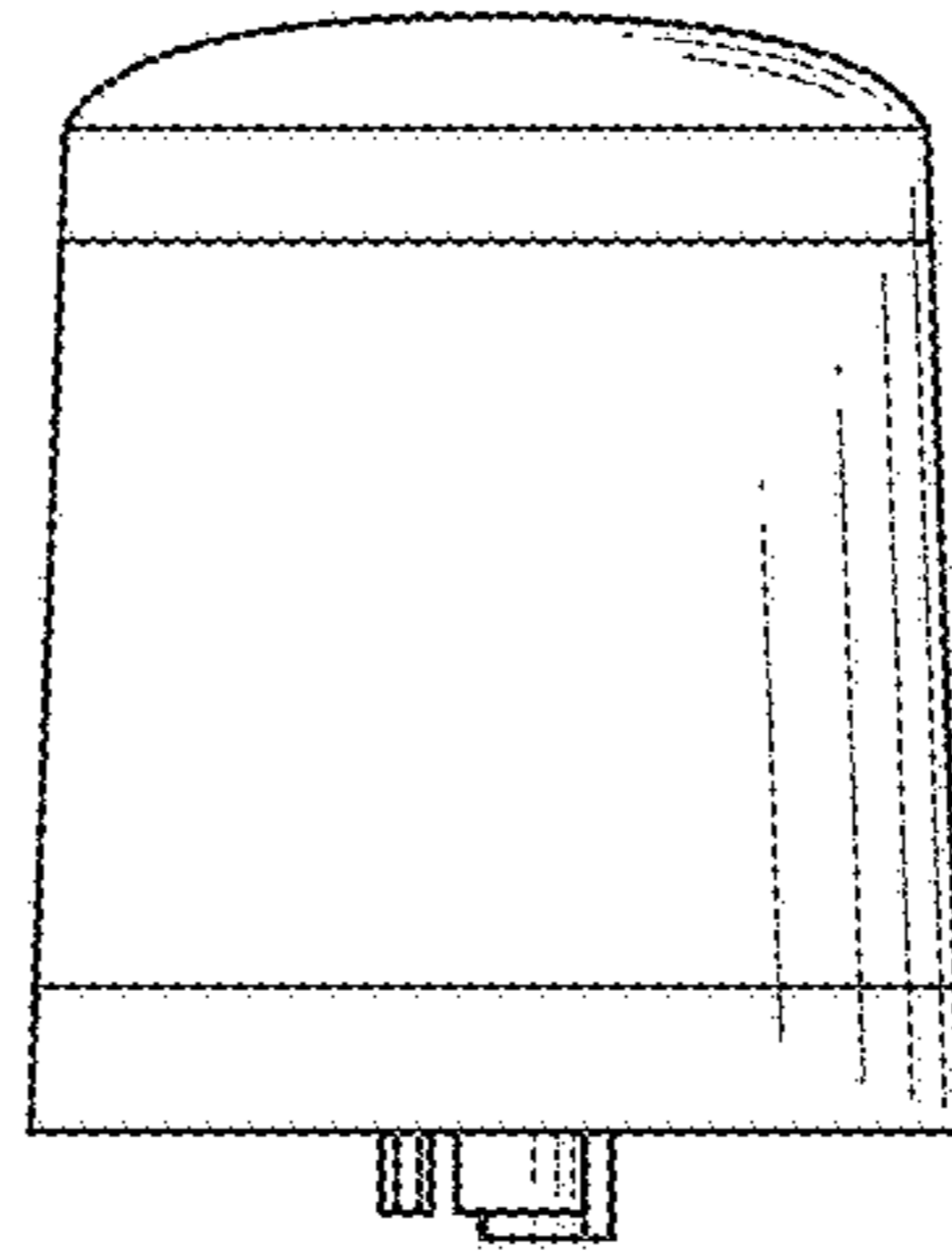

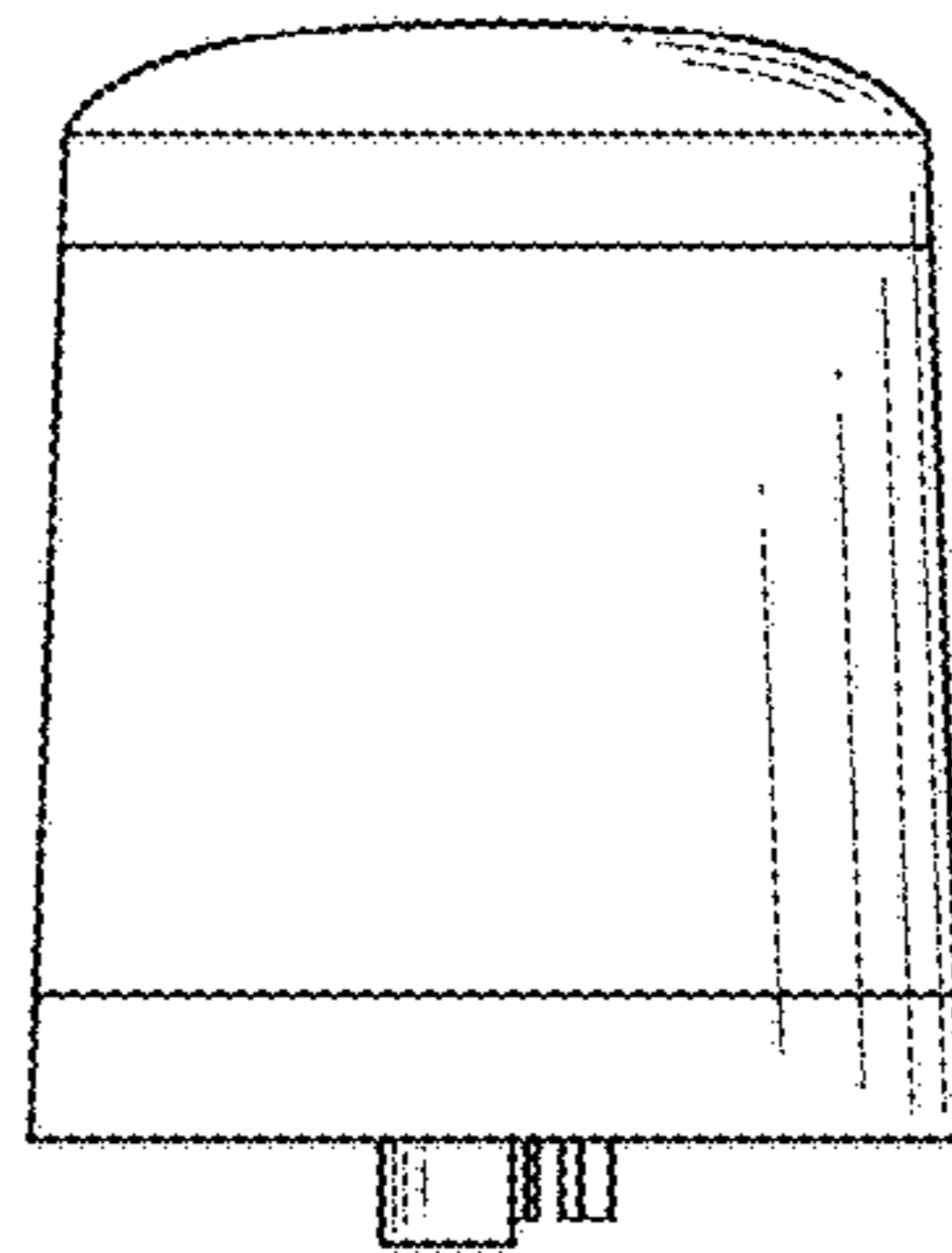

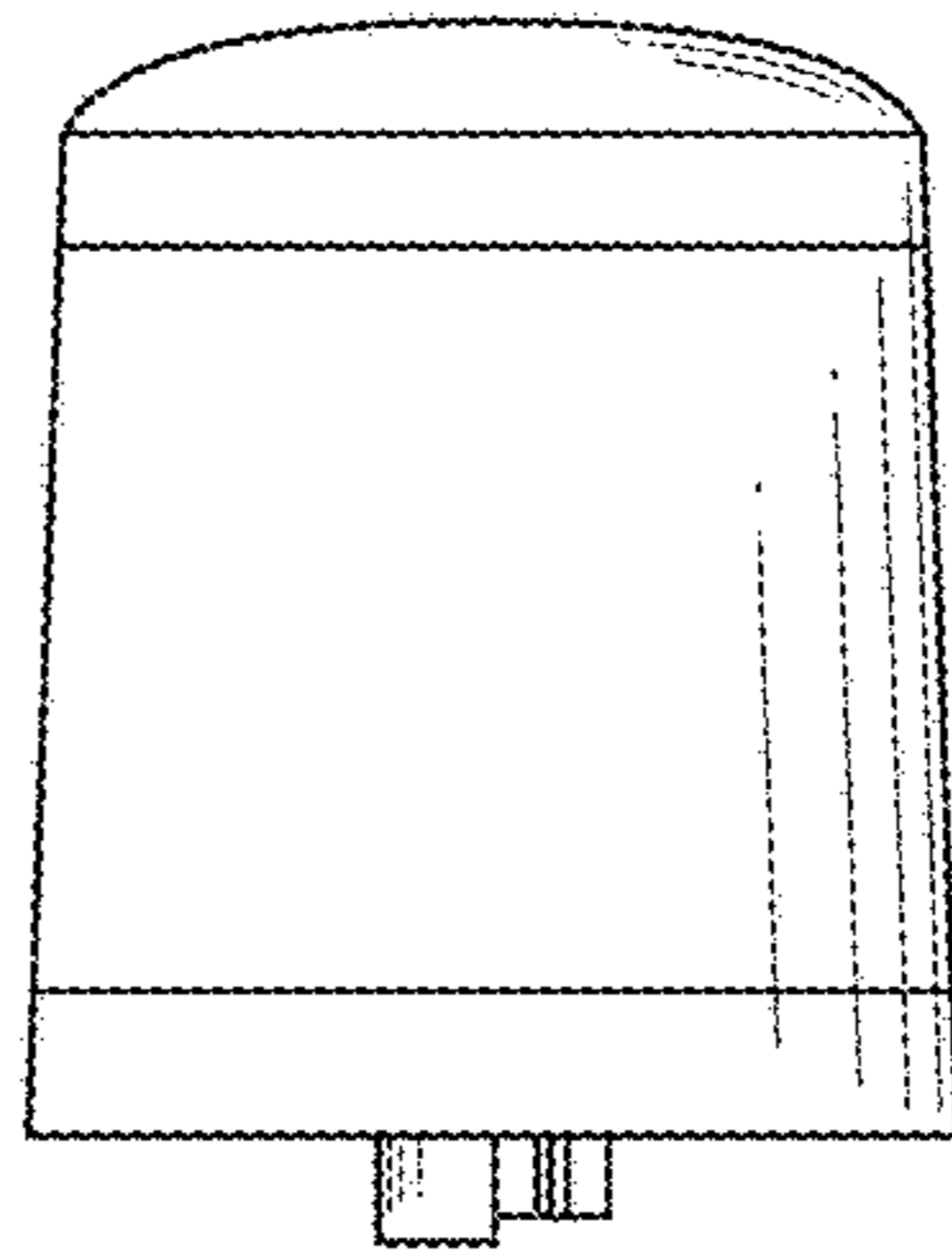

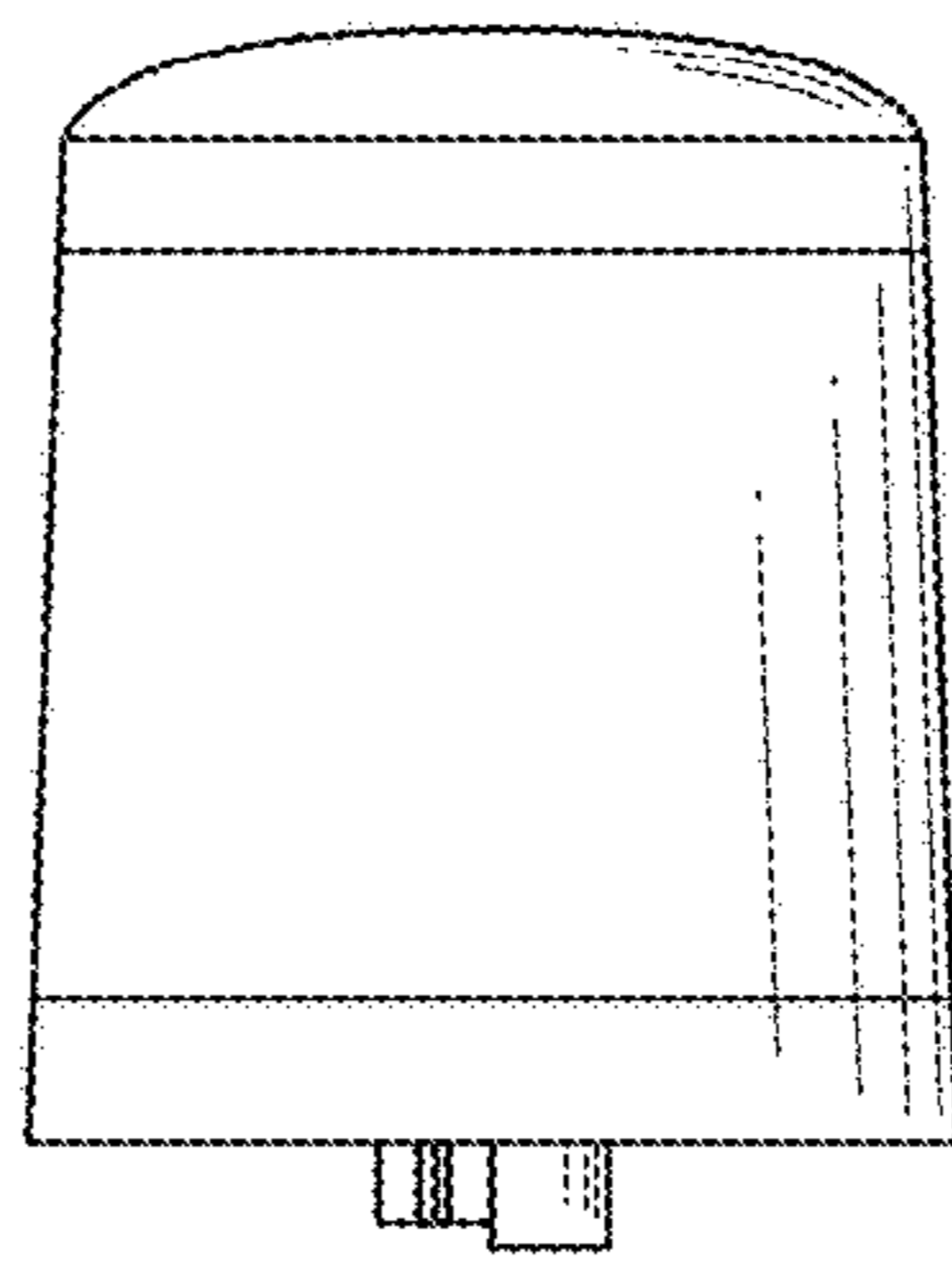

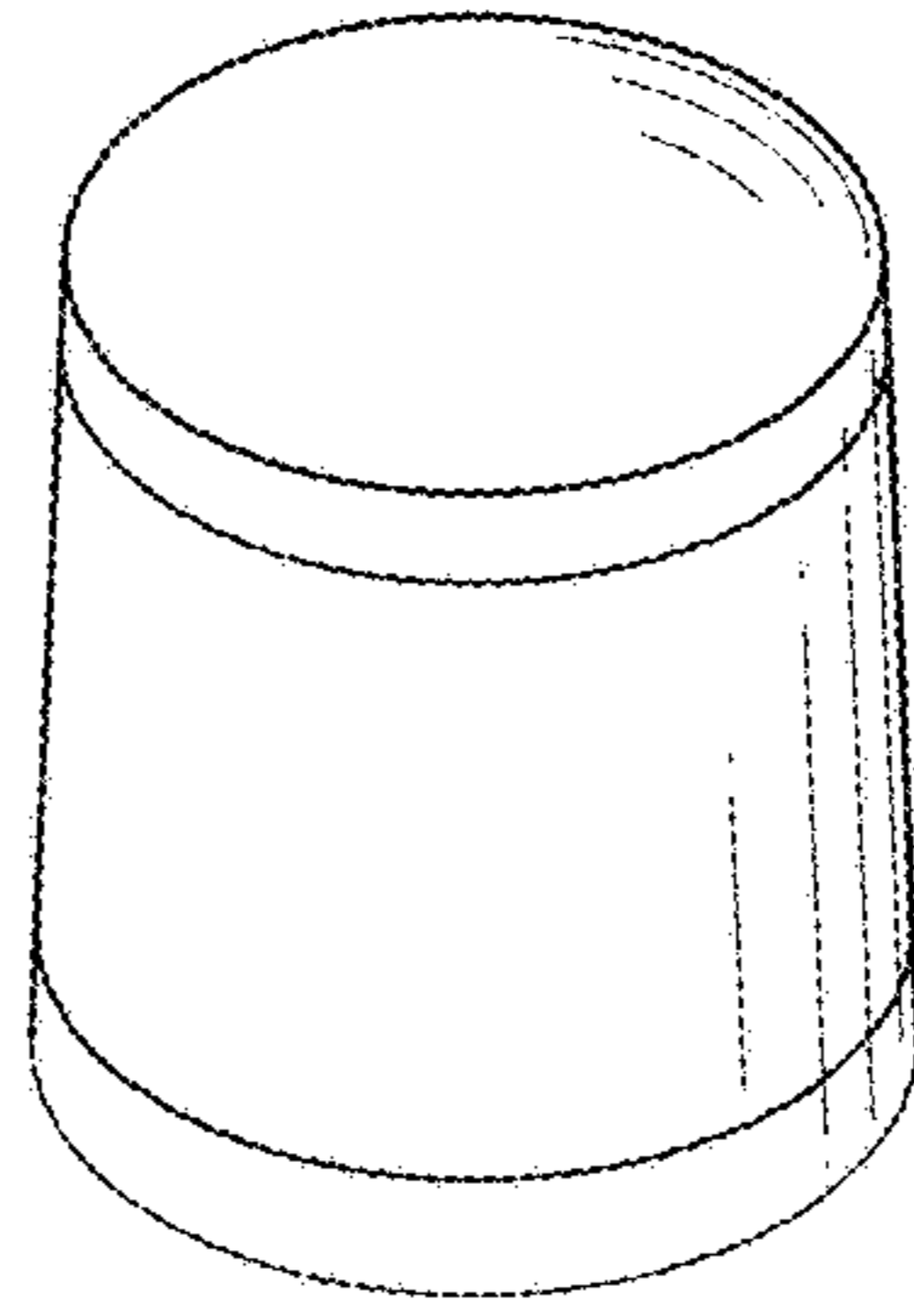

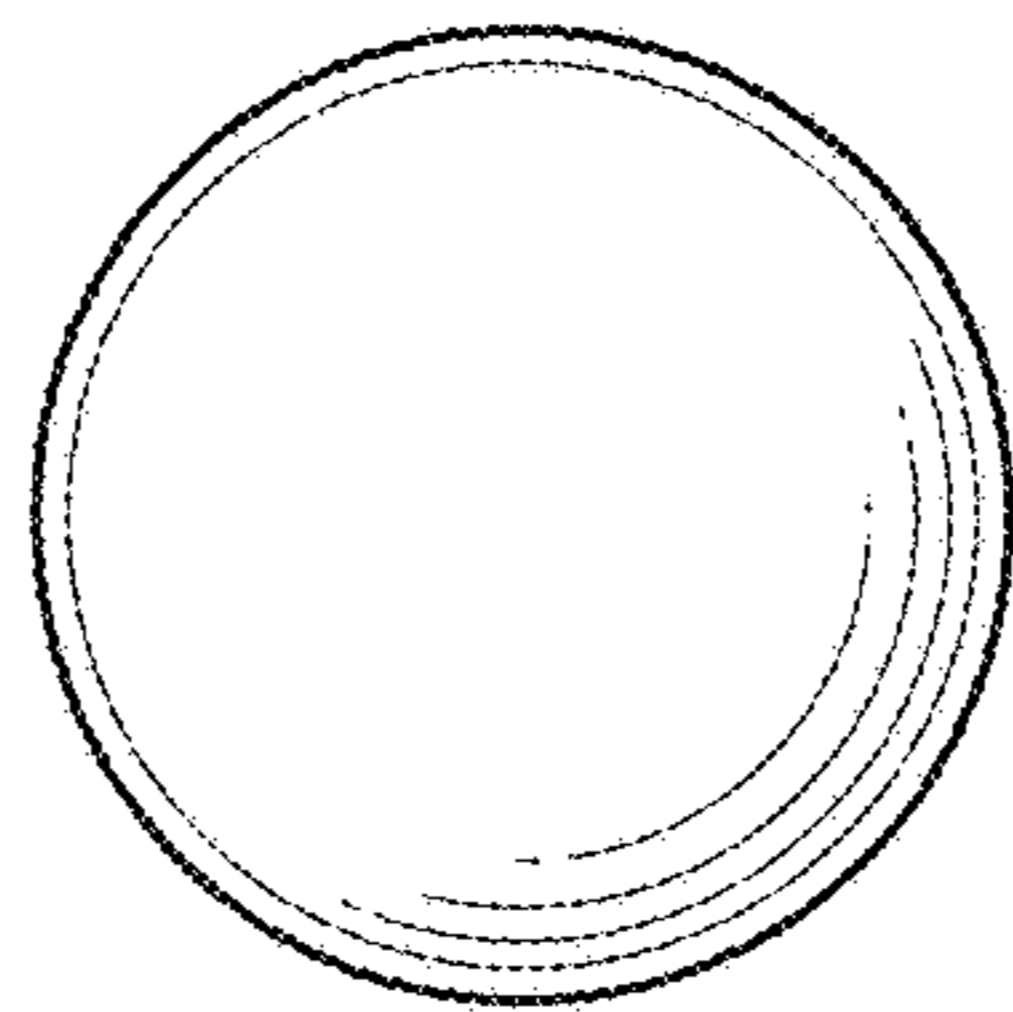

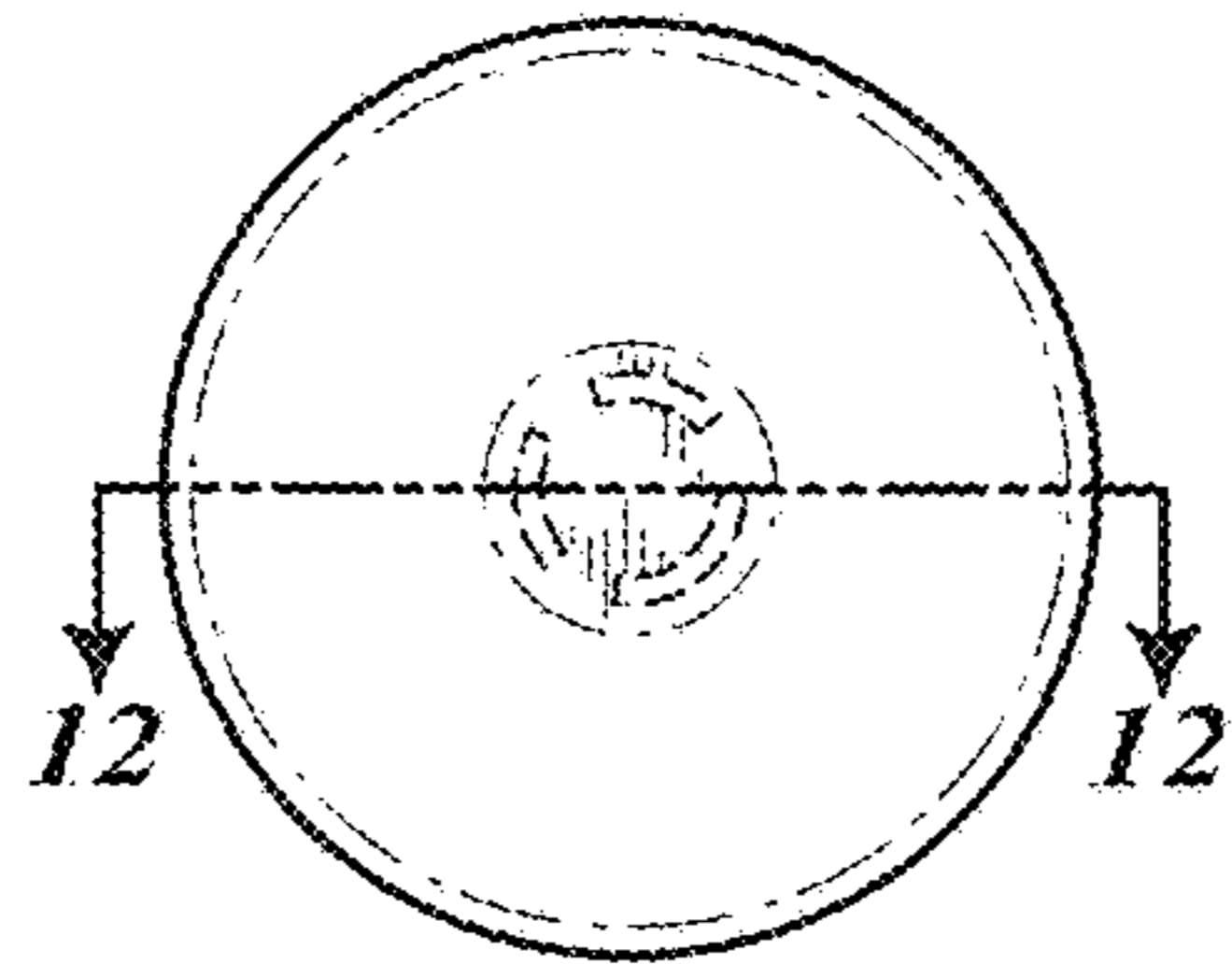

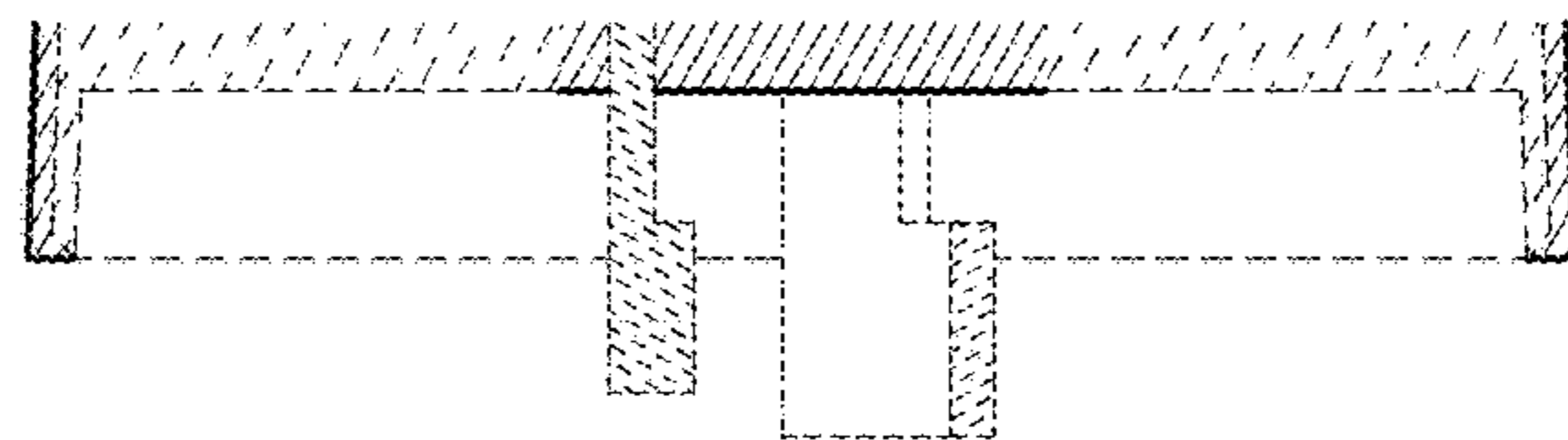

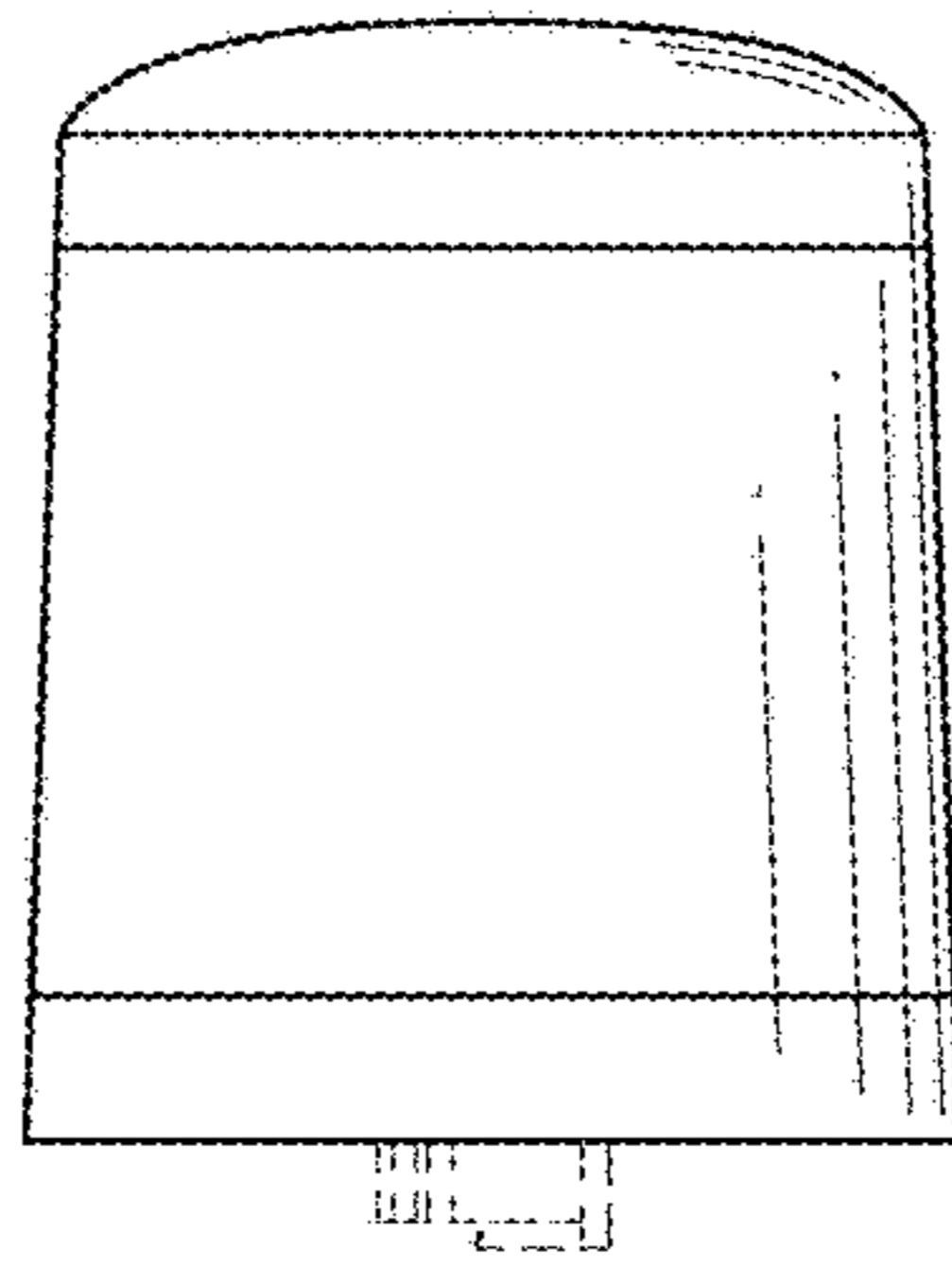

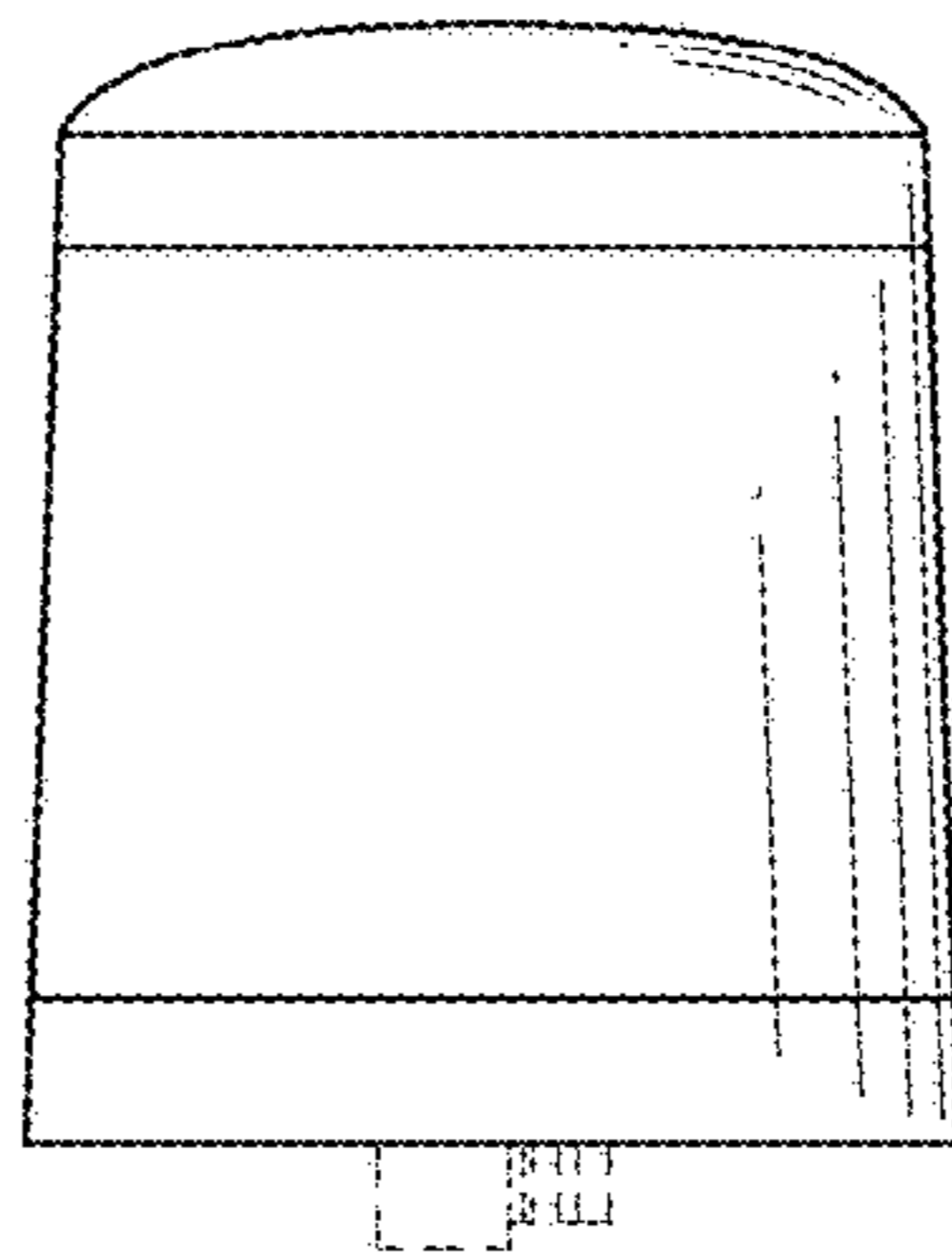

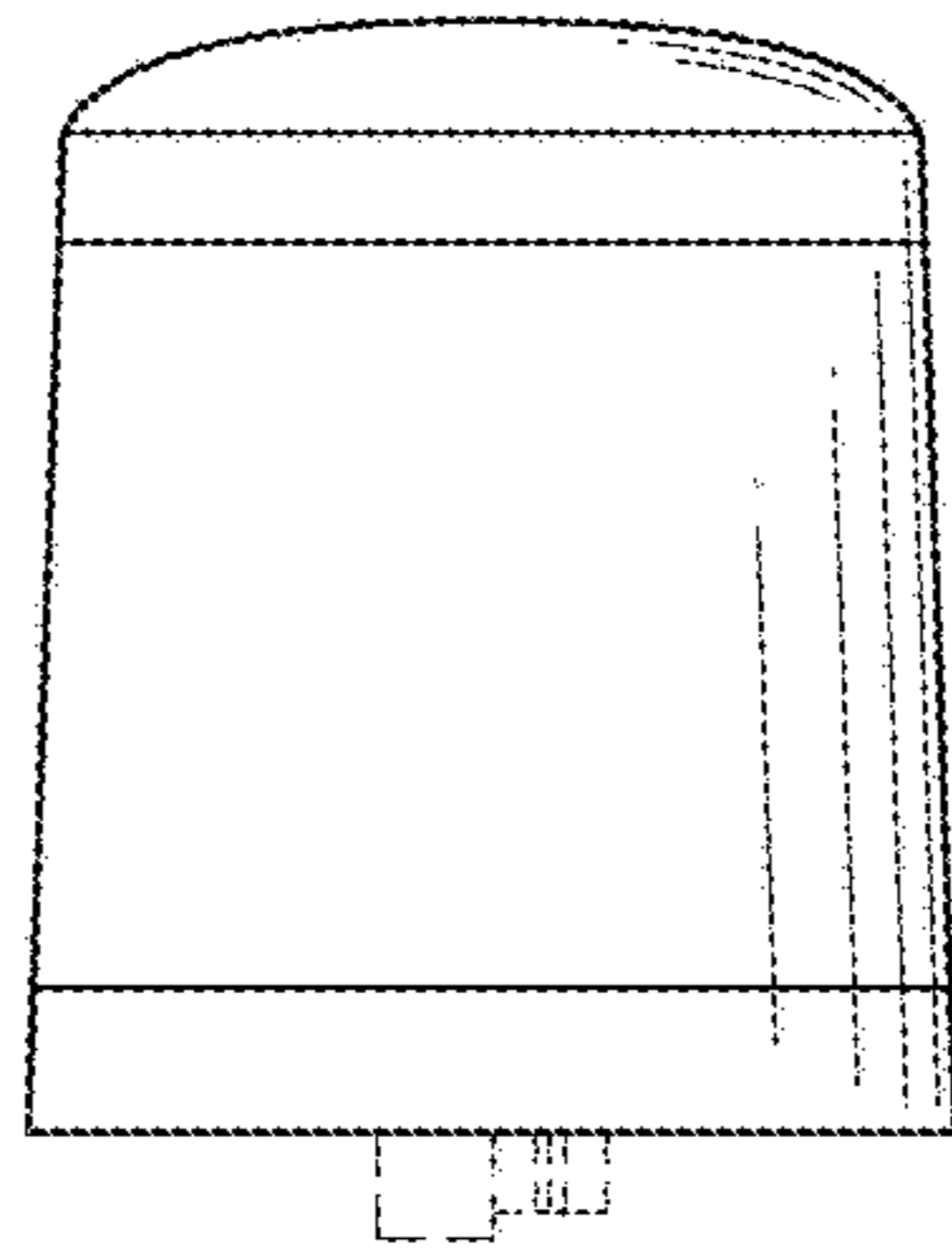

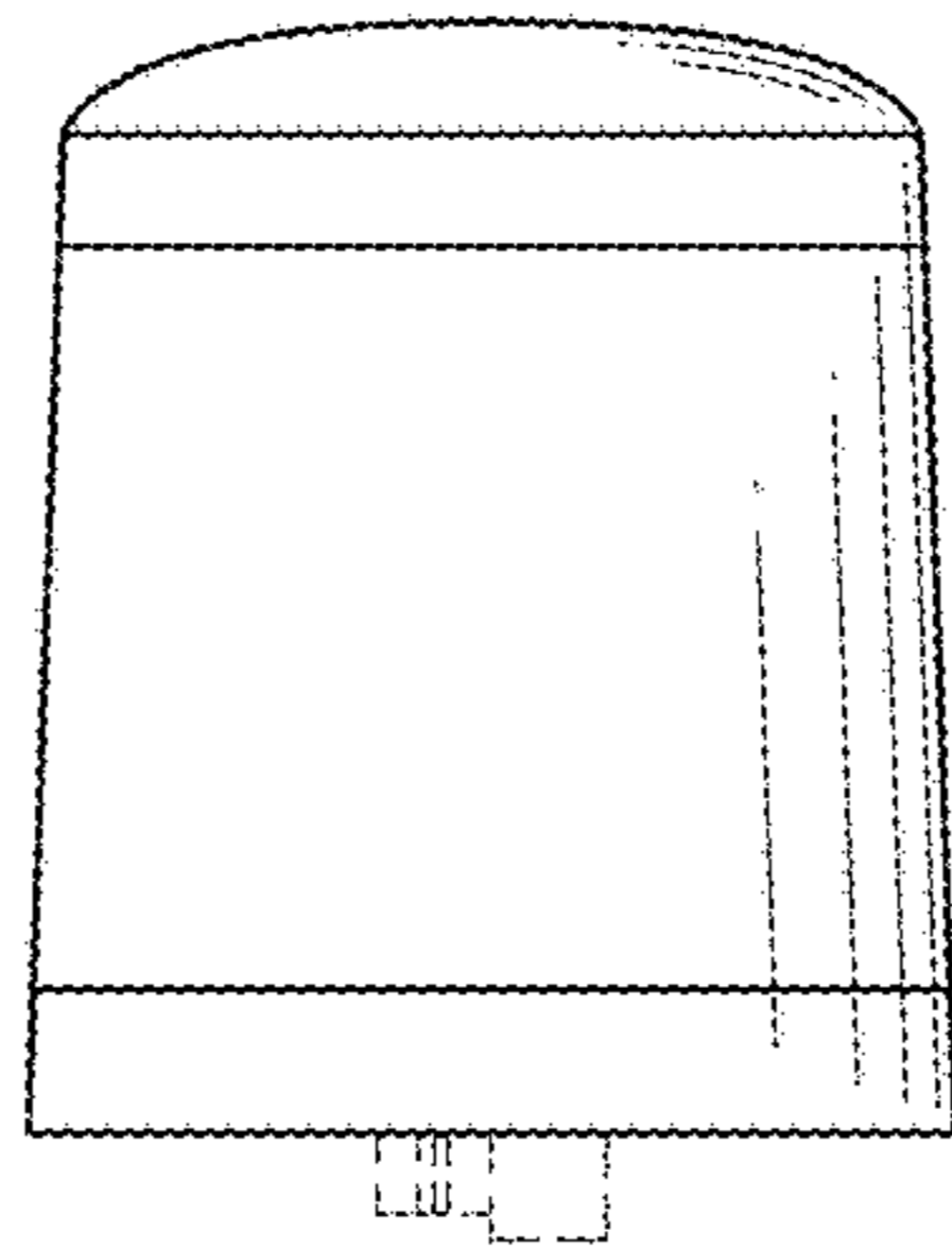
