**DESCRIPTION**

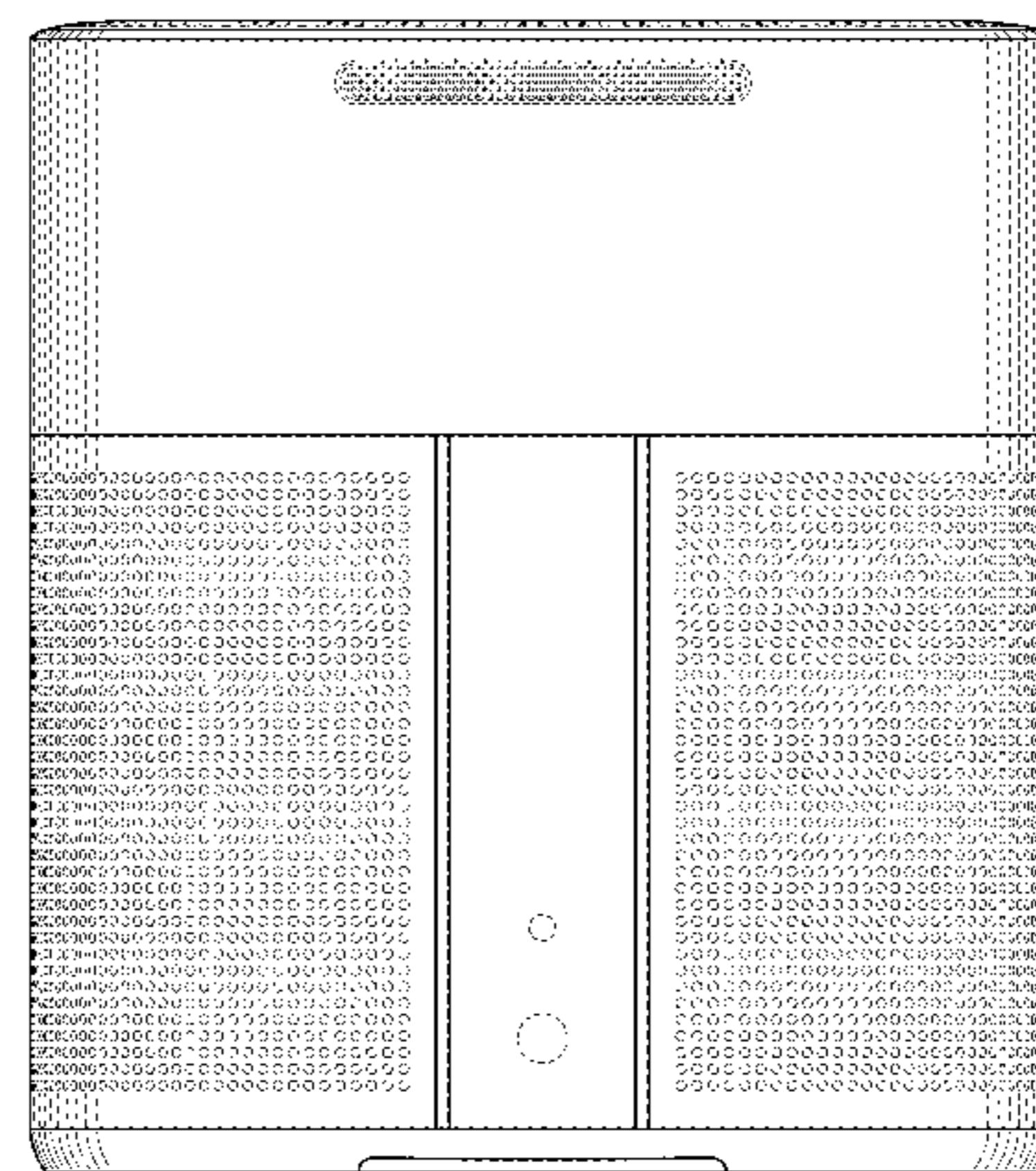
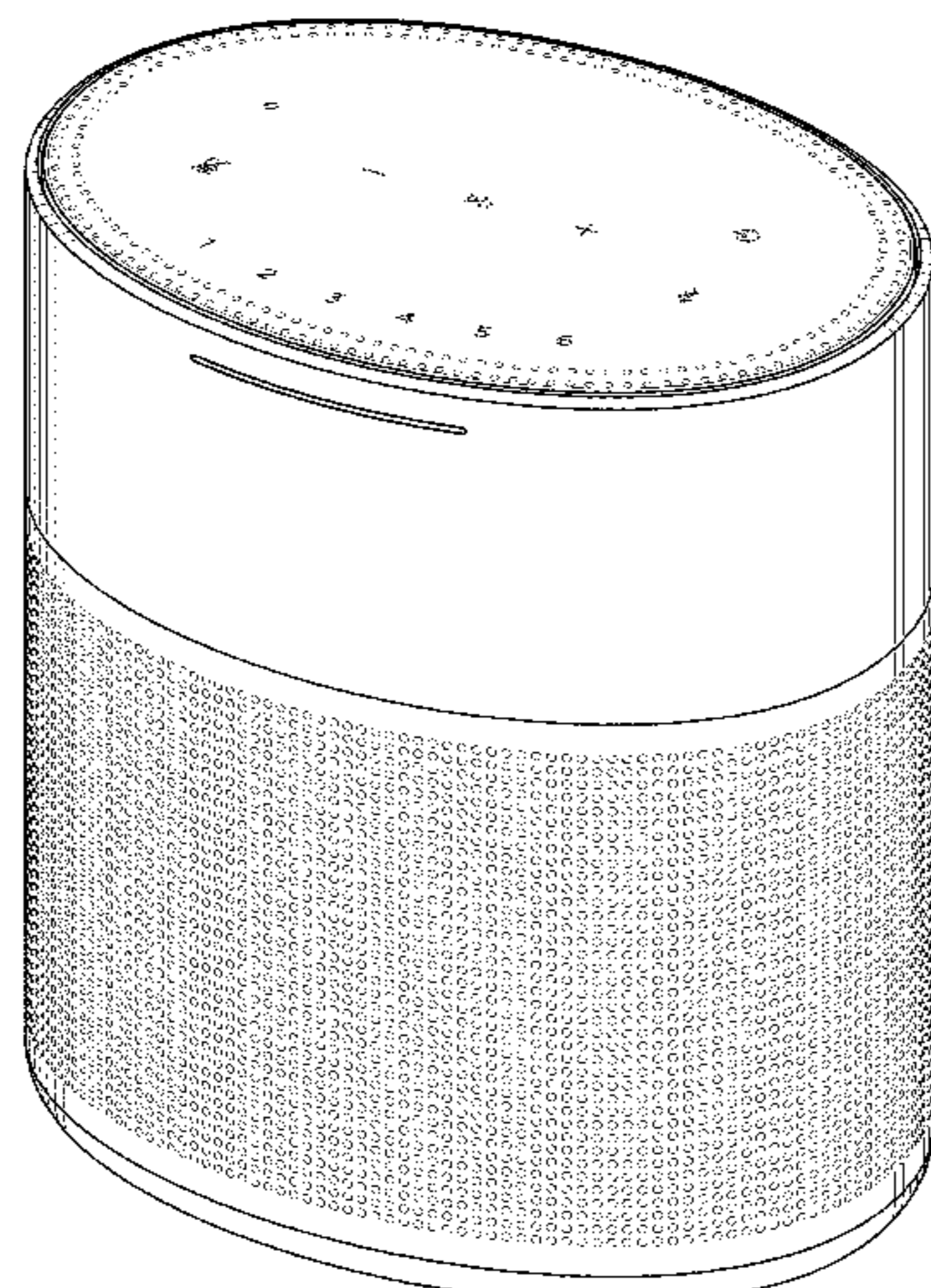
FIG. 1 is a perspective view of a loudspeaker as seen from the front, top, and side;

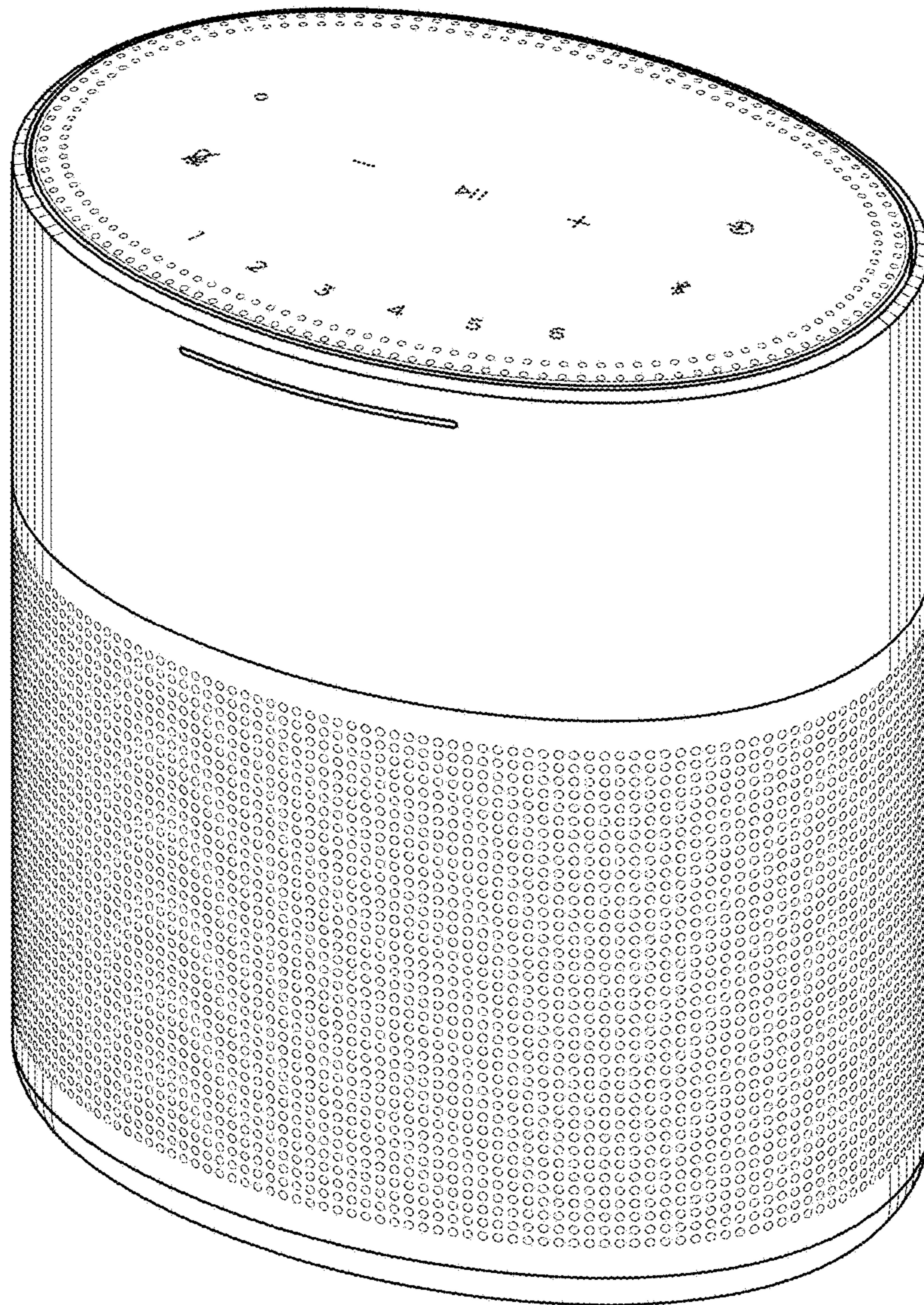

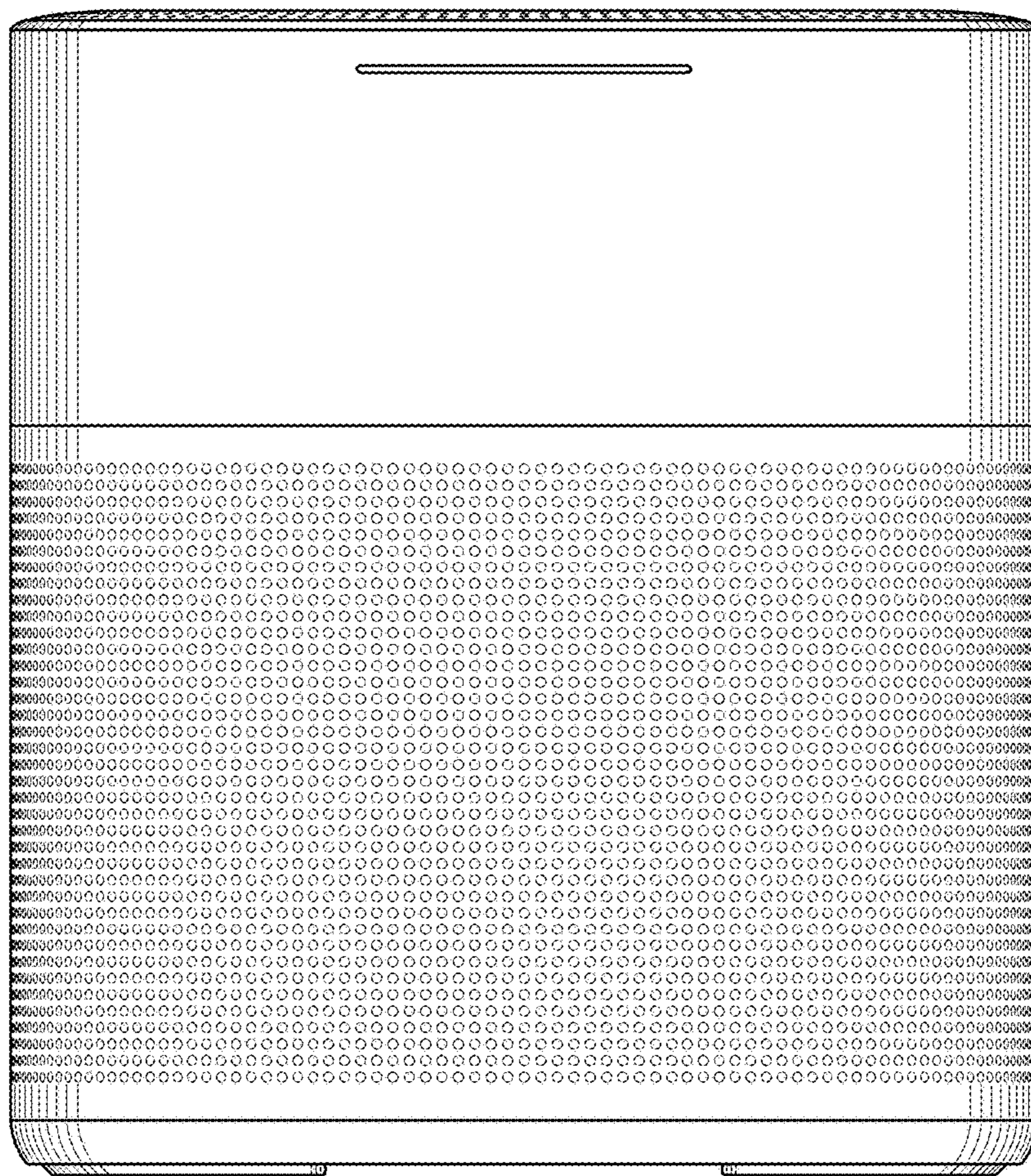

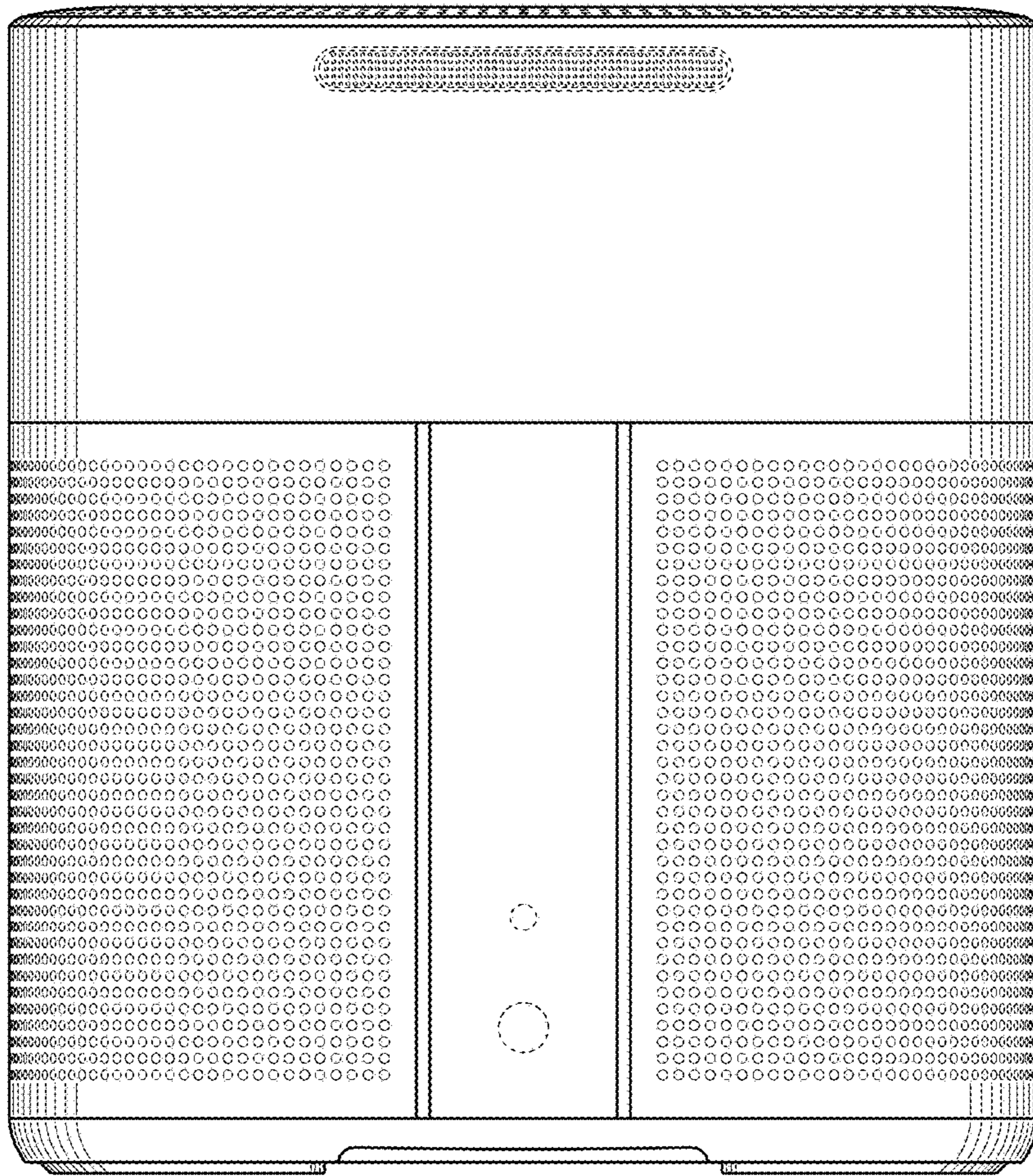

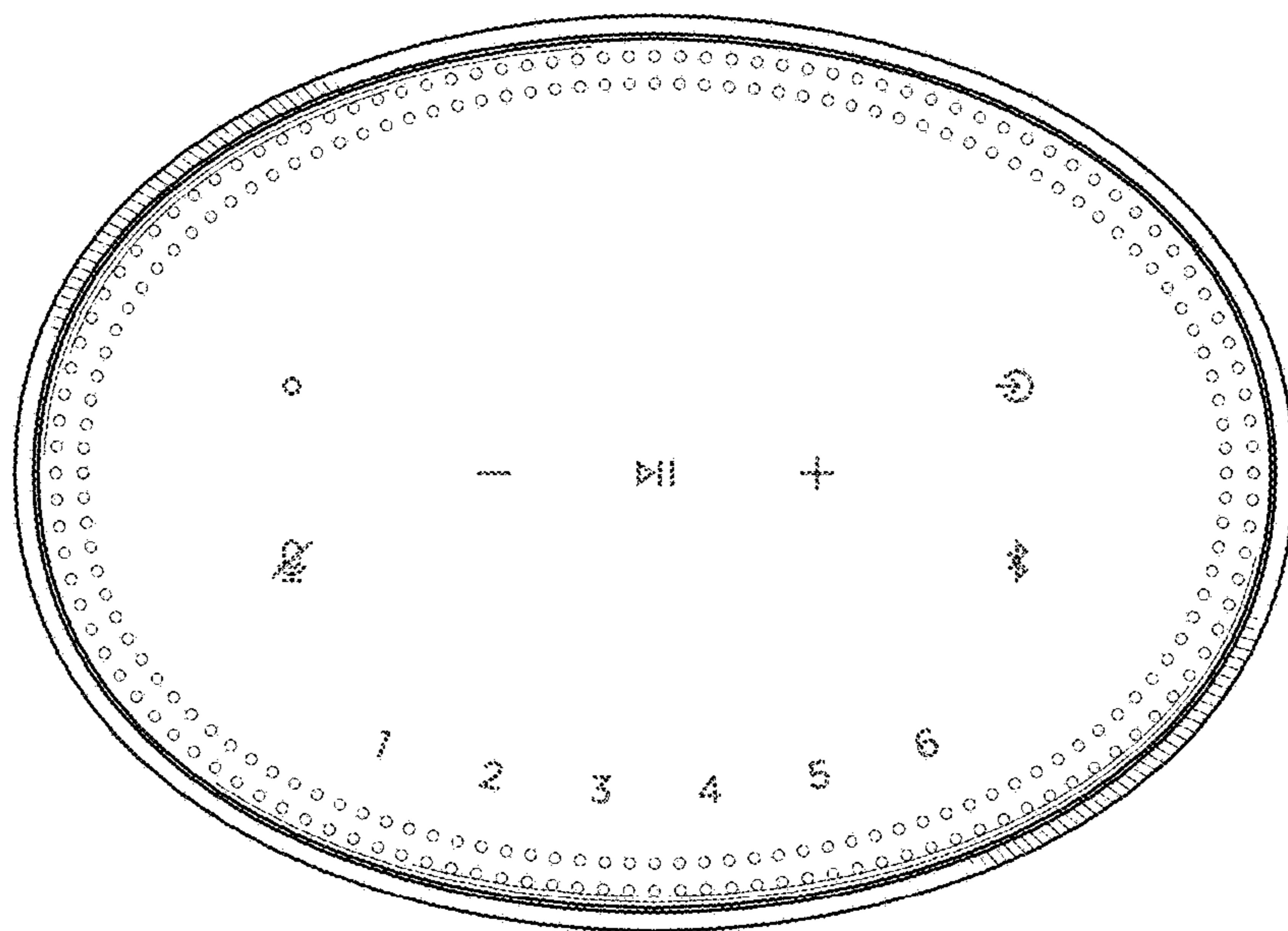

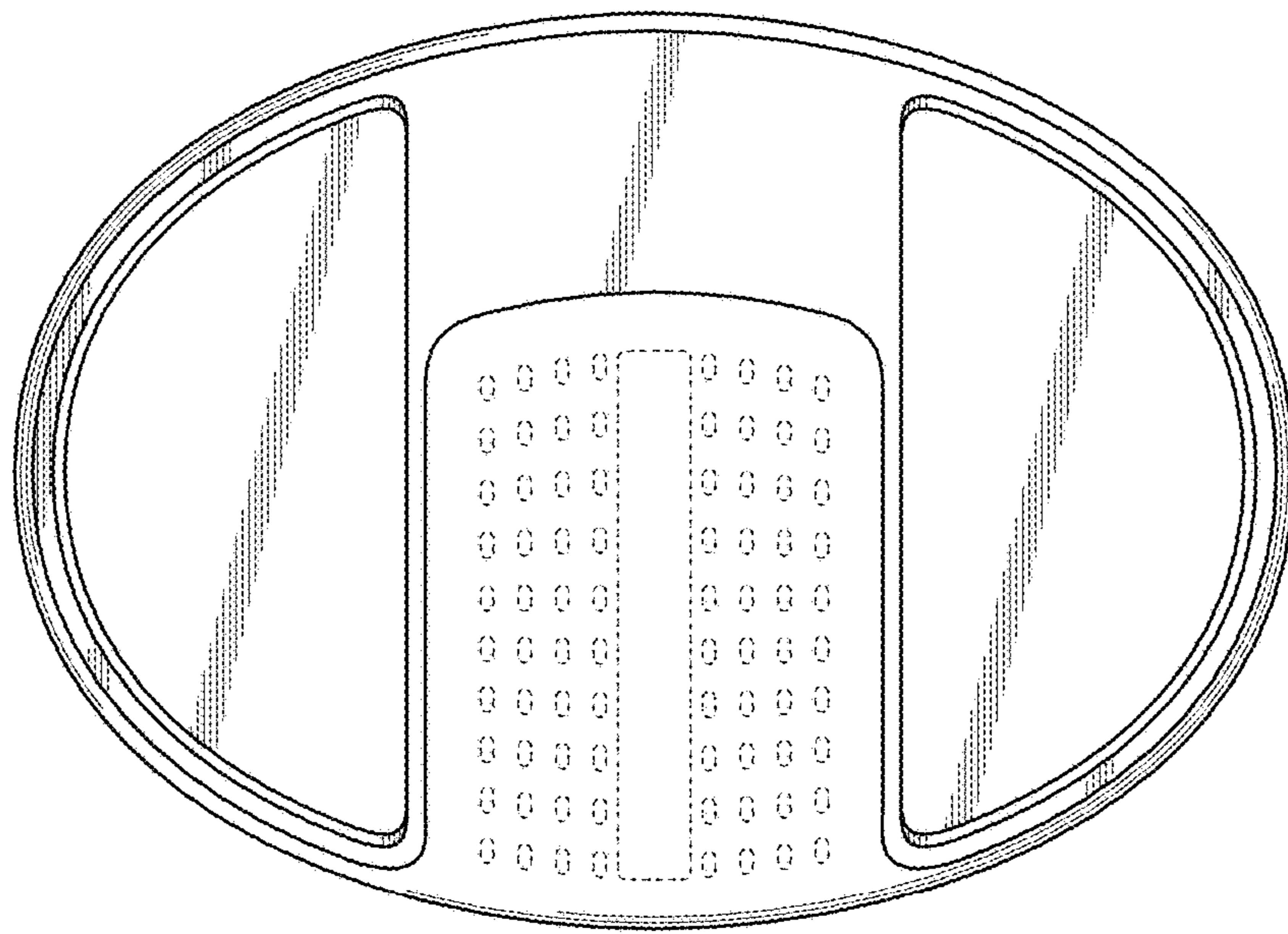

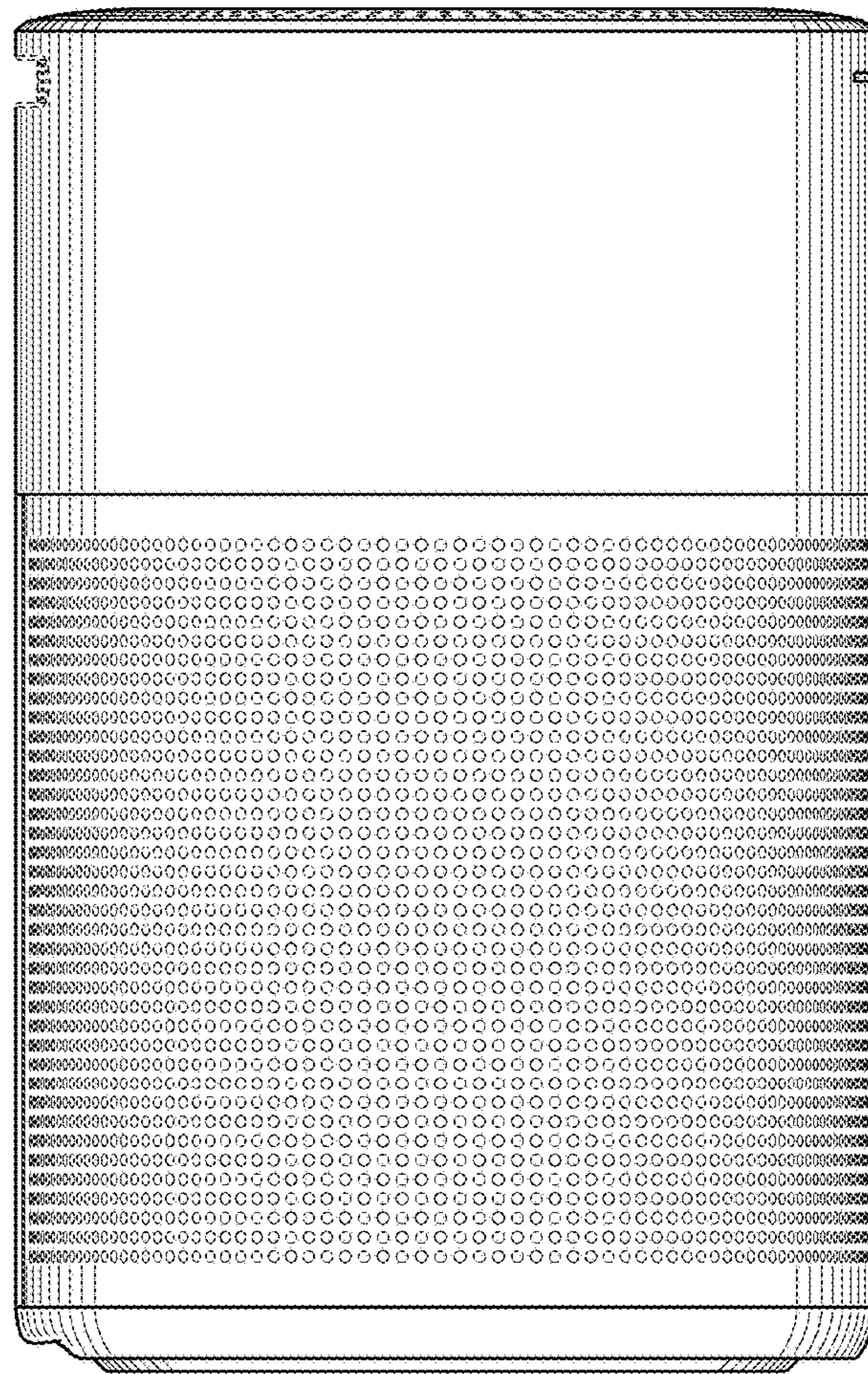

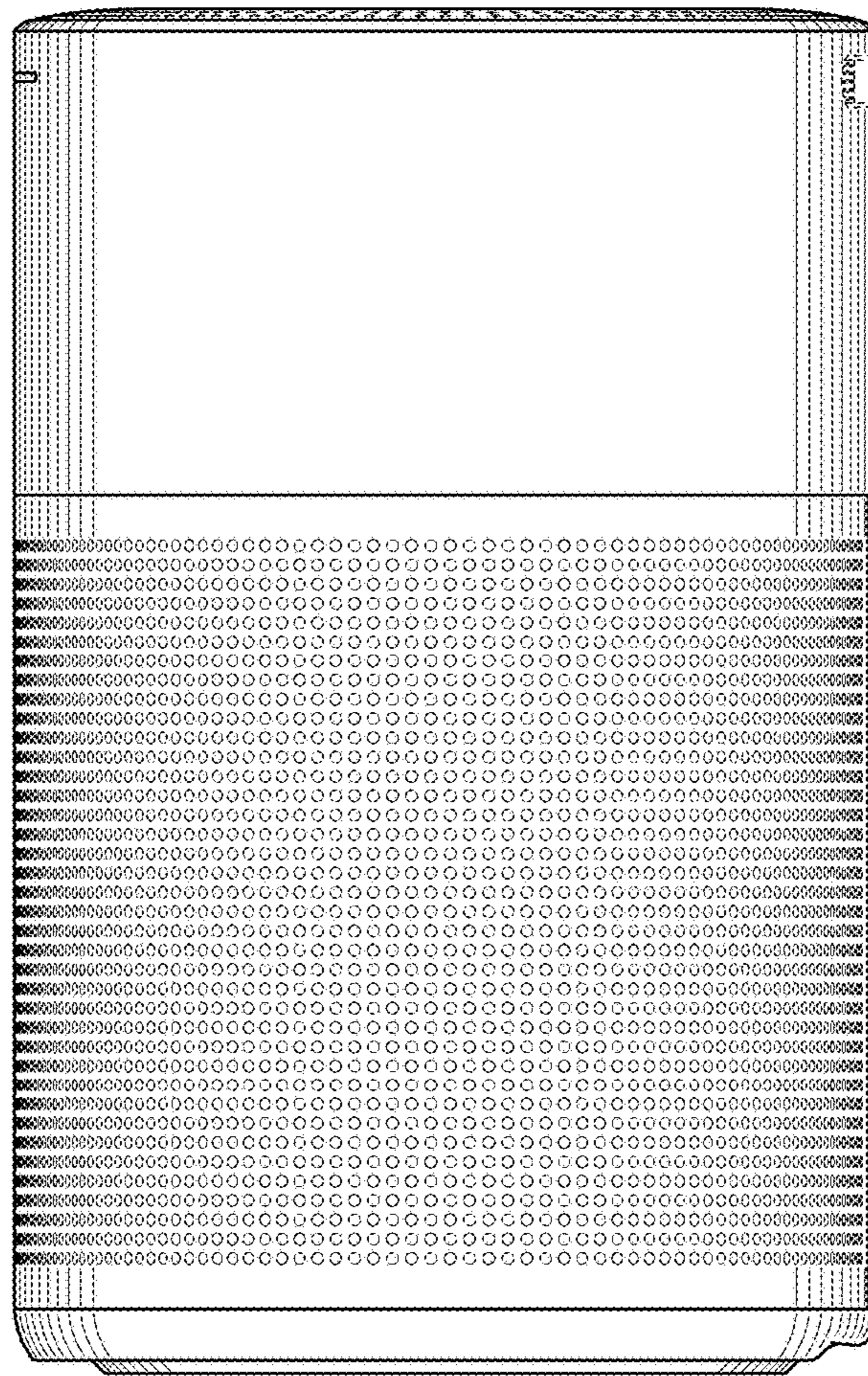
