(57) **CLAIM**

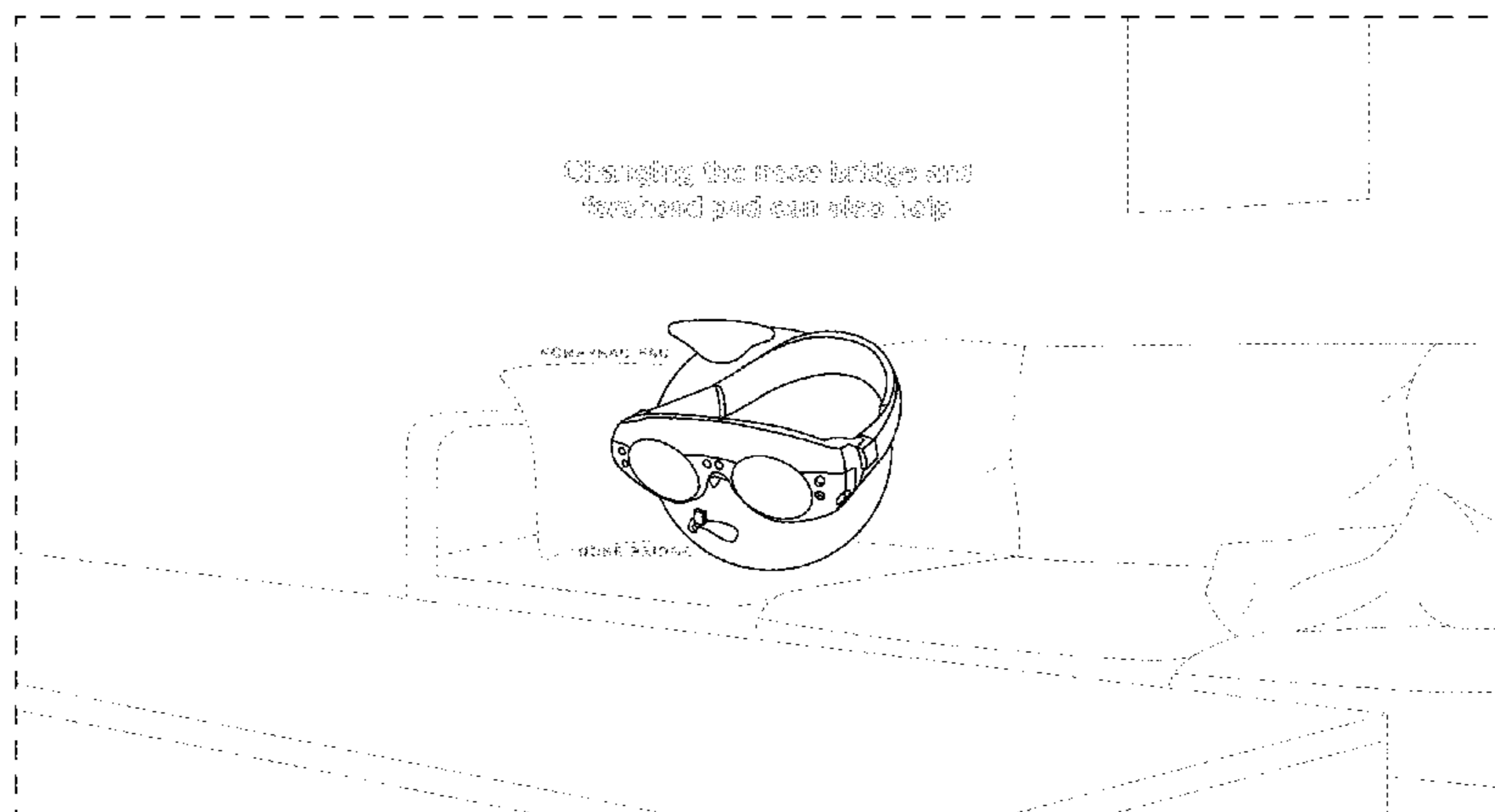
The ornamental design for display panel or portion thereof with graphical user interface, as shown and described.
