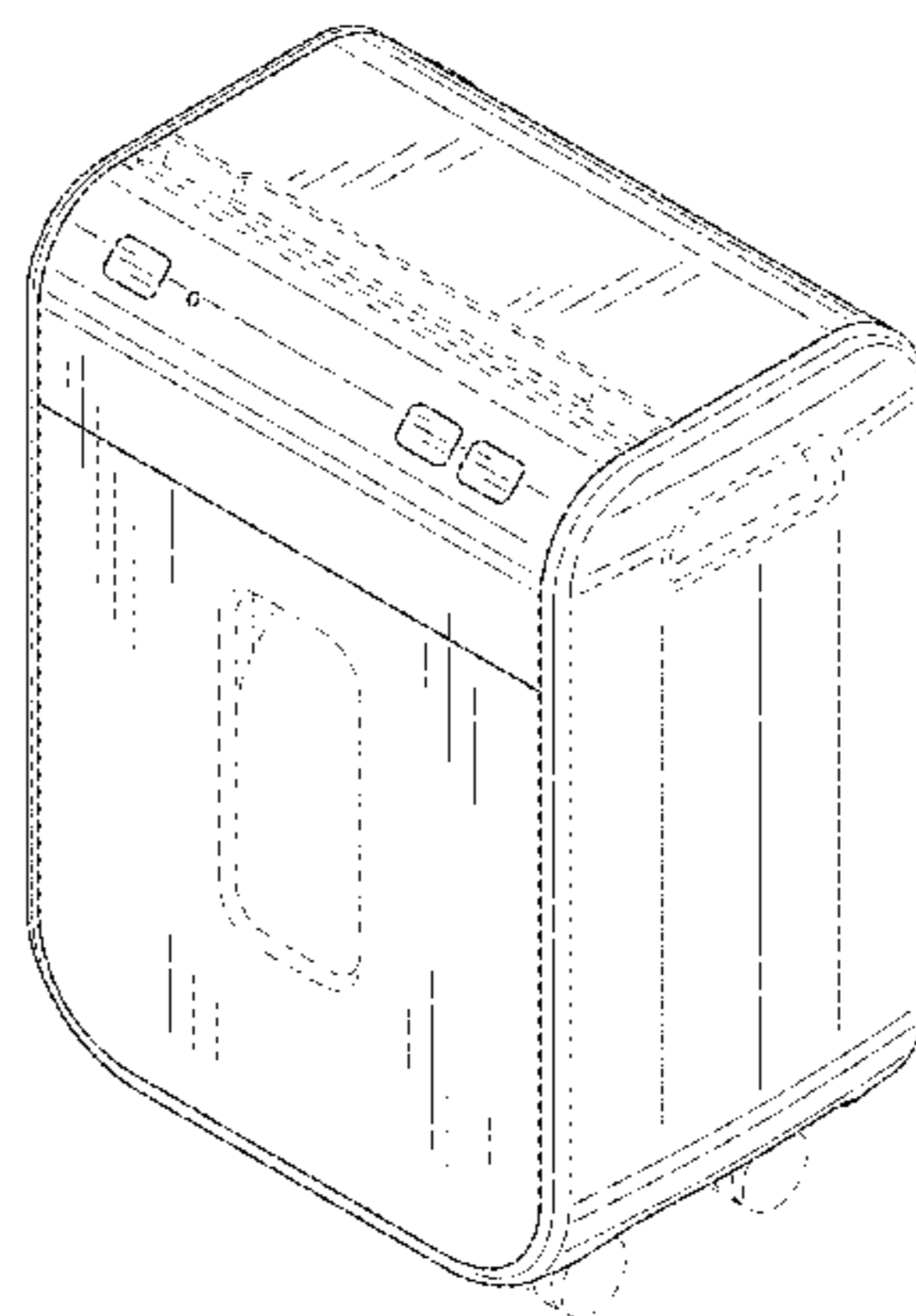
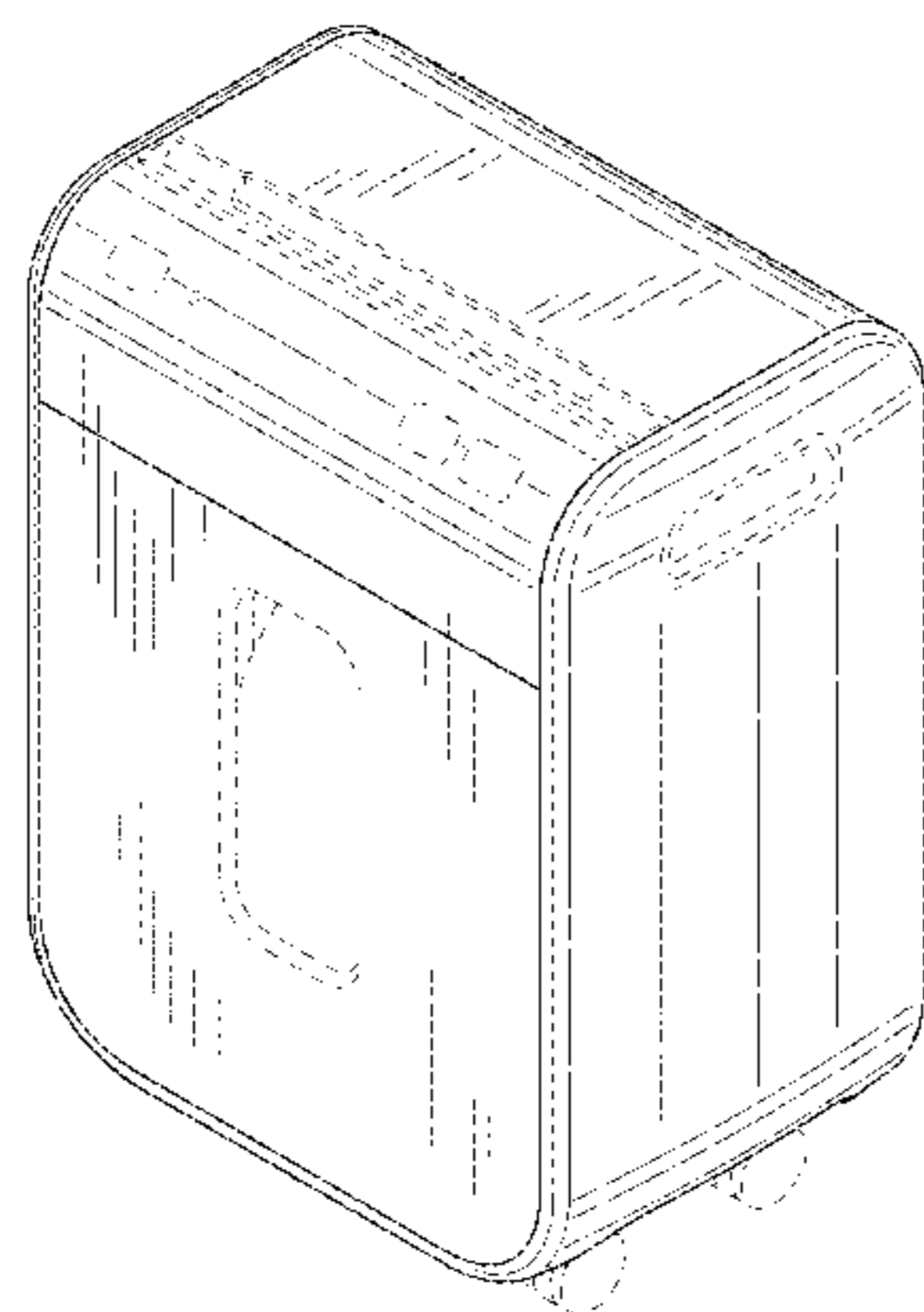


FIG. 21 is a bottom plan view of the media shredder of FIG. 15.

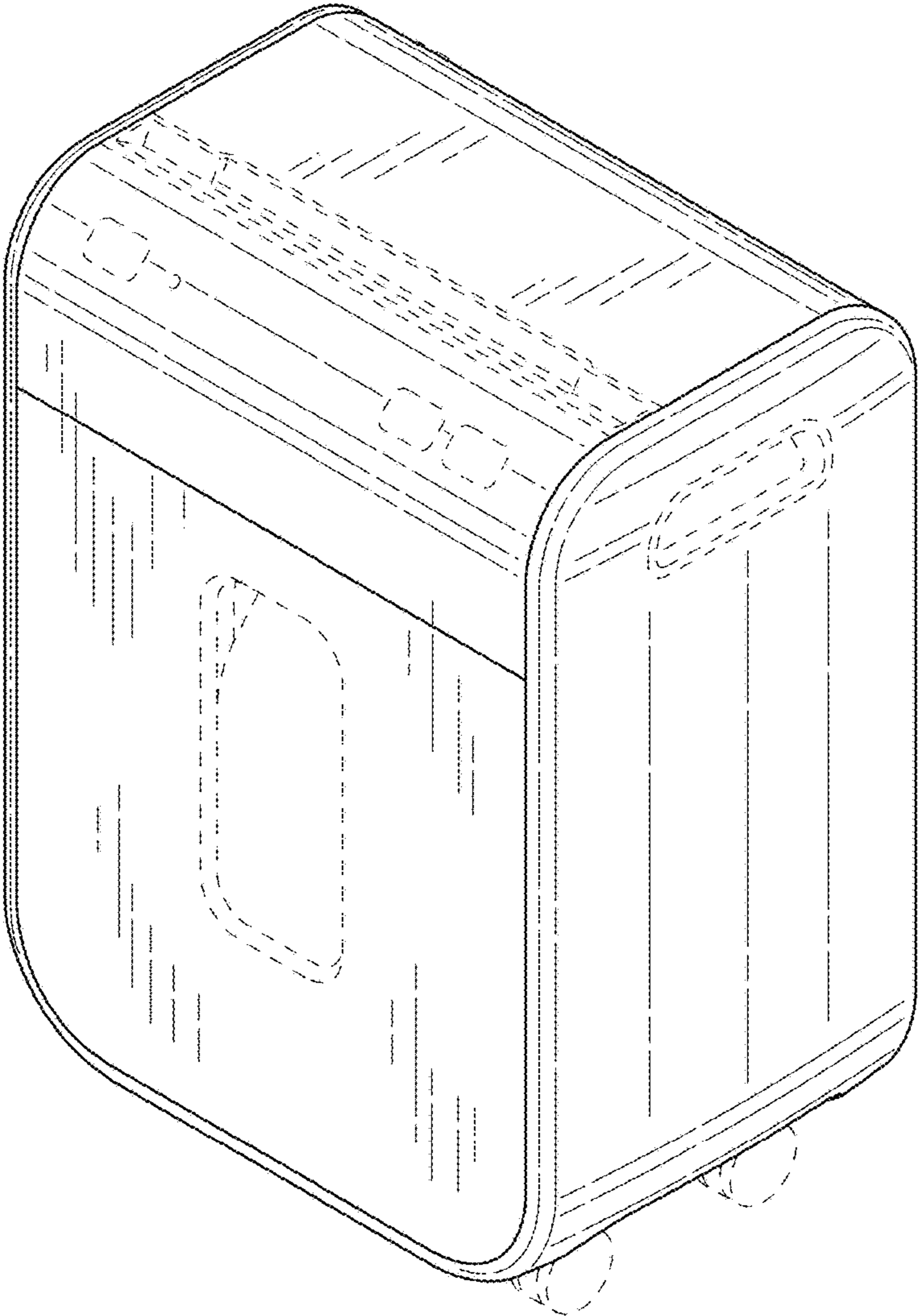

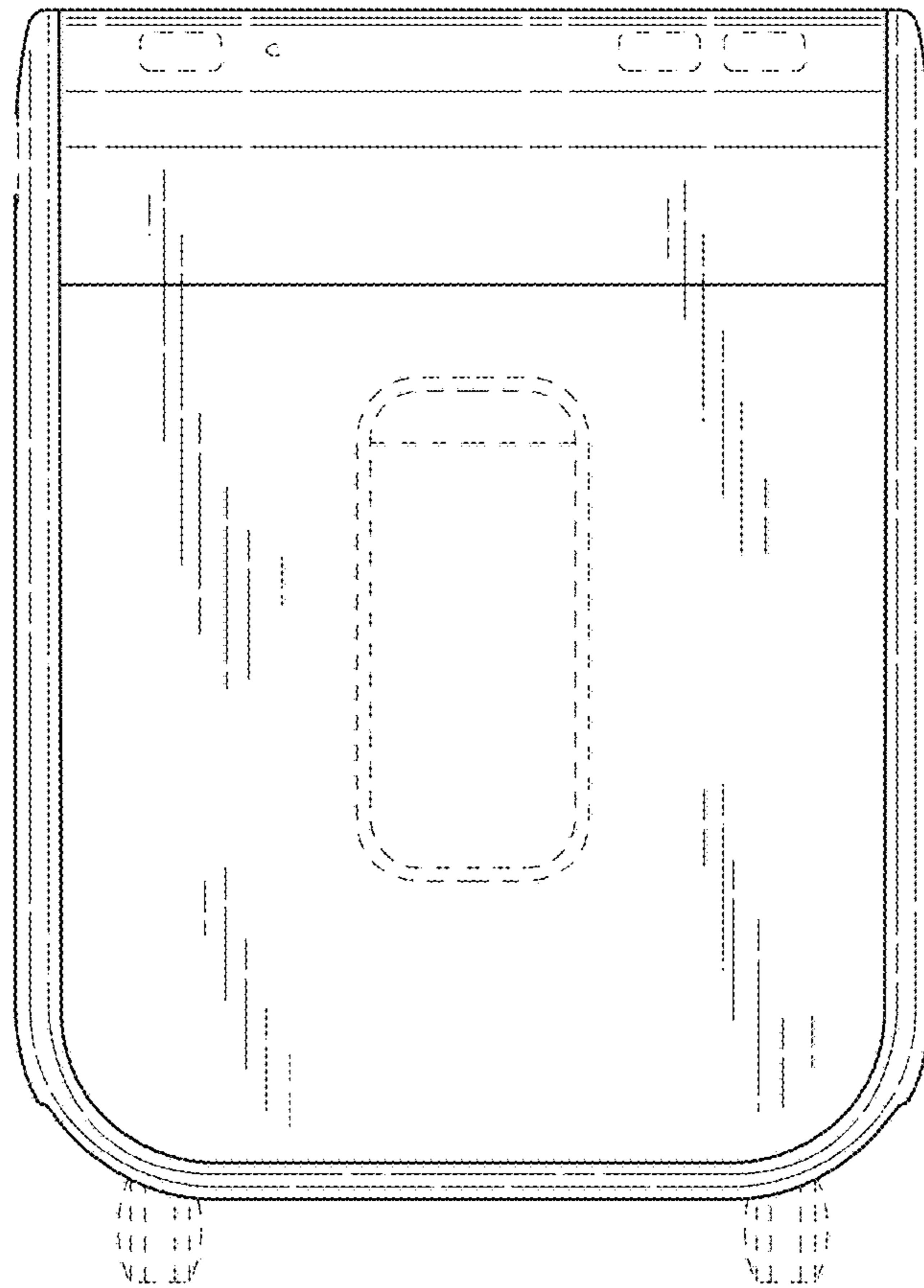

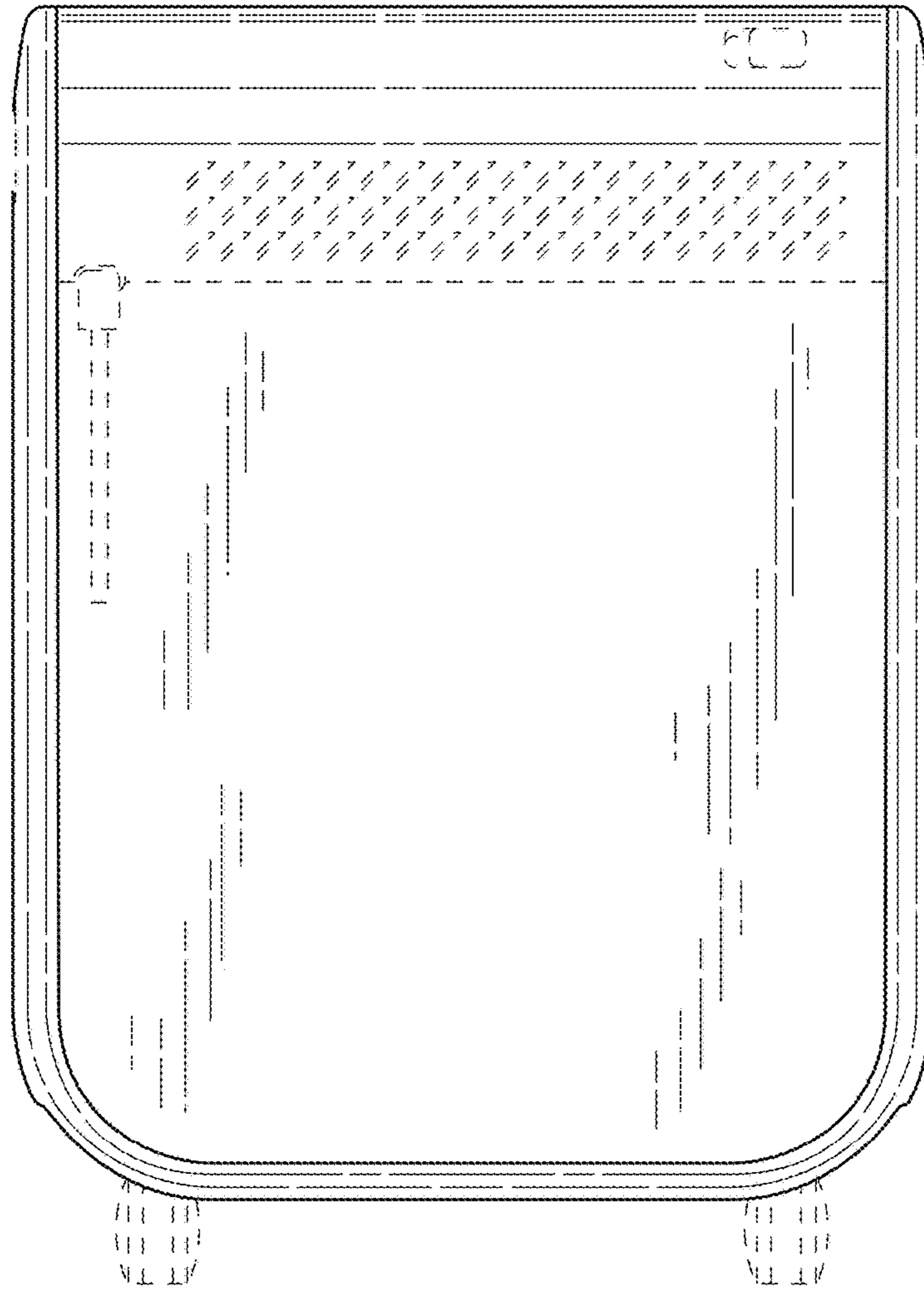

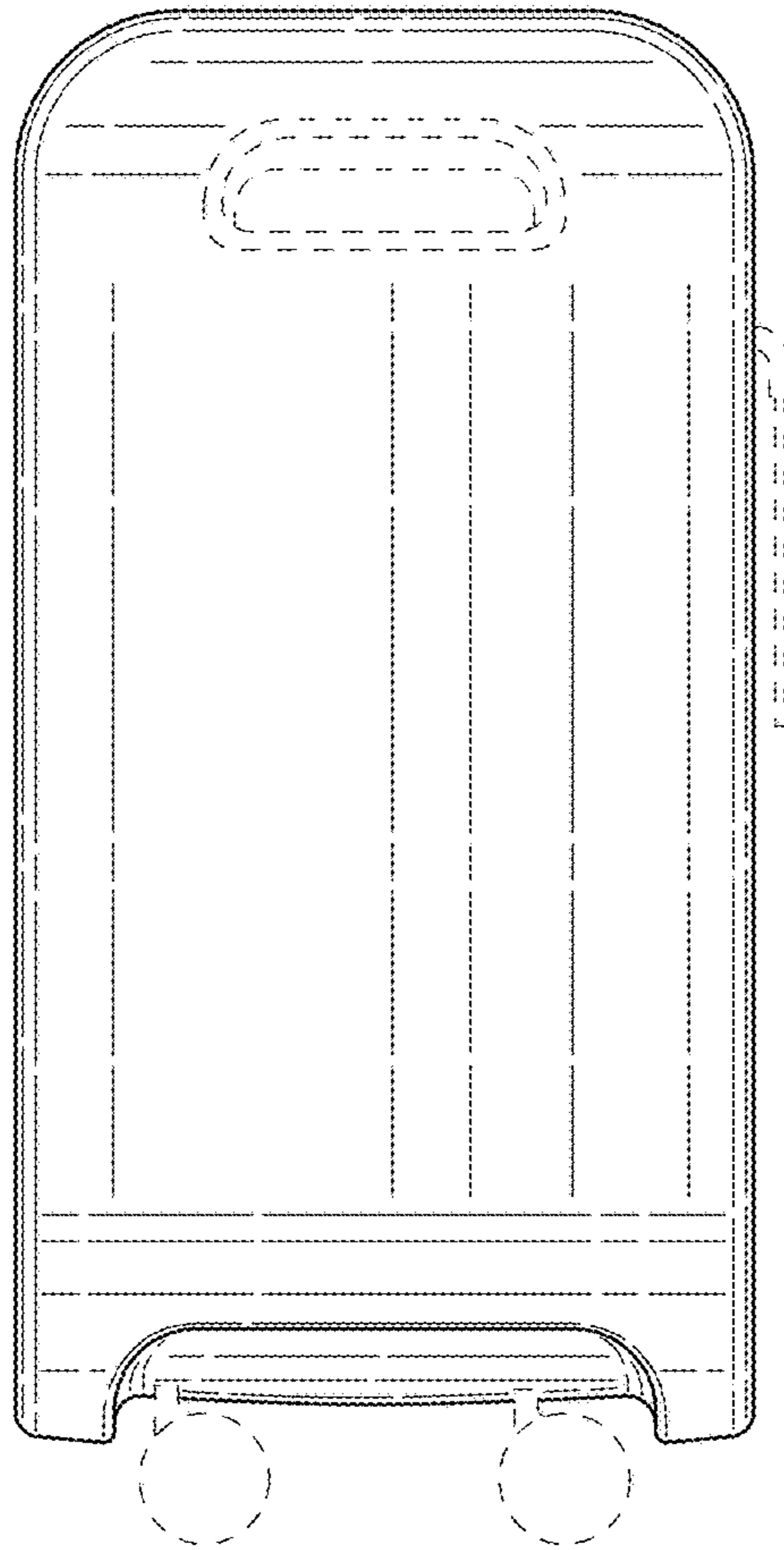

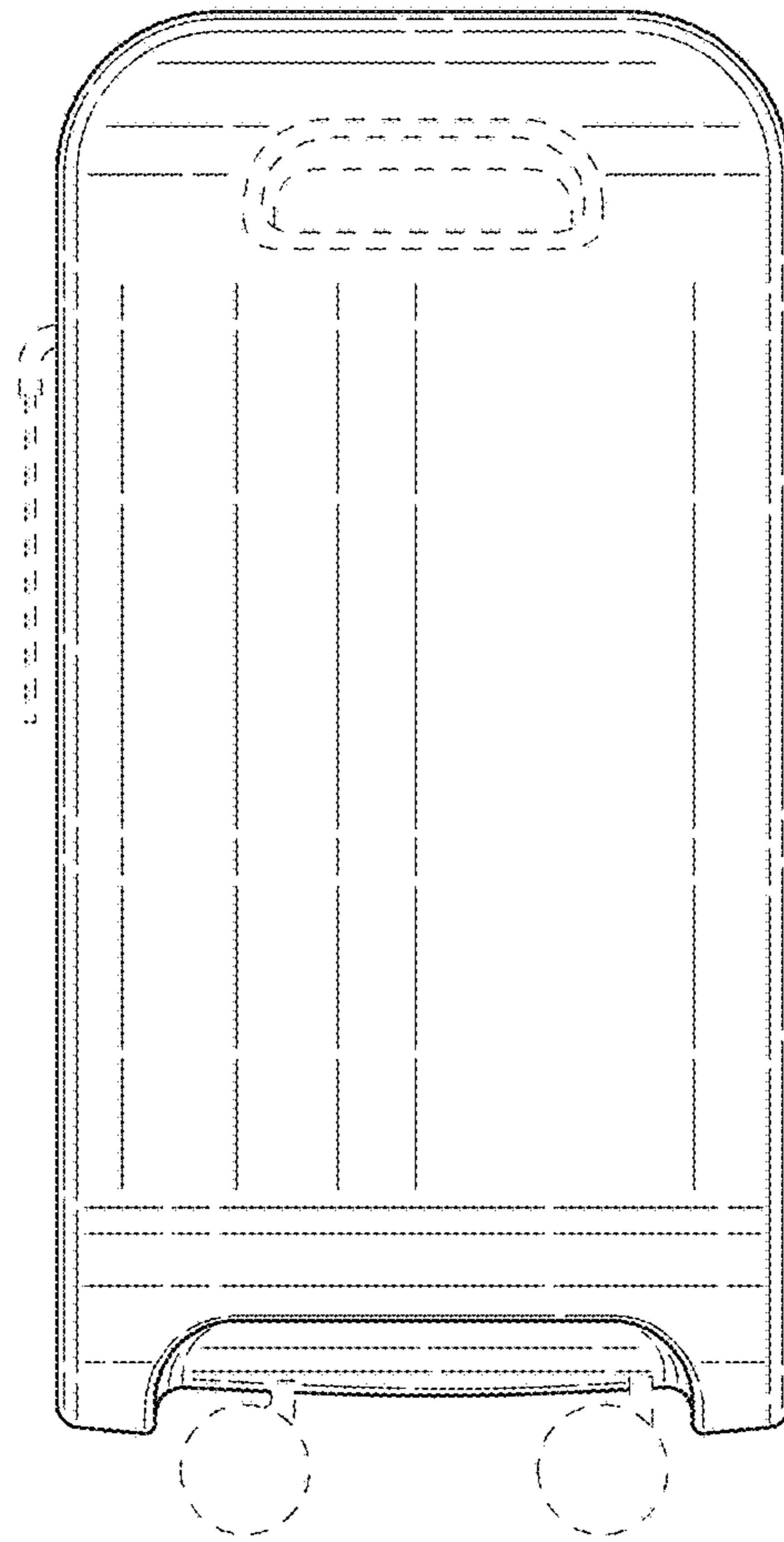

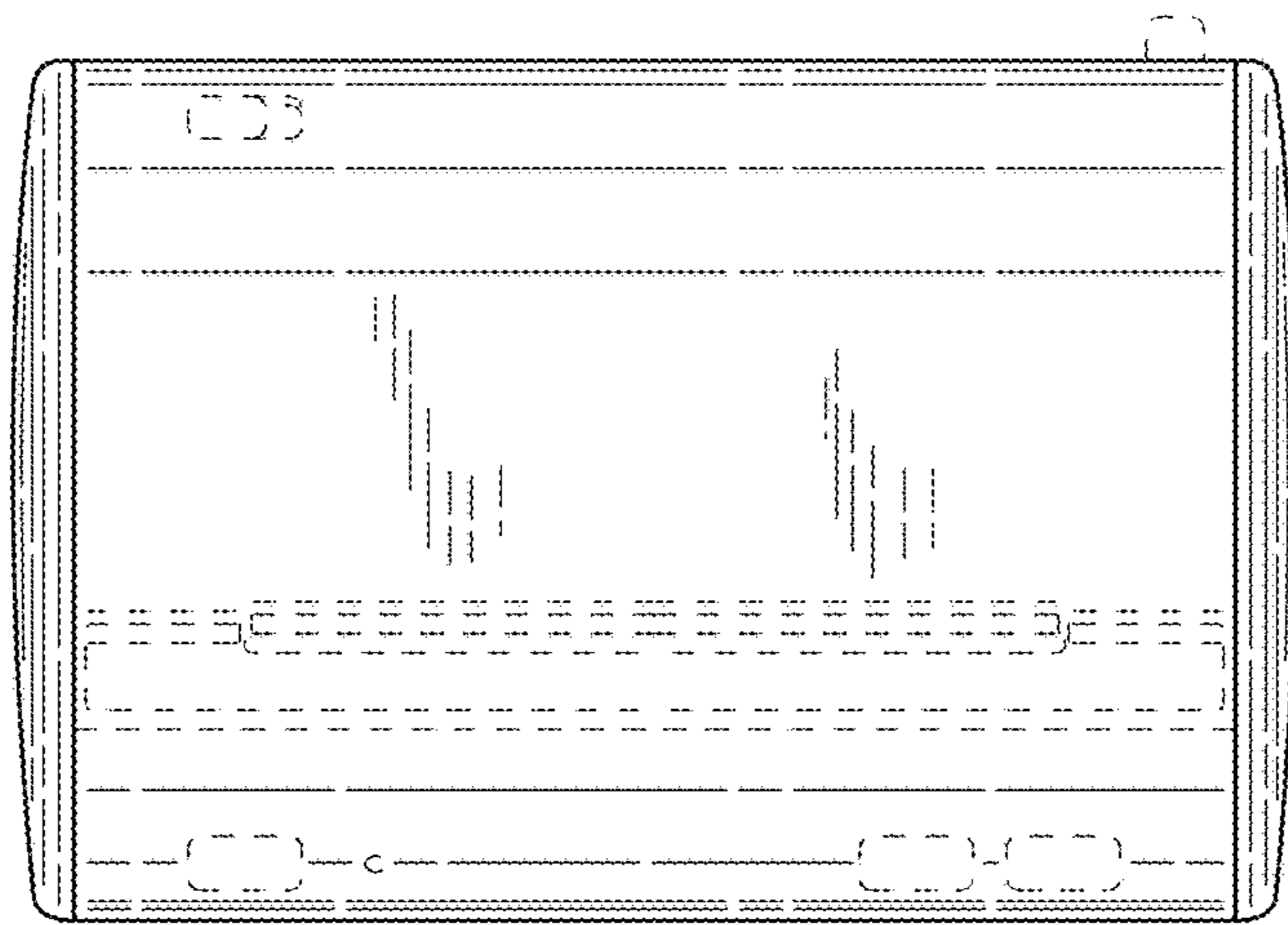

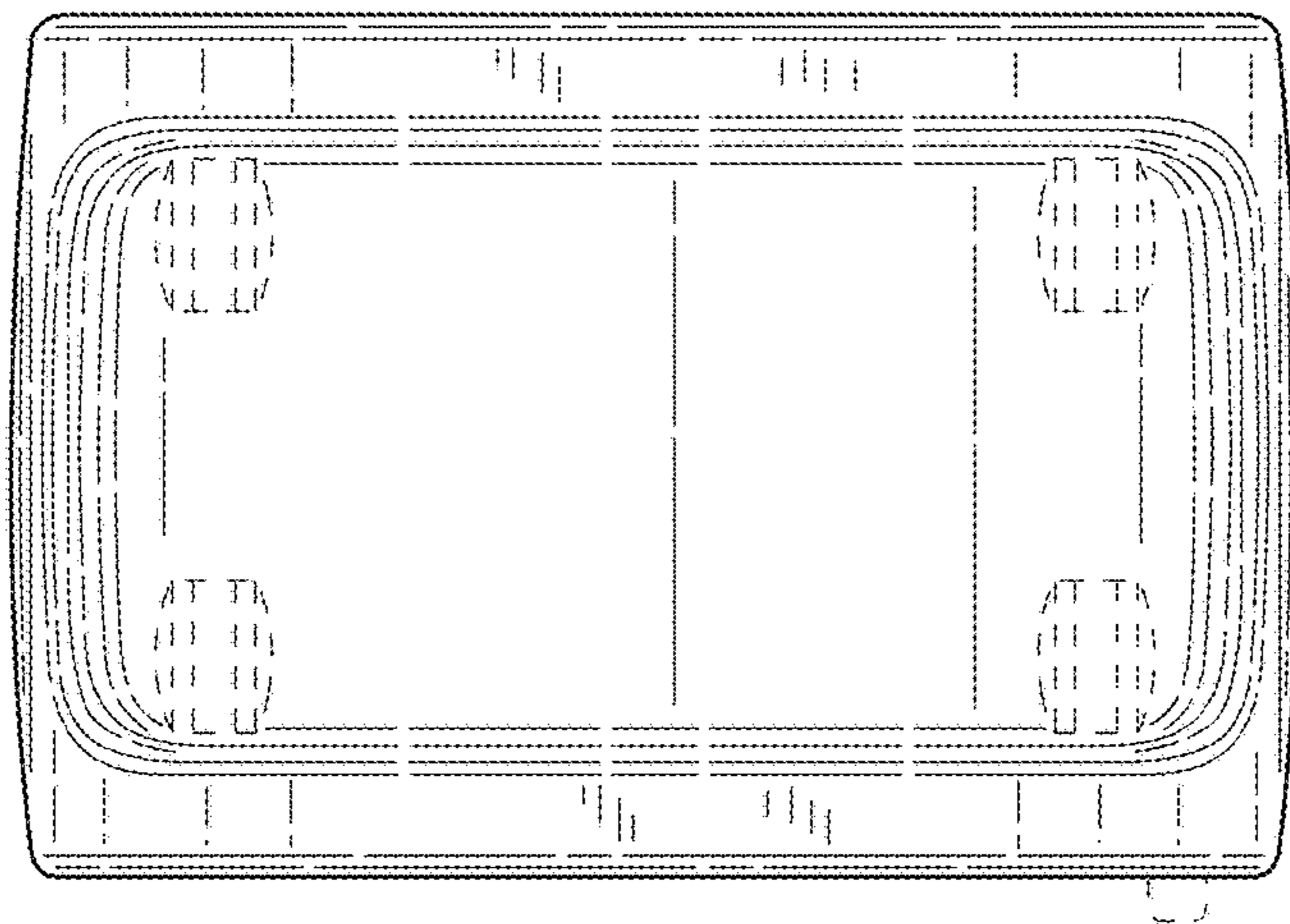

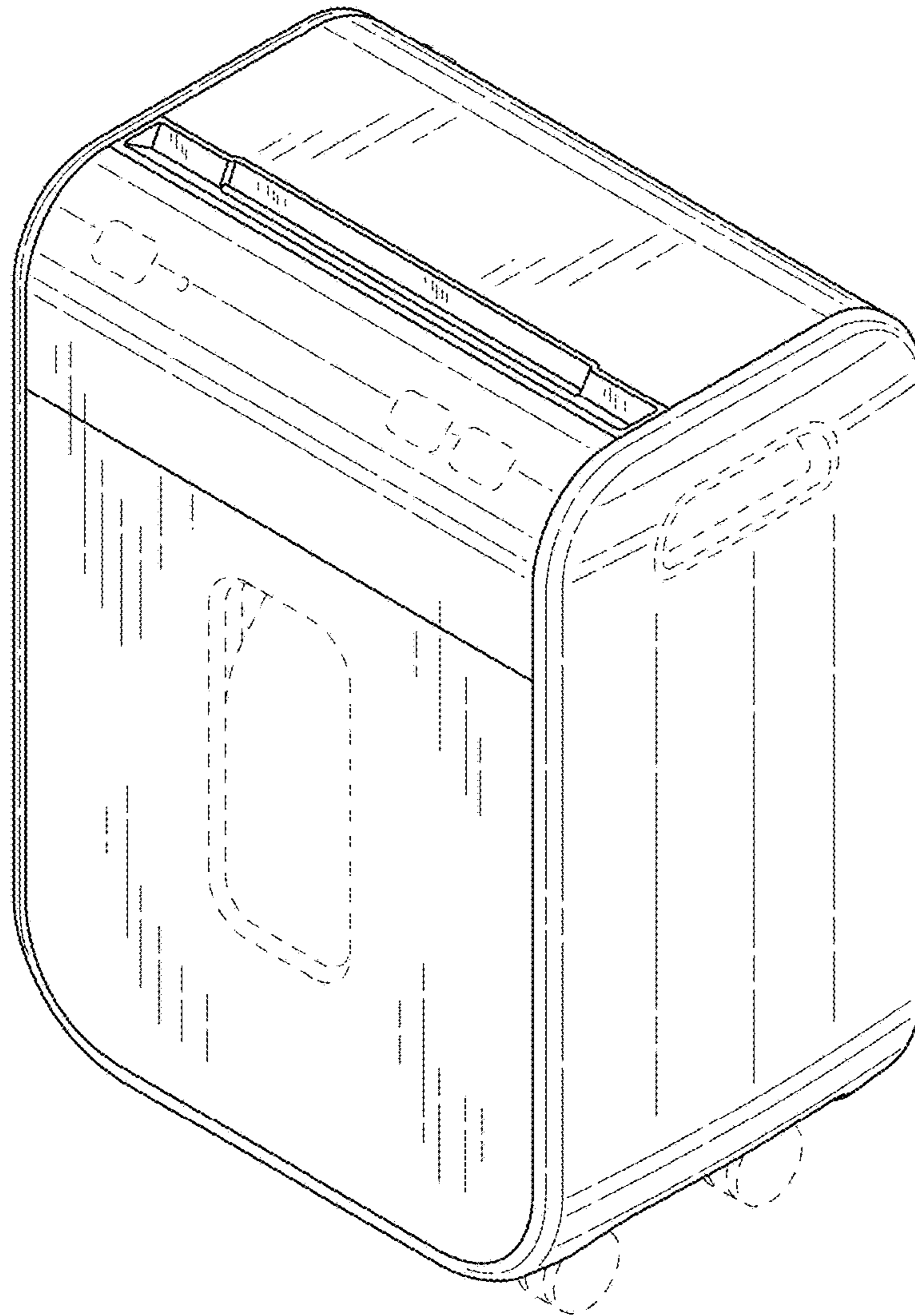

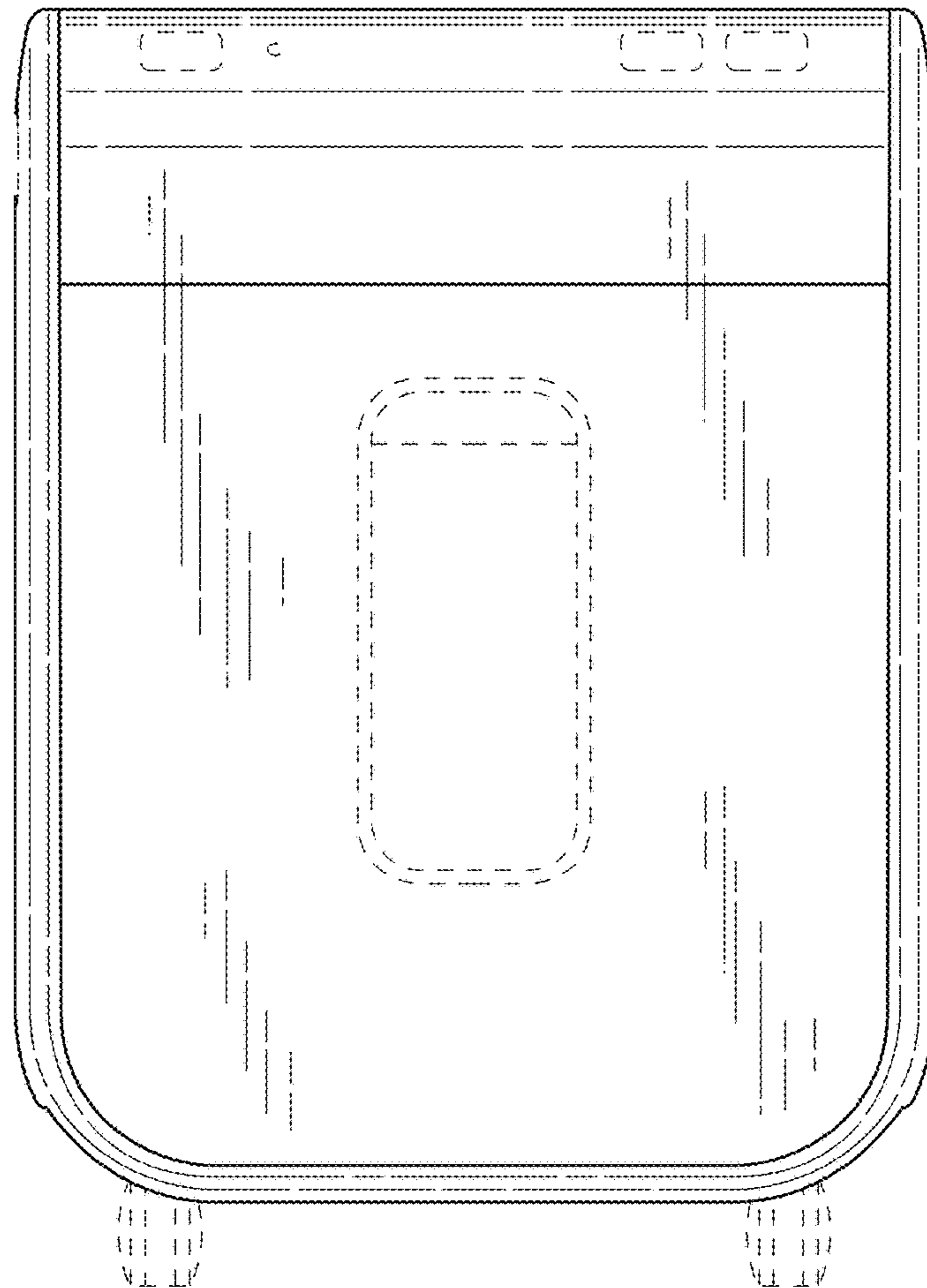

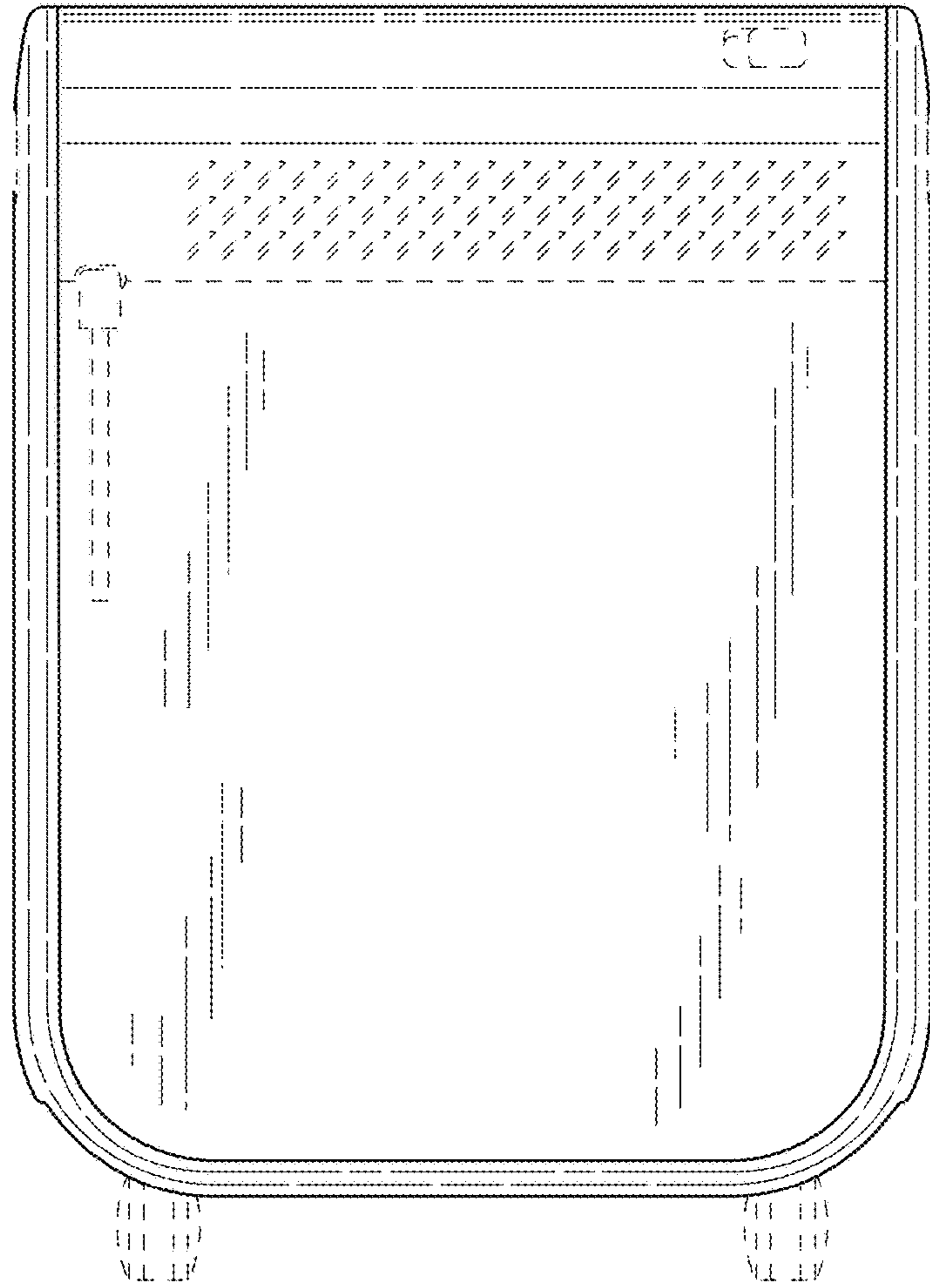

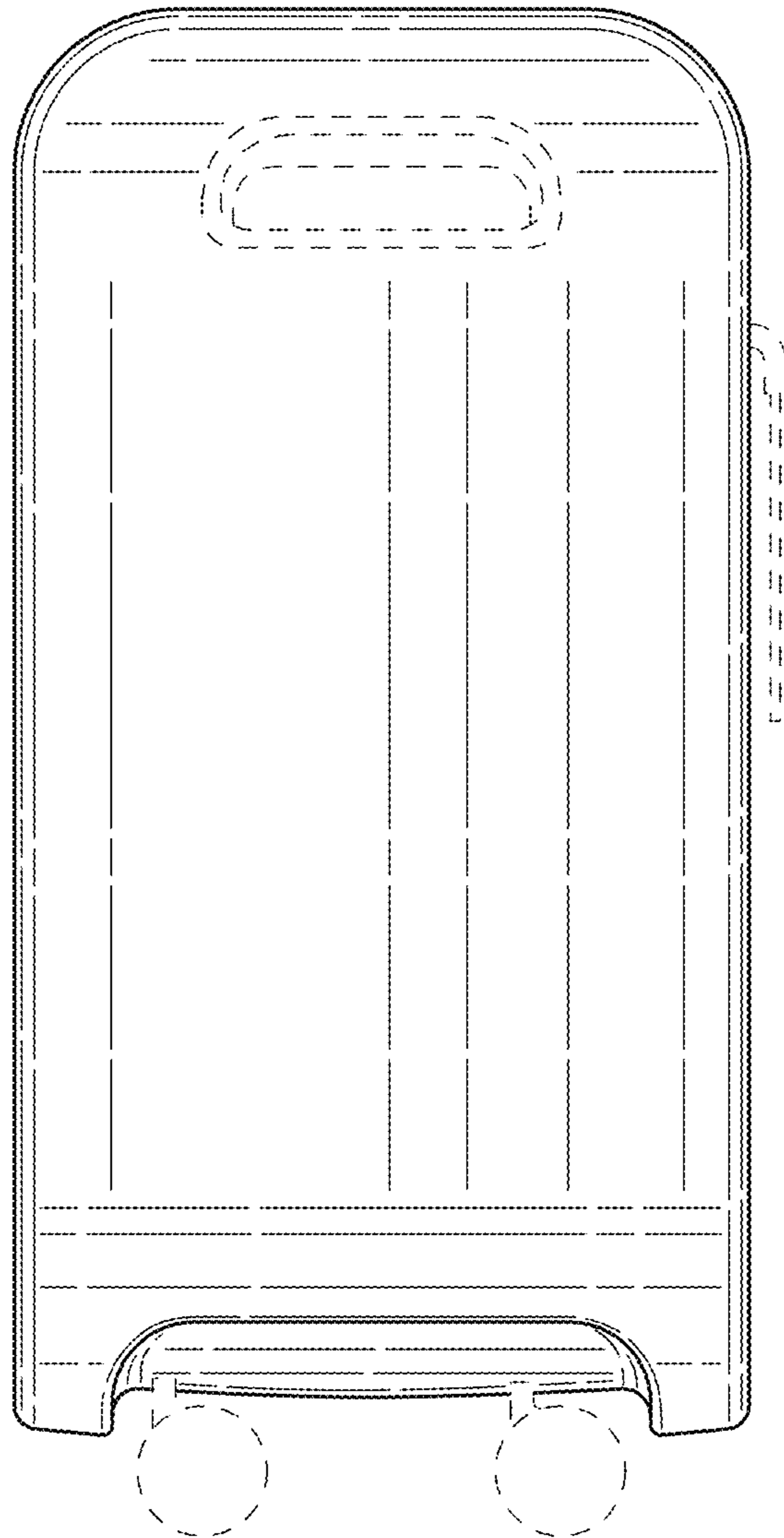

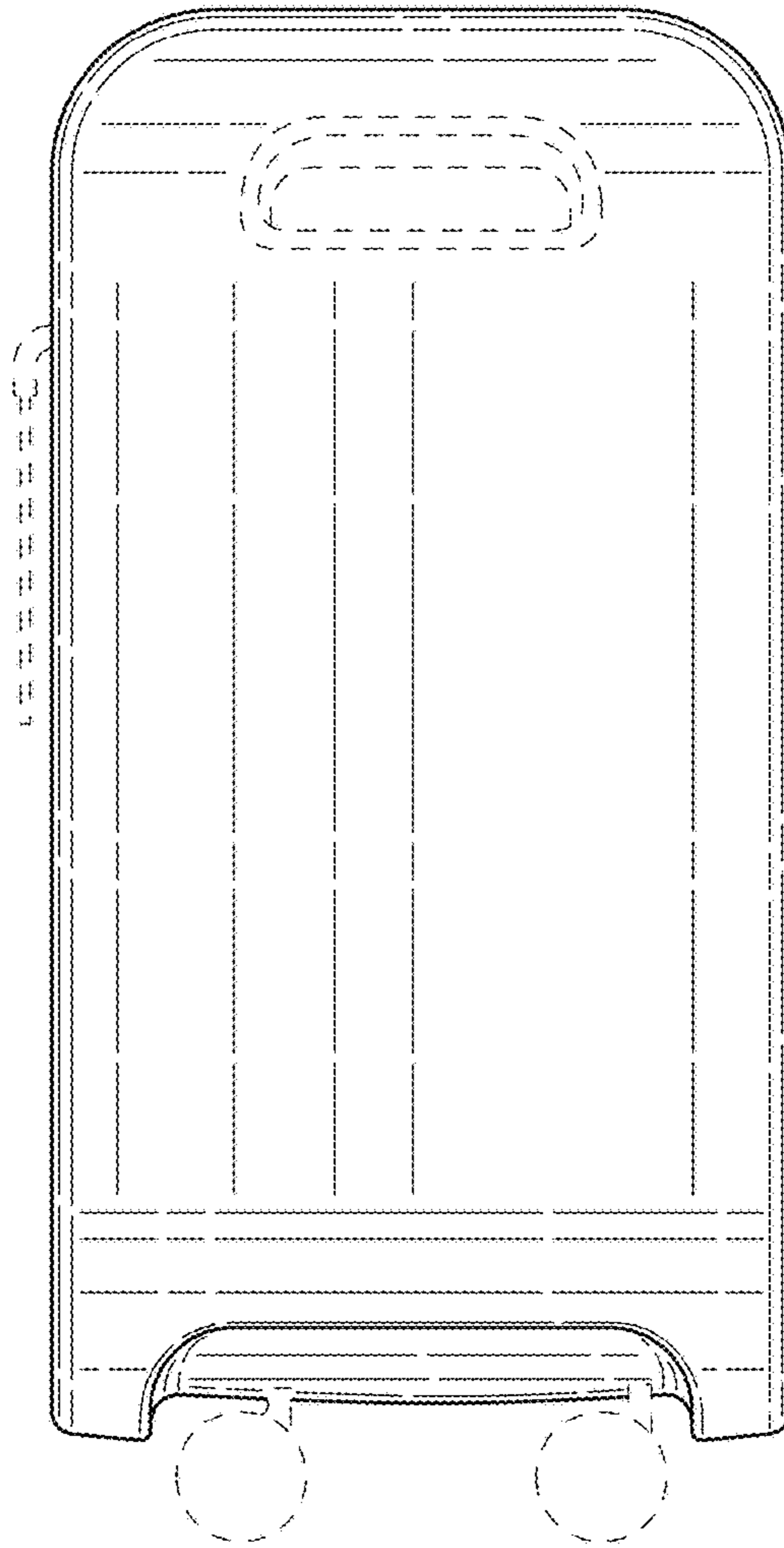

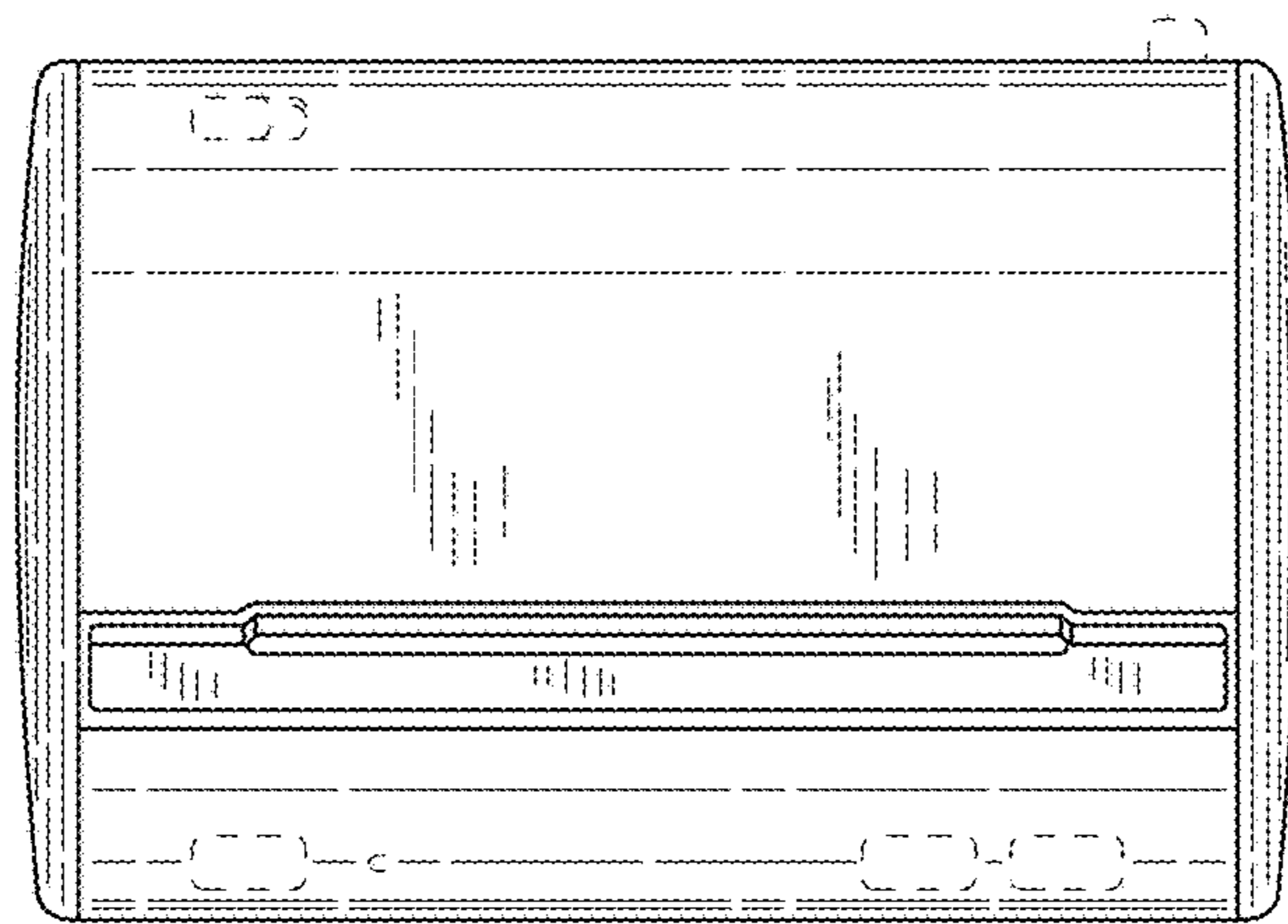

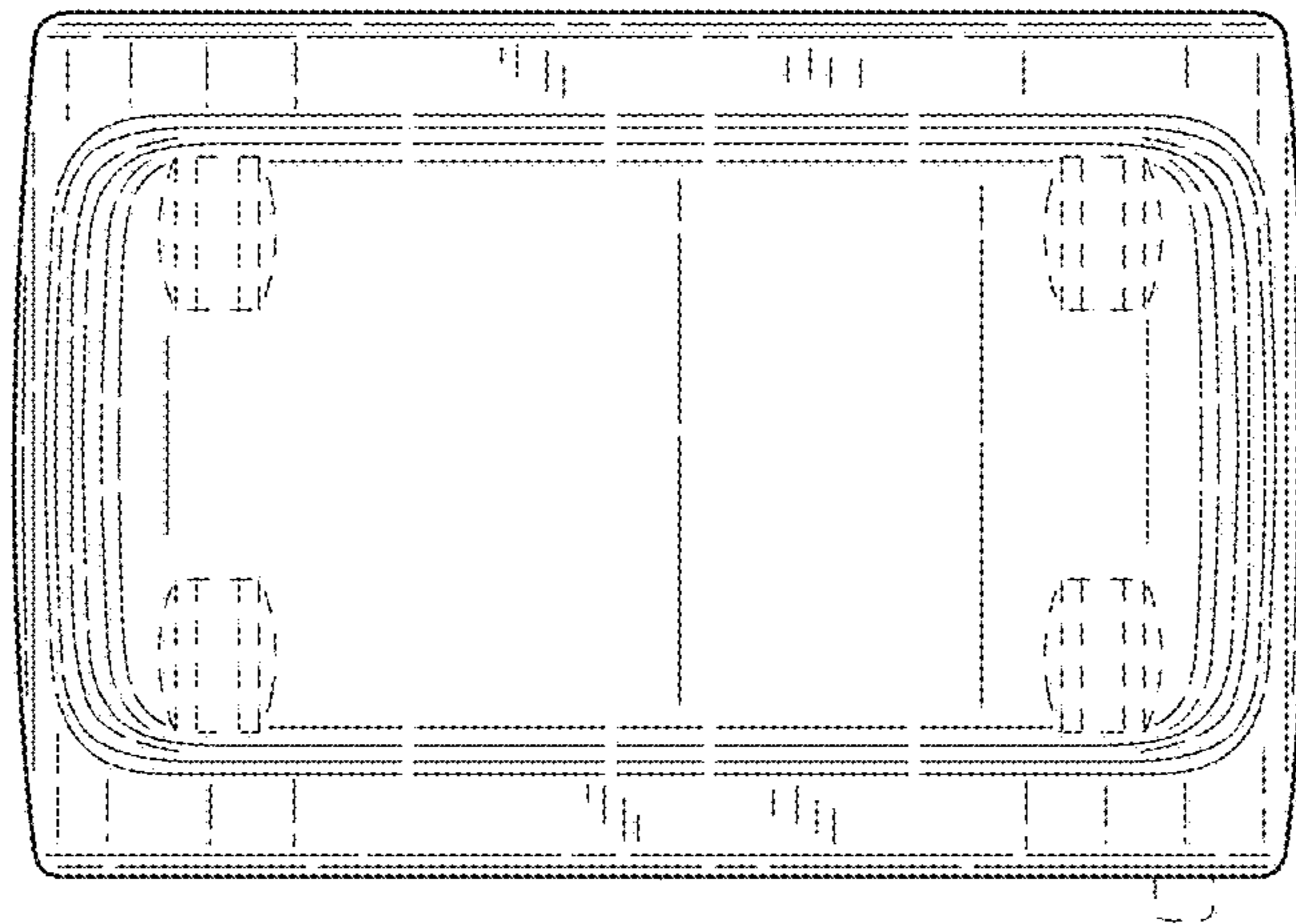

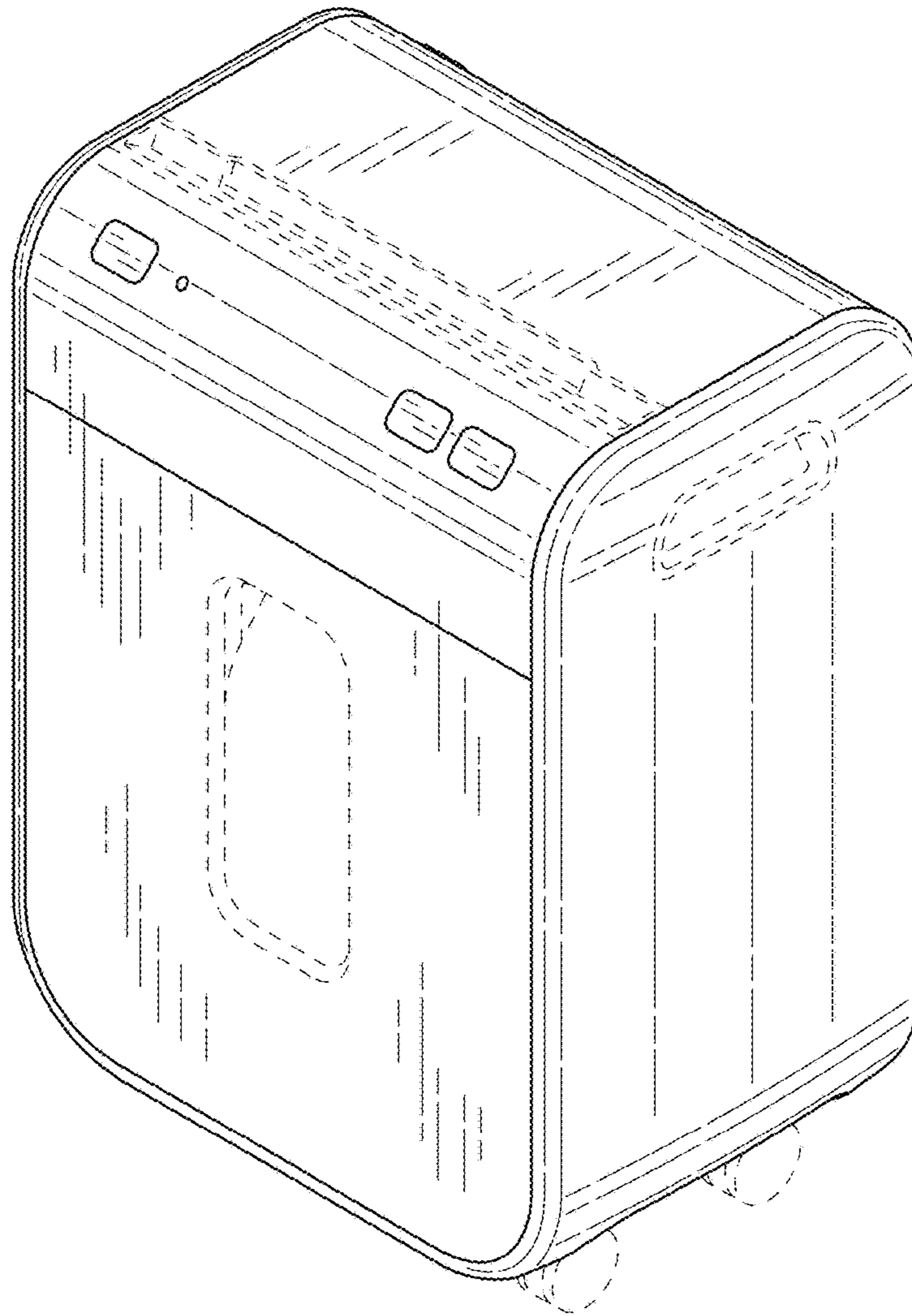

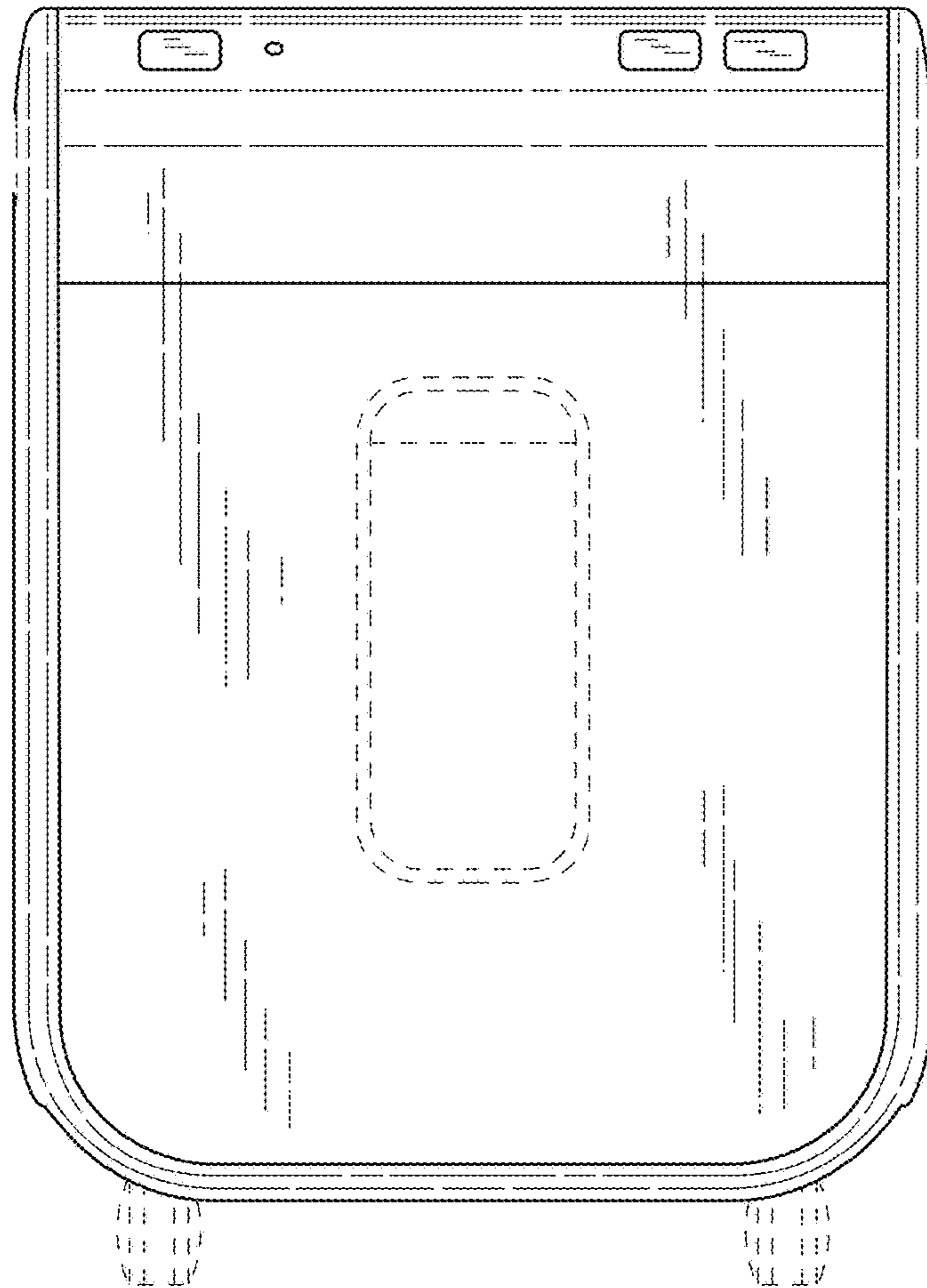

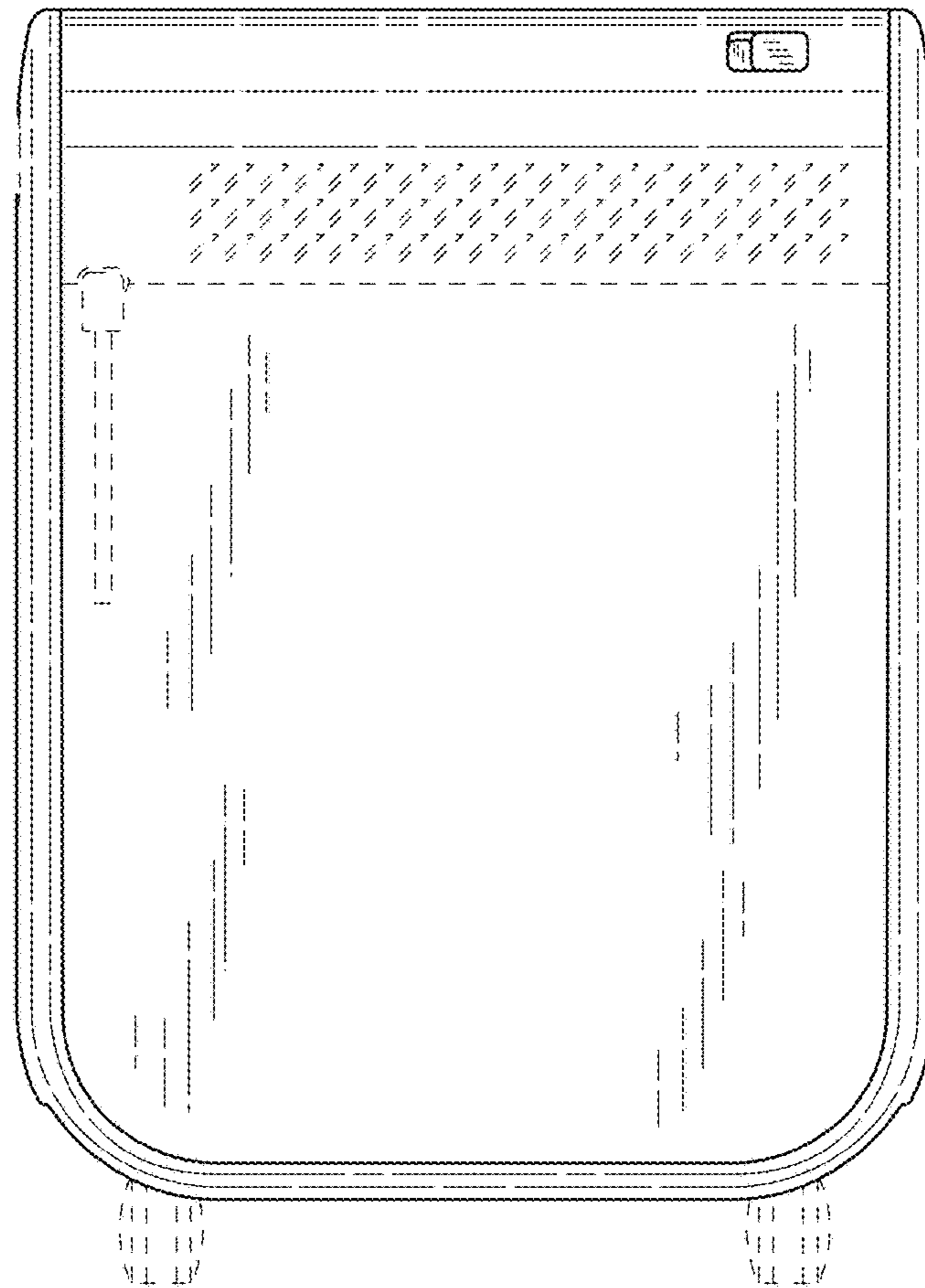

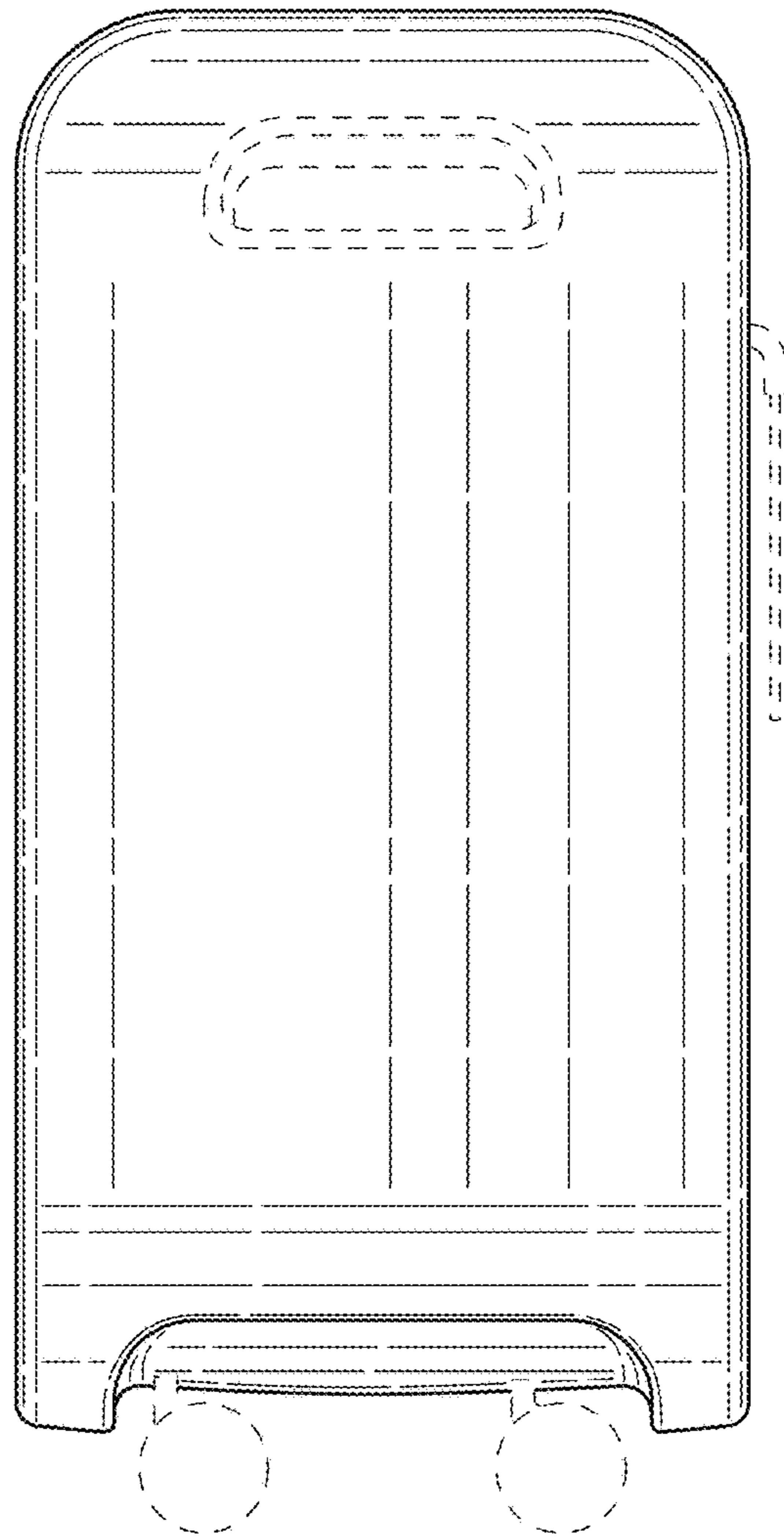

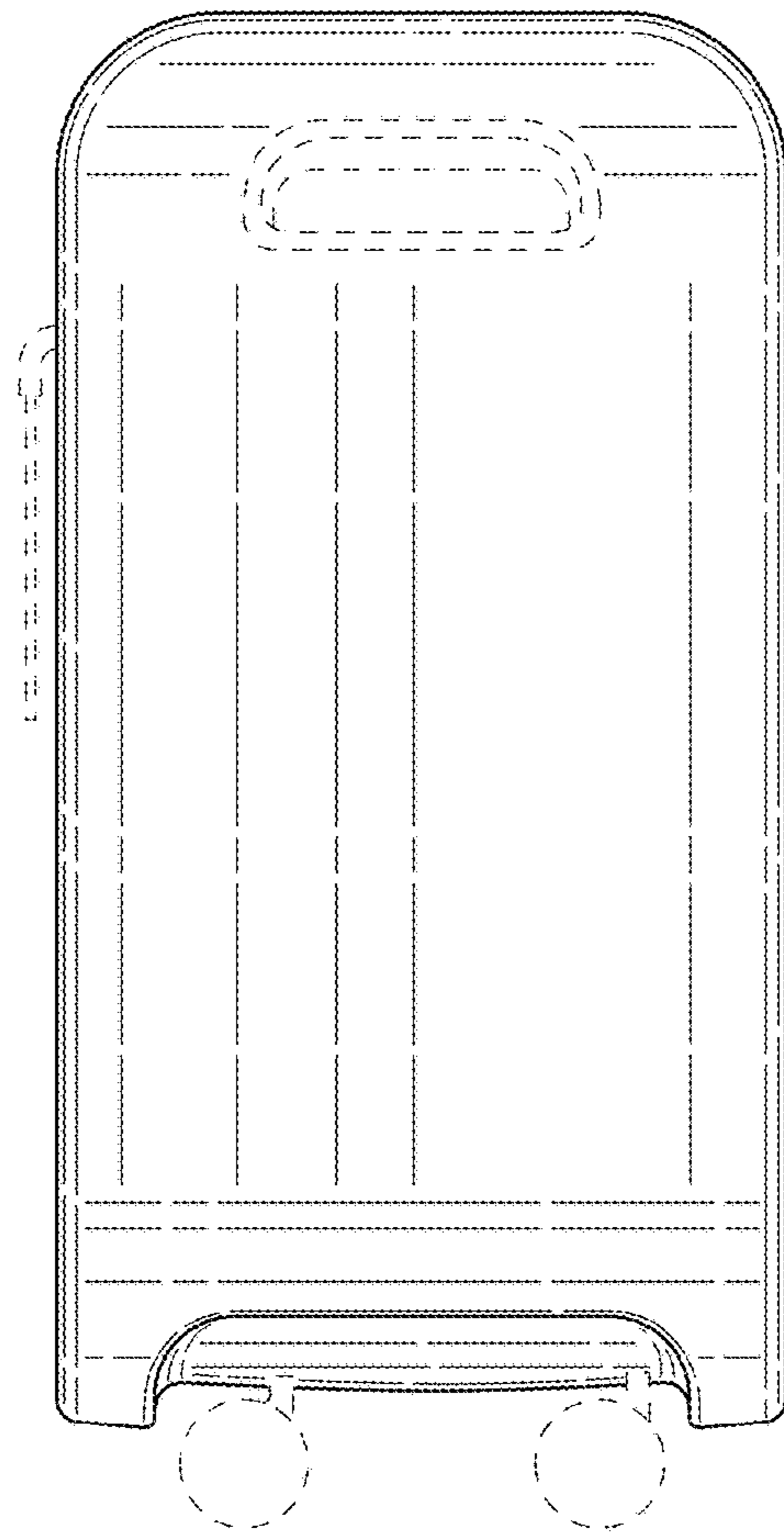

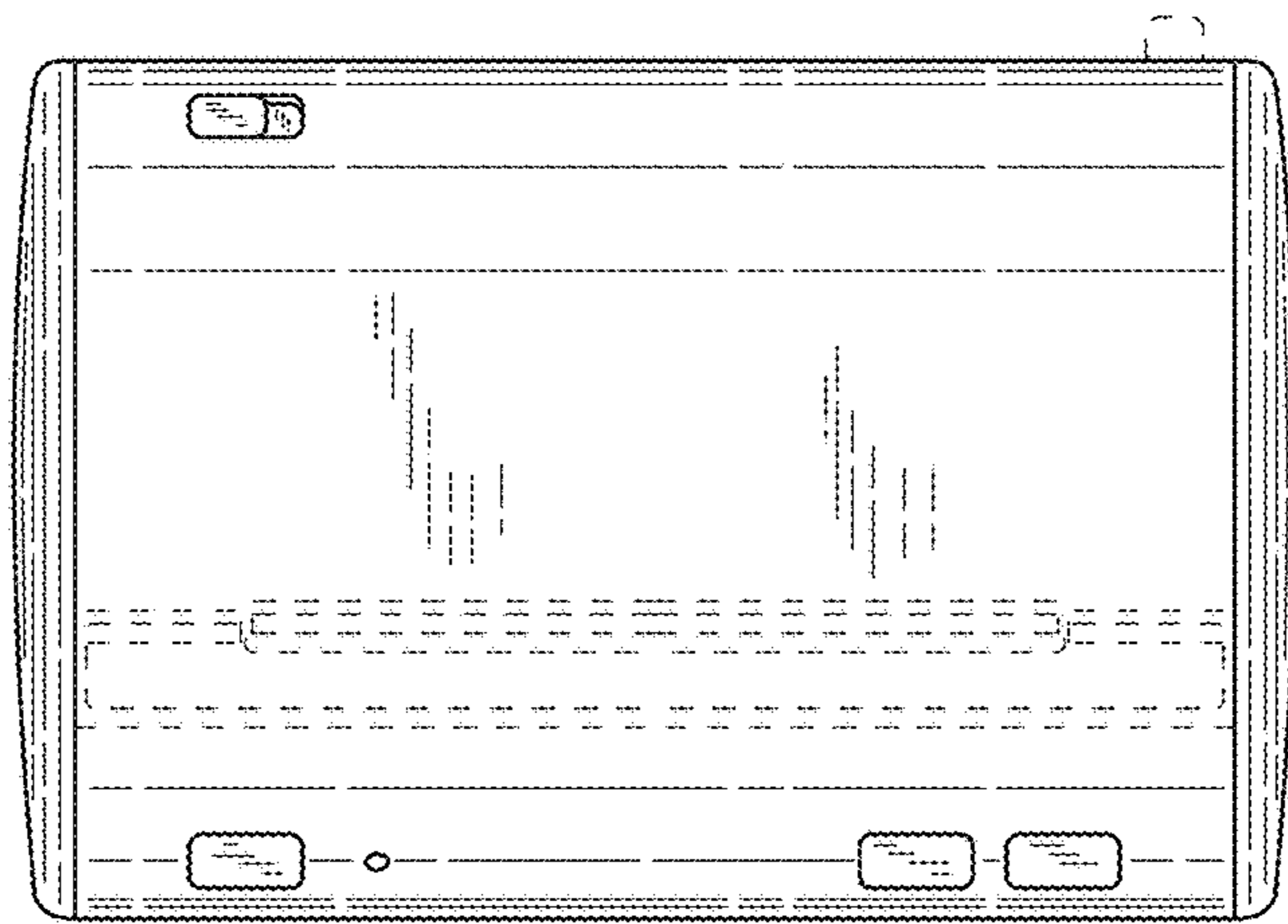

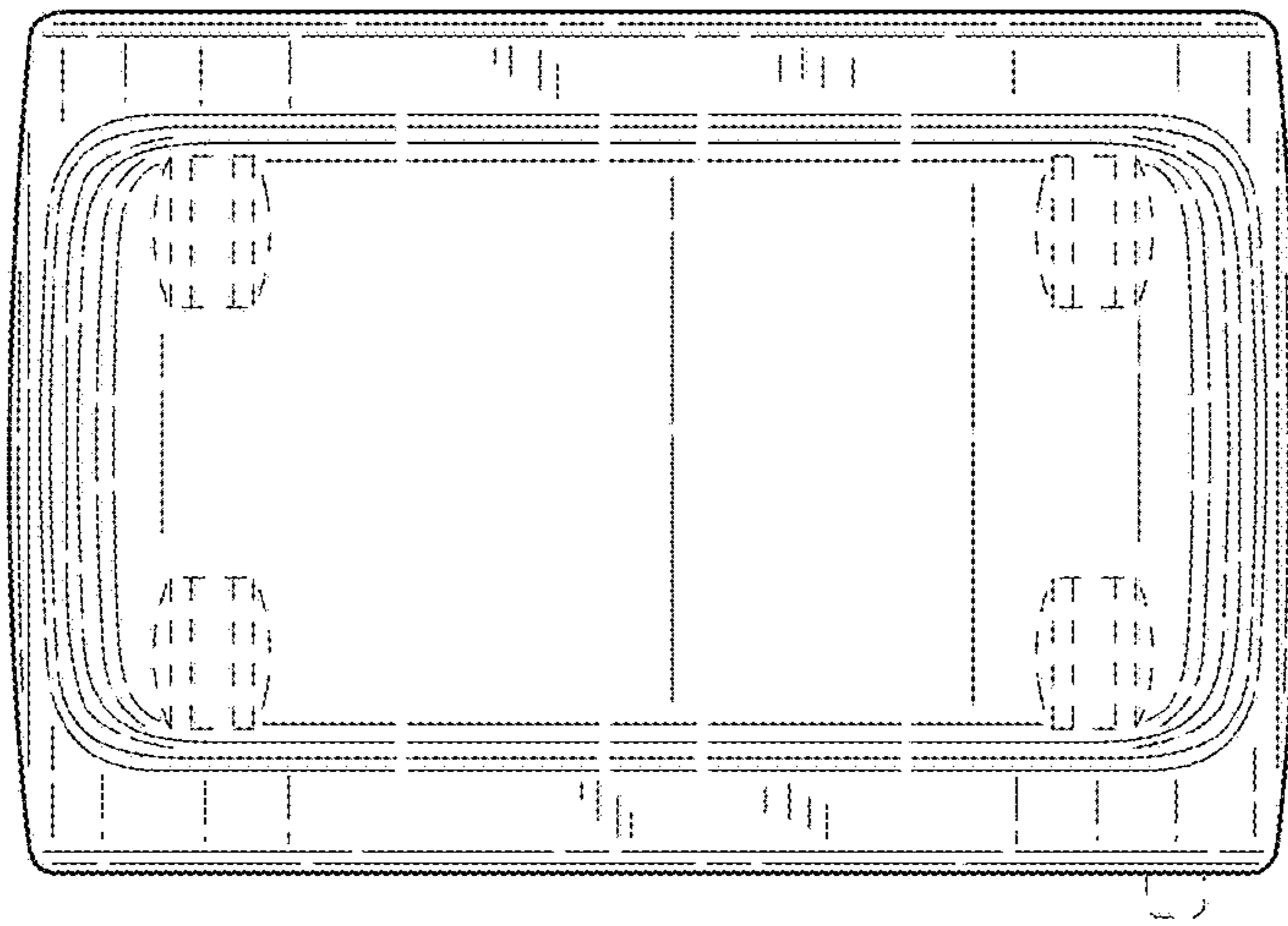
