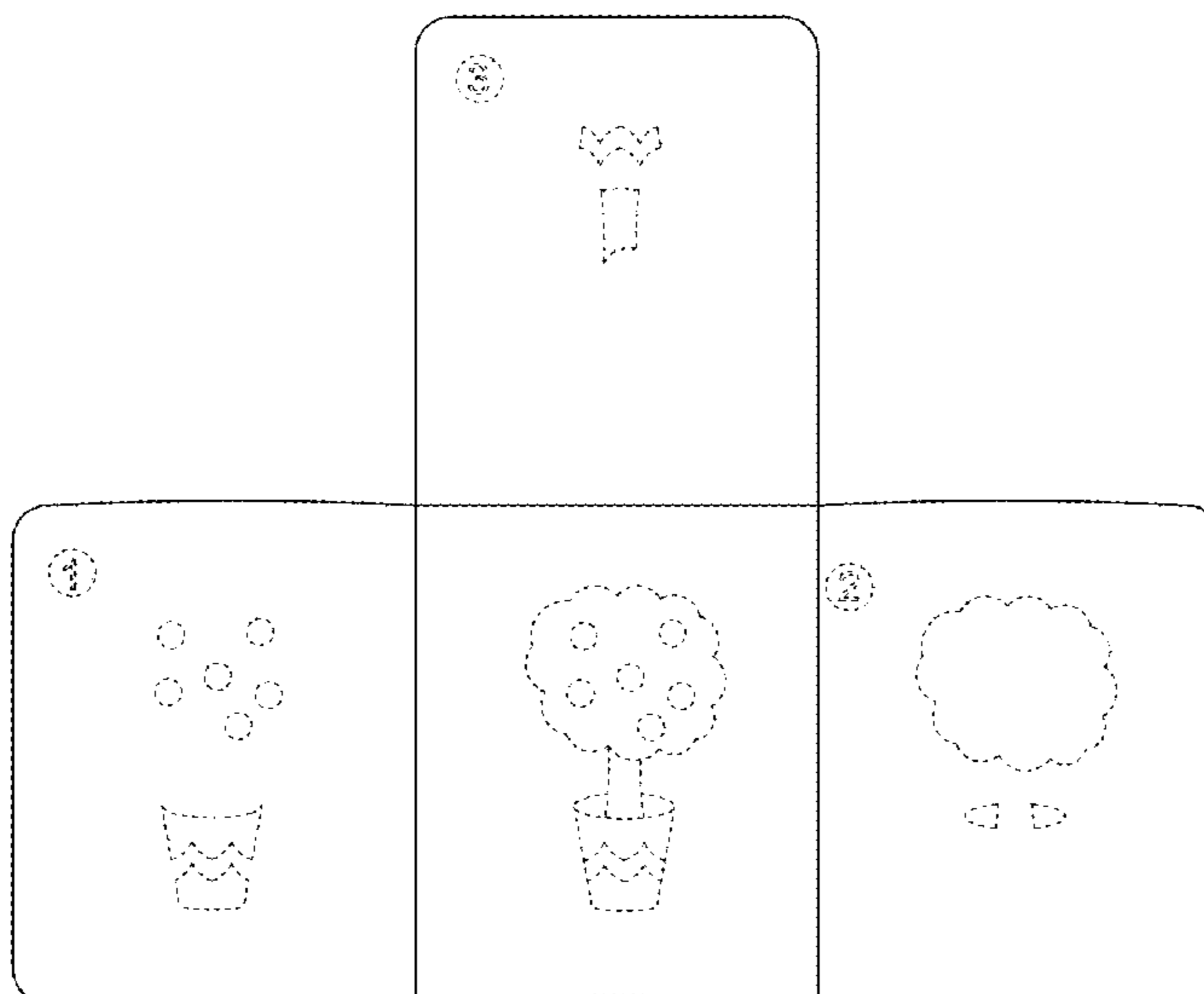
(57) **CLAIM**

The ornamental design for a foldable stencil, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the outside of the foldable stencil showing our new design folded;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is a rear view thereof;  
 FIG. 5 is a left side view thereof;  
 FIG. 6 is a right side view thereof;  
 FIG. 7 is a top plan view thereof unfolded;  
 FIG. 8 is a top plan view of the inside thereof;  
 FIG. 9 is a top plan view of the inside thereof with the two side panels folded inward;  
 FIG. 10 is a top plan view of the inside thereof with only the left side panel folded inward;  
 FIG. 11 is a top plan view of the inside thereof with only the right side panel folded inward;  
 FIG. 12 is a top plan view of the inside thereof with only the top panel folded downward;  
 FIG. 13 is a top perspective inside view thereof;  
 FIG. 14 is another top perspective inside view thereof;  
 FIG. 15 is a top plan view of the outside thereof folded closed in use;  
 FIG. 16 is a bottom plan view of the outside thereof;  
 FIG. 17 is a top plan view of the inside thereof unfolded;  
 FIG. 18 is a top plan view of the outside thereof;  
 FIG. 19 is a top plan view of the inside thereof with only the left side panel folded inward;  
 FIG. 20 is a top plan view of the inside thereof with only the right side panel folded inward; and,  
 FIG. 21 is a top plan view thereof with only the top panel folded downward.  
 The broken lines are included to show portions of the foldable stencil that form no part of the claimed design.

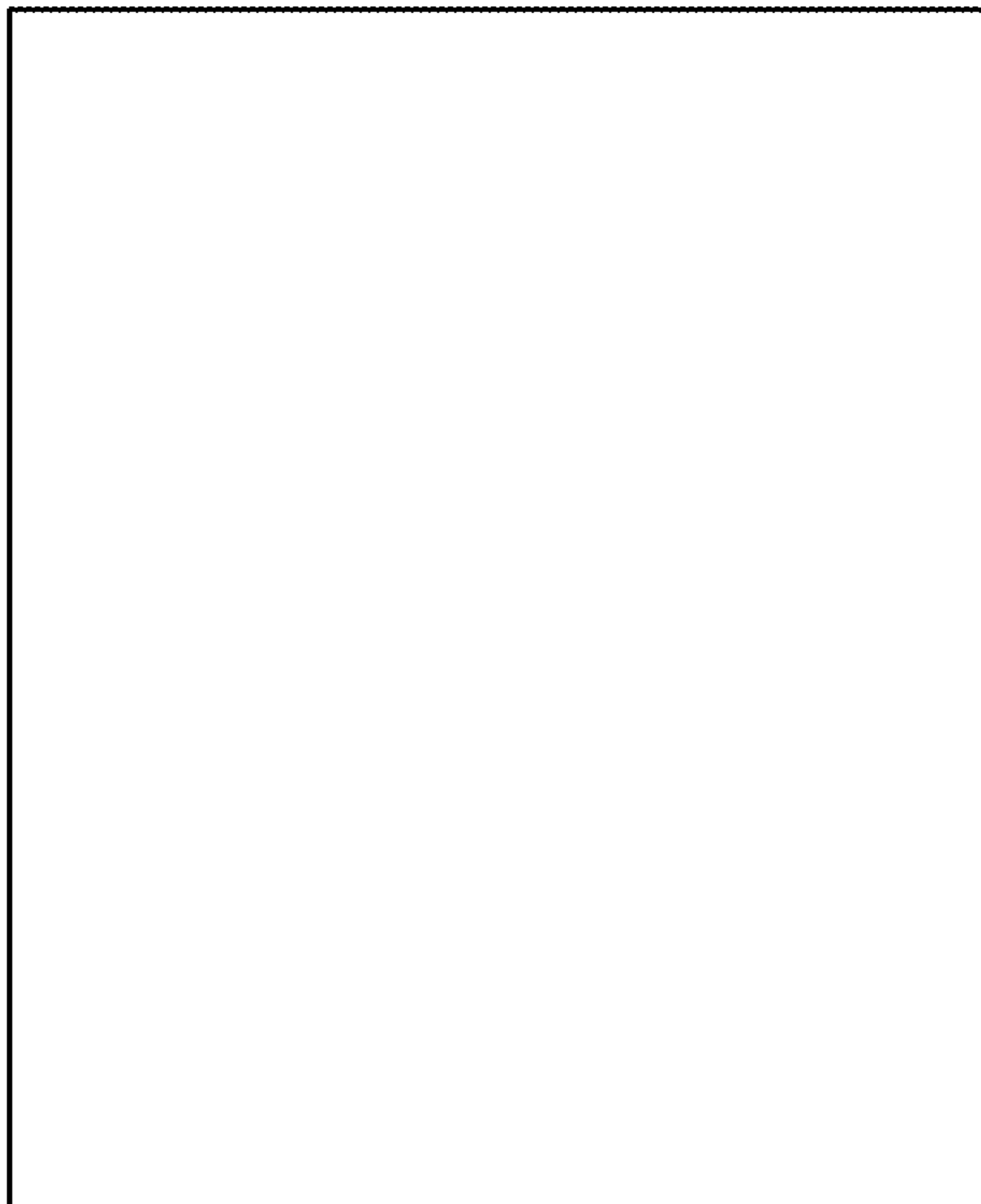

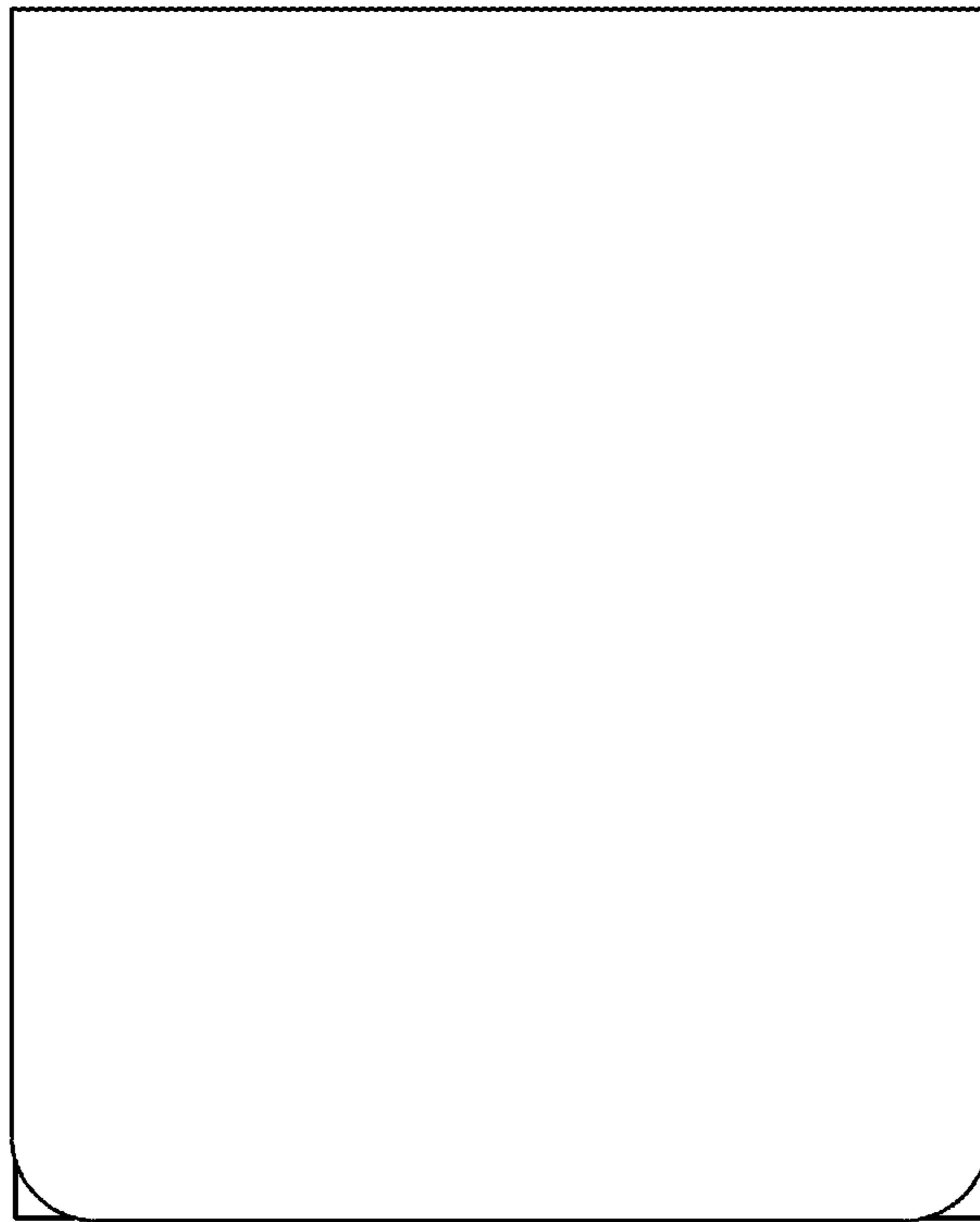

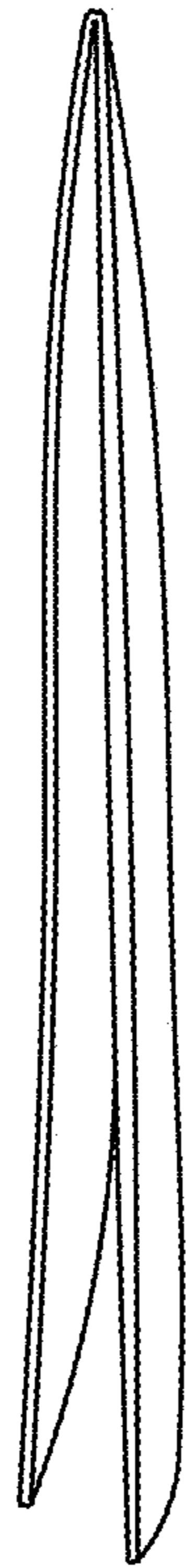

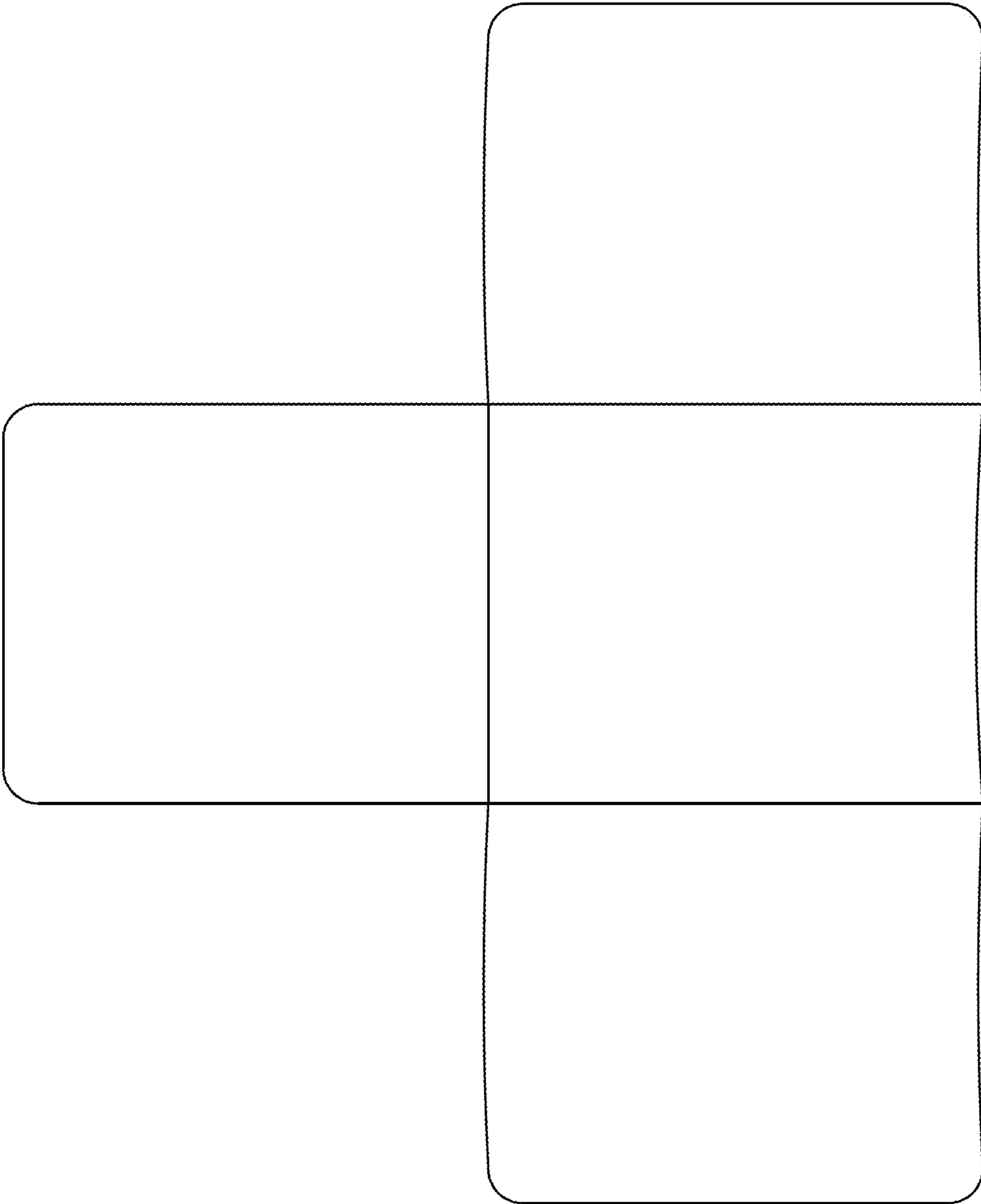

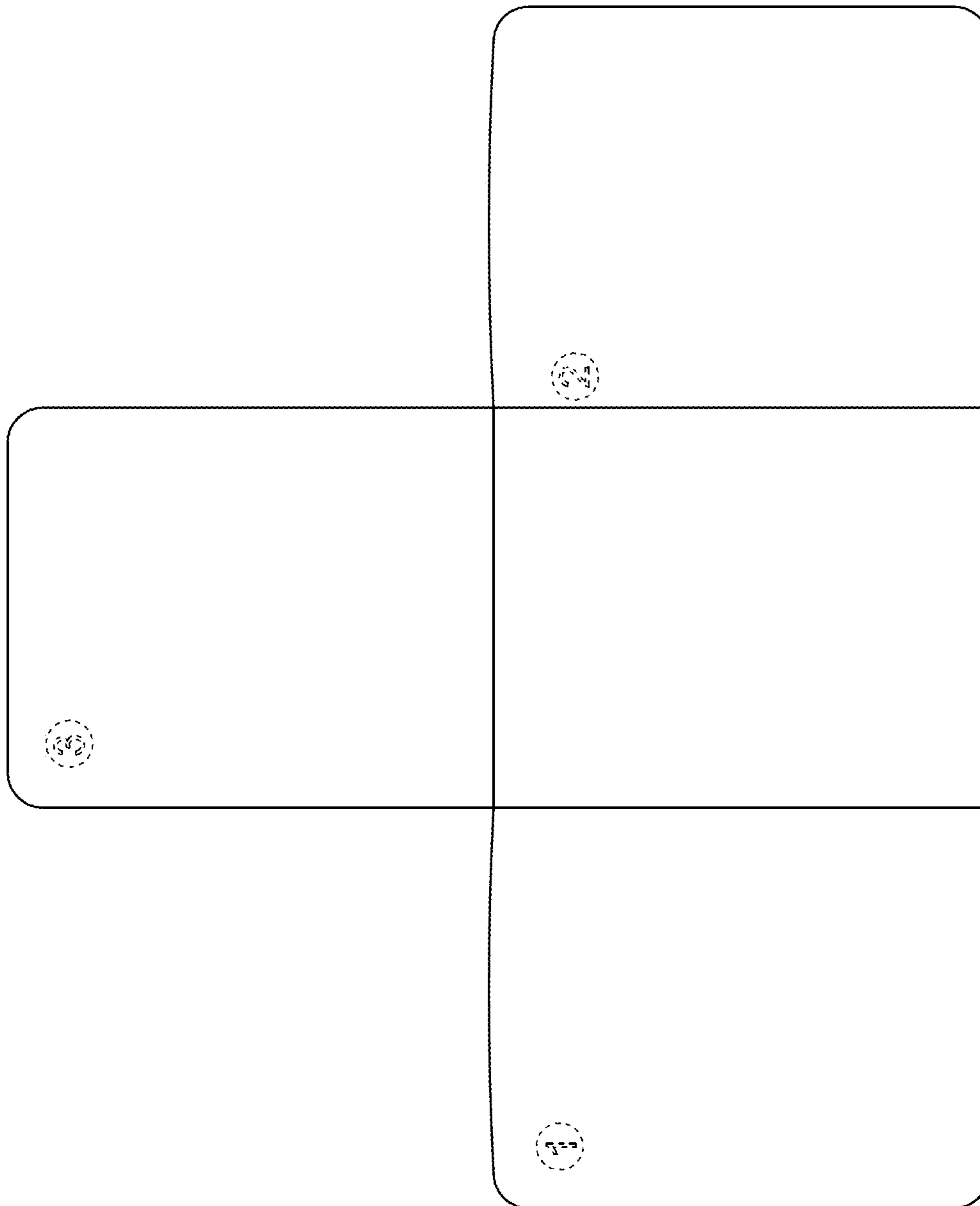

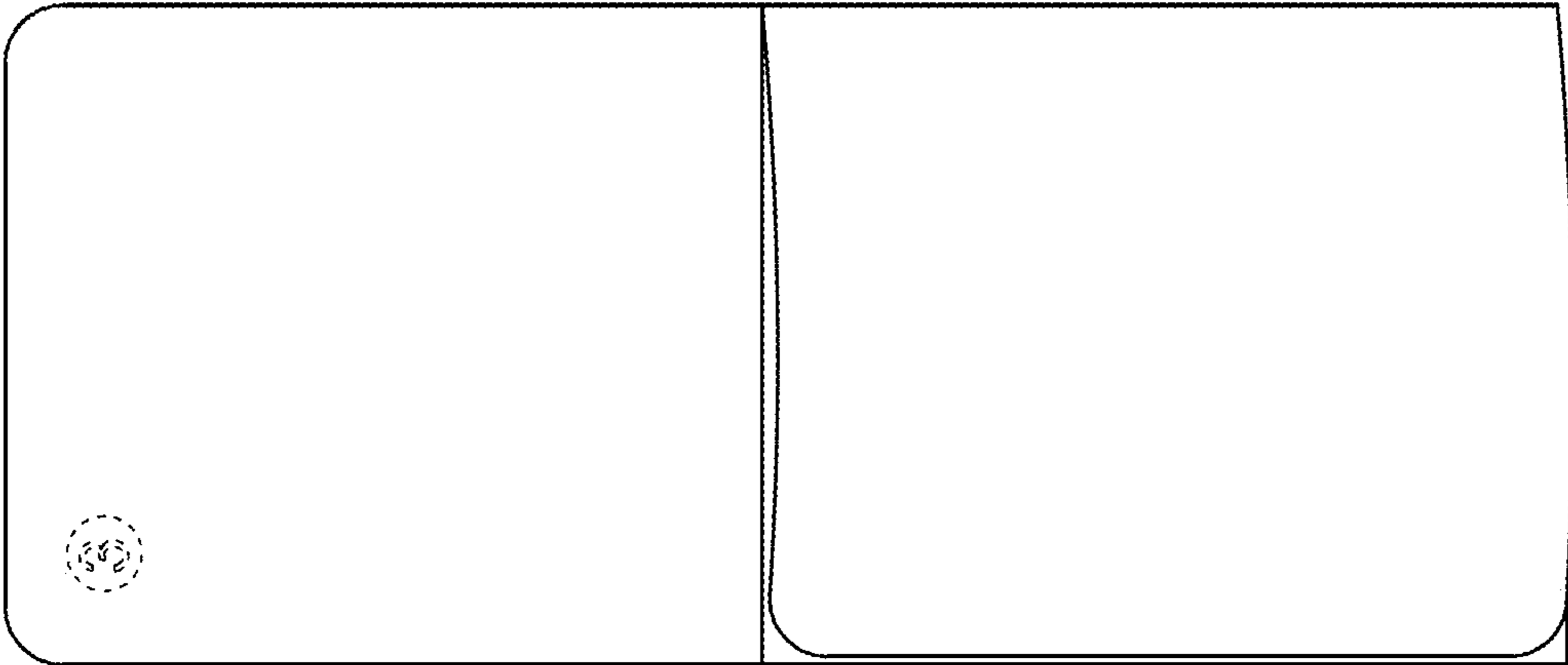

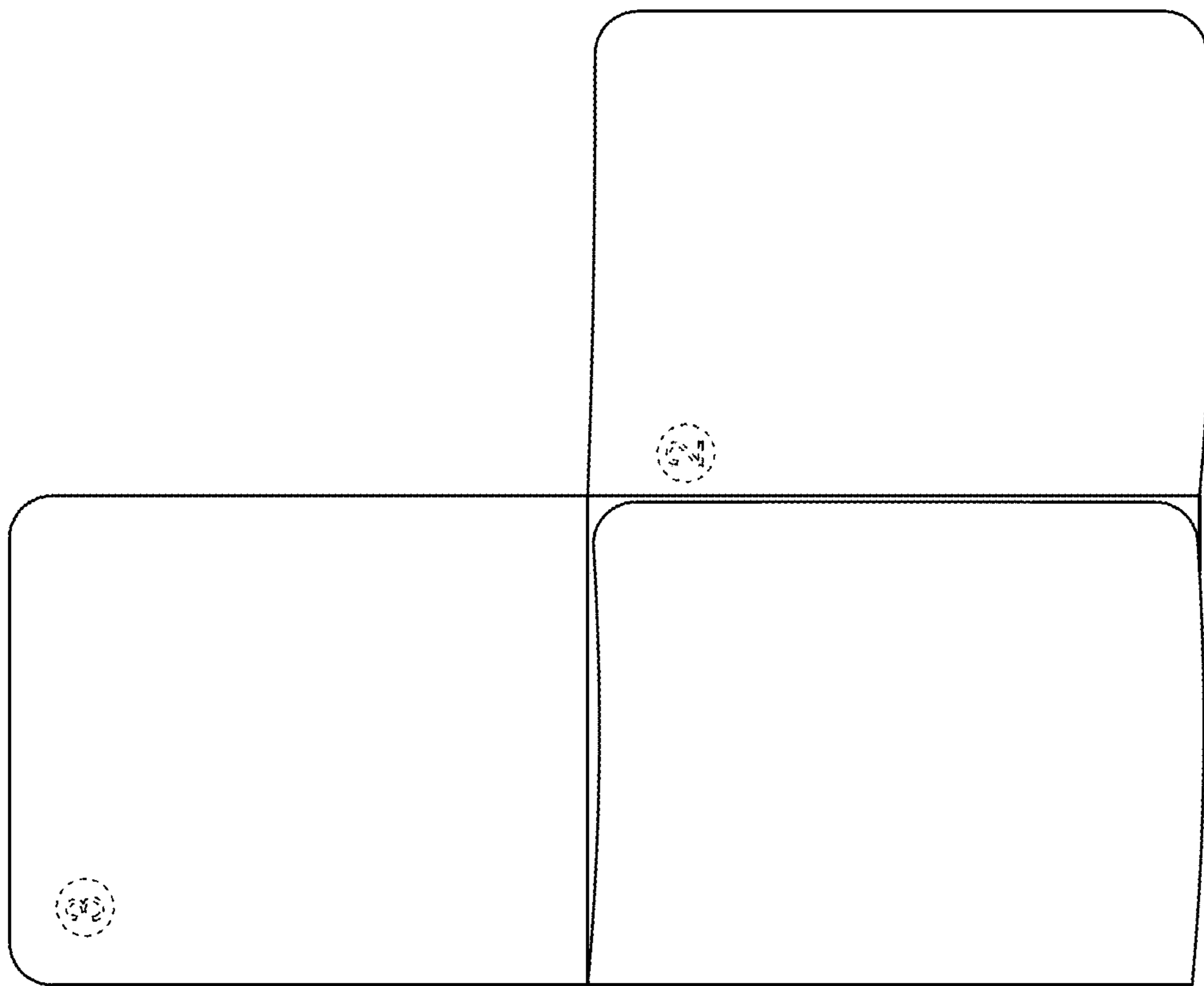

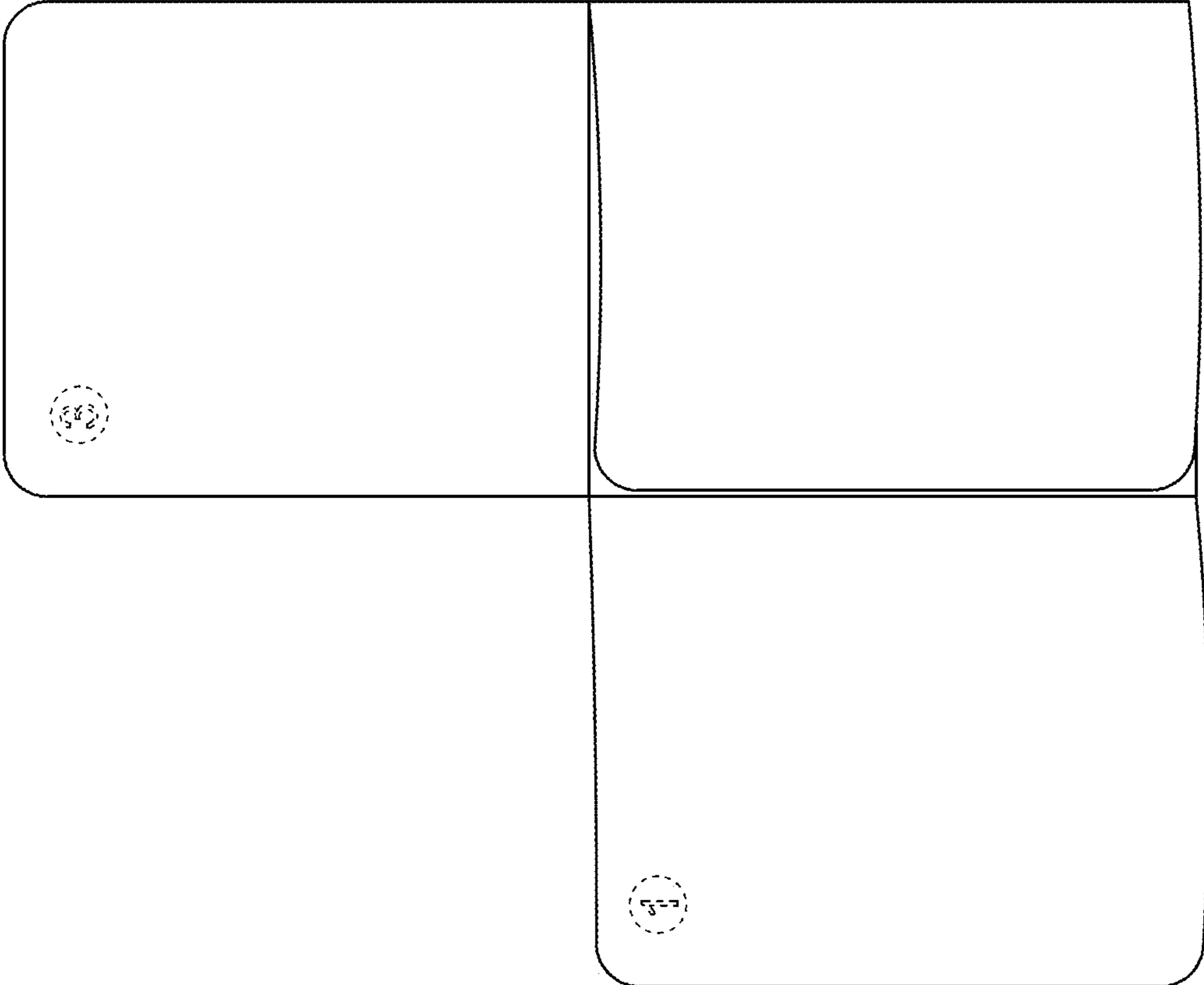

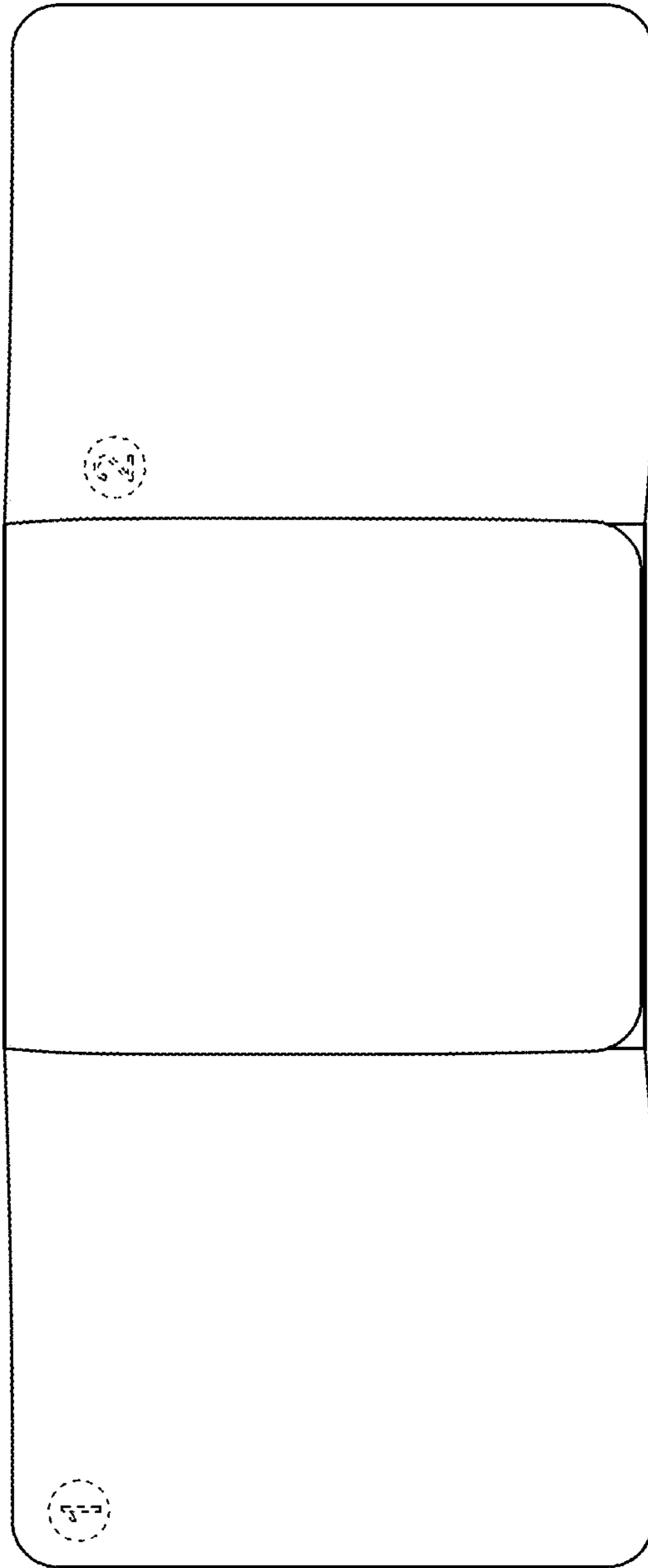

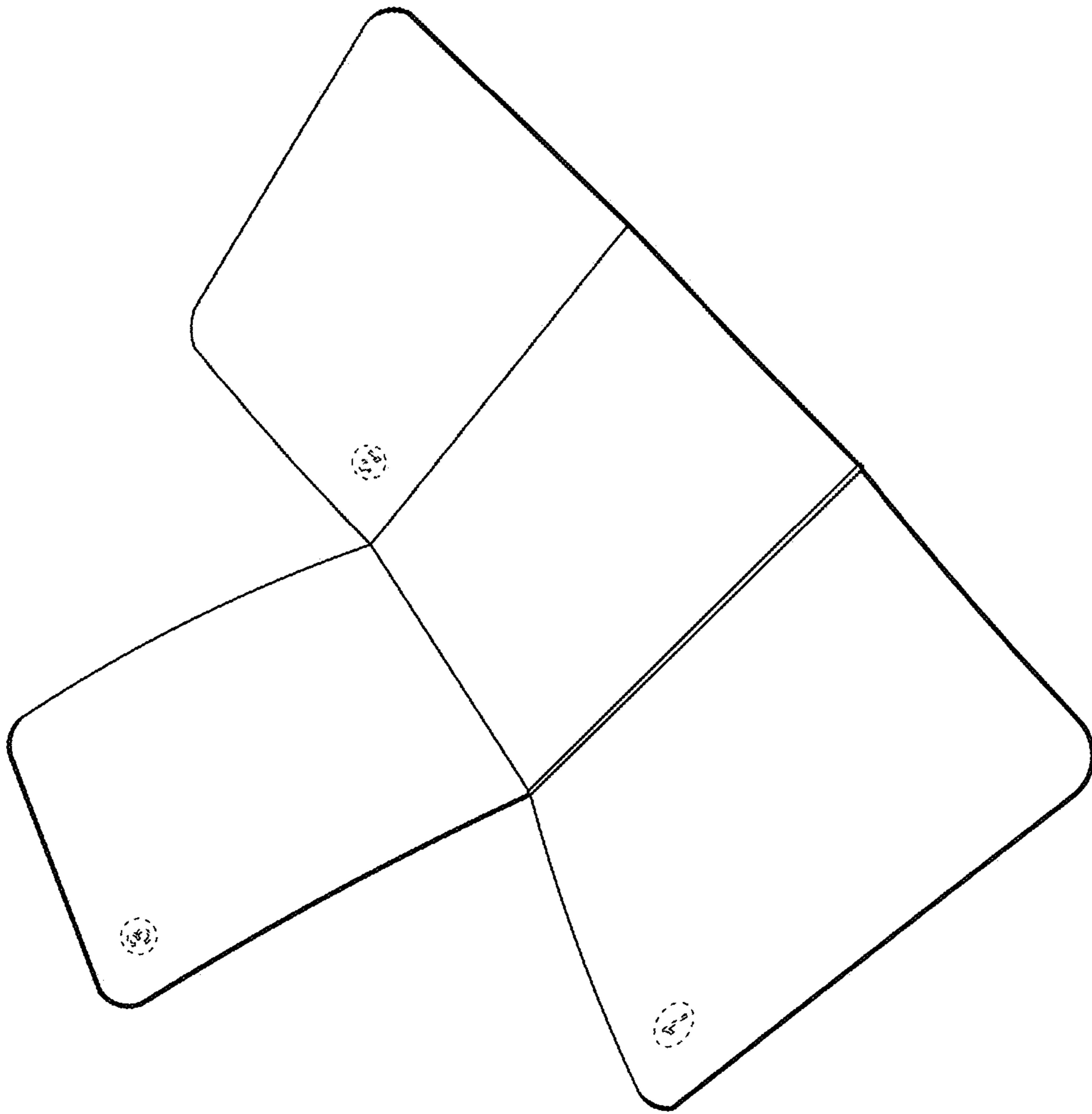

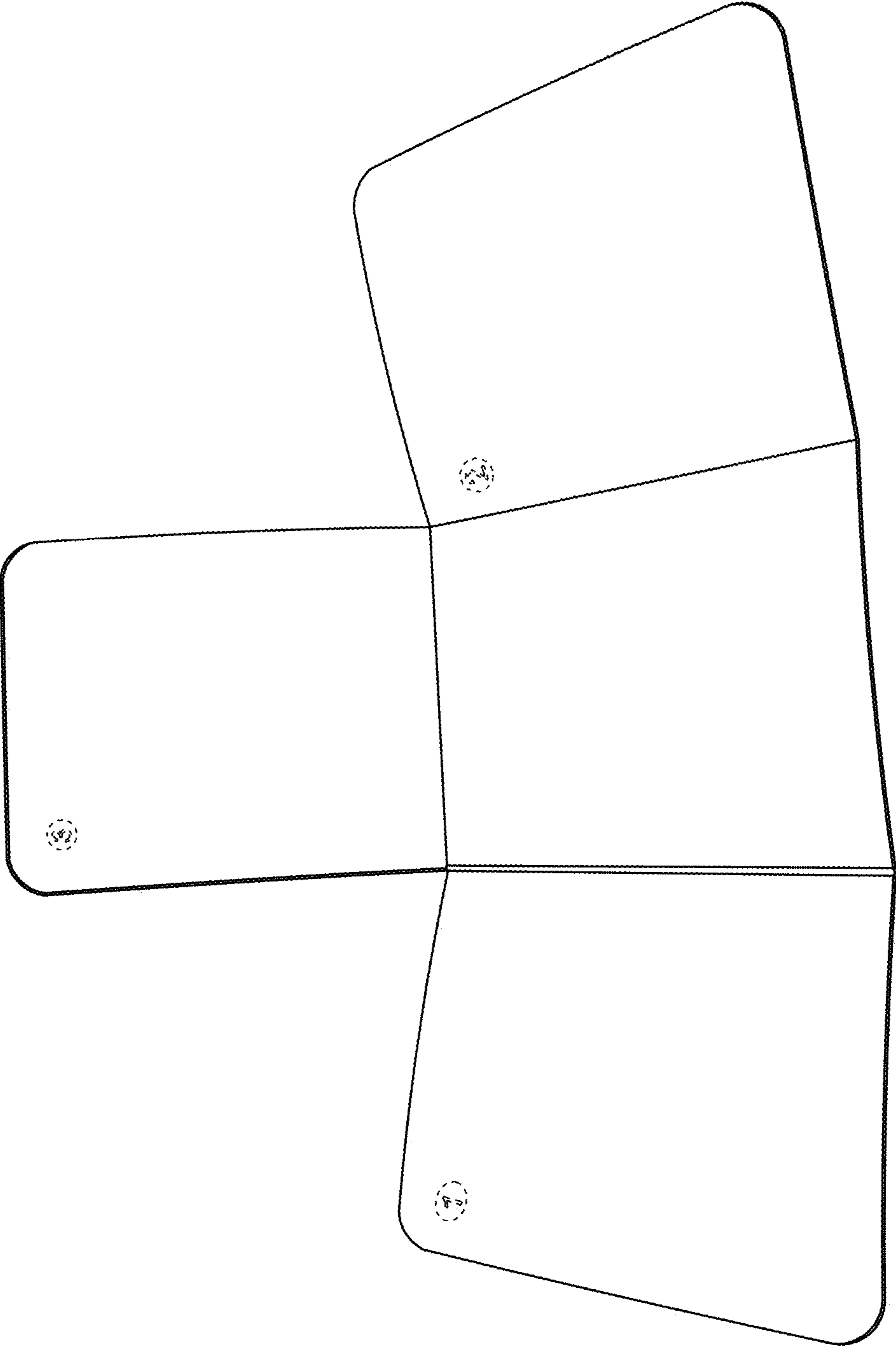

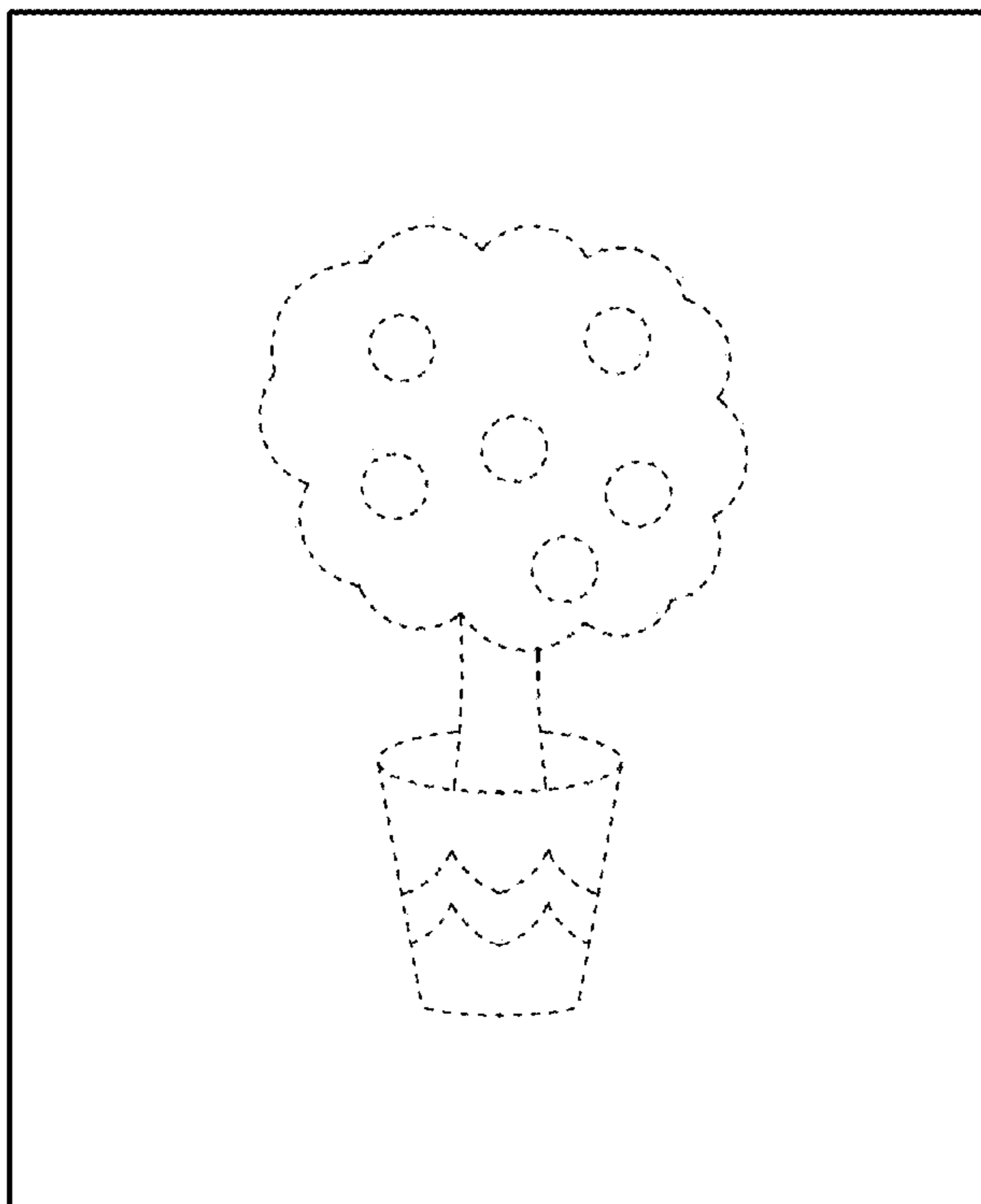

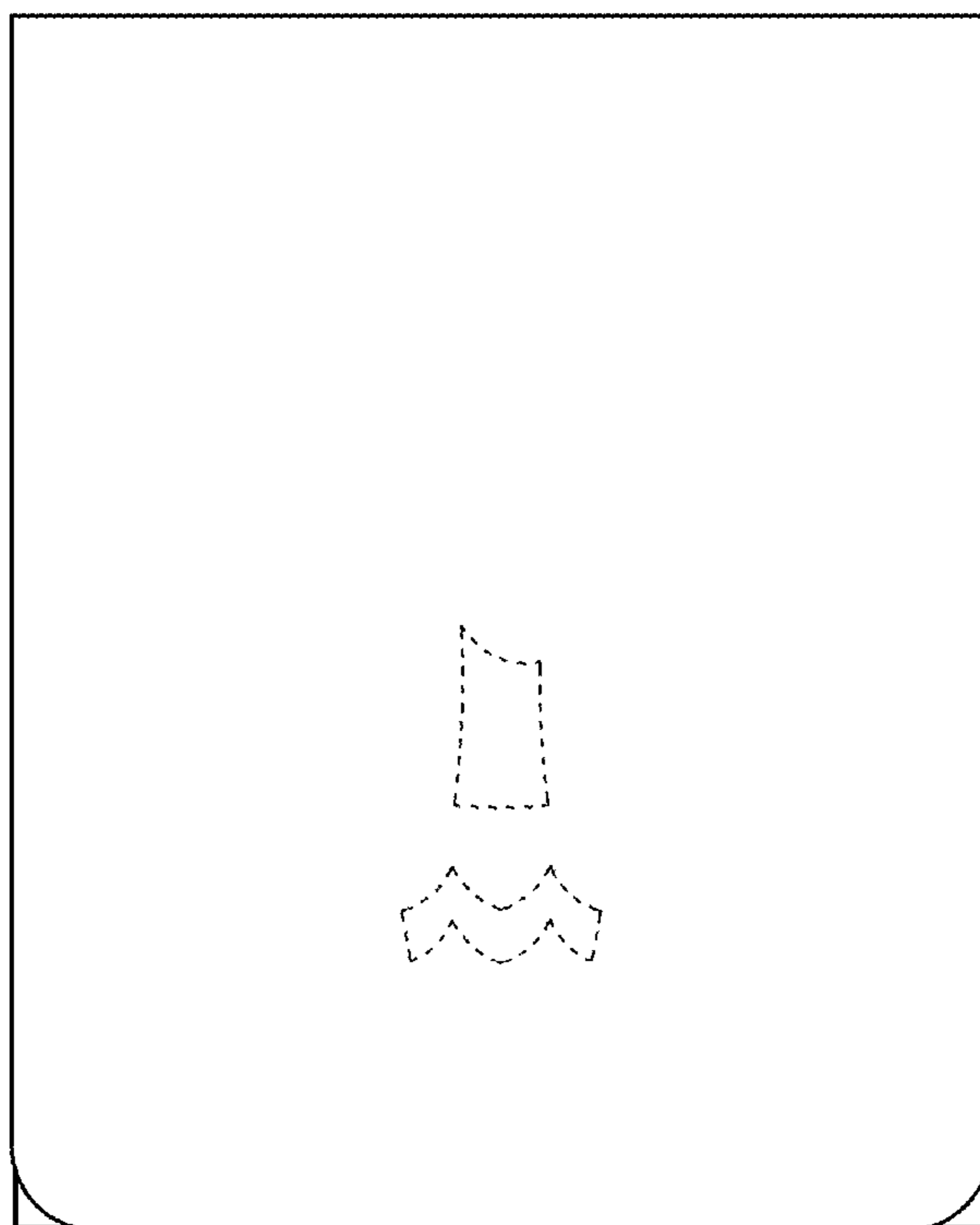

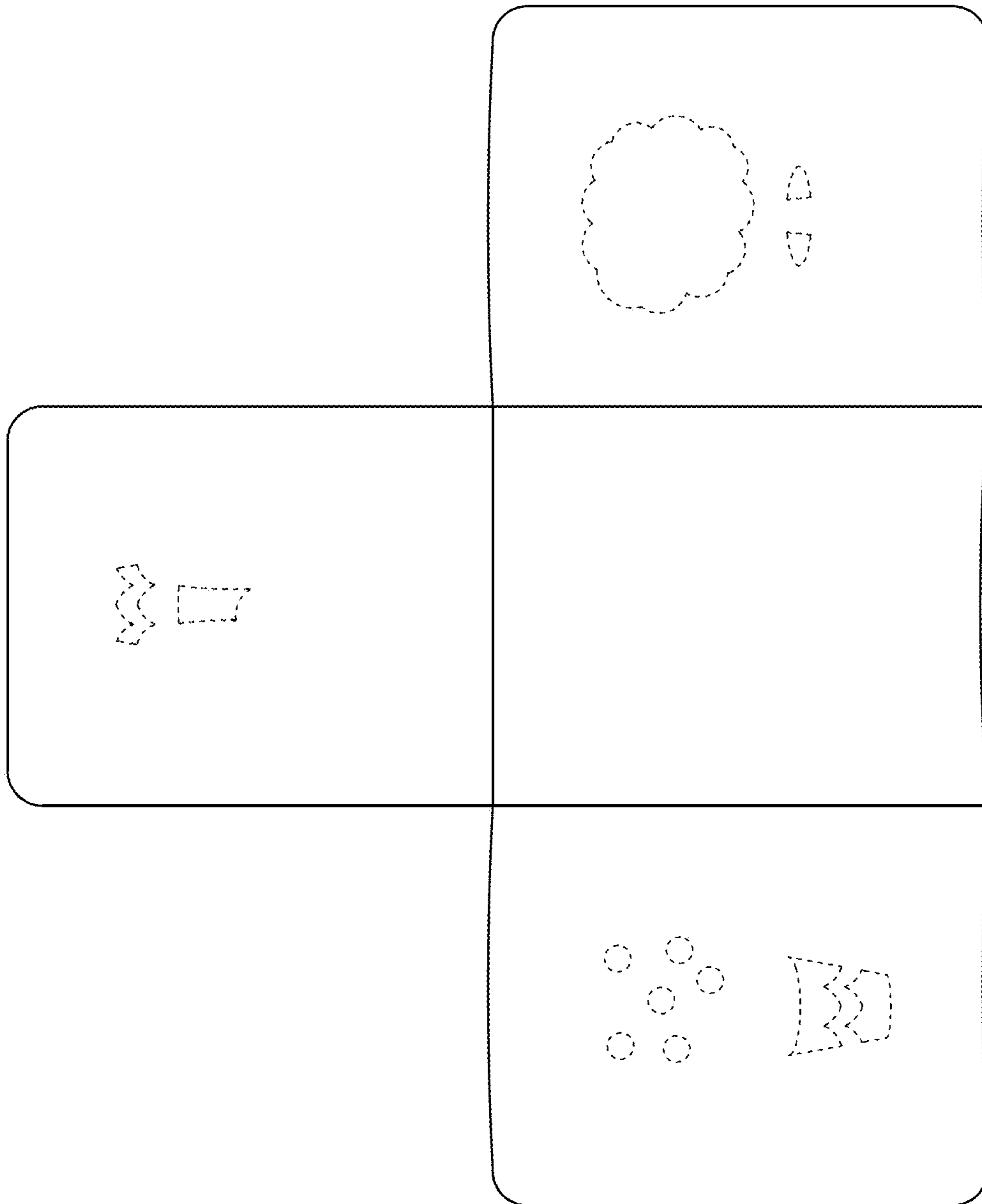

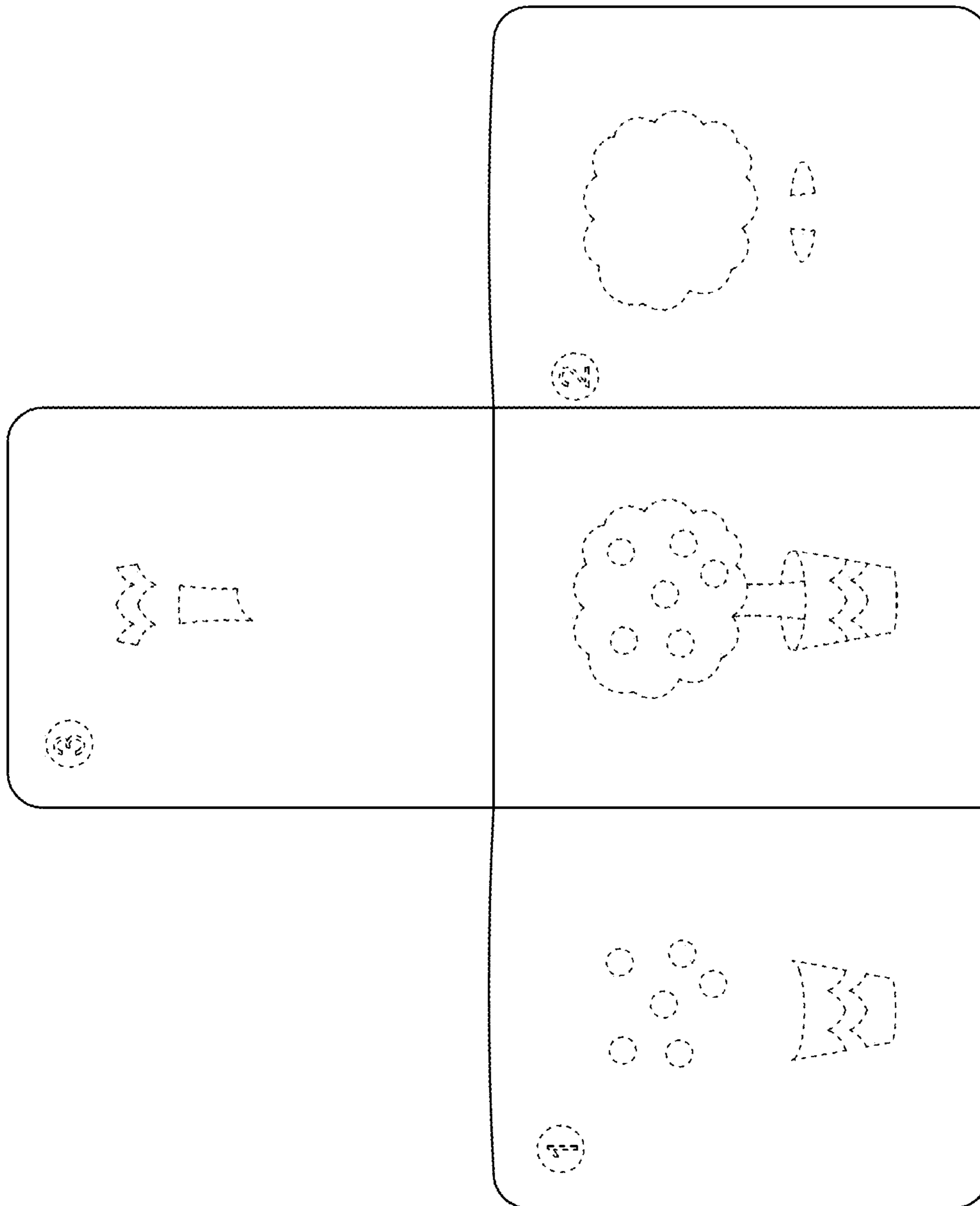

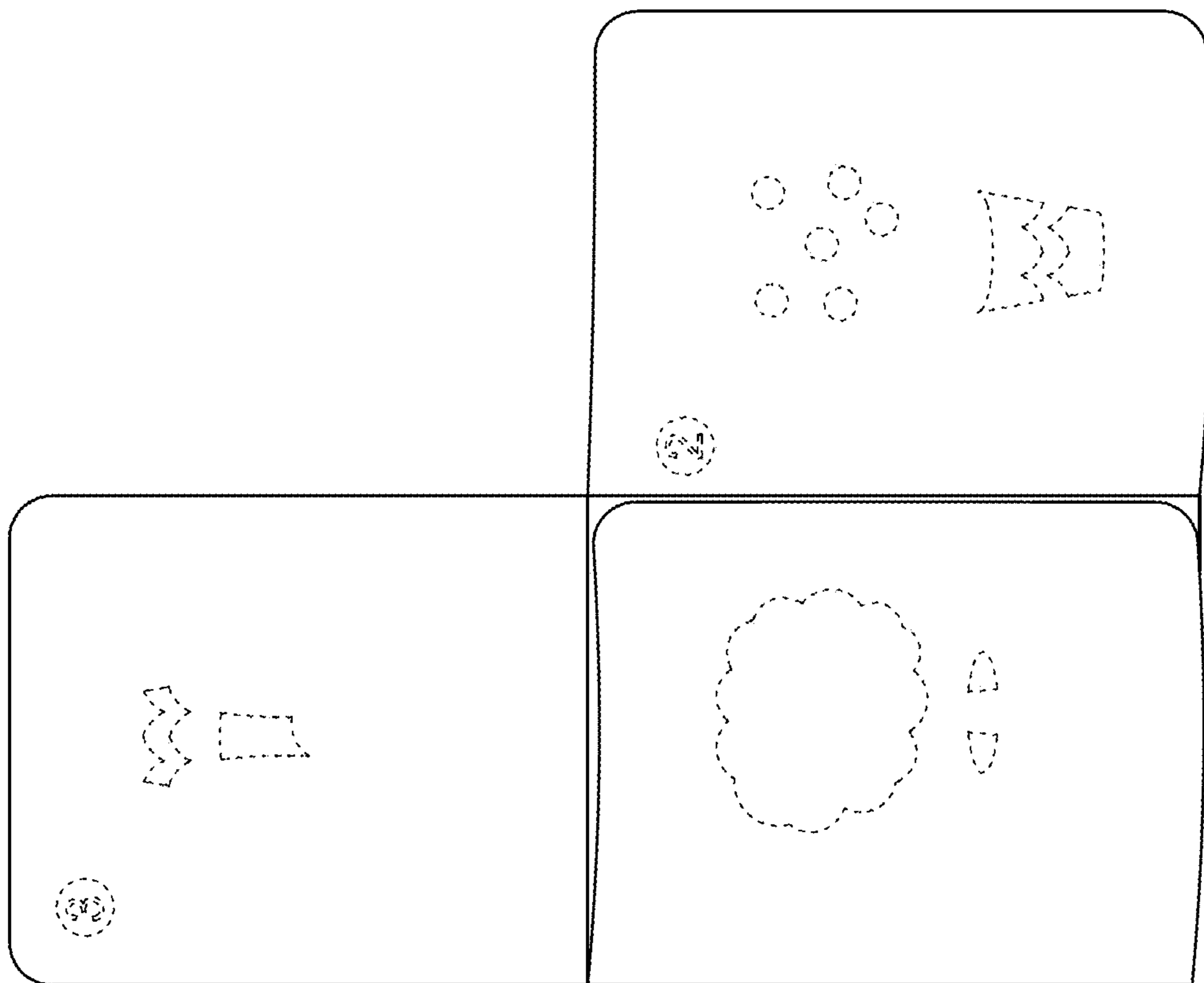

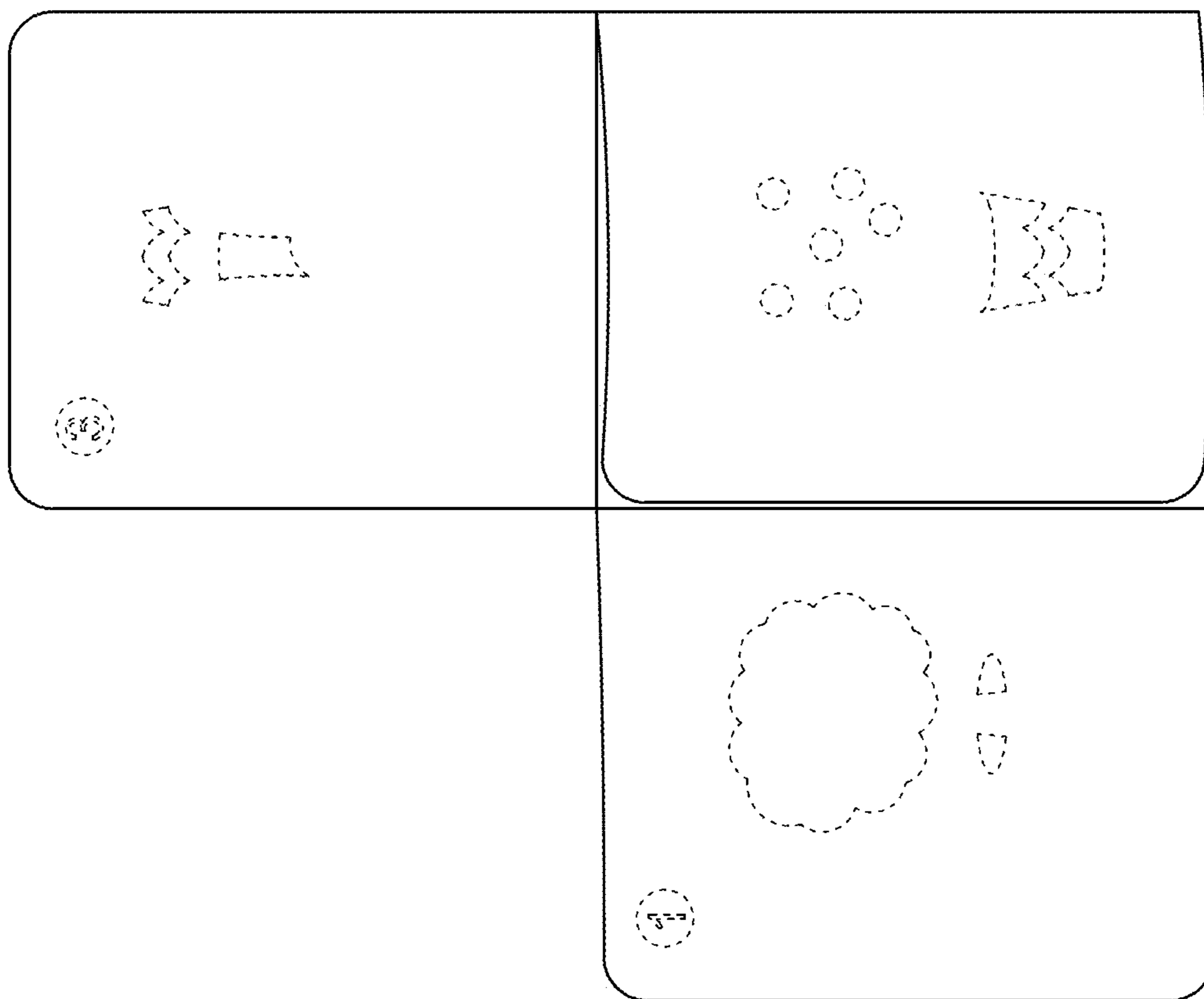

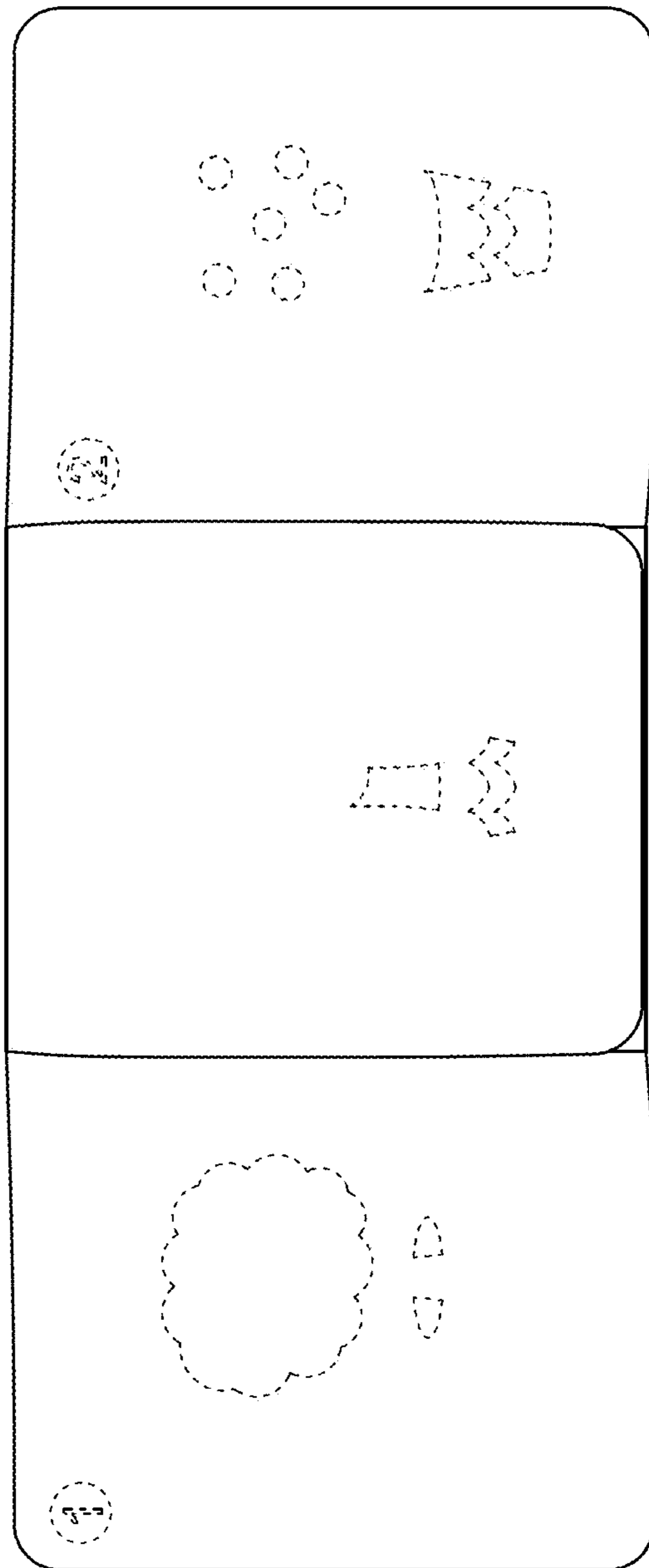
