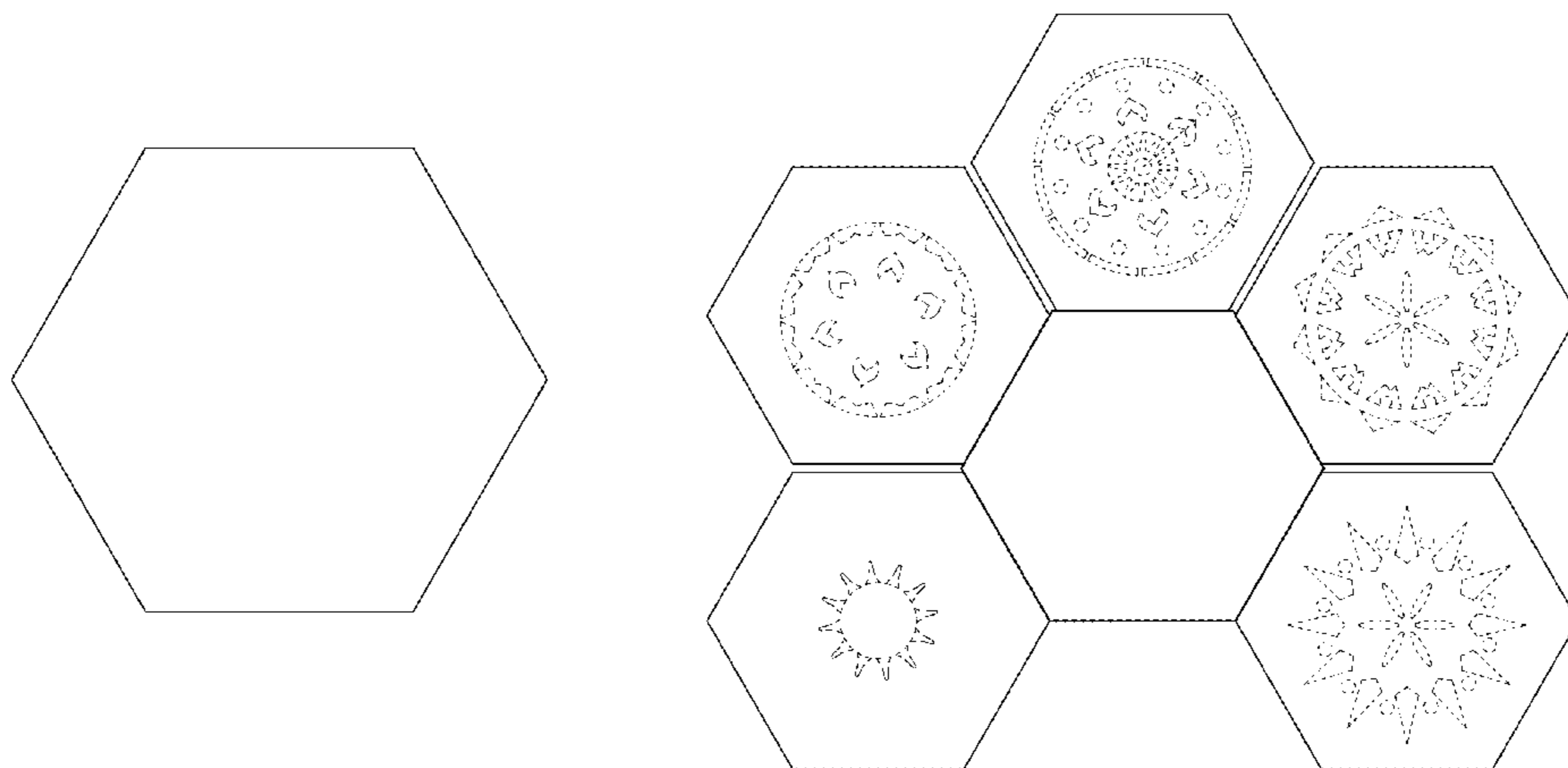


FIG. 31 is a view thereof with the lower left panel folded inward;

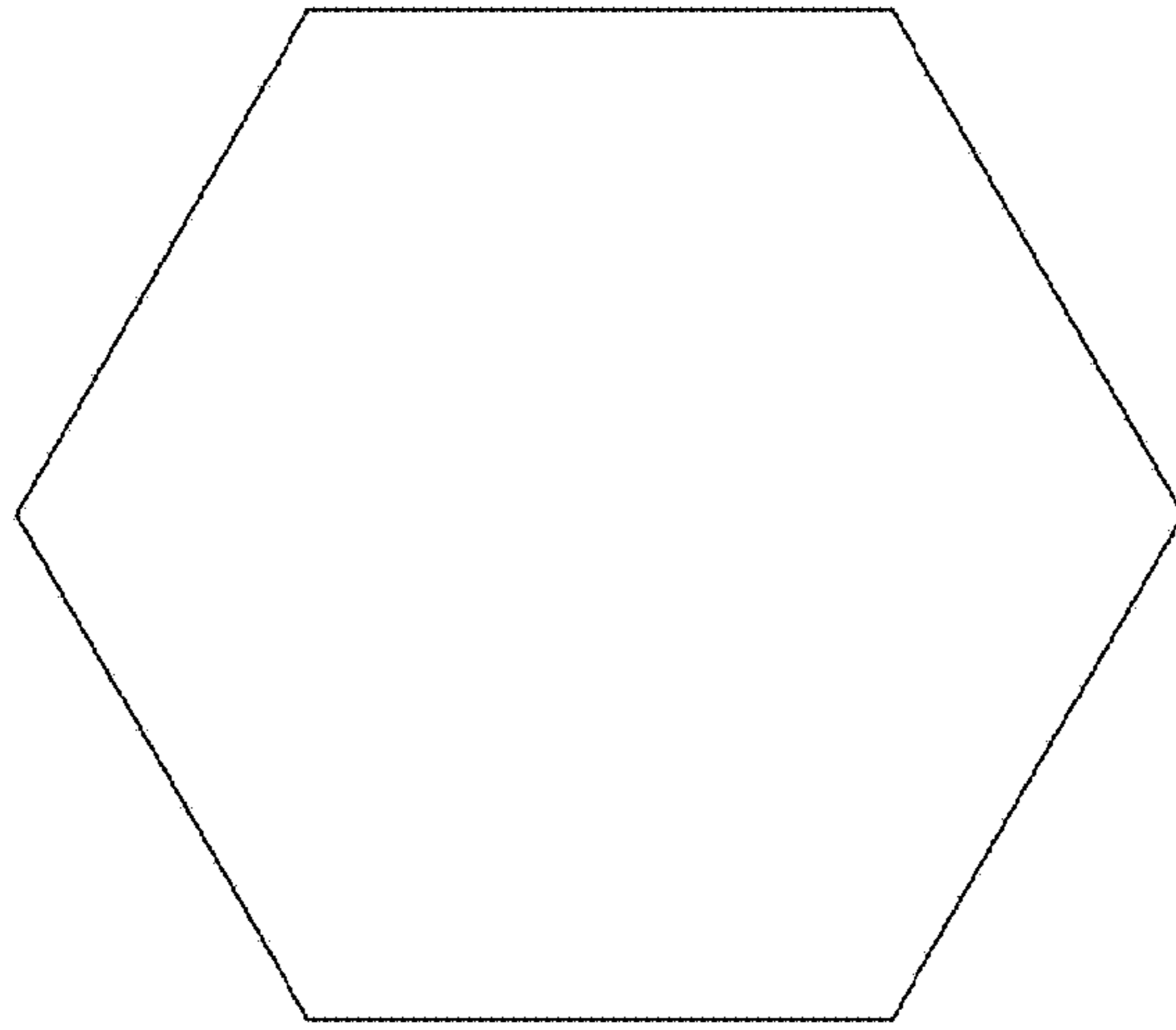

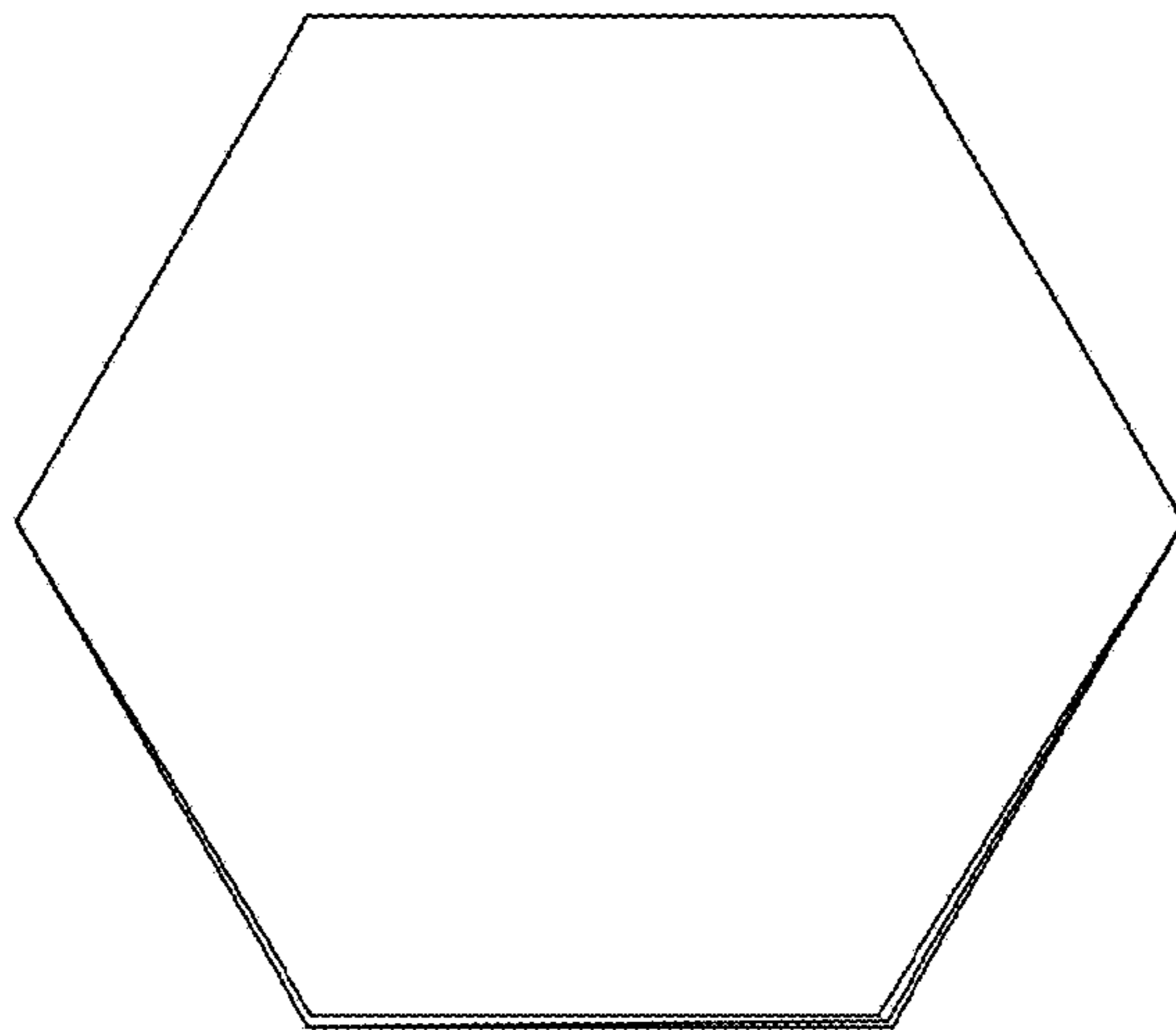

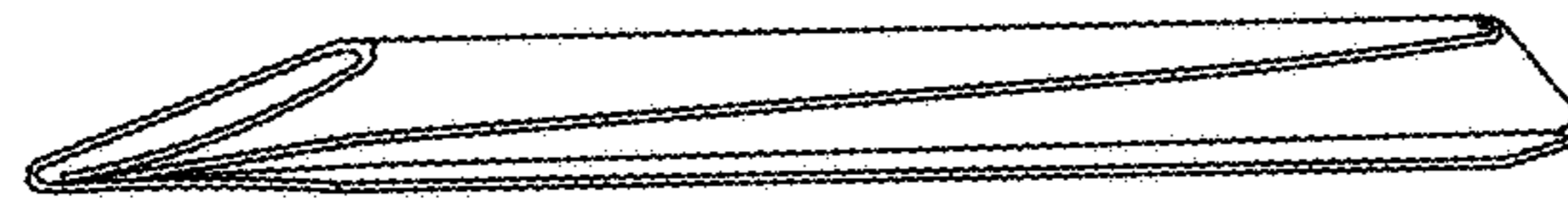

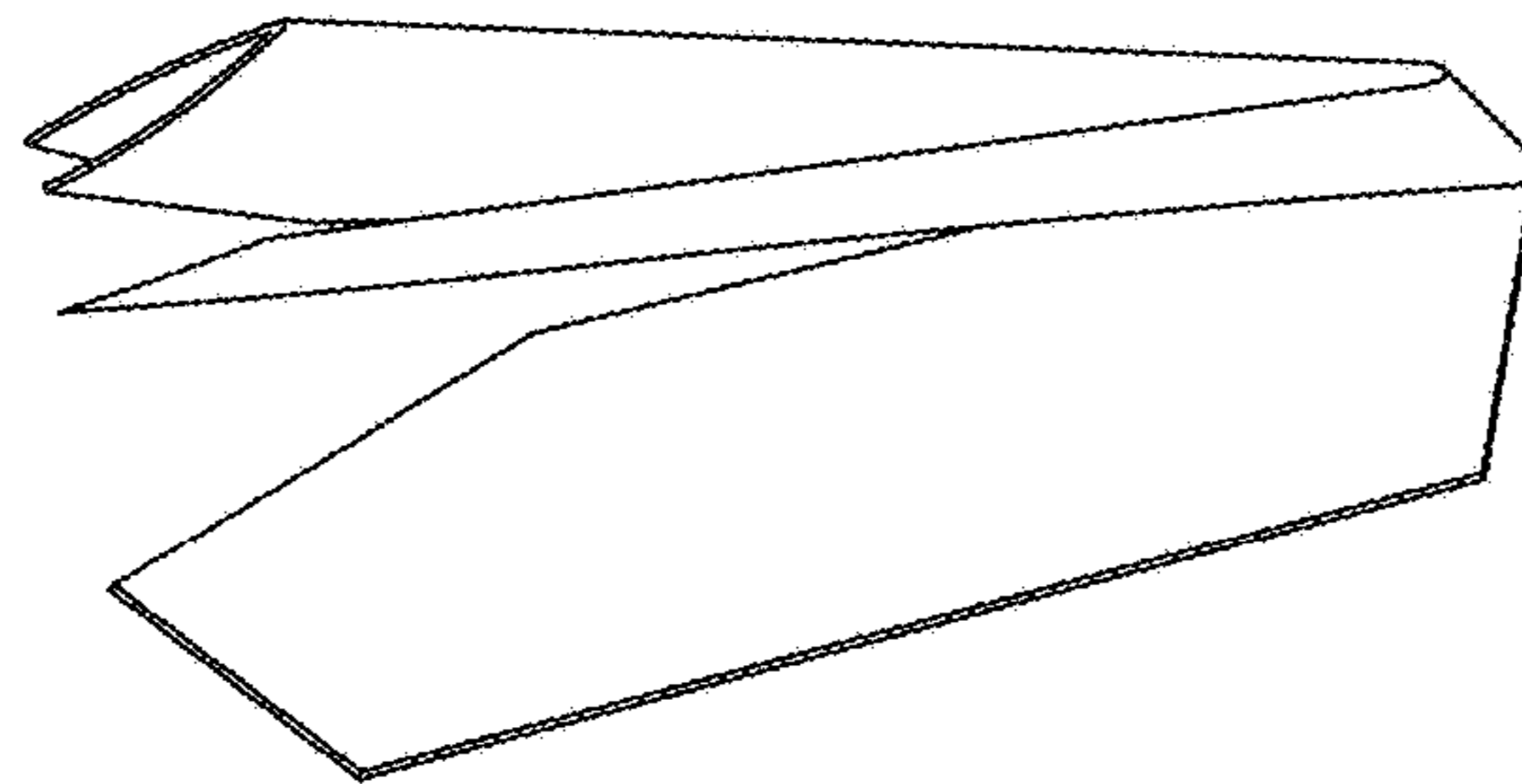

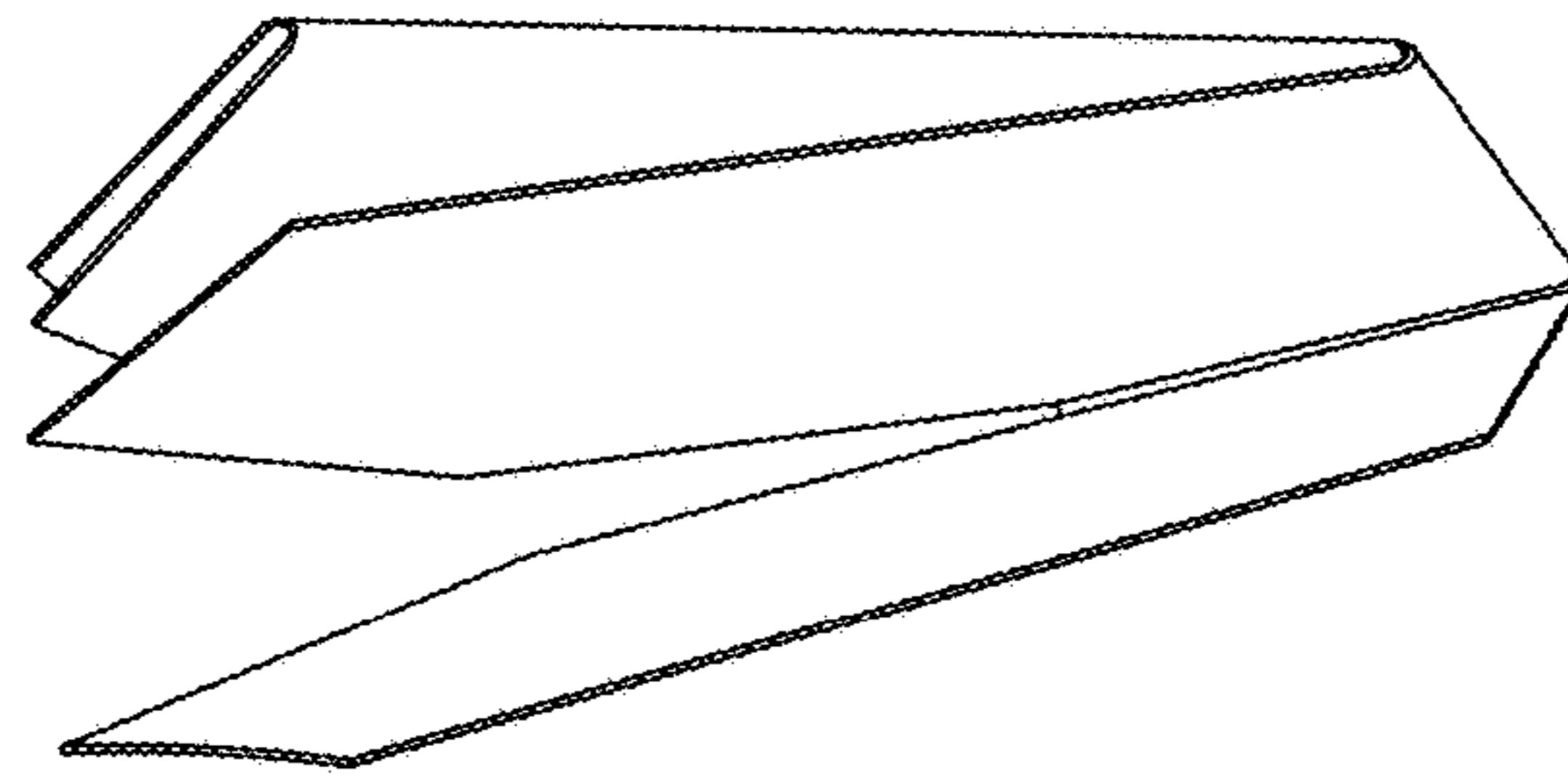

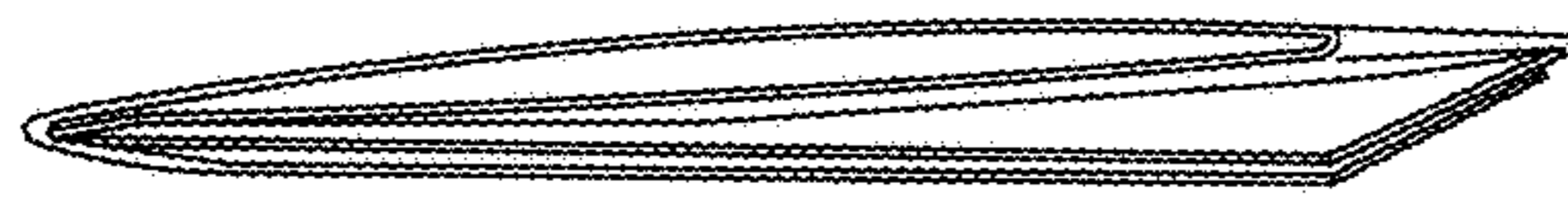

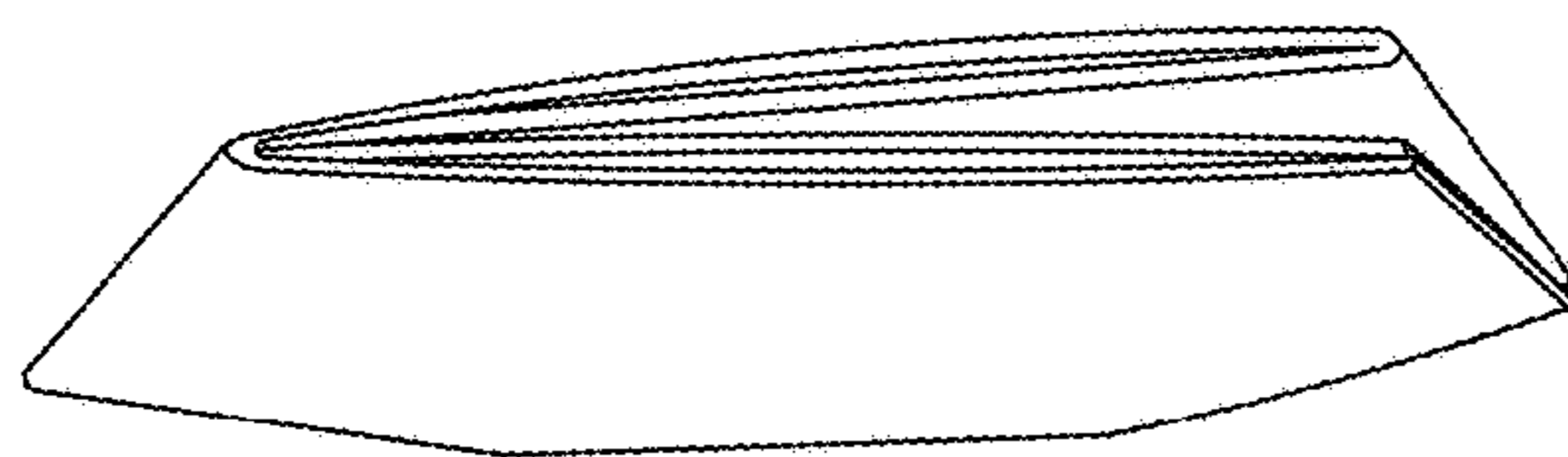

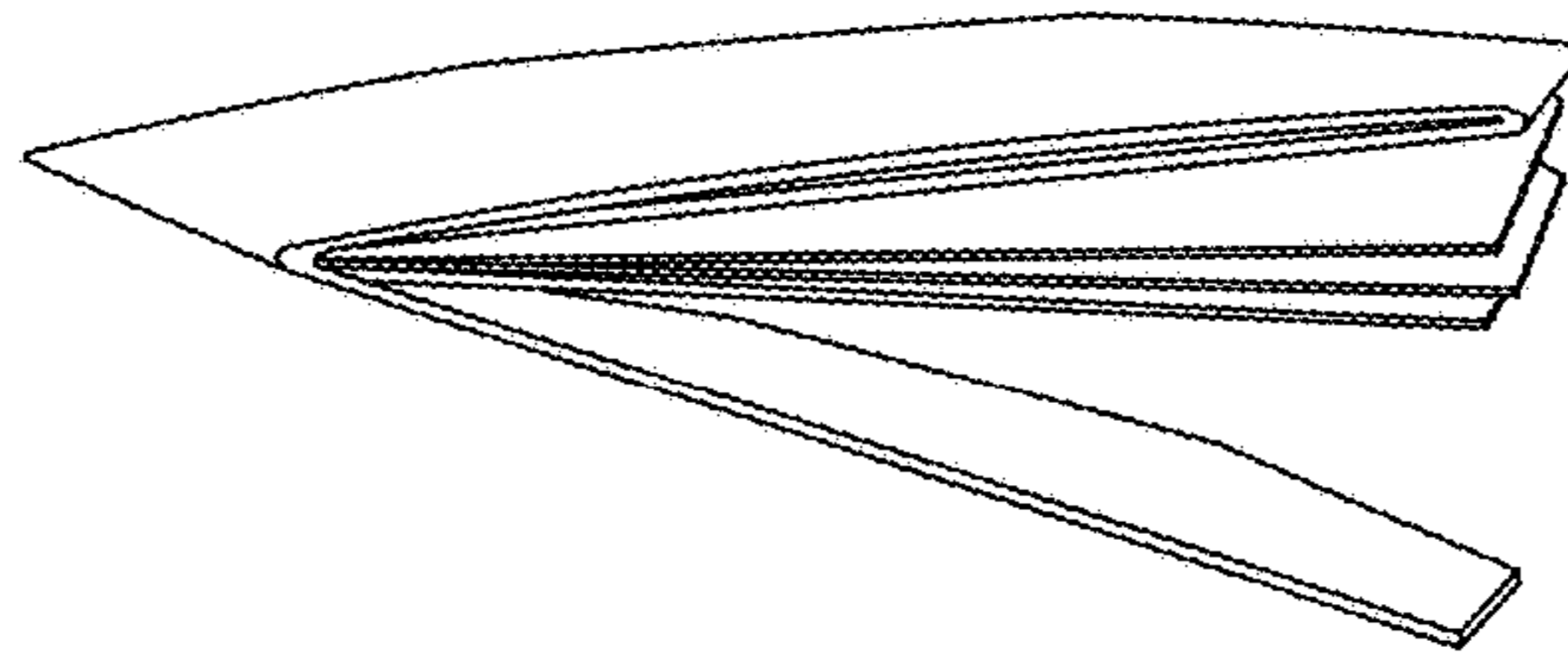

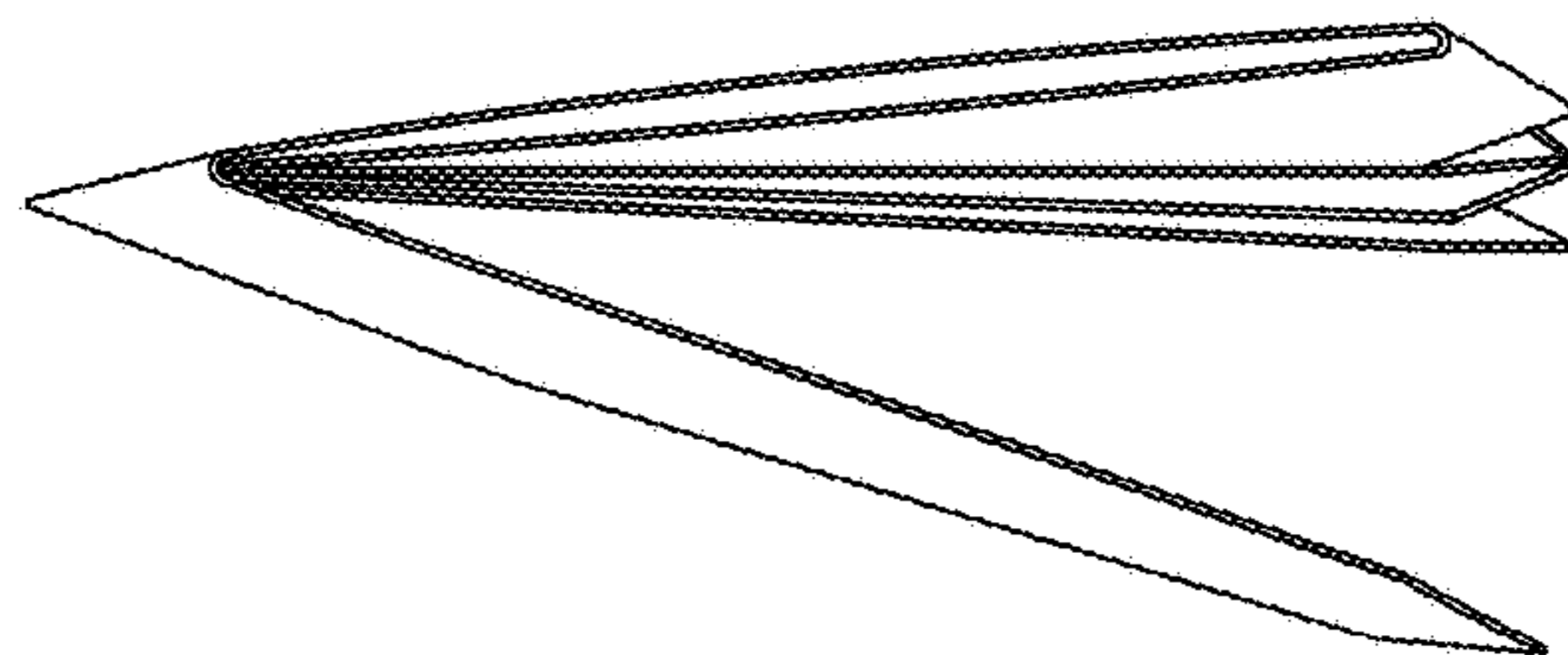

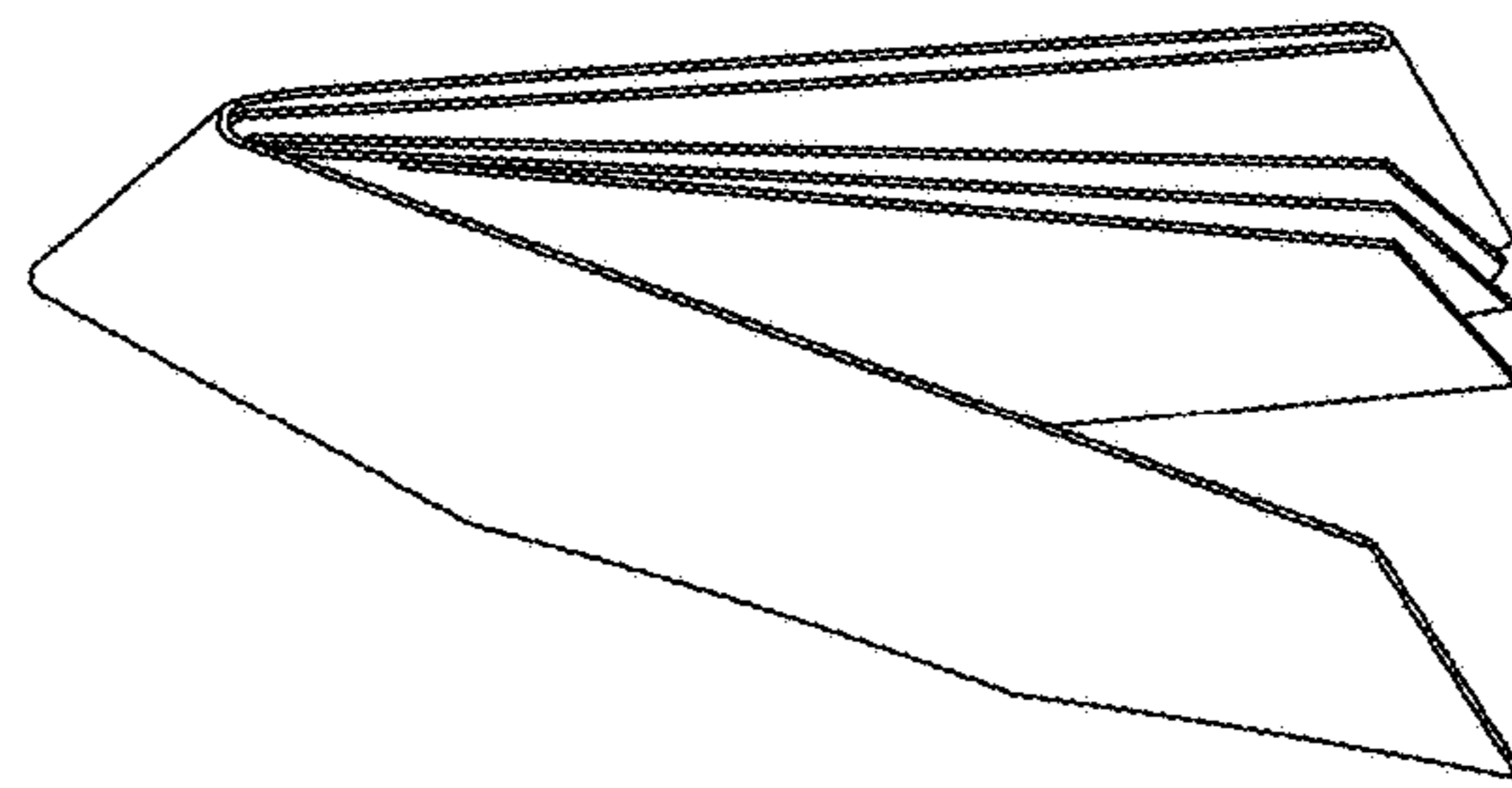

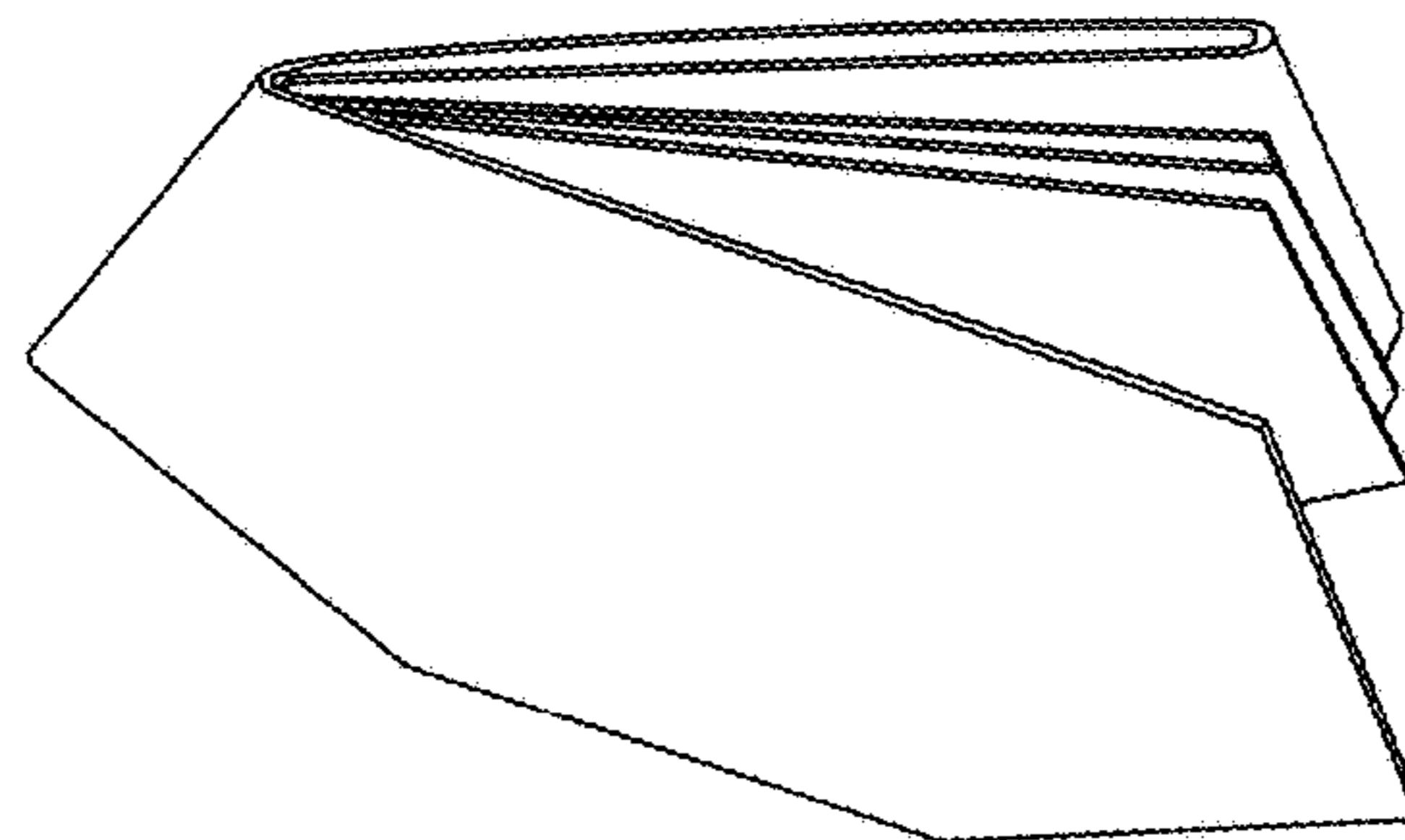

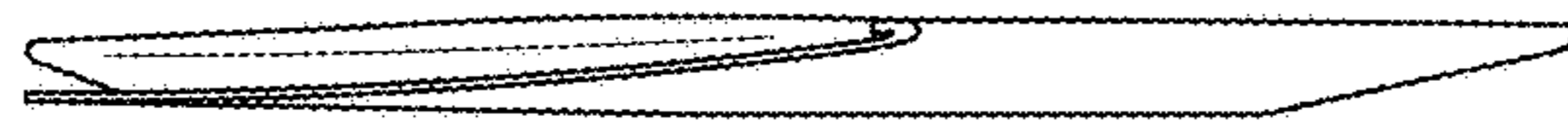

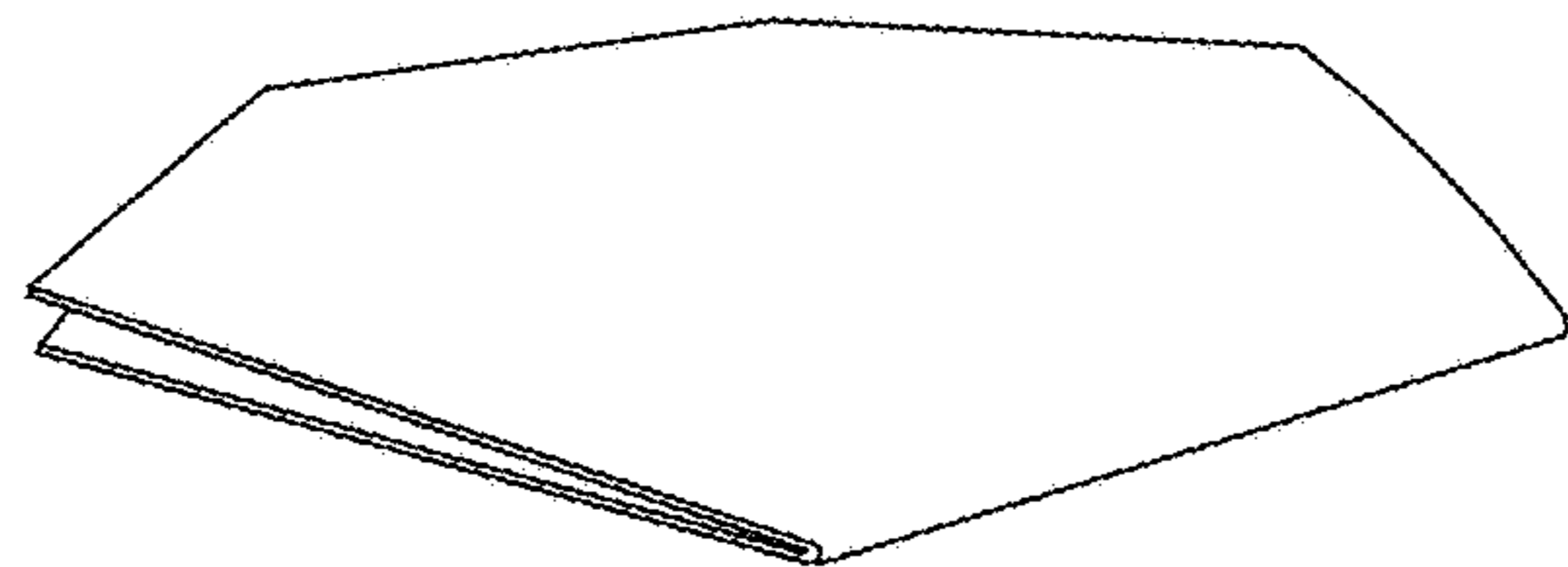

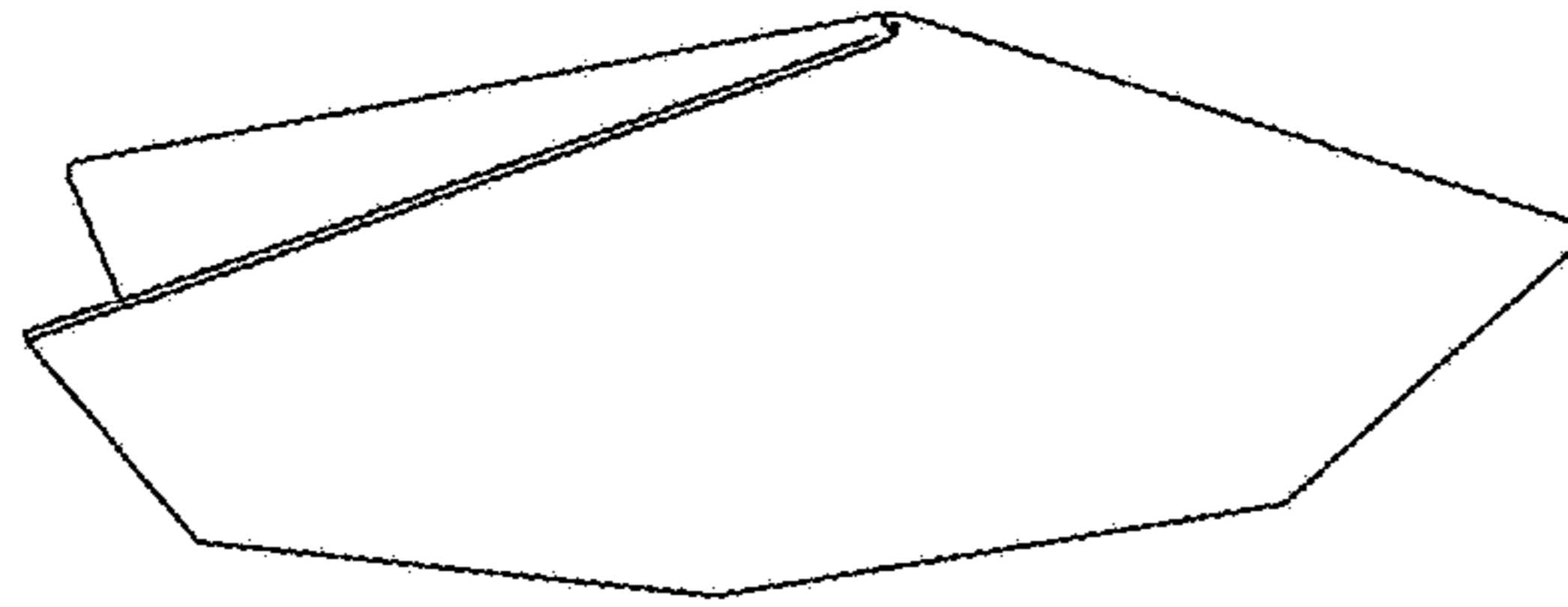

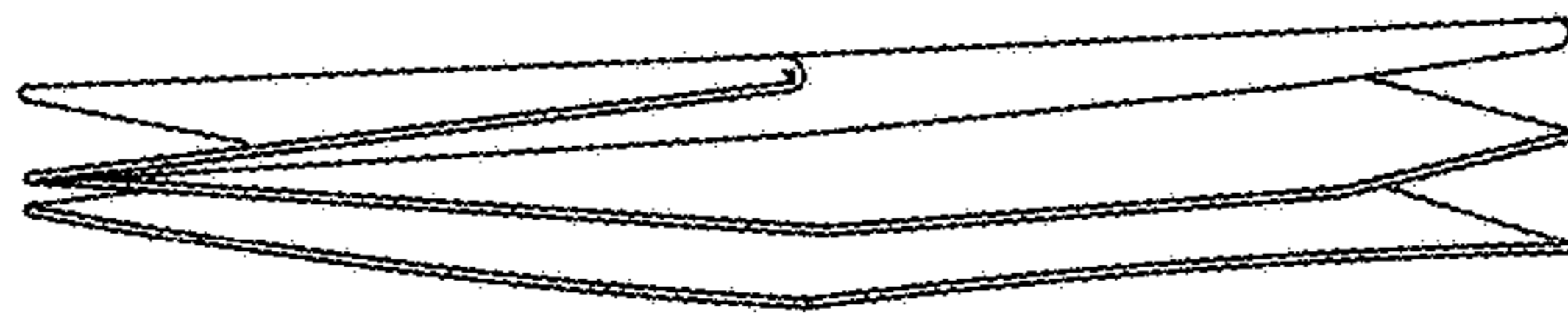

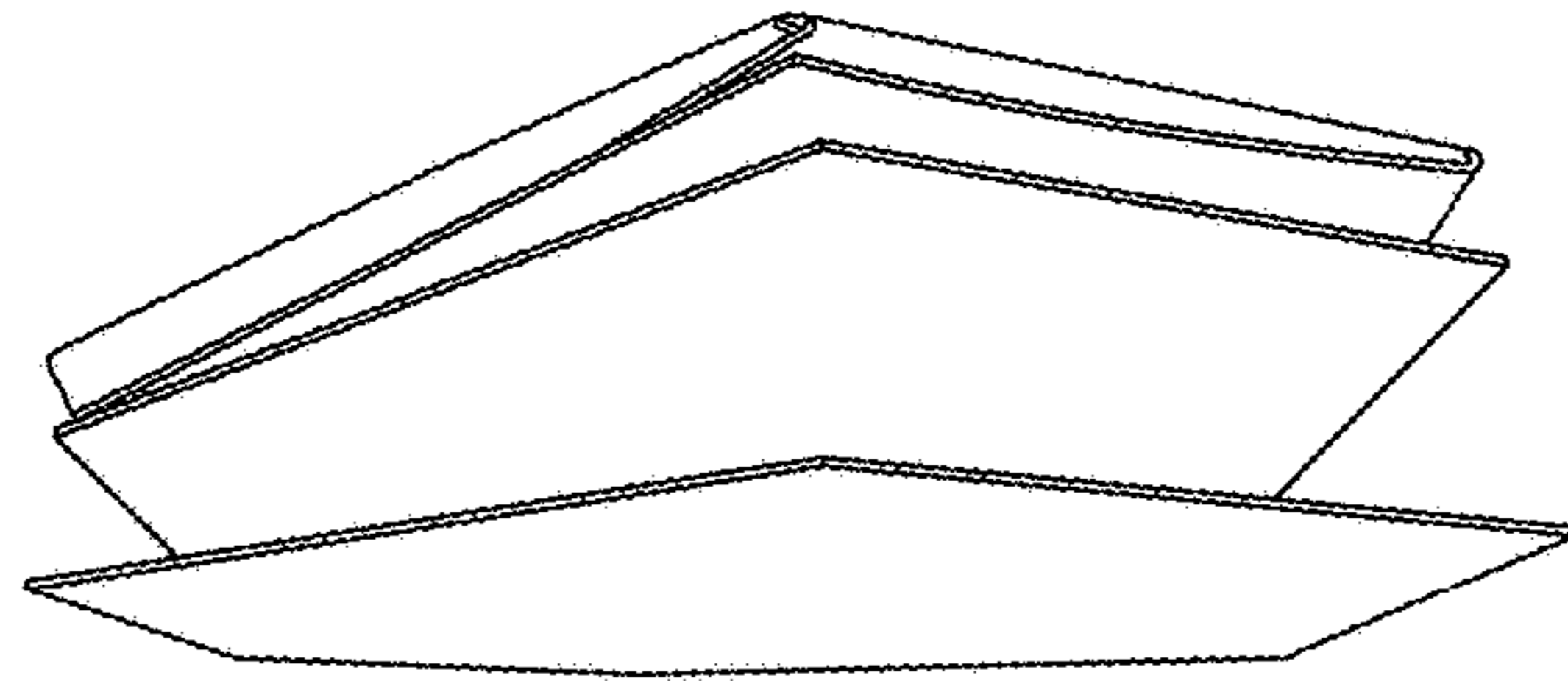

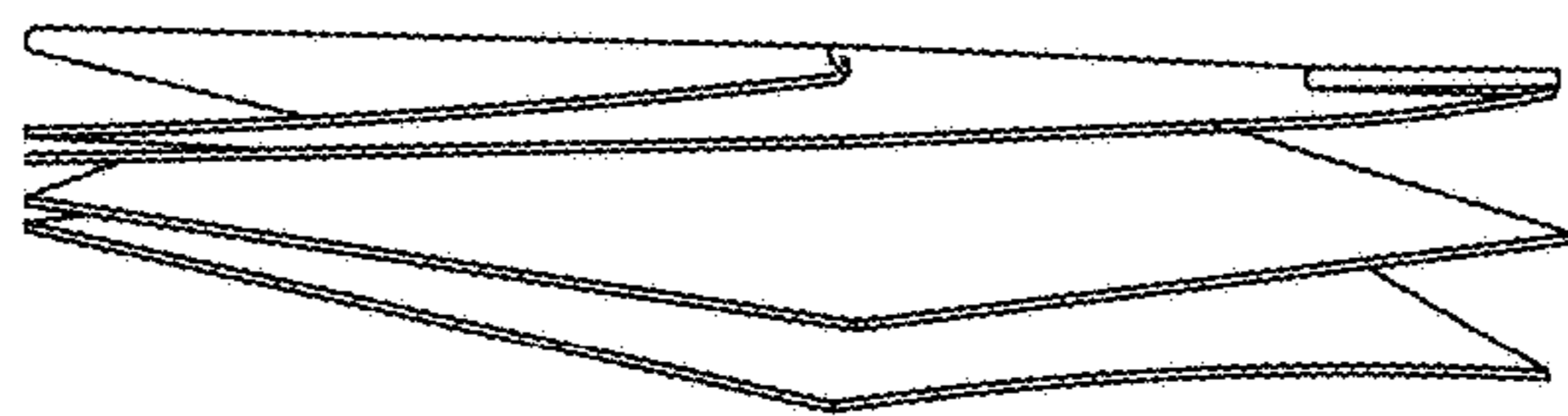

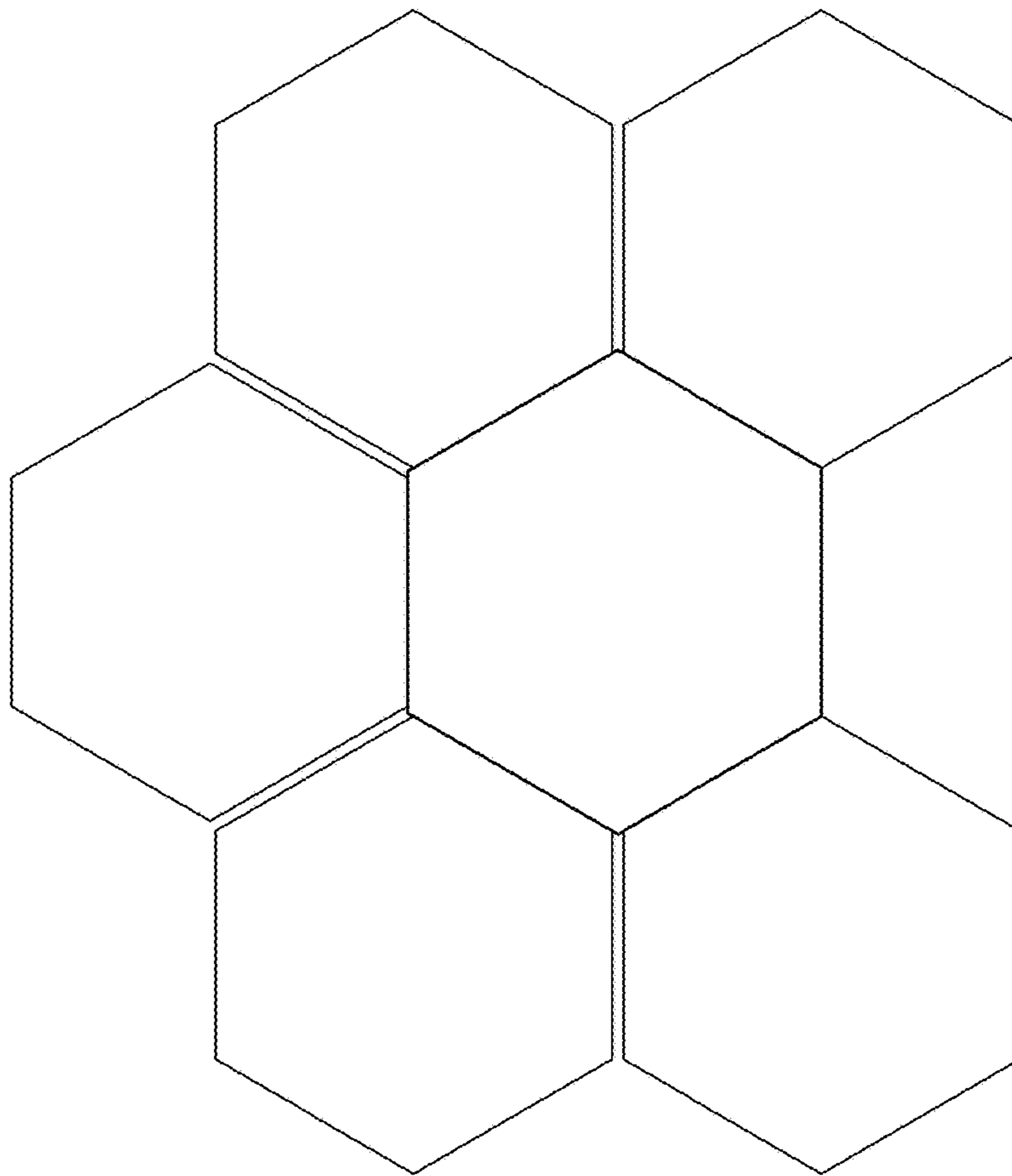

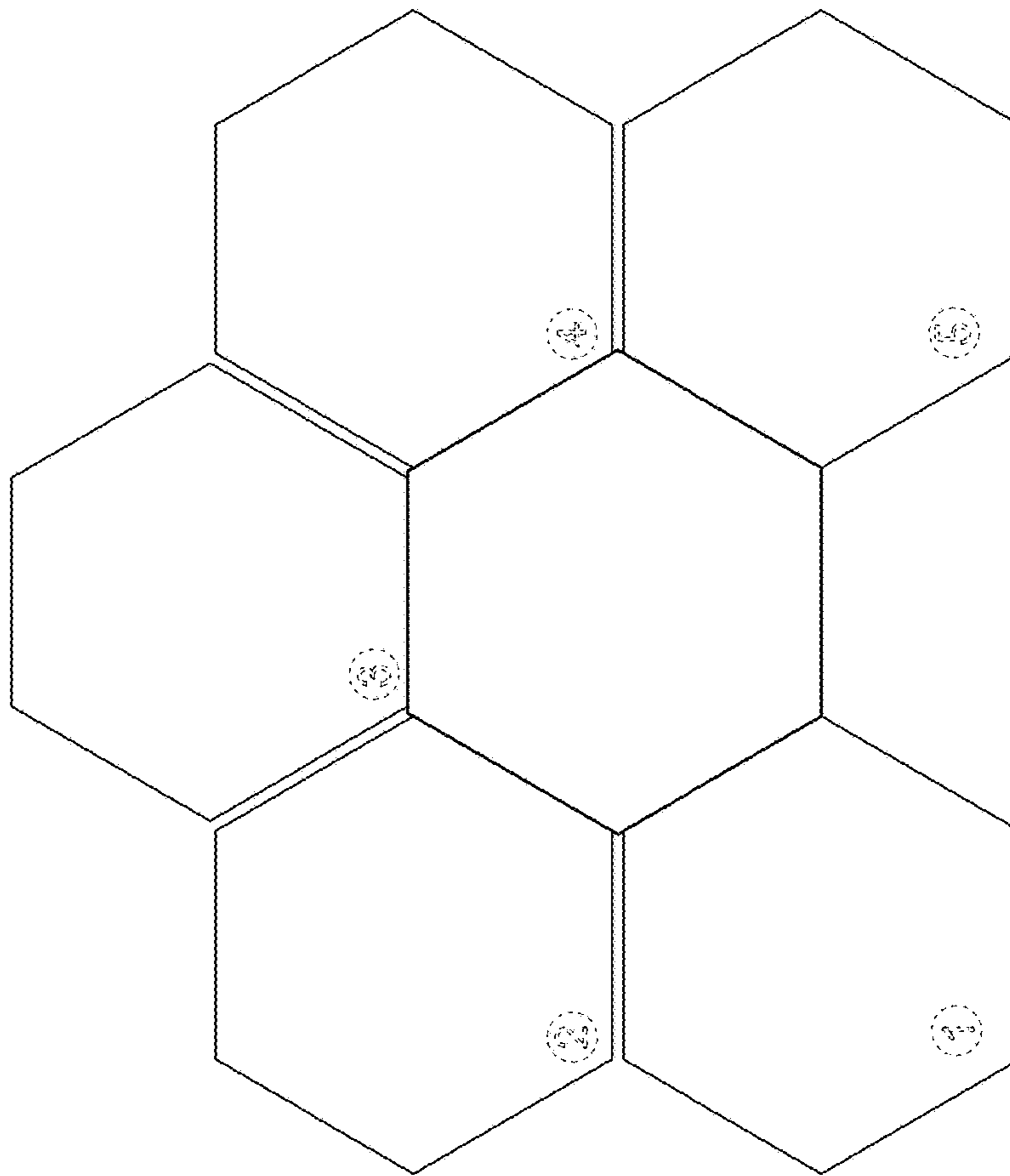

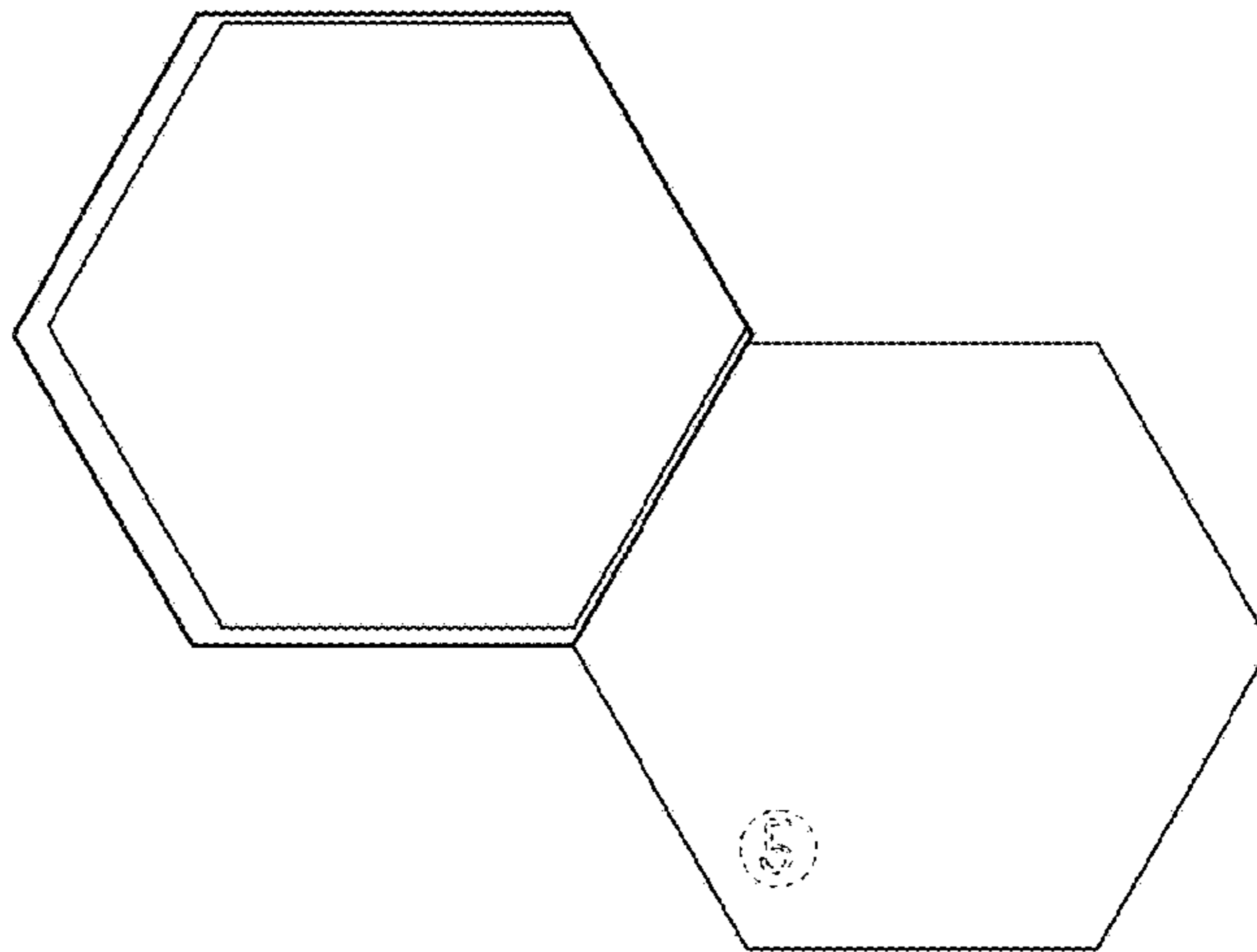

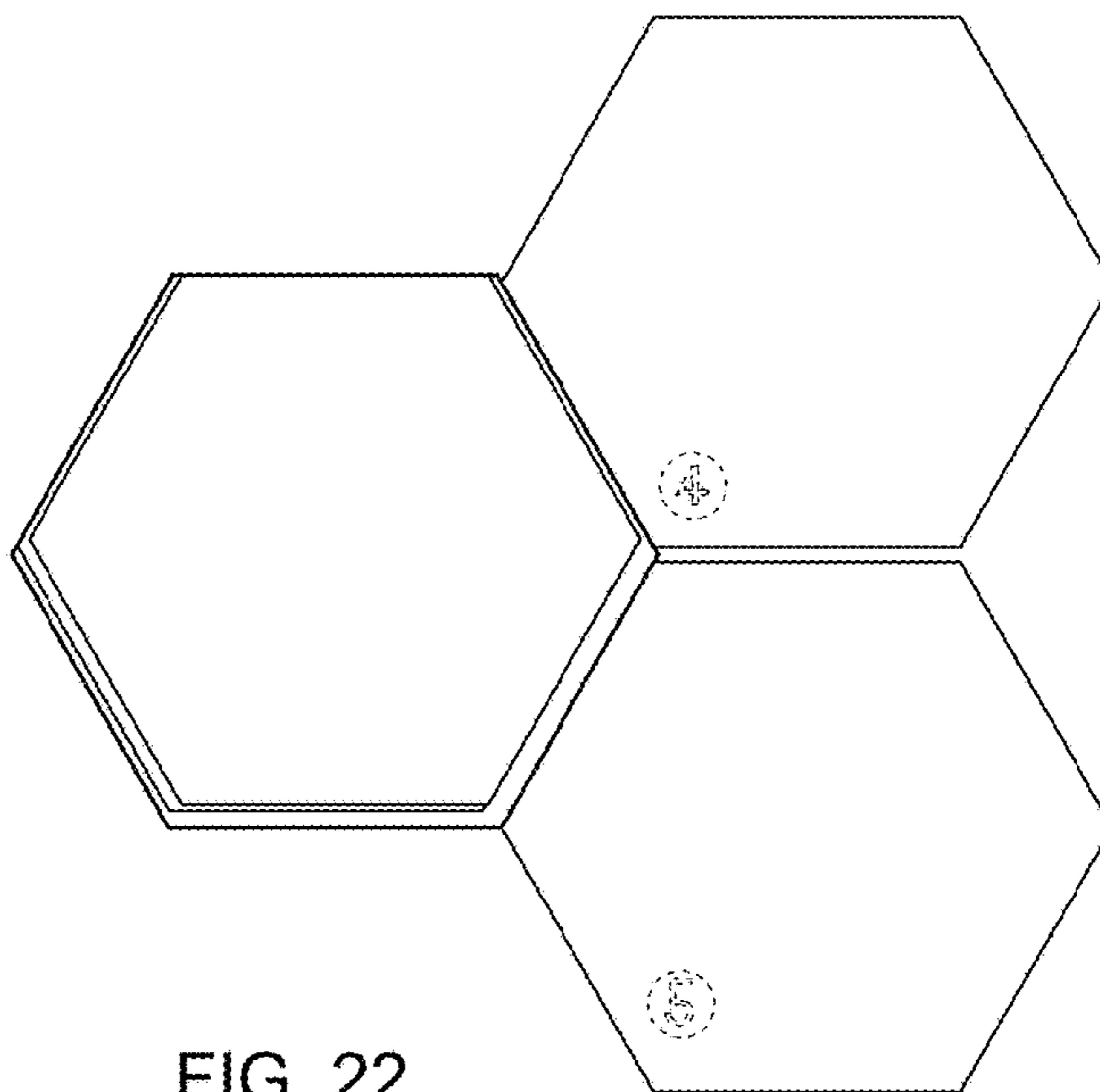

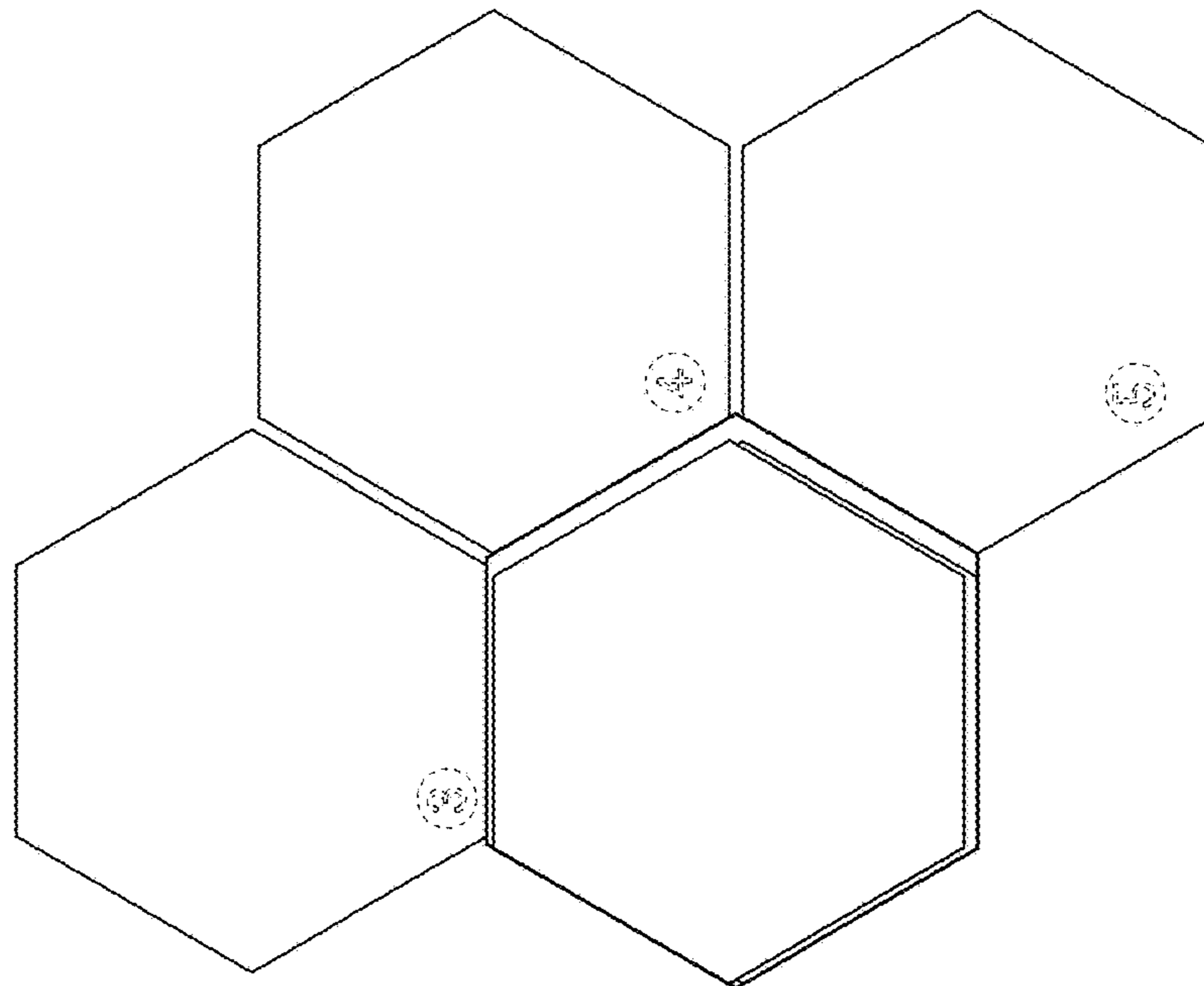

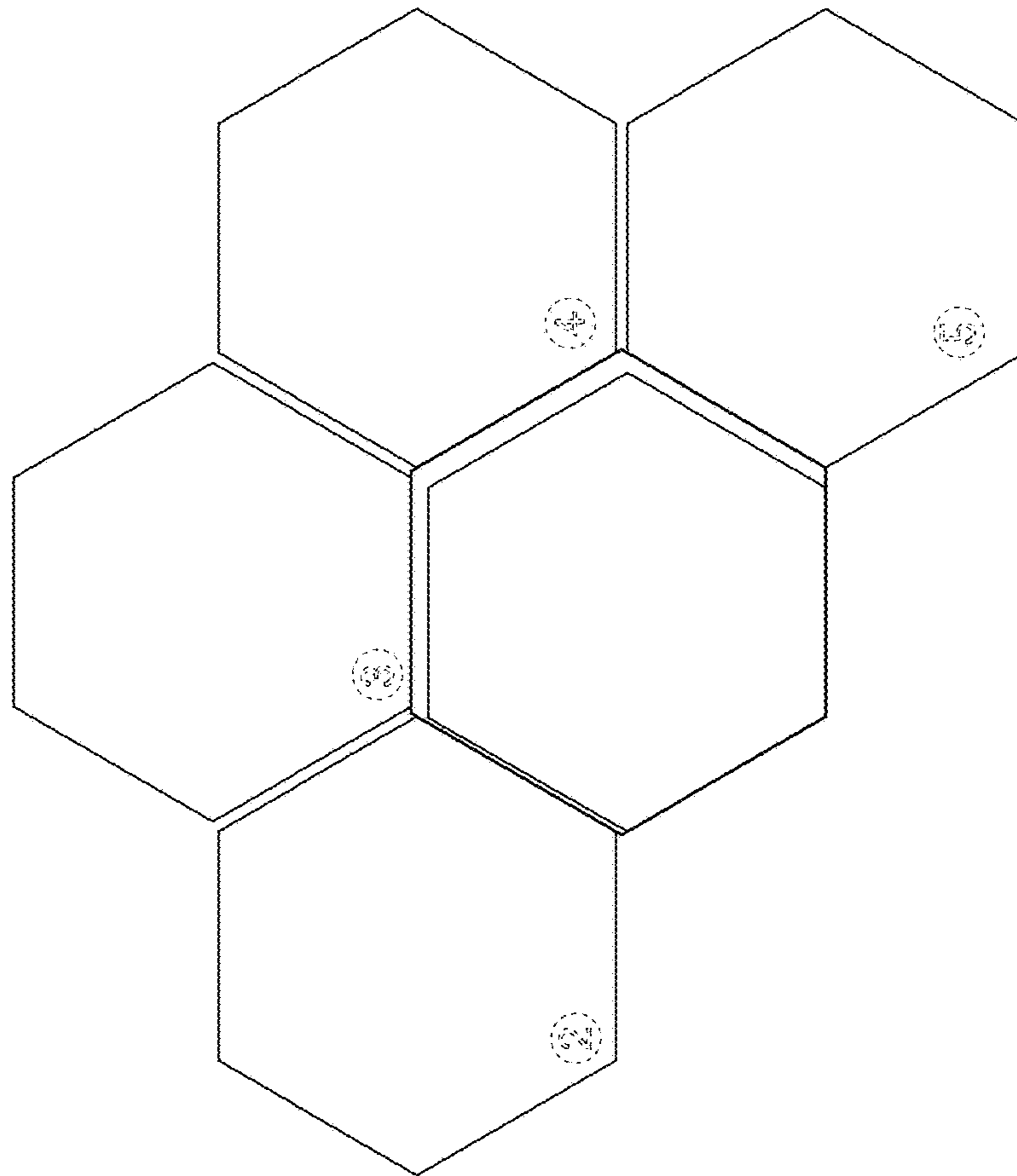

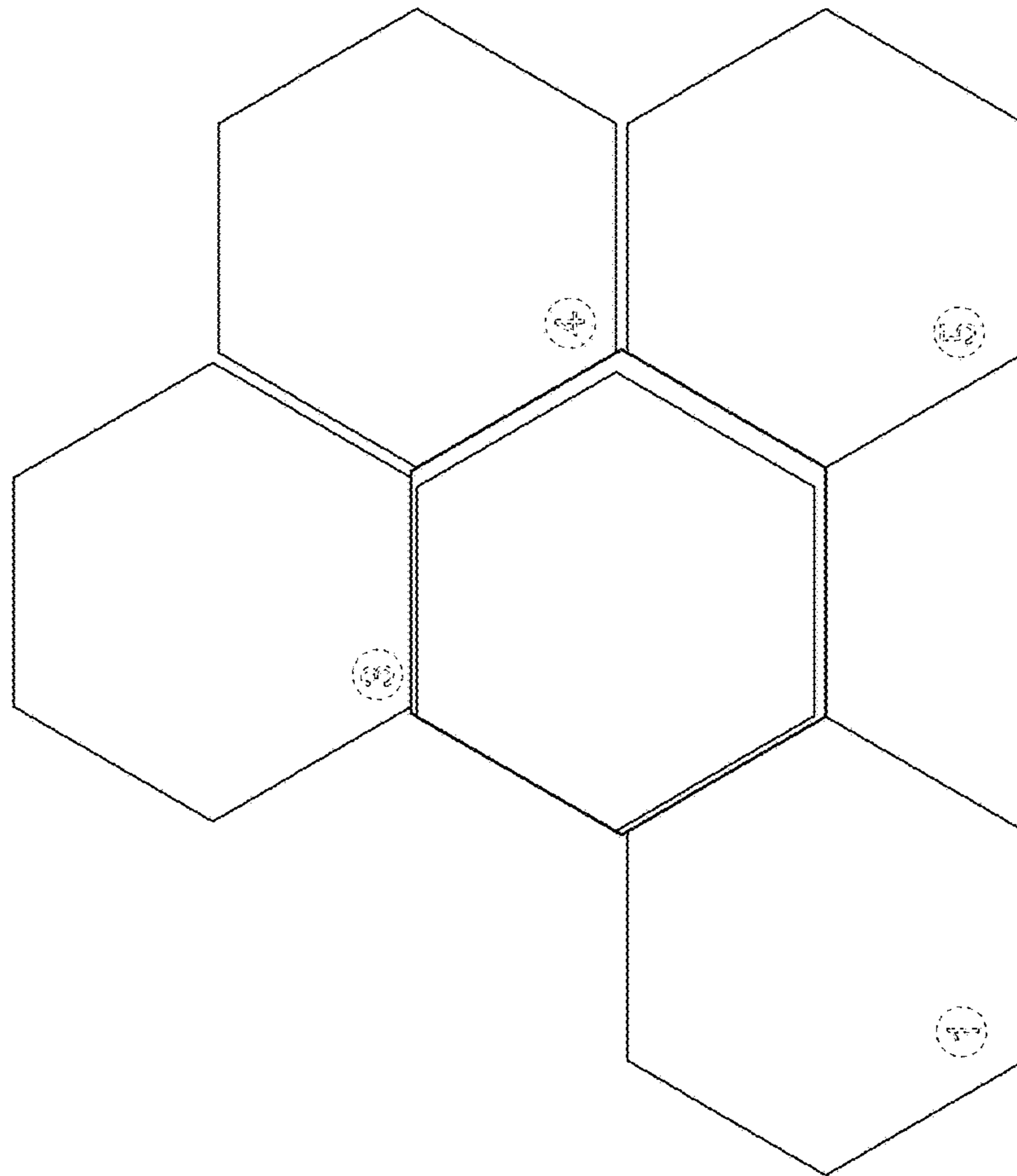

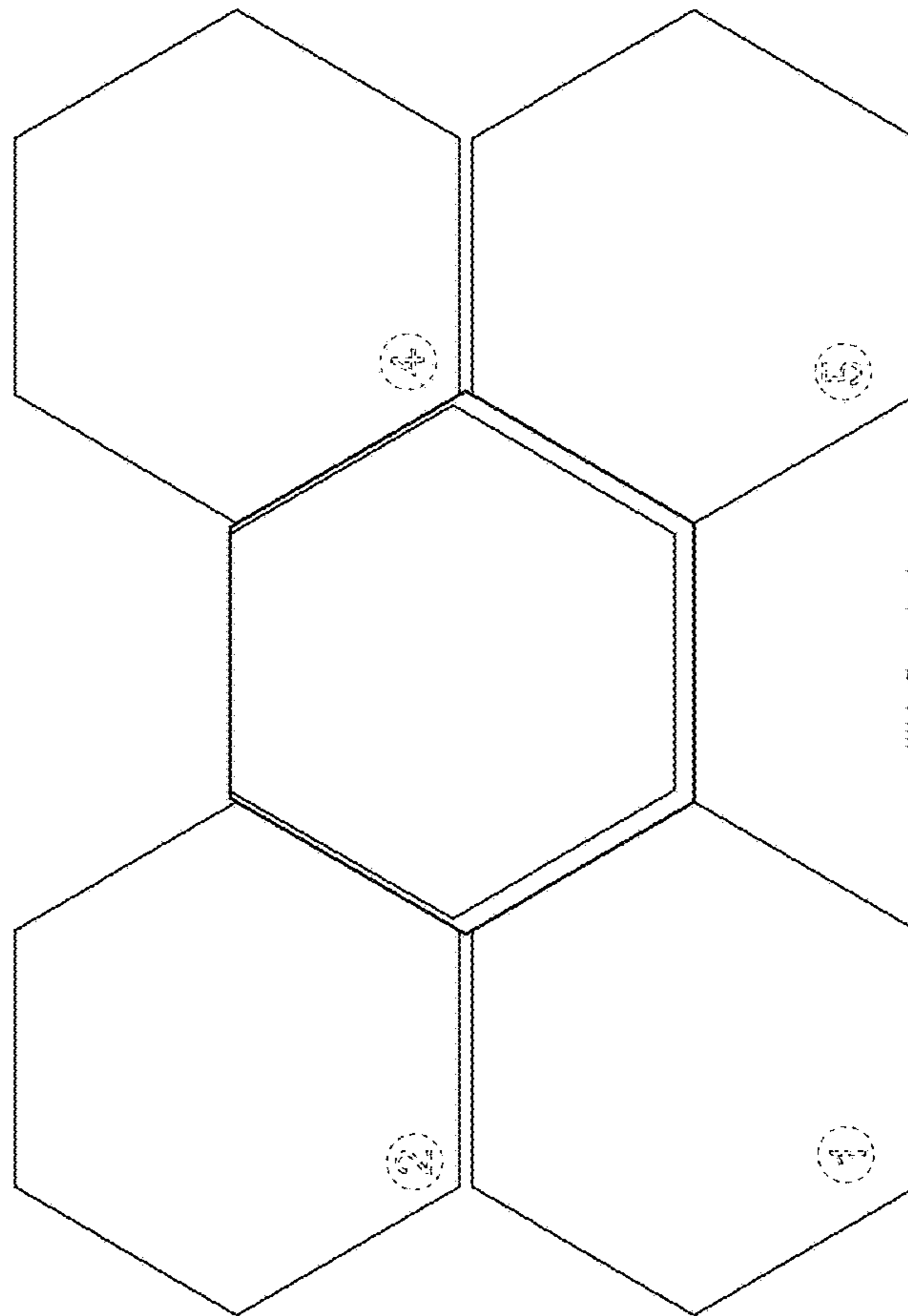

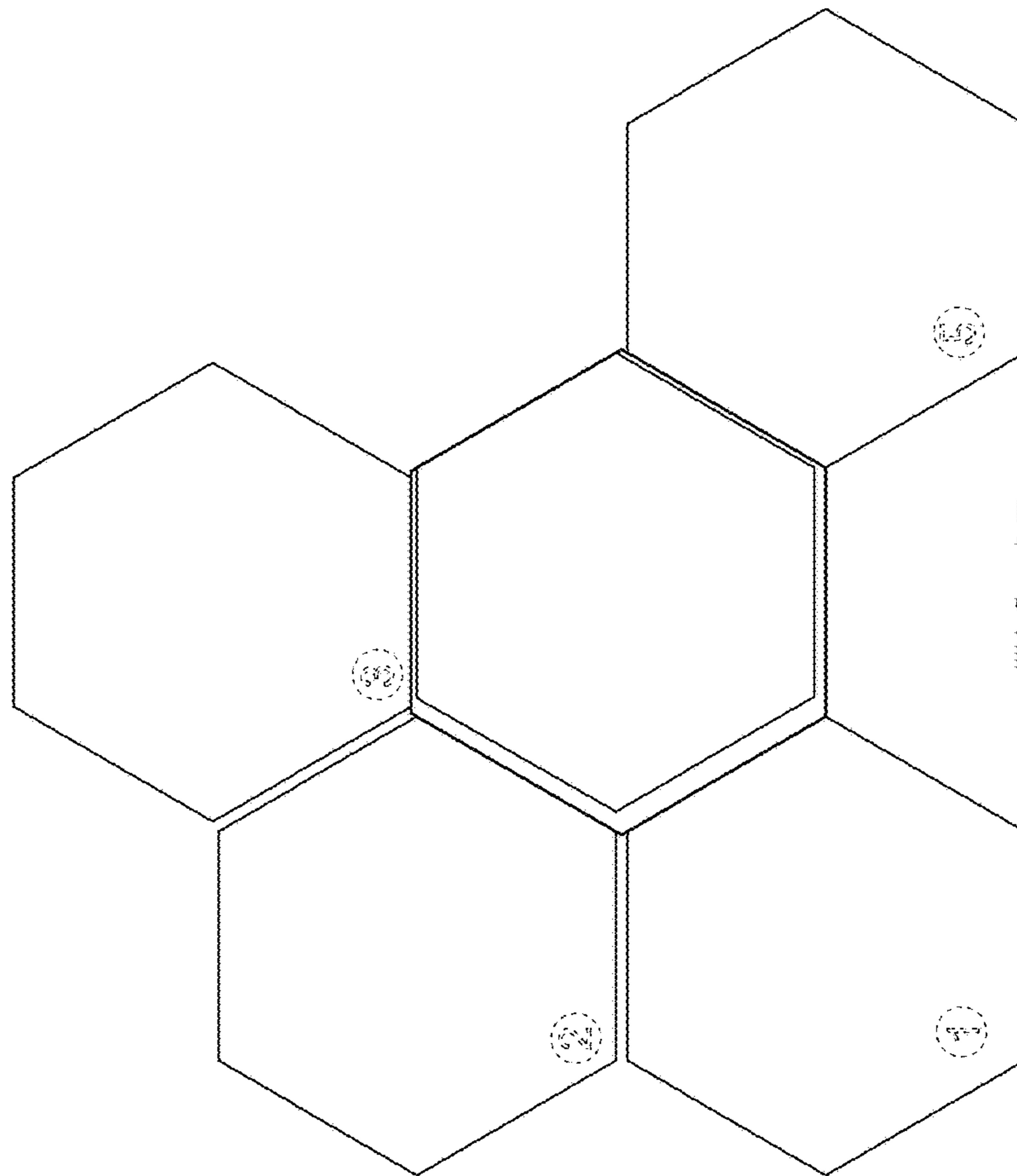

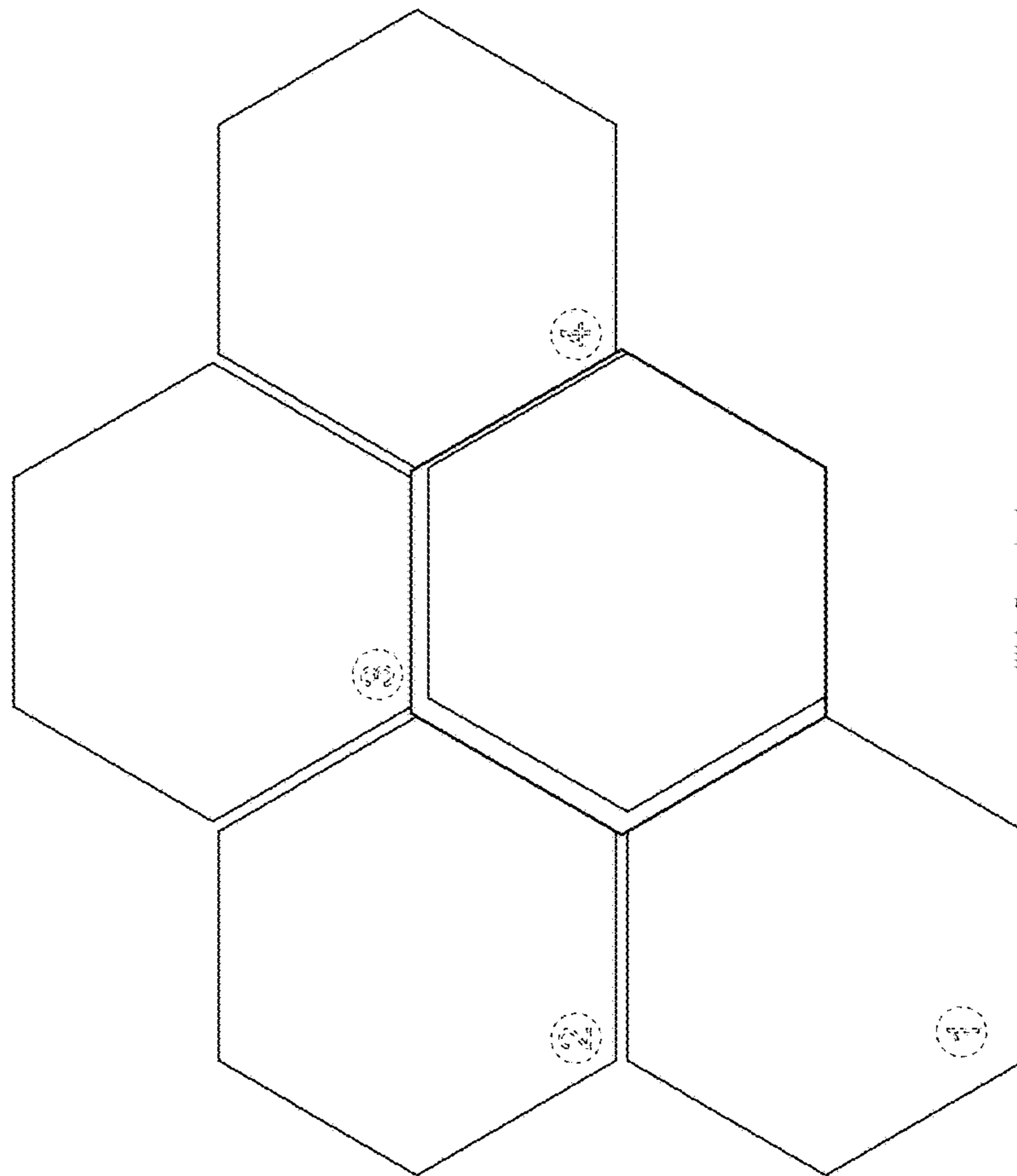

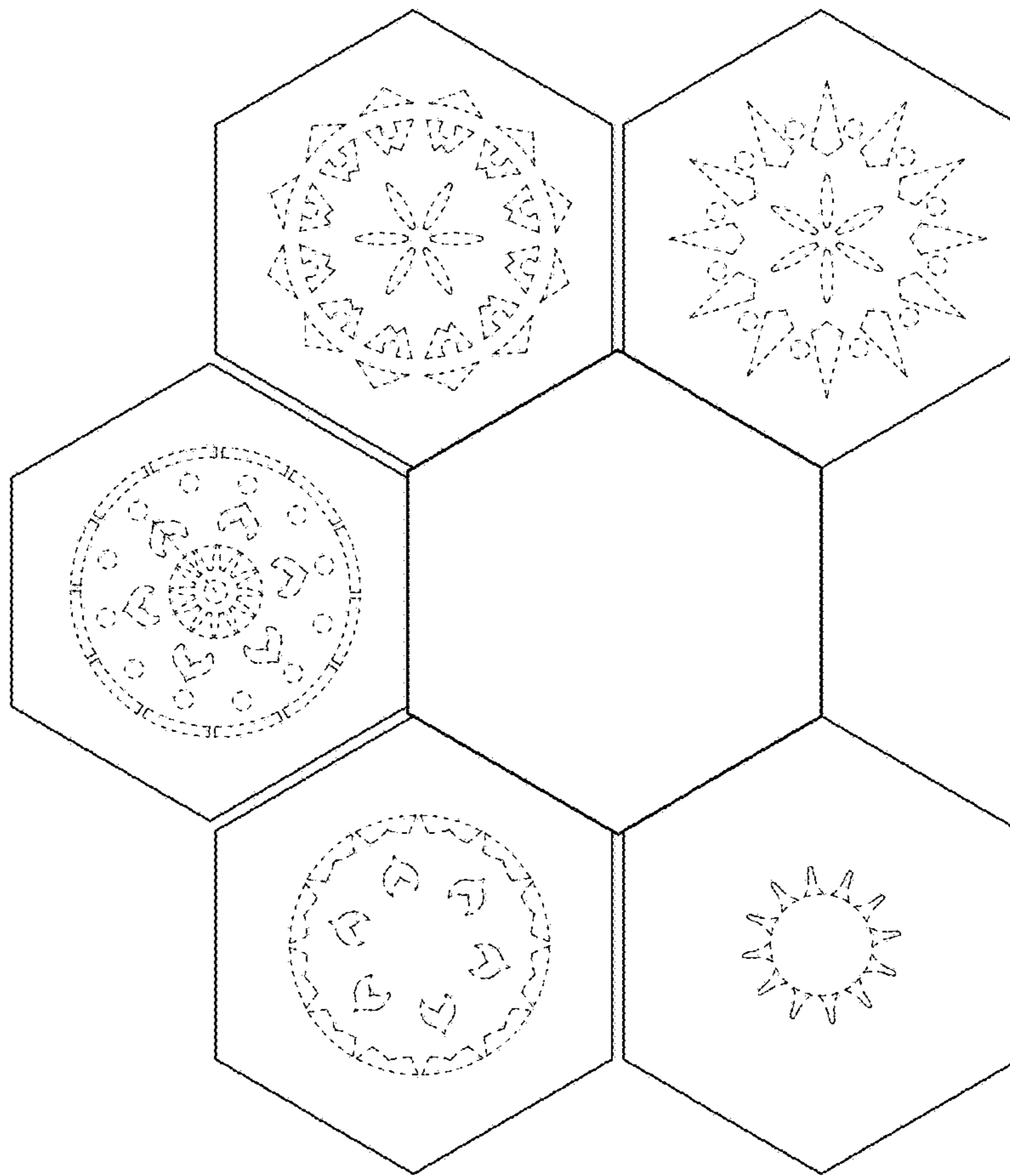

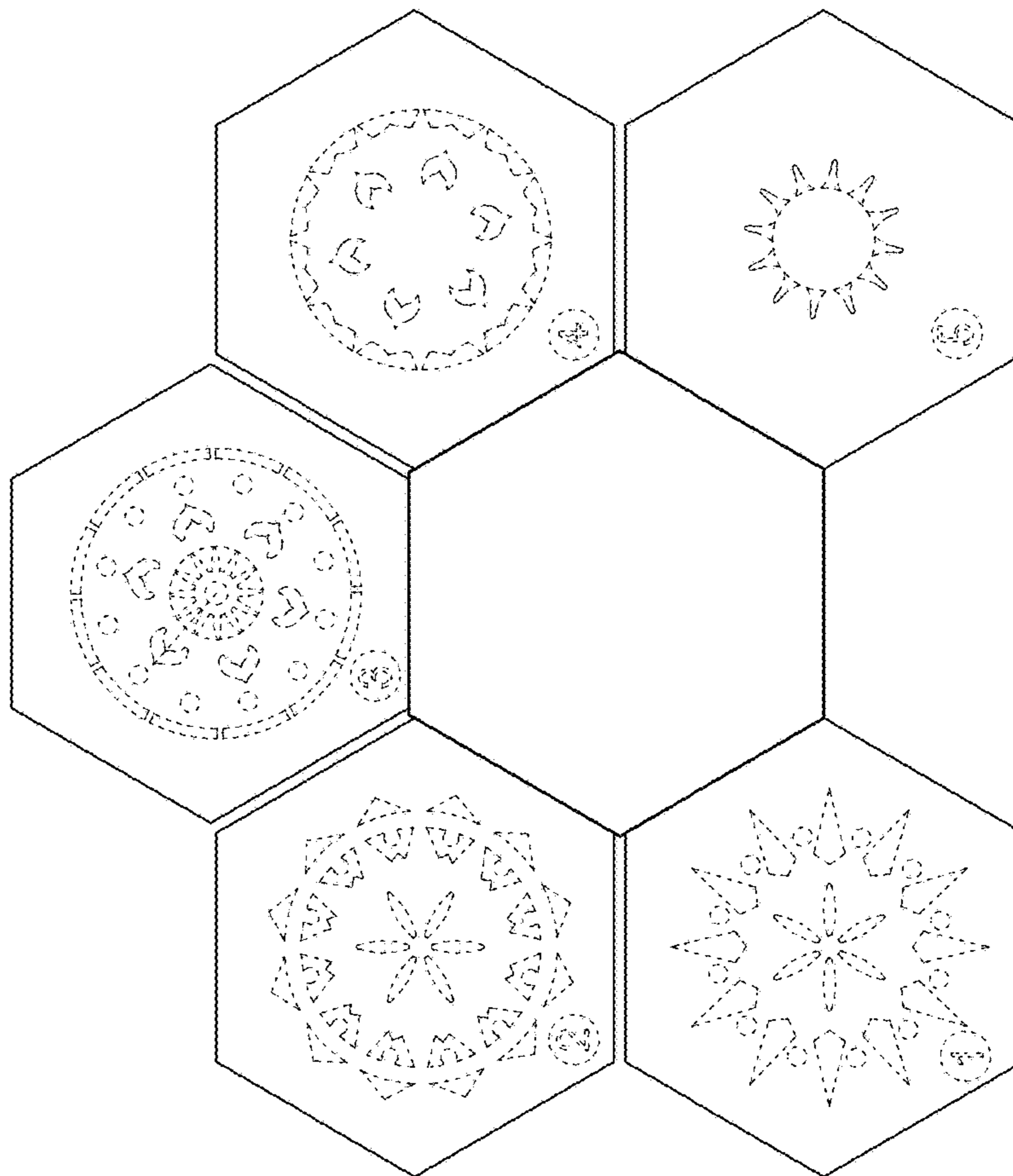

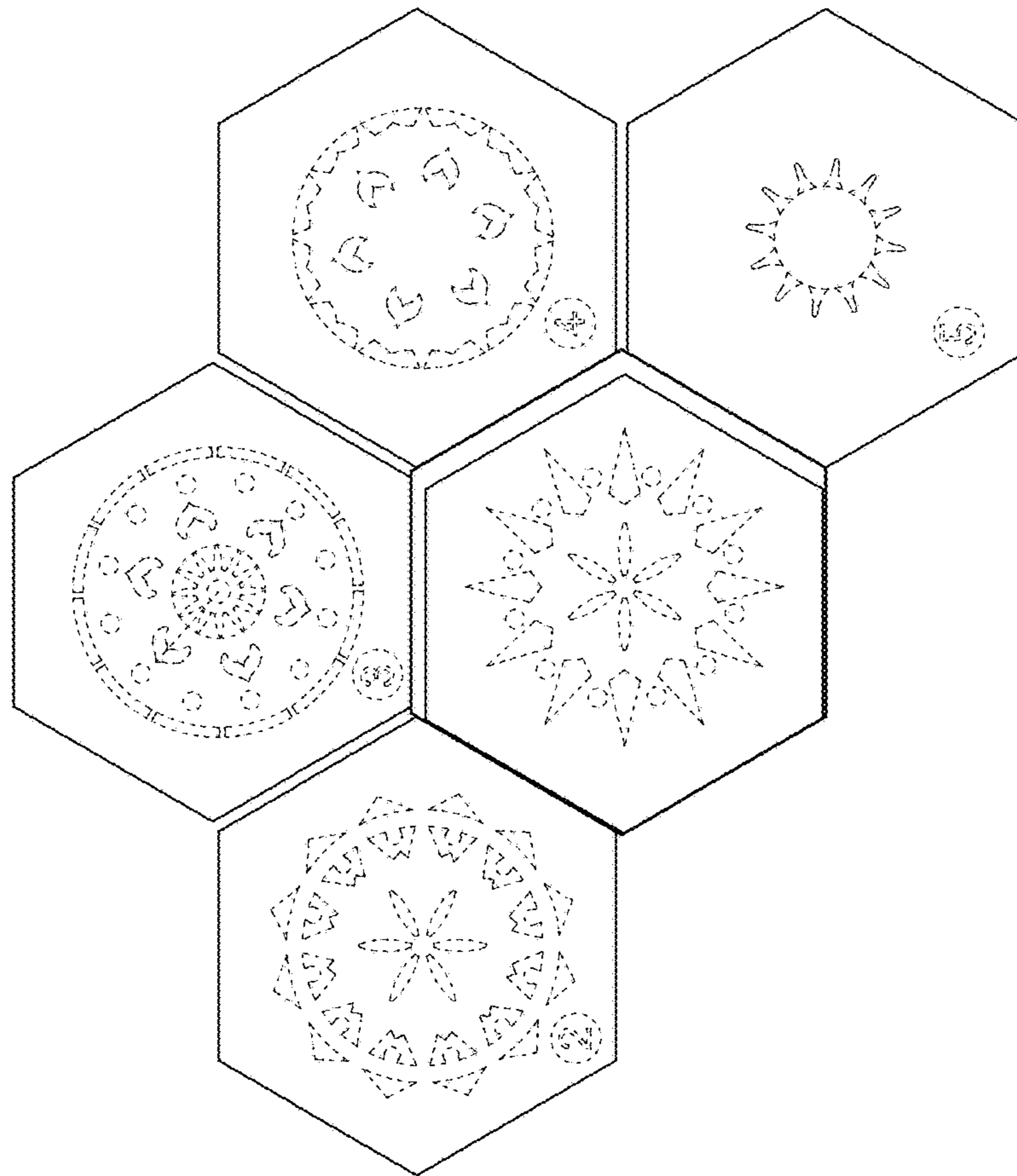

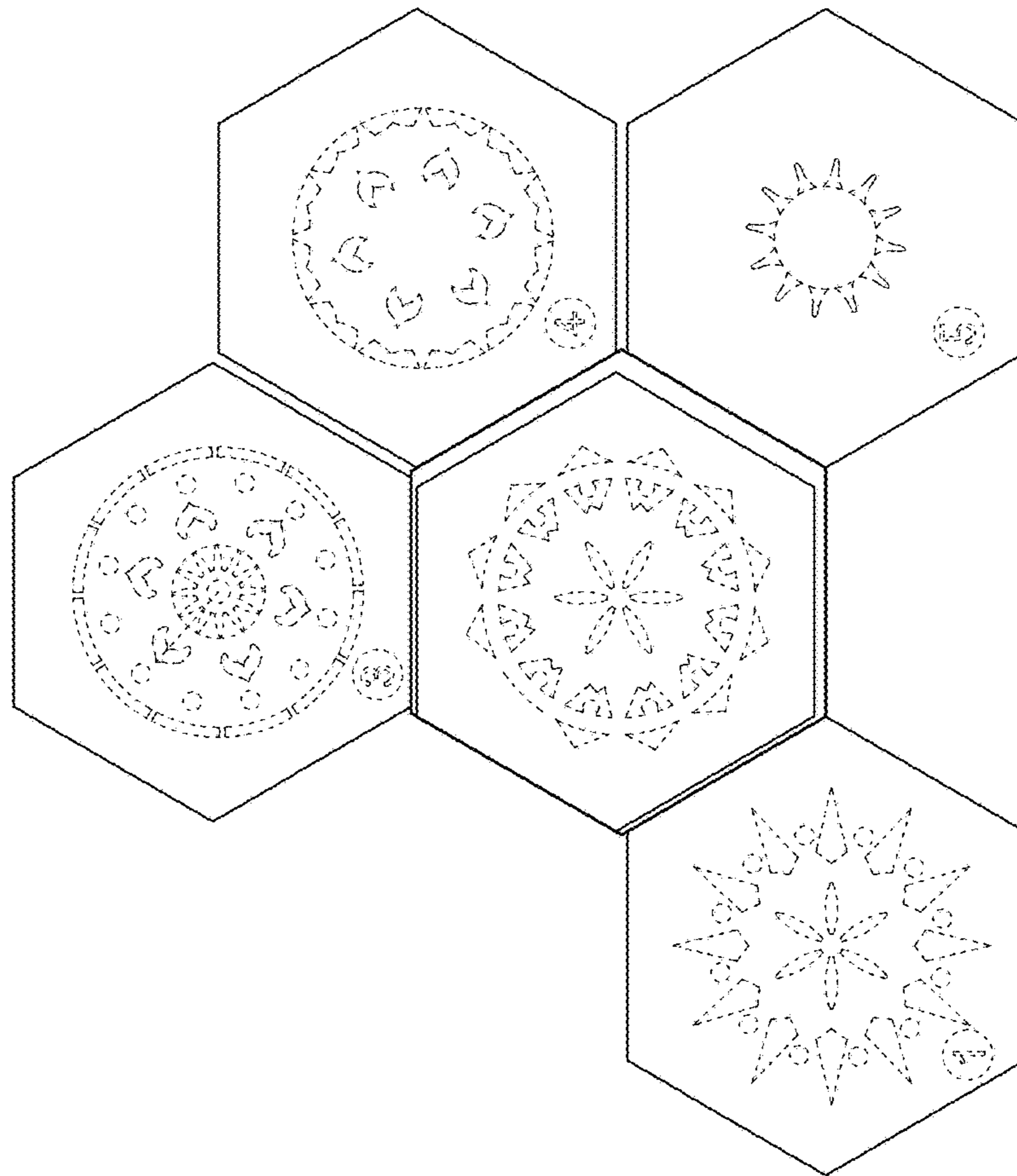

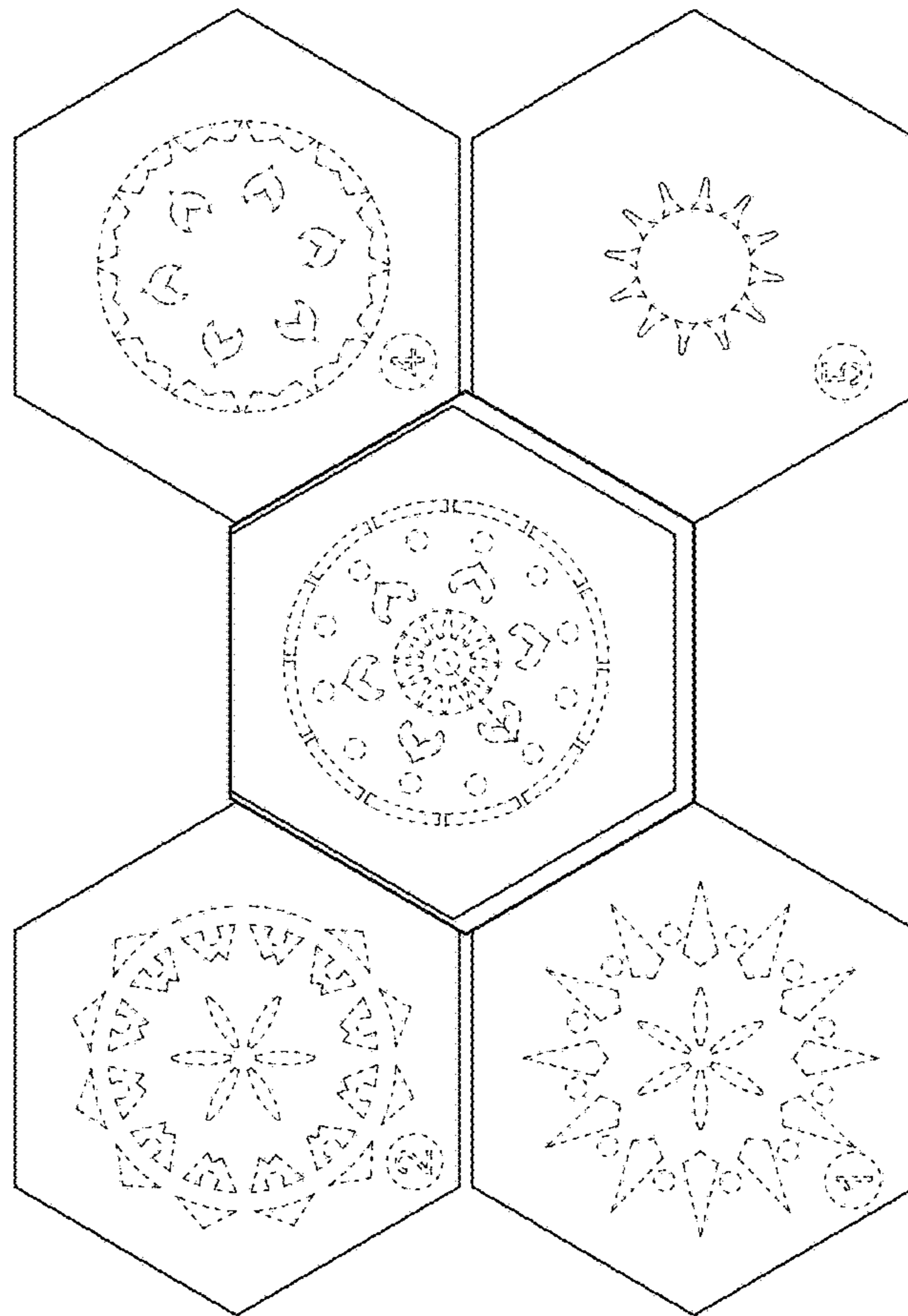

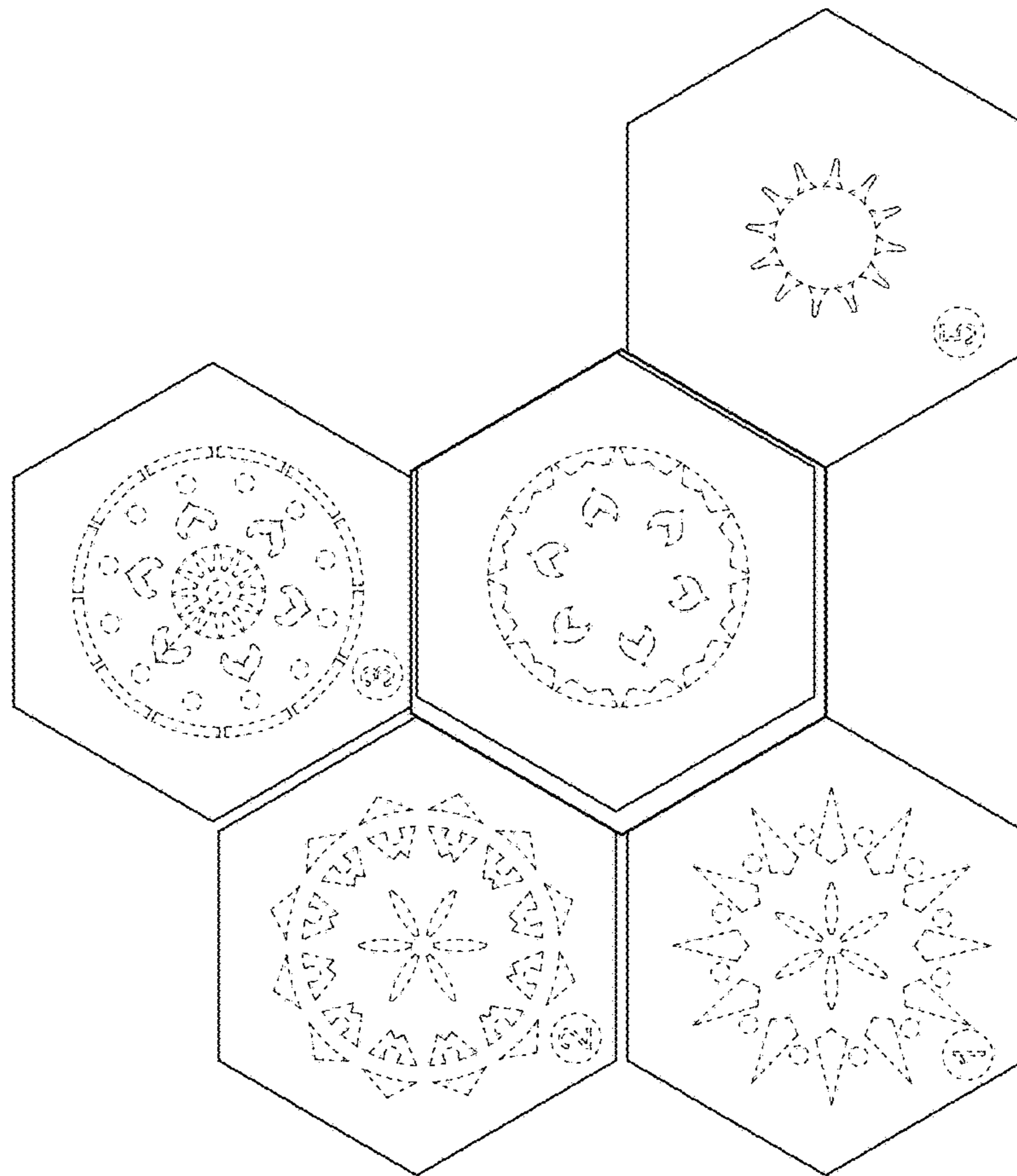

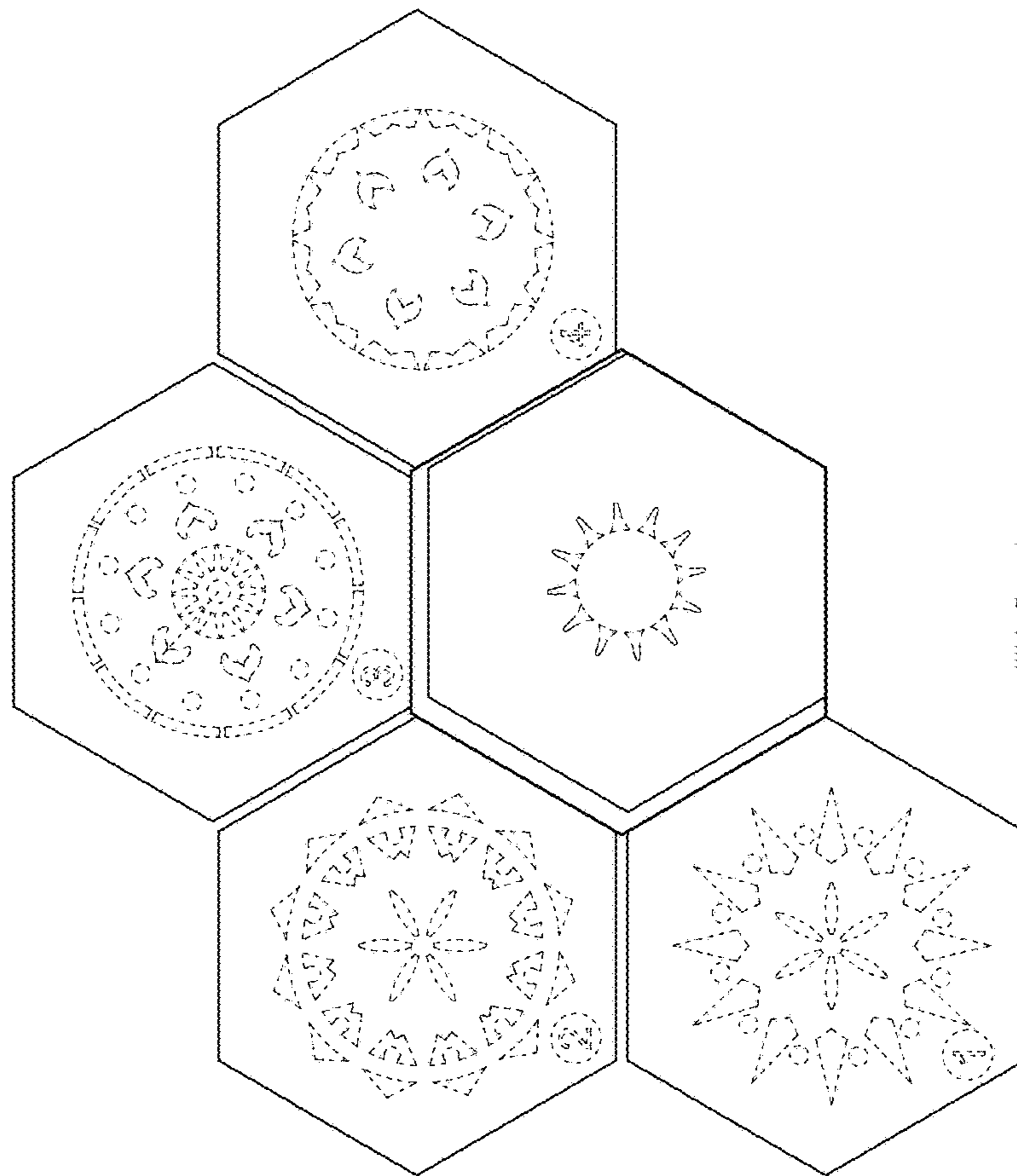
