(57) **CLAIM**

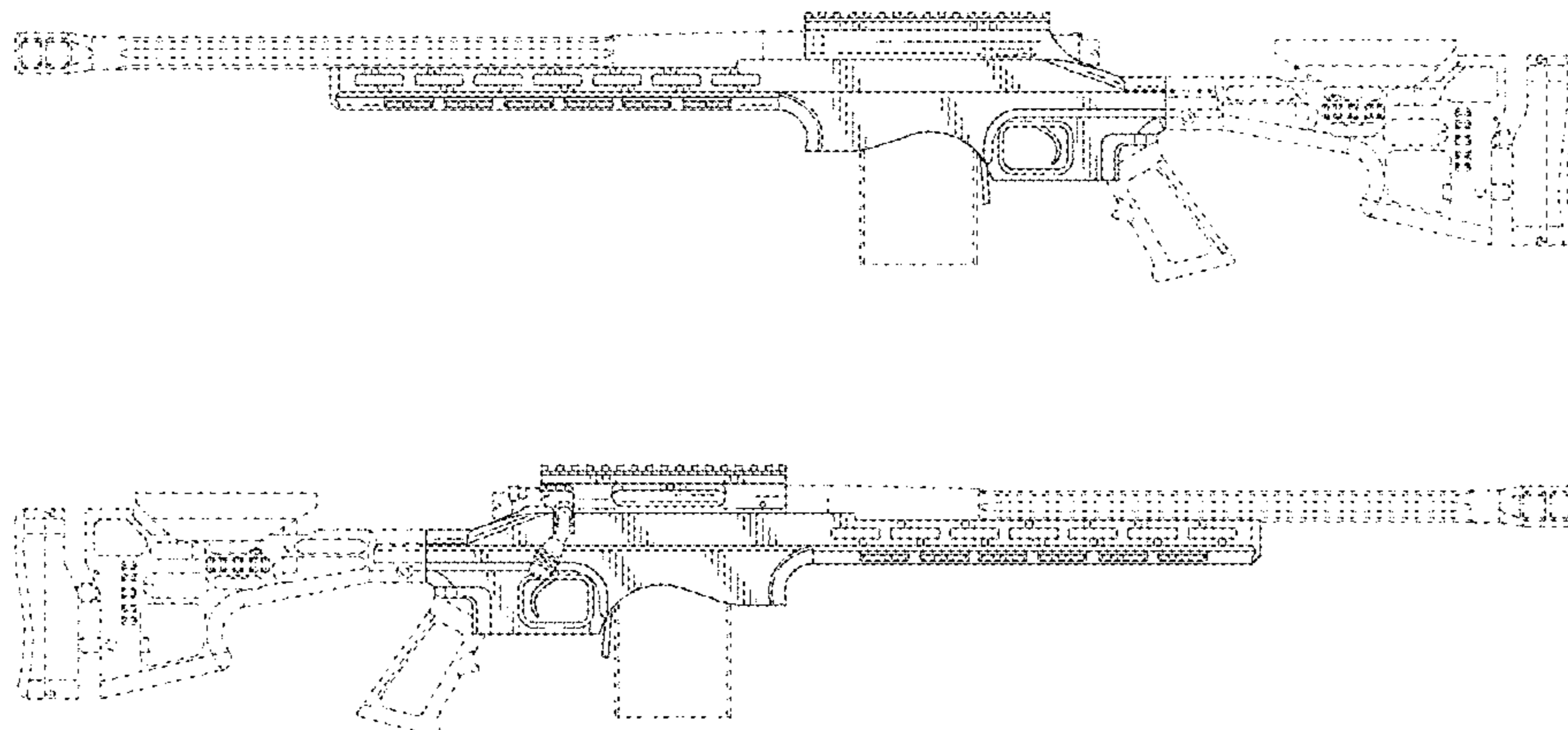
We claim the ornamental design for a rifle, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of our design for a rifle;

FIG. 4 is a bottom view of the design for the rifle shown in FIG. 1;

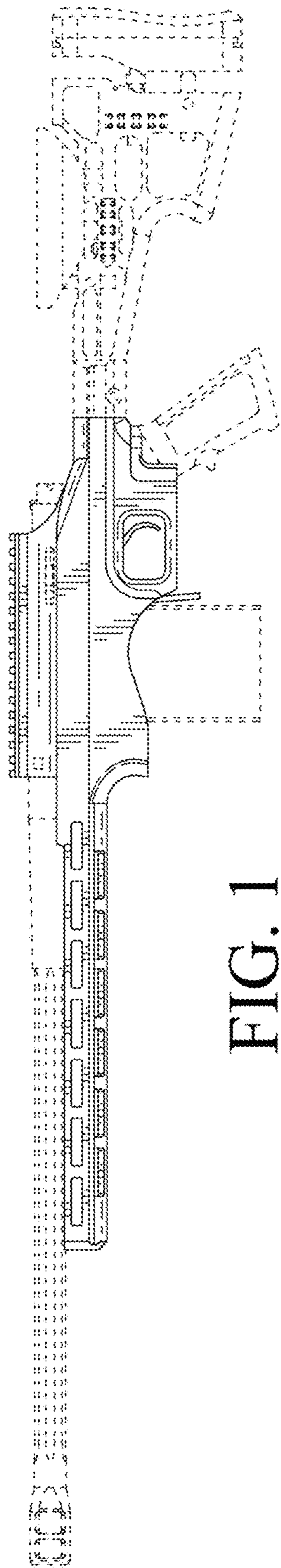

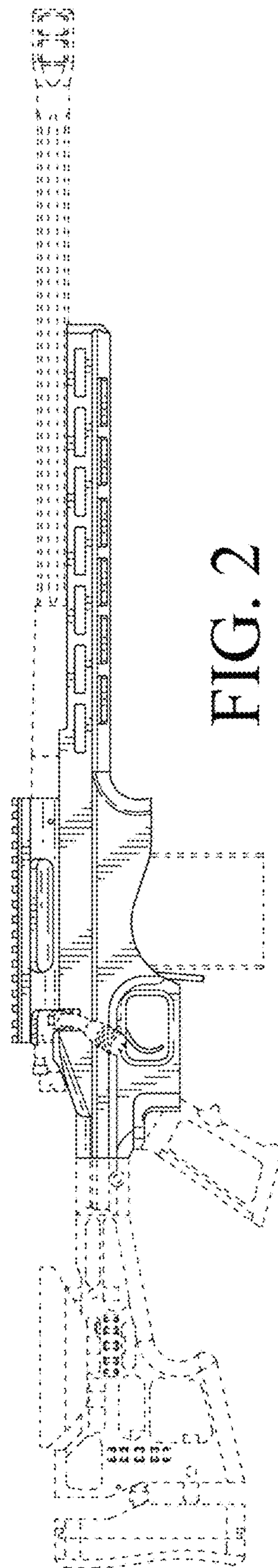

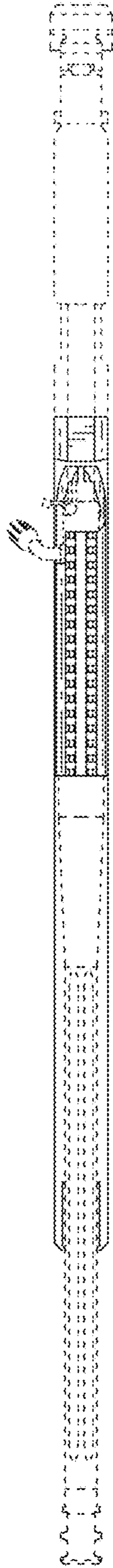

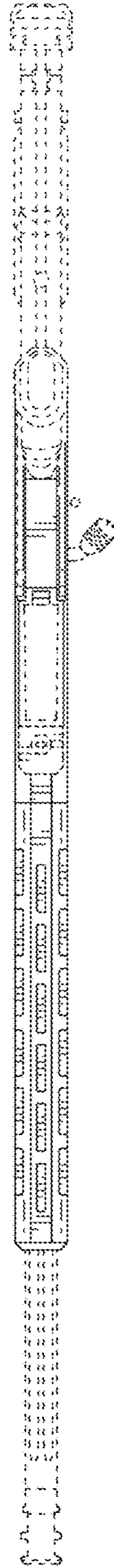

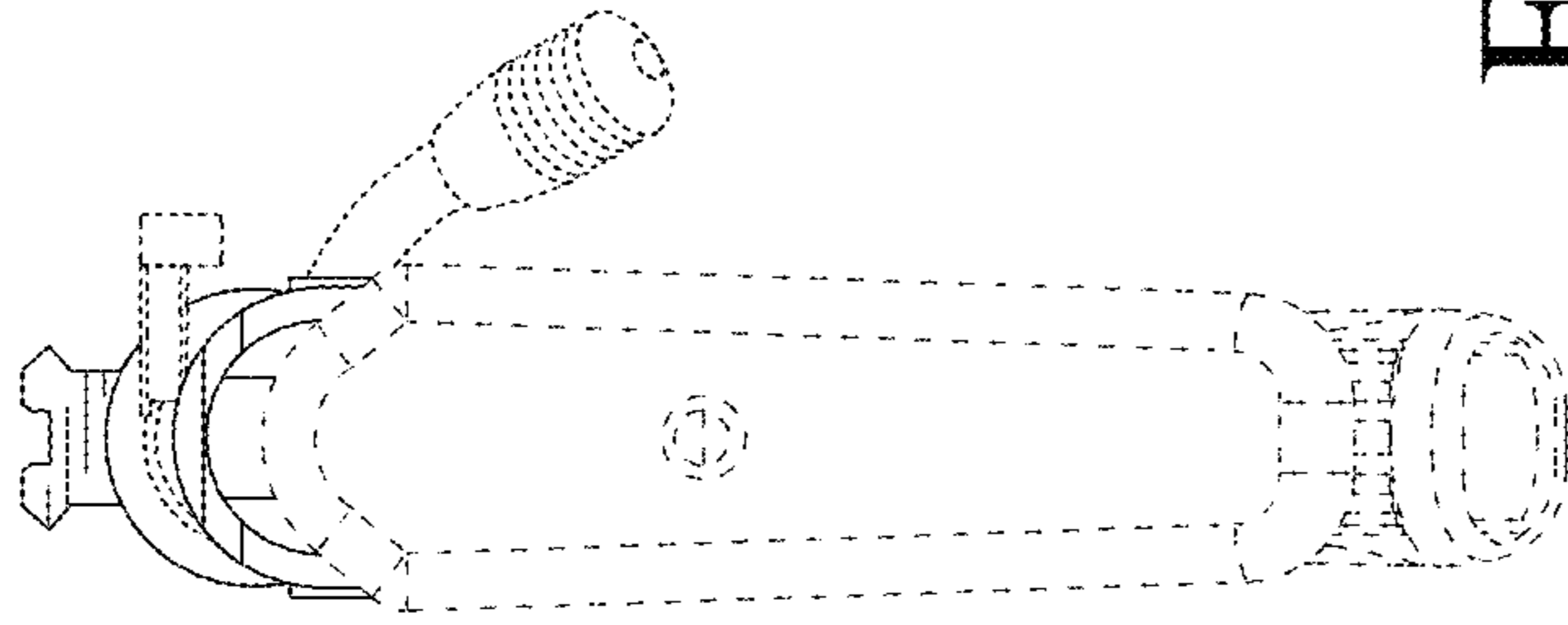

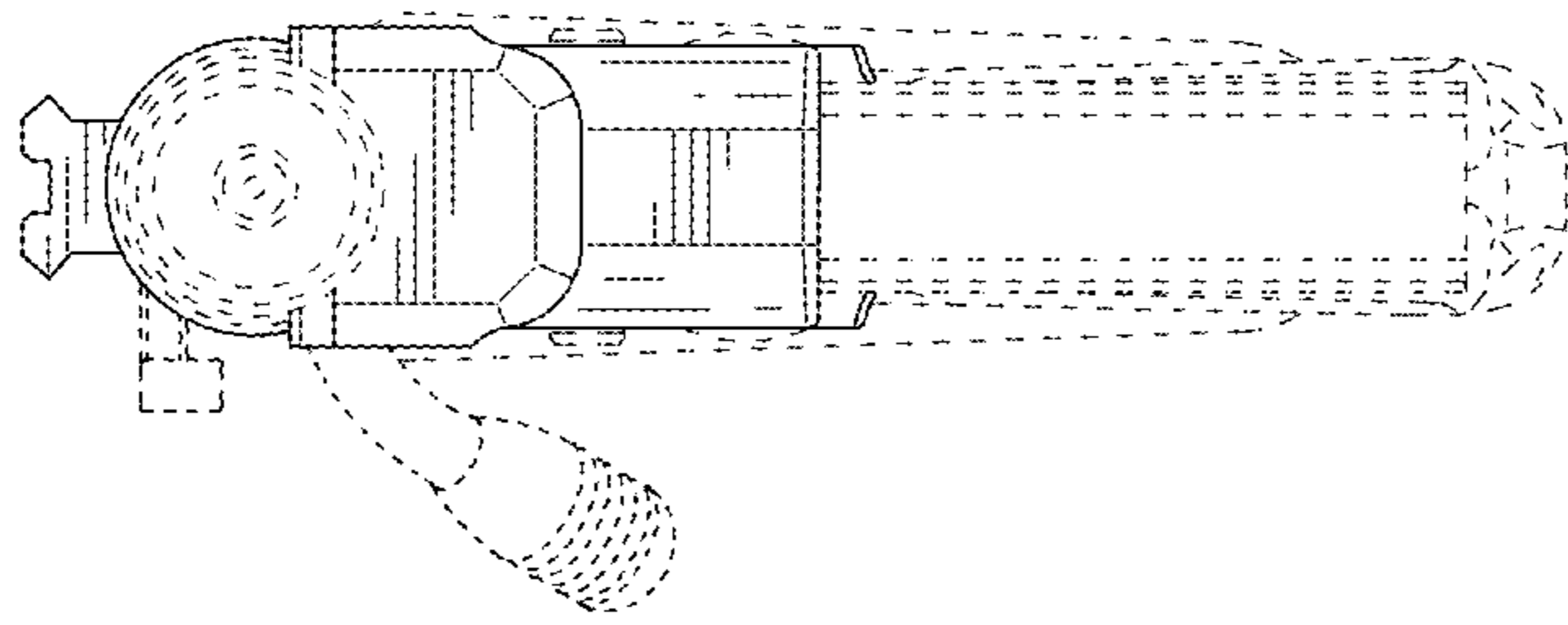
