(57) **CLAIM**

The ornamental design for a tube implant, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the tube implant comprising the new design;

FIG. 2 is a front elevational view of the design of FIG. 1, where the right, left and back views are mirror images thereof; and

FIG. 3 is a top view of the design of FIG. 1; where the bottom view is a mirror image thereof.

FIG. 4 is a top perspective view of an alternative embodiment of the tube implant of FIG. 1;

FIG. 5 is a front elevational view of the design of FIG. 1, where the right, left and back views are mirror images thereof; and

FIG. 6 is a top view of the design of FIG. 4; where the bottom view is a mirror image thereof.

FIG. 7 is a top perspective view of a further alternative embodiment of the tube implant of FIG. 1;

FIG. 8 is a front elevational view of the design of FIG. 7, where the back view is a mirror image thereof;

FIG. 9 is a right side elevational view of the design of FIG. 7;

FIG. 10 is a left side elevational view of the design of FIG. 7;

FIG. 11 is a top view of the design of FIG. 7; and

FIG. 12 is a bottom view of the design of FIG. 7.

FIG. 13 is a top perspective view of an alternative embodiment of the tube implant of FIG. 7;

FIG. 14 is a front elevational view of the design of FIG. 13, where the back view is a mirror image thereof;

FIG. 15 is a right side elevational view of the design of FIG. 13;

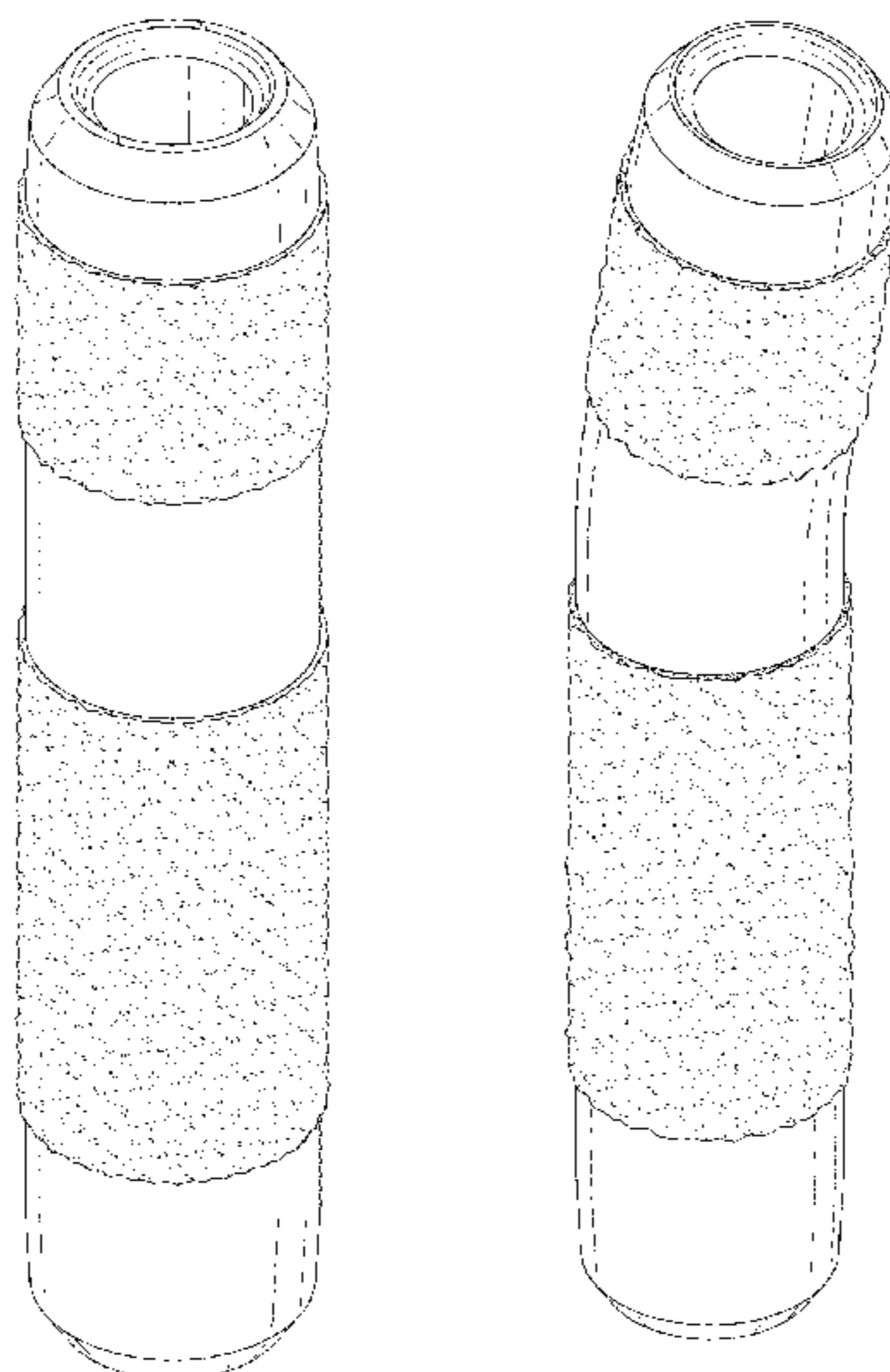
FIG. 16 is a left side elevational view of the design of FIG. 13;

FIG. 18 is a bottom view of the design of FIG. 13.

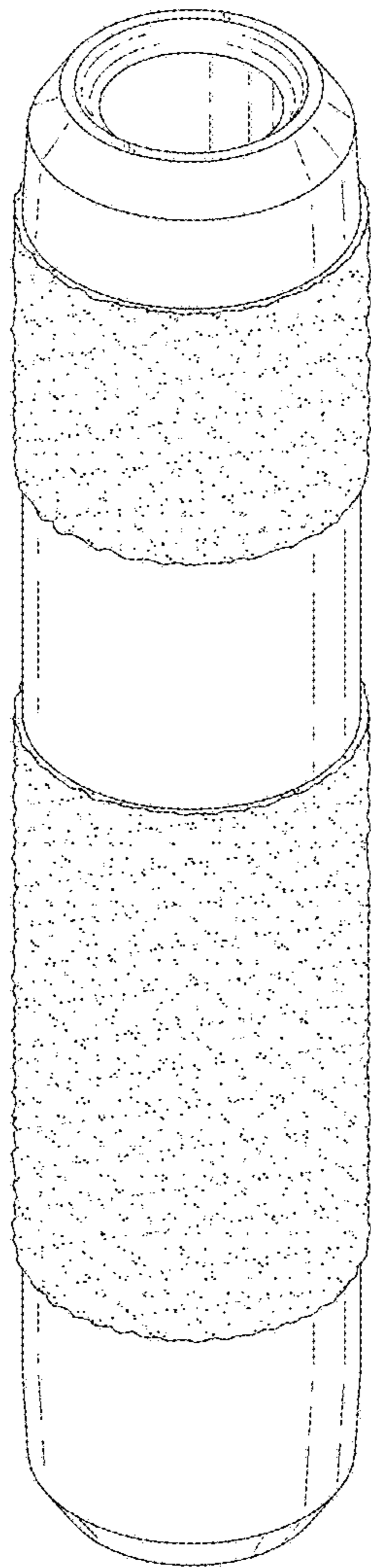

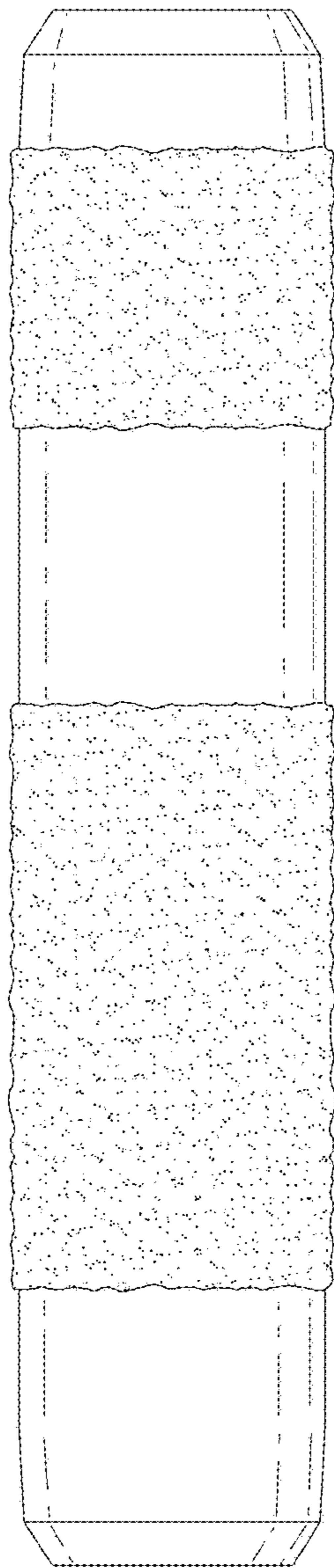

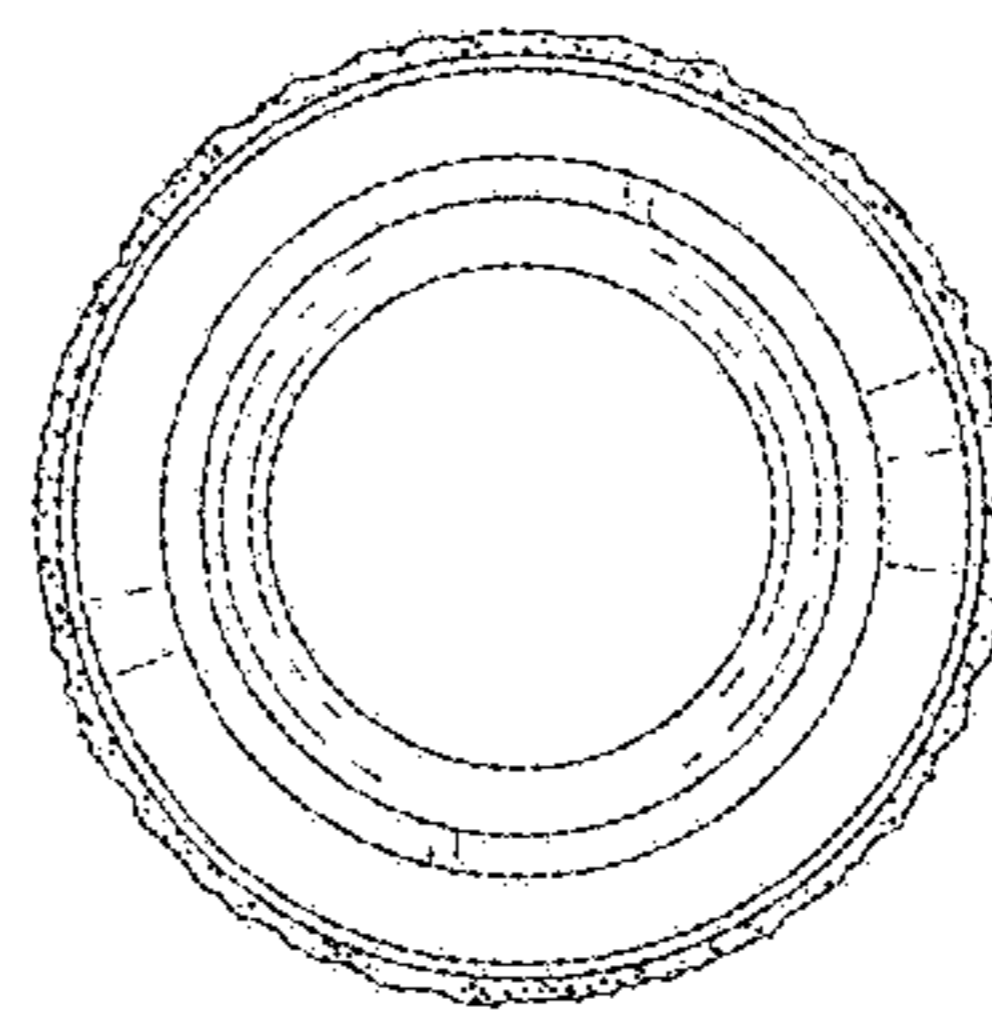

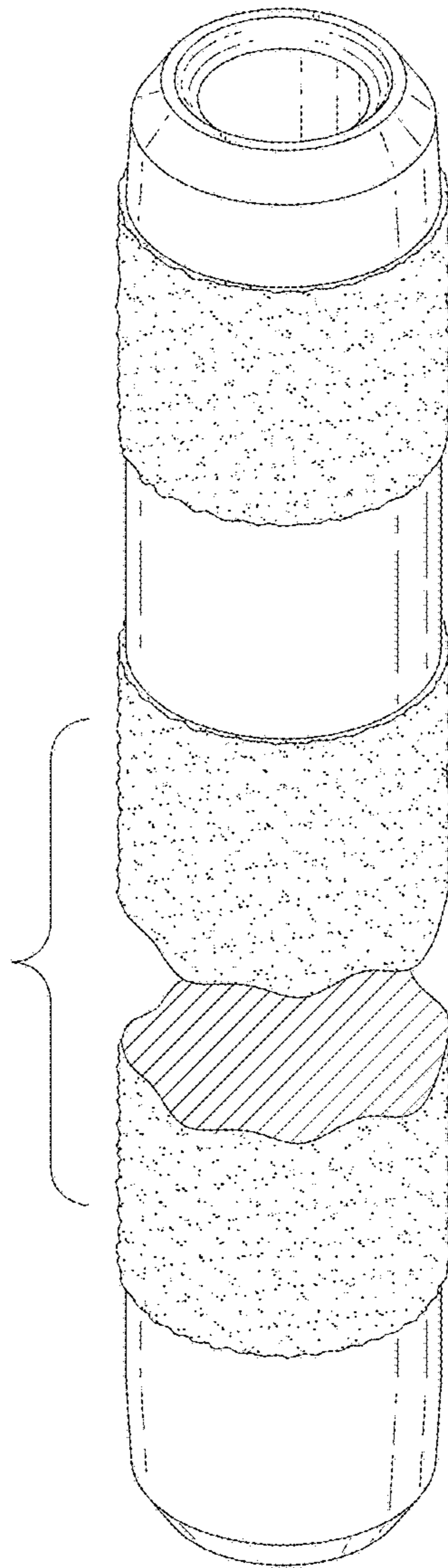

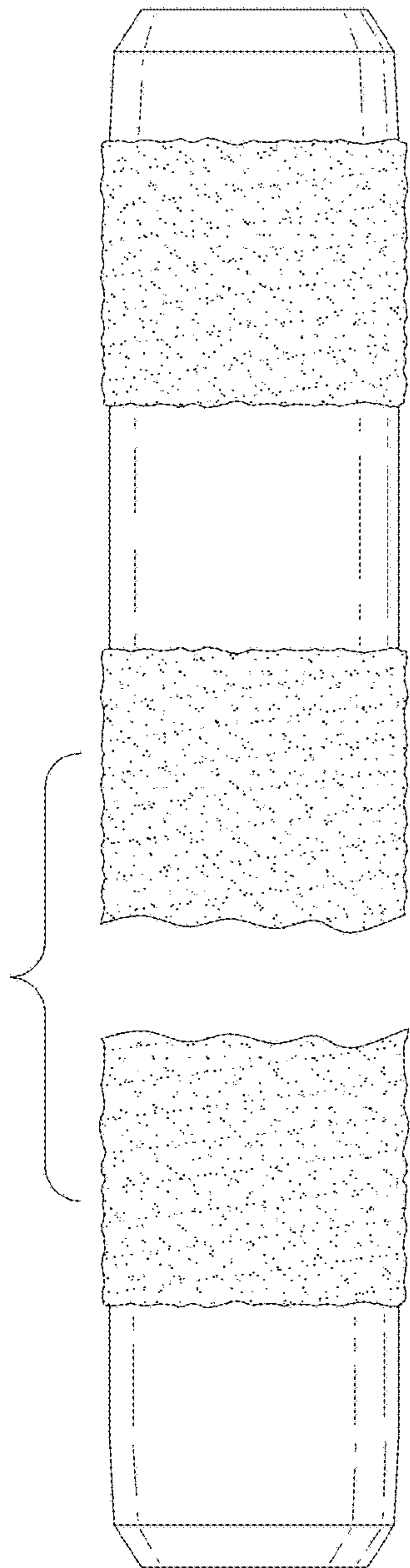

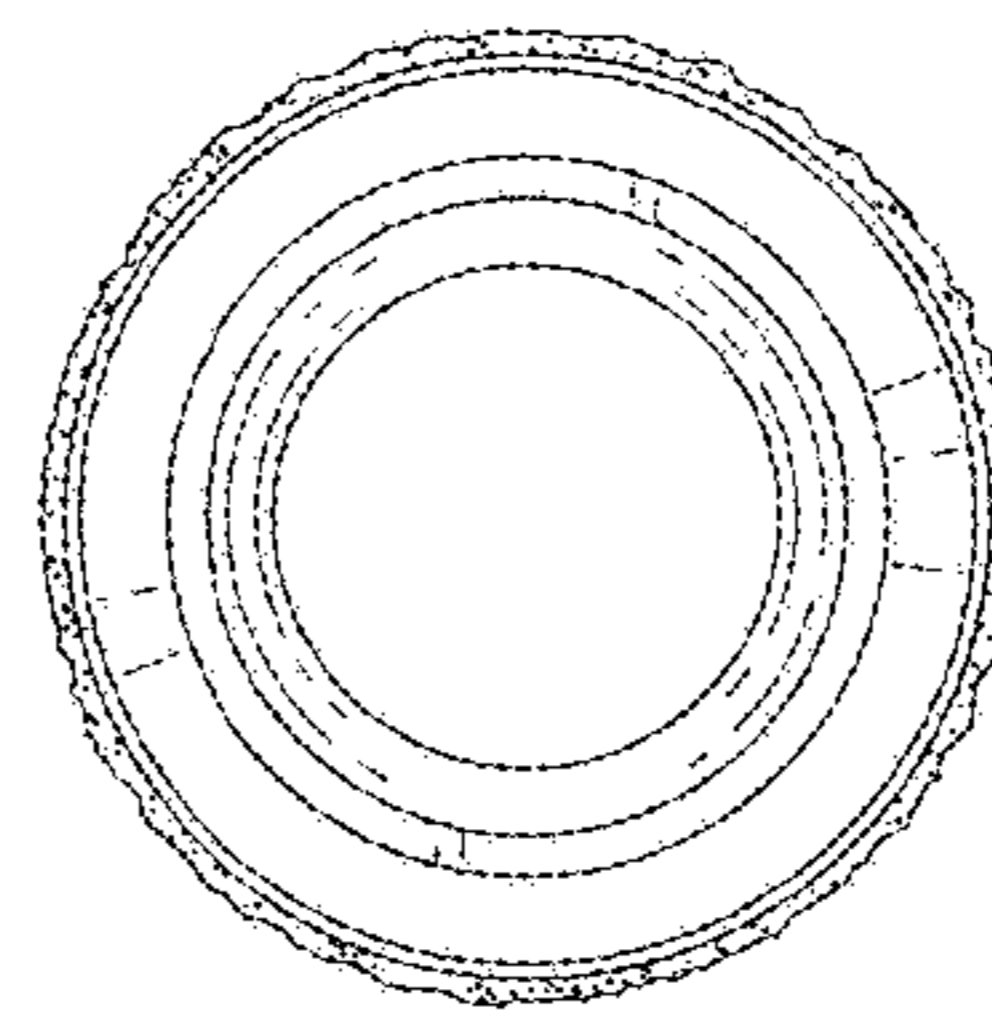

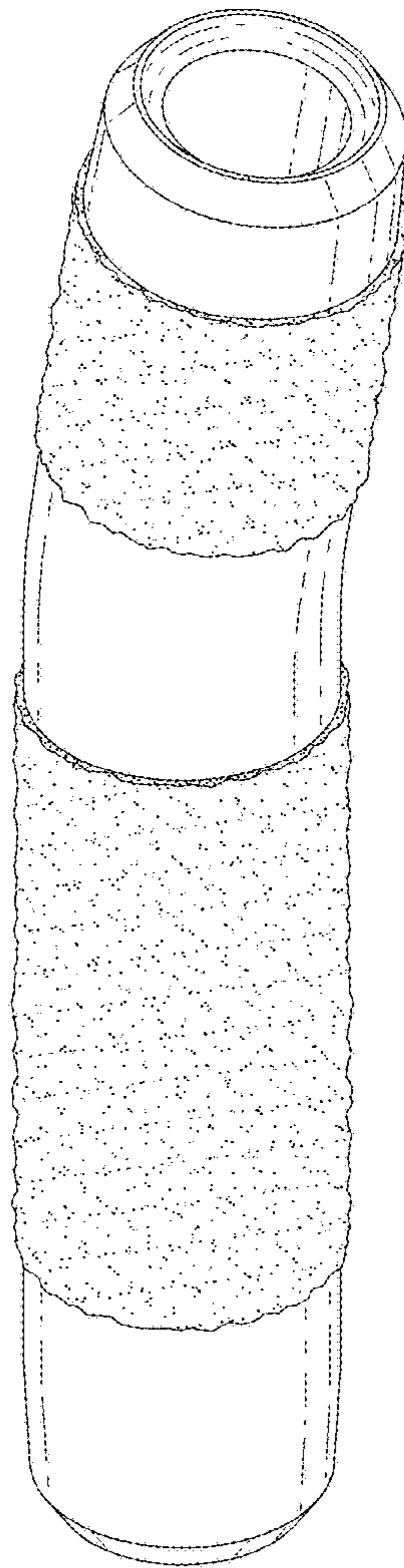

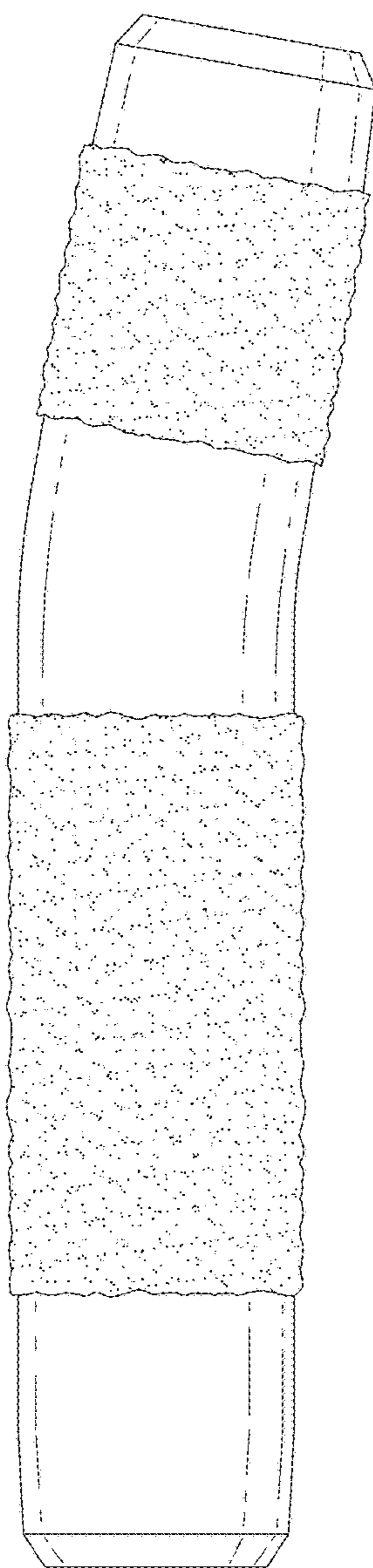

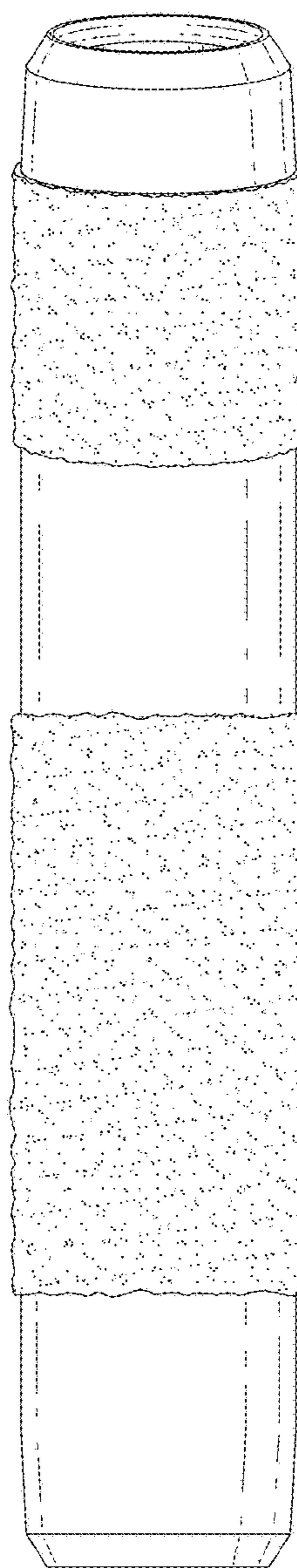

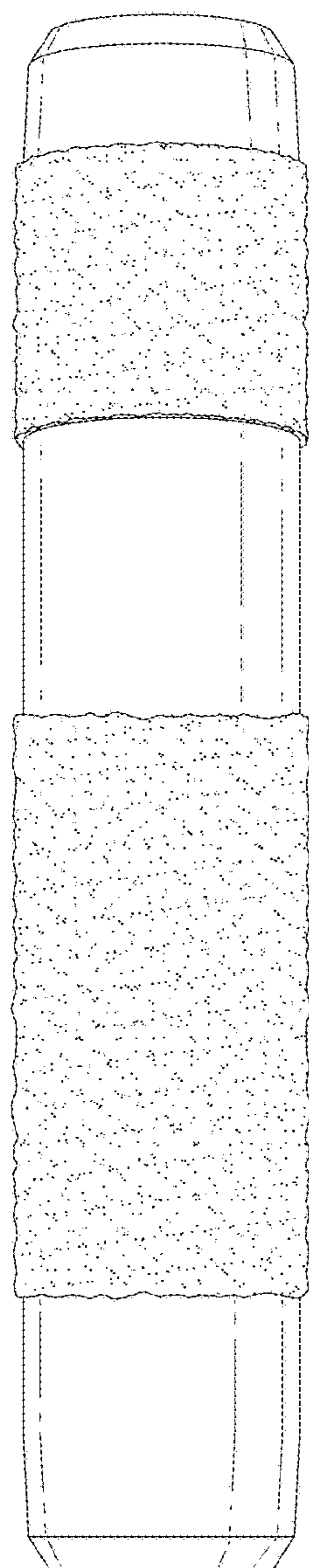

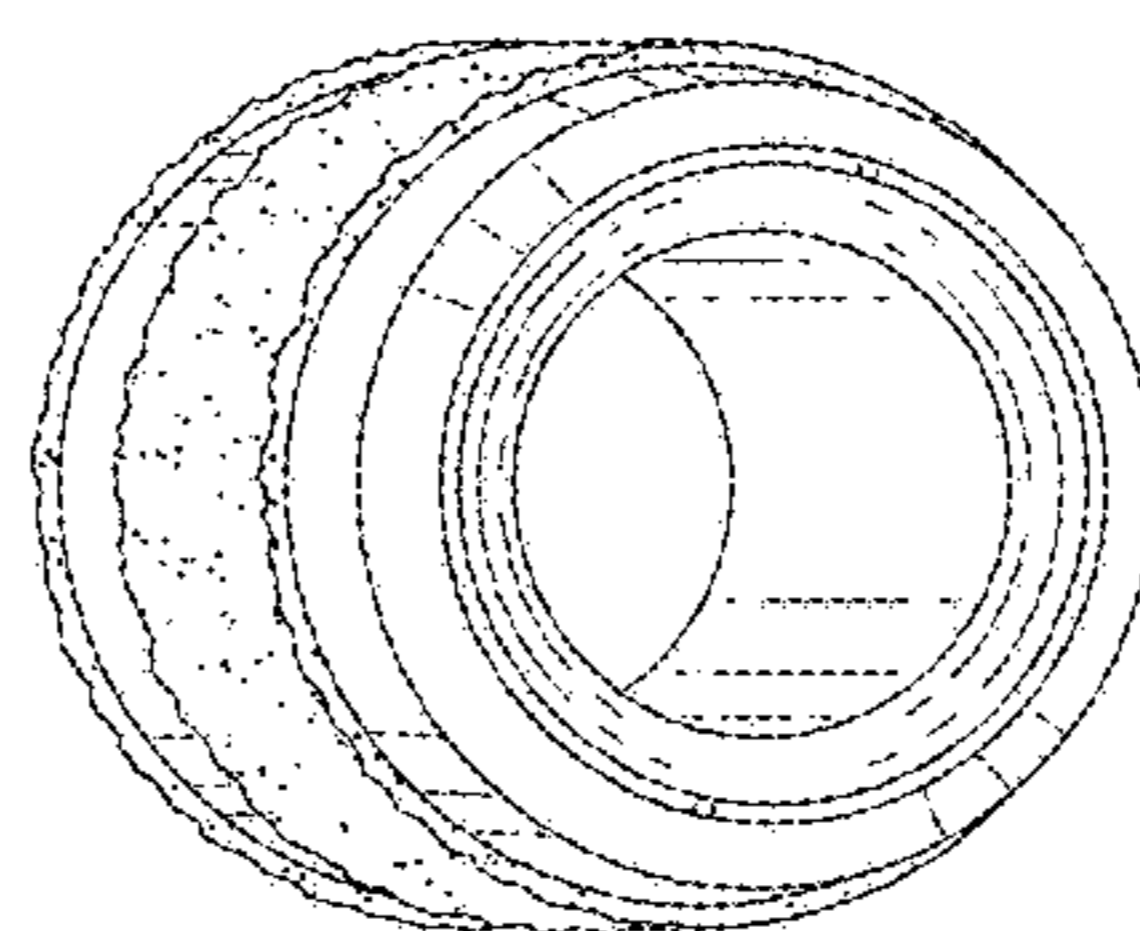

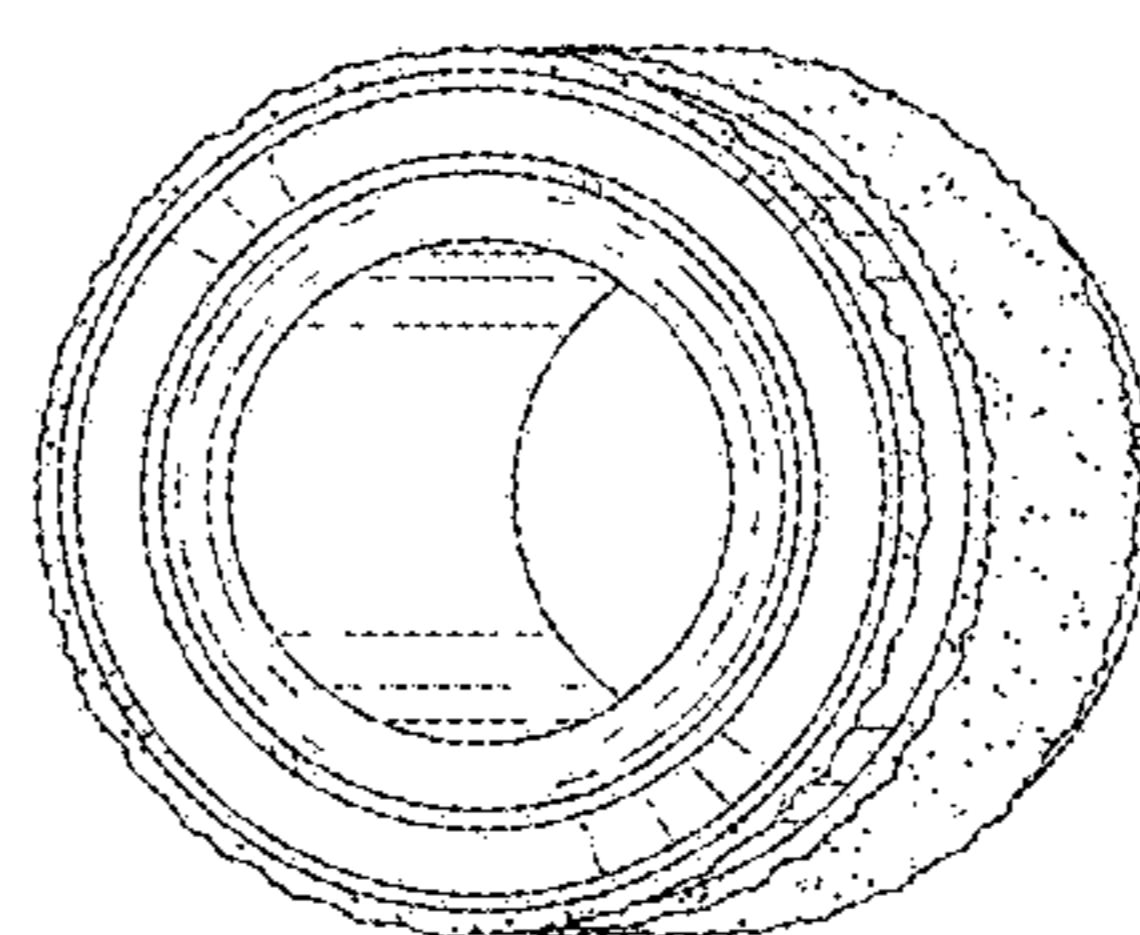

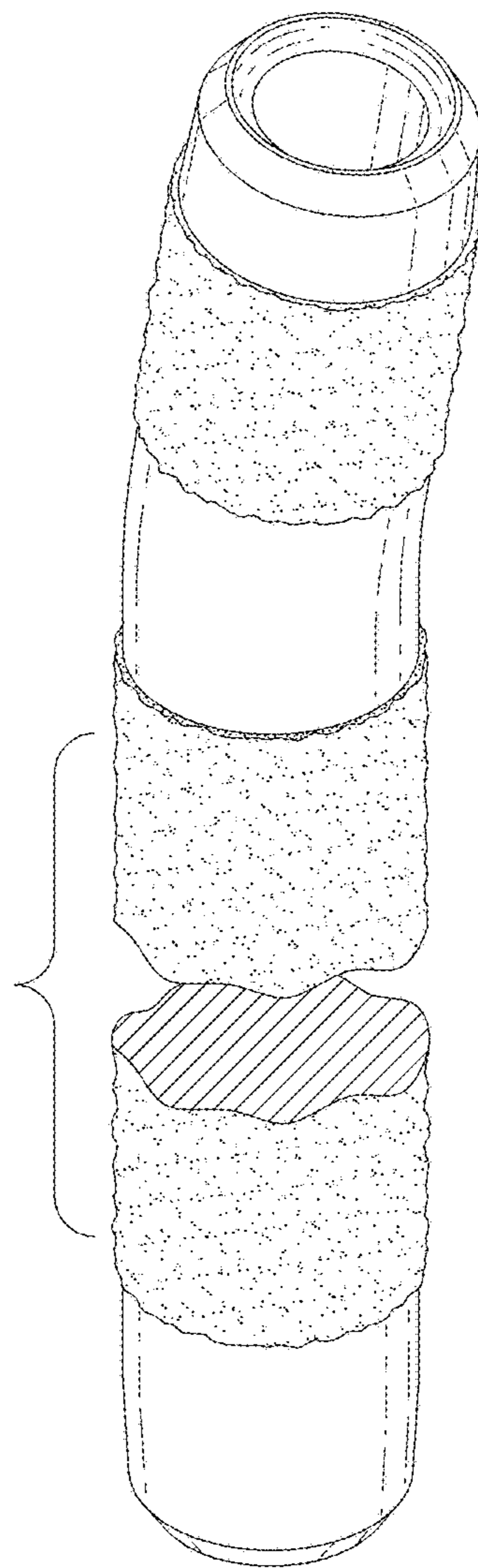

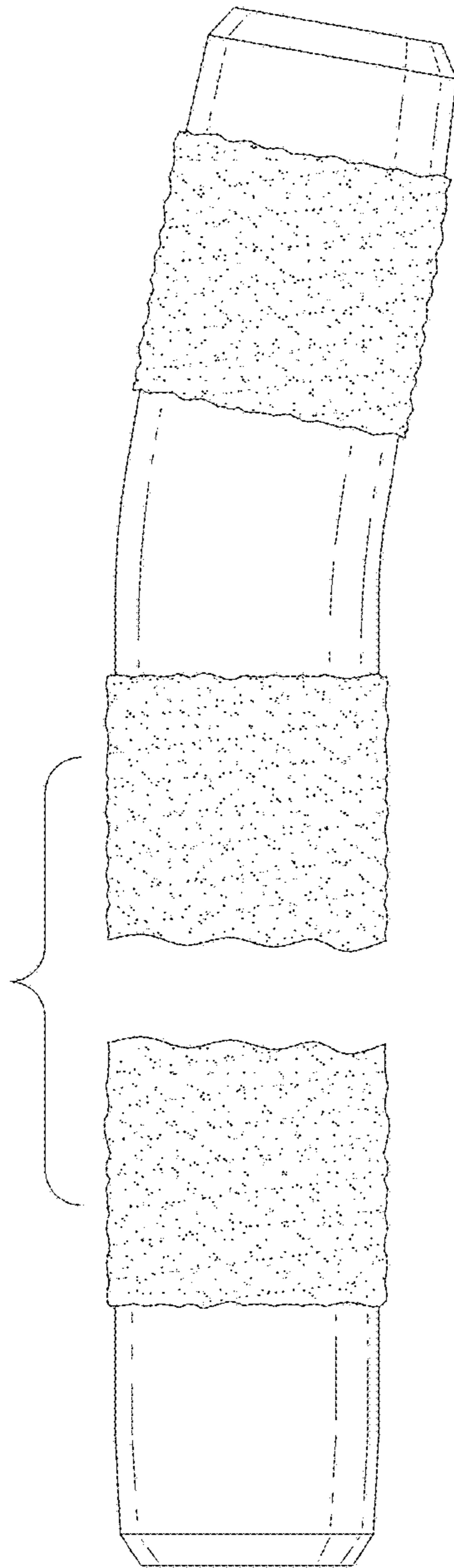

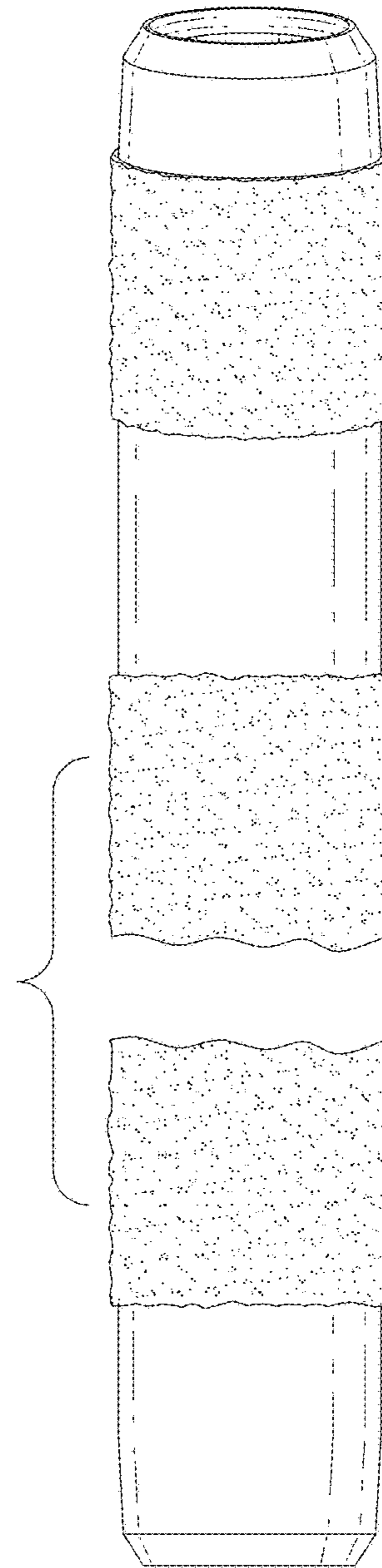

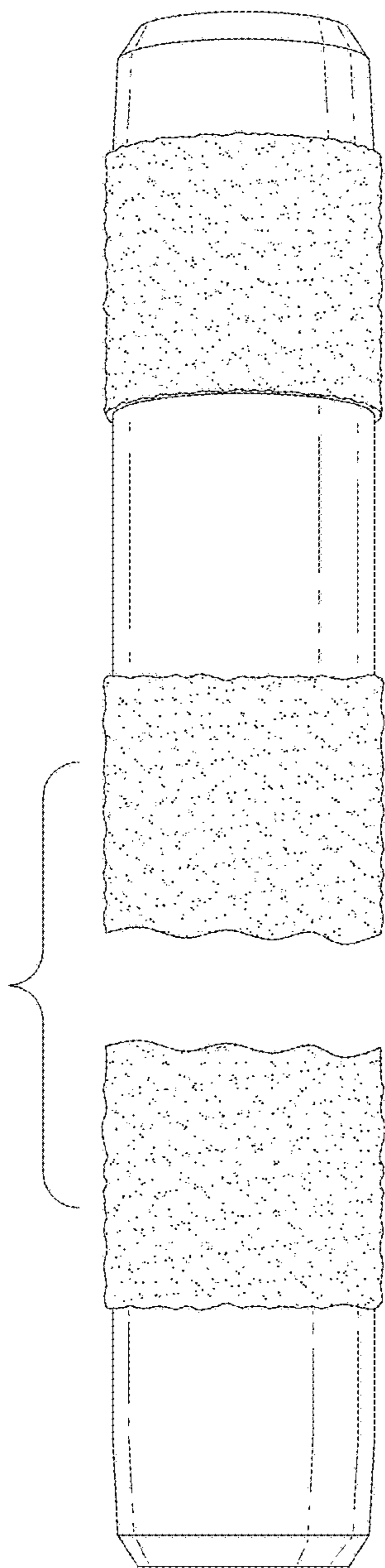

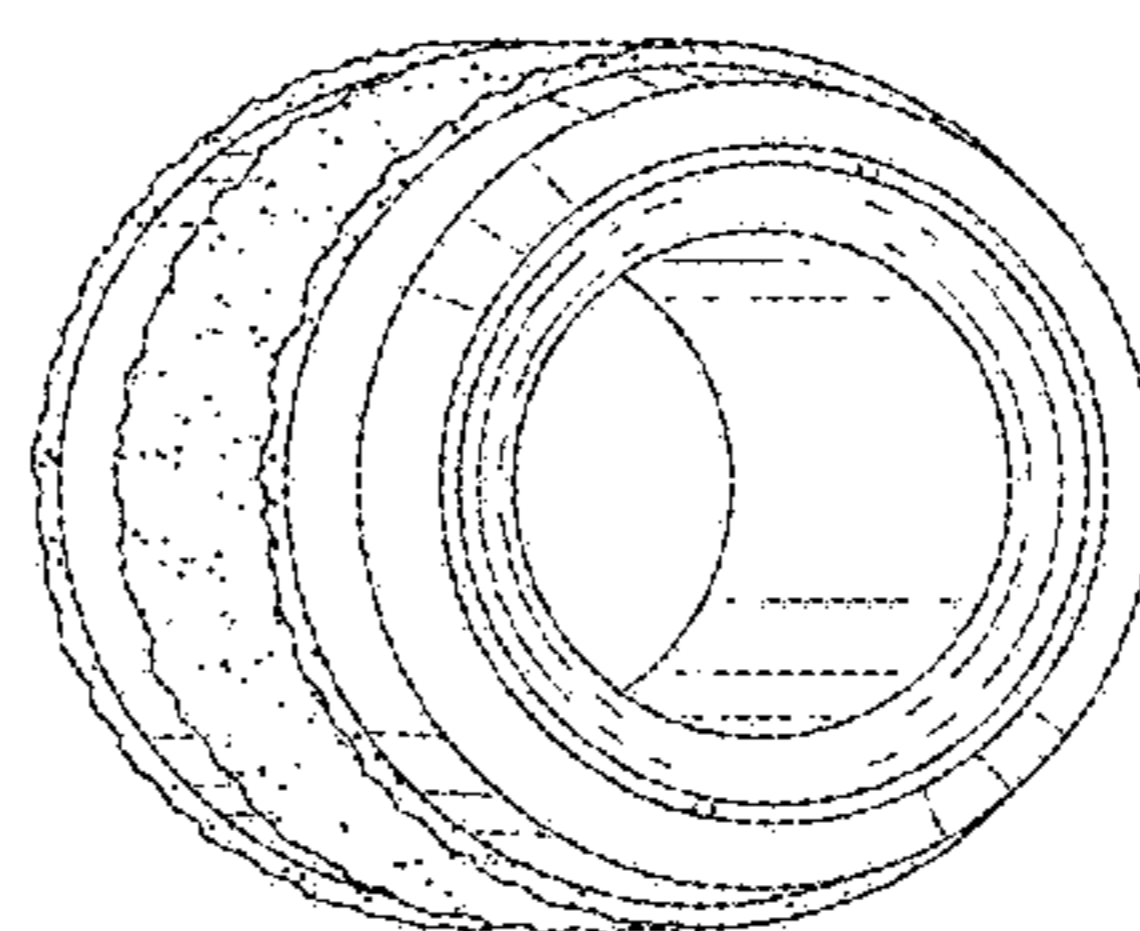

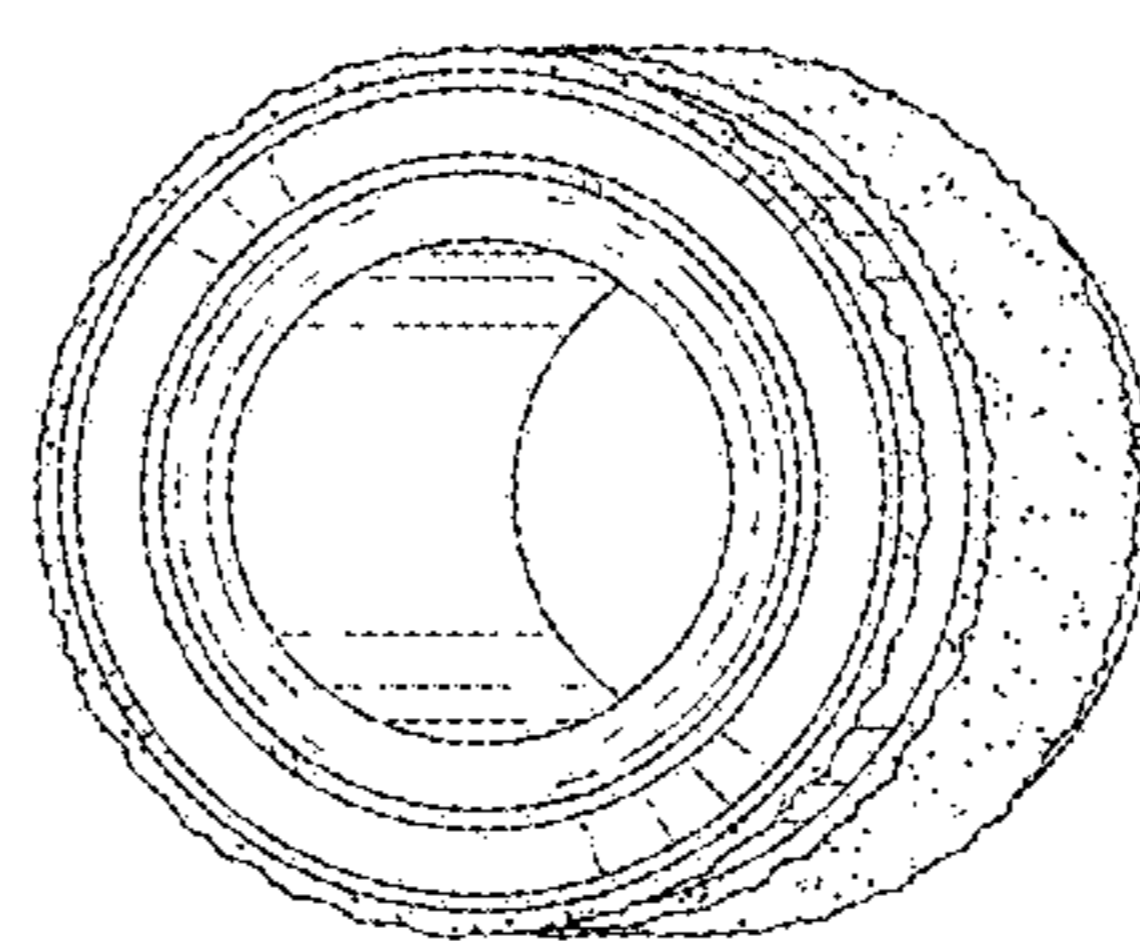
