FIG. 25 is a rear view thereof;

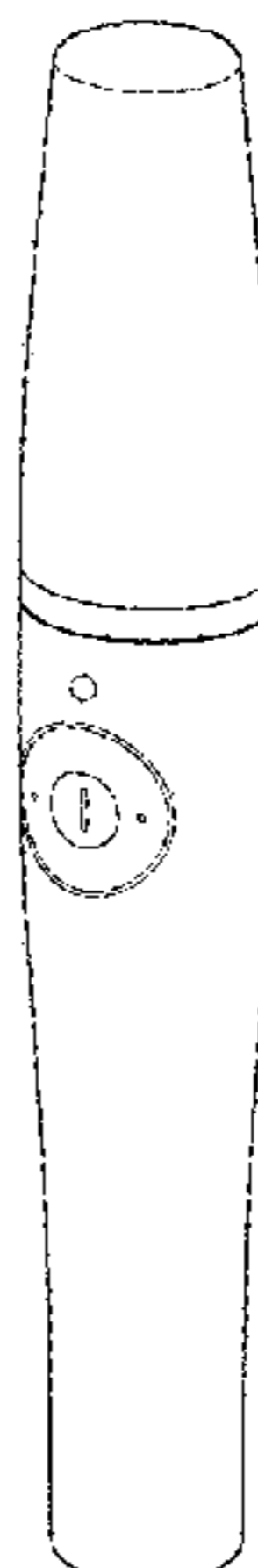

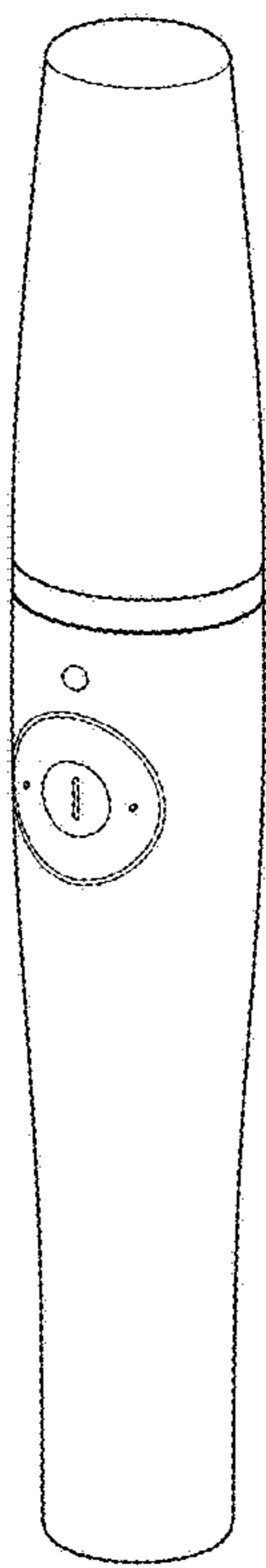

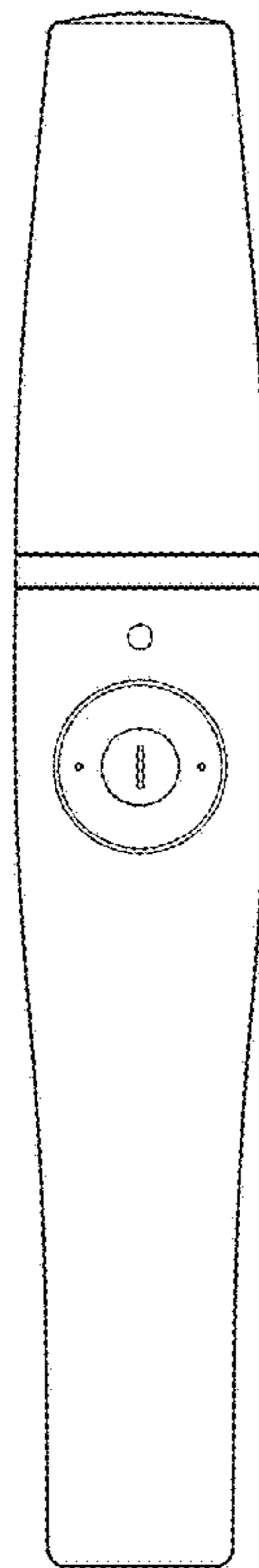

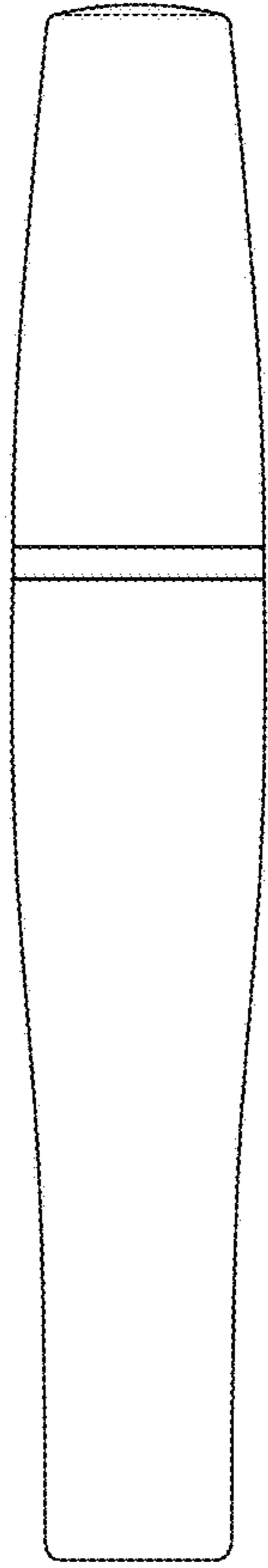

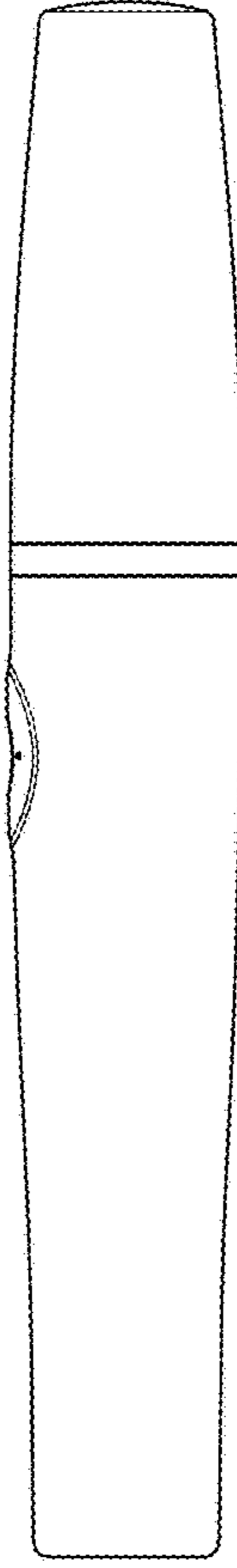

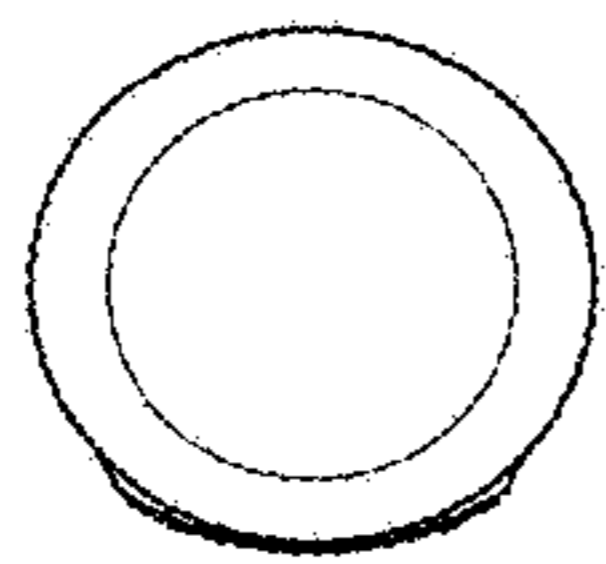

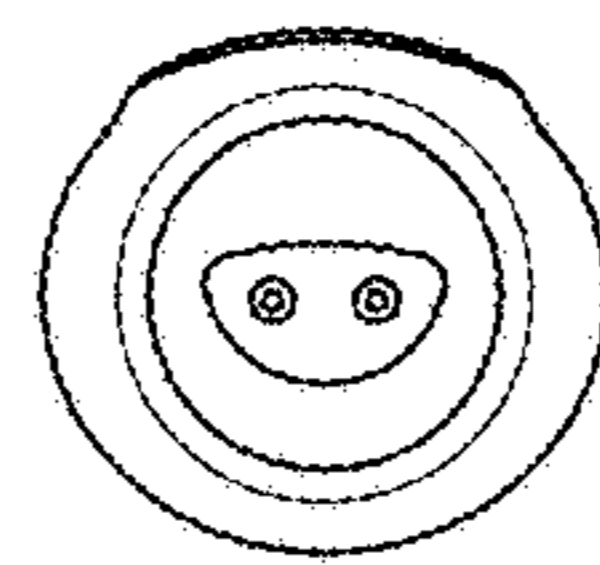

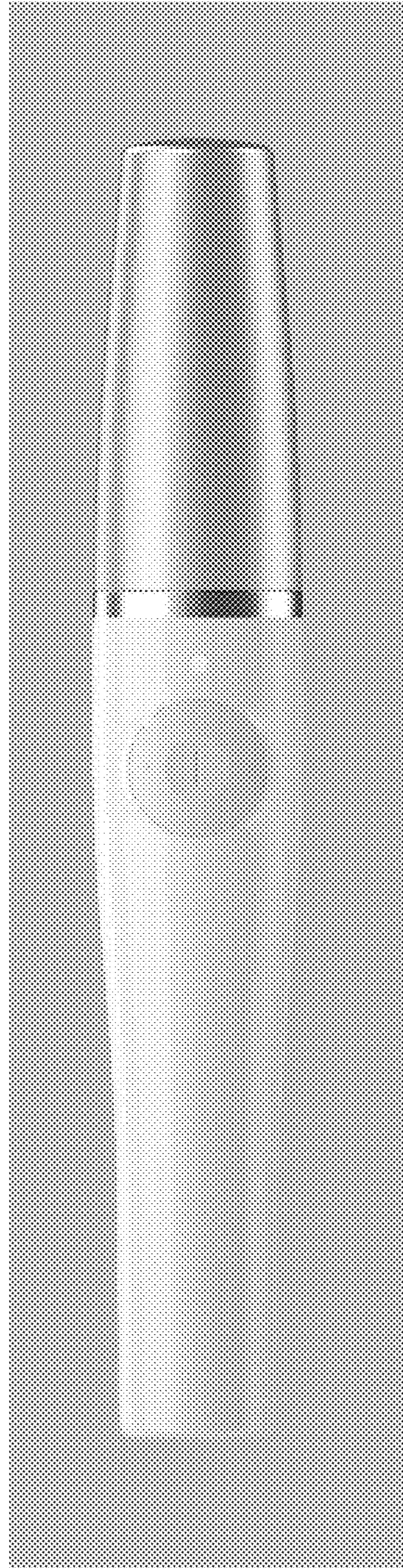

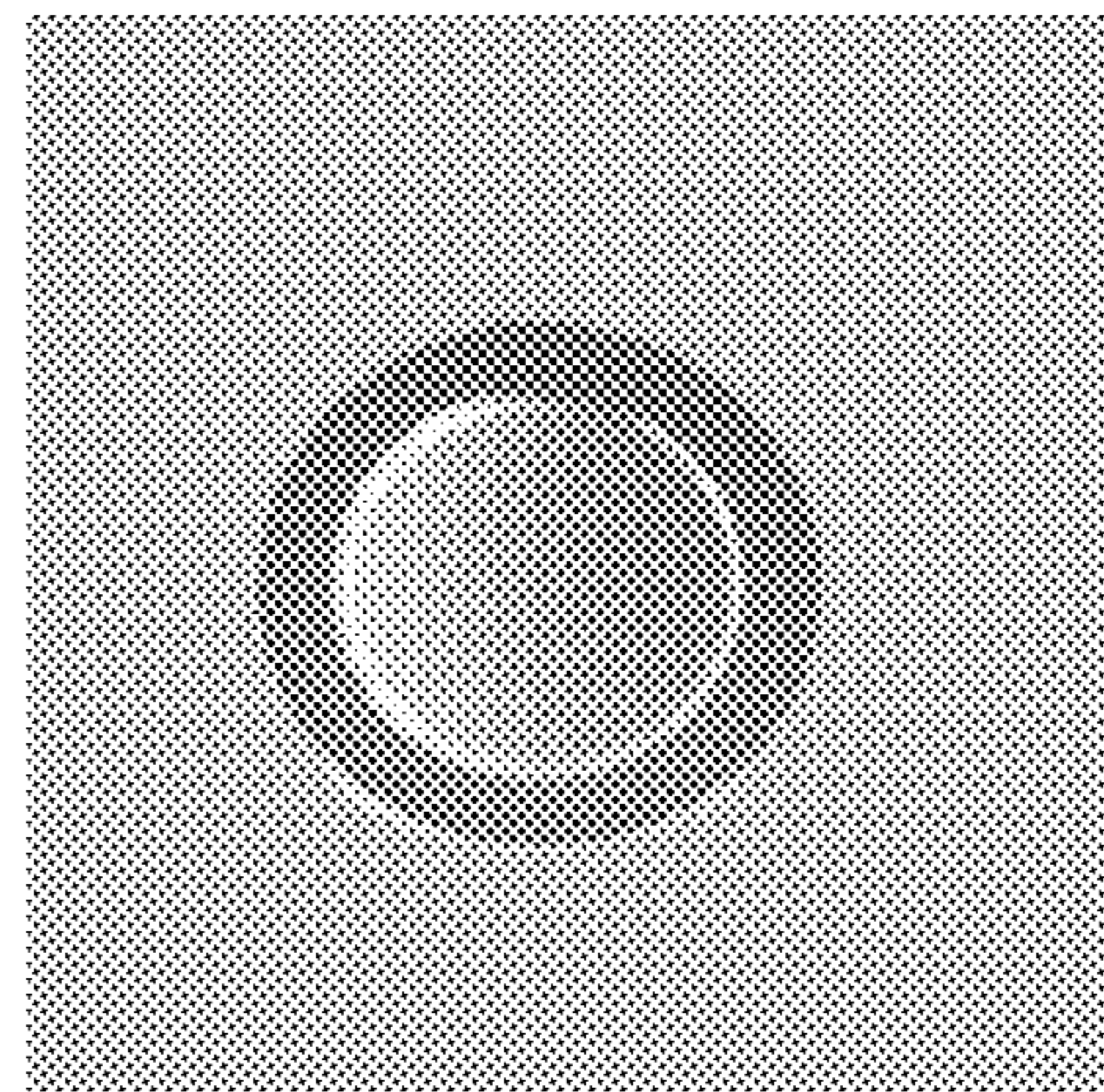

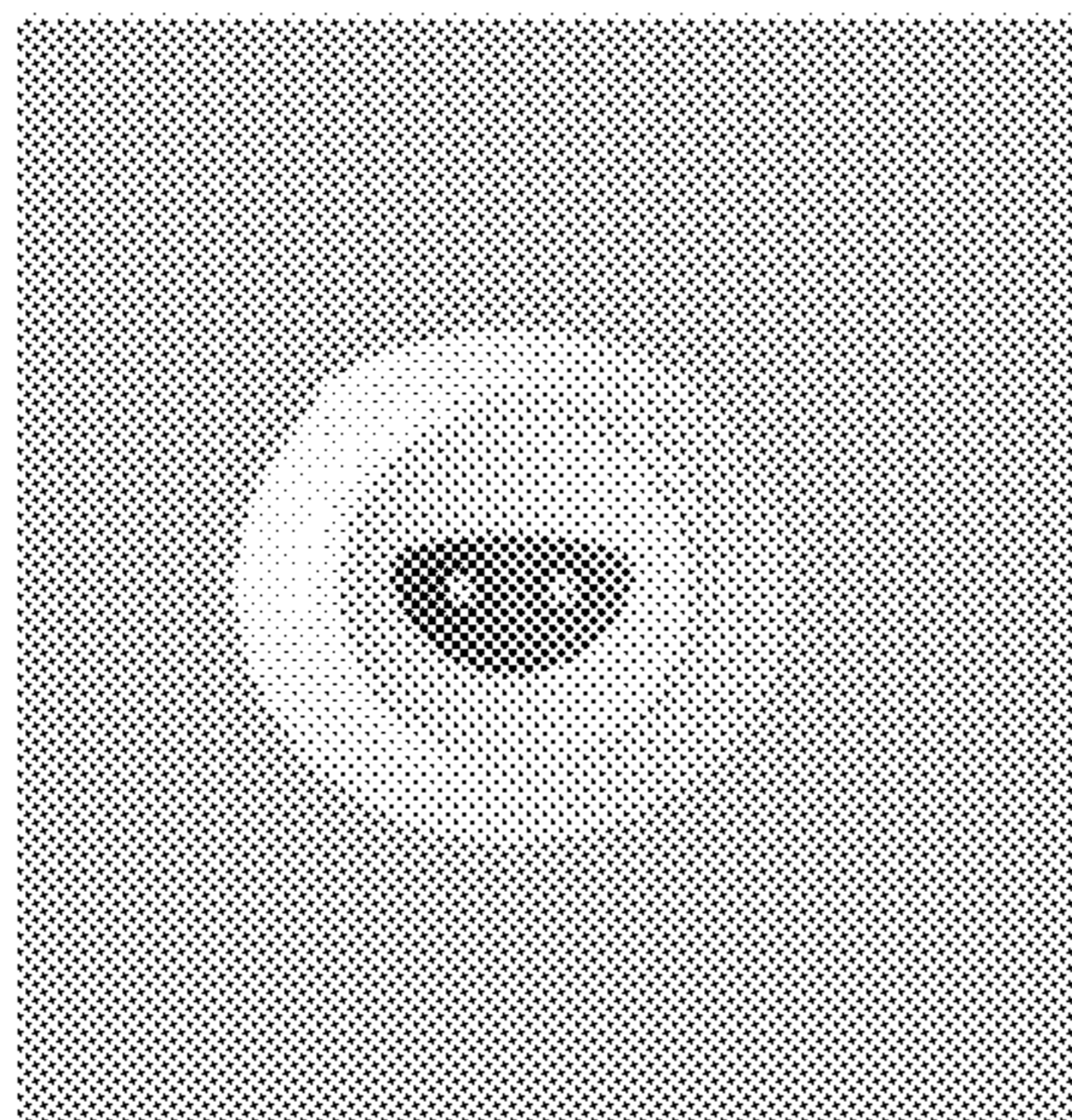

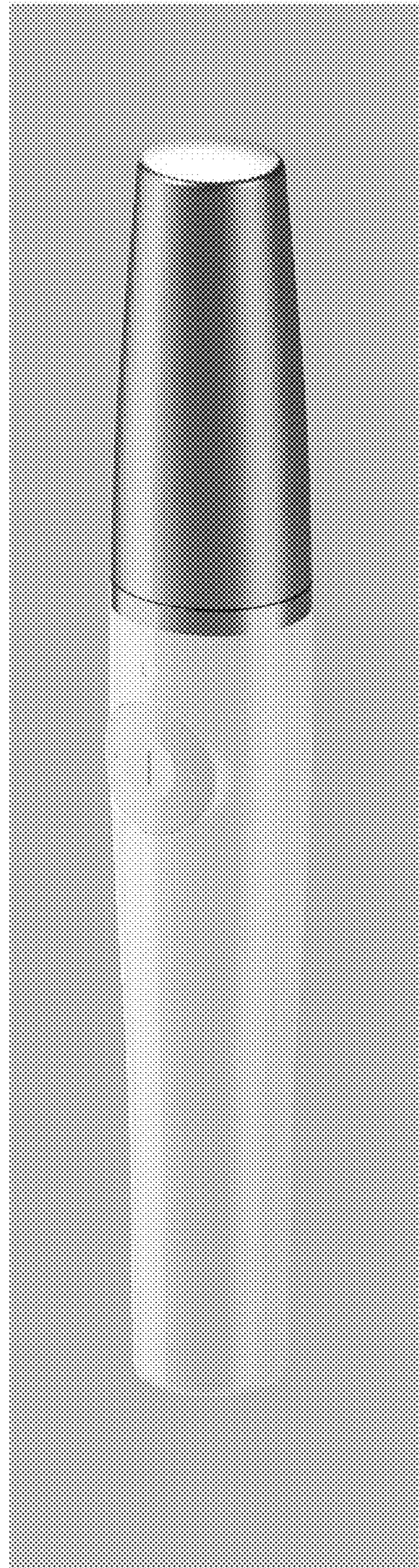

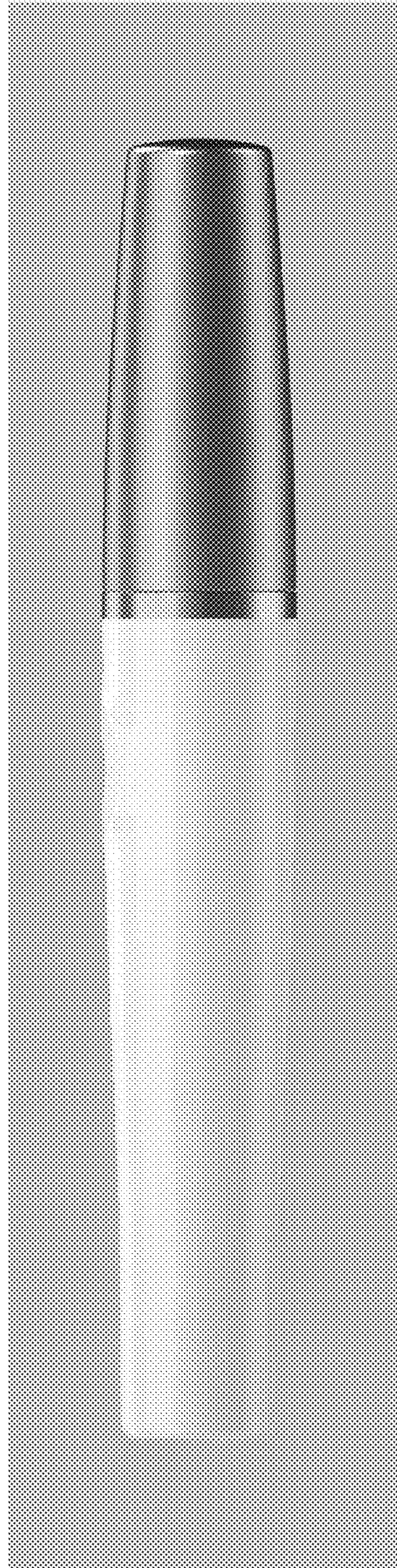

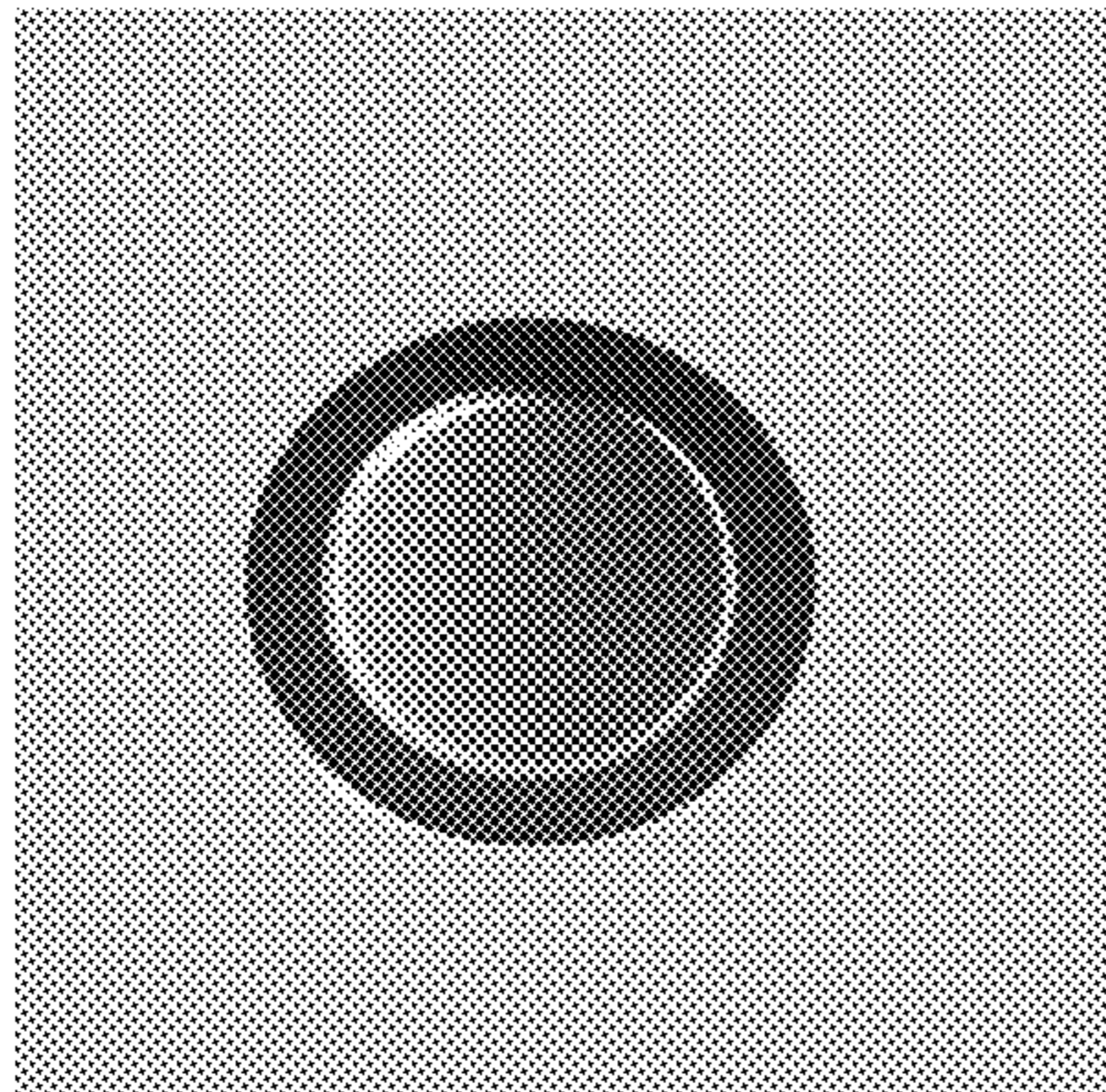

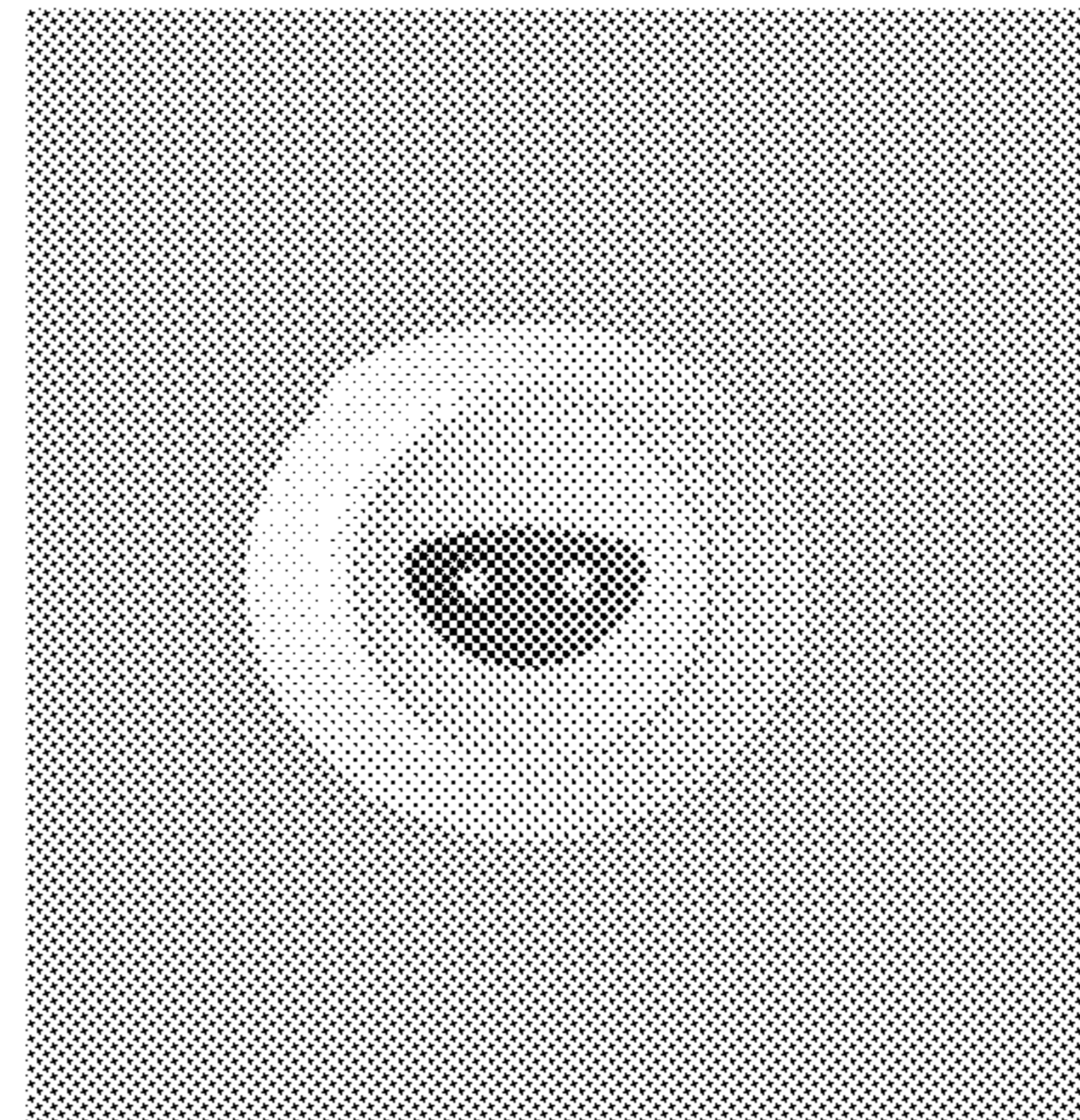

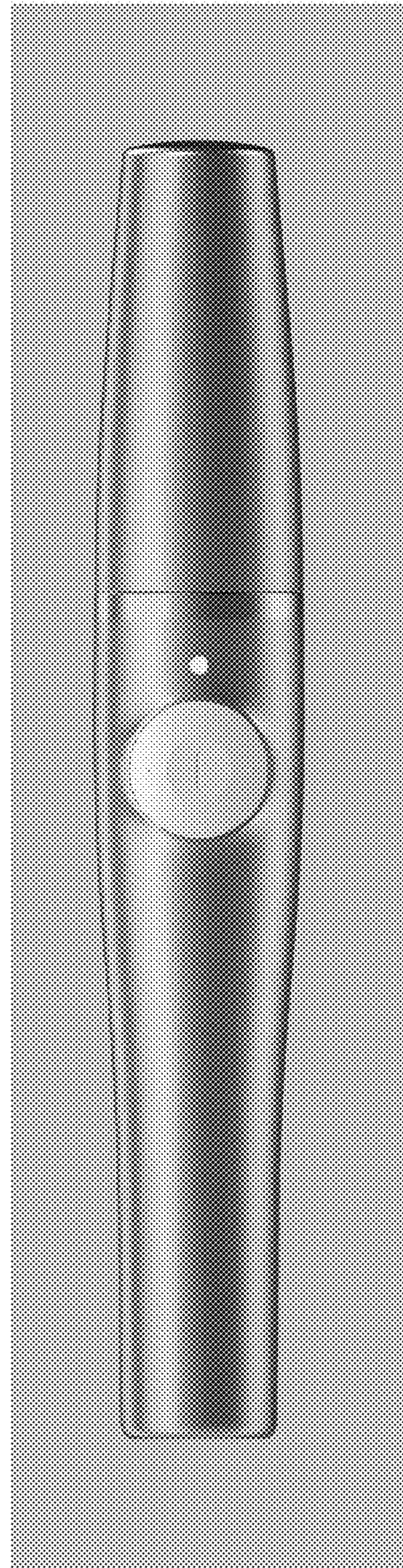

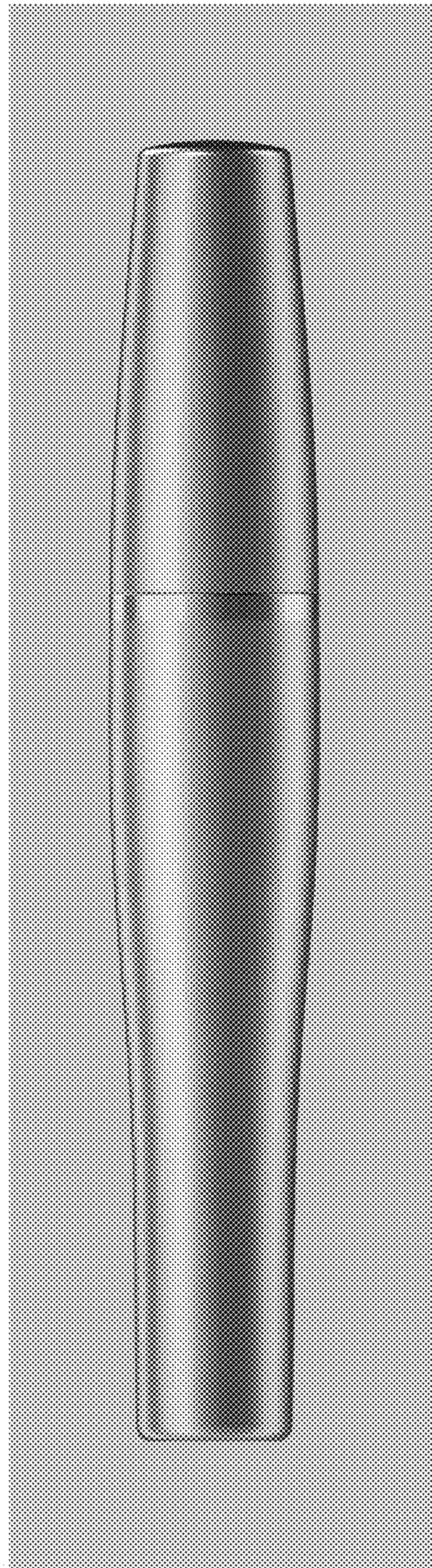

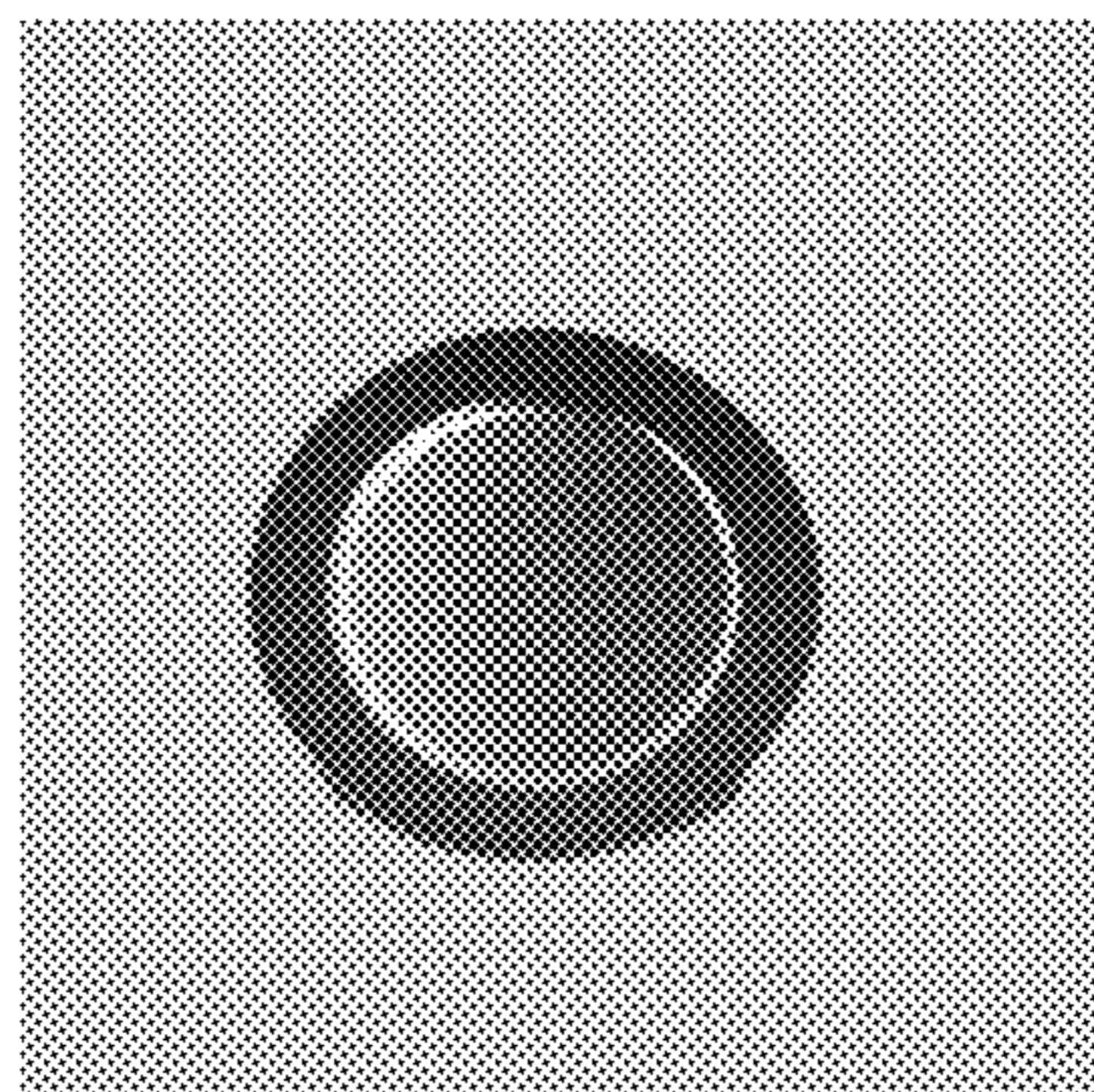

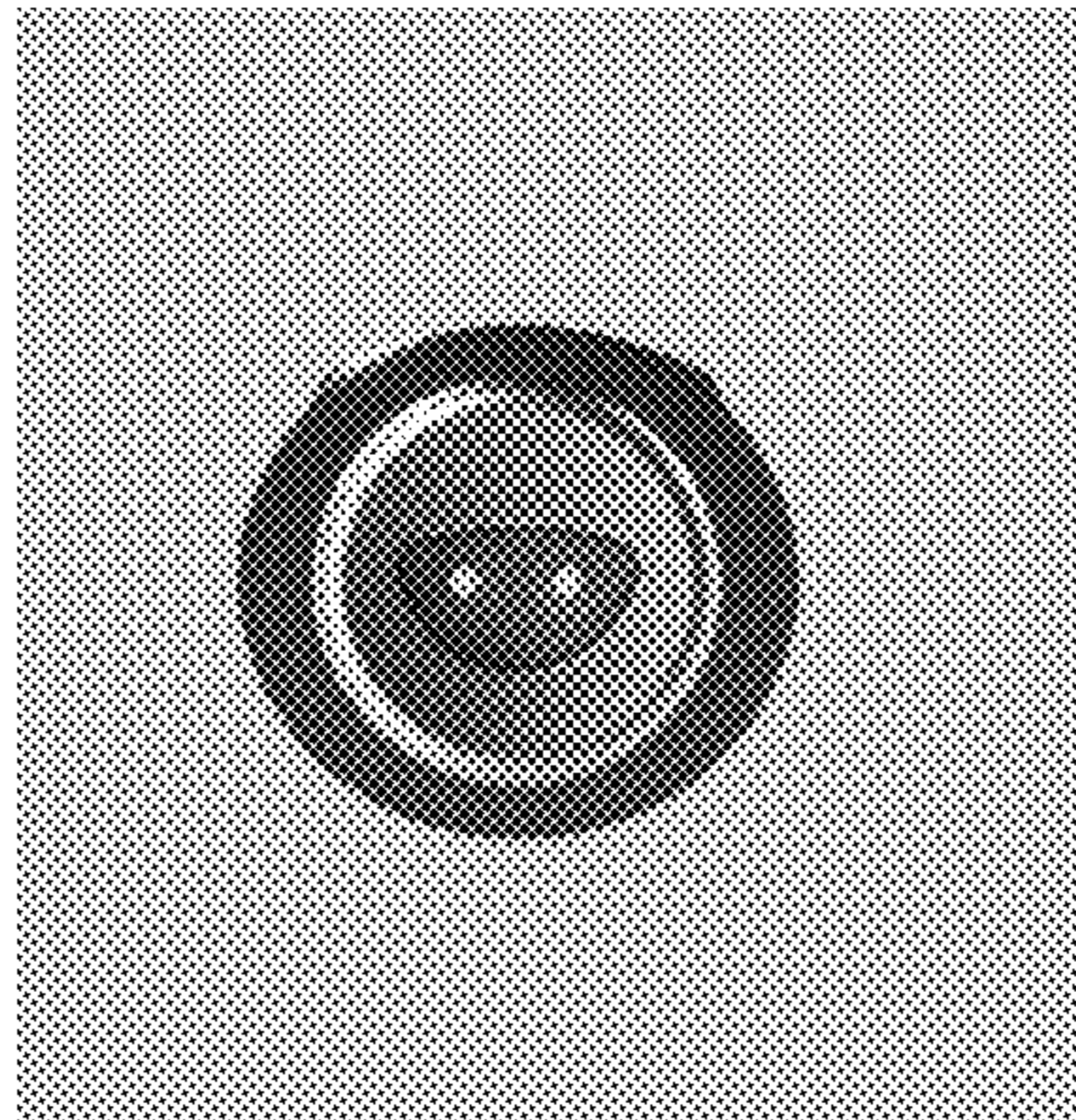
