(57) **CLAIM**

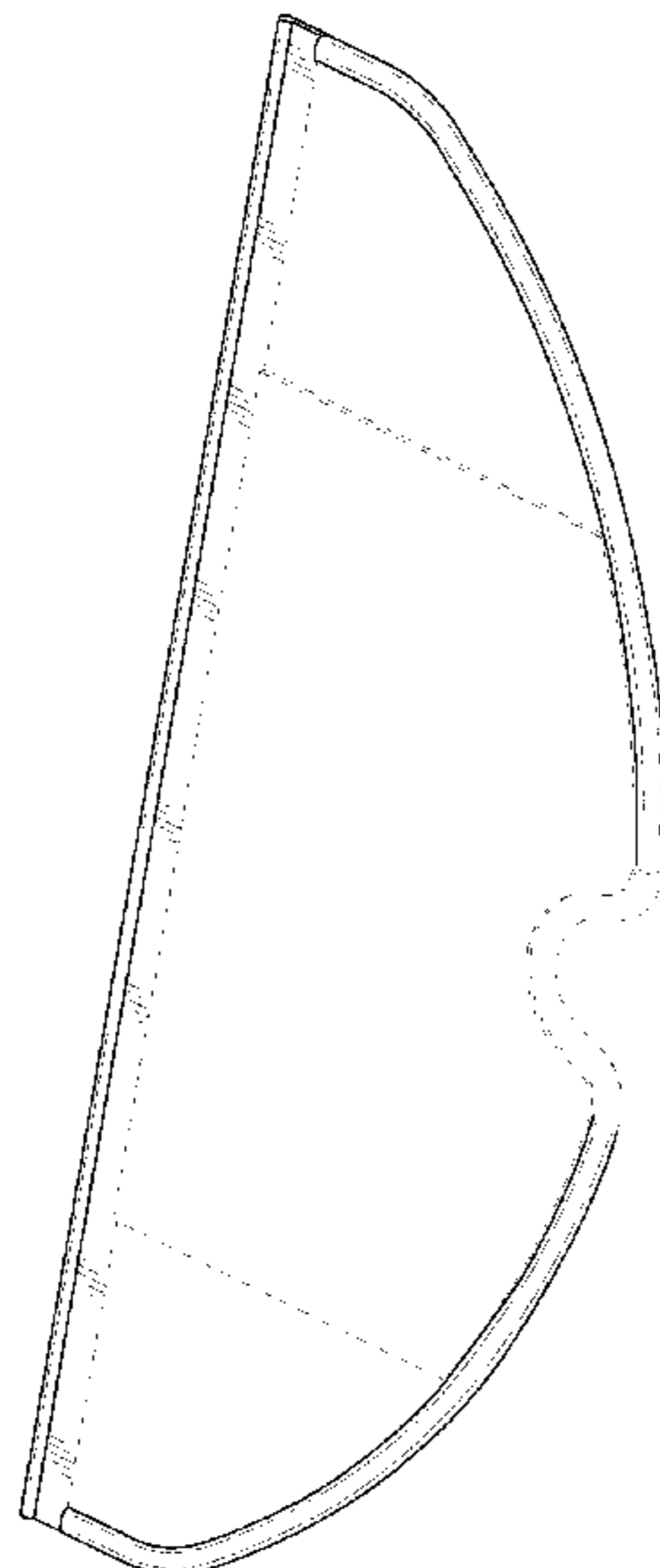
We claim the ornamental design for a cleaning pad, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our cleaning pad;
FIG. 2 is a front elevational view thereof;
FIG. 3 a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is another perspective view thereof, showing environmental structure;
FIG. 9 is a detail view of zone IX of FIG. 8; and,
FIG. 10 is another perspective view thereof, showing environmental structure.

The dashed lines in the figures form no part of the claimed design. The long-short dashed lines that abut a claimed surface represent an unclaimed boundary between claimed and unclaimed surfaces and form no part of the claimed design.

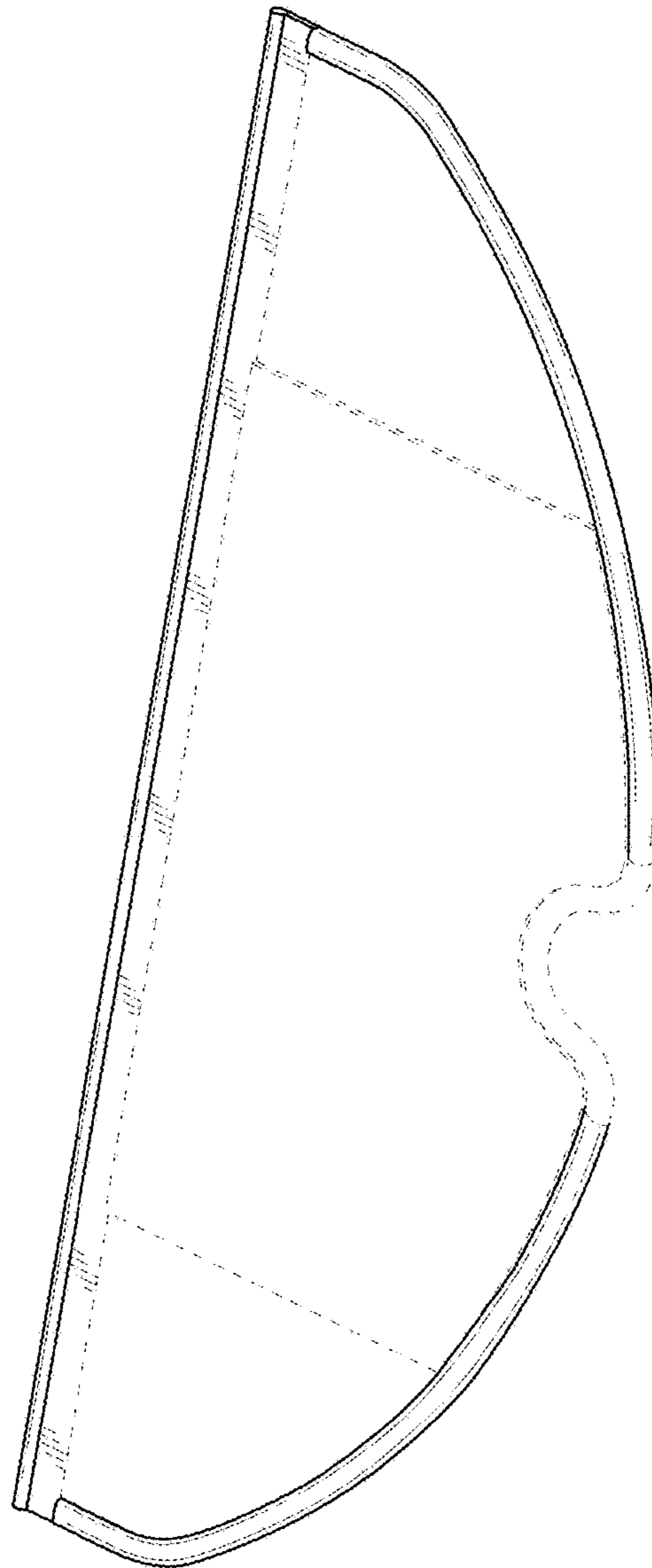

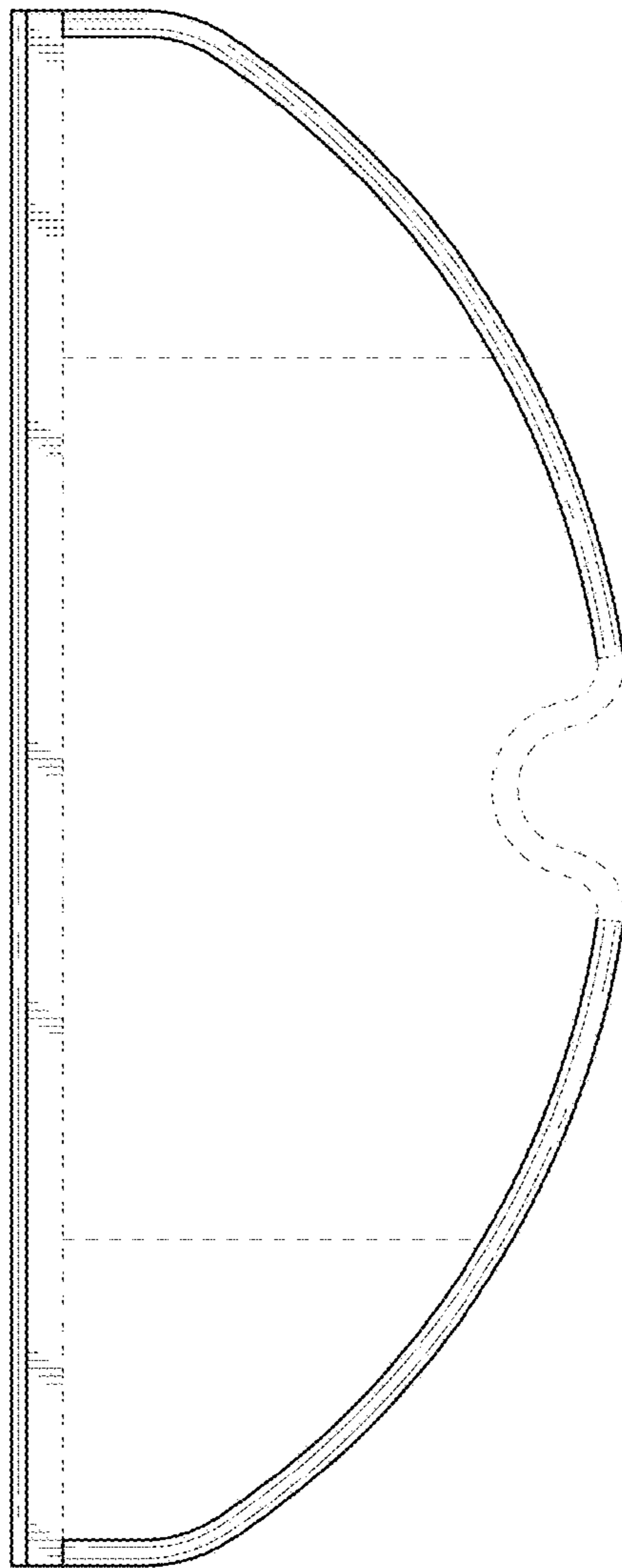

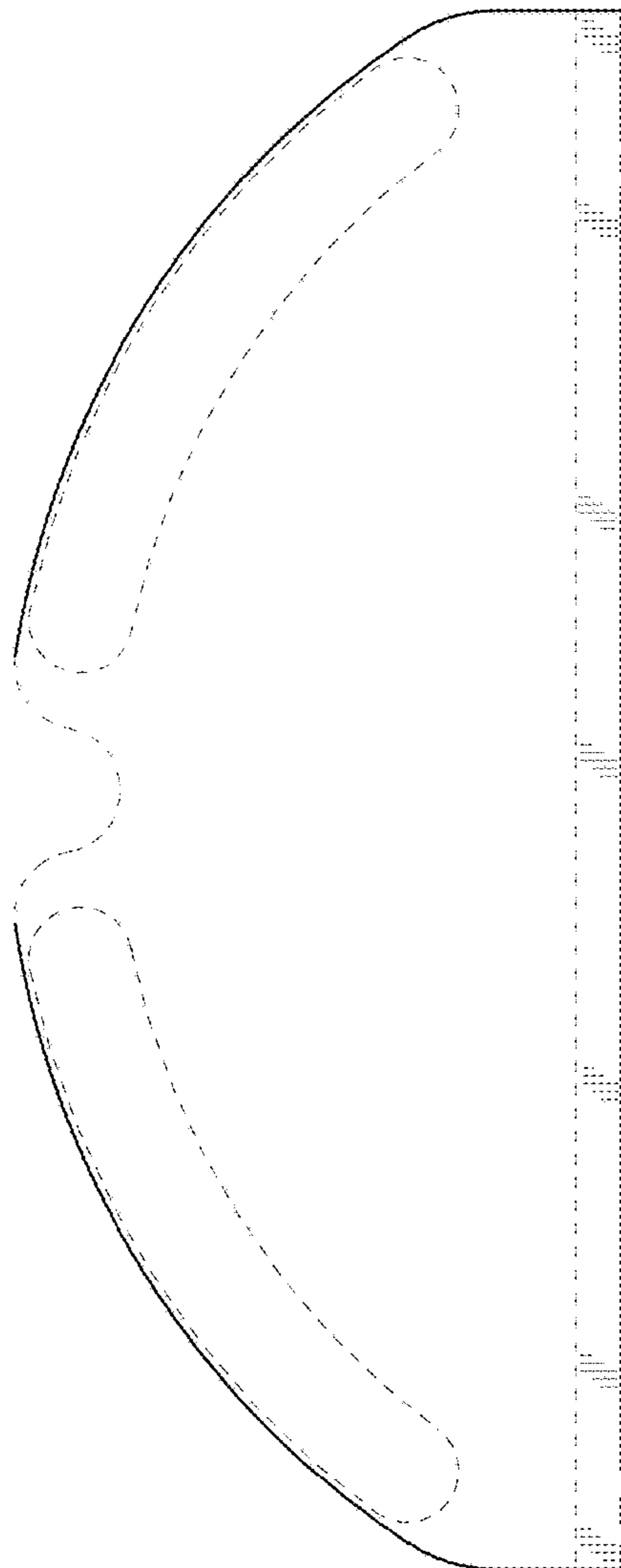

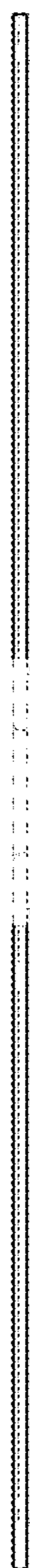

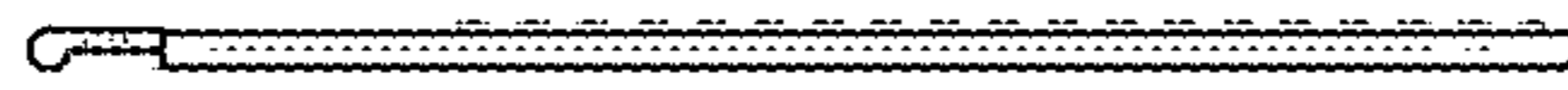

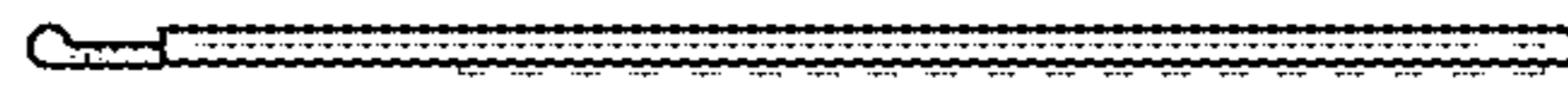

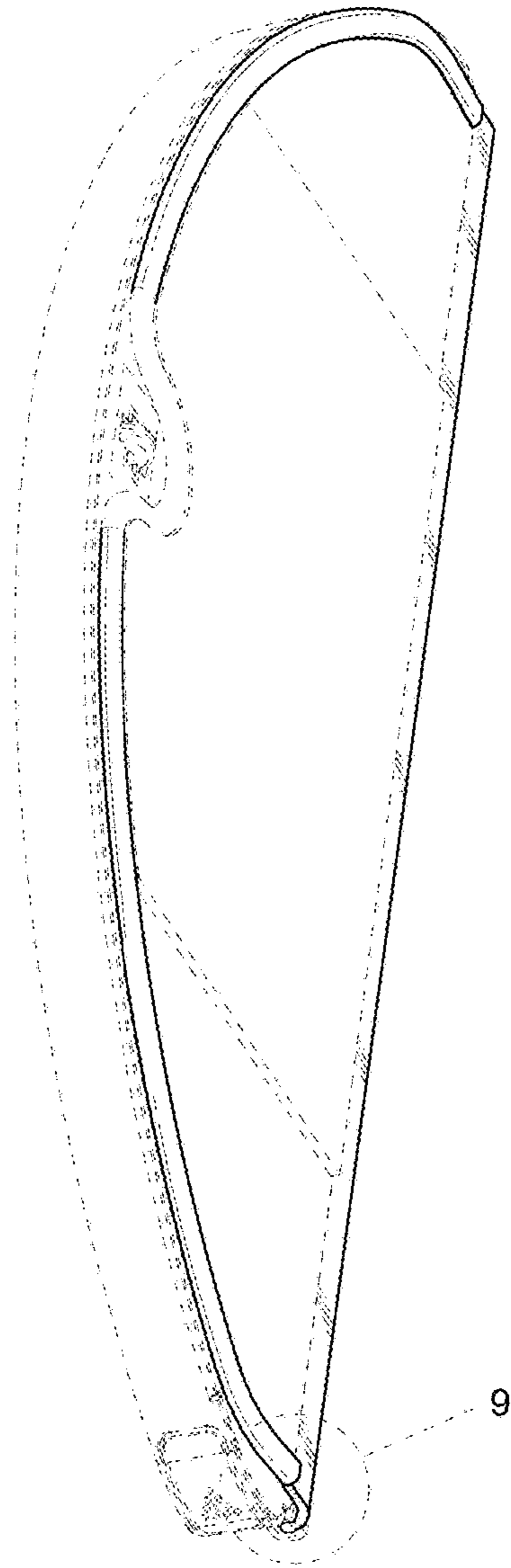

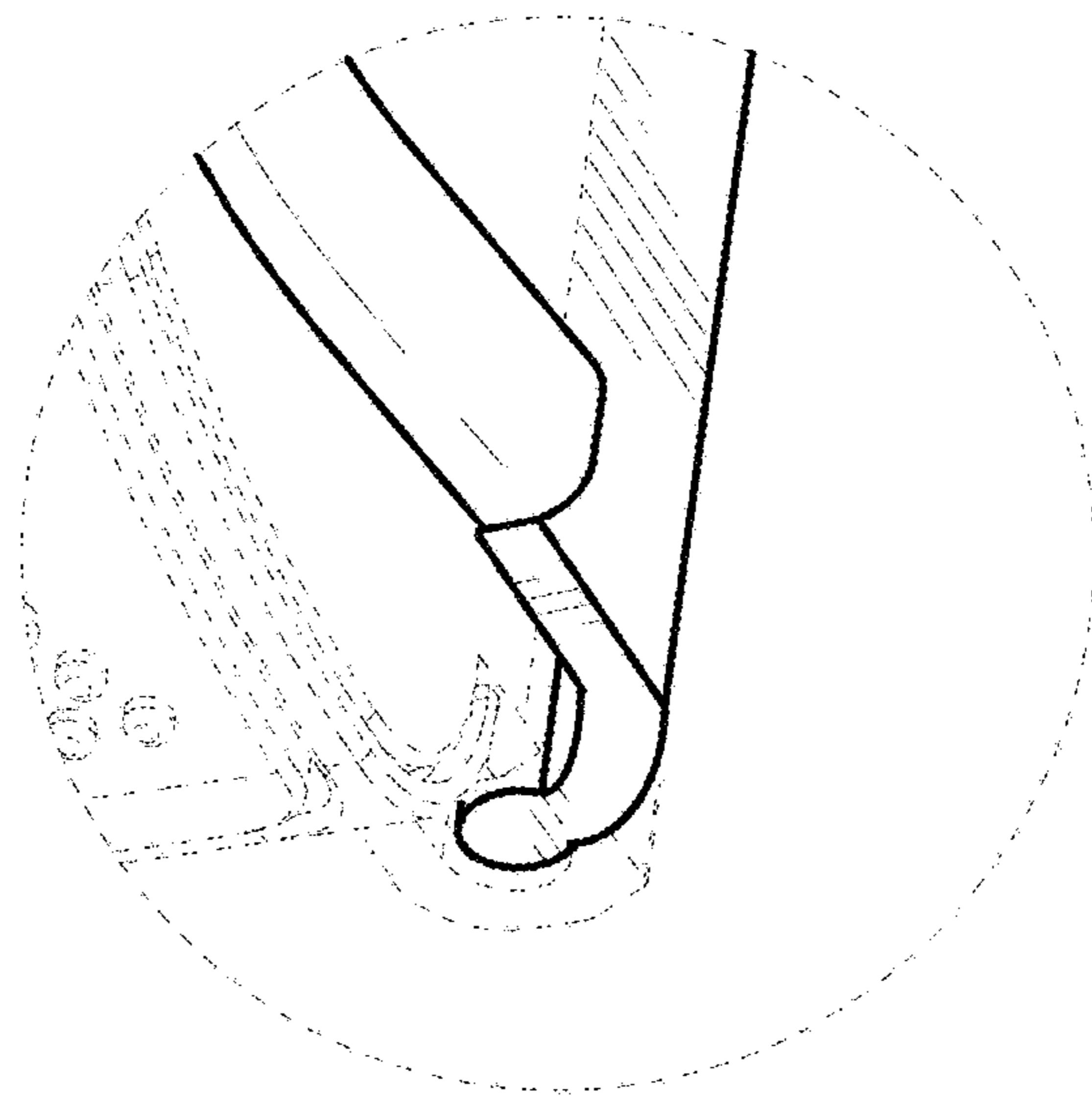

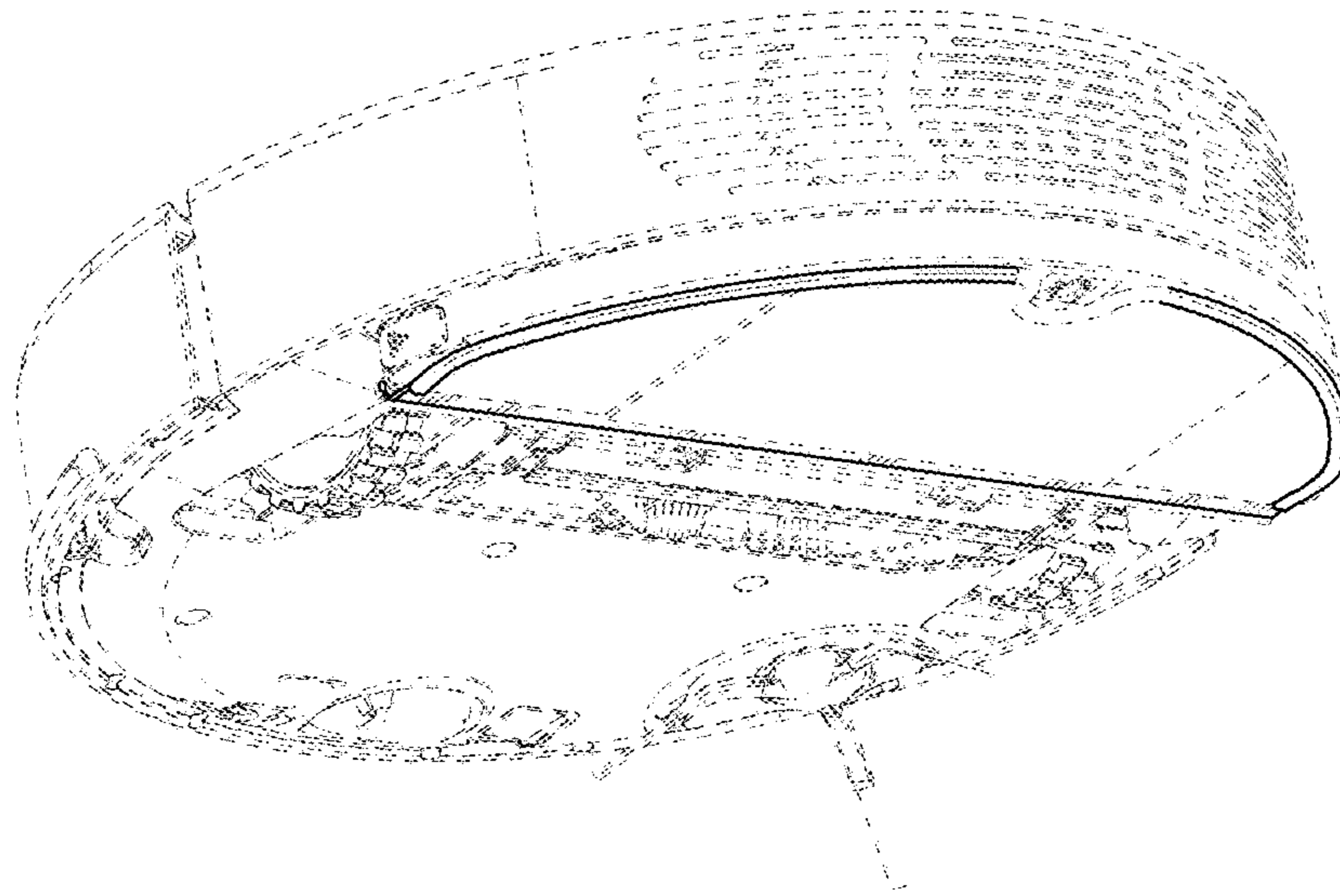
