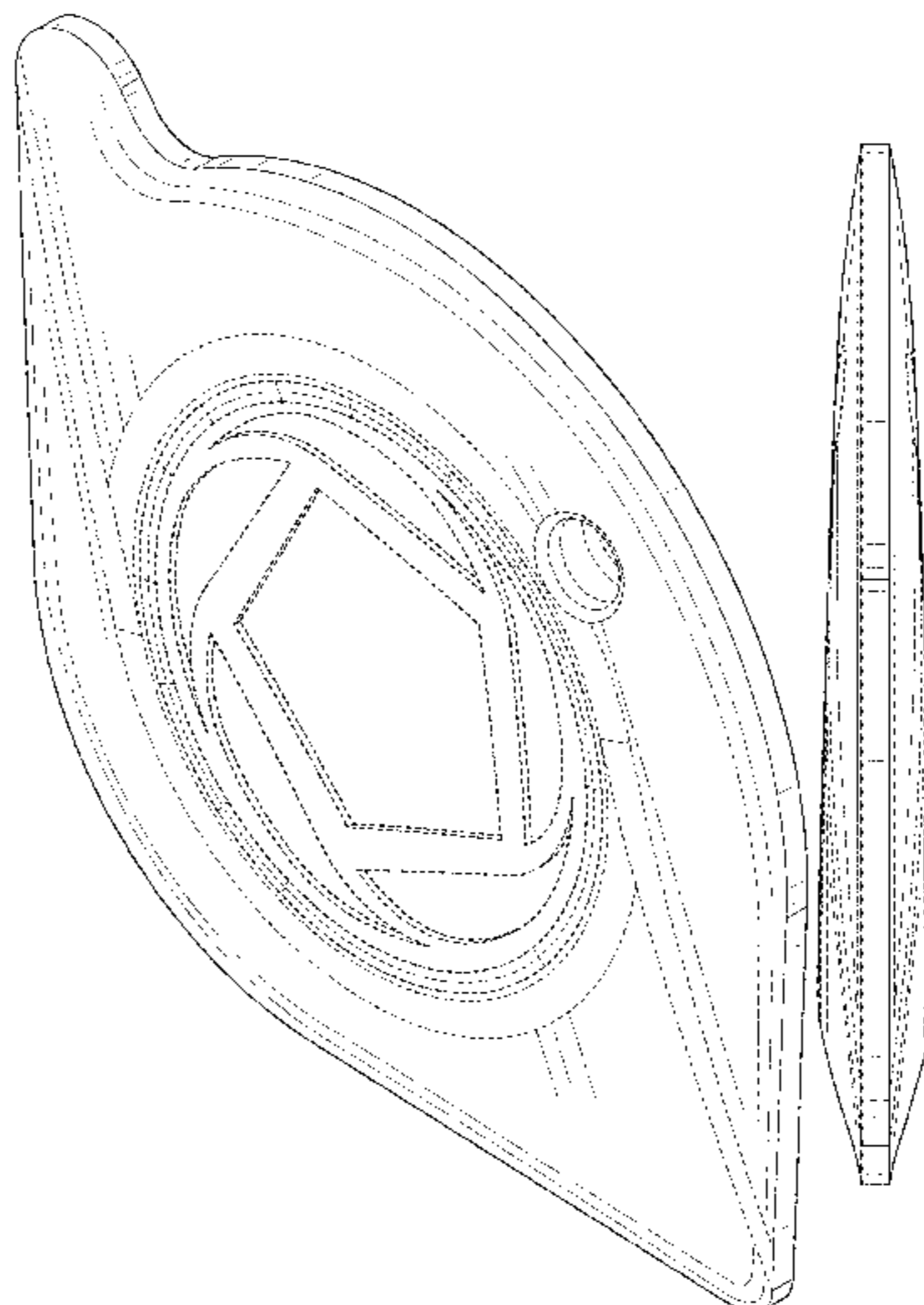
(57) **CLAIM**

The ornamental design for a scraper, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a scraper showing the design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a right elevation view thereof;
FIG. 5 is a left elevation view thereof;
FIG. 6 is a front elevation view thereof; and
FIG. 7 is a rear elevation view thereof;
FIG. 8 is a top perspective view of a second embodiment of a scraper showing the design;
FIG. 9 is a top plan view thereof;
FIG. 10 is a bottom plan view thereof;
FIG. 11 is a right elevation view thereof;
FIG. 12 is a left elevation view thereof;
FIG. 13 is a front elevation view thereof; and,
FIG. 14 is a rear elevation view thereof.

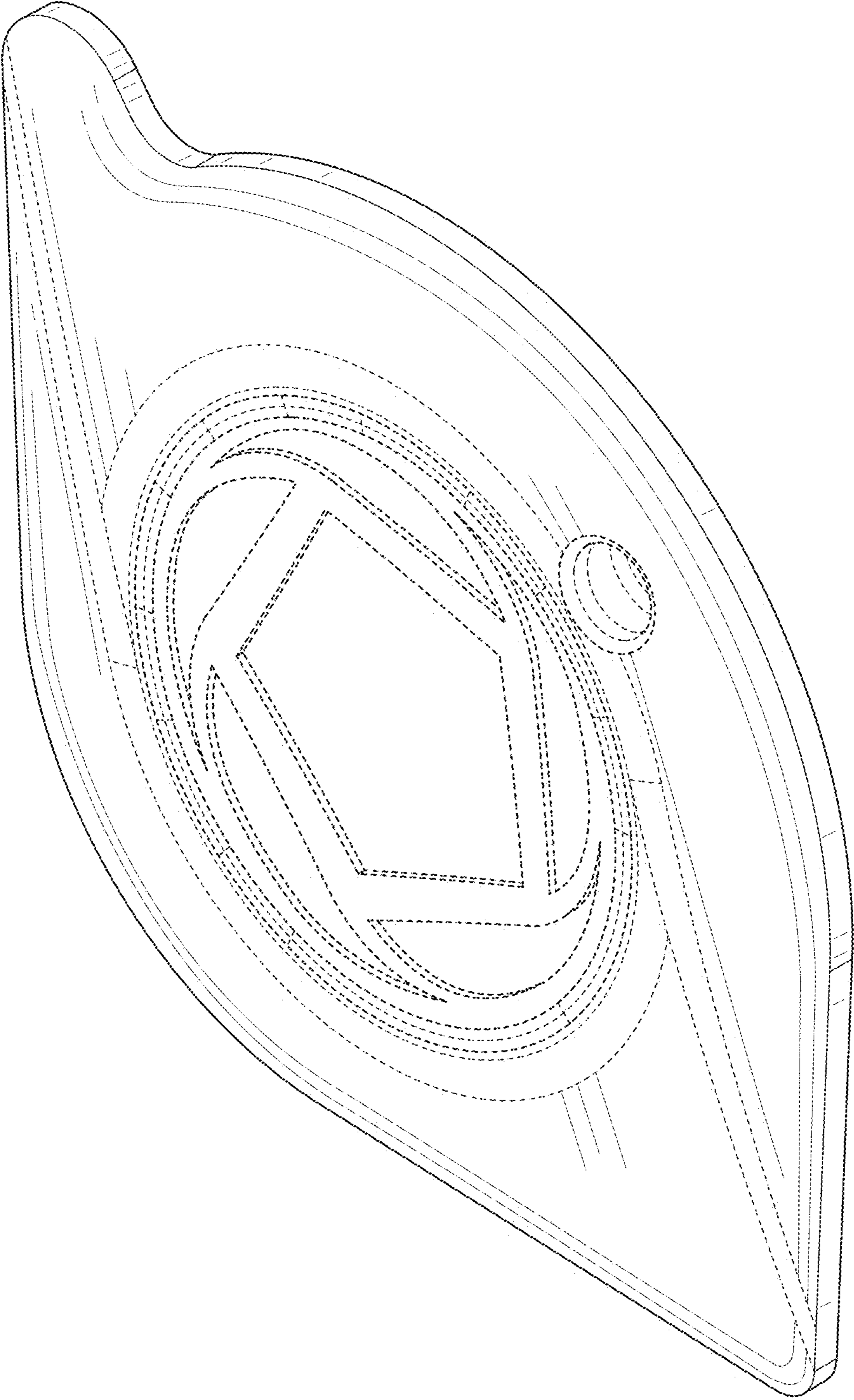

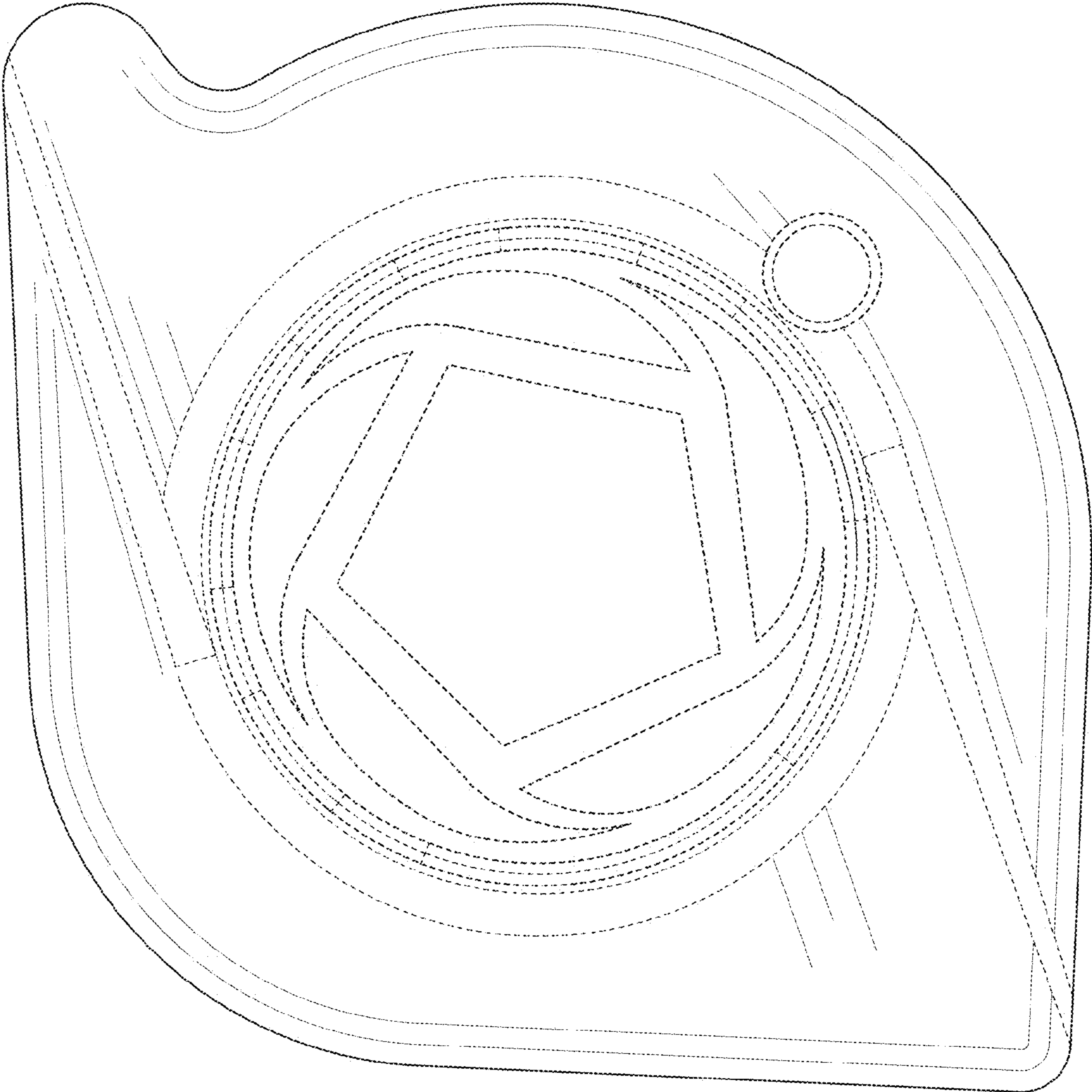

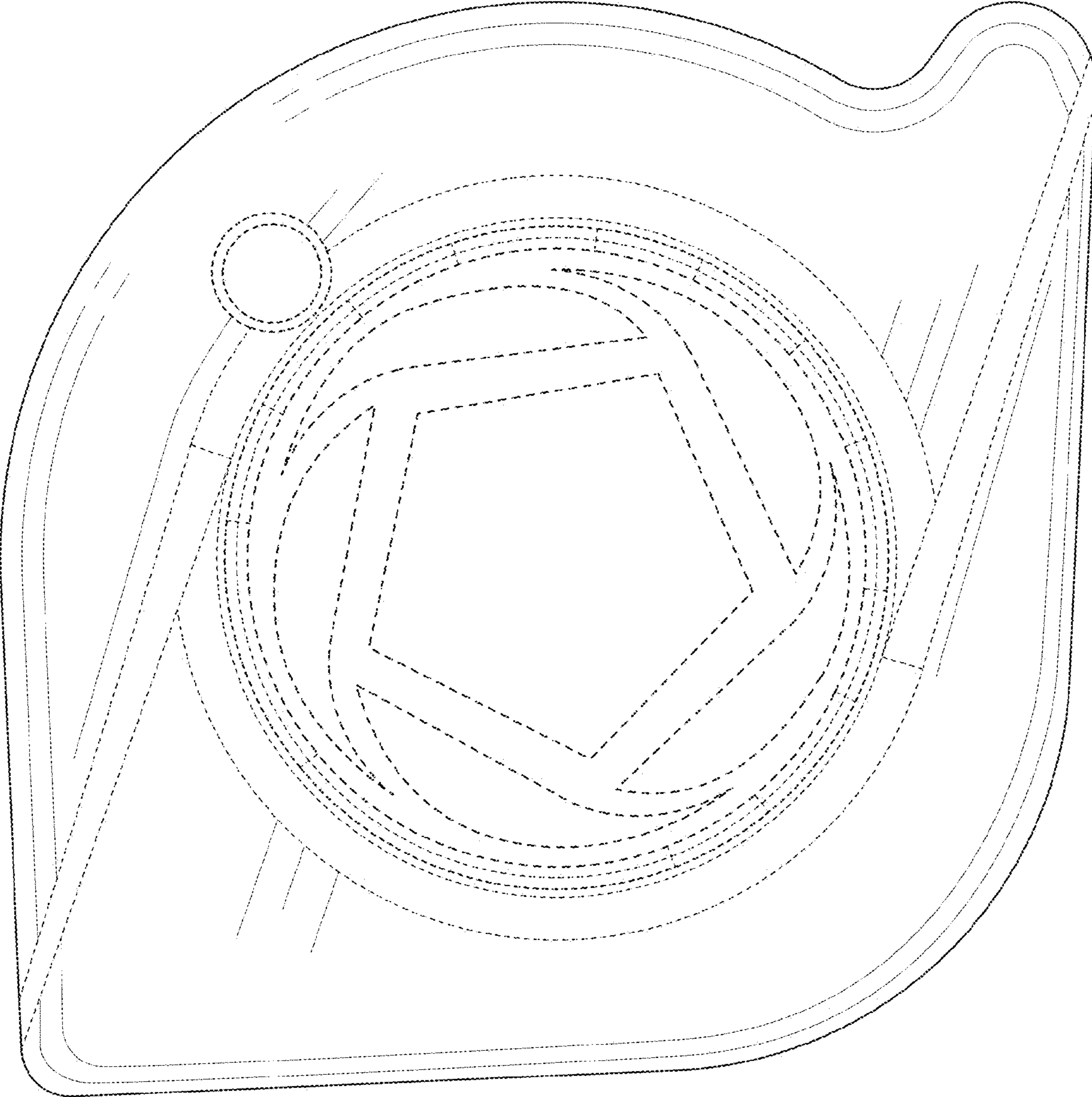

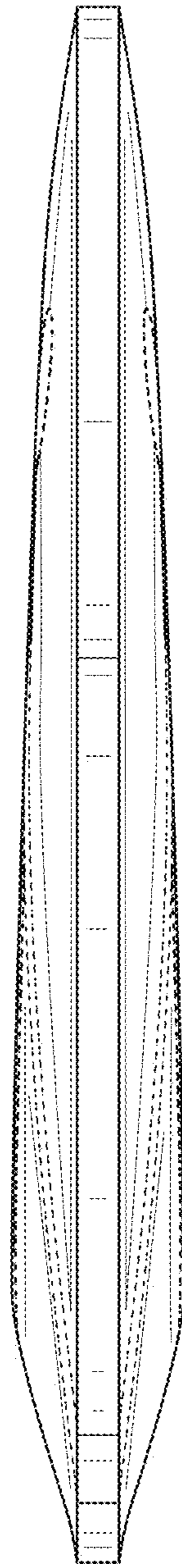

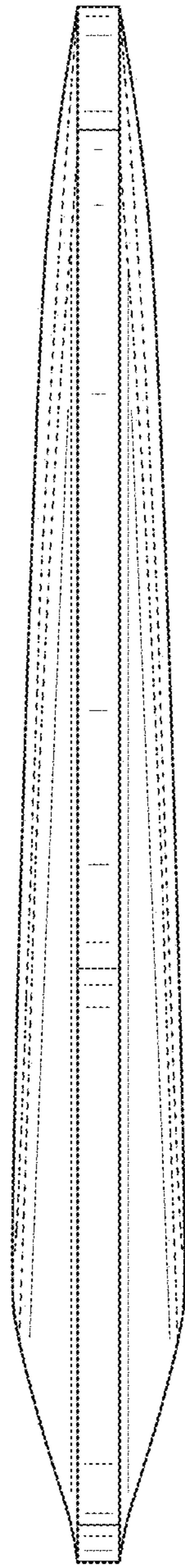

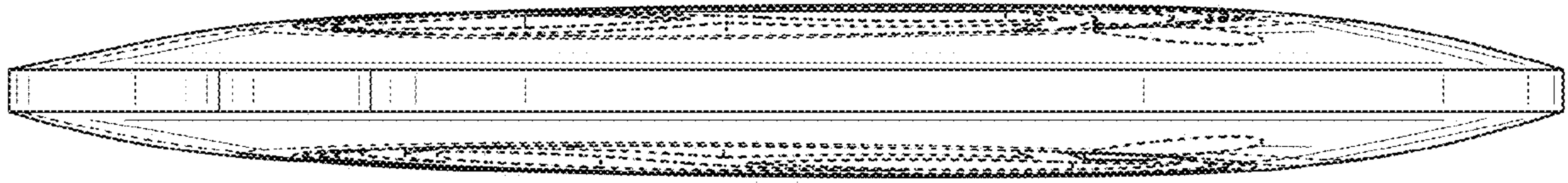

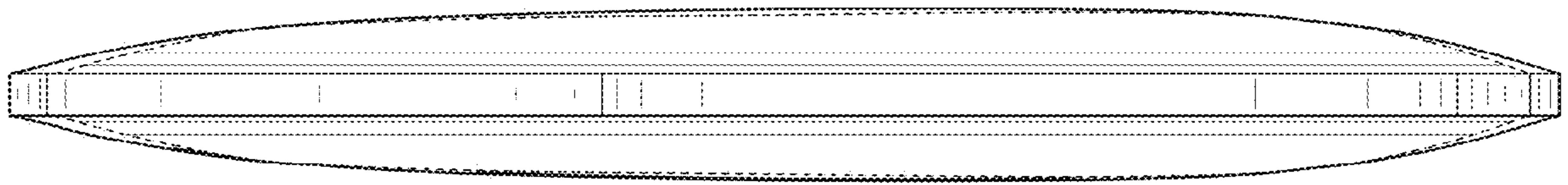

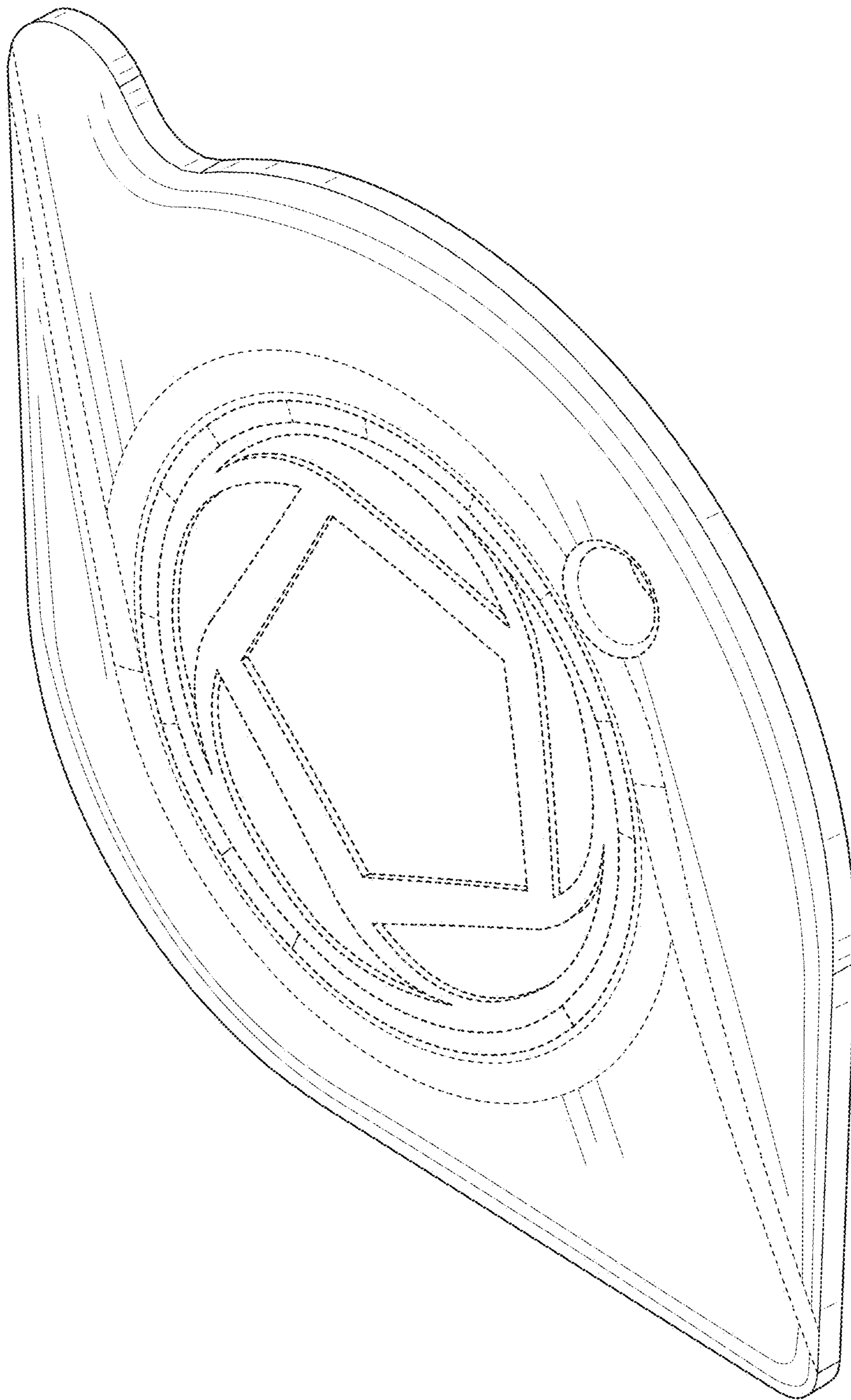

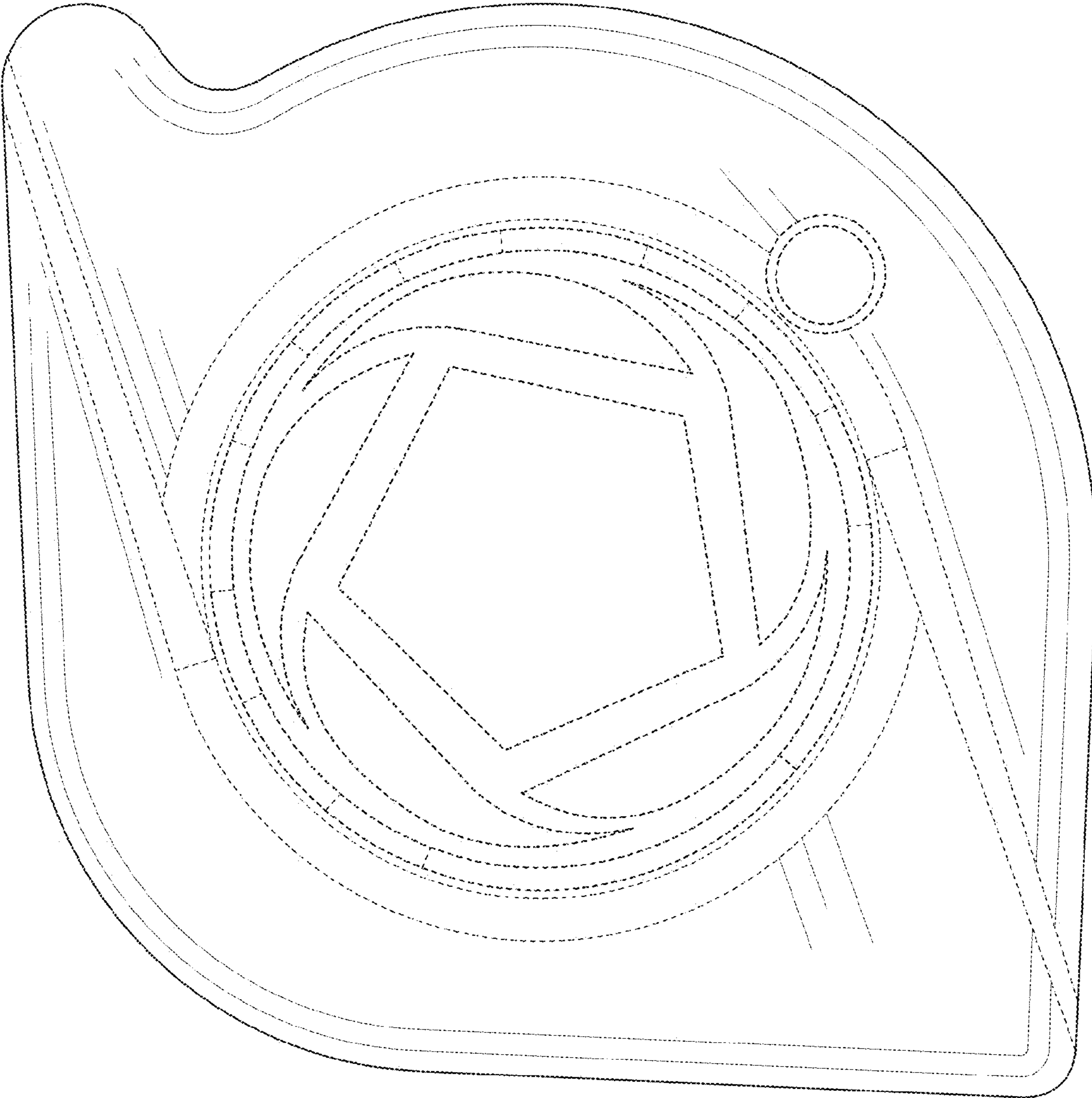

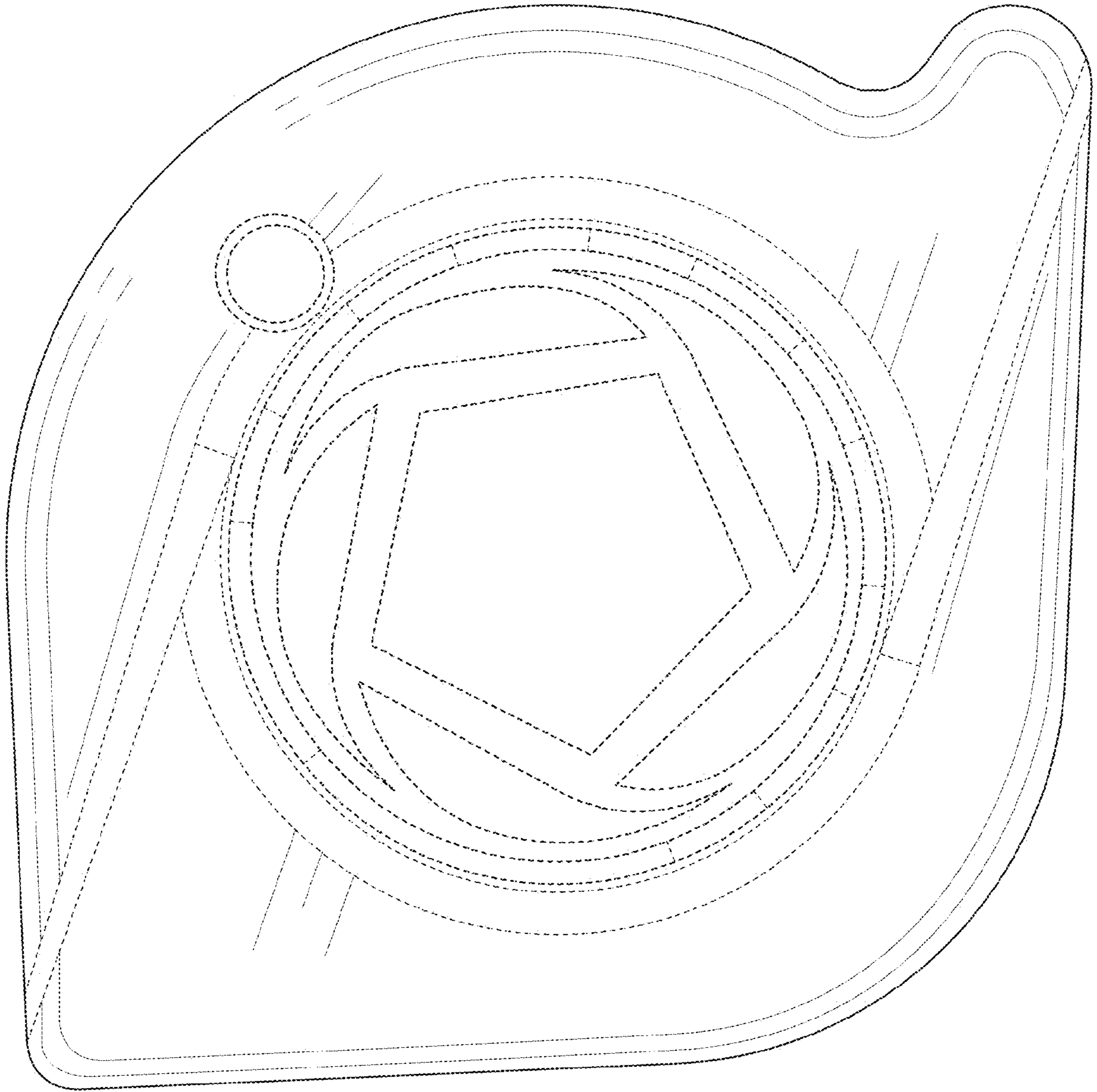

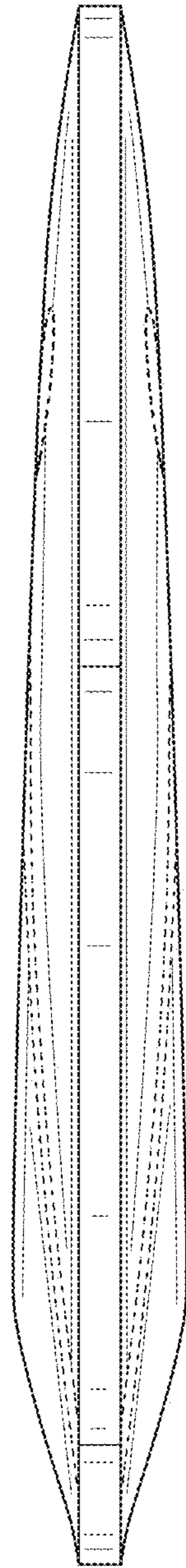

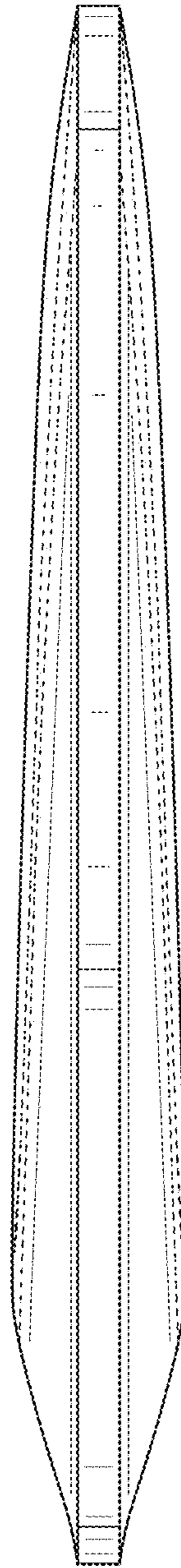

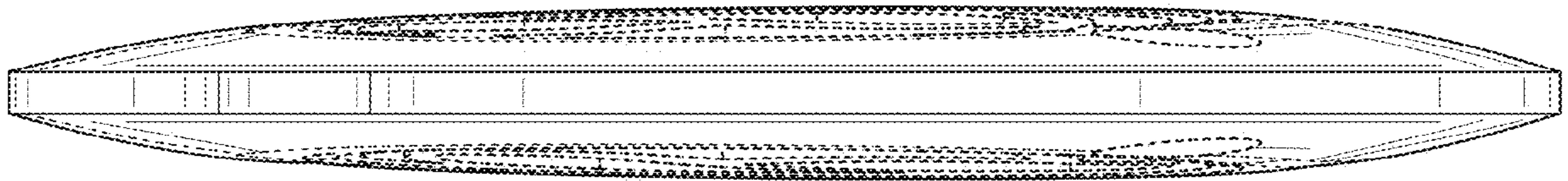

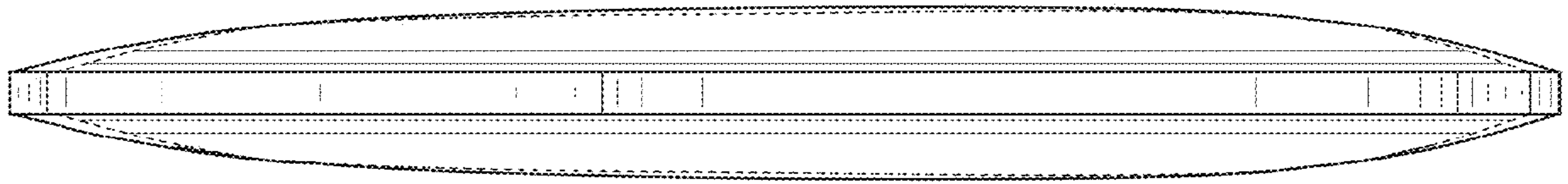
