(57) **CLAIM**

The ornamental design for a garment for applying topical medication to an upper body, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a garment for applying topical medication to an upper body according to a first embodiment of the present invention shown with environment illustrated in broken lines.

FIG. 2 is a front elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 1 in an open configuration.

FIG. 3 is a rear elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 1 in an open configuration.

FIG. 4 is a front elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 1 in a closed configuration.

FIG. 5 is a rear elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 1 in a closed configuration.

FIG. 6 is a side elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 1 in a closed configuration.

FIG. 7 is a top plan view of the garment for applying topical medication to an upper body illustrated in FIG. 1 in a closed configuration.

FIG. 8 is a bottom plan view of the garment for applying topical medication to an upper body illustrated in FIG. 1 in a closed configuration.

FIG. 9 is a perspective view of a garment for applying topical medication to an upper body according to a second embodiment of the present invention shown with environment illustrated in broken lines.

FIG. 10 is a front elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 9 in an open configuration.

FIG. 11 is a front elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 9 in a closed configuration.

FIG. 12 is a rear elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 9 in an open configuration.

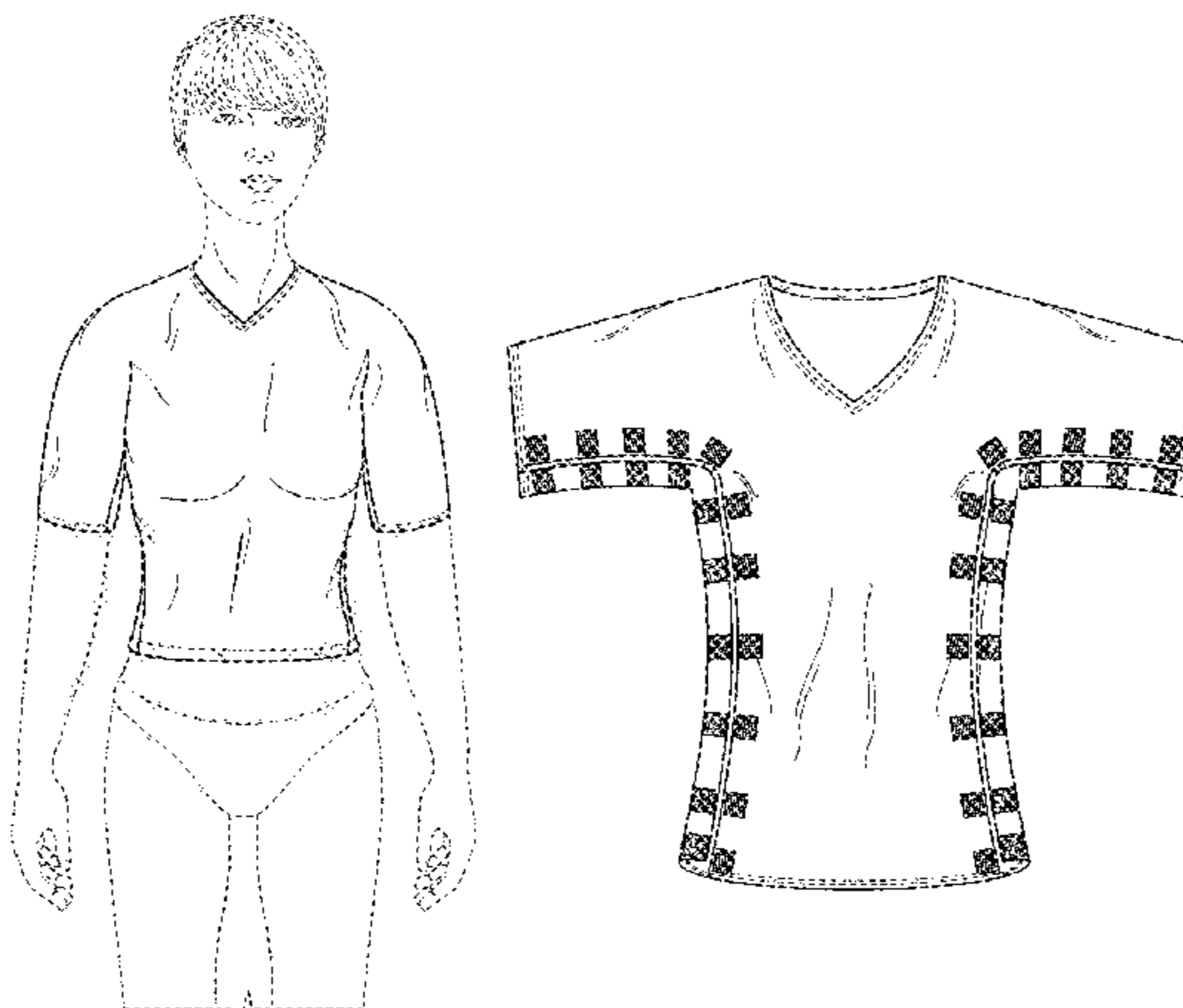


FIG. 13 is a rear elevation view of the garment for applying topical medication to an upper body illustrated in FIG. 9 in a closed configuration.

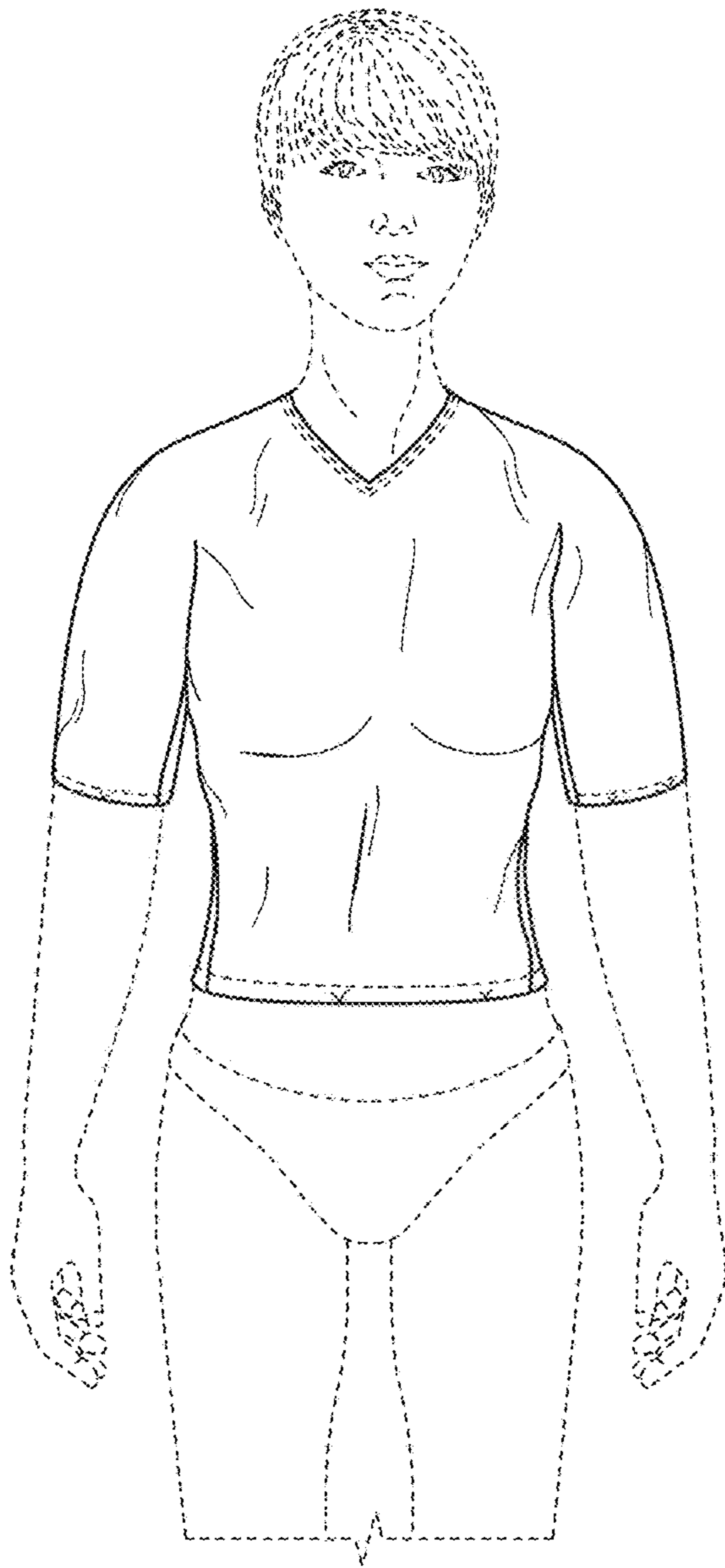

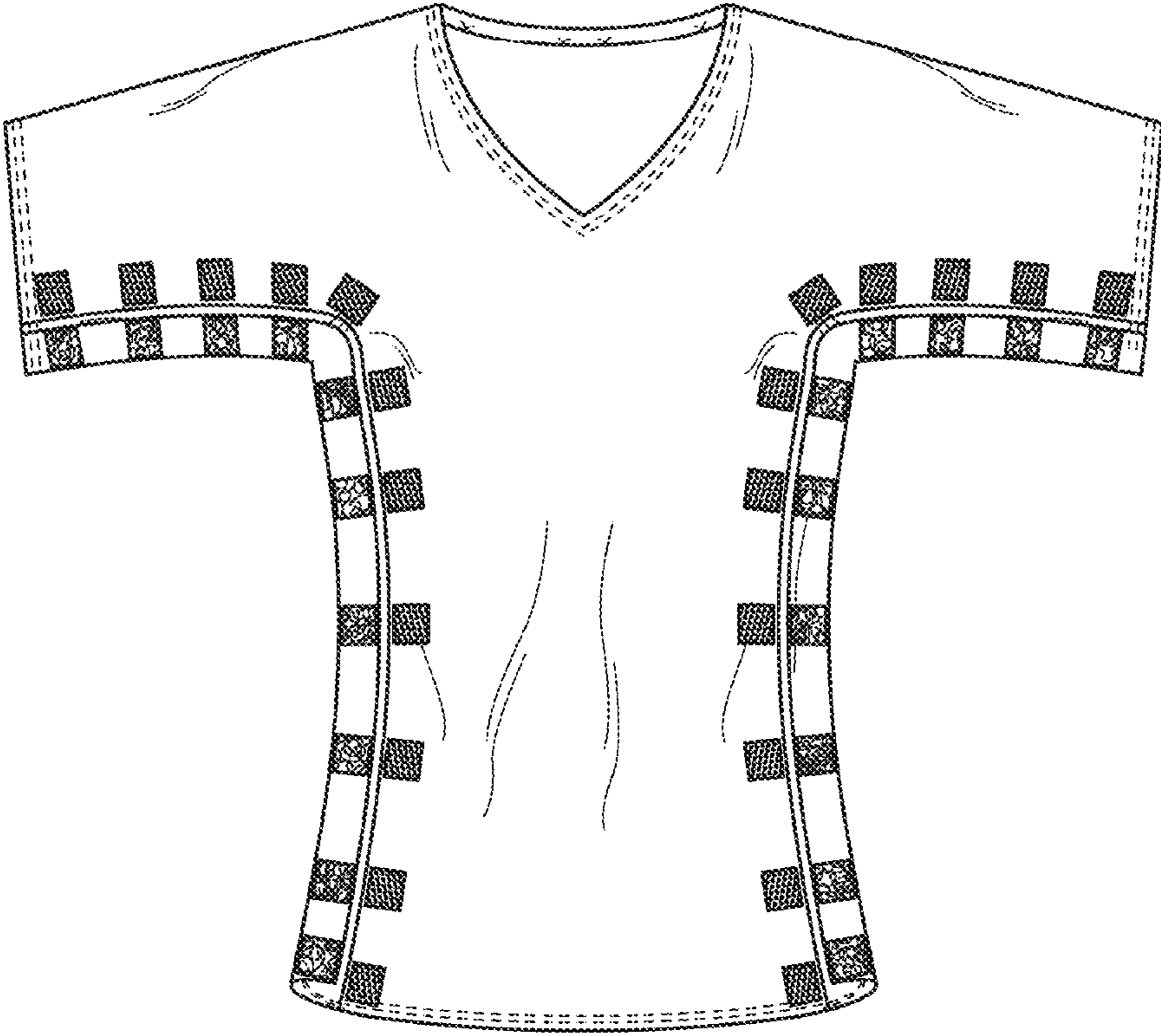

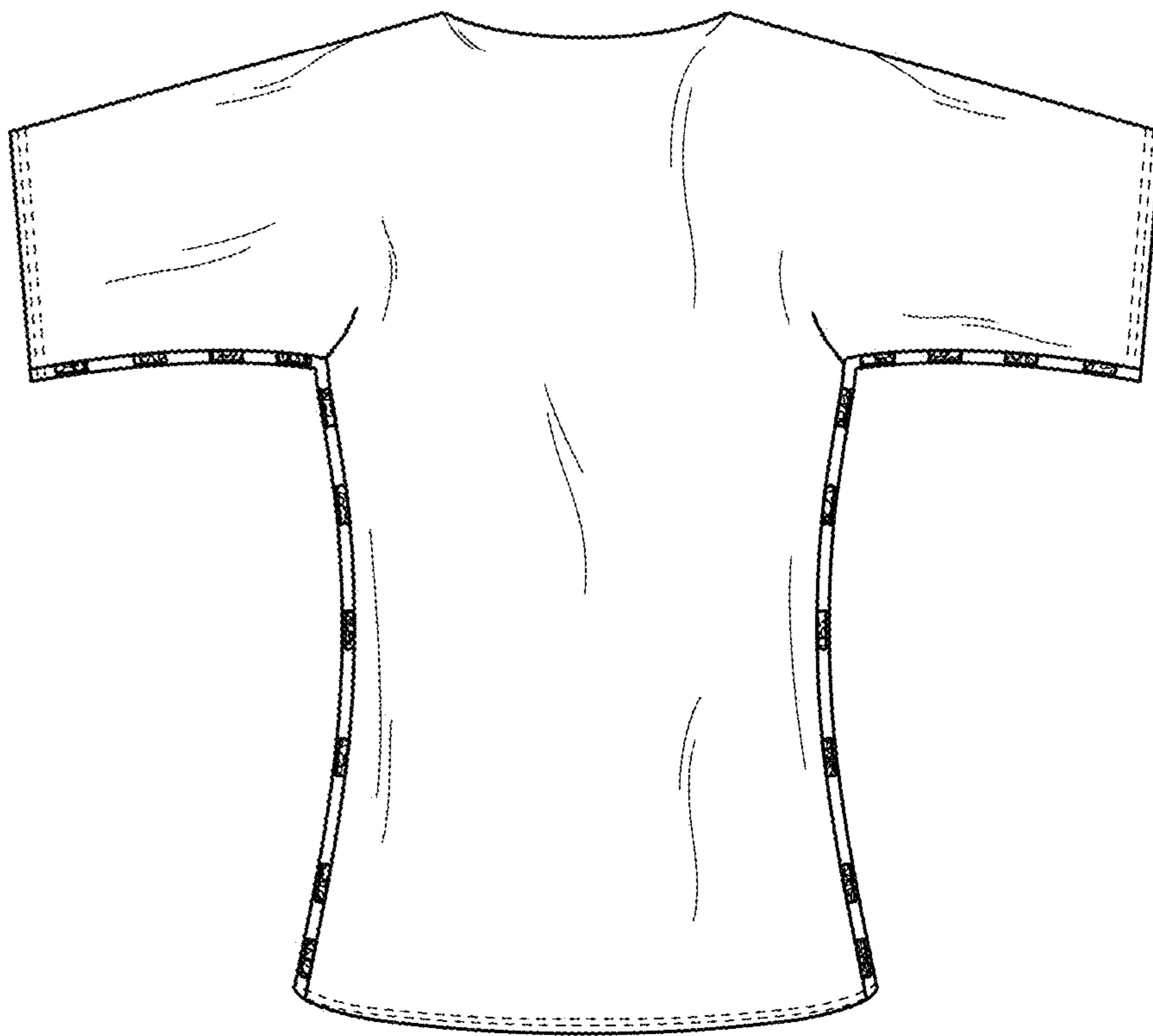

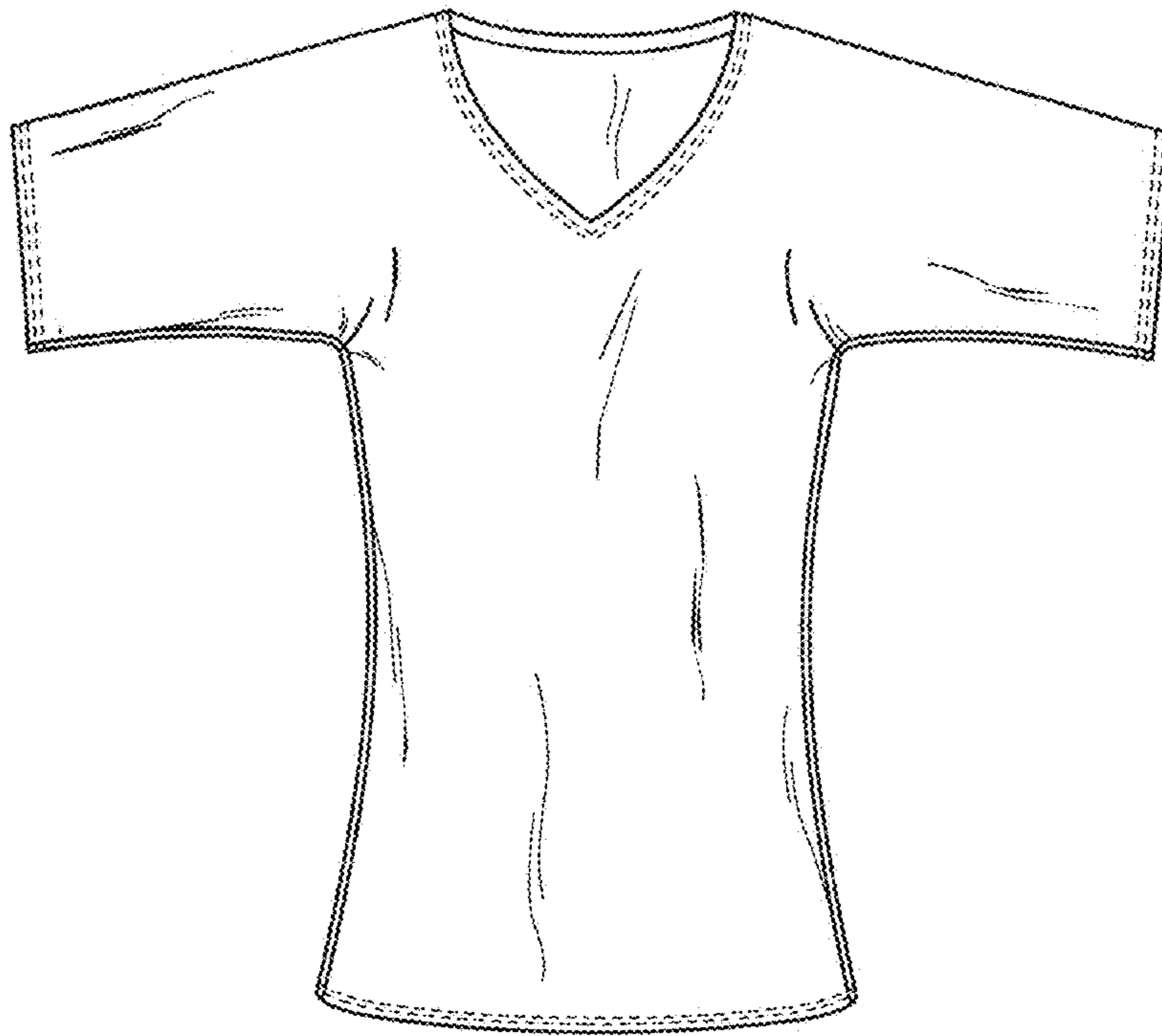

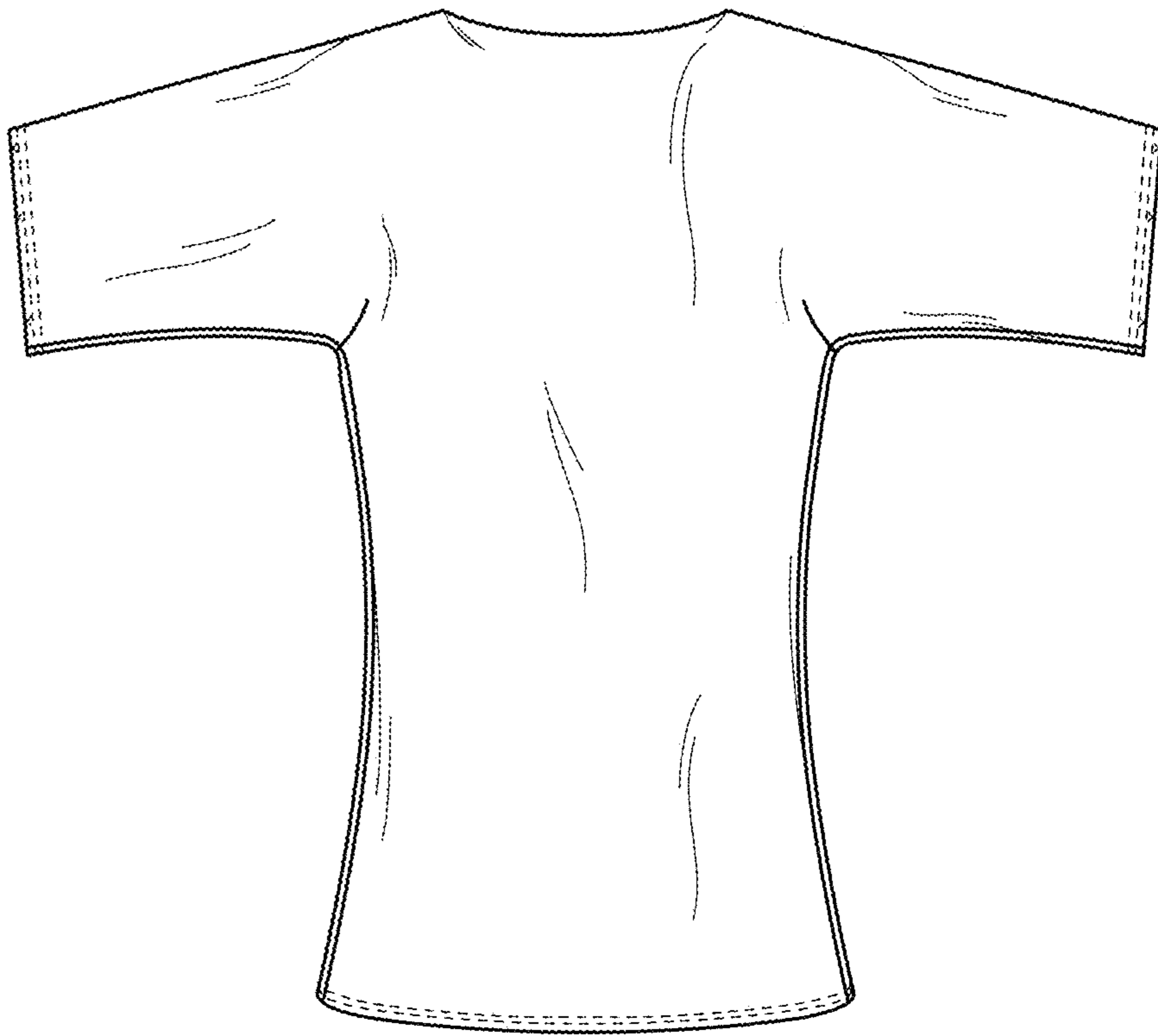

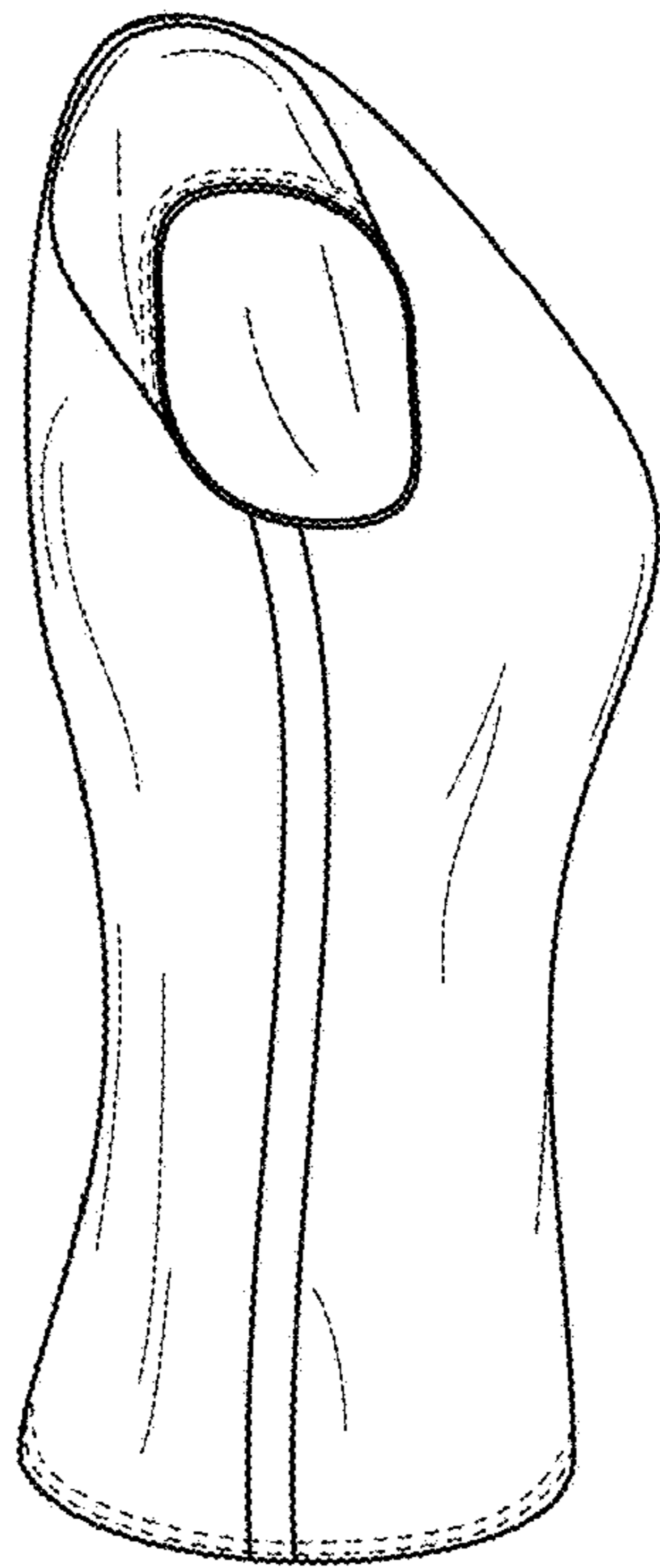

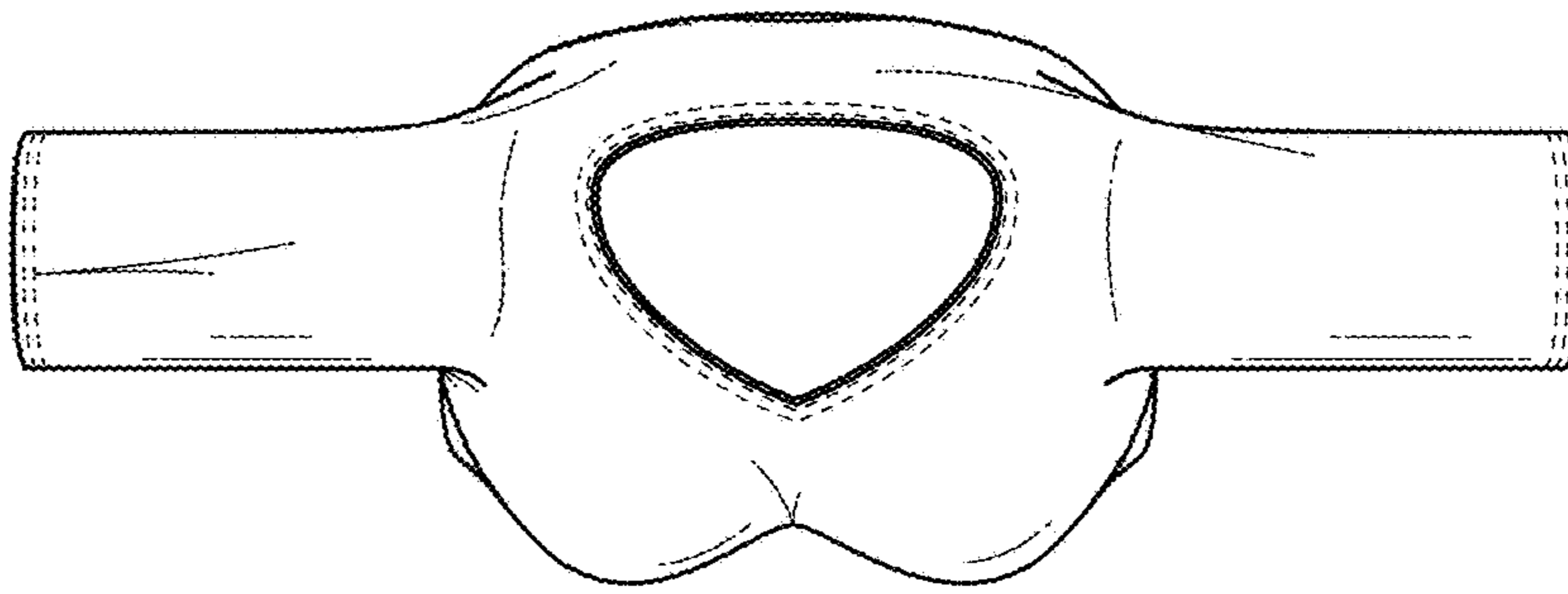

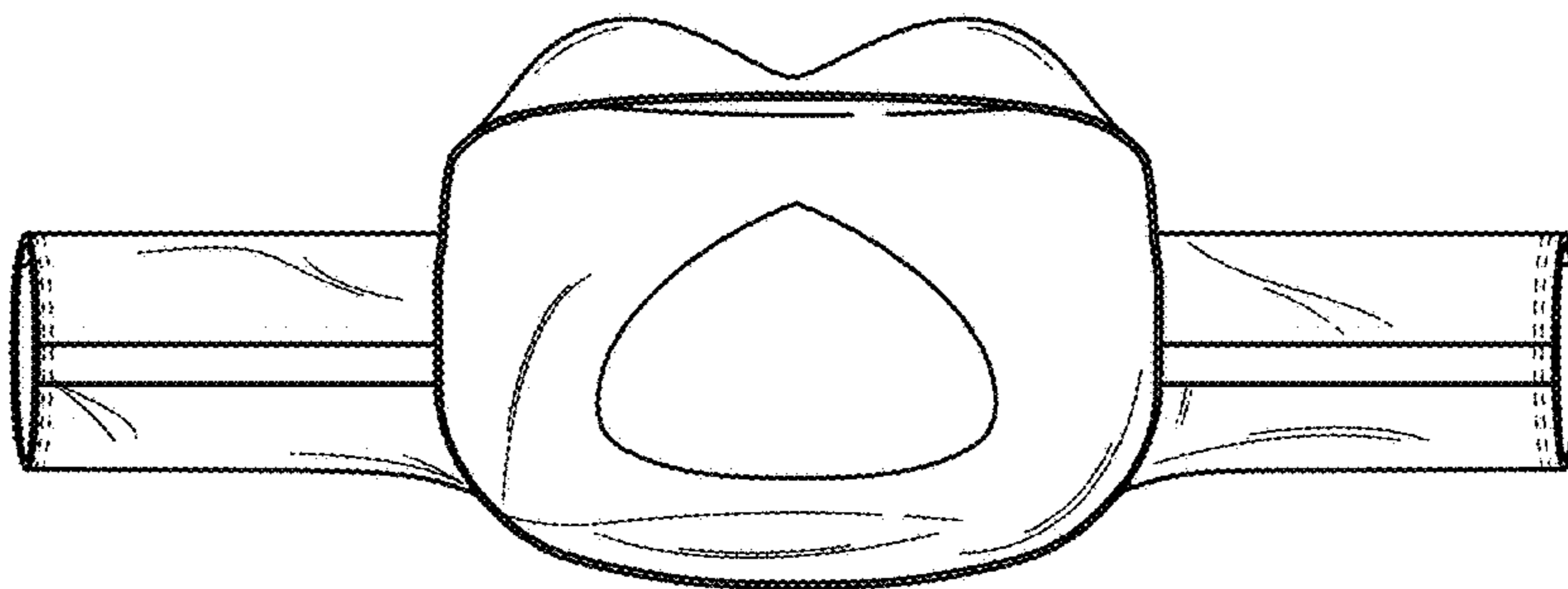

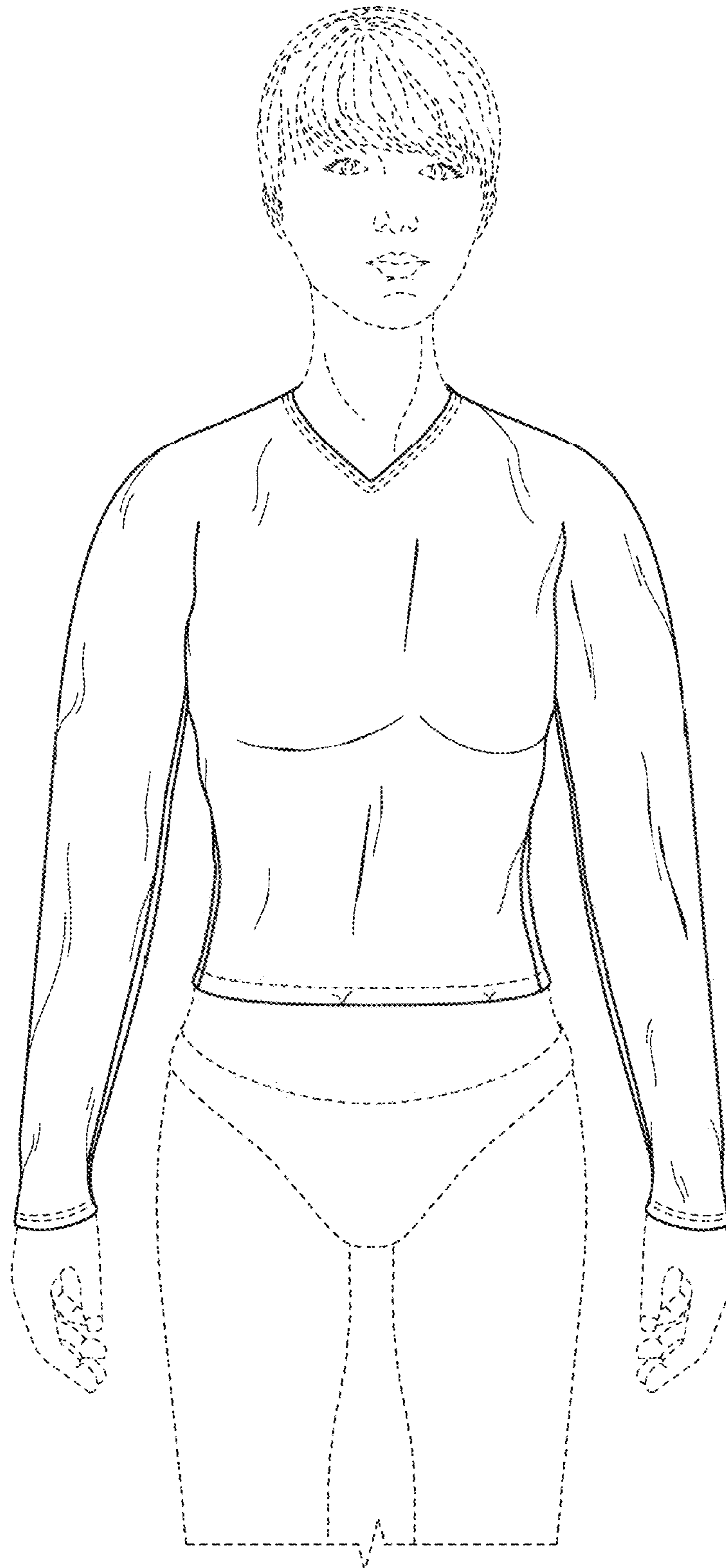

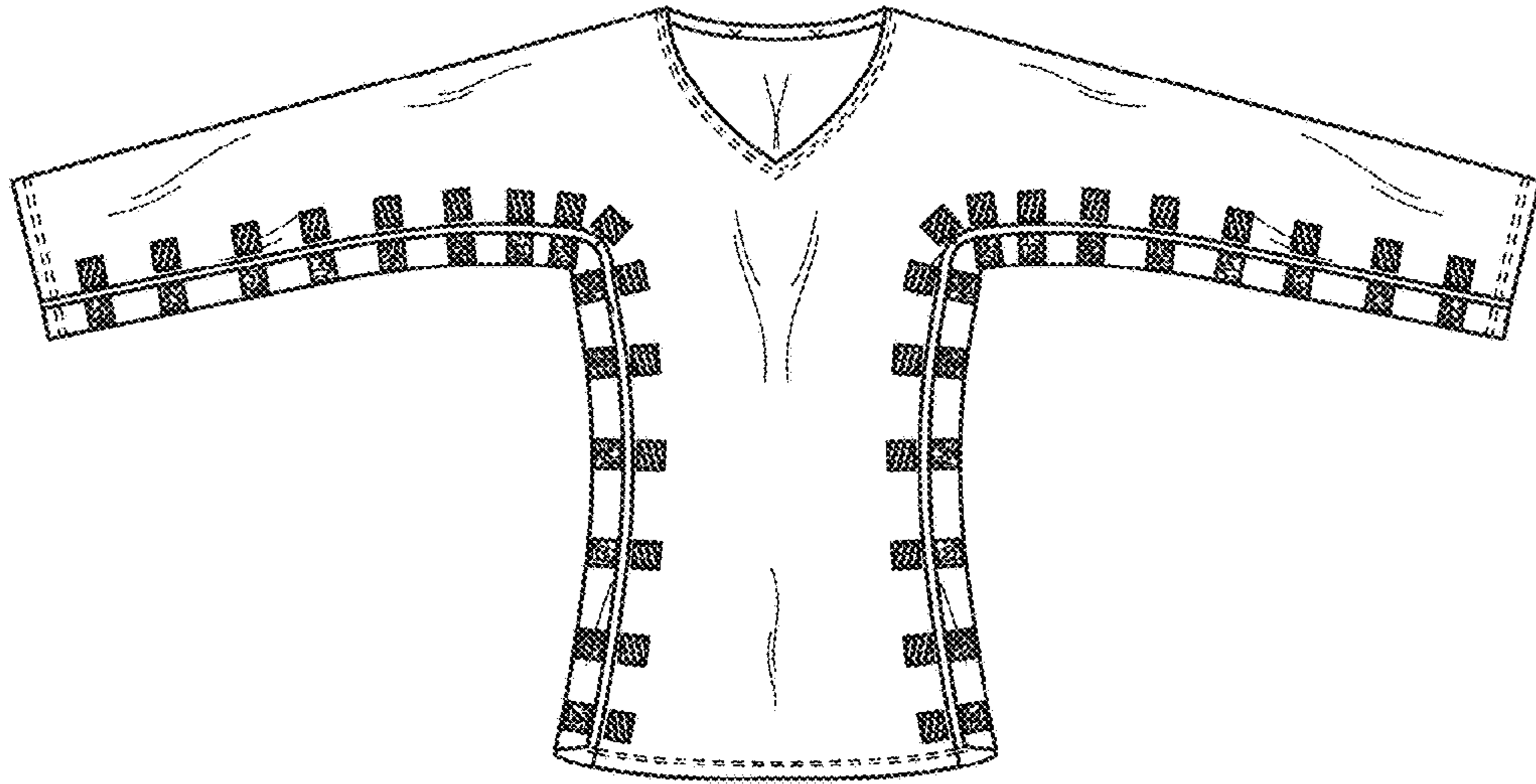

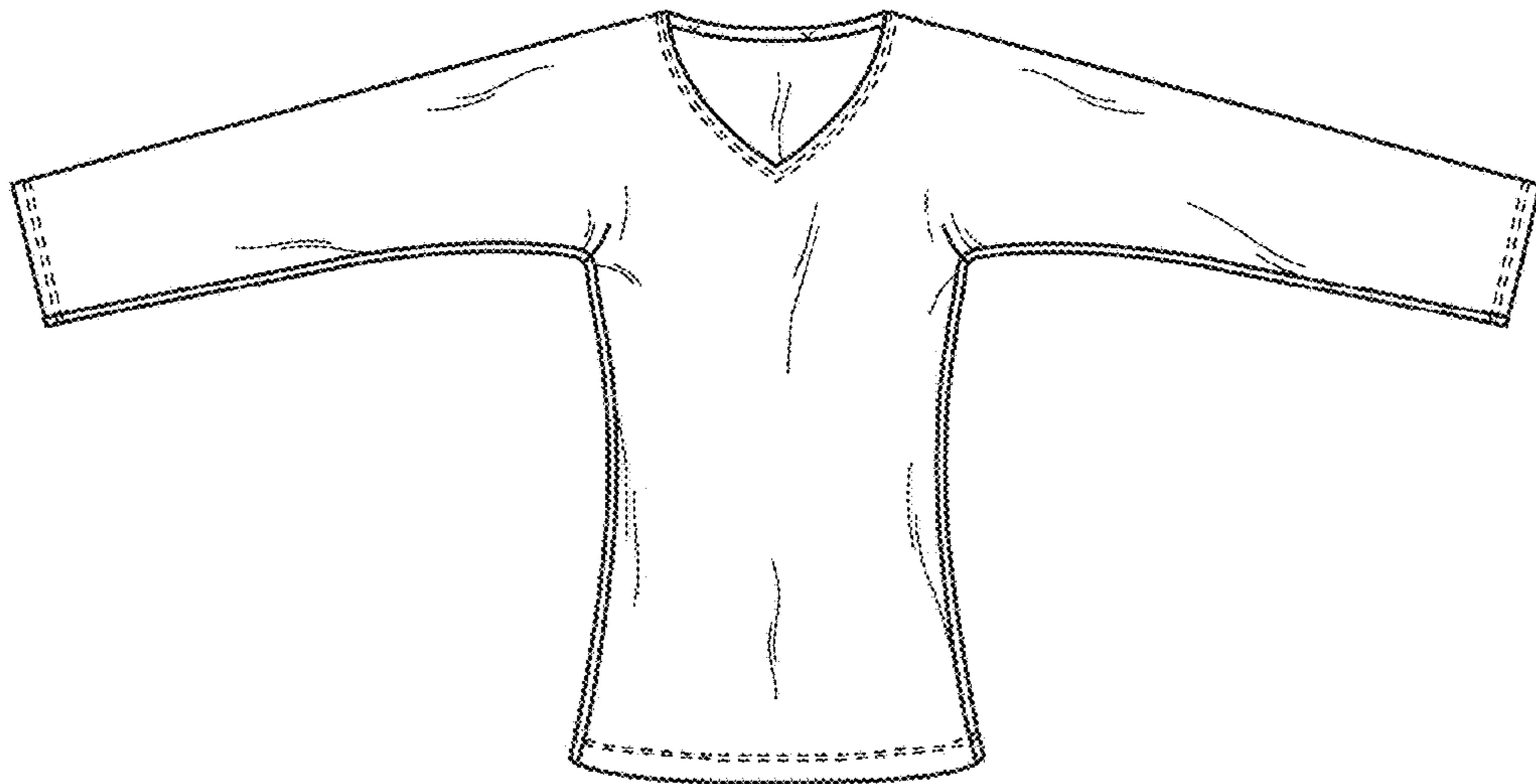

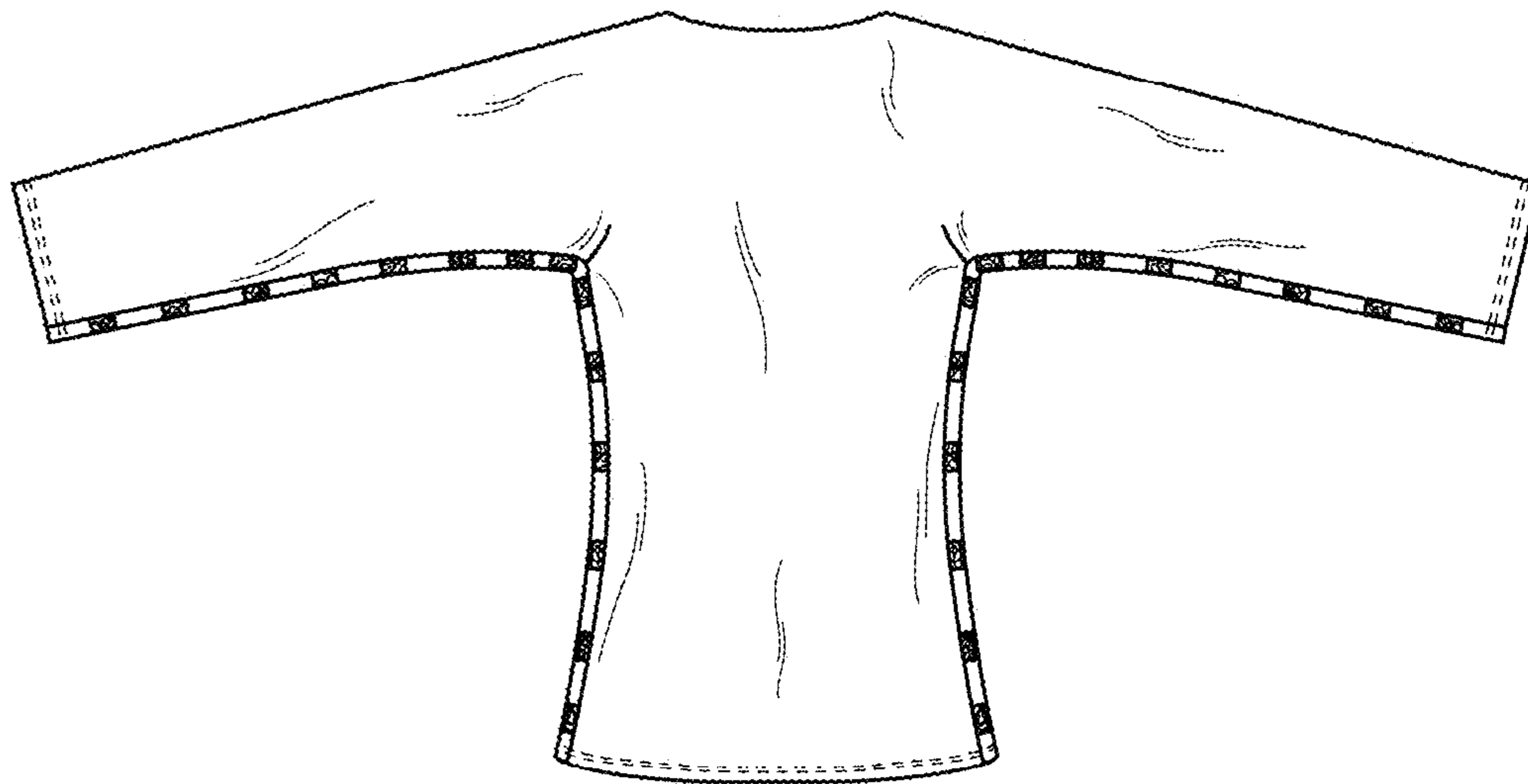

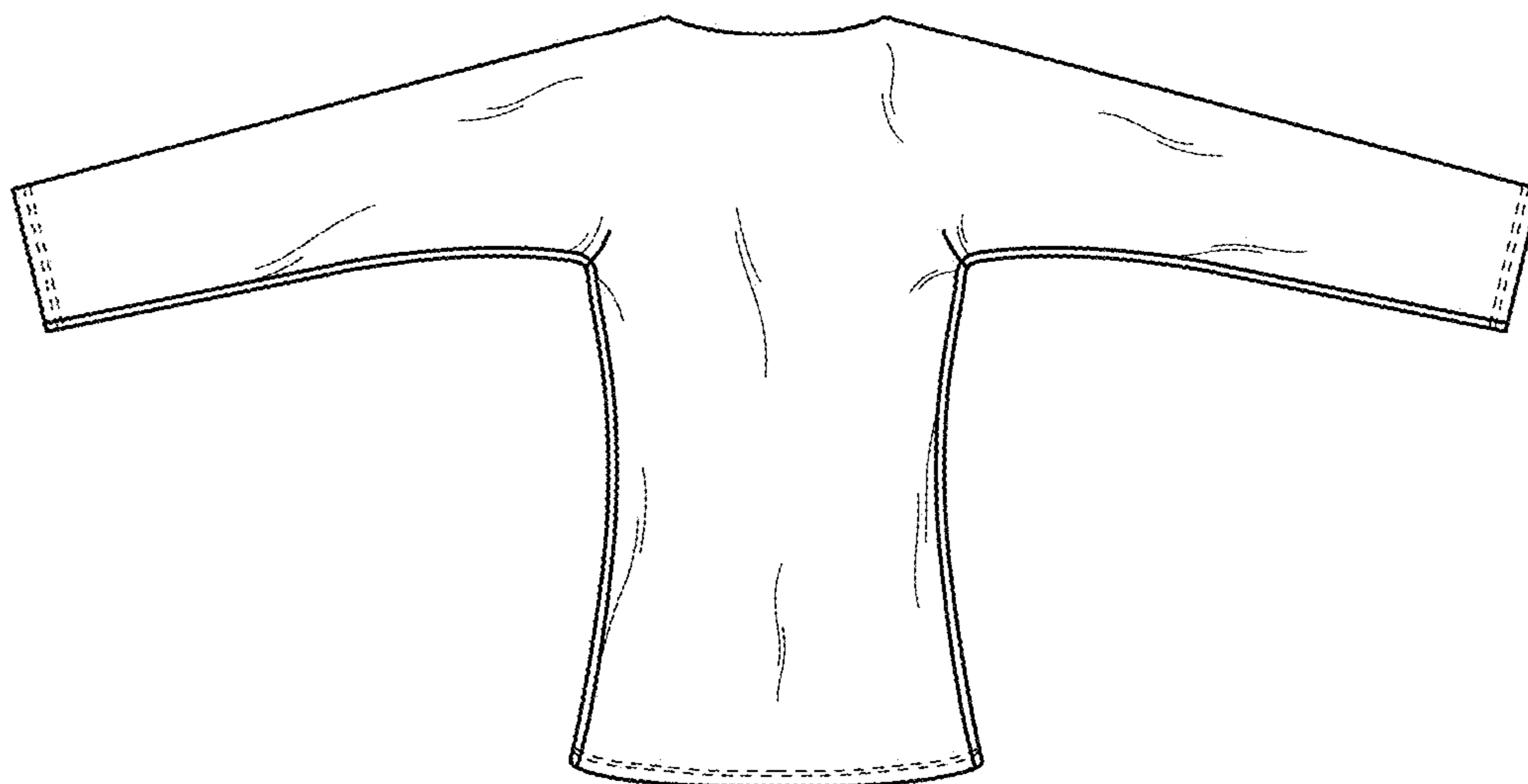

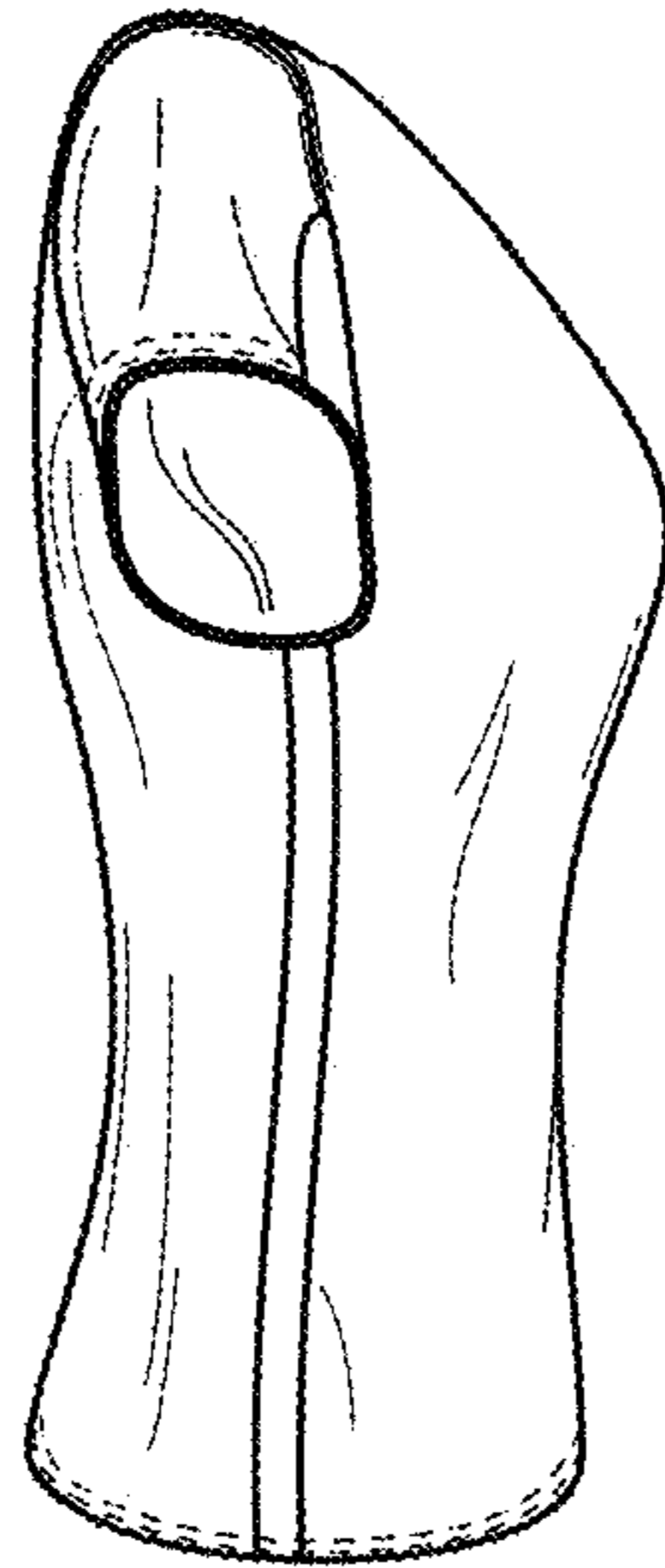

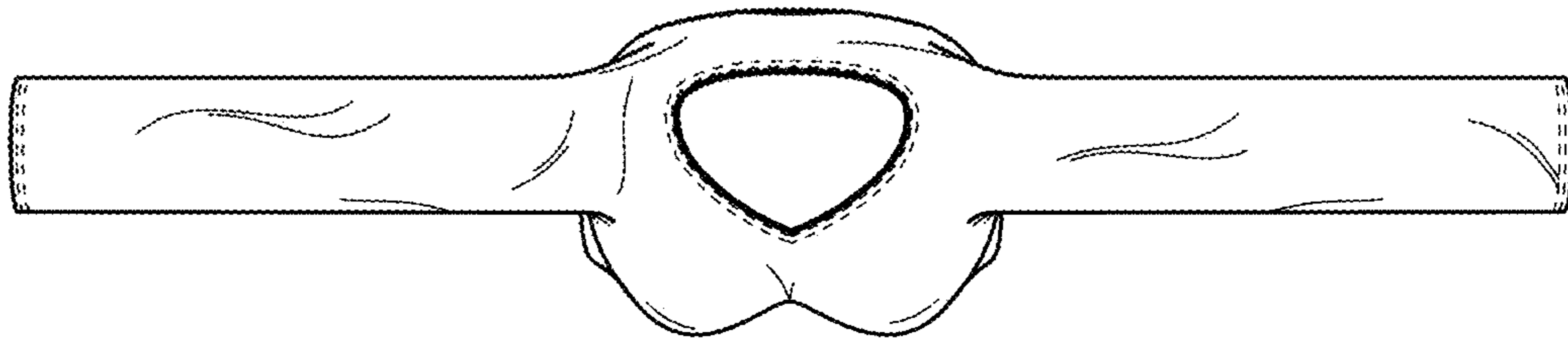

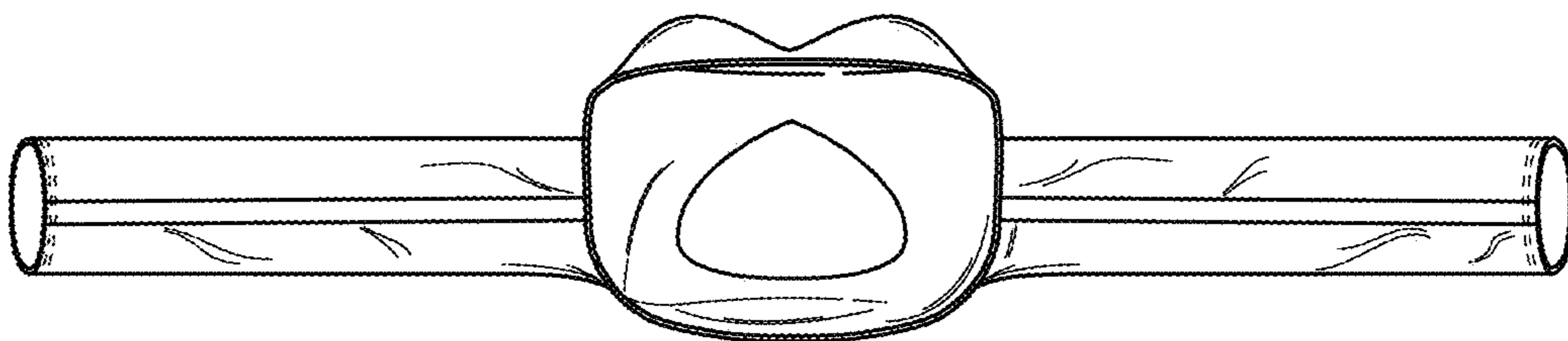
