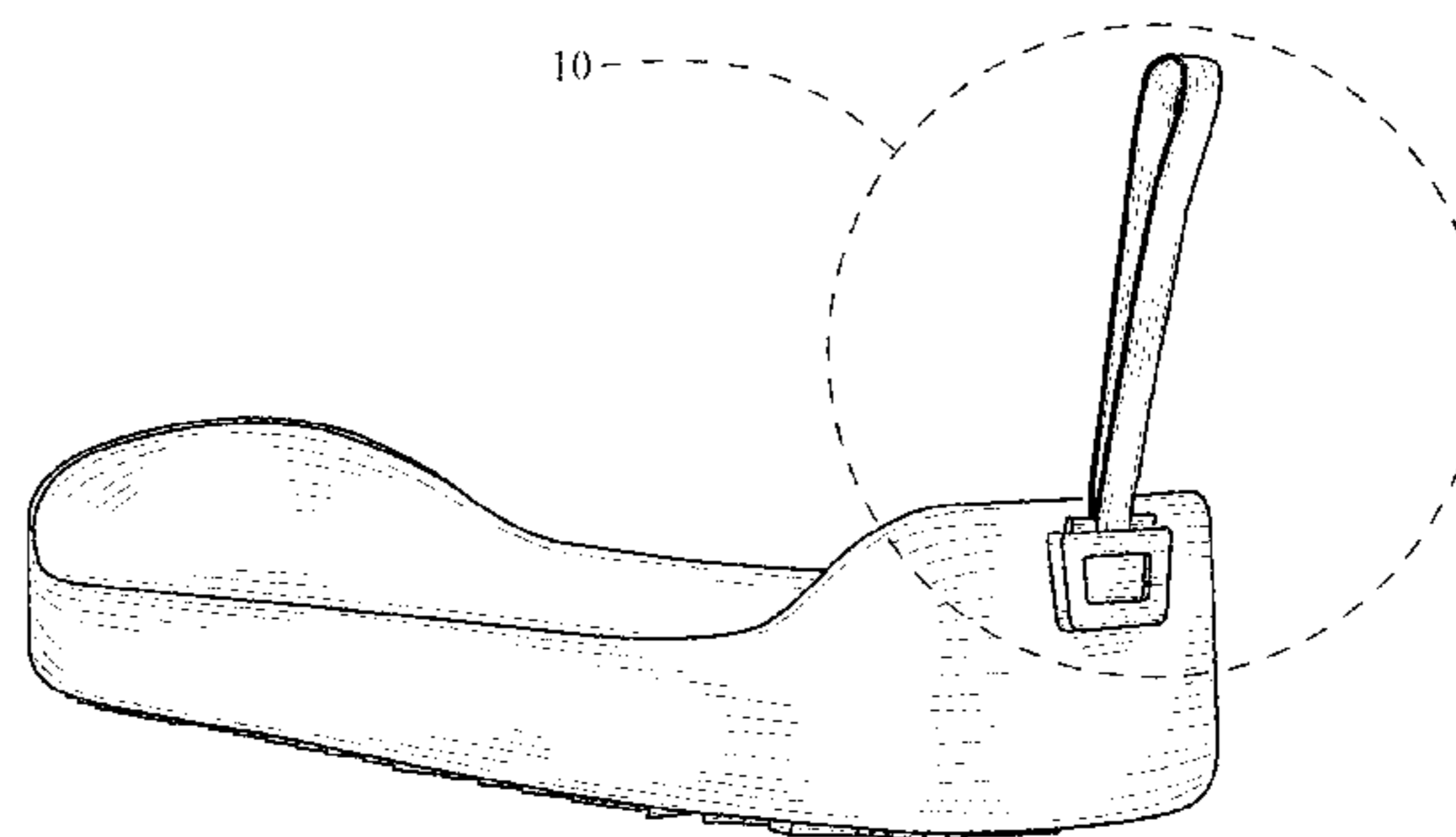
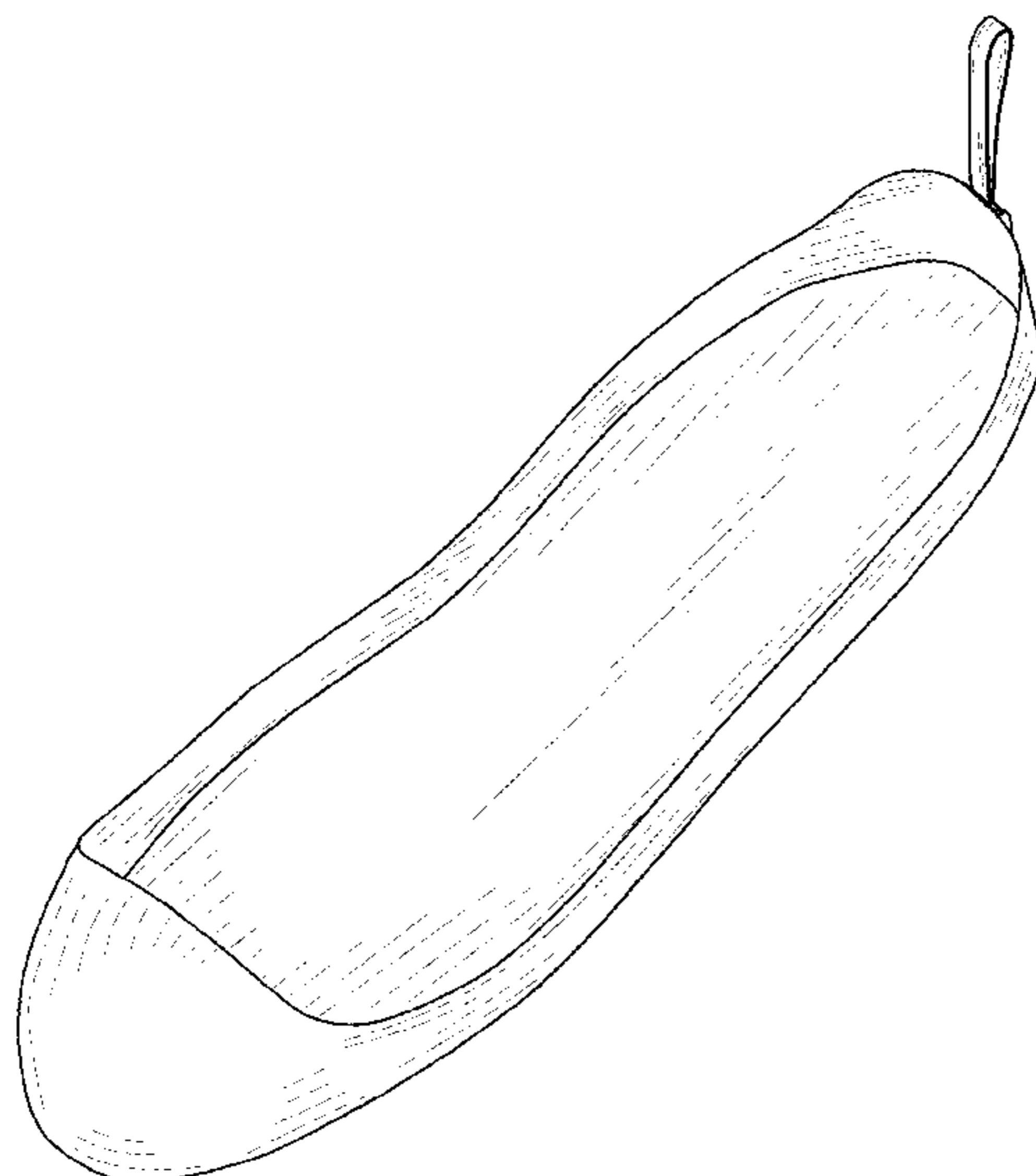
The ornamental design for a shoe cover, as shown and described.

DESCRIPTION

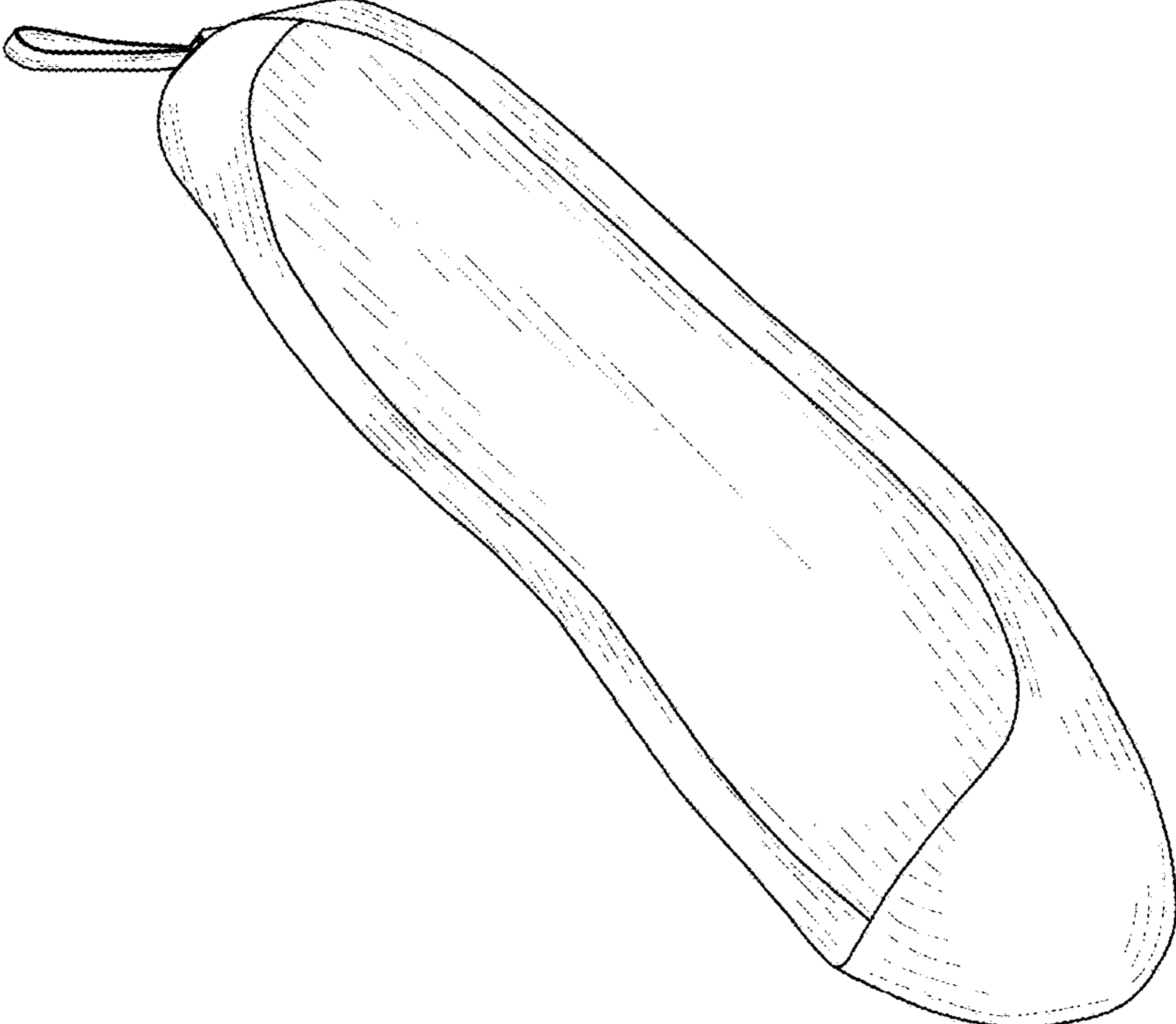

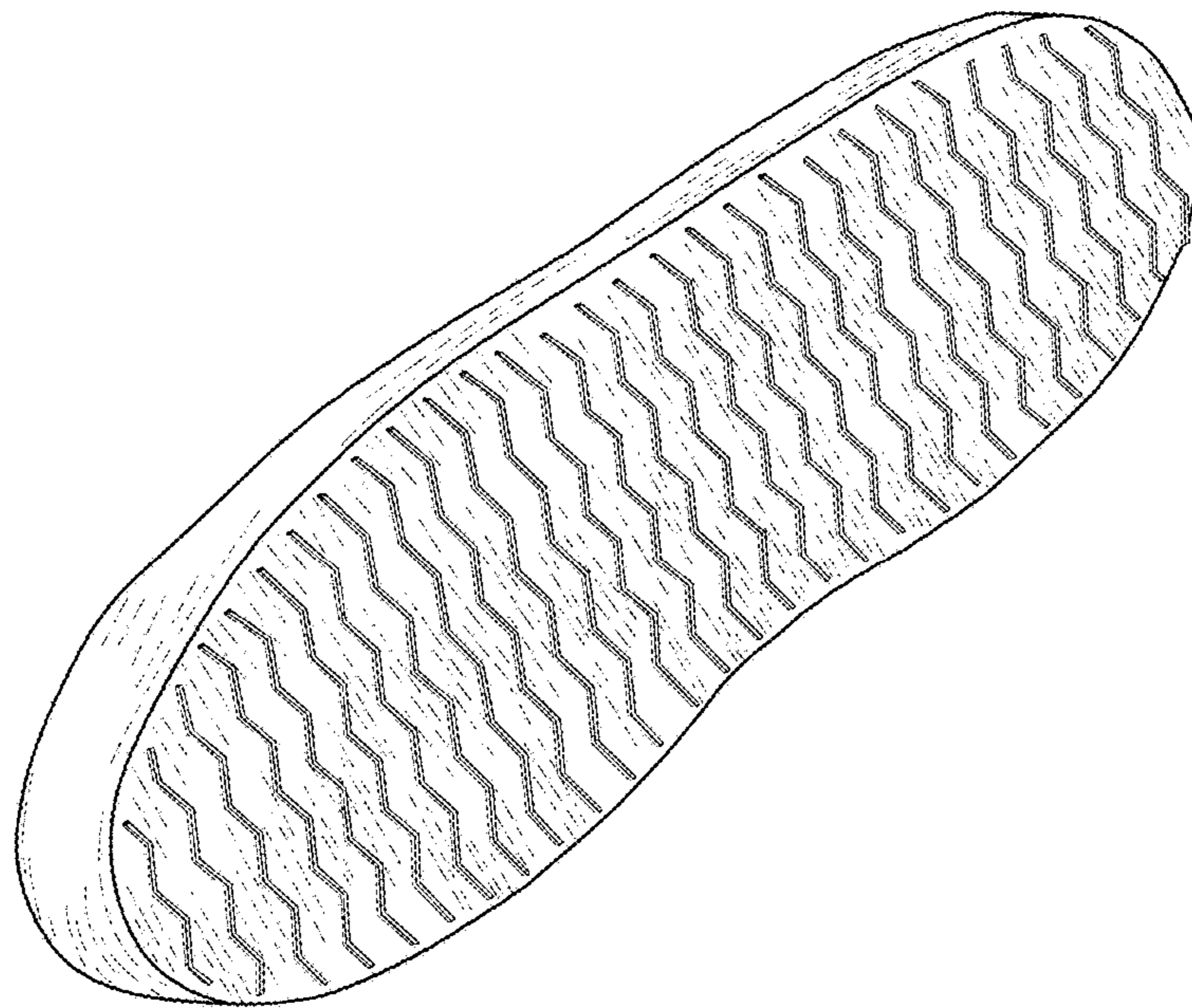

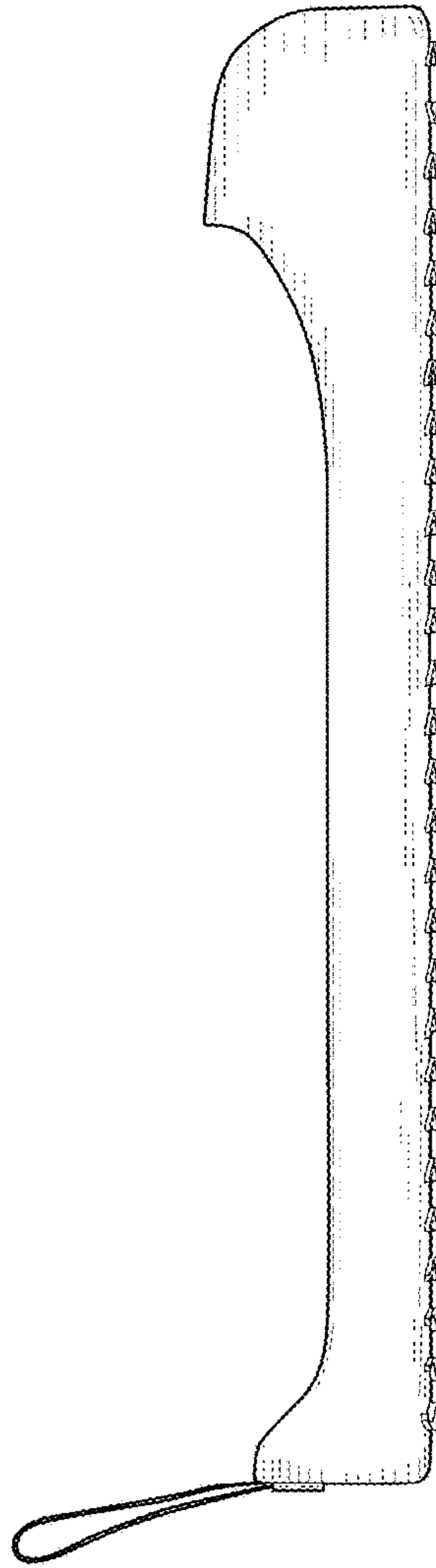

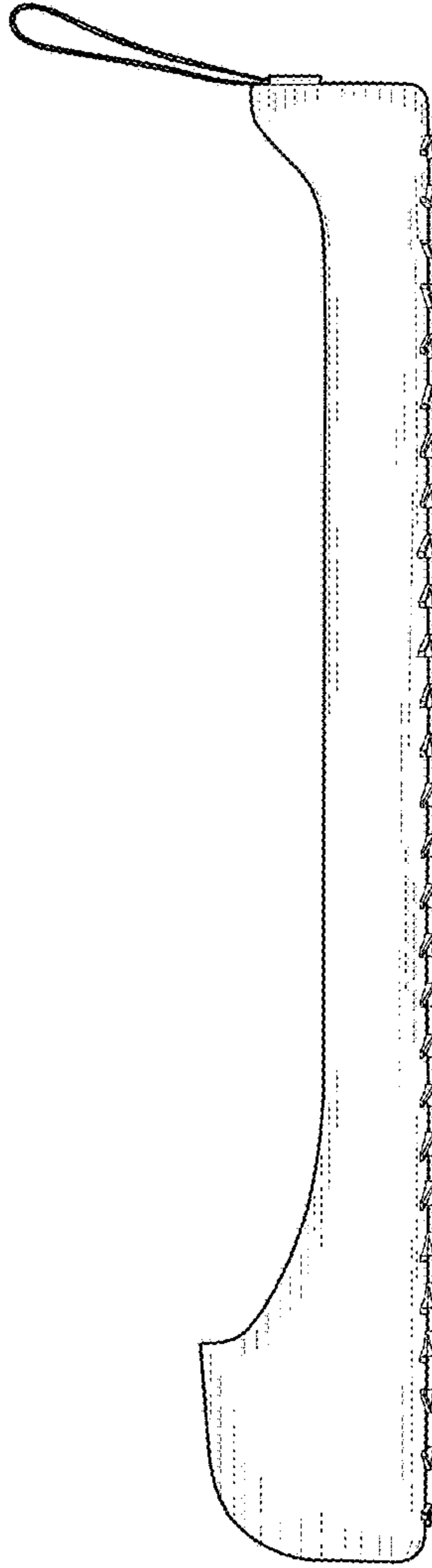

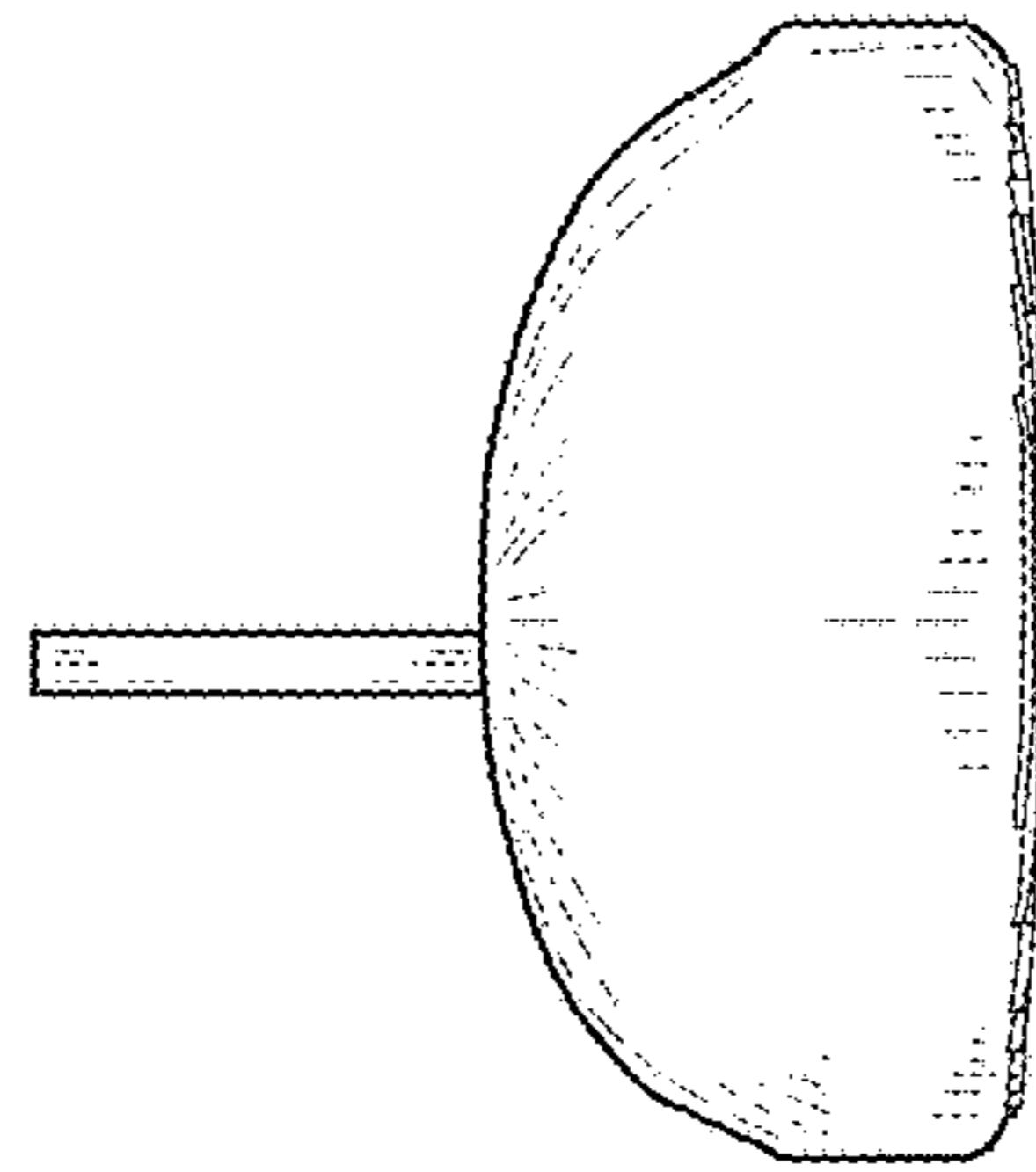

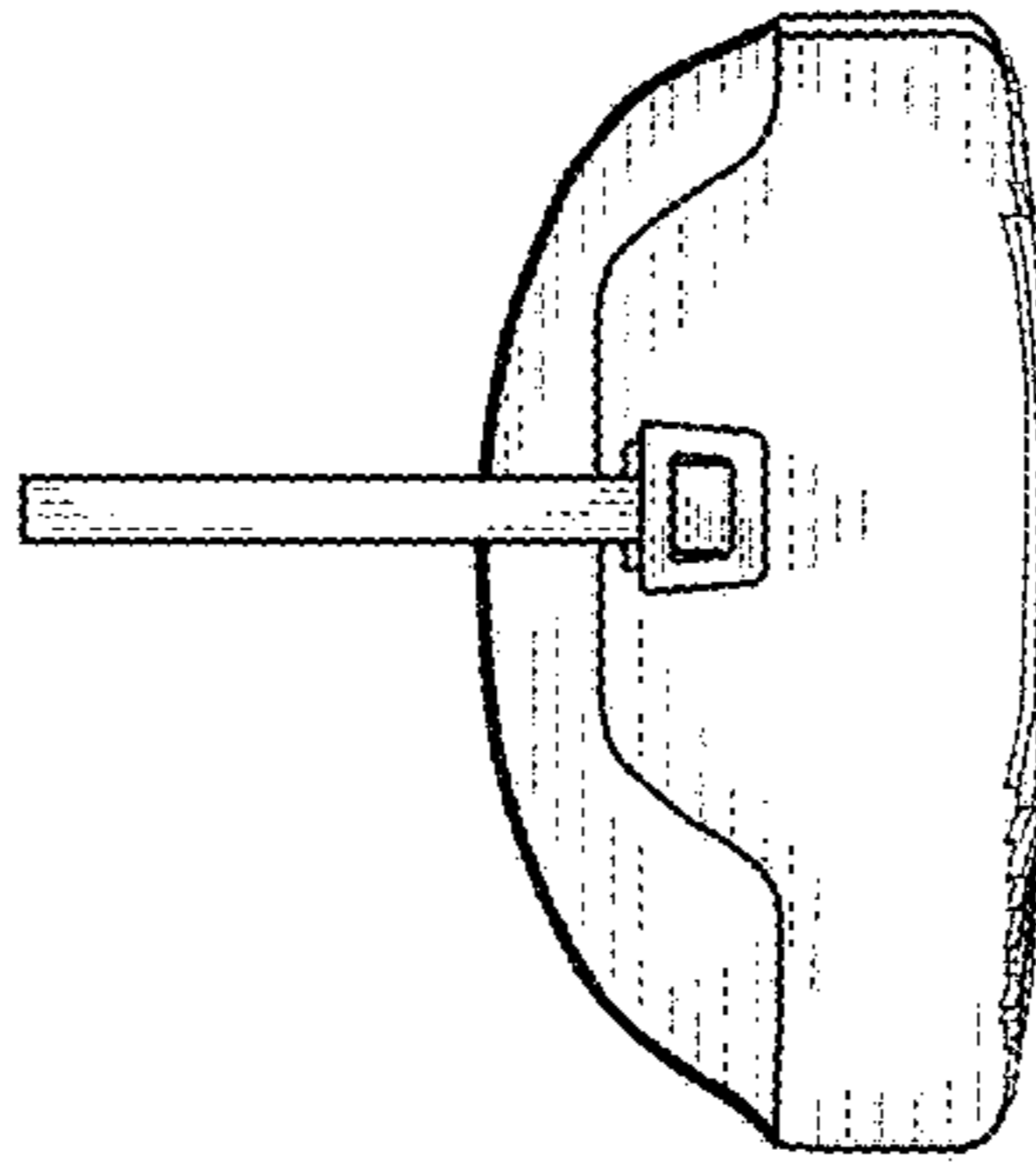

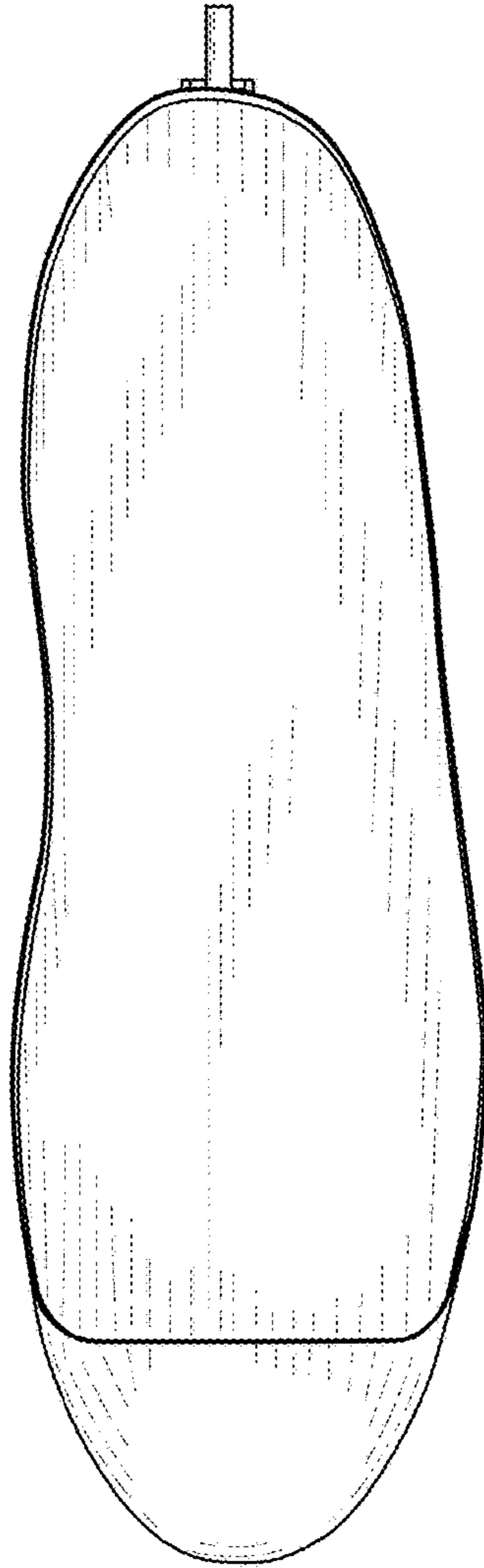

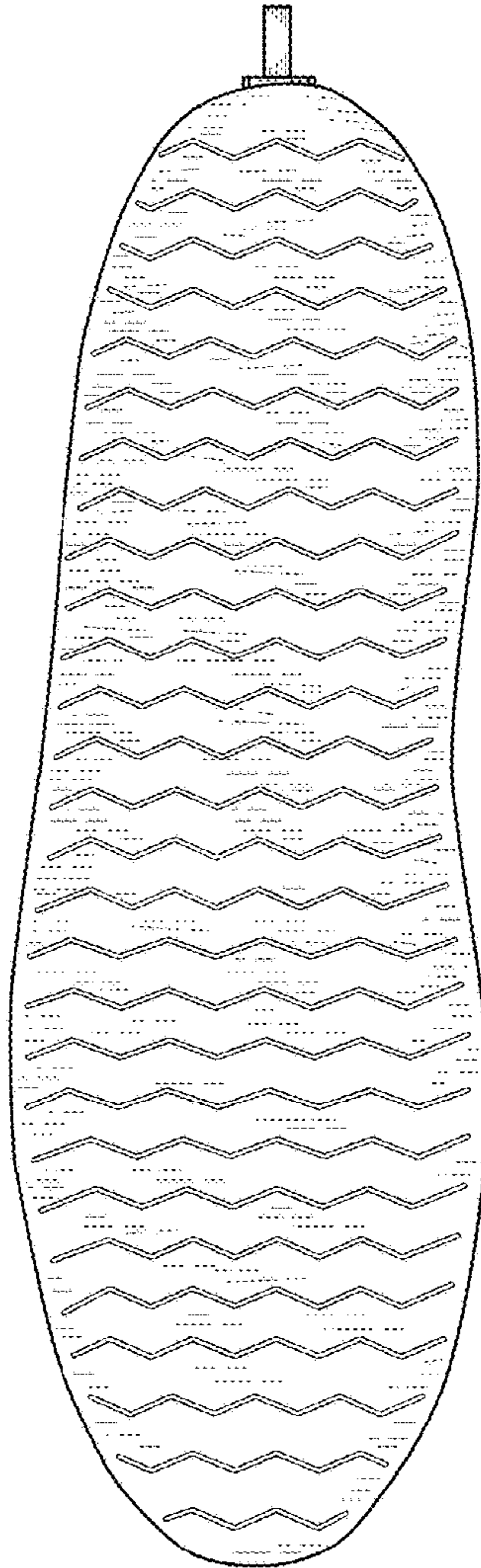

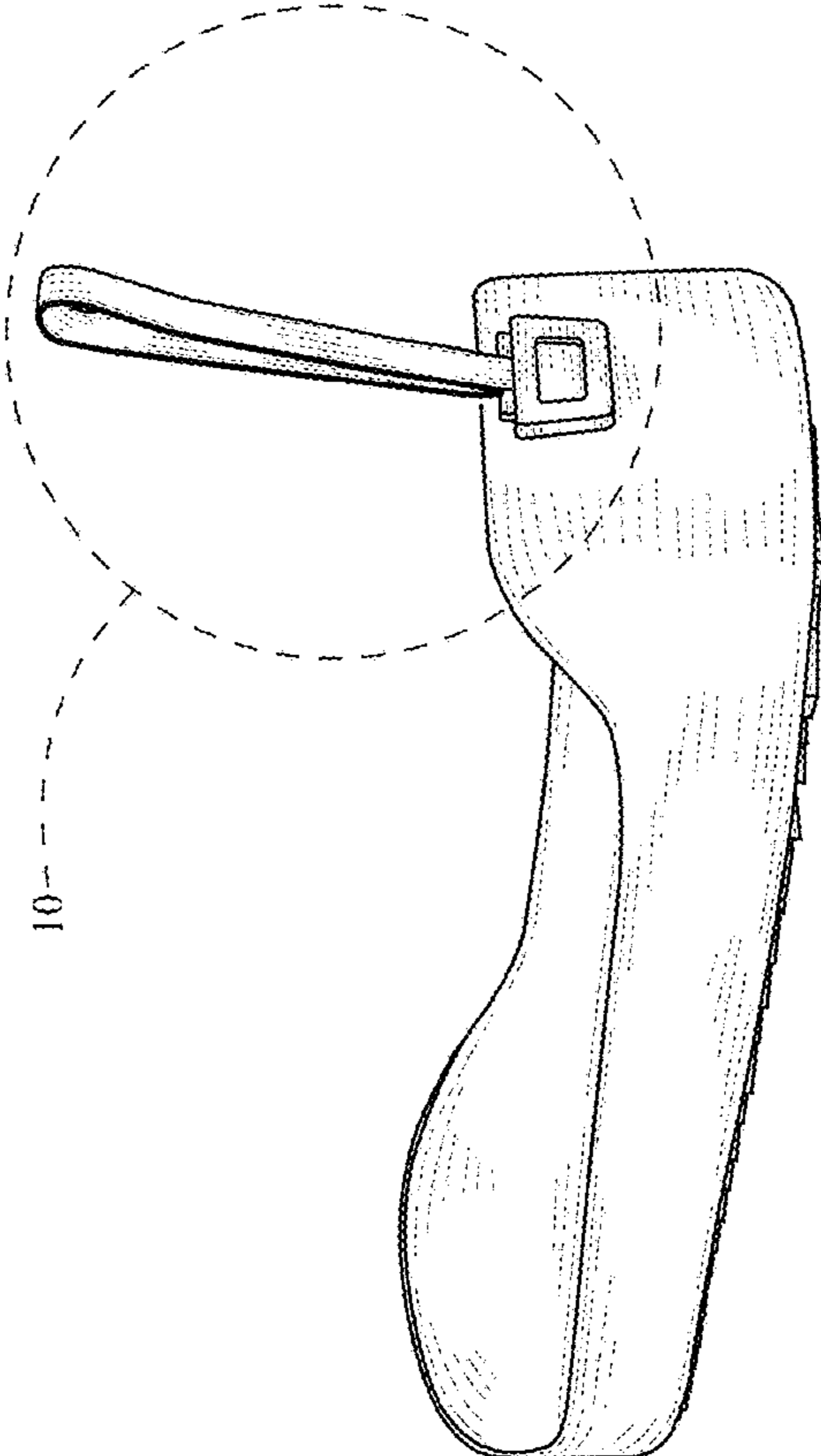

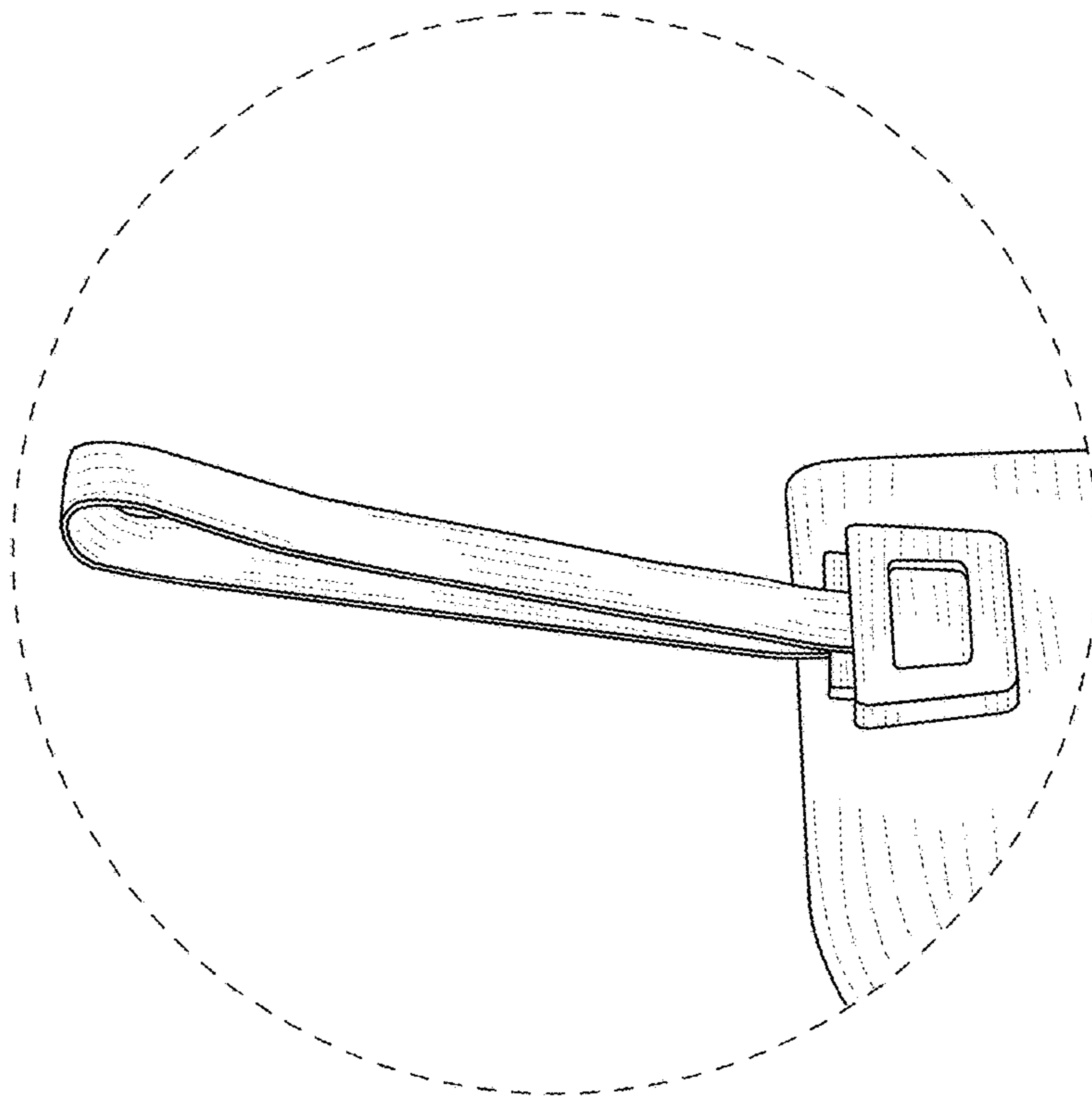
