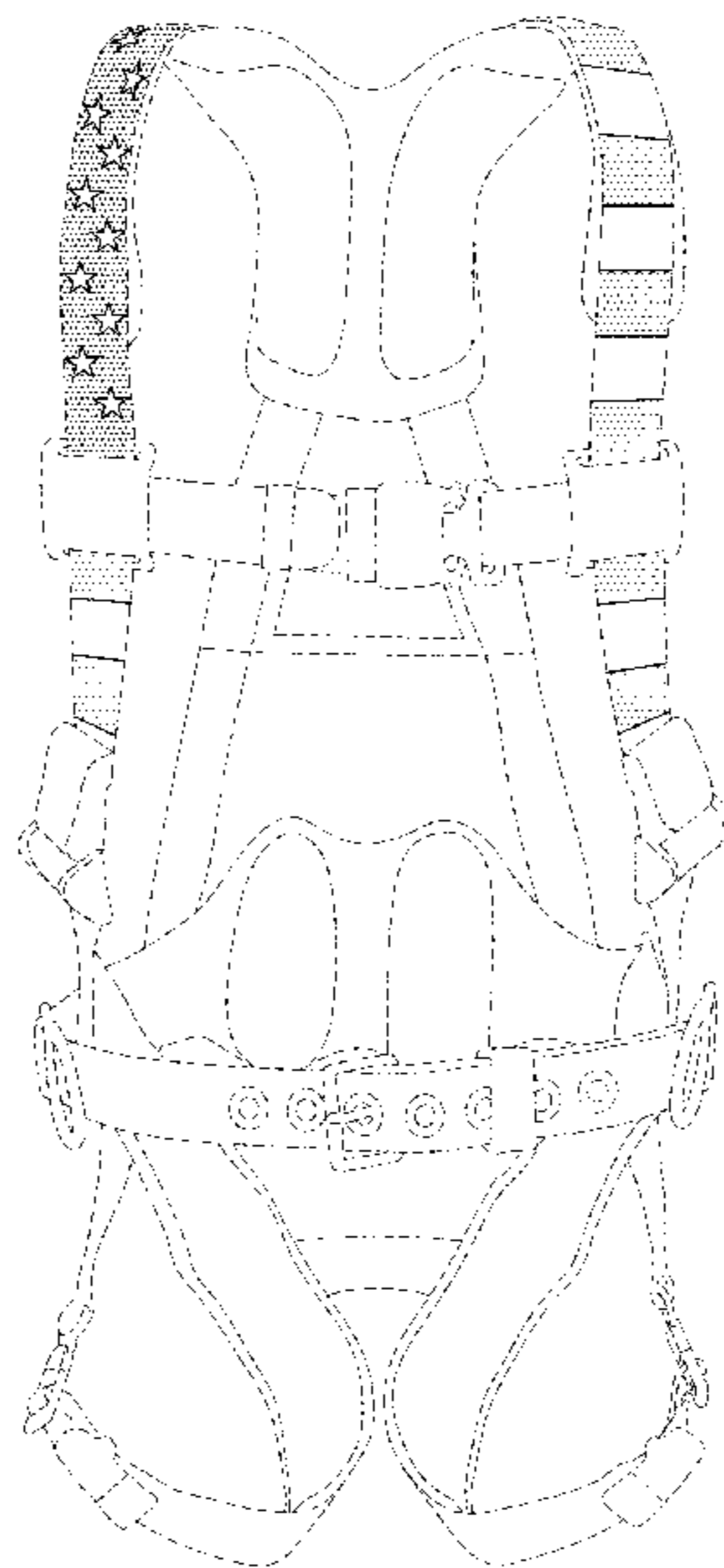
(57) **CLAIM**

The ornamental design for a safety harness with American flag design, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a safety harness with American flag design showing the new design;
FIG. 2 is a back elevational view of the safety harness with American flag design of FIG. 1;
FIG. 3 is a right-side elevational view of the safety harness with American flag design of FIG. 1;
FIG. 4 is a left-side elevational view of the safety harness with American flag design of FIG. 1;
FIG. 5 is a front perspective view of the safety harness with American flag design of FIG. 1; and,
FIG. 6 is a back perspective view of the safety harness with American flag design of FIG. 1.

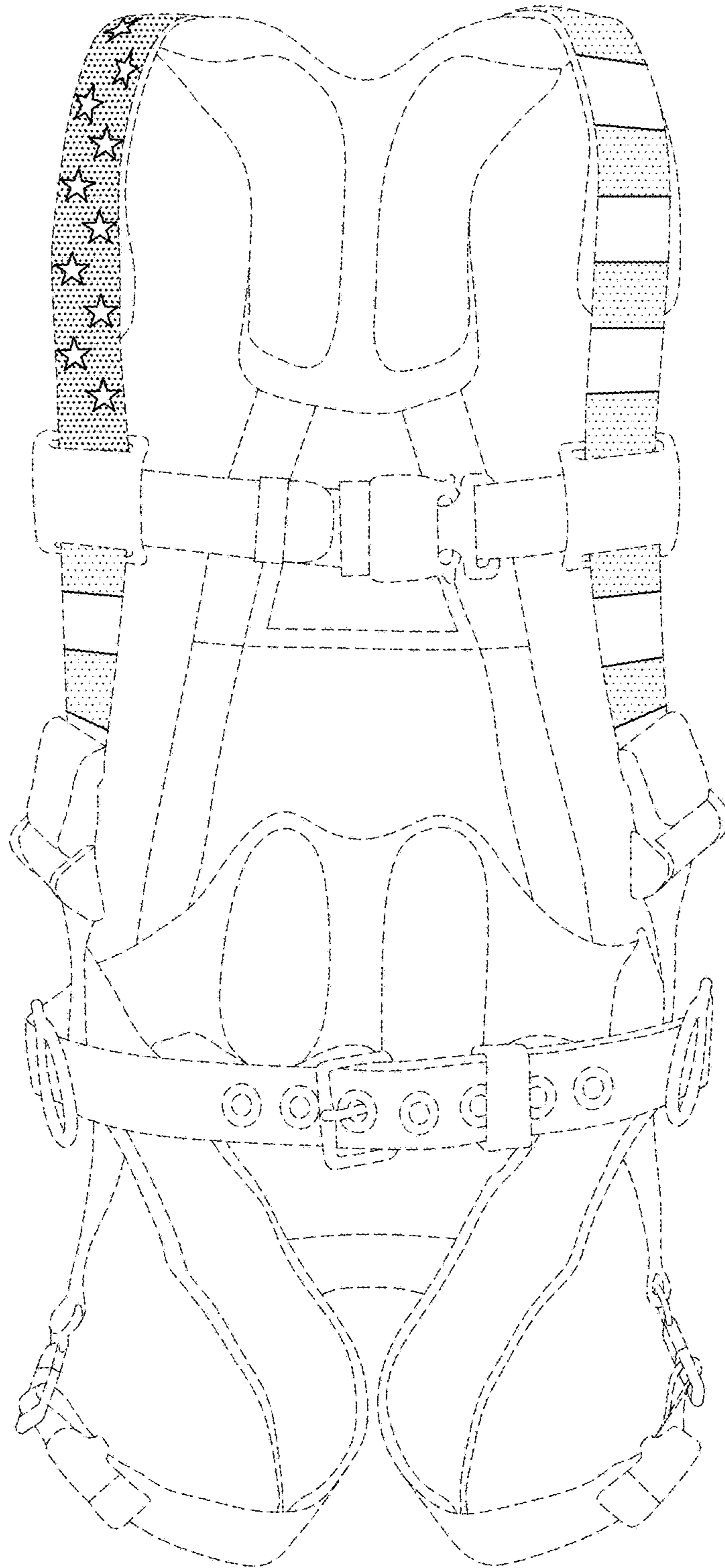

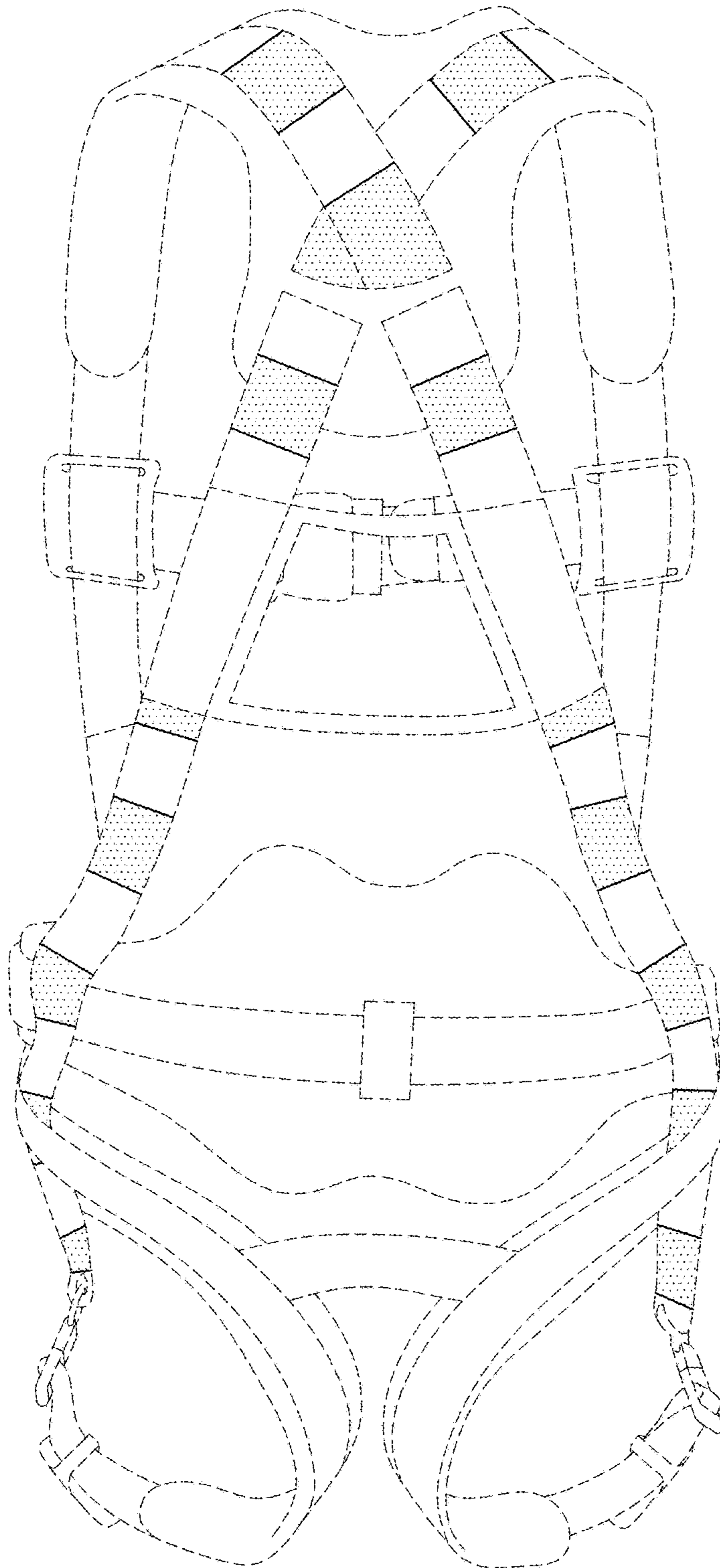

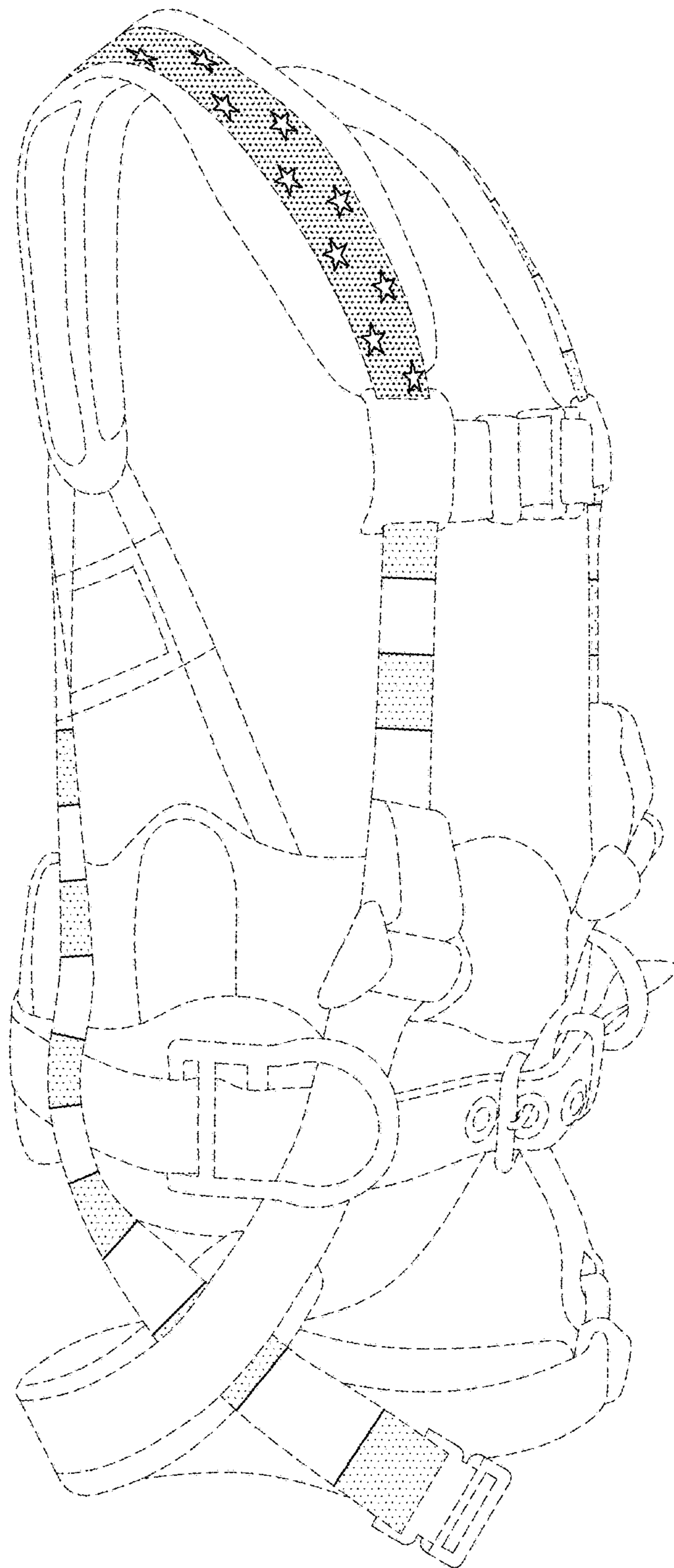

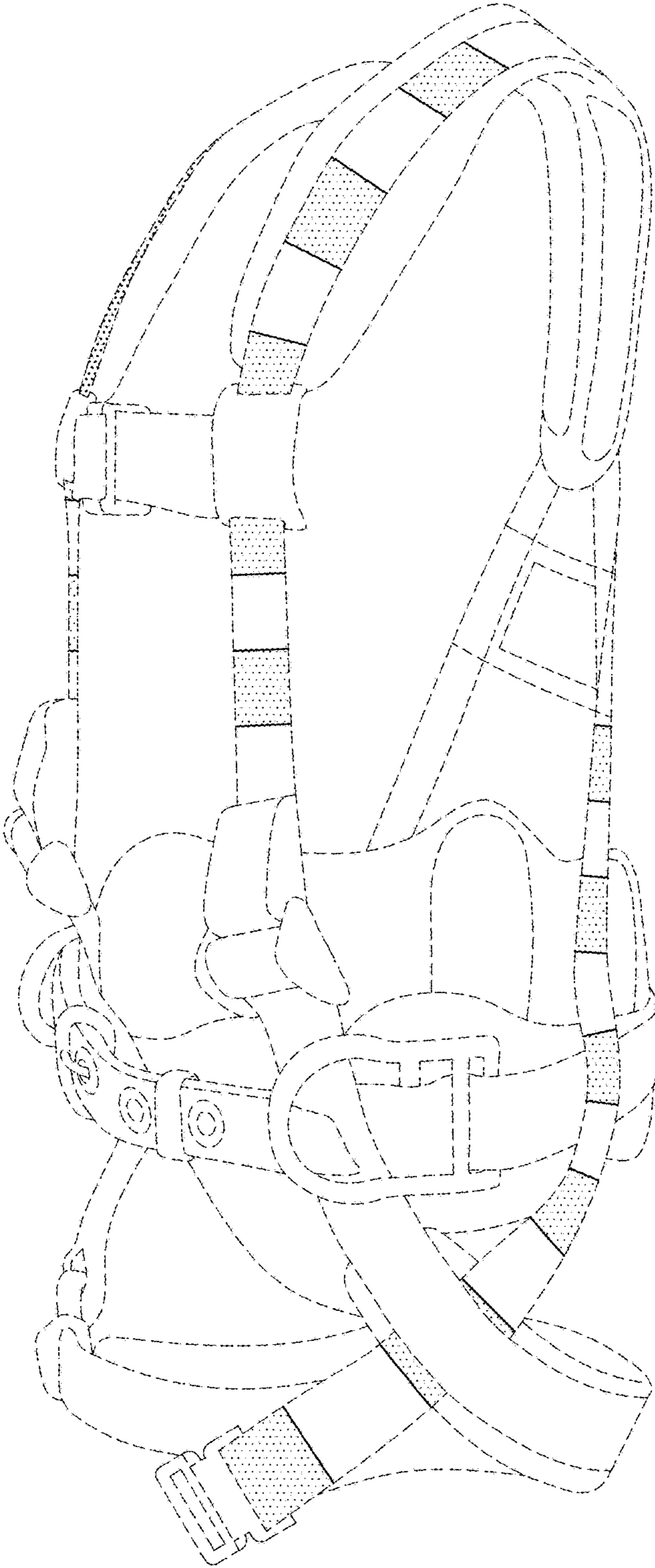

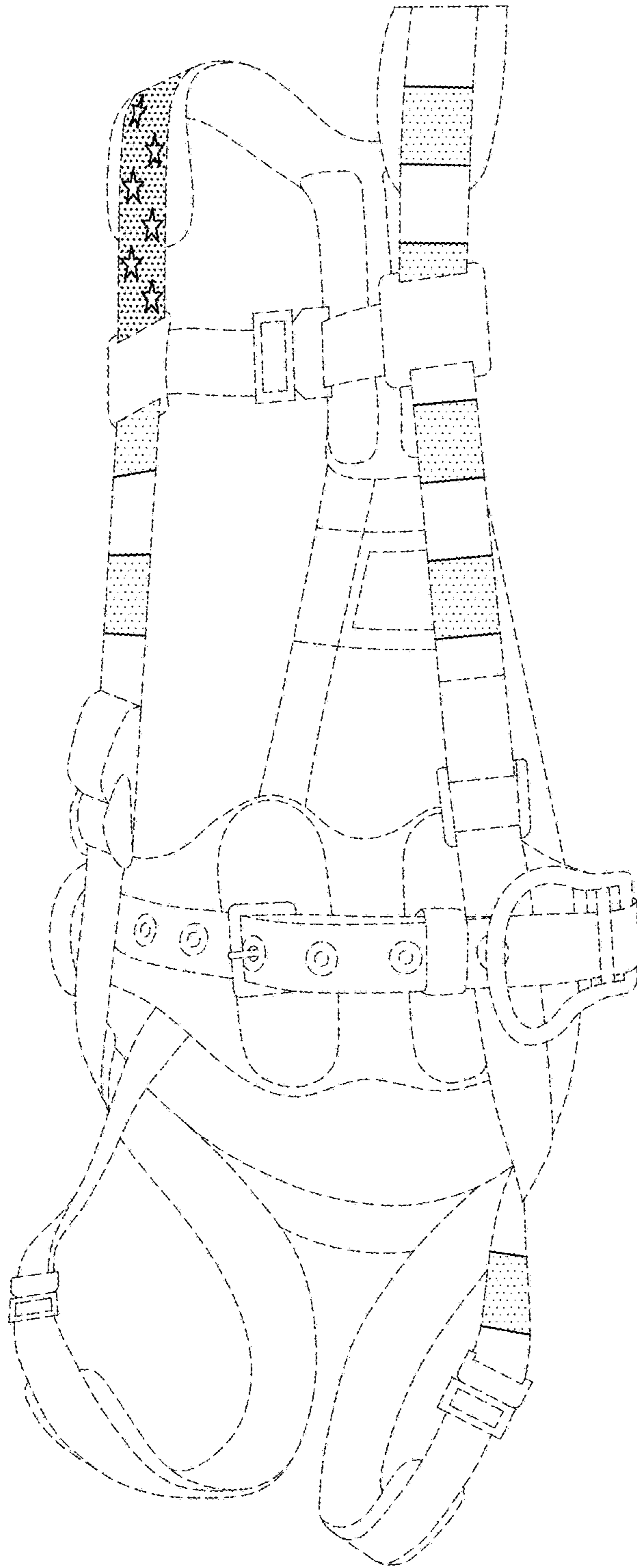

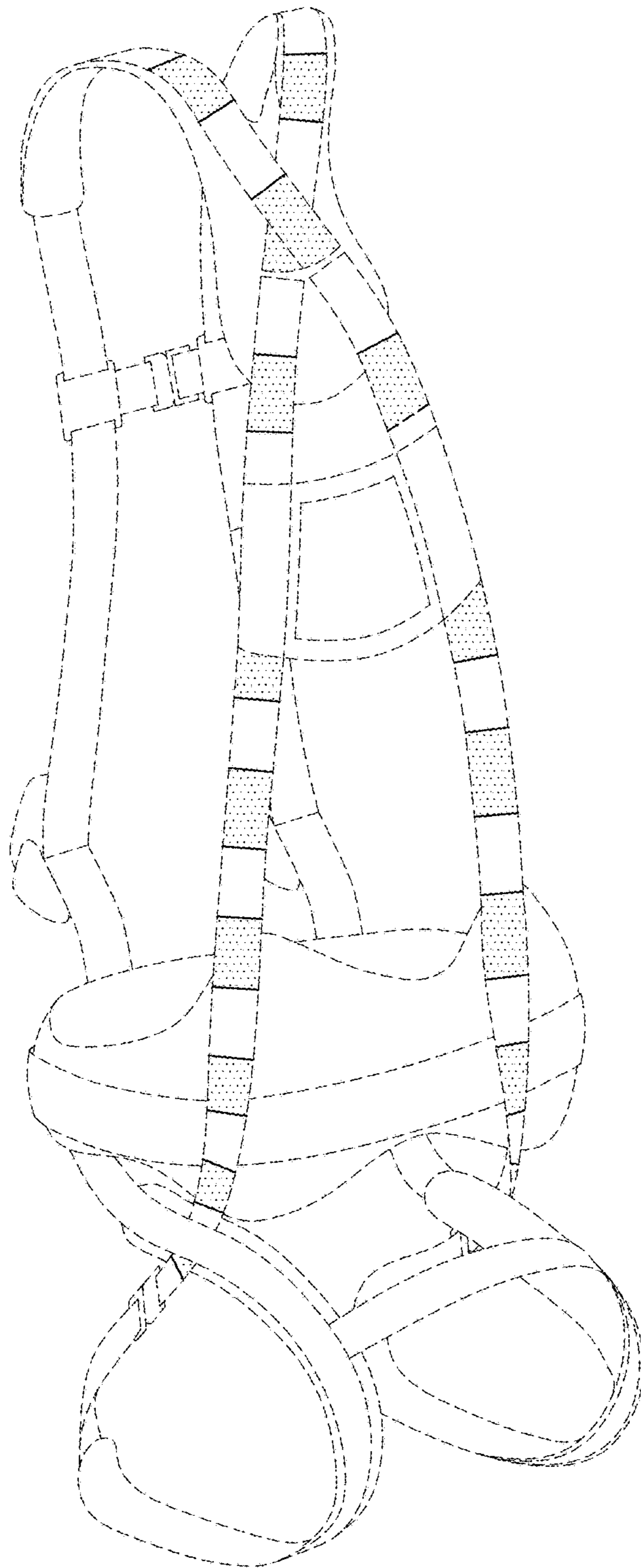
