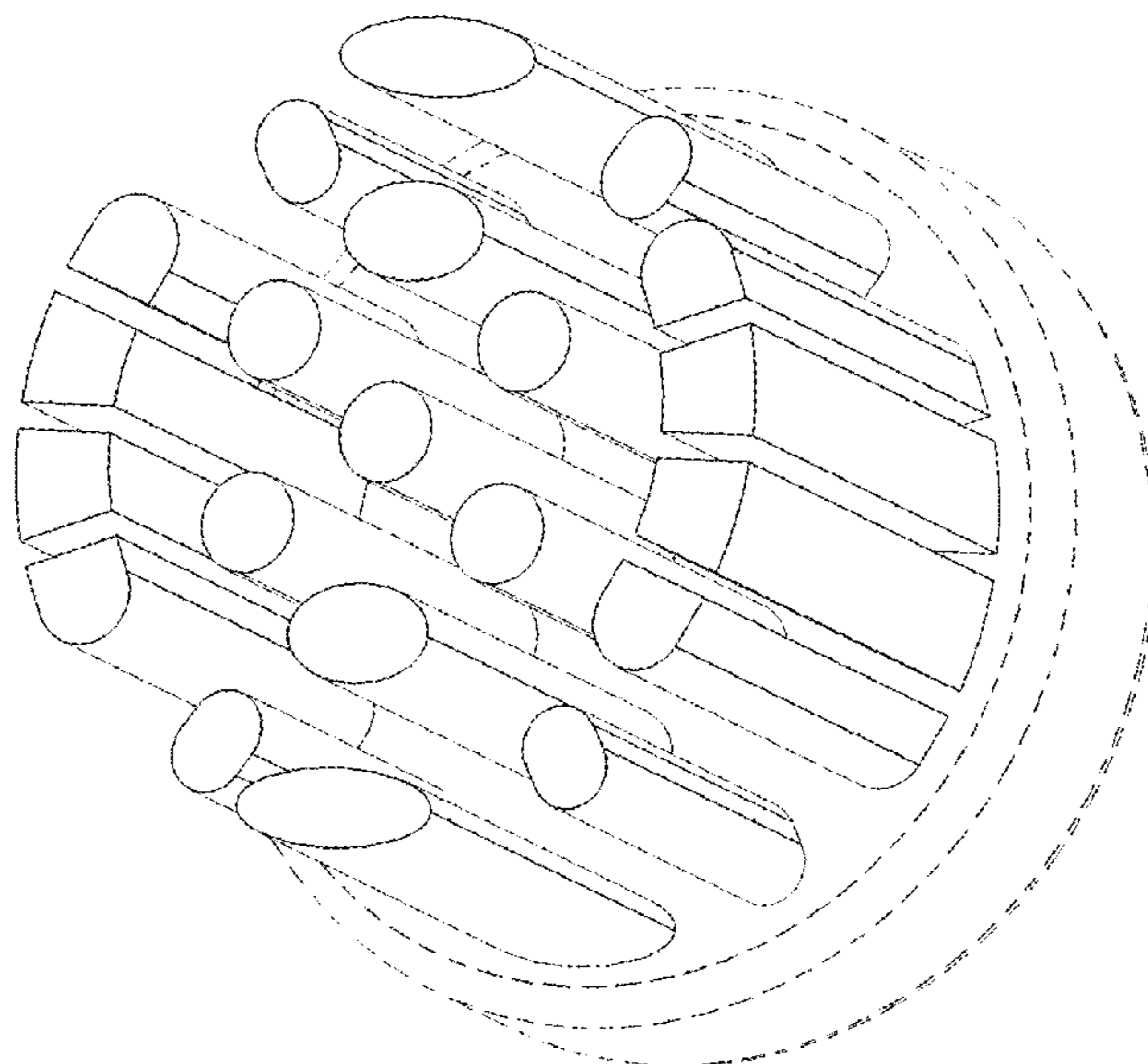
(57) **CLAIM**

The ornamental design for a toothbrush head, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a toothbrush head showing my new design;
FIG. 2 is a front elevation view of the design shown in FIG. 1;
FIG. 3 is a left side elevation view of the design shown in FIG. 1;
FIG. 4 is a right side elevation view of the design shown in FIG. 1;
FIG. 5 is a rear elevation view of the design shown in FIG. 1;
FIG. 6 is a bottom plan view of the design shown in FIG. 1; and,
FIG. 7 is a top plan view of the design shown in FIG. 1.
The broken lines showing the bristle support portion of the toothbrush head from no part of the claimed design.

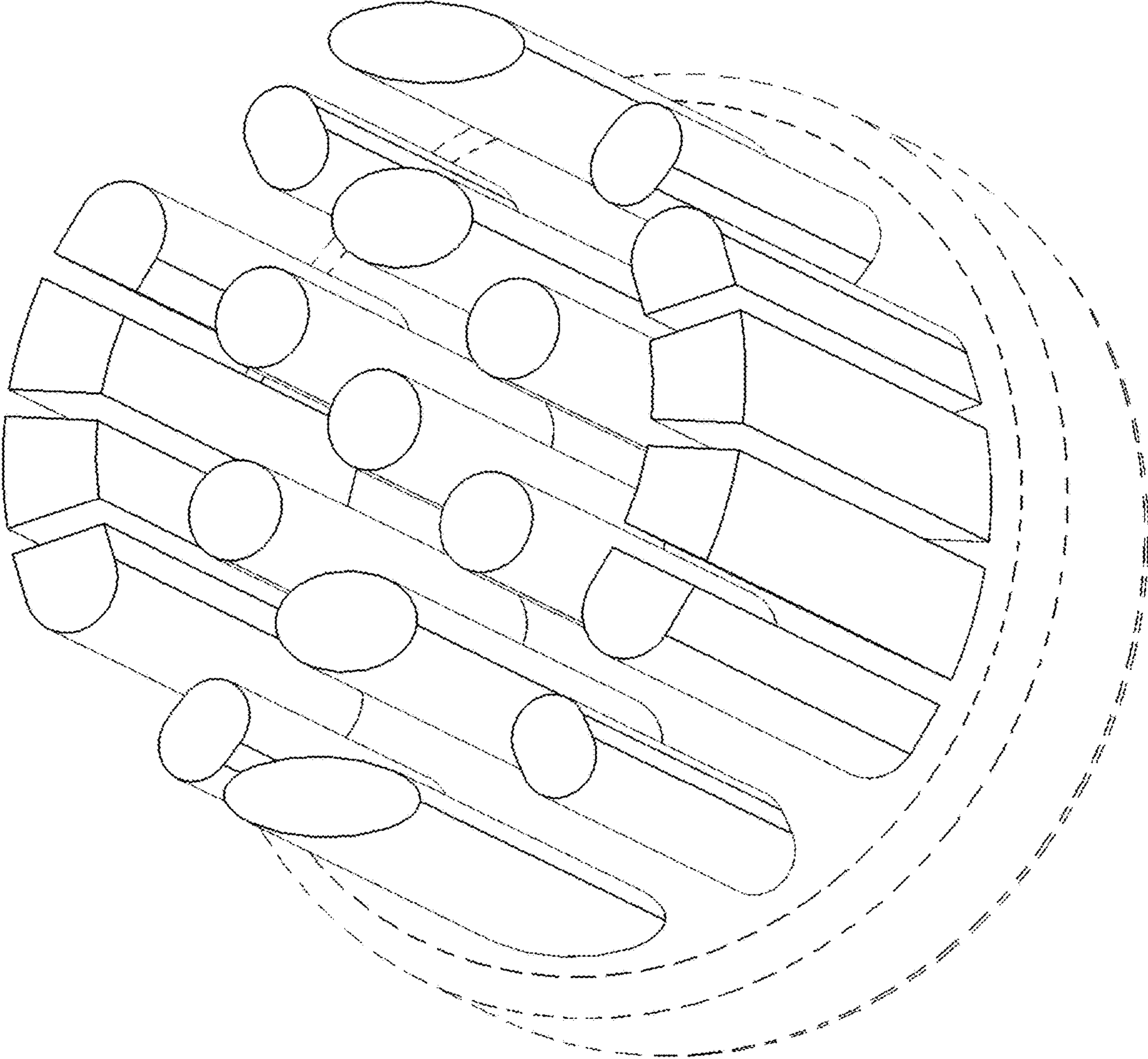

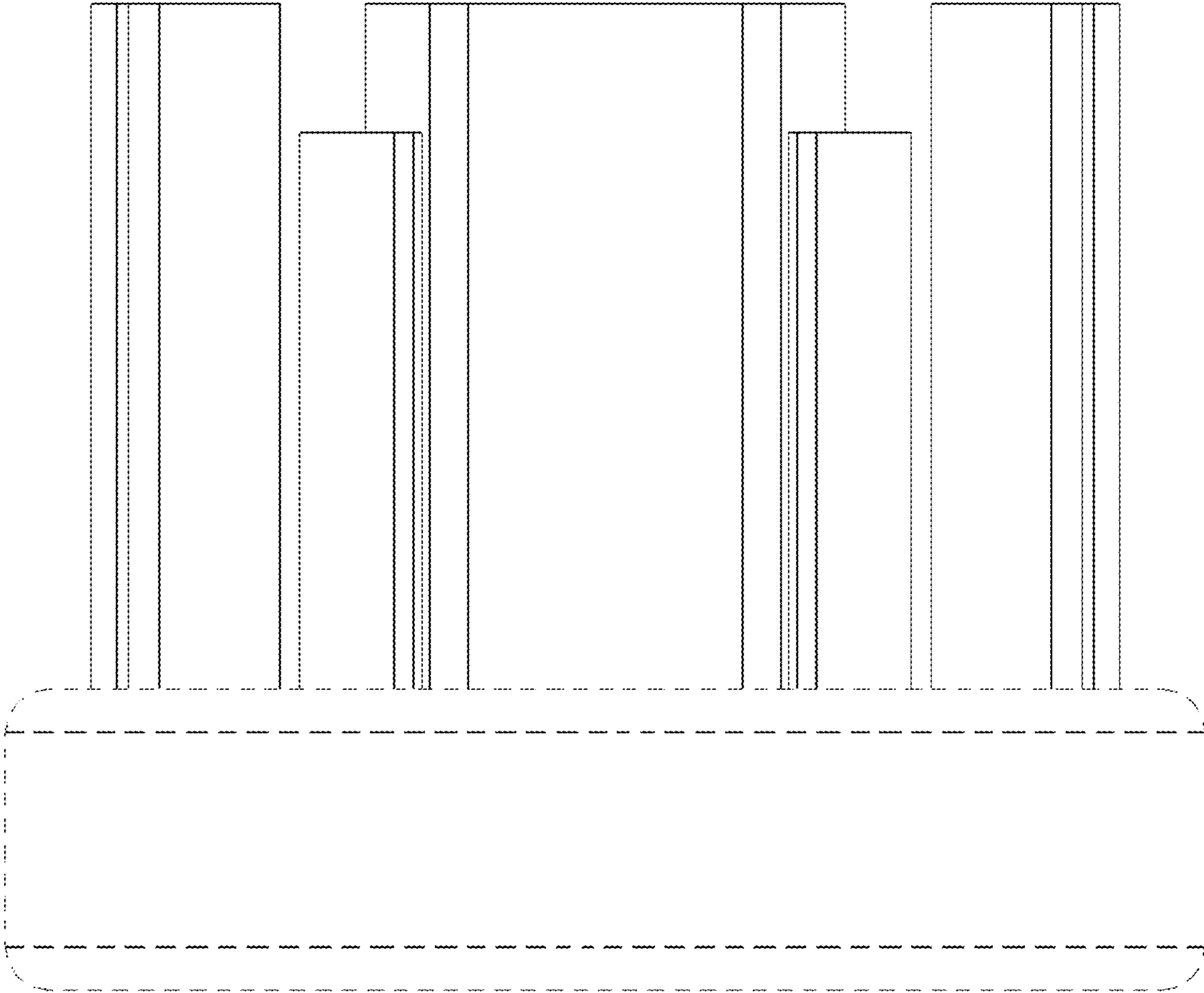

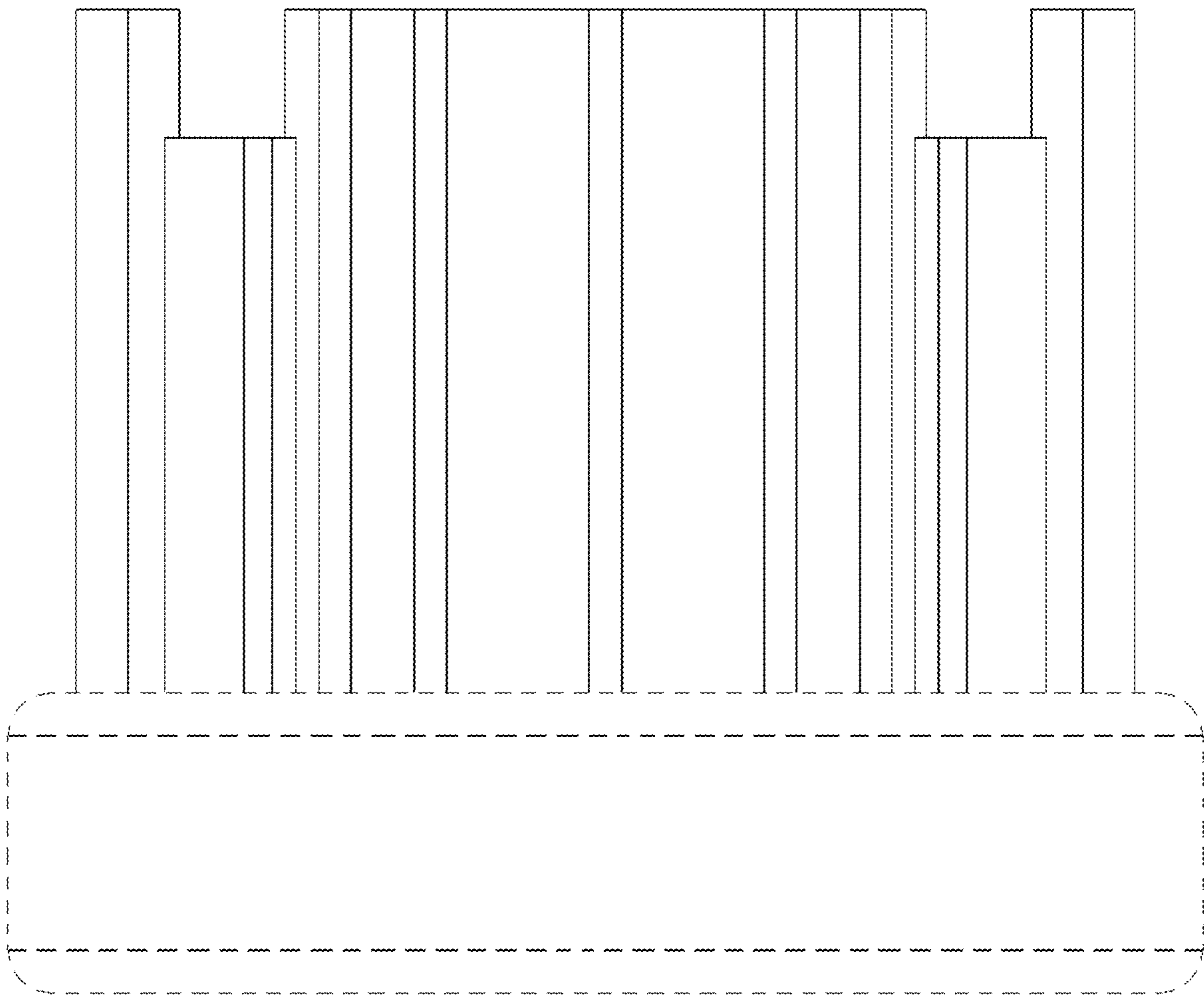

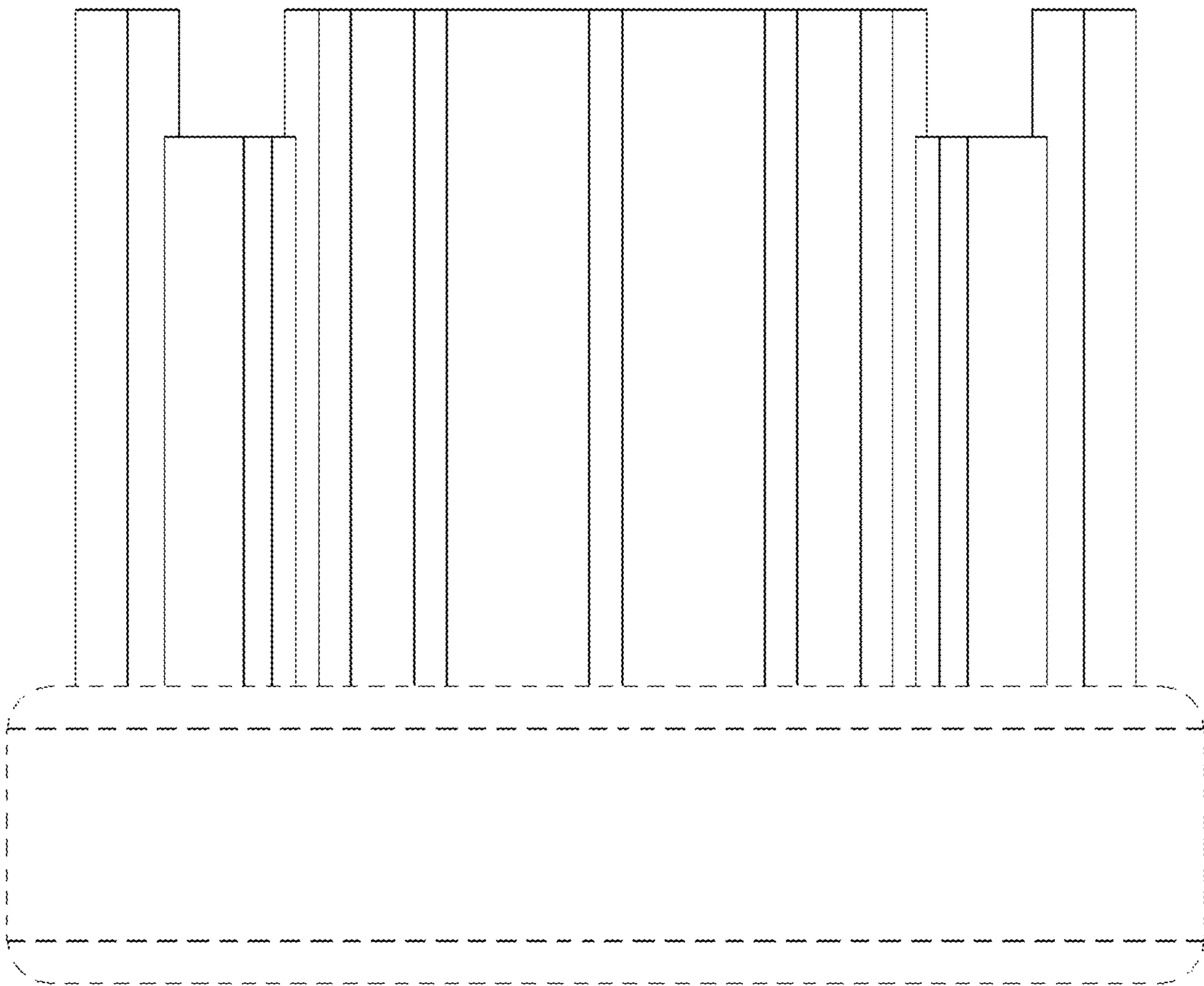

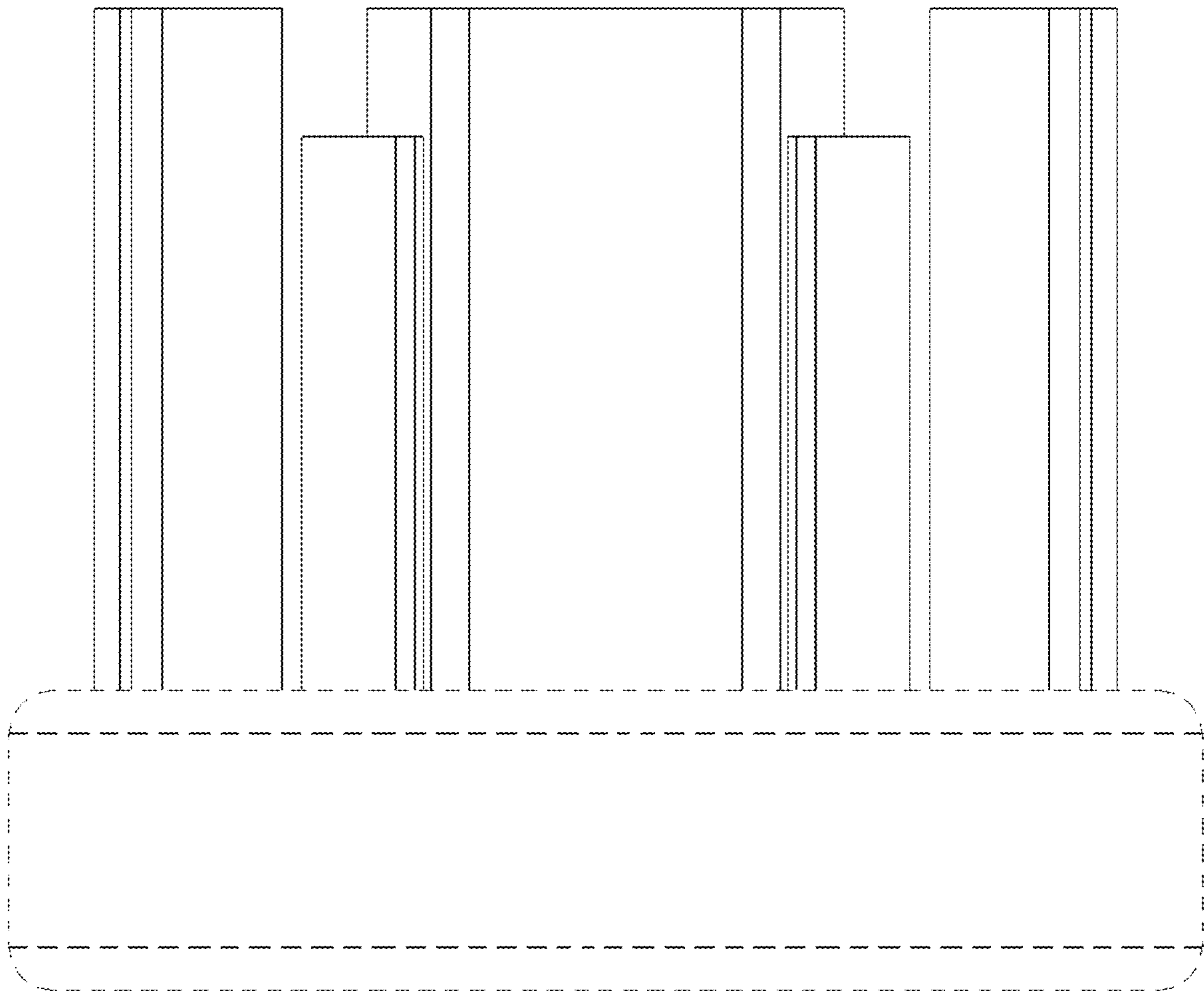

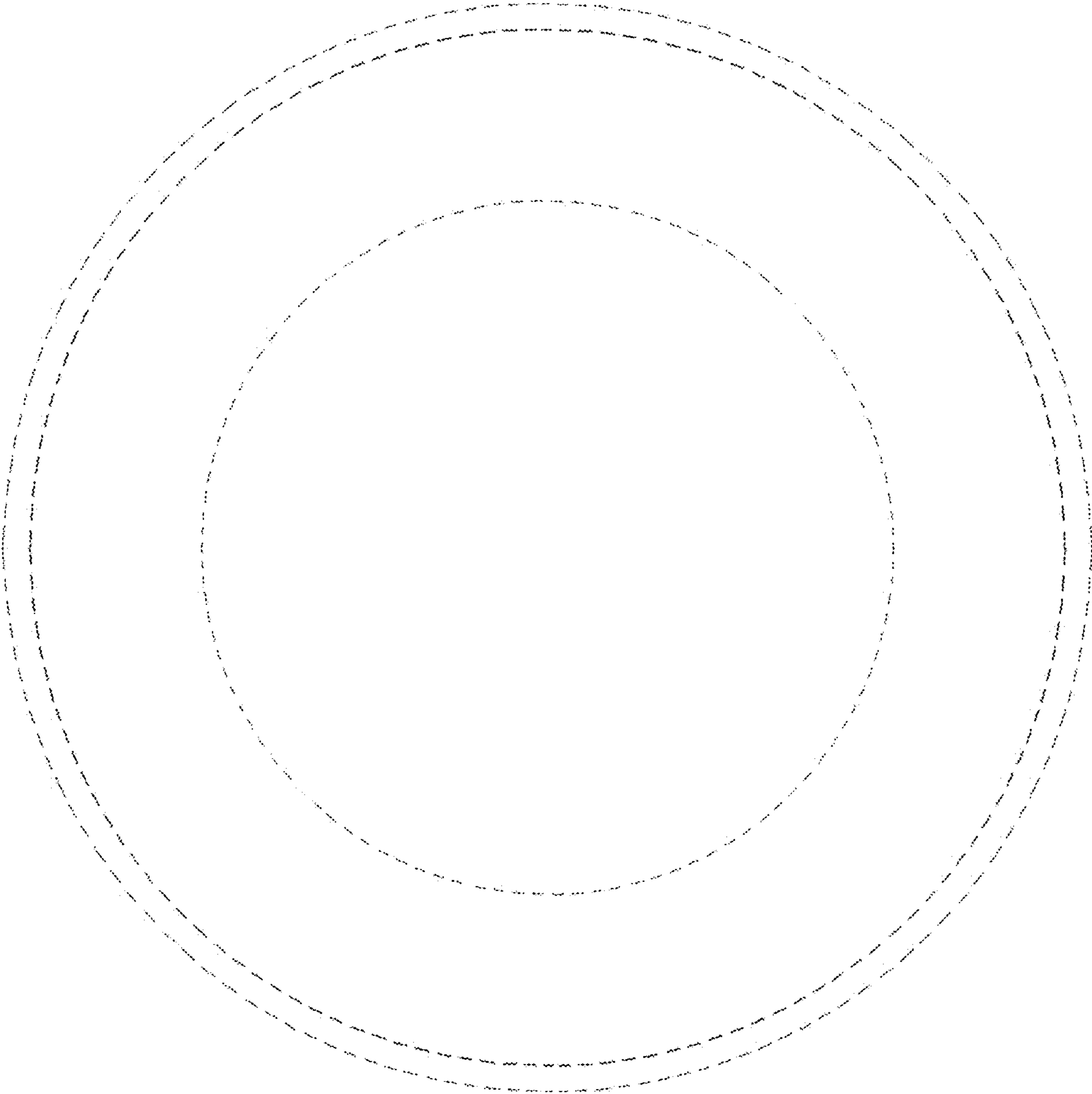

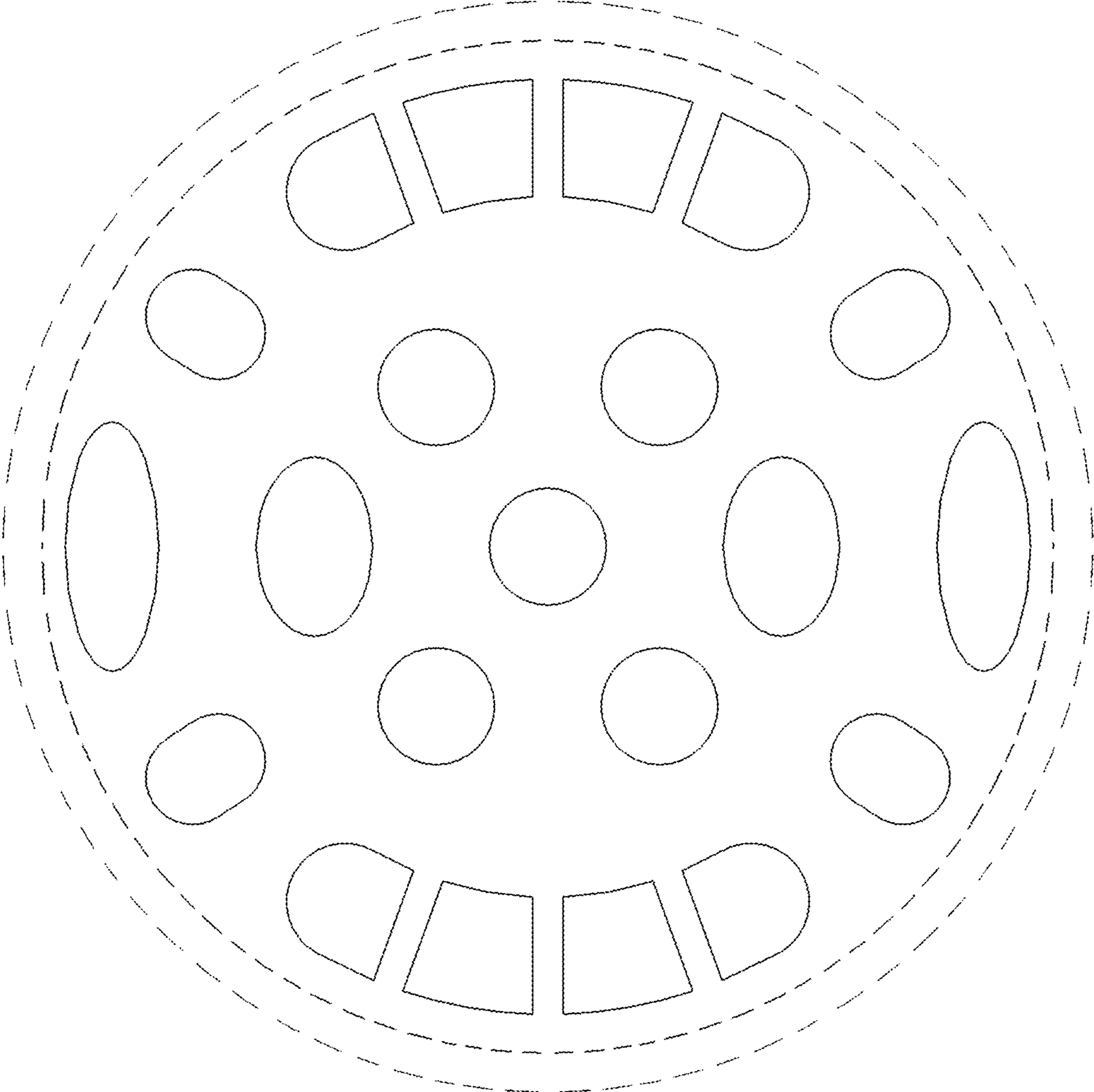
