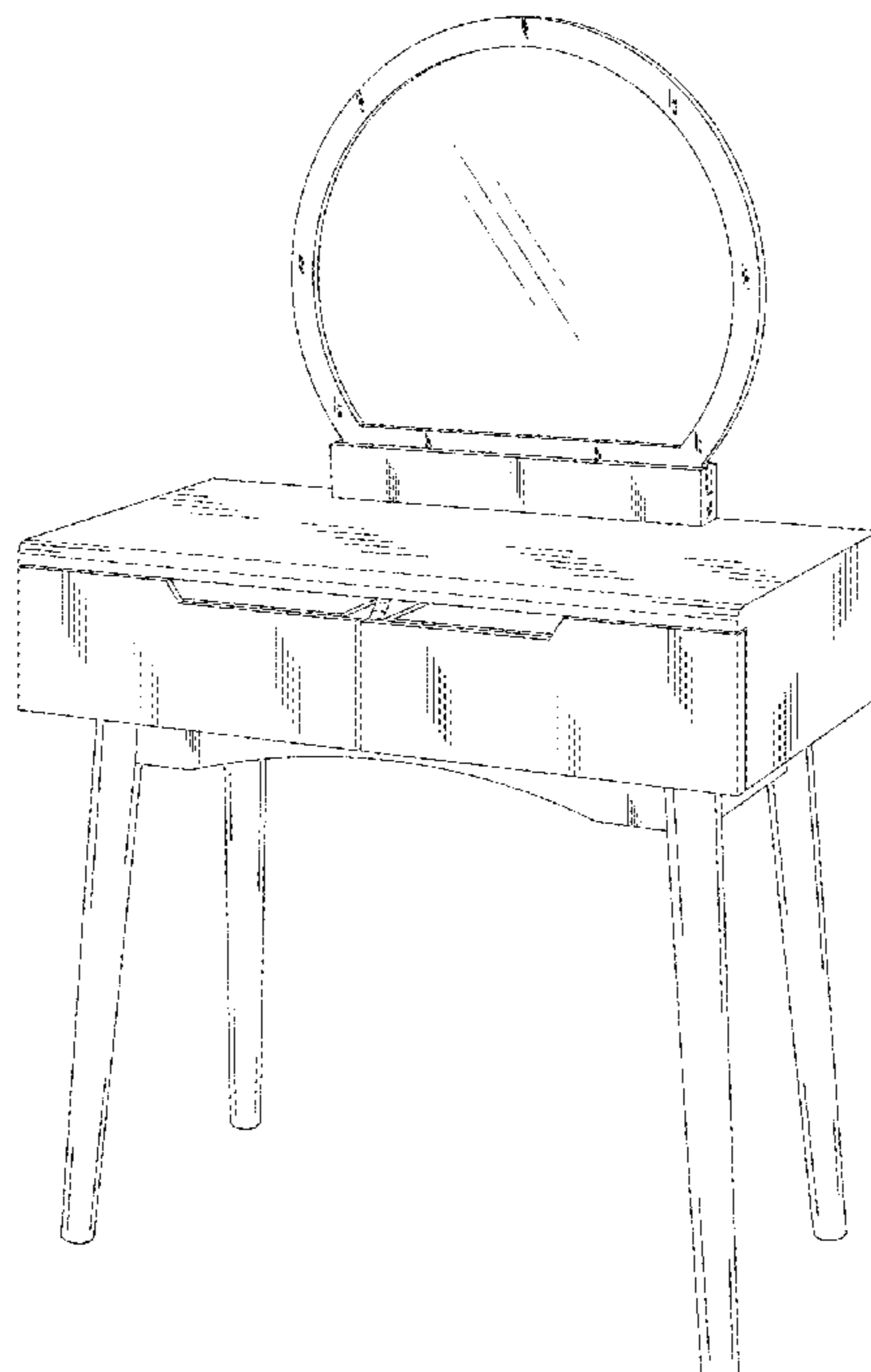

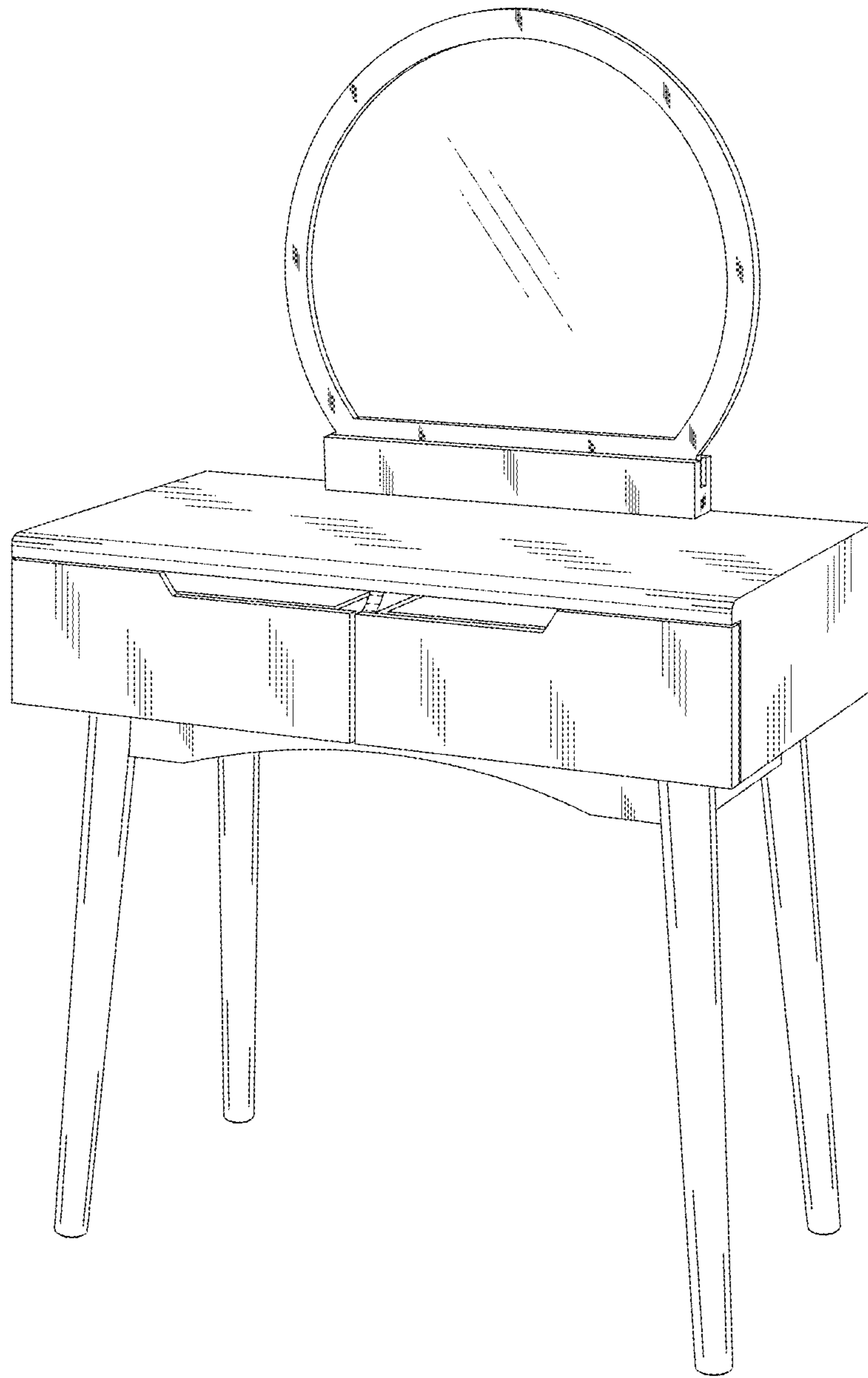
The ornamental design for a vanity desk, as shown and described.

**DESCRIPTION**

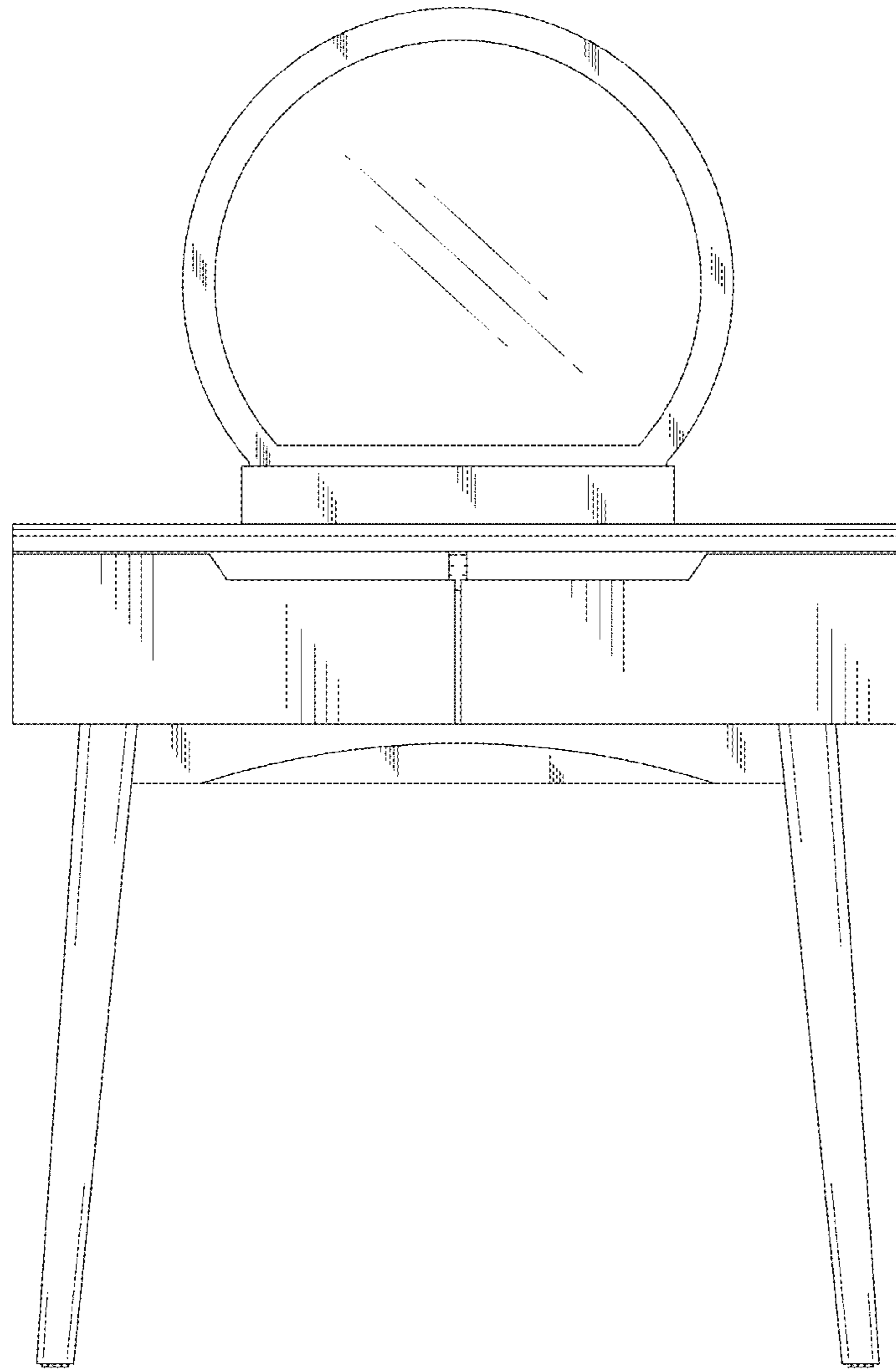
FIG. 1 is a perspective view of a vanity desk showing my new design;

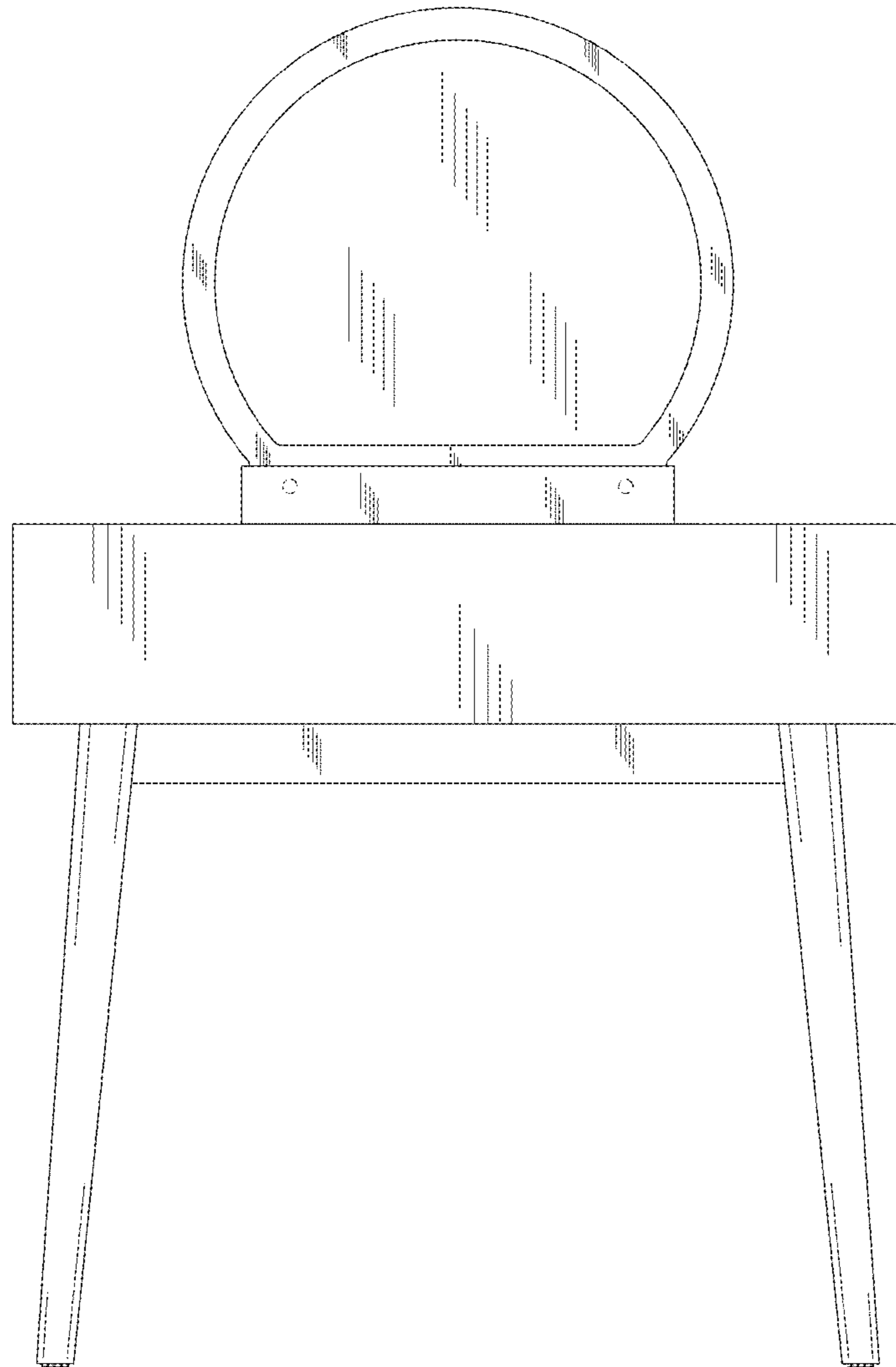

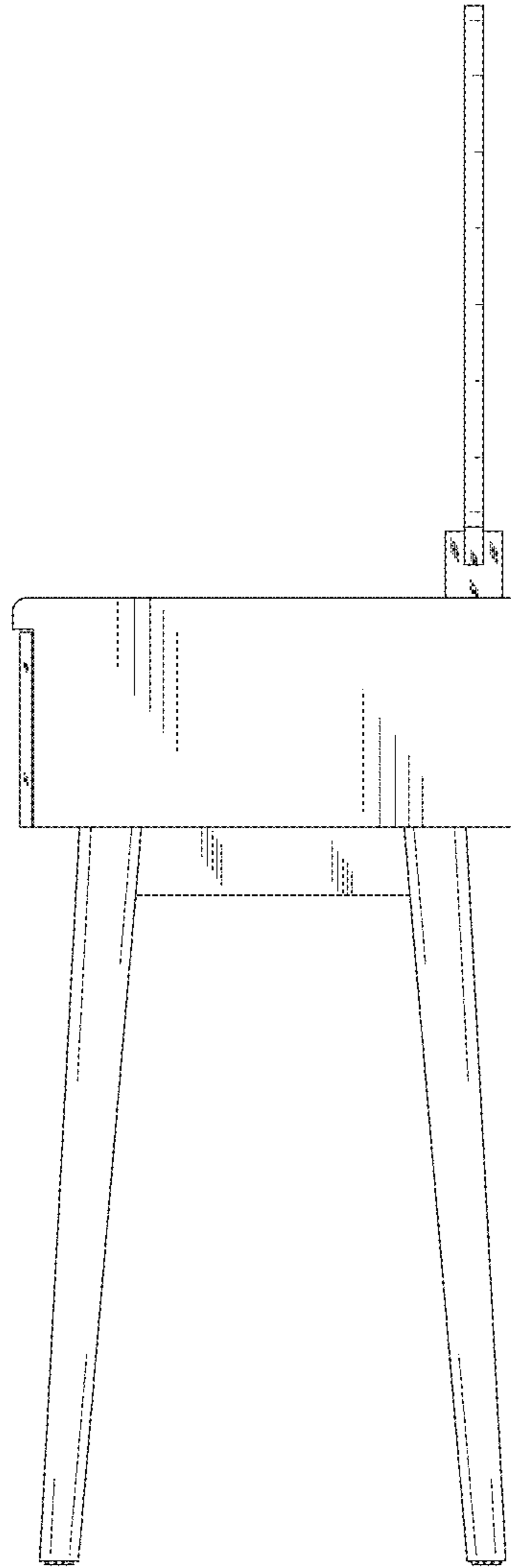
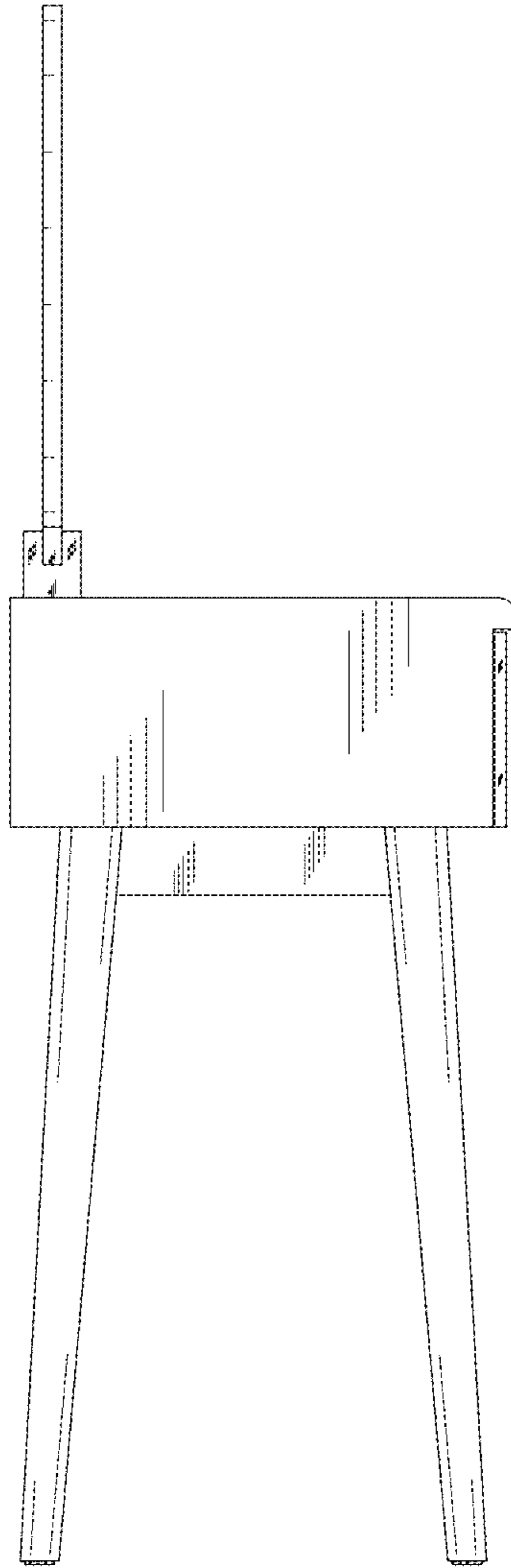
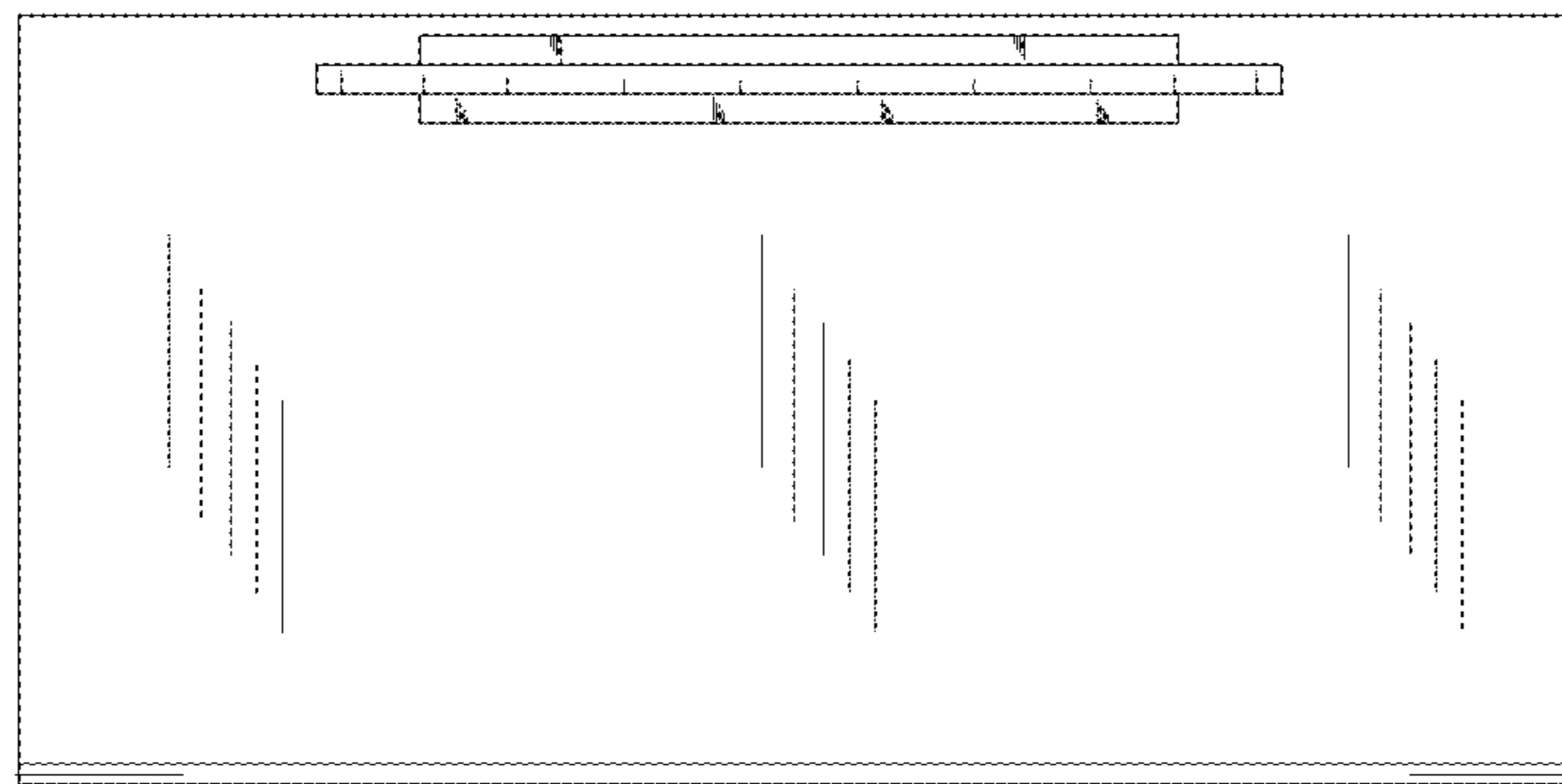


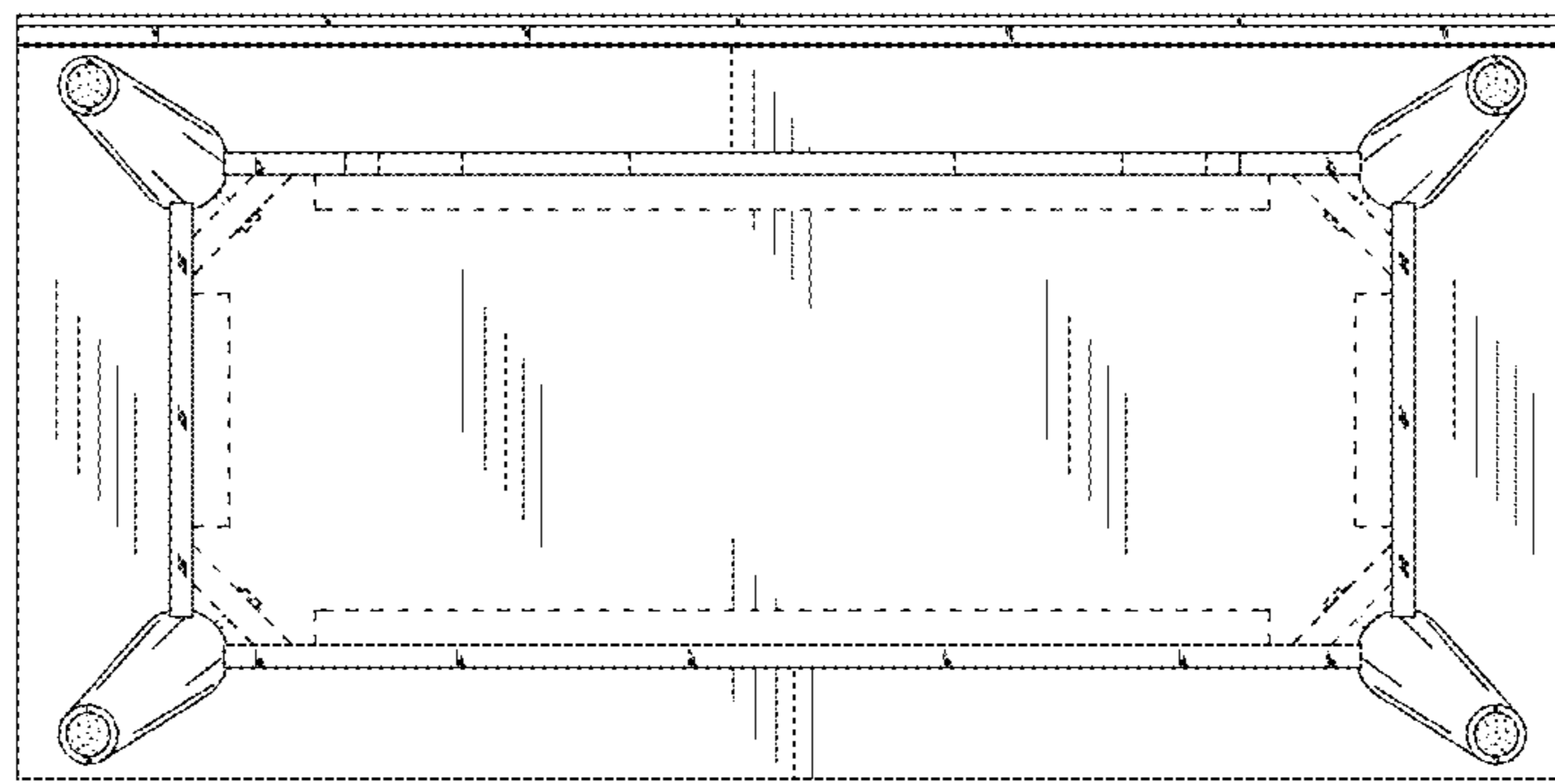
