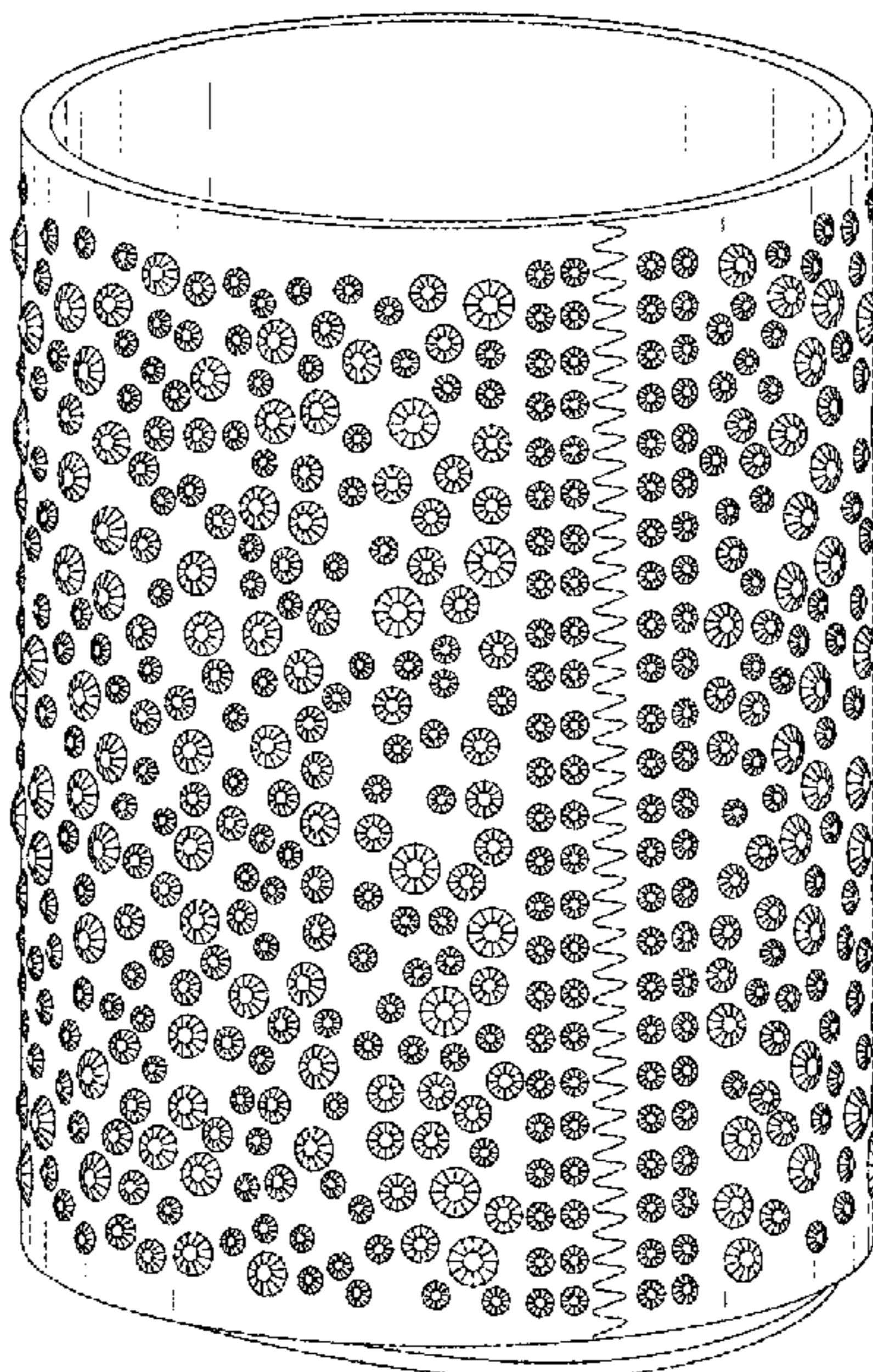

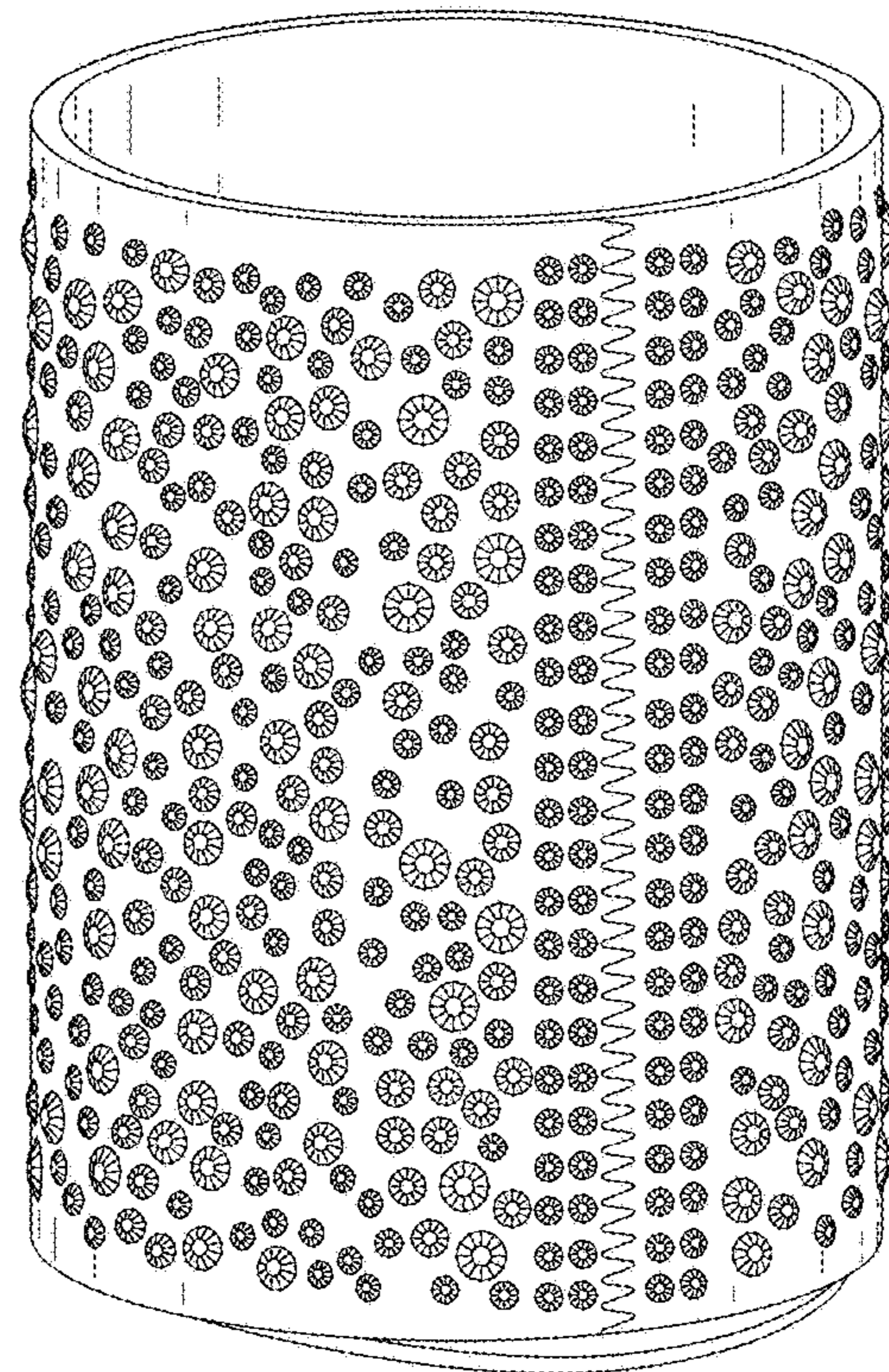
The ornamental design for a drink cozy, as shown and described.

**DESCRIPTION**

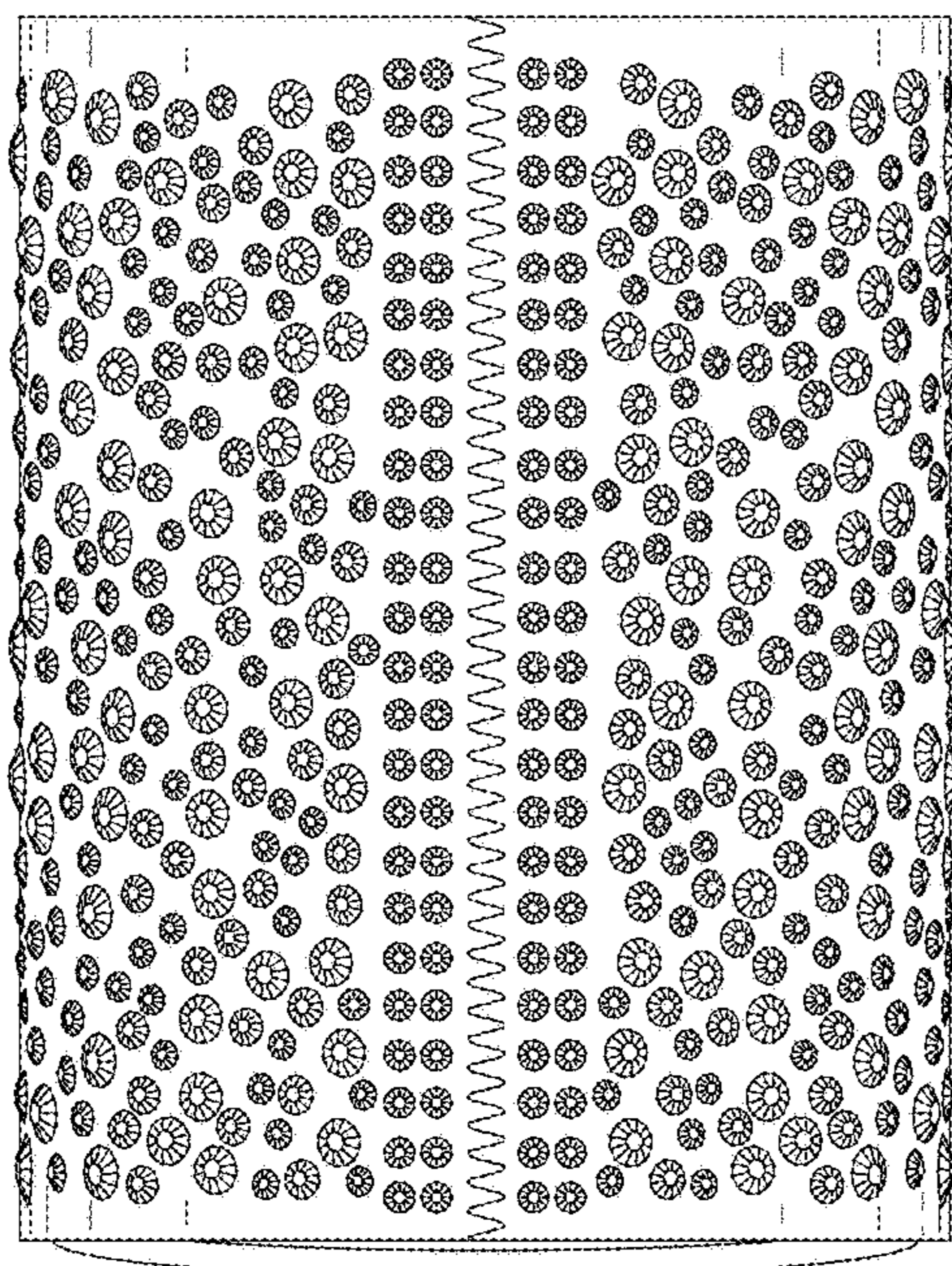
FIG. 1 is a perspective view of a first embodiment of a drink cozy;

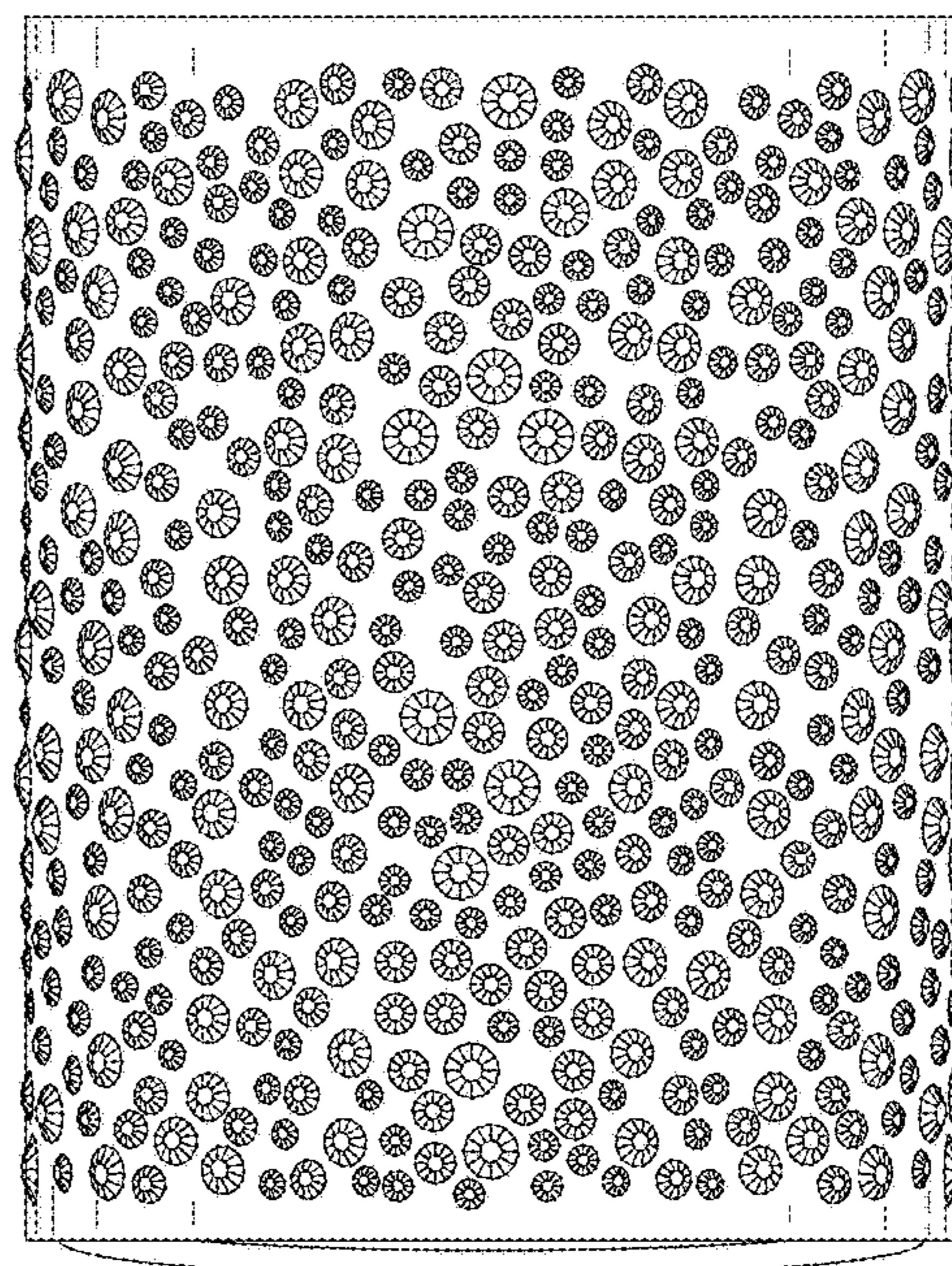




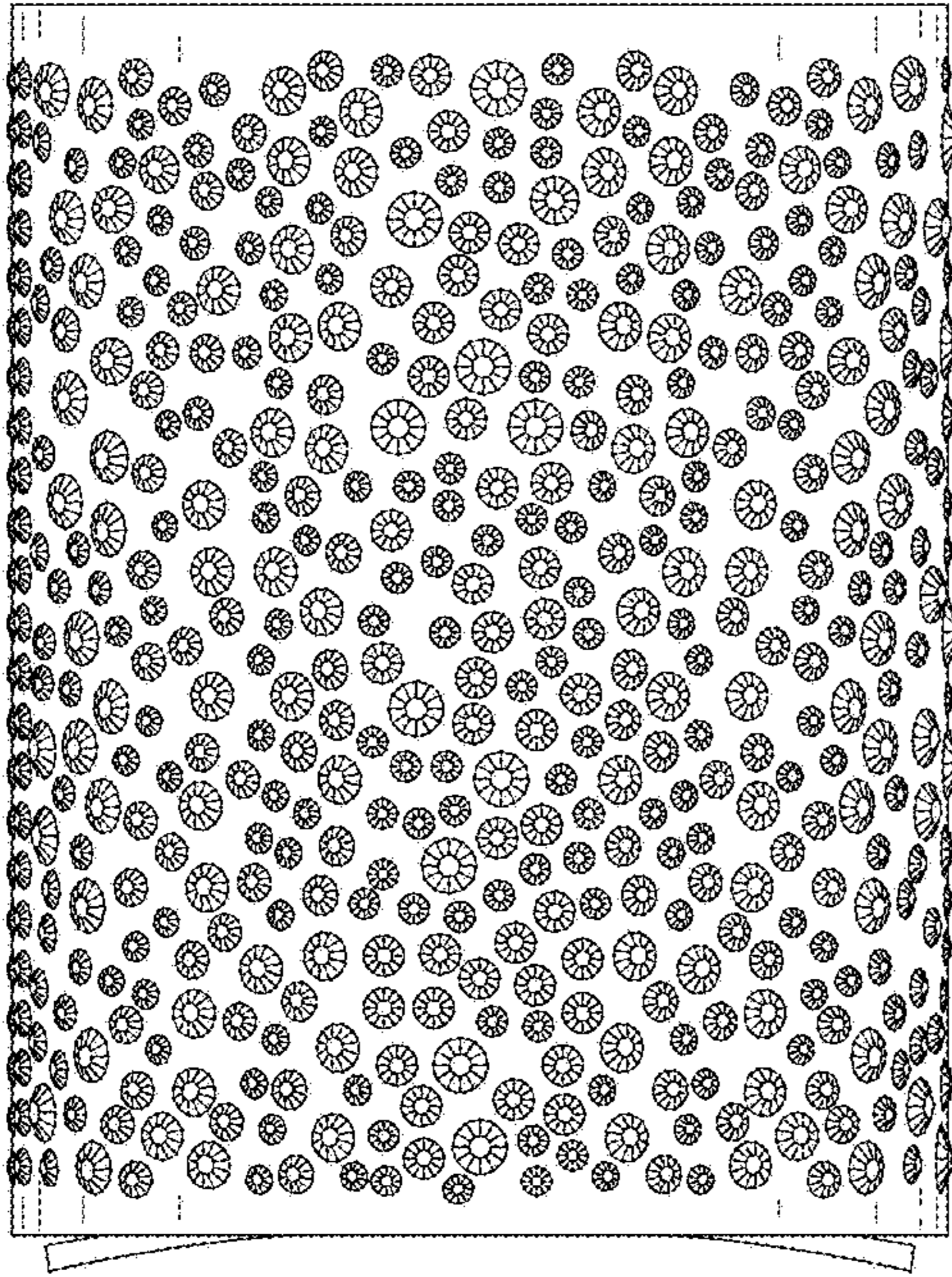

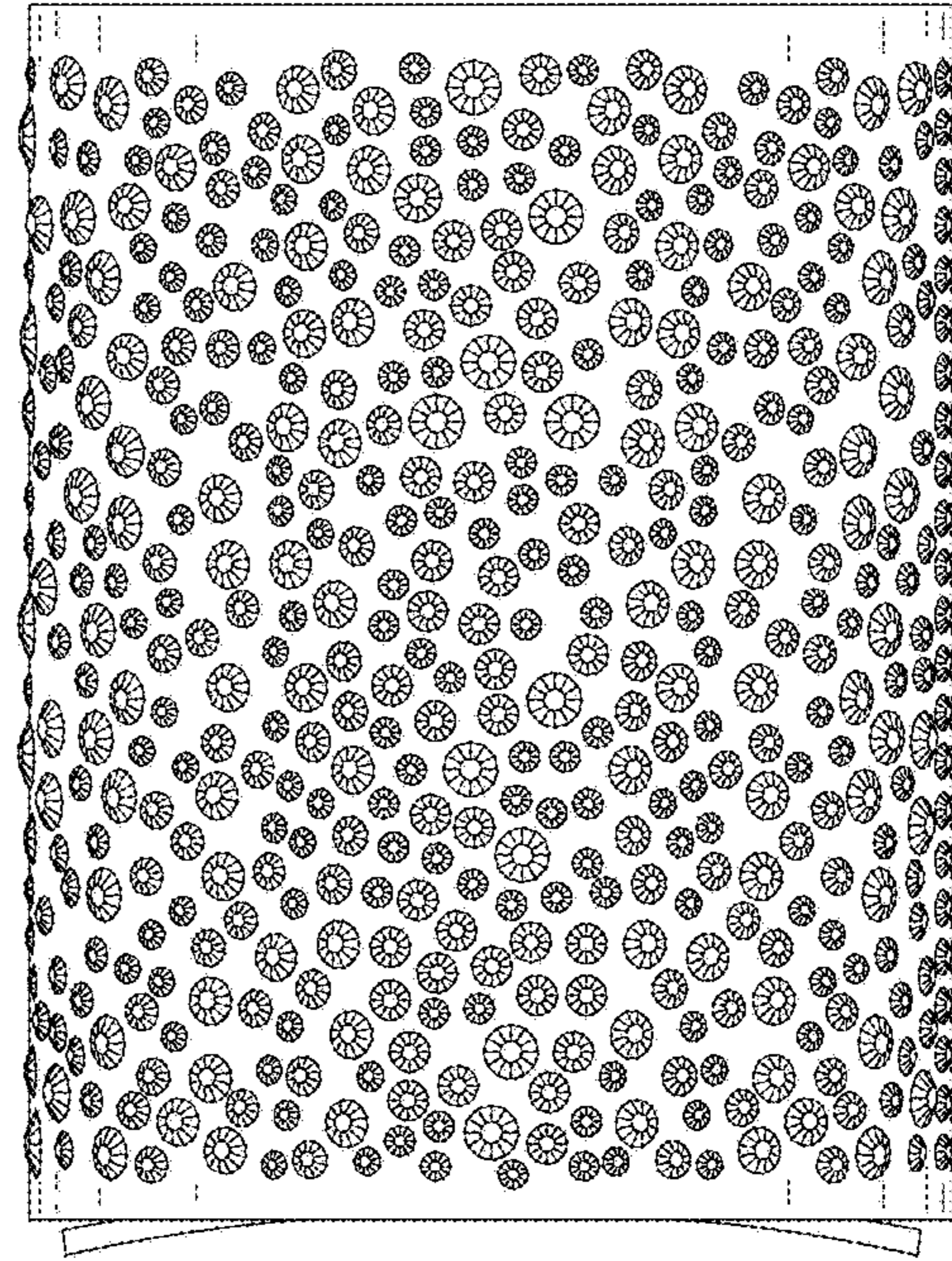

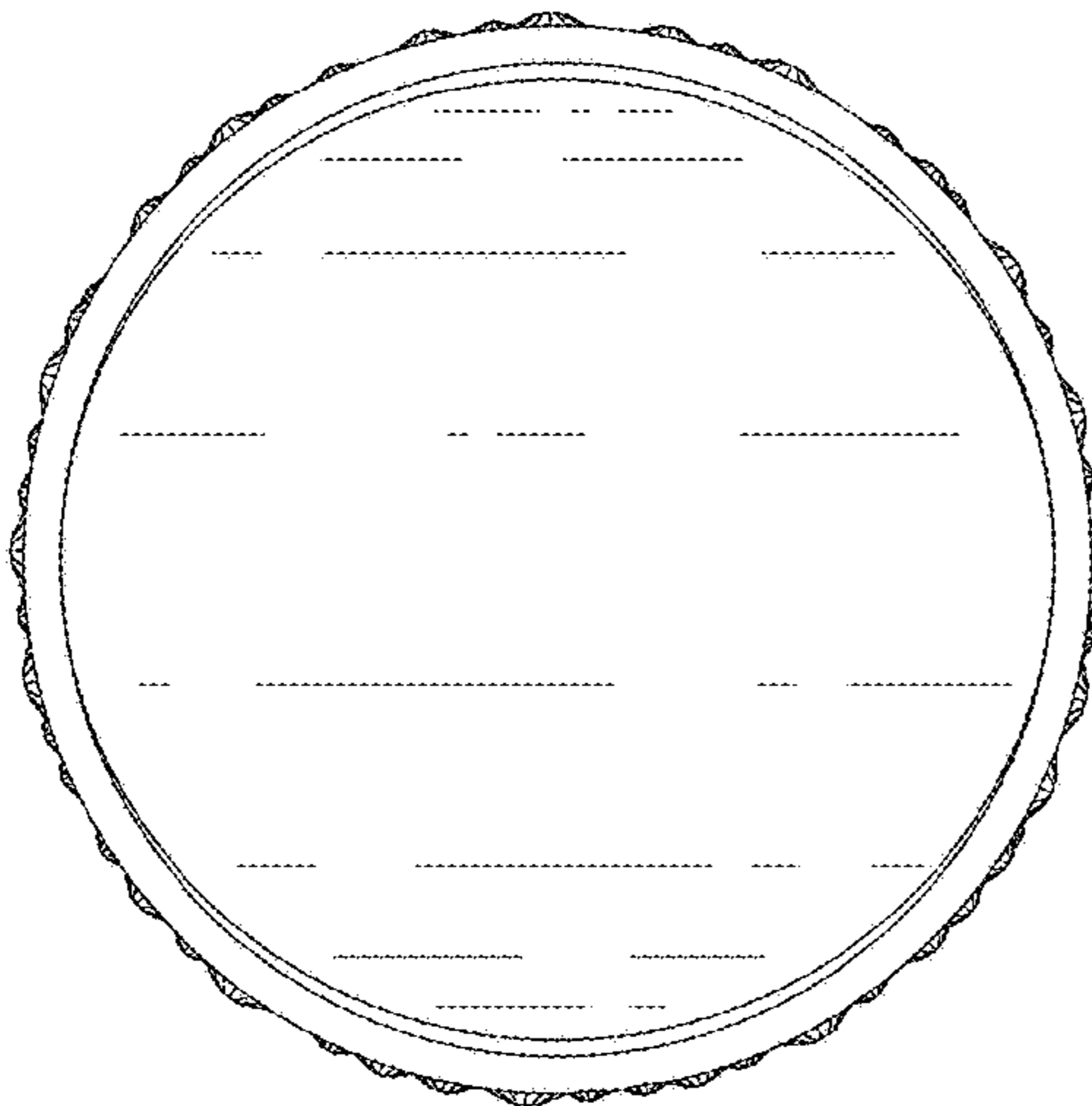

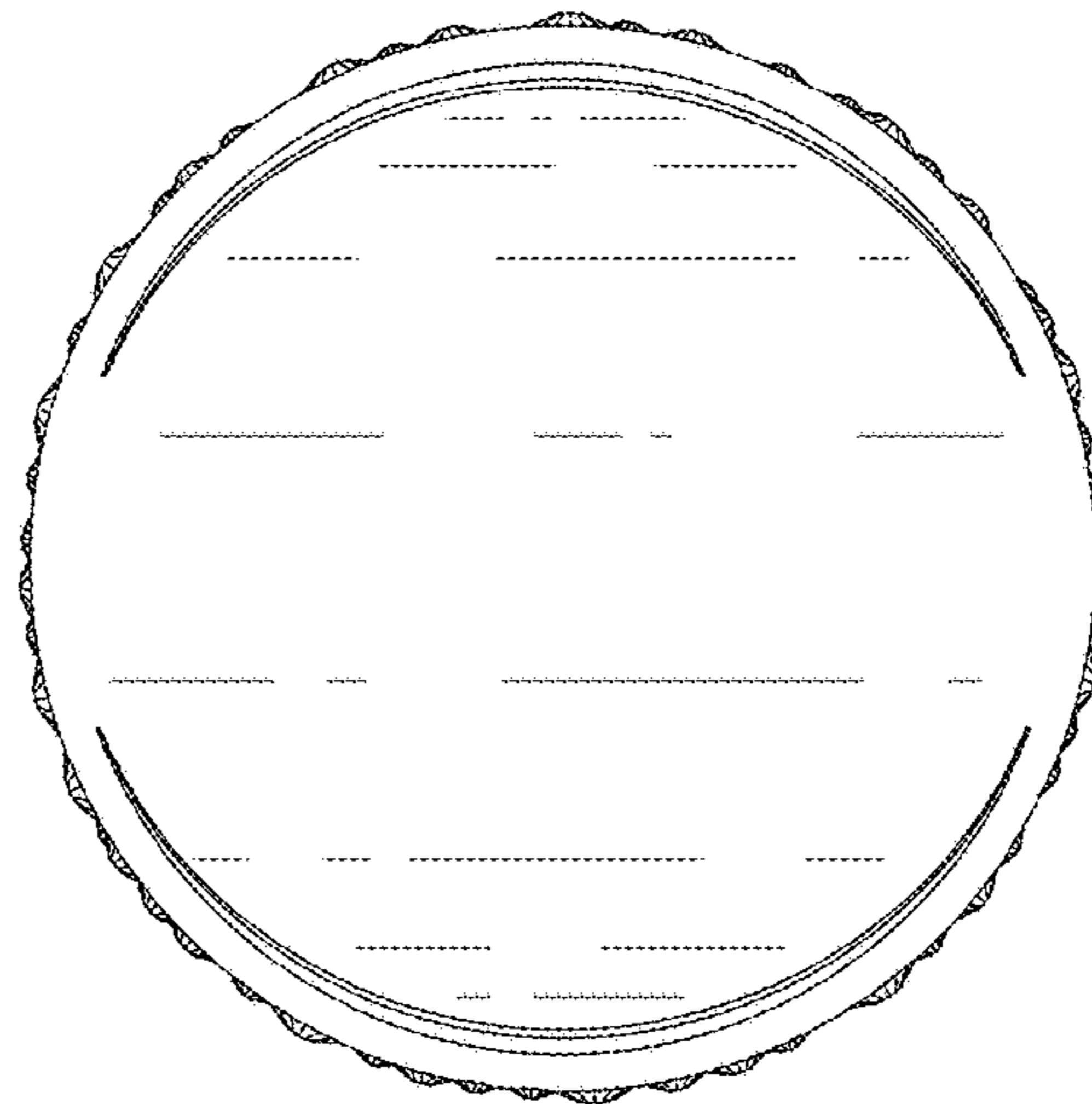

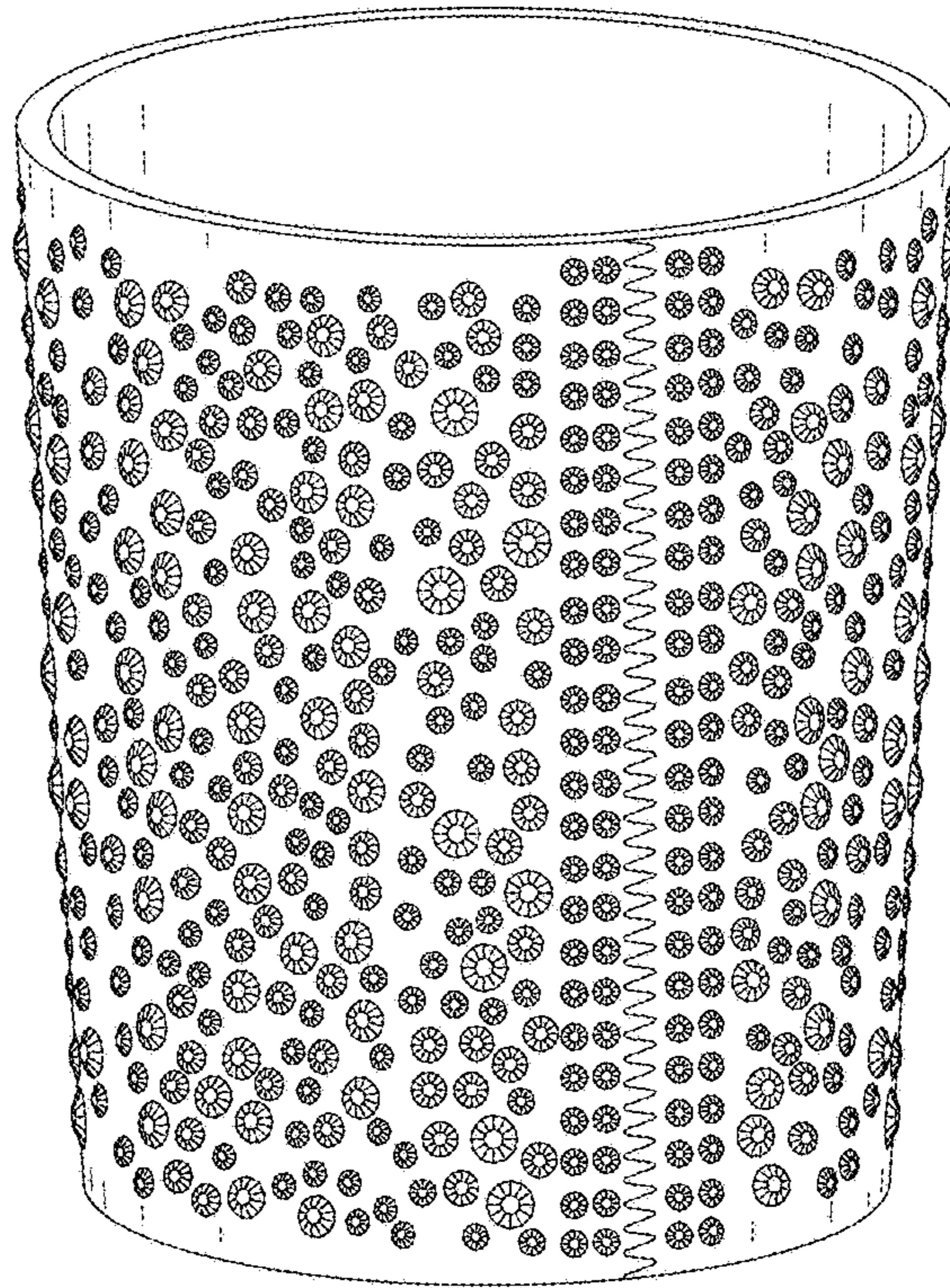

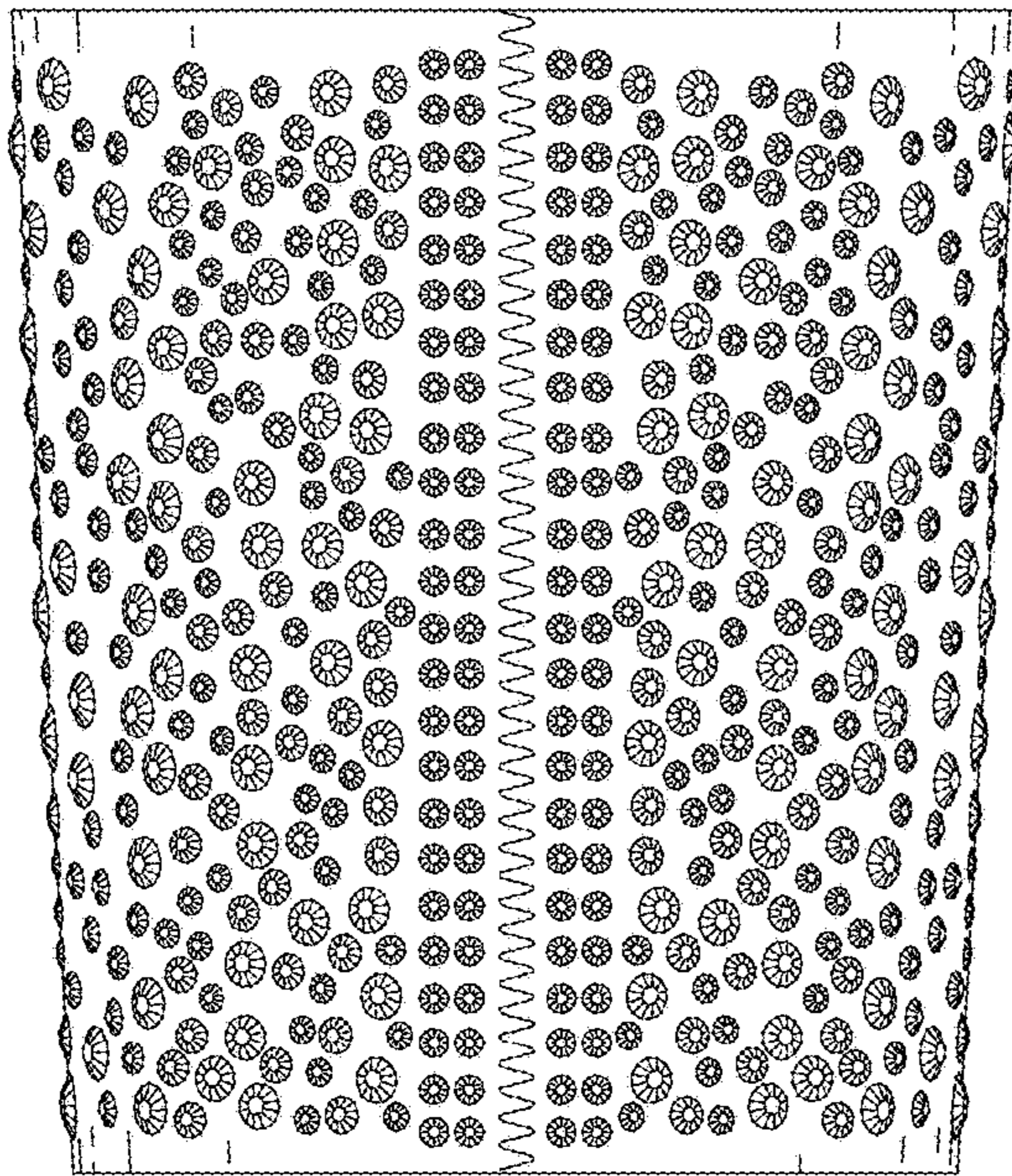

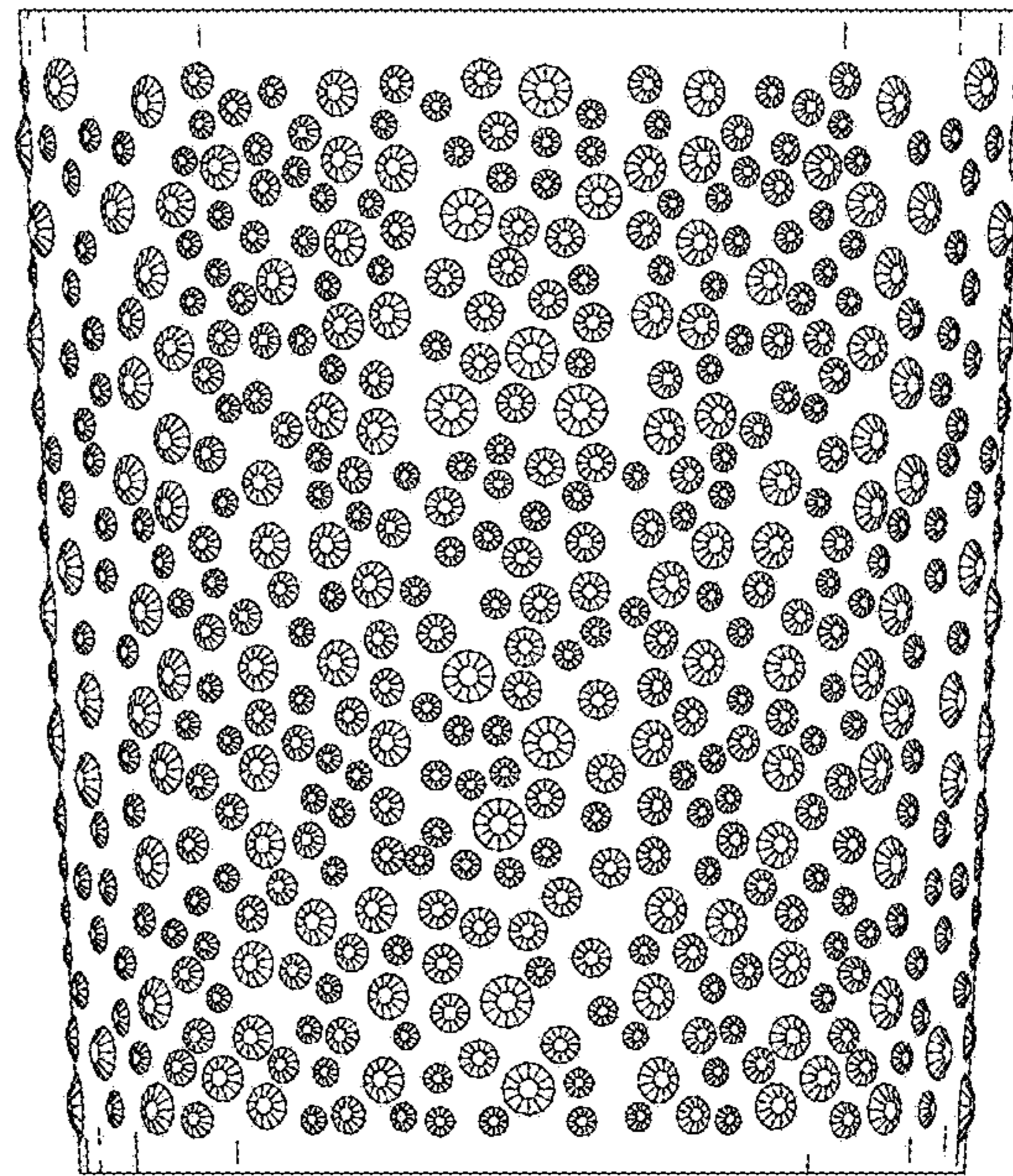

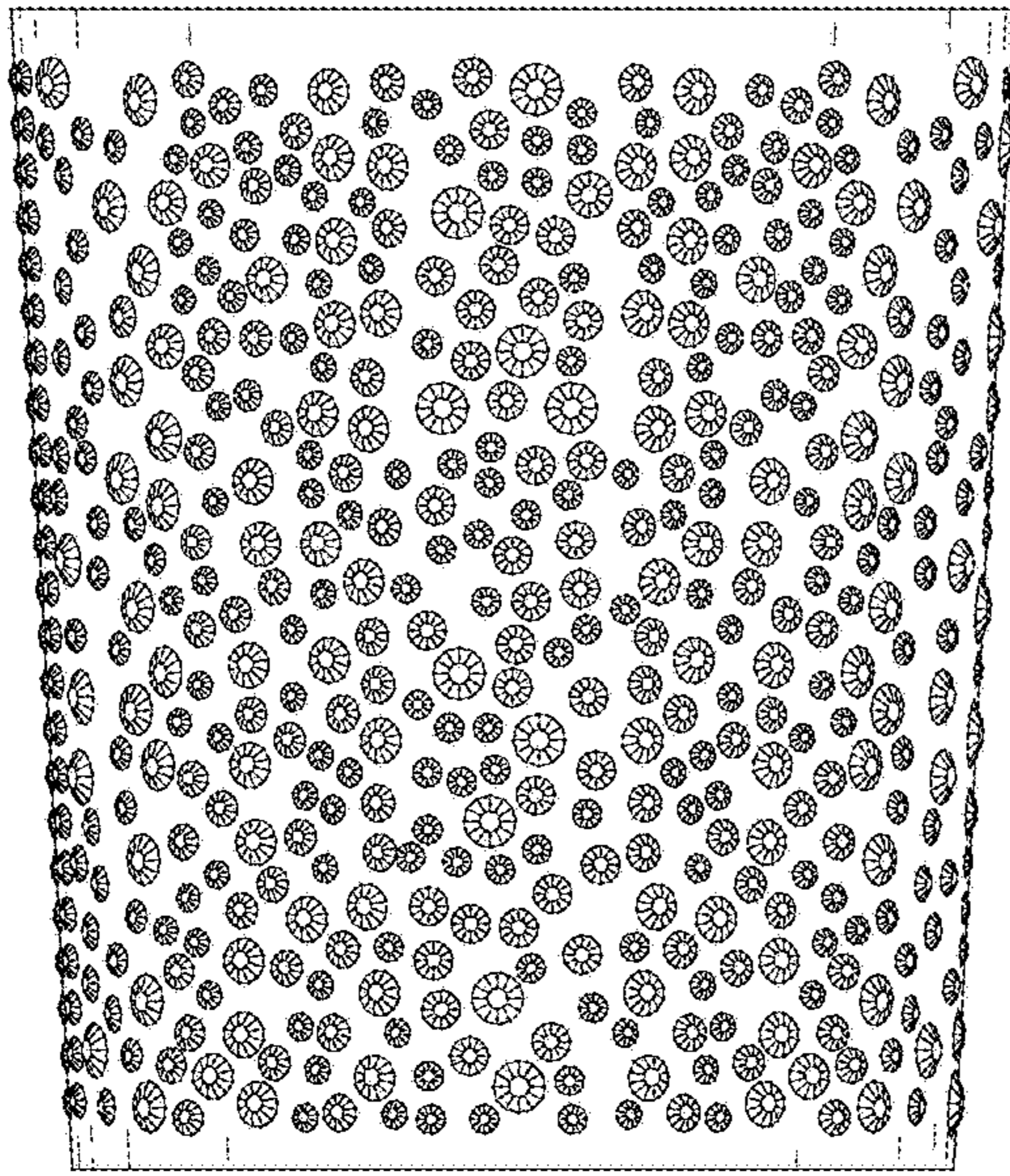

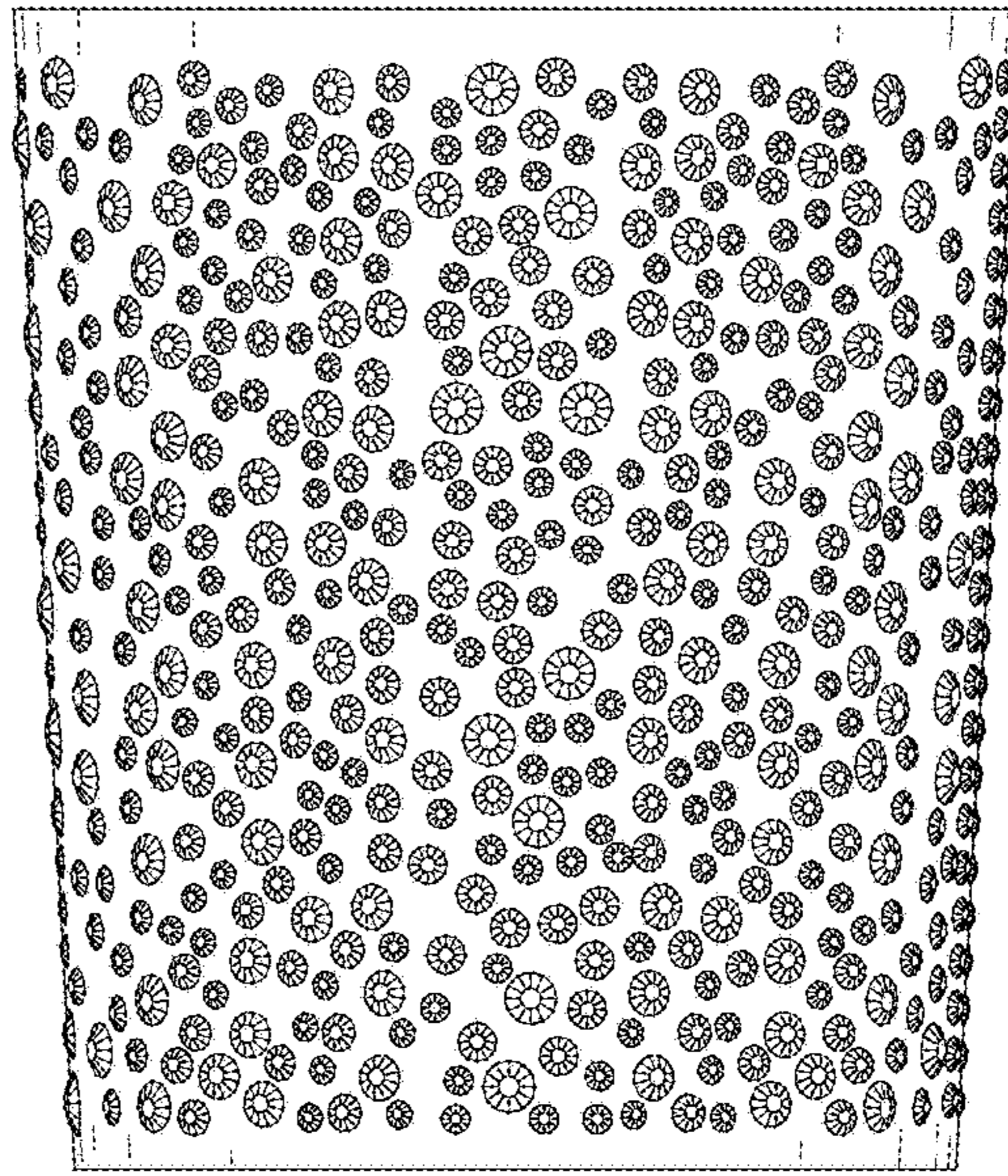

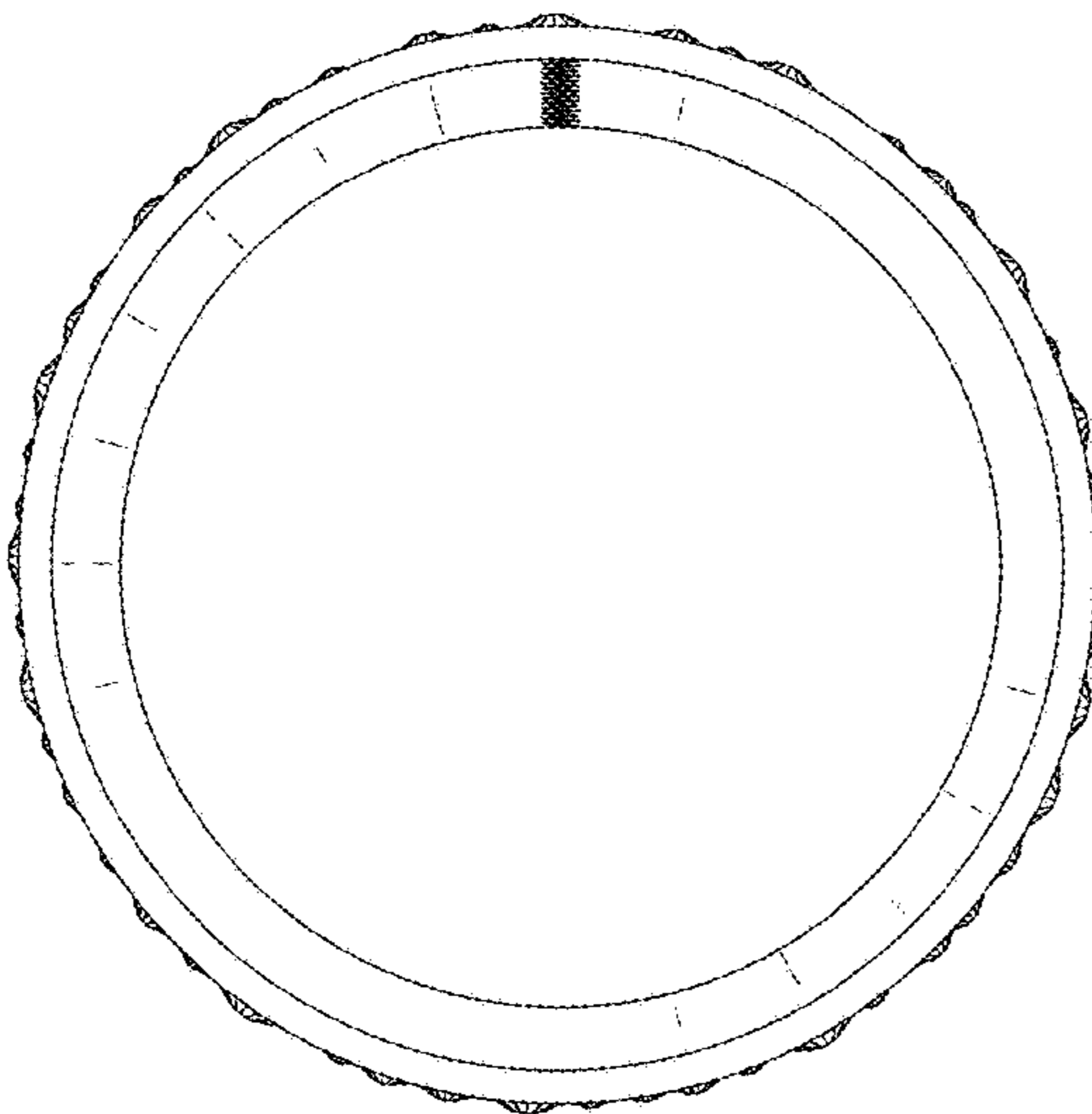

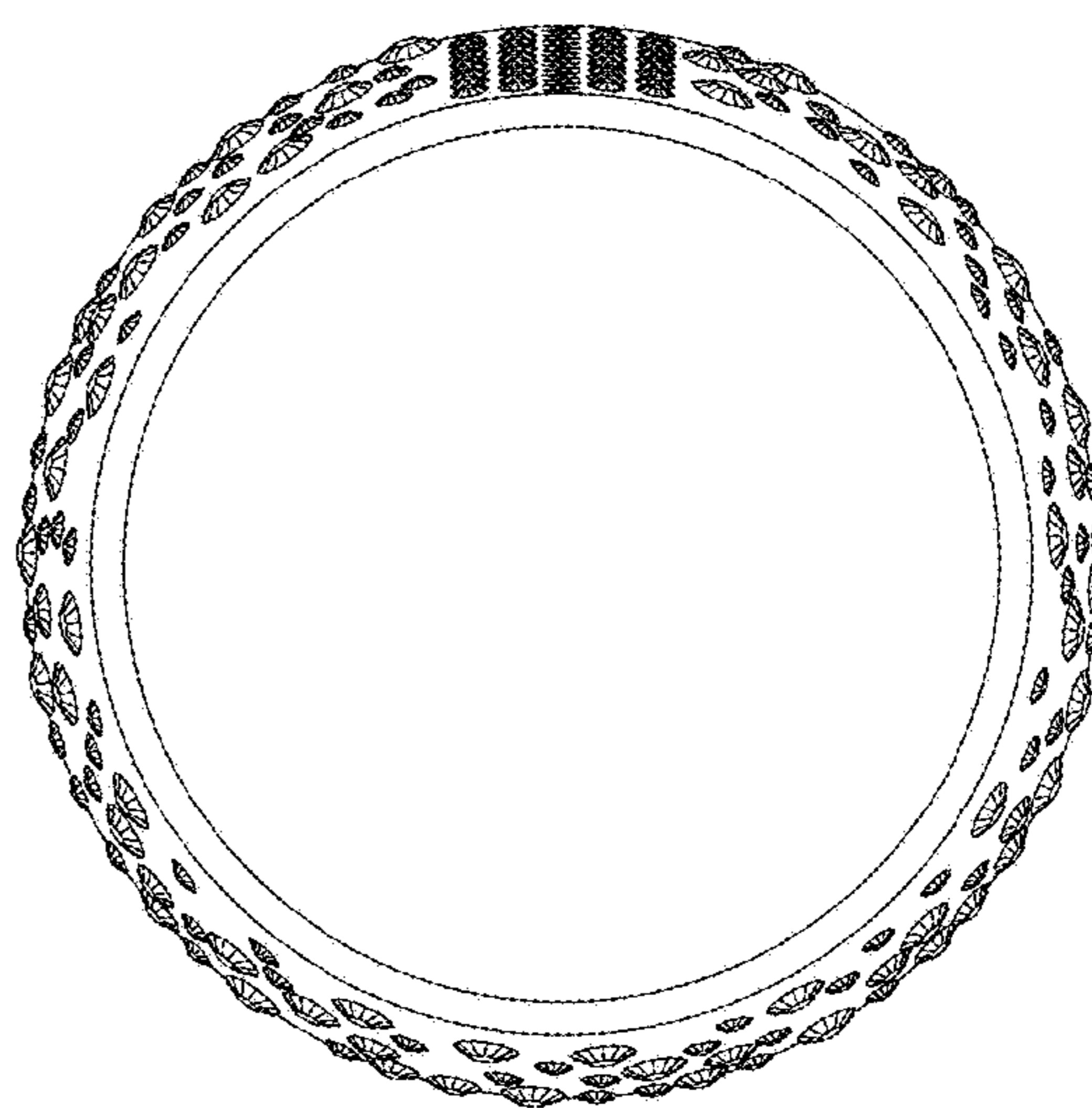
