We claim the ornamental design for a wipes dispenser with
surface ornamentation, as shown and described.

DESCRIPTION

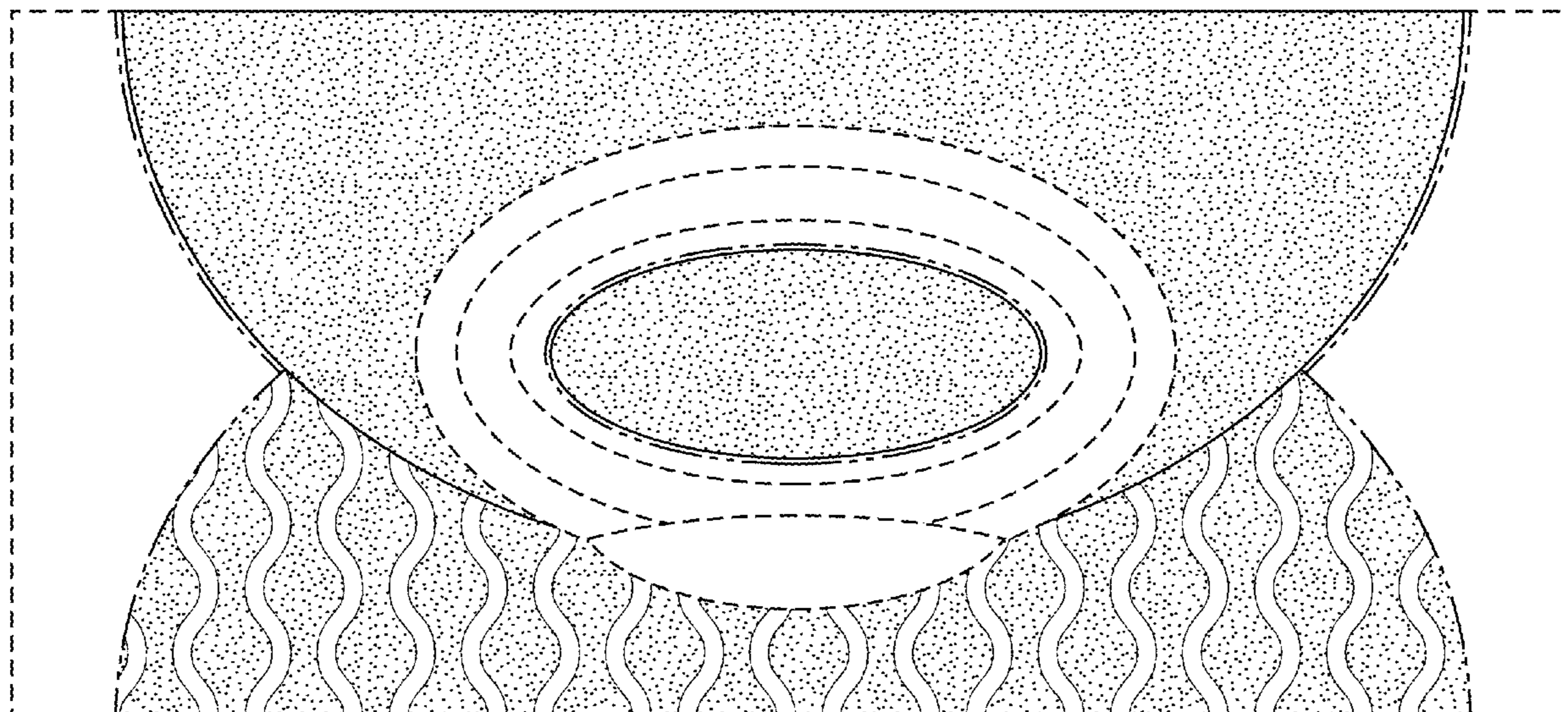
FIG. 1 is a top elevation view of a wipes dispenser with
surface ornamentation showing our new design;
FIG. 2 is a bottom elevation view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof; and,
FIG. 5 is a front elevation view thereof.

The surface shading represents contrasted color(s) but not a
specific color.

The dot-dot-dash lines in the Figures are boundary lines
which show an unclaimed boundary which forms no part of
the claimed design.

The broken lines shown in the drawings represent portions
of the wipes dispenser that form no part of the claimed
design.

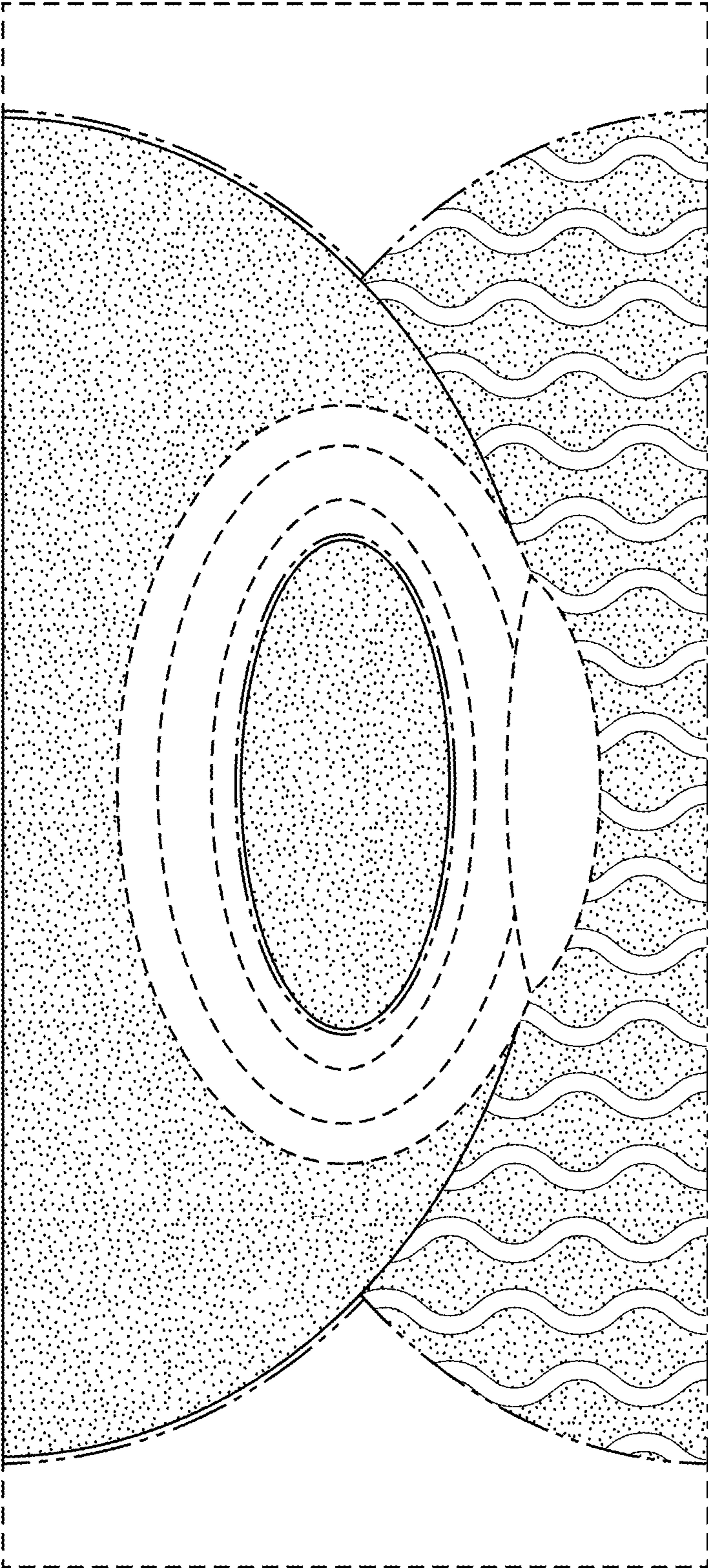

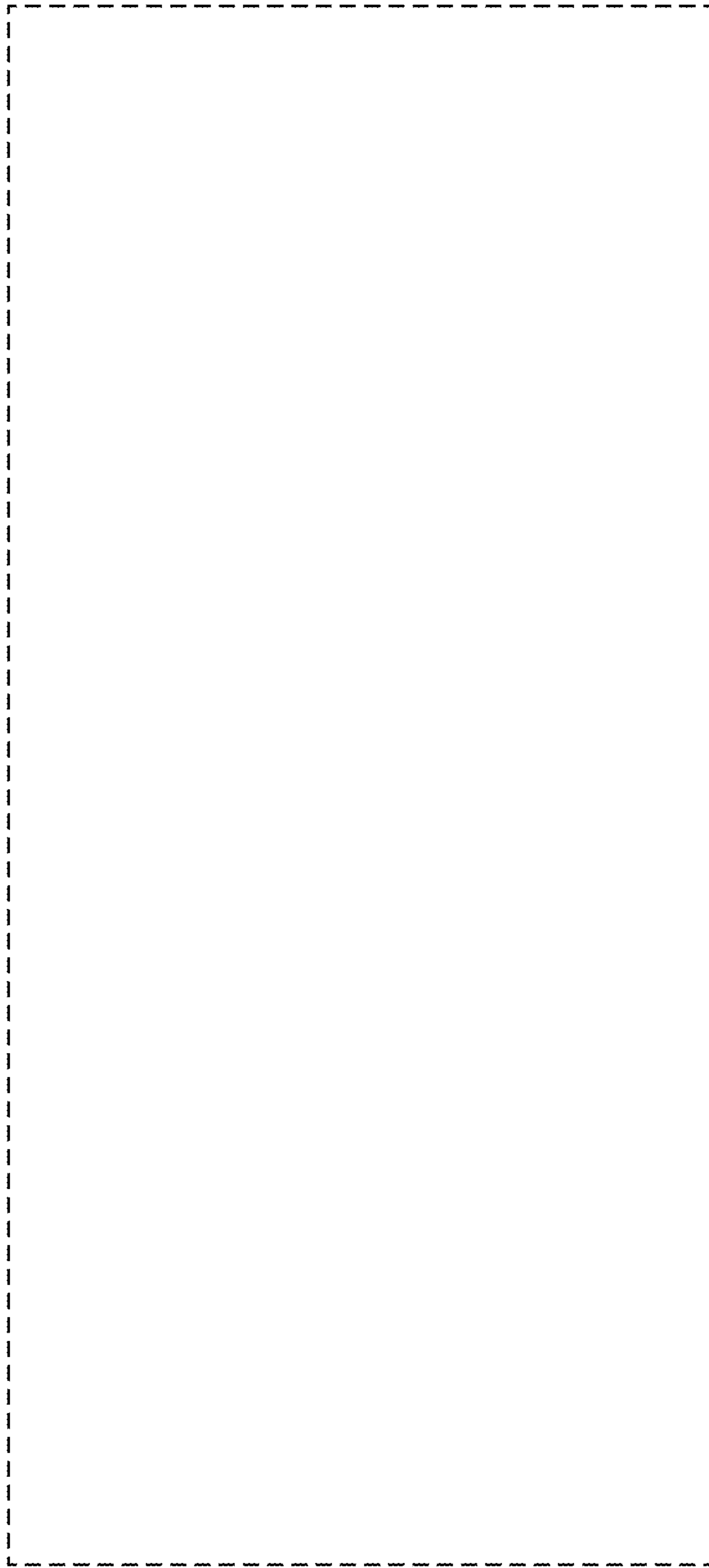

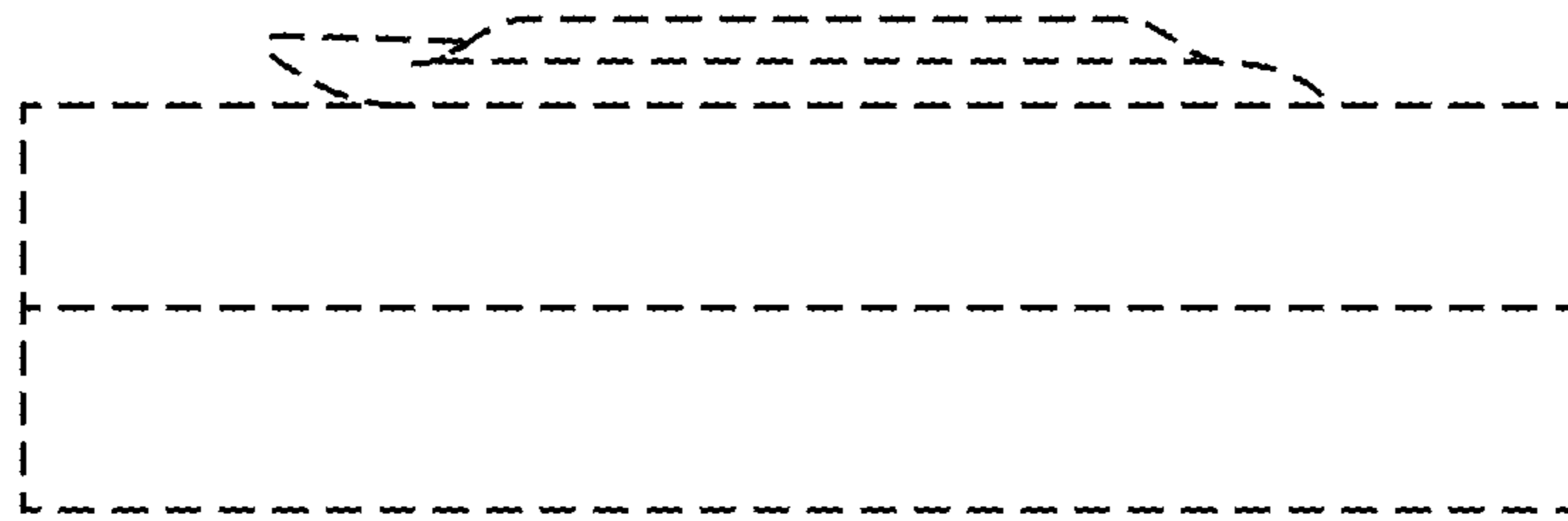

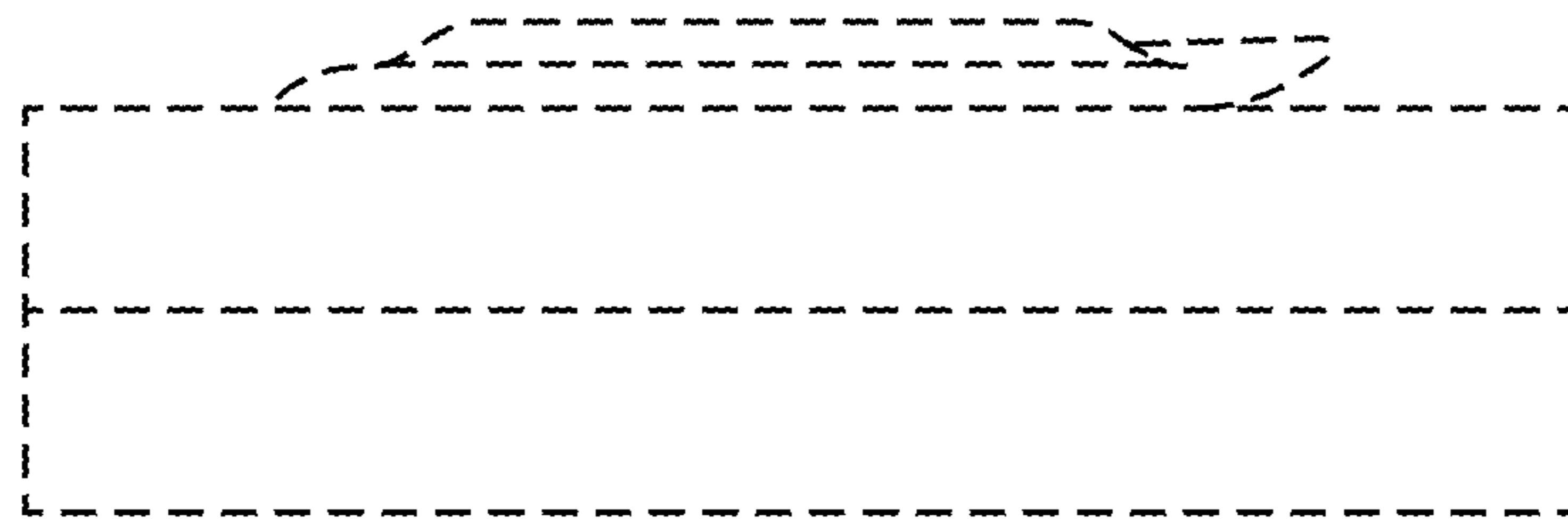

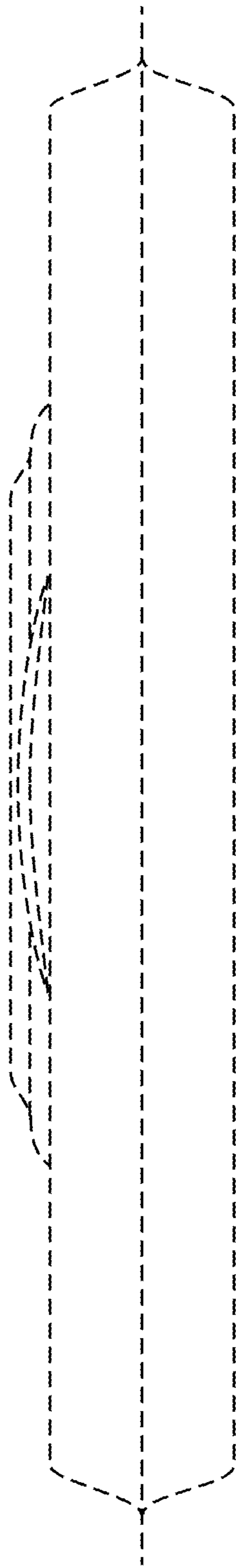
