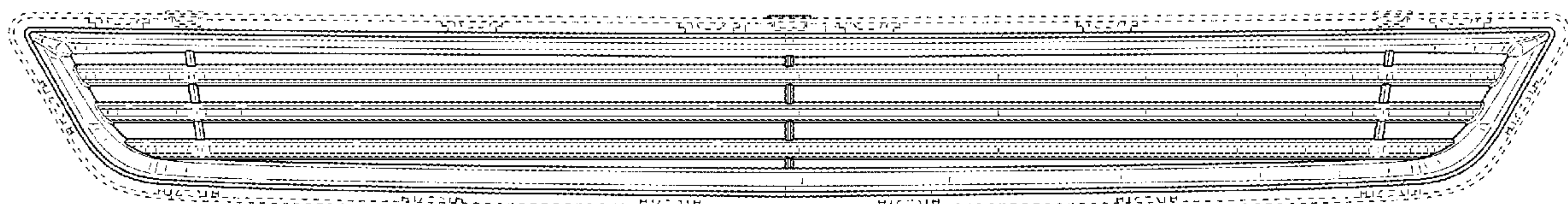
The ornamental design for the lower grille, as shown and described.

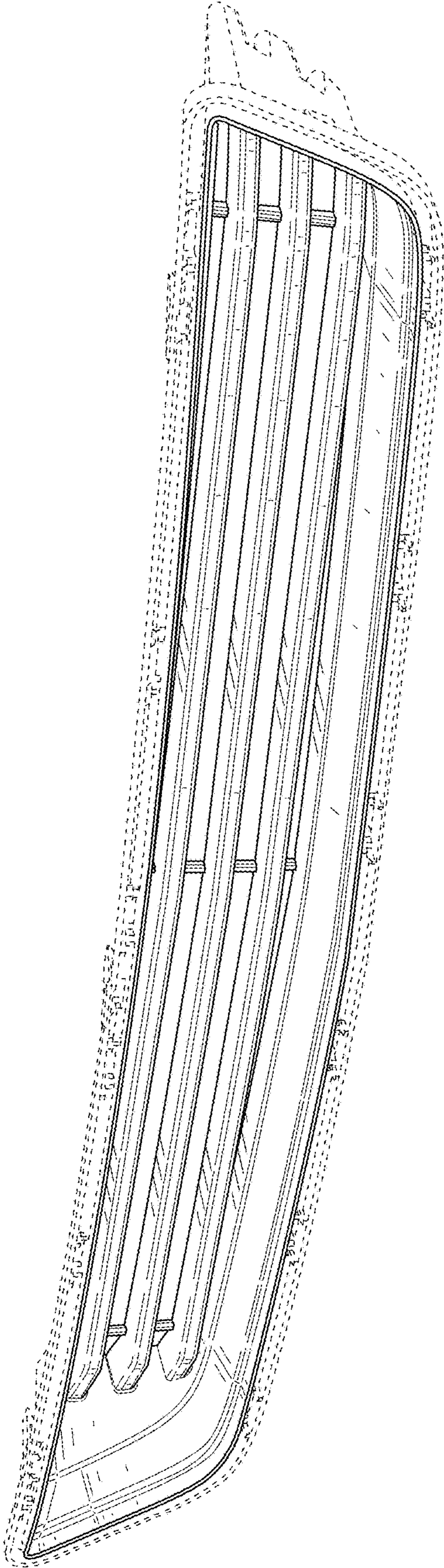

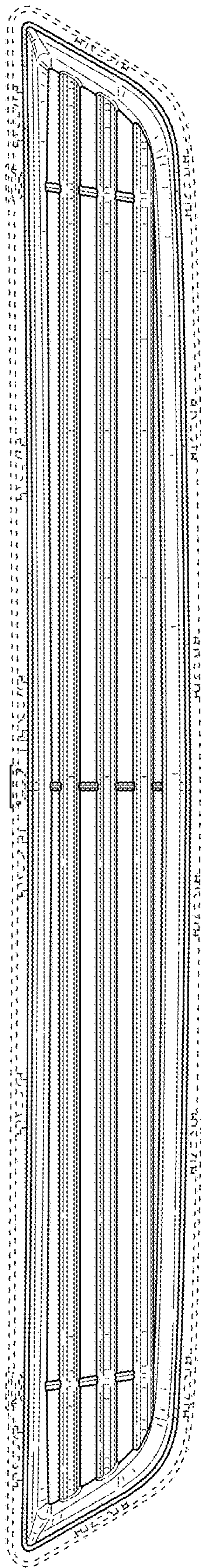

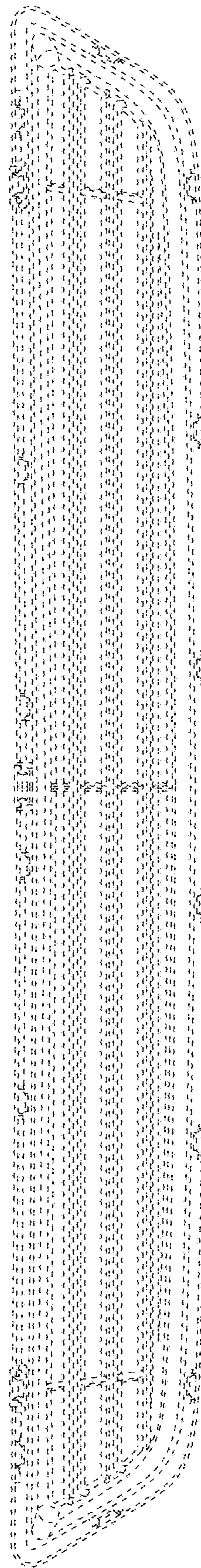

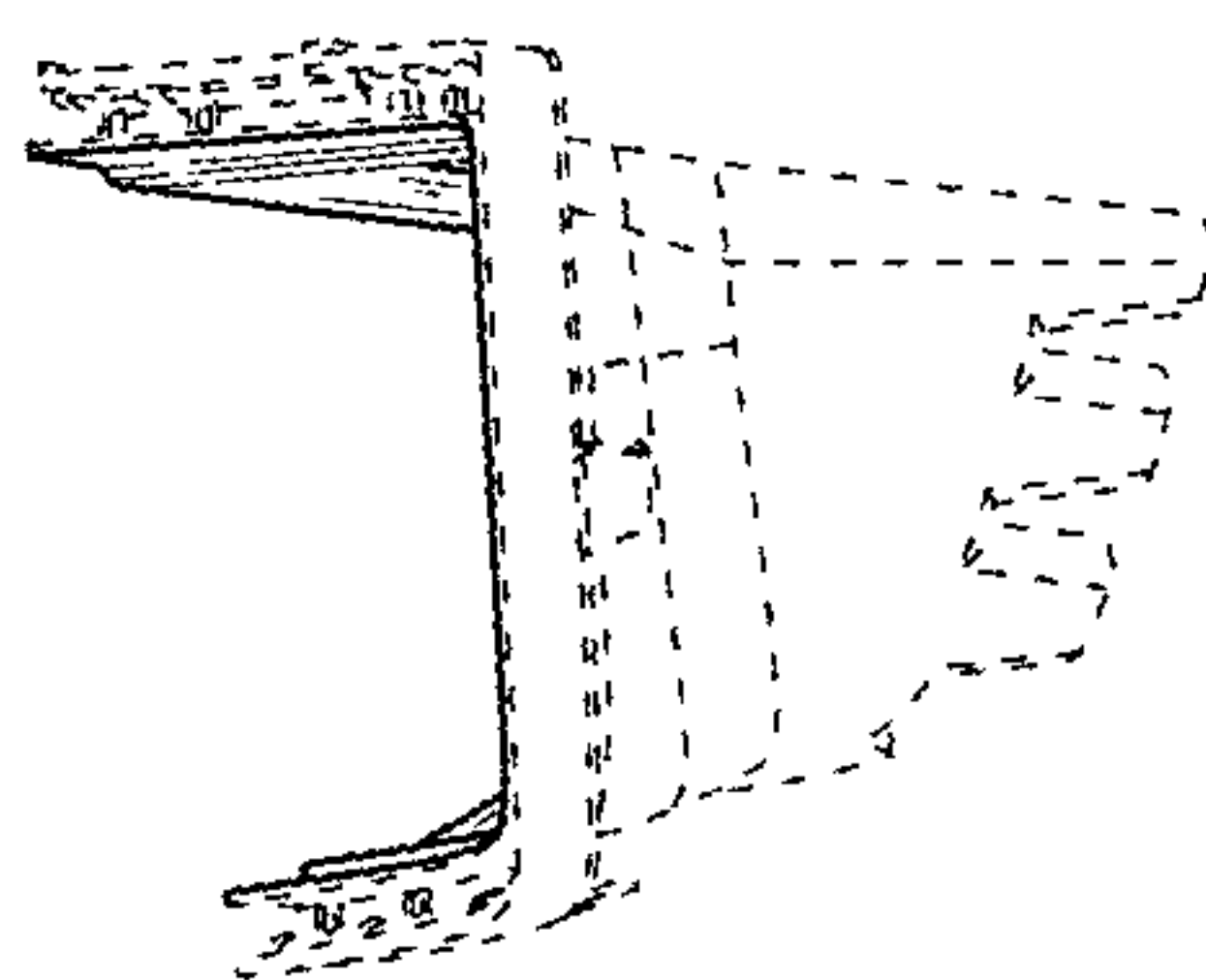

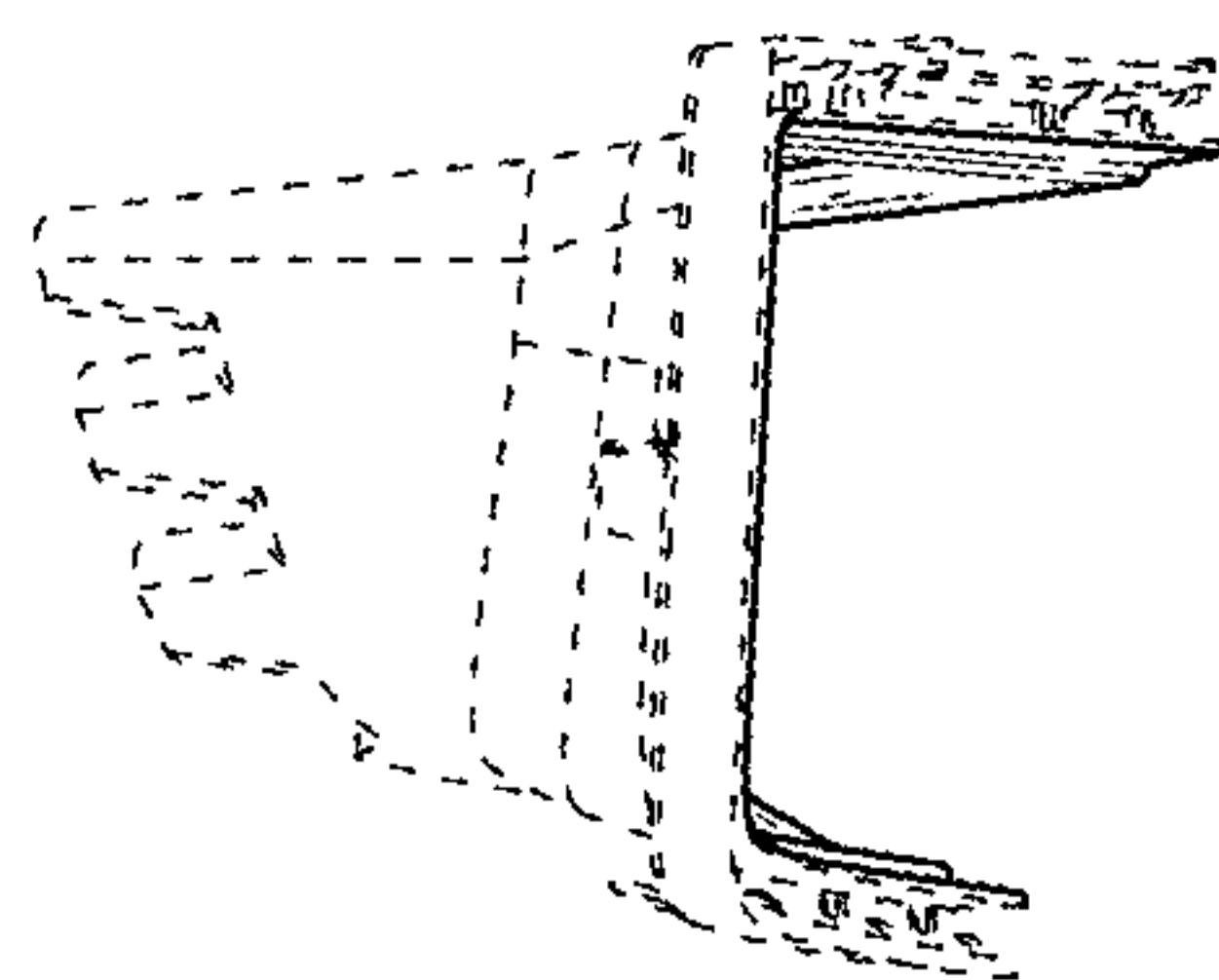

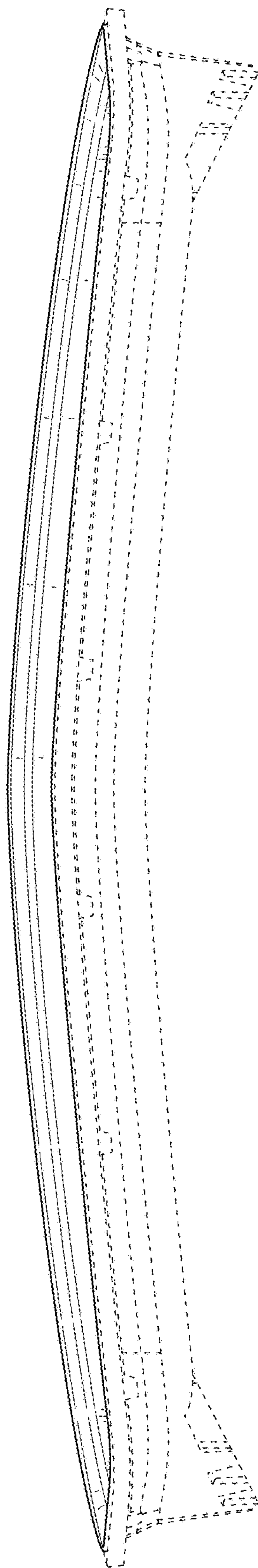

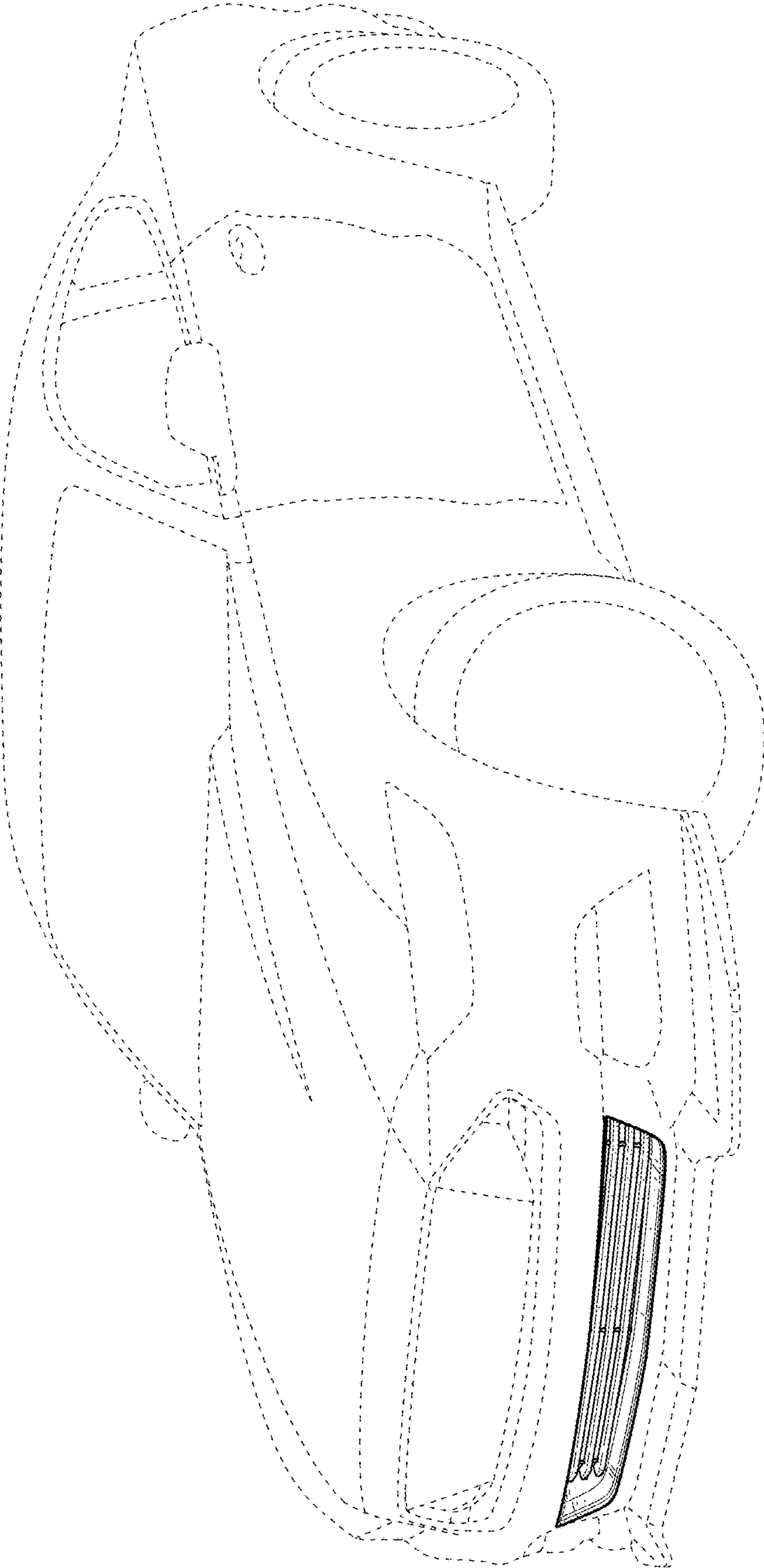
