**DESCRIPTION**

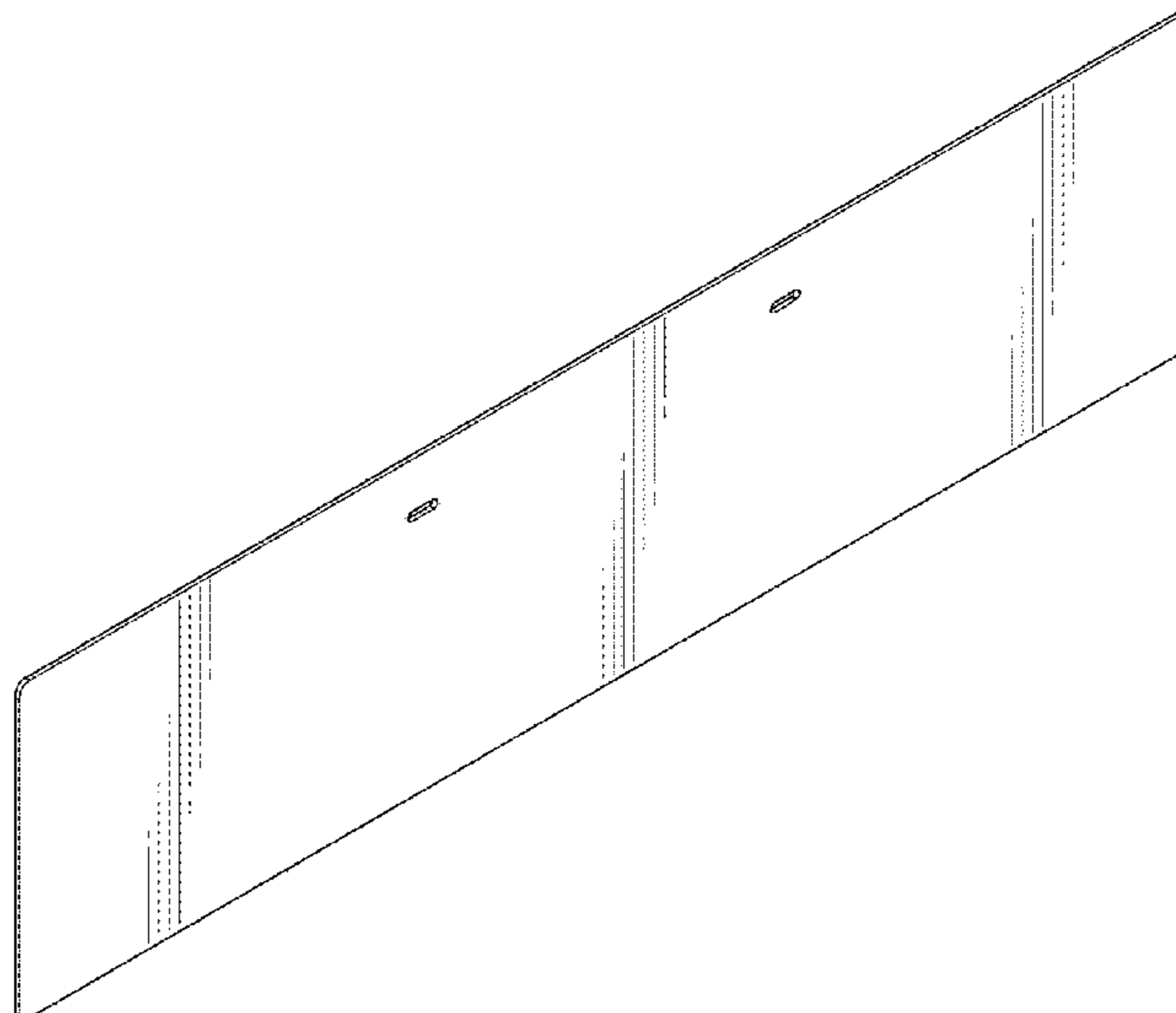
FIG. 1 is a front isometric view of the license plate cover of the present invention;

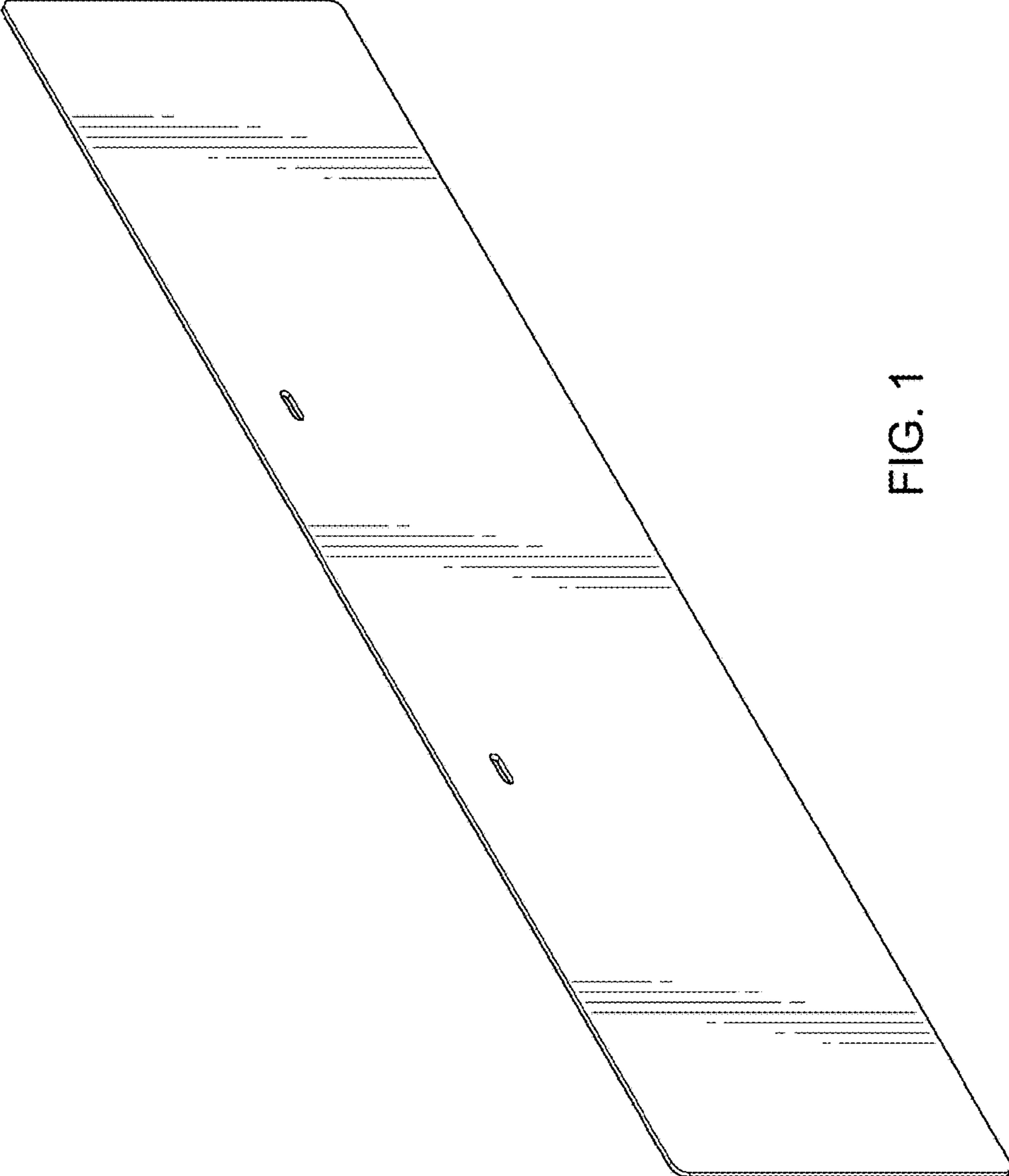

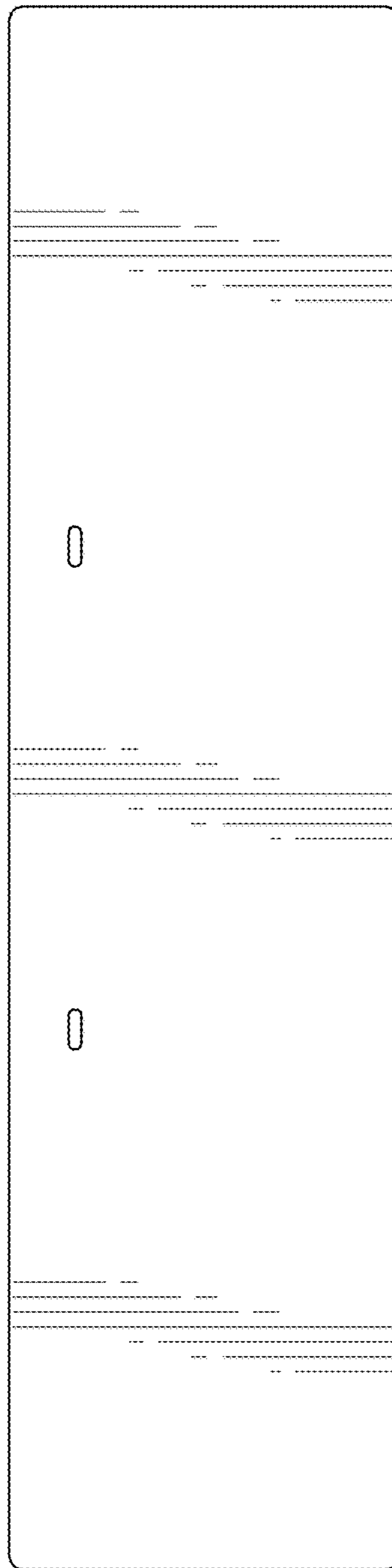

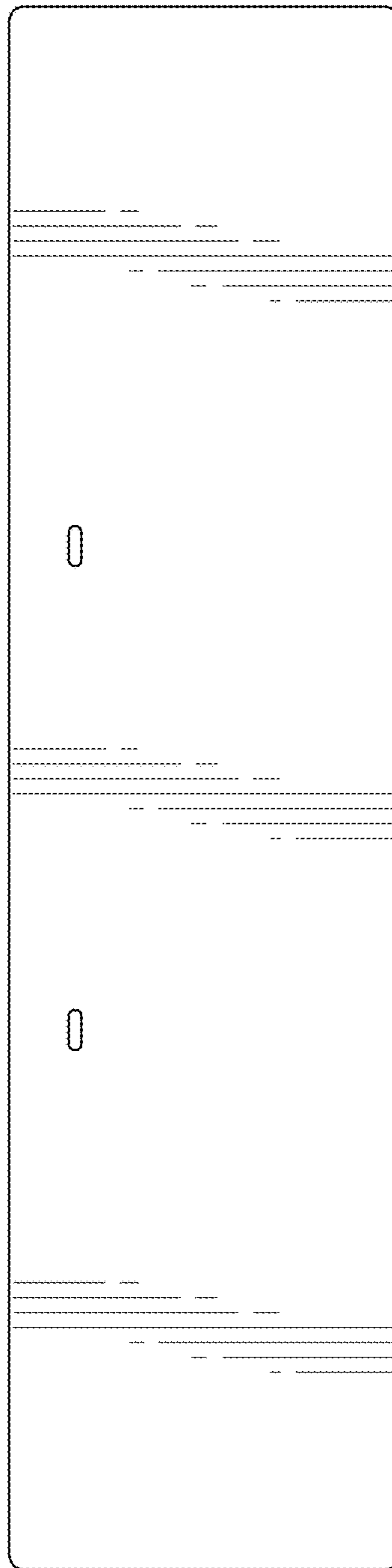

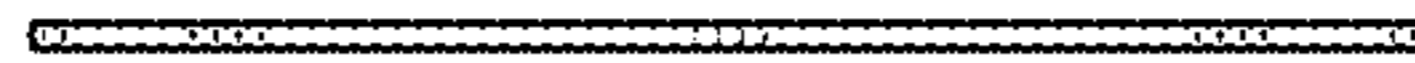
