The ornamental design for an off-road vehicle side panel, as shown and described.

DESCRIPTION

FIG. 15 is a bottom plan view thereof;

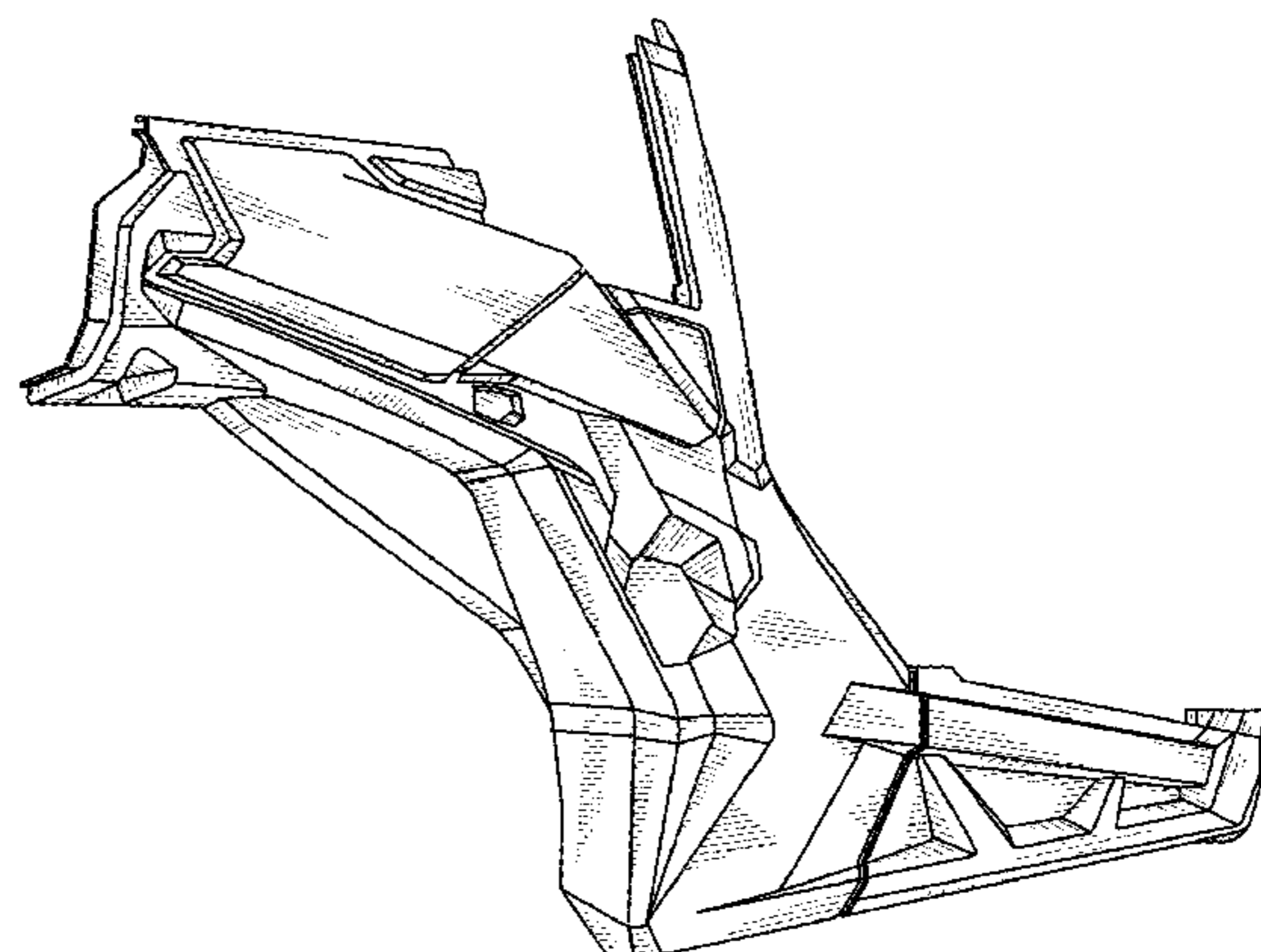
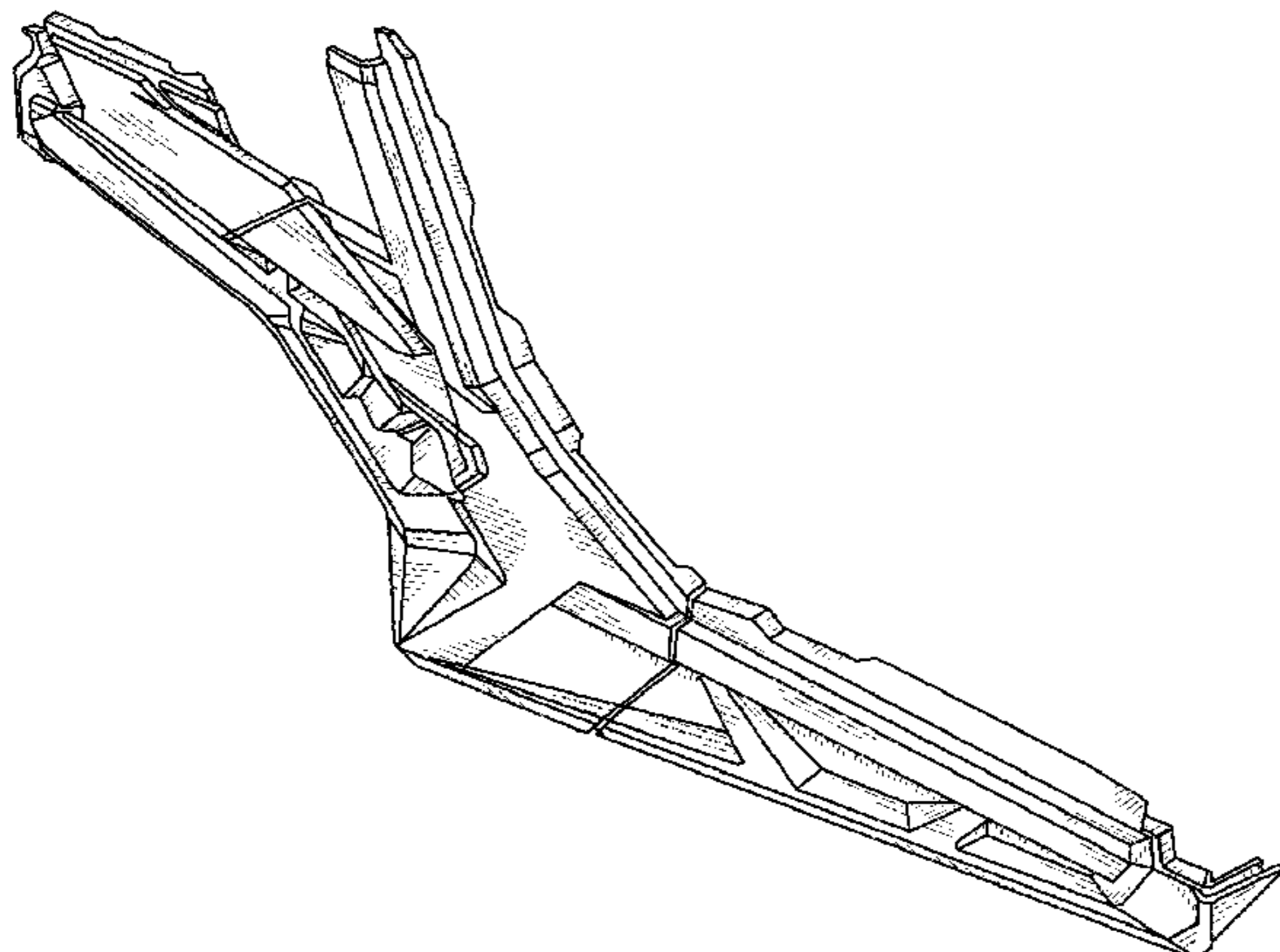
FIG. 16 is a perspective view taken from a front, left side thereof;

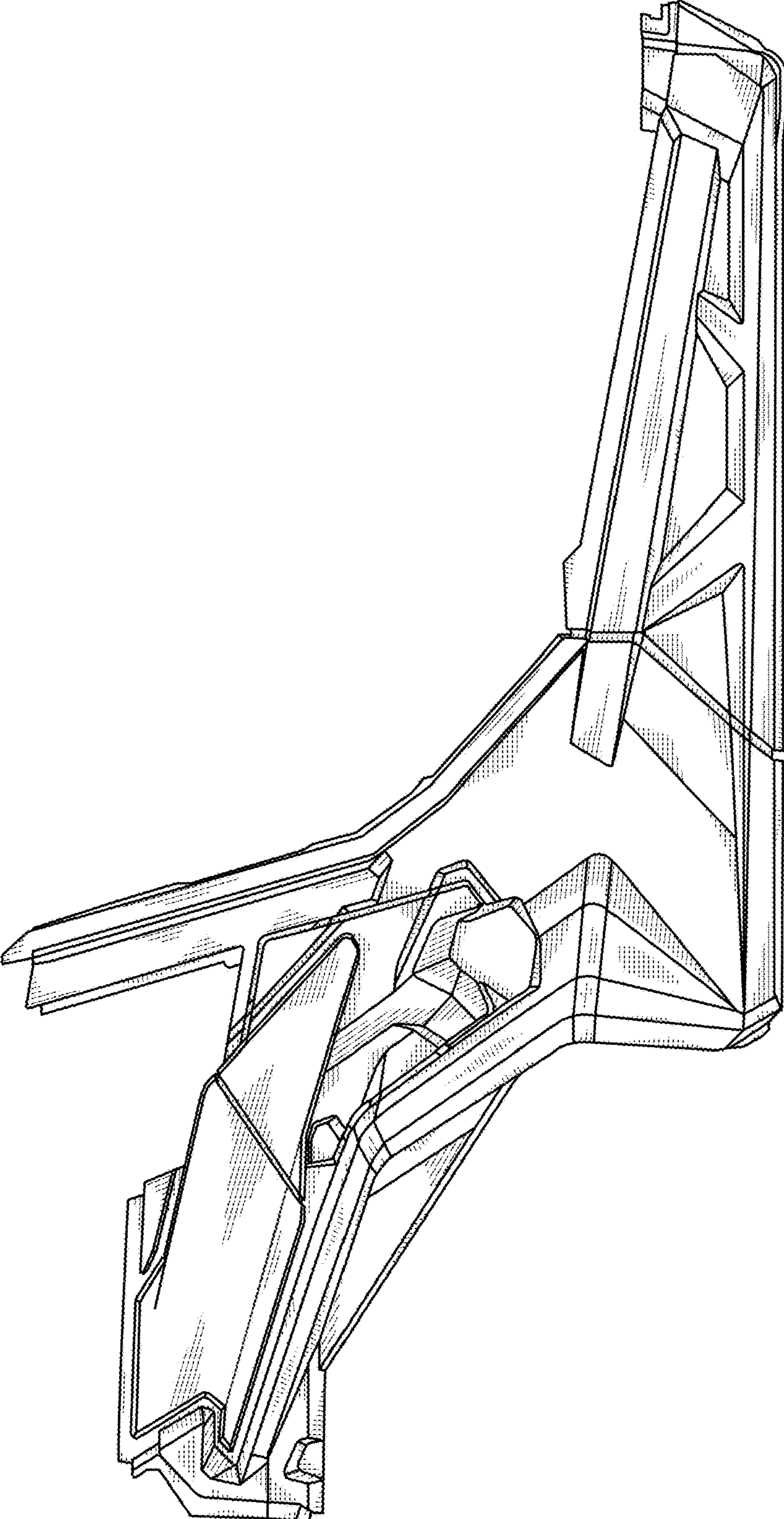

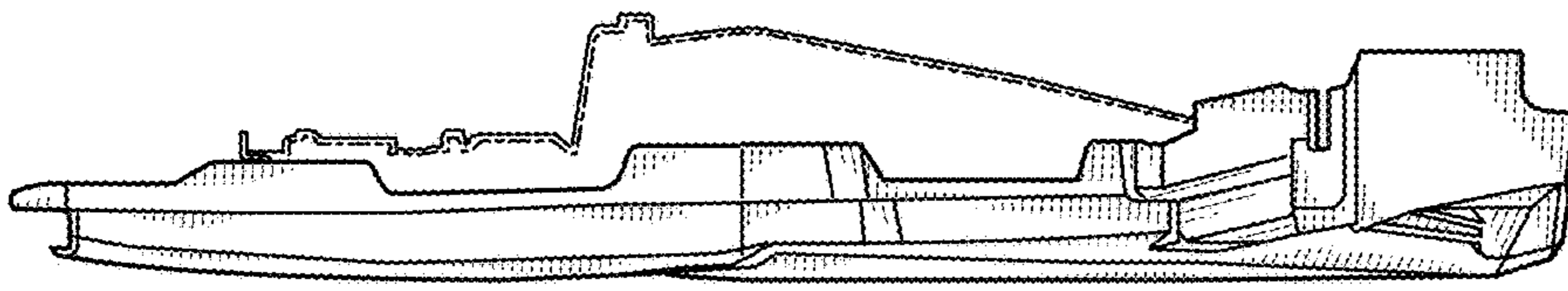

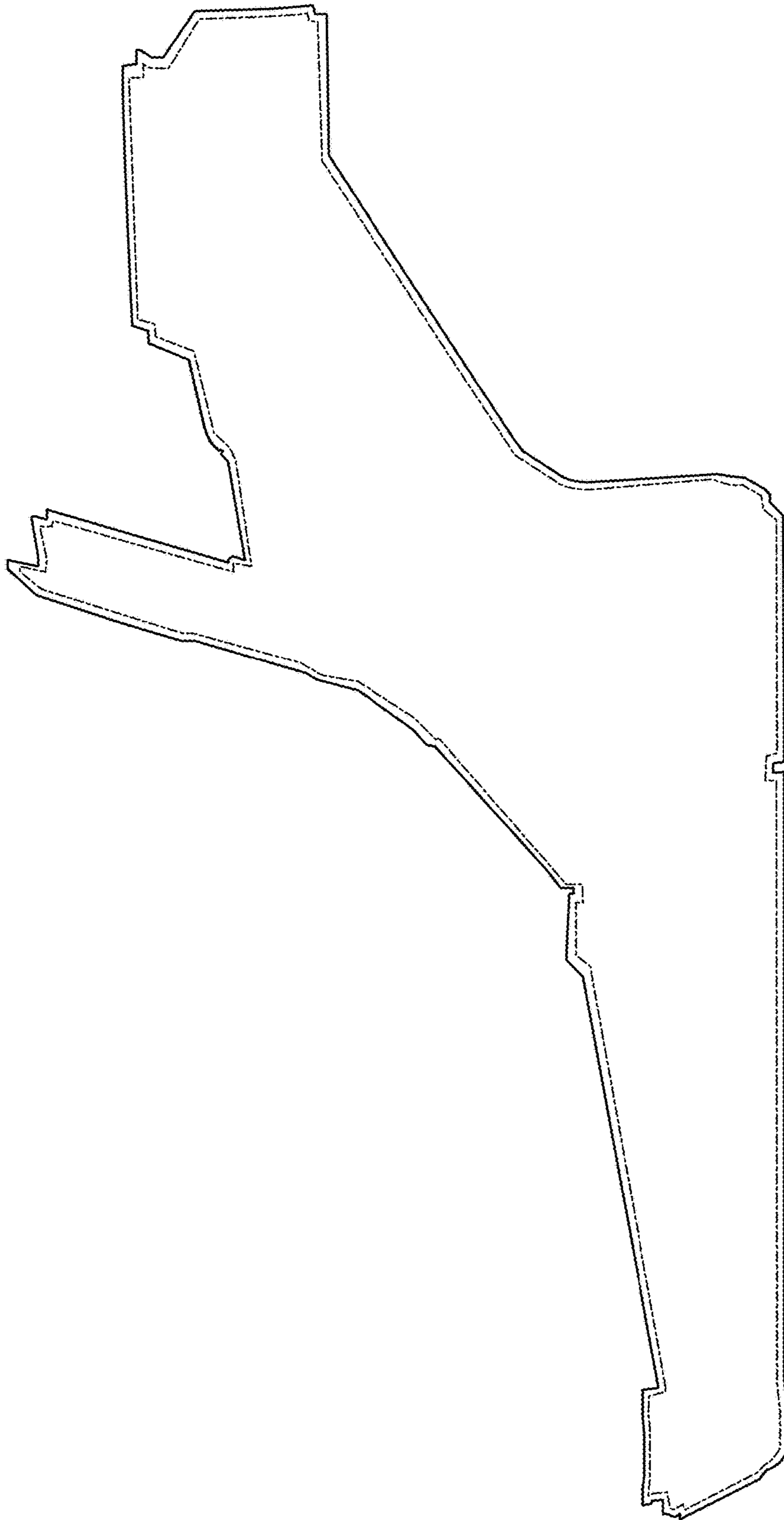

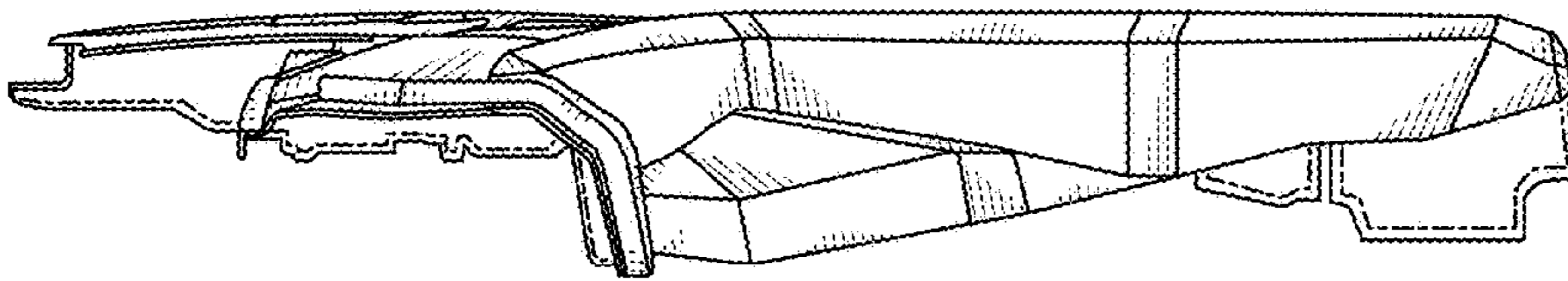

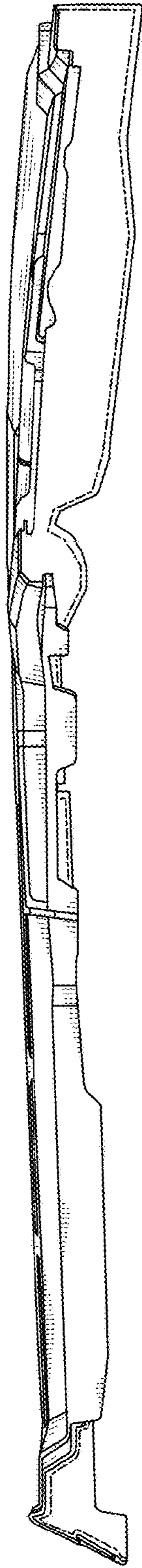

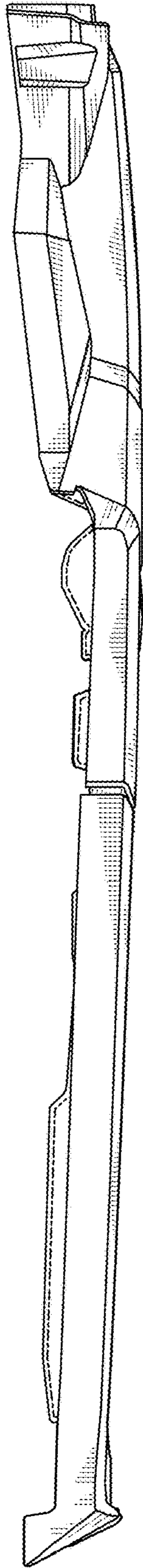

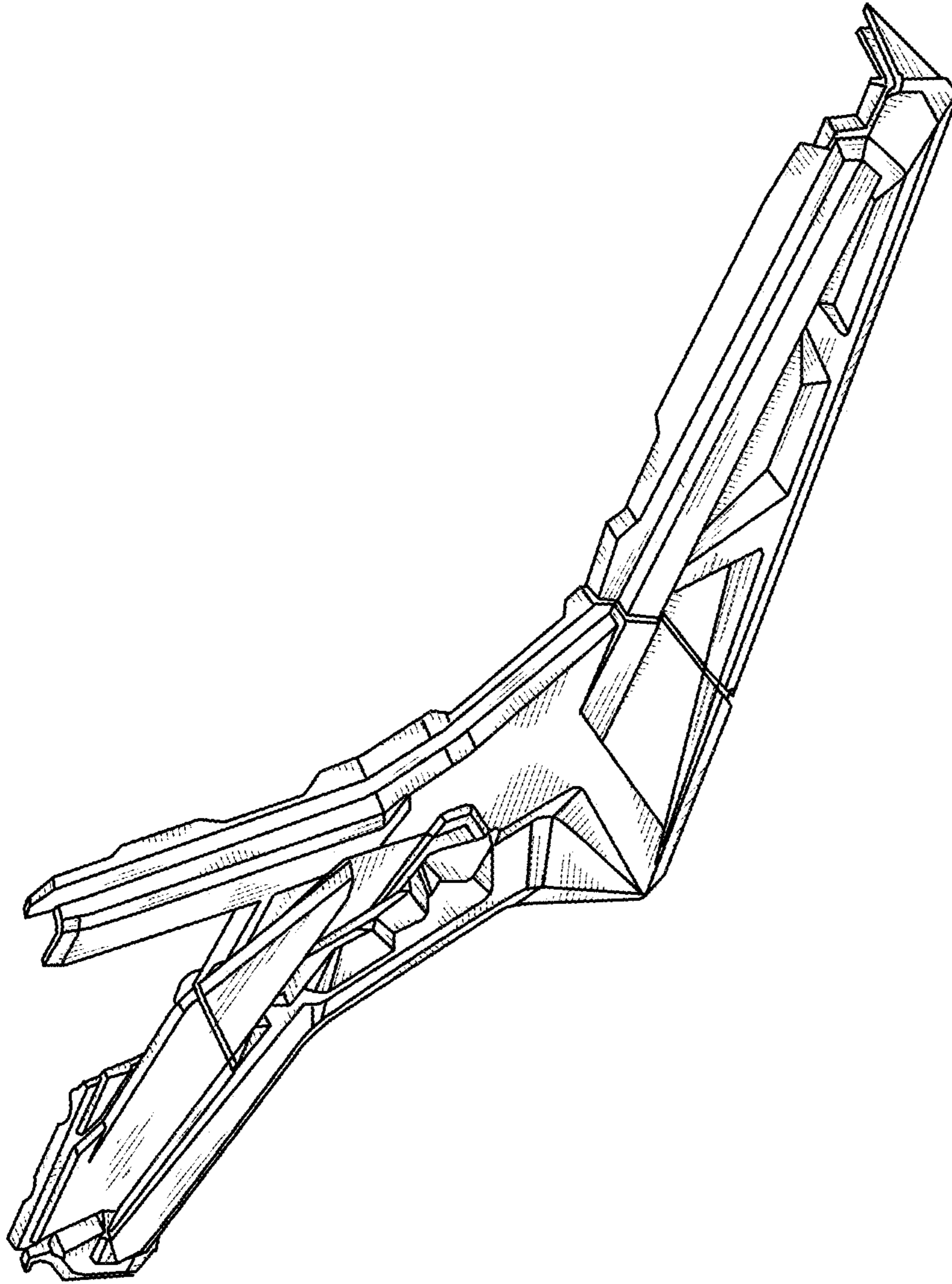

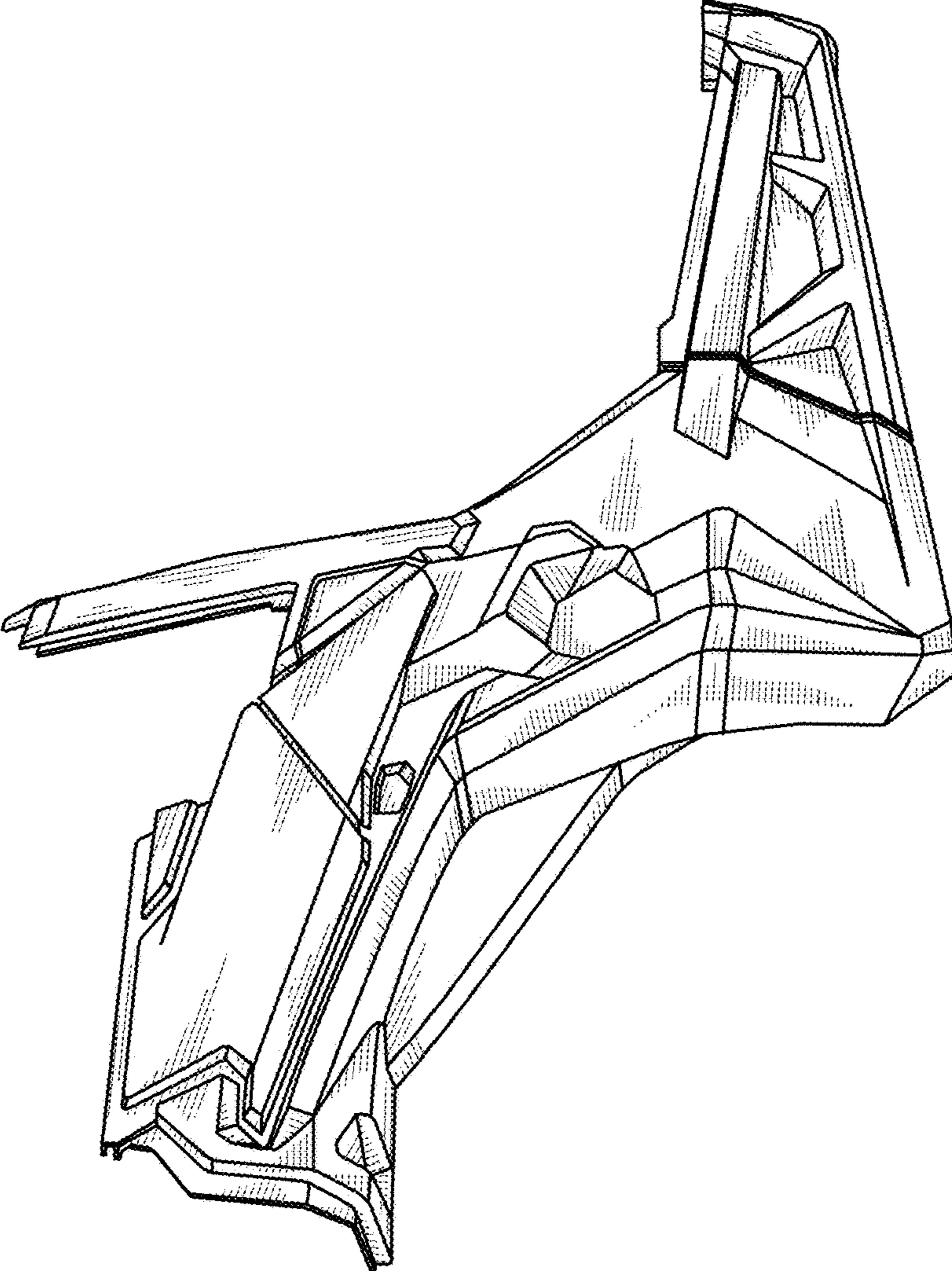

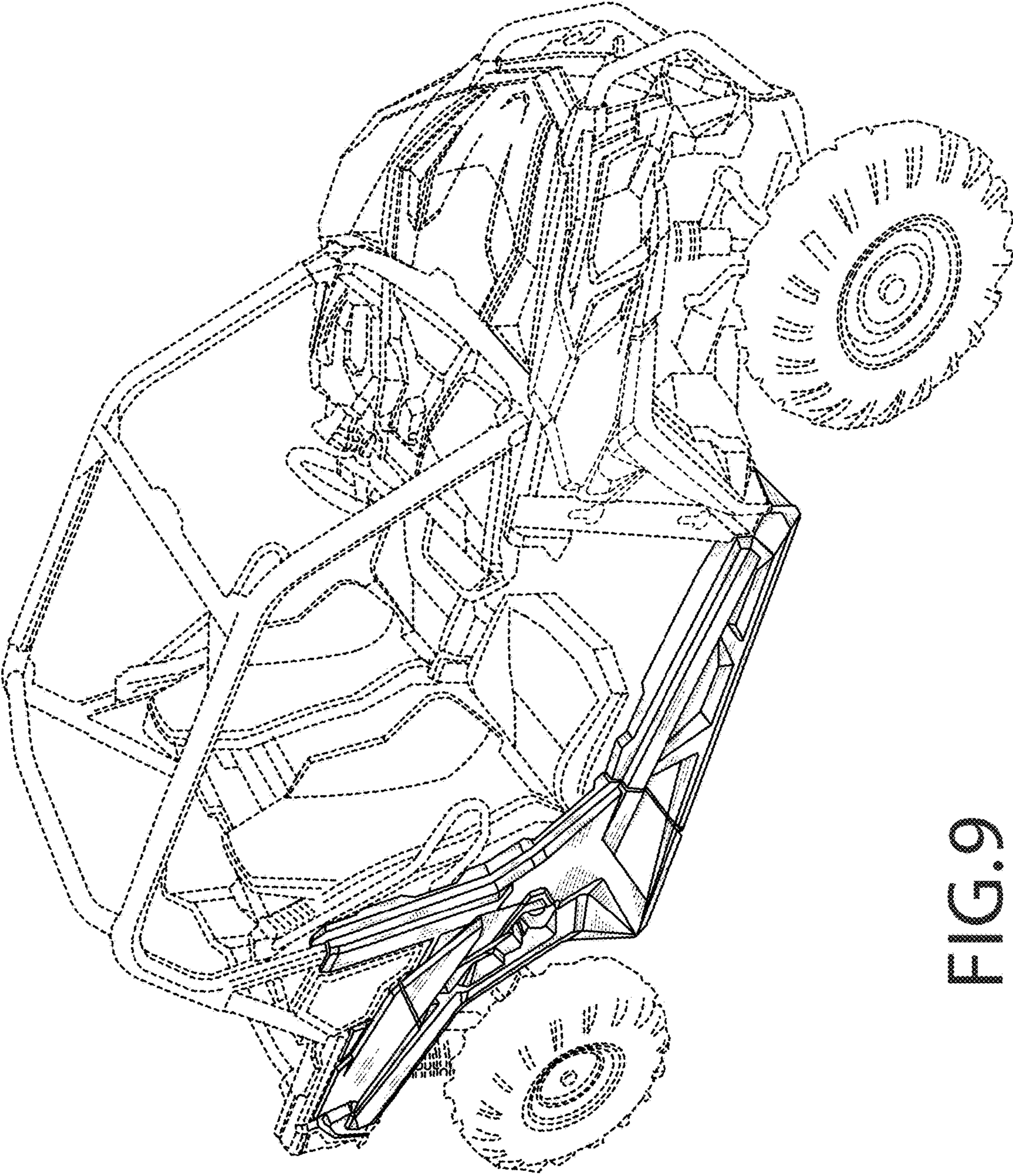

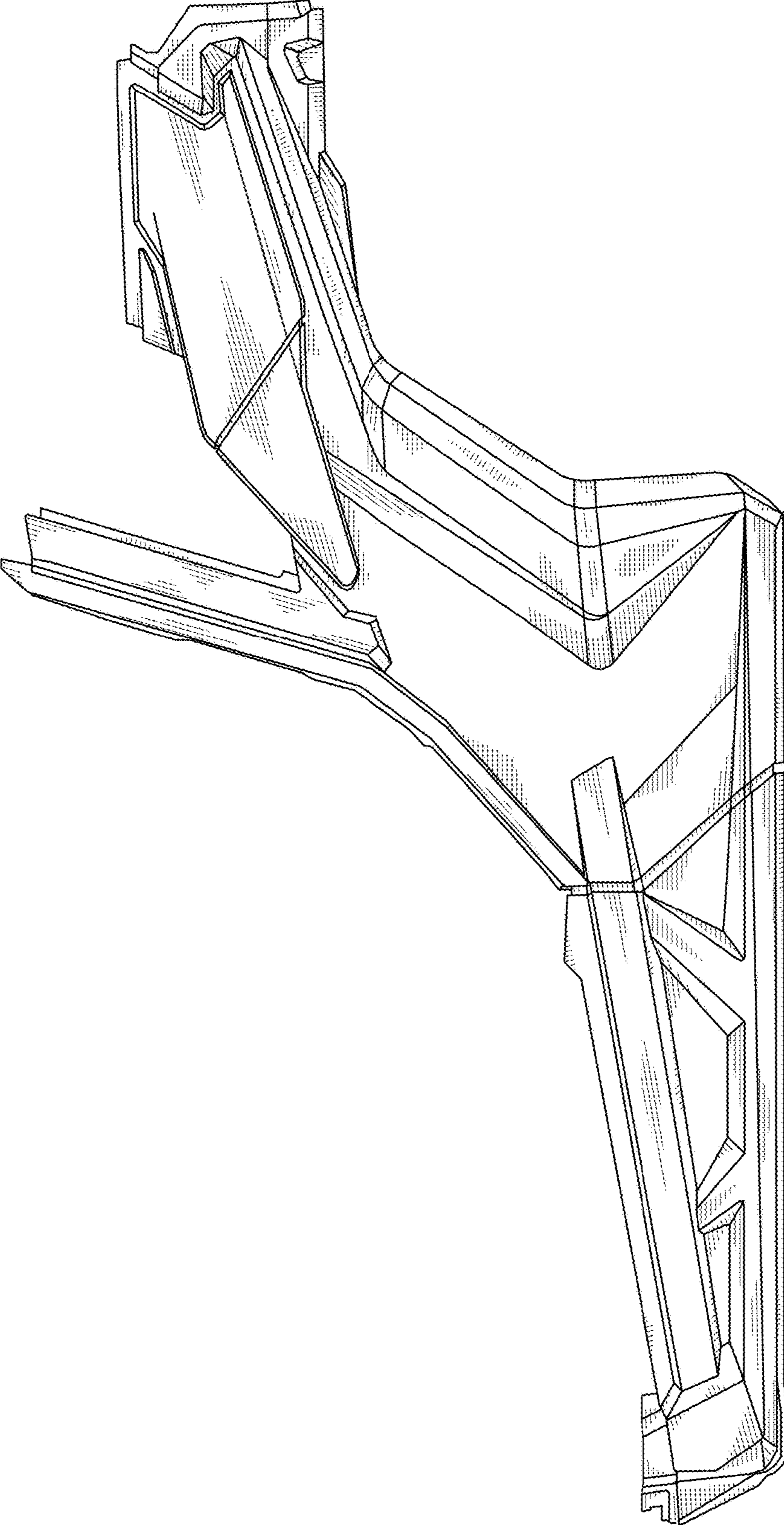

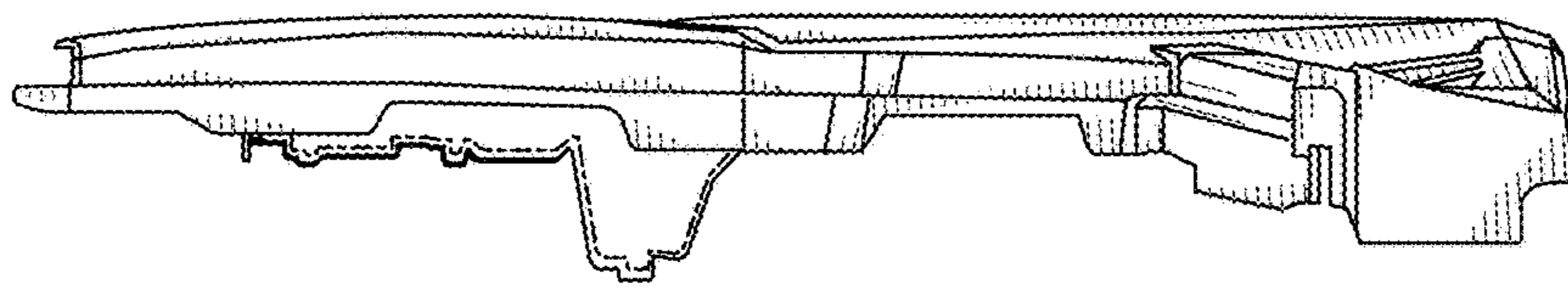

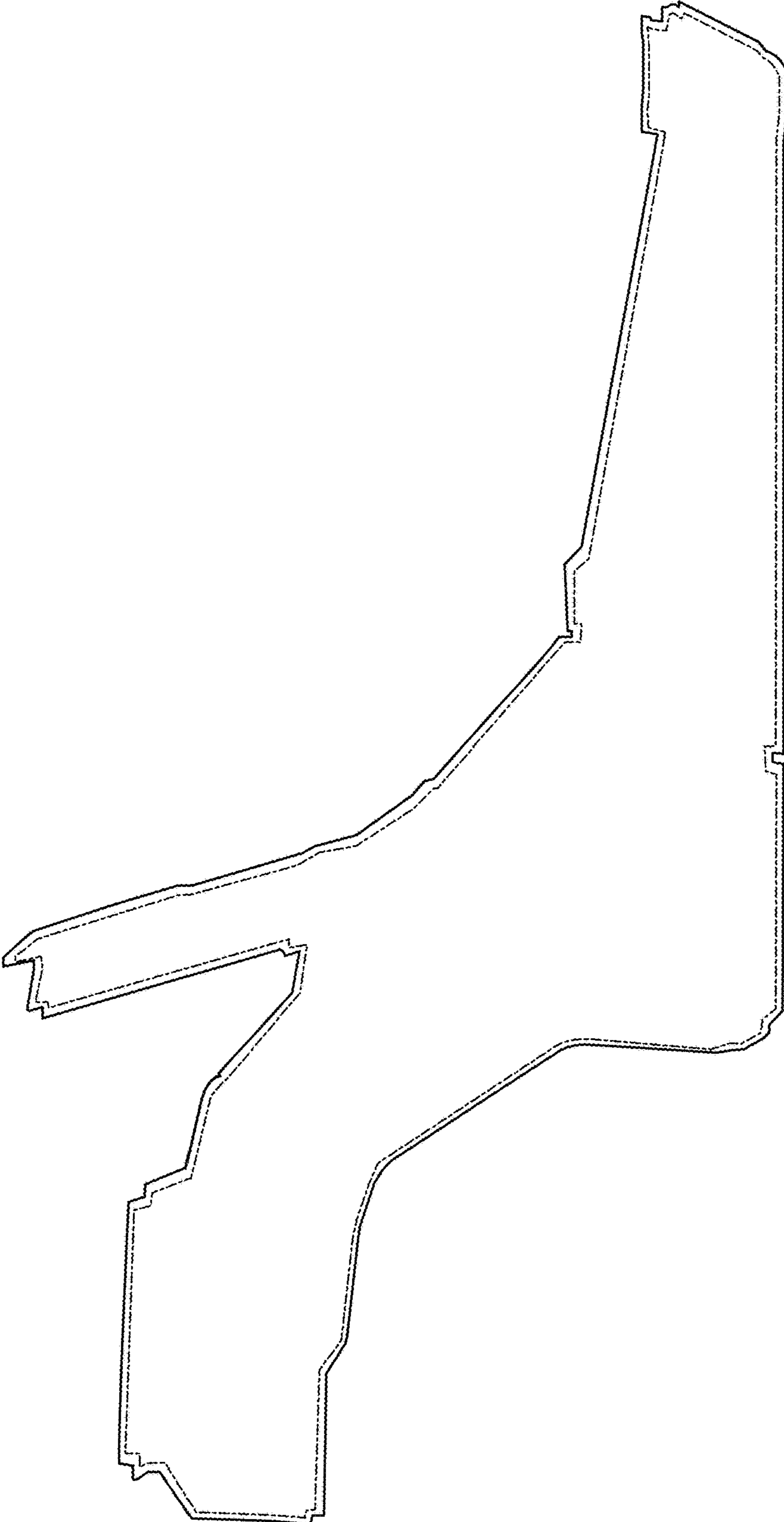

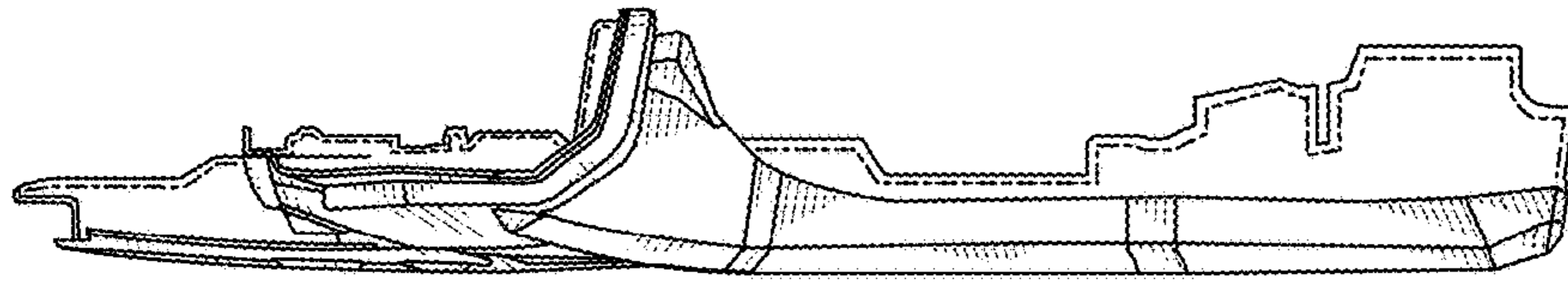

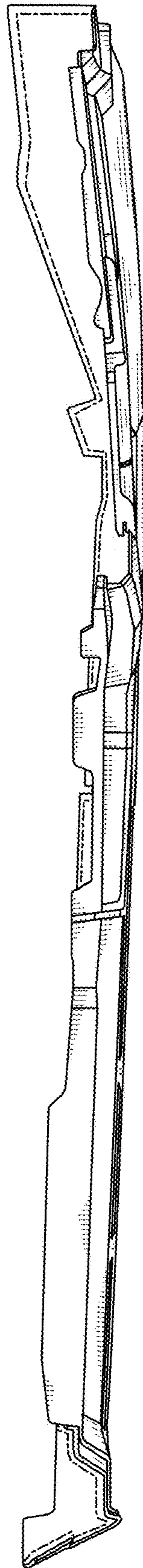

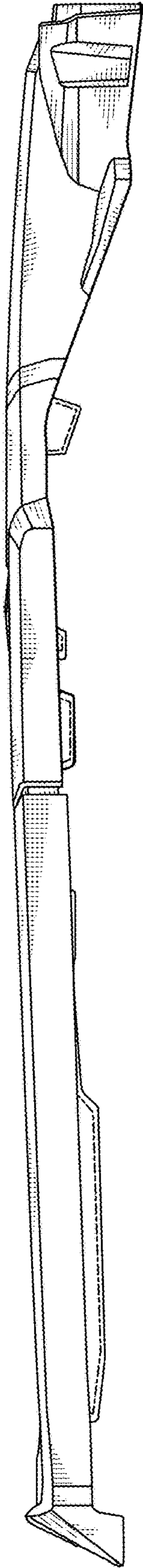

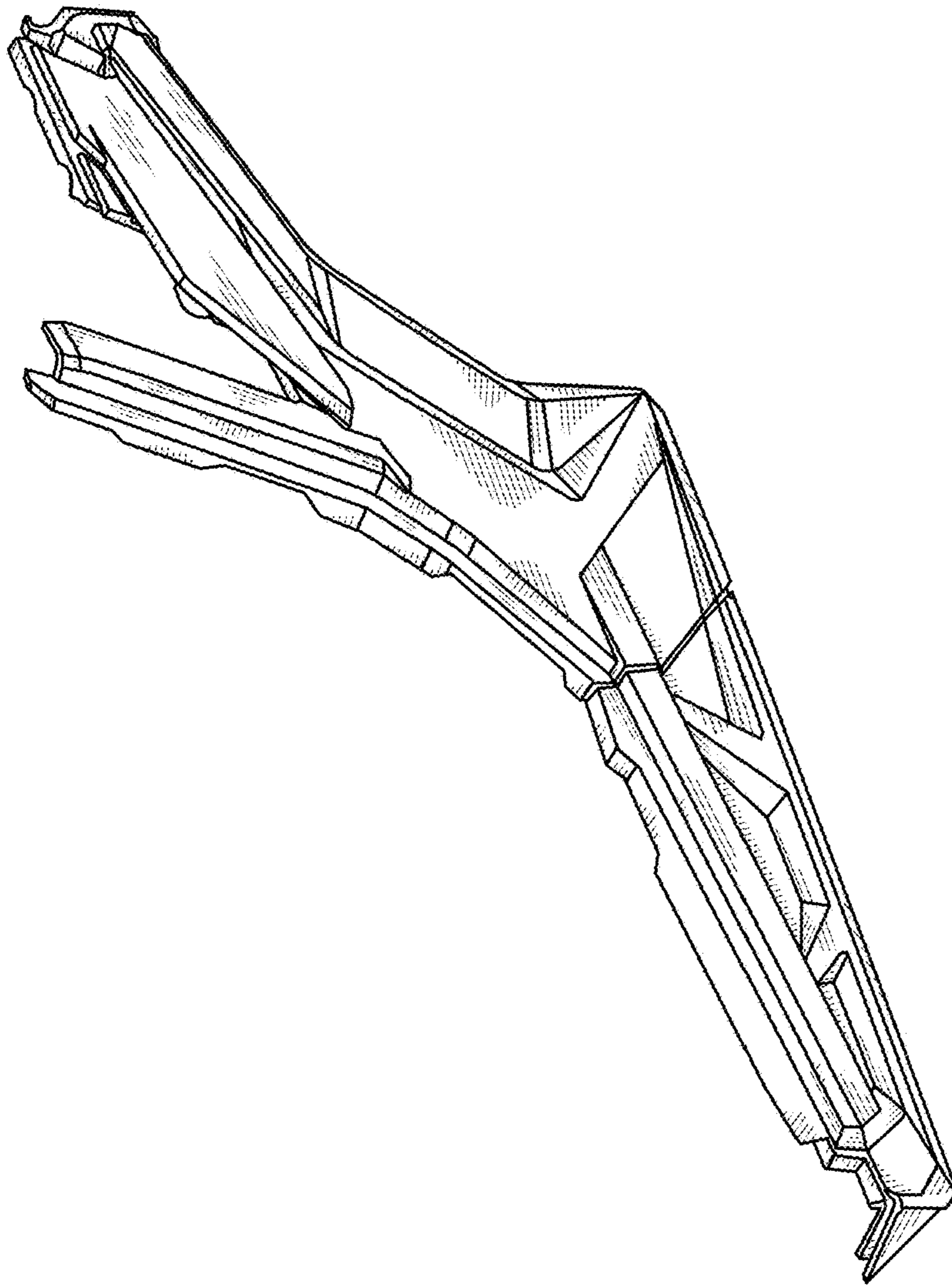

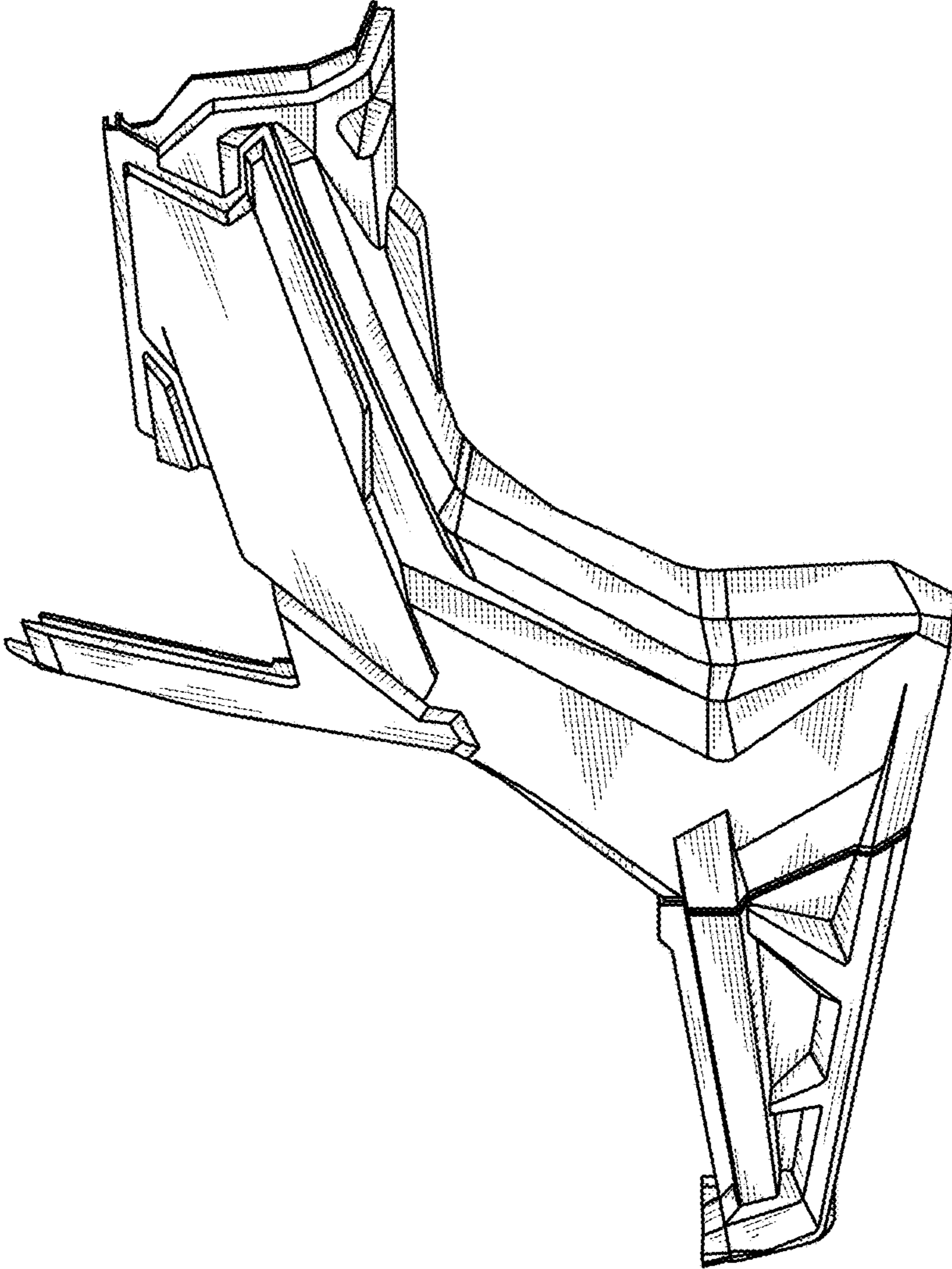

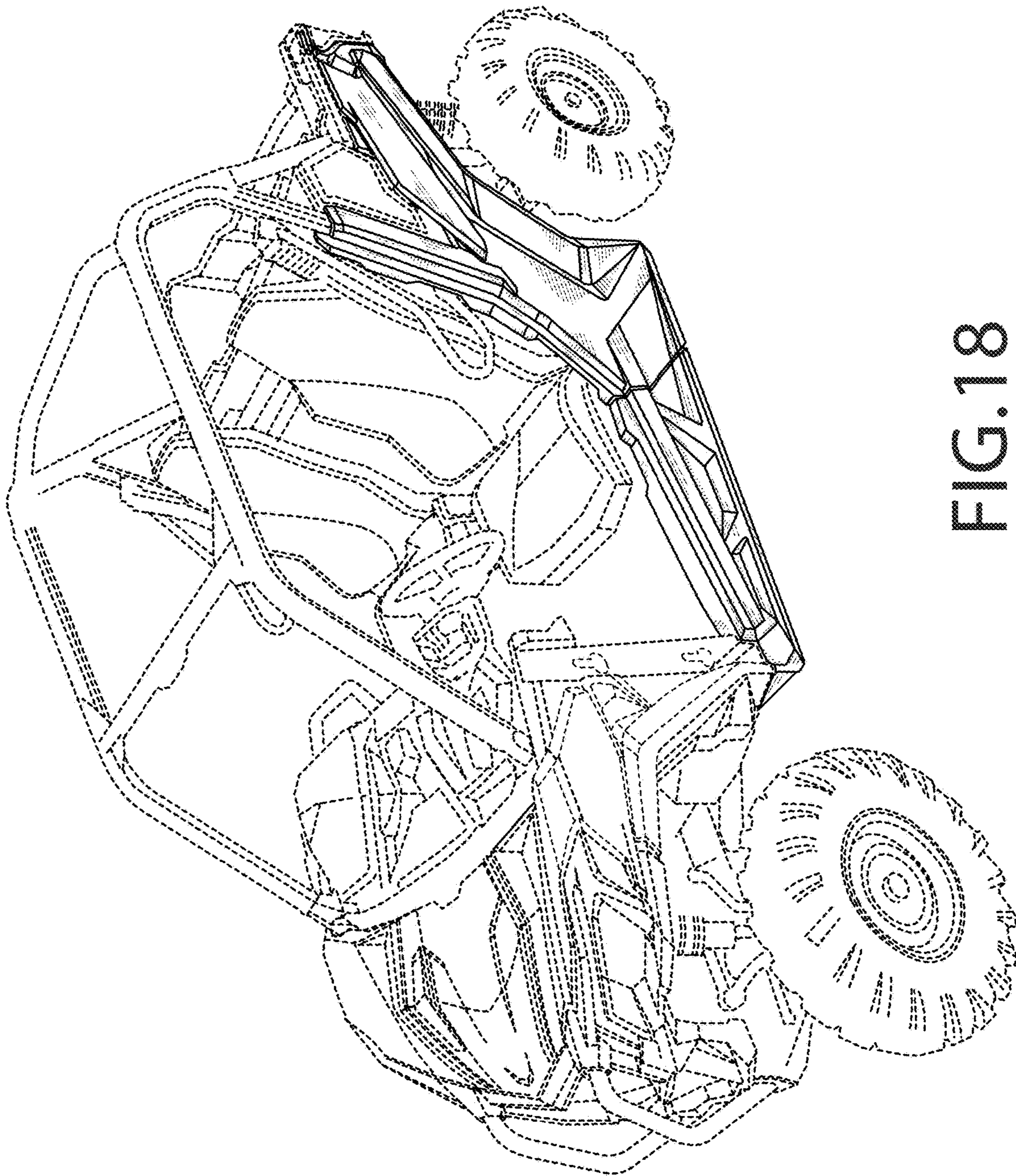
