FIG. 11 is a front view of an eleventh embodiment thereof;

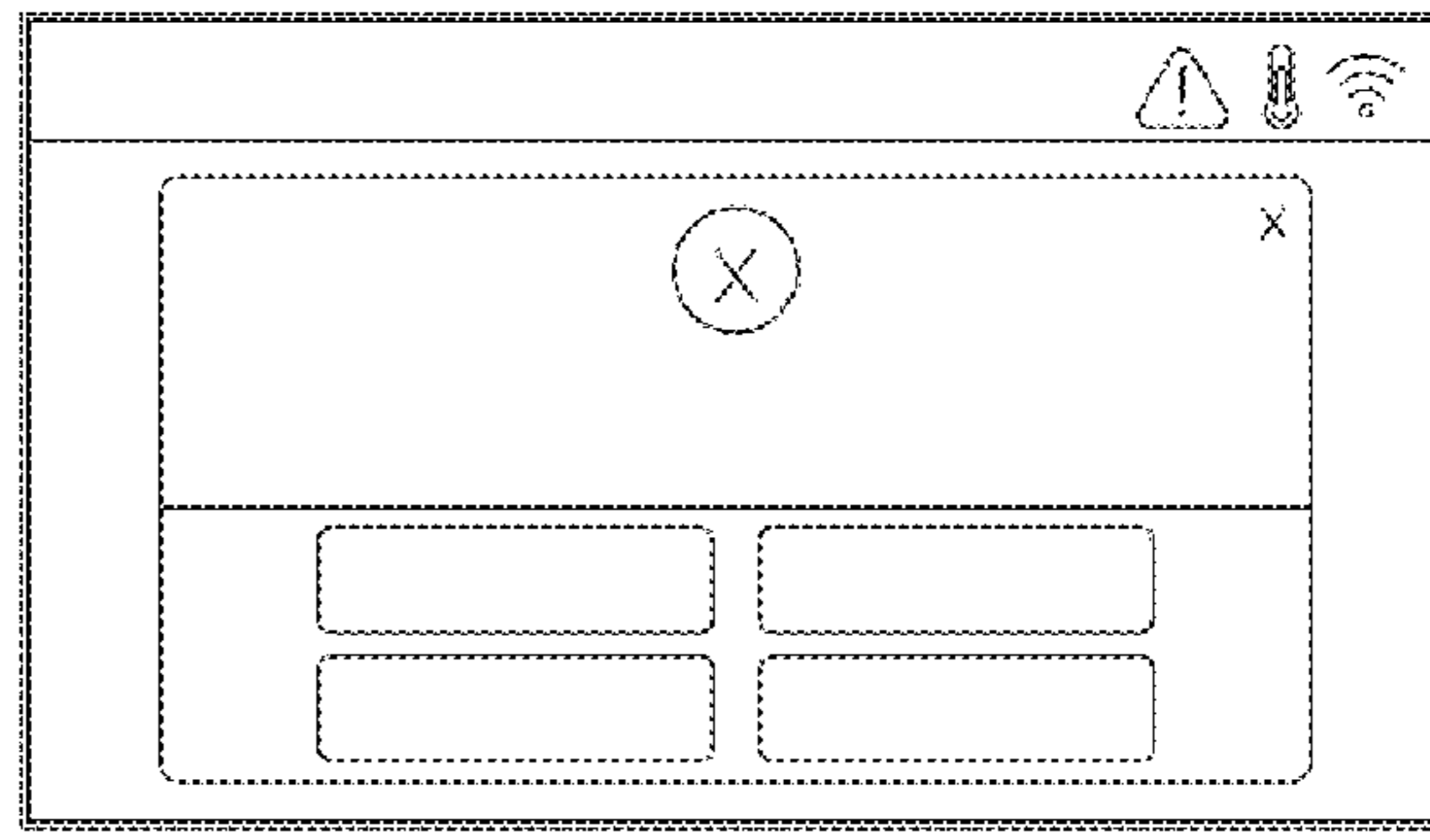
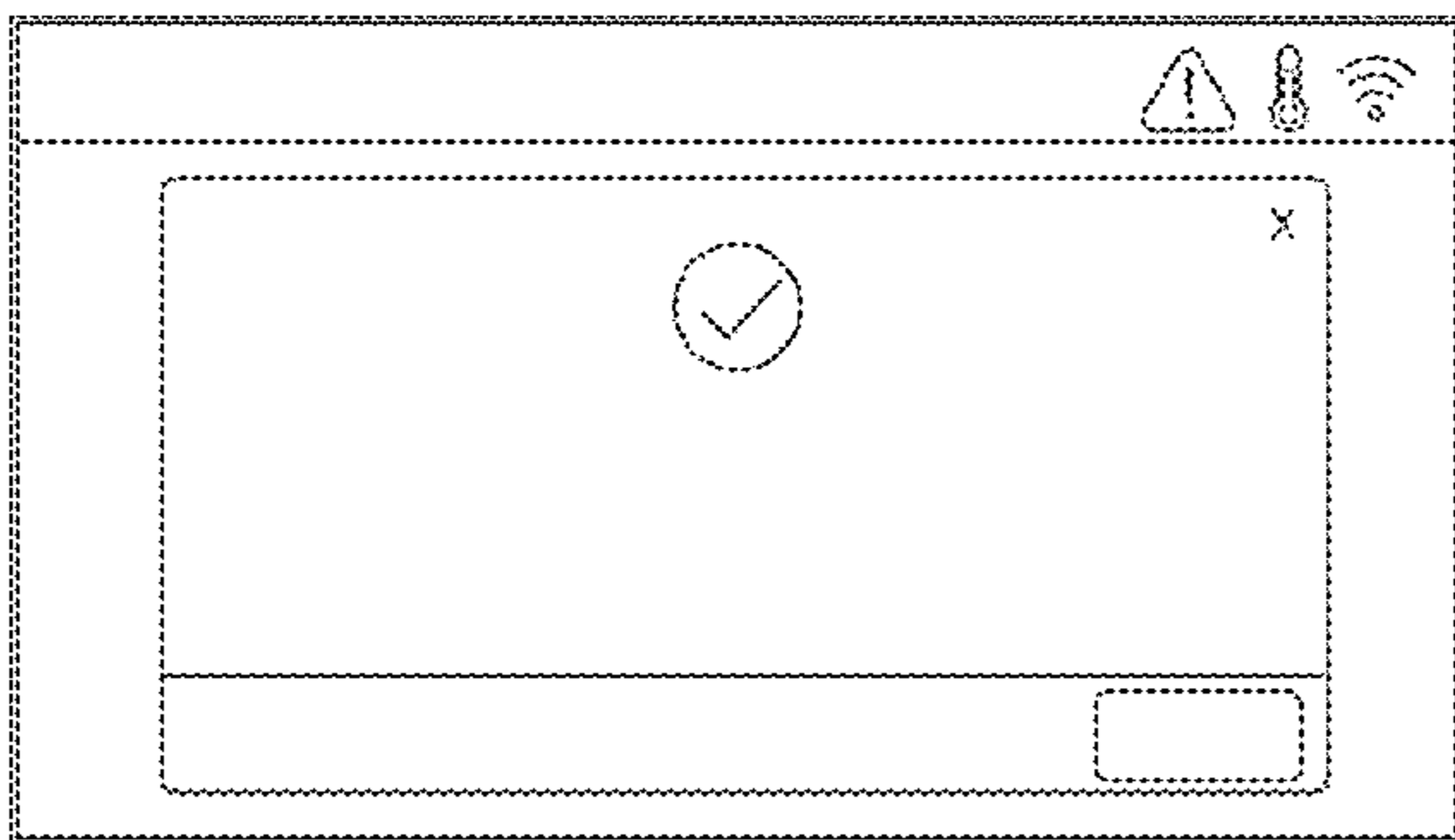
FIG. 12 is a front view of a twelfth embodiment thereof;

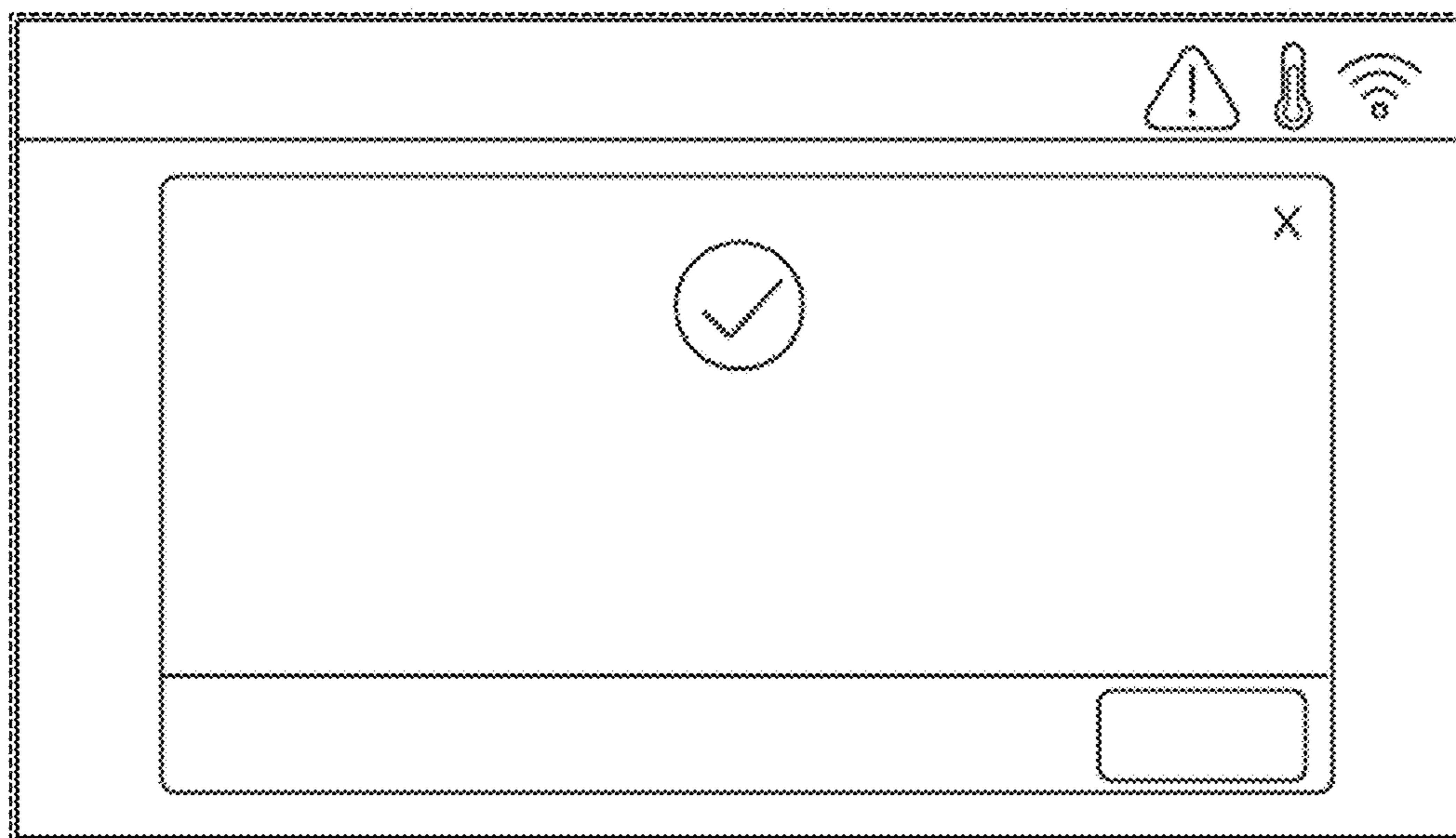

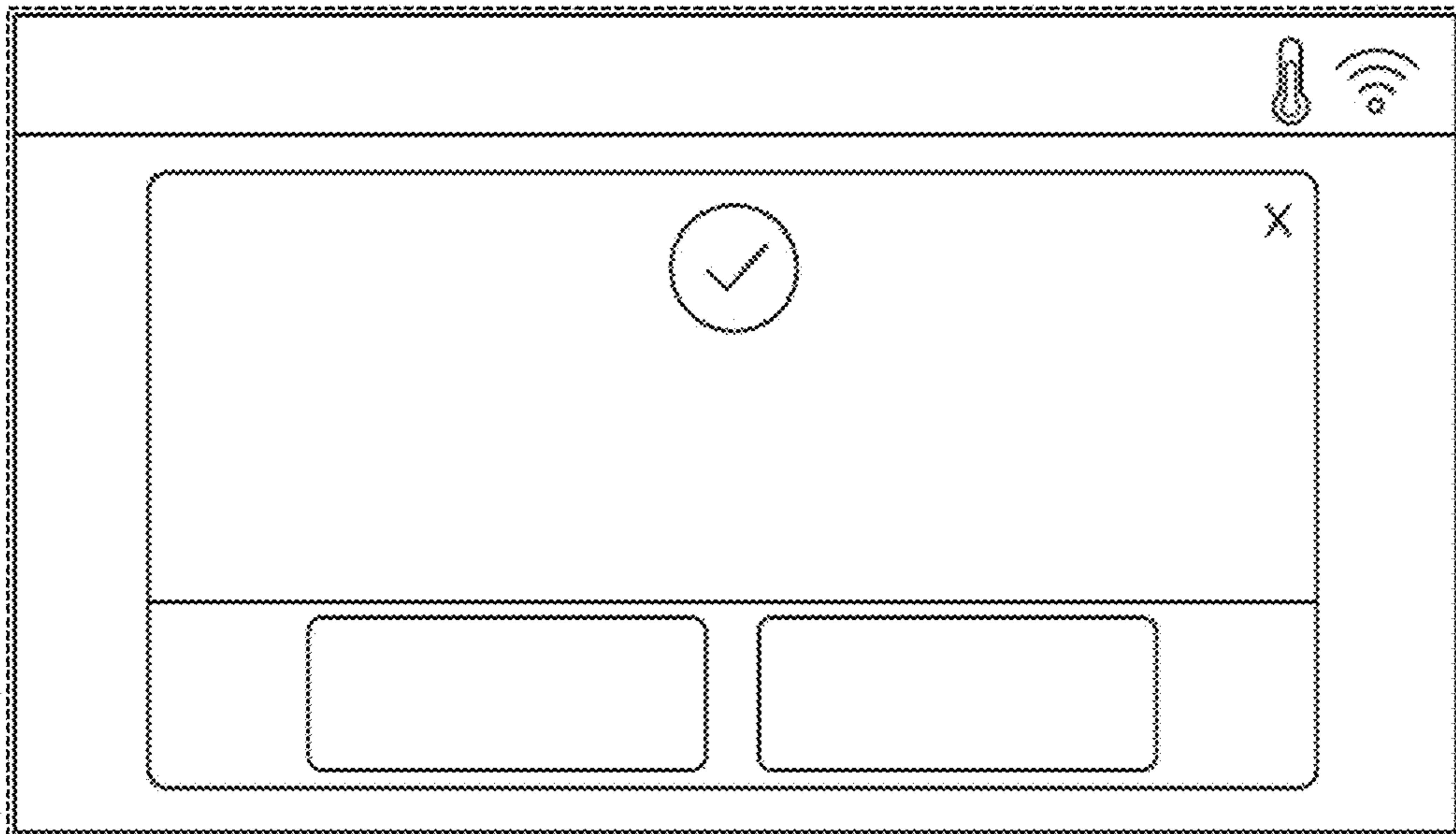

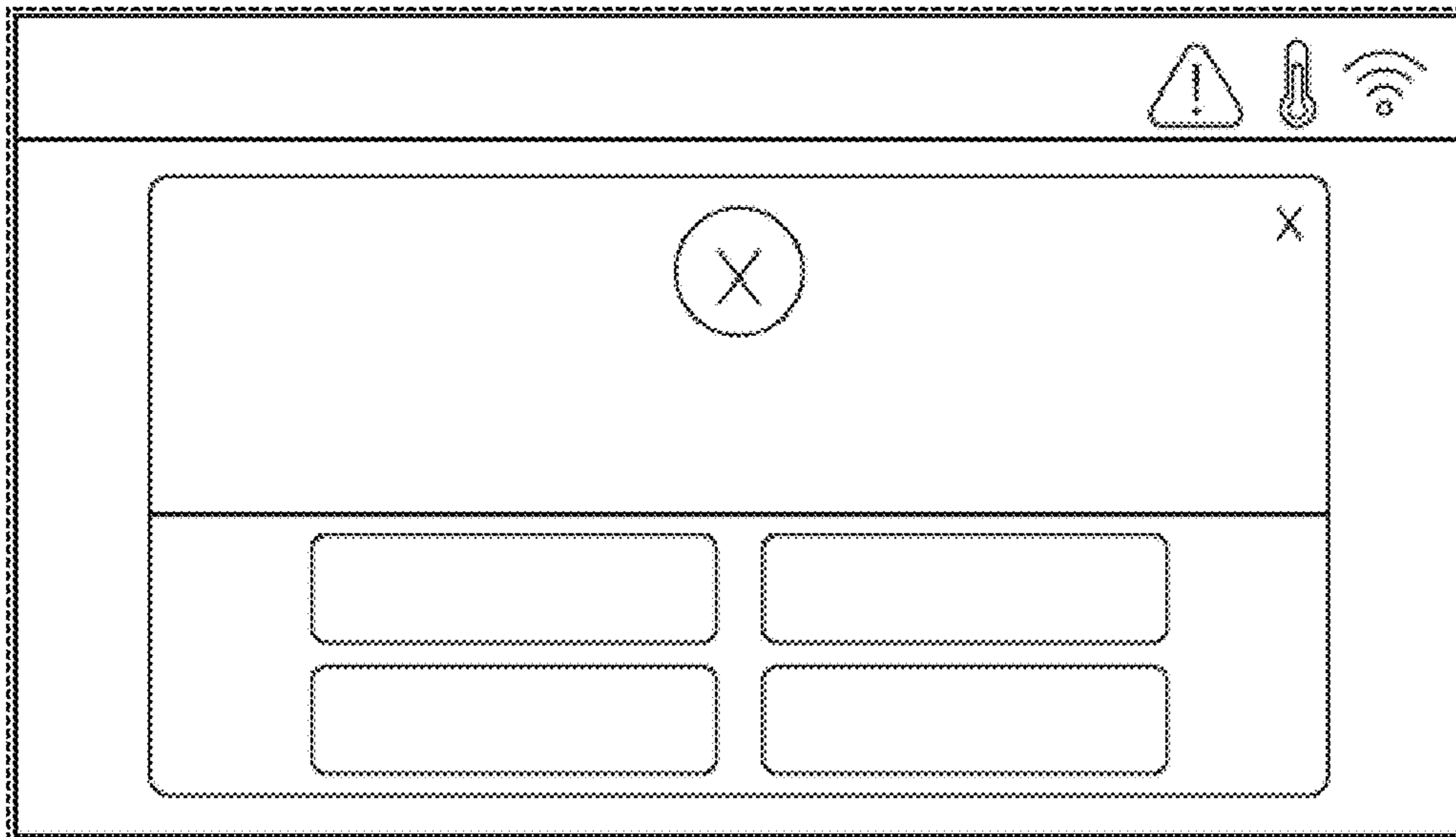

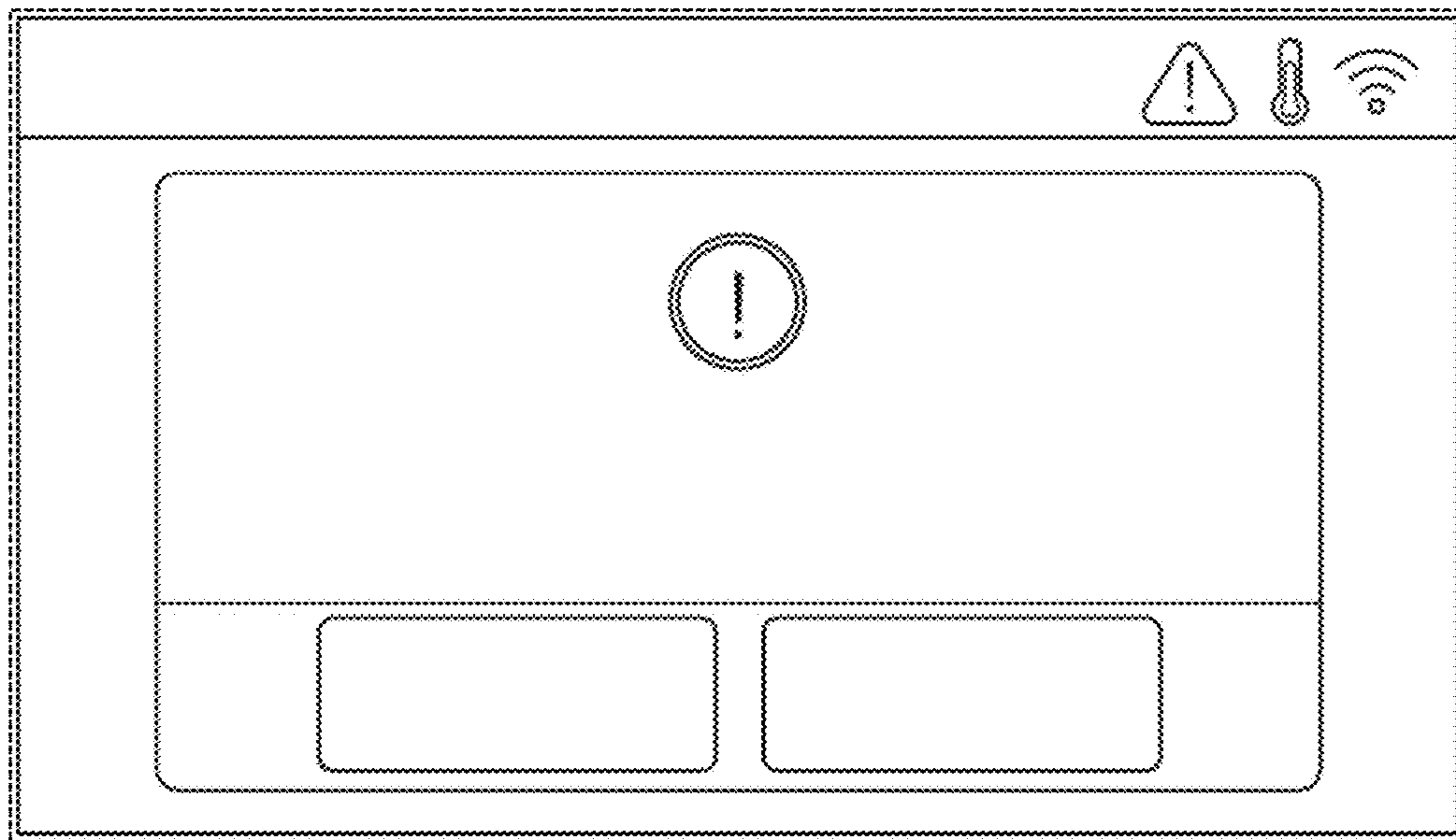

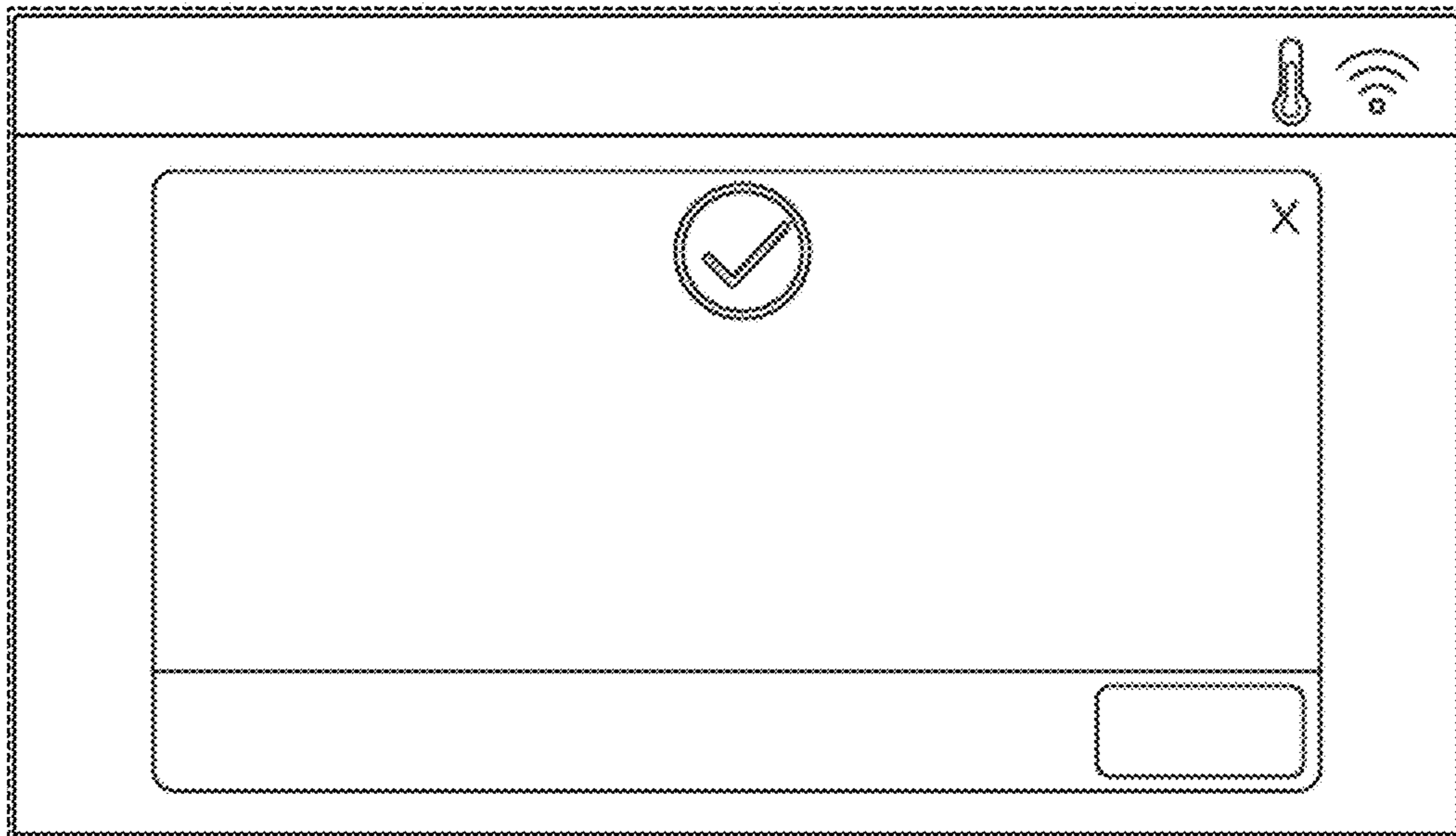

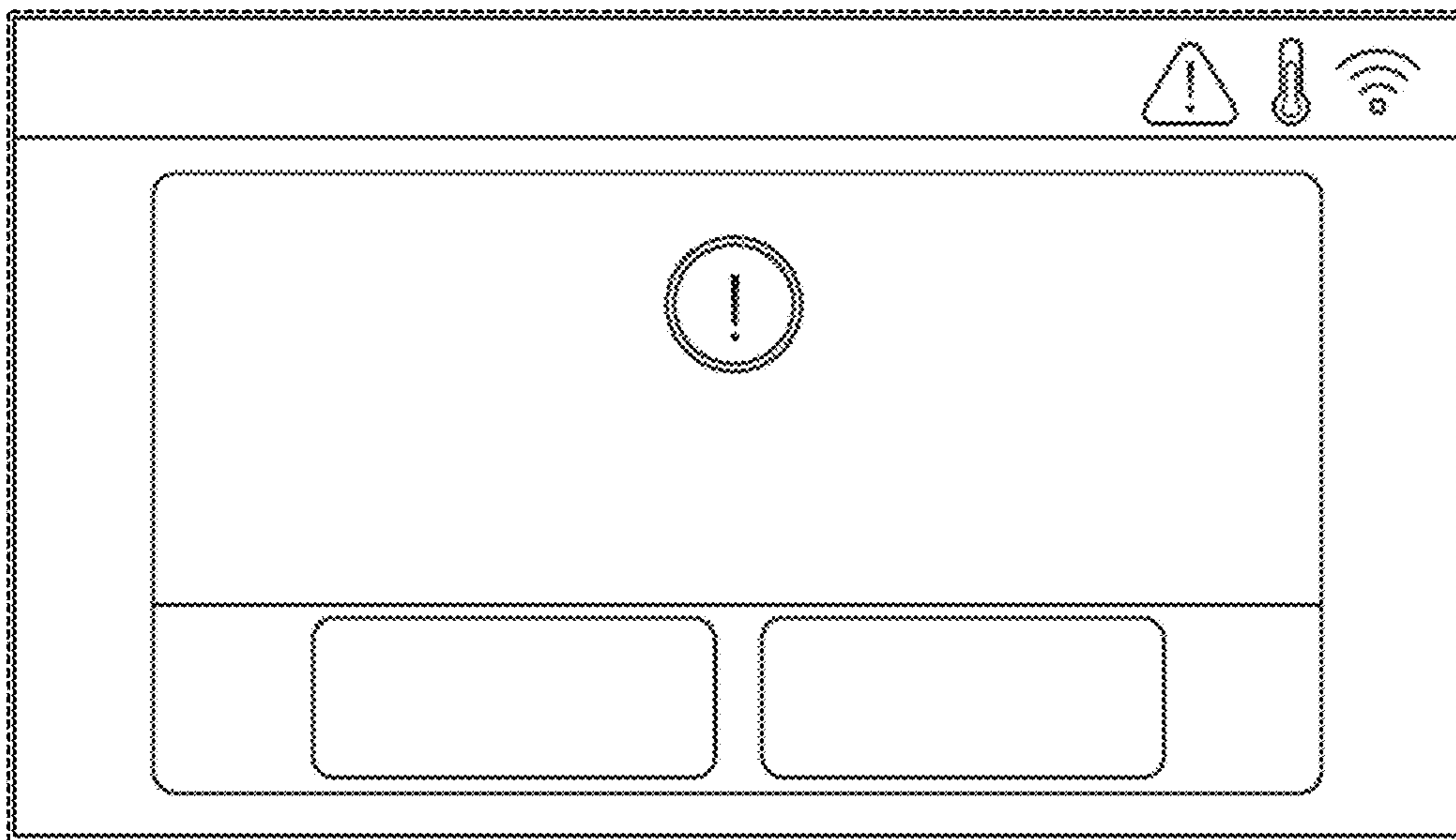

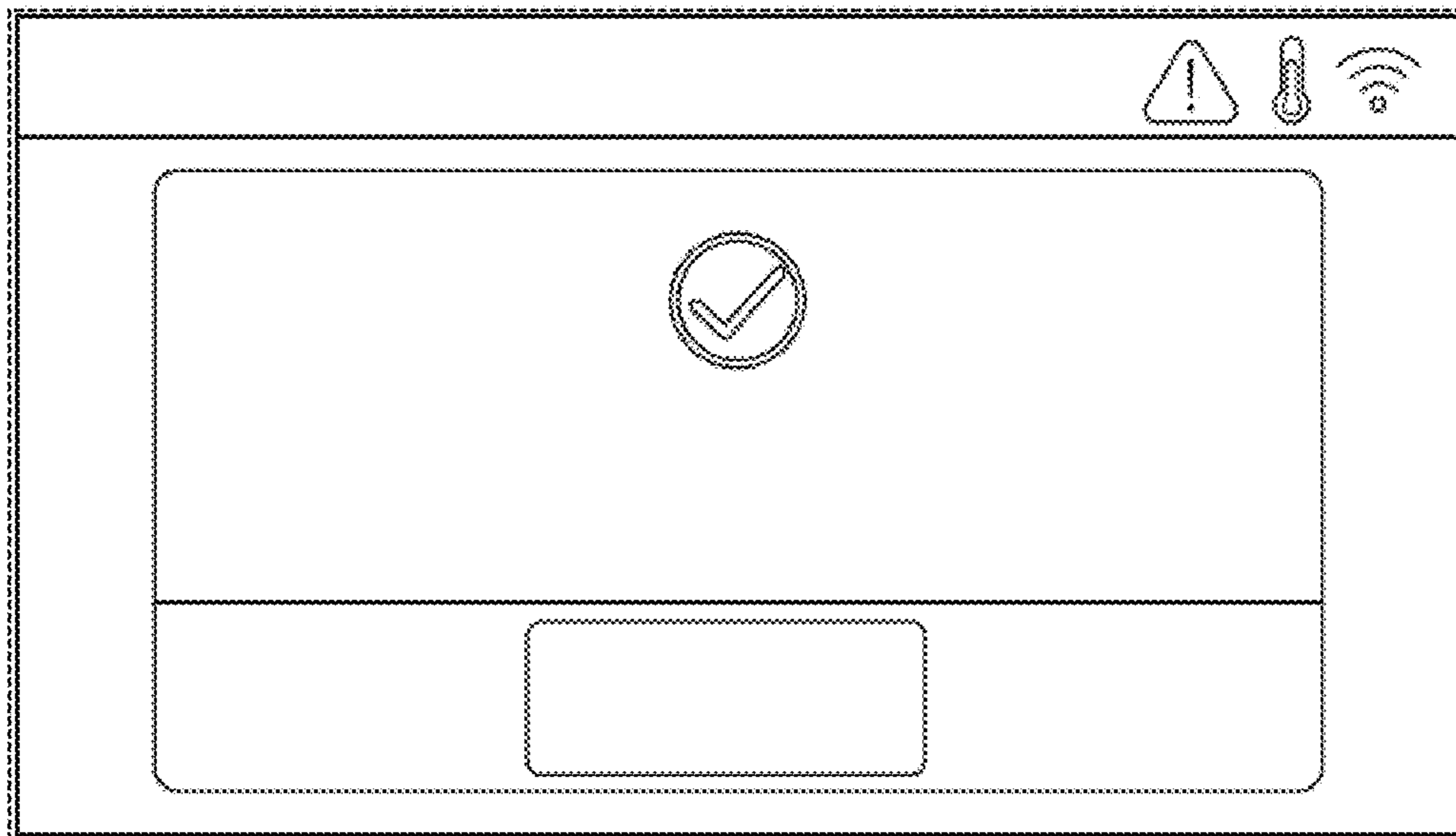

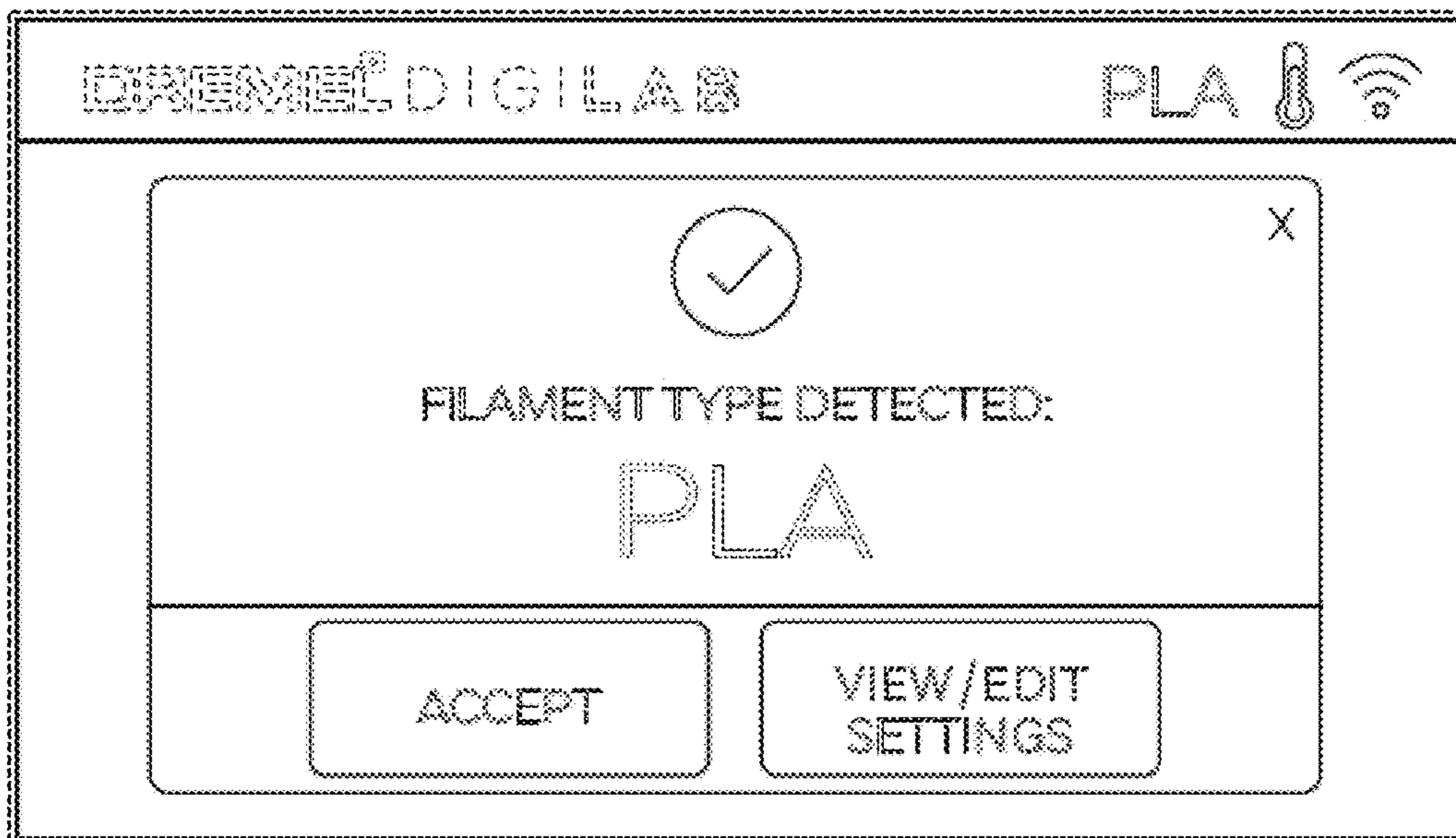

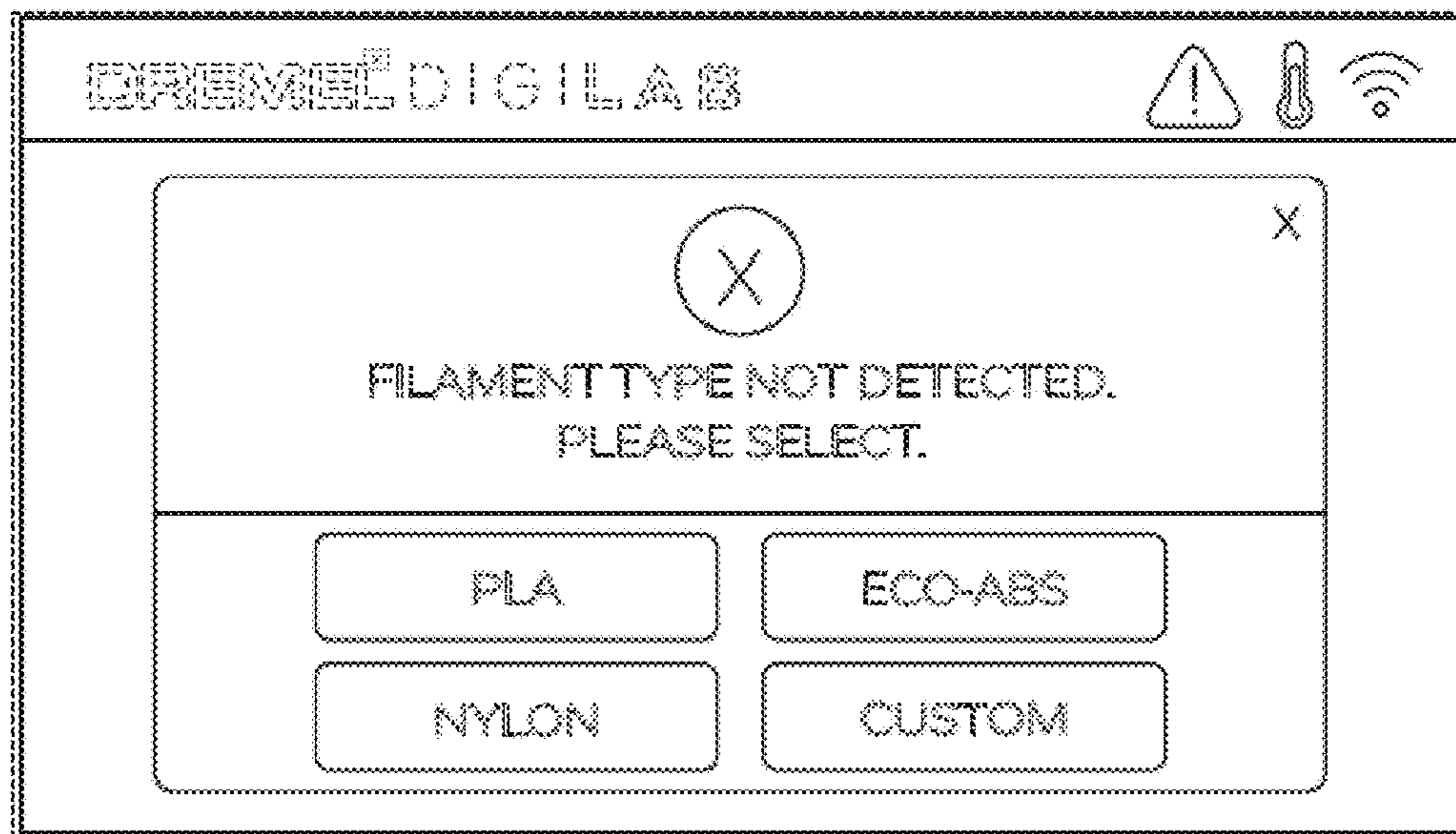

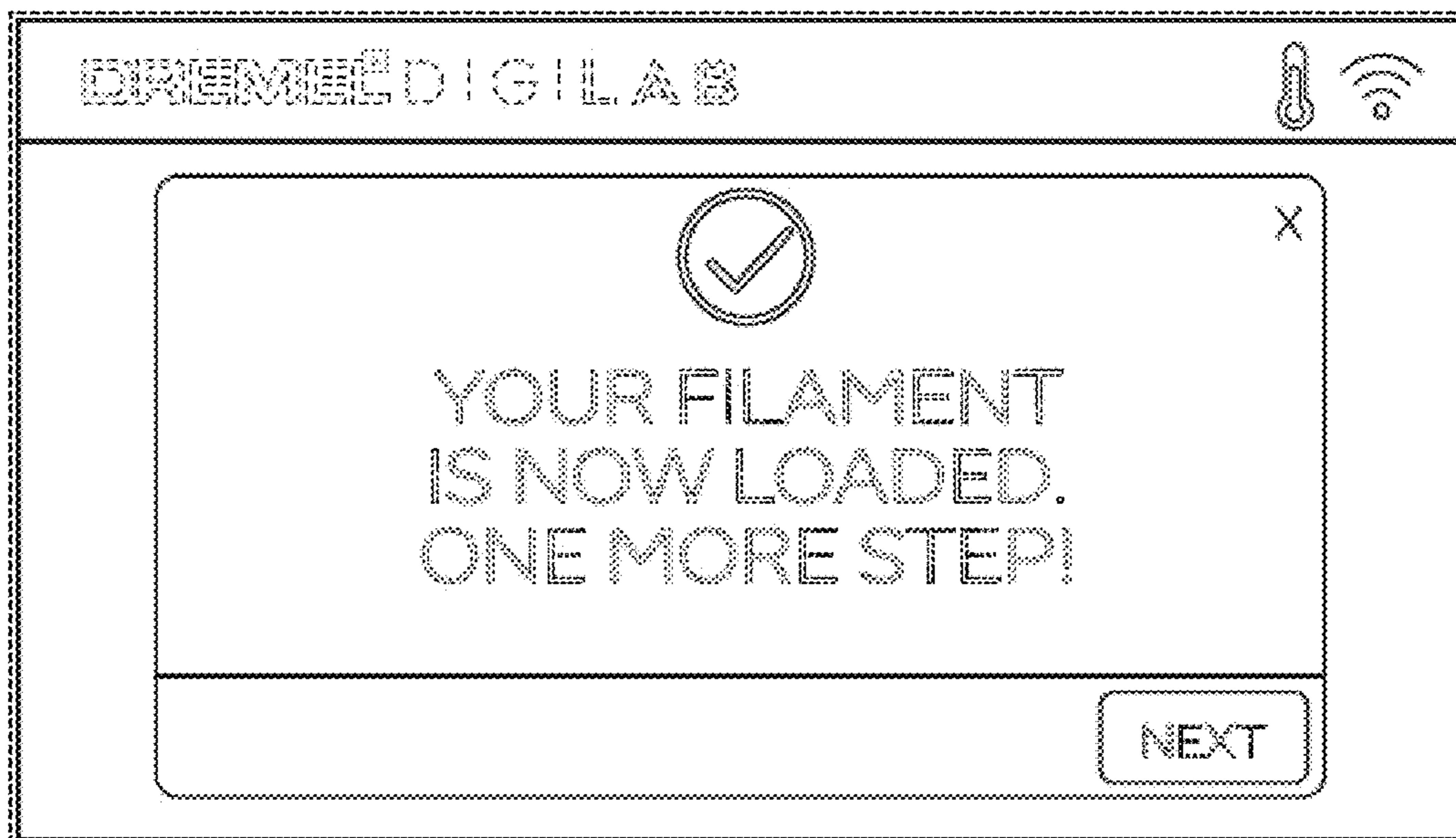

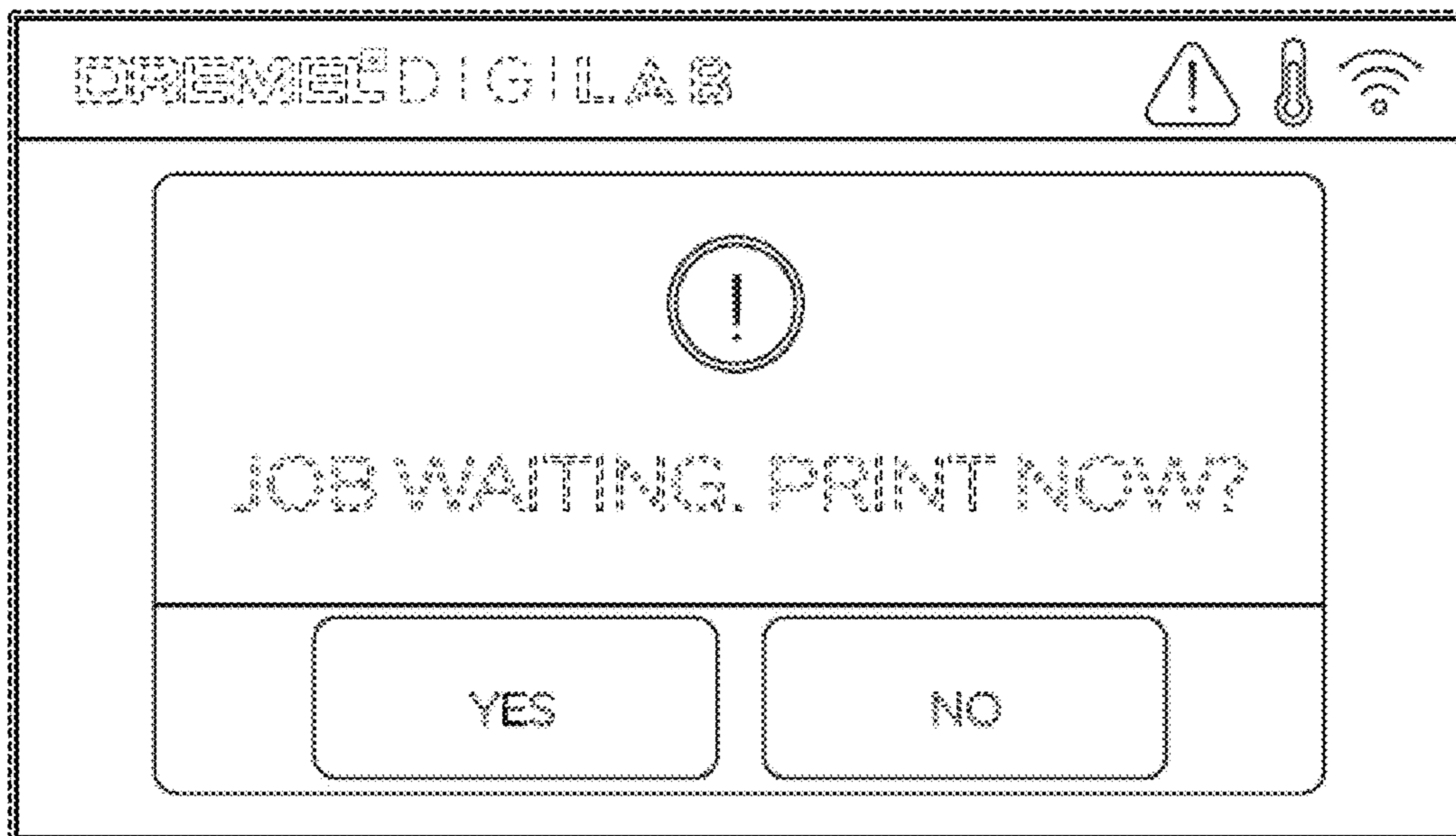

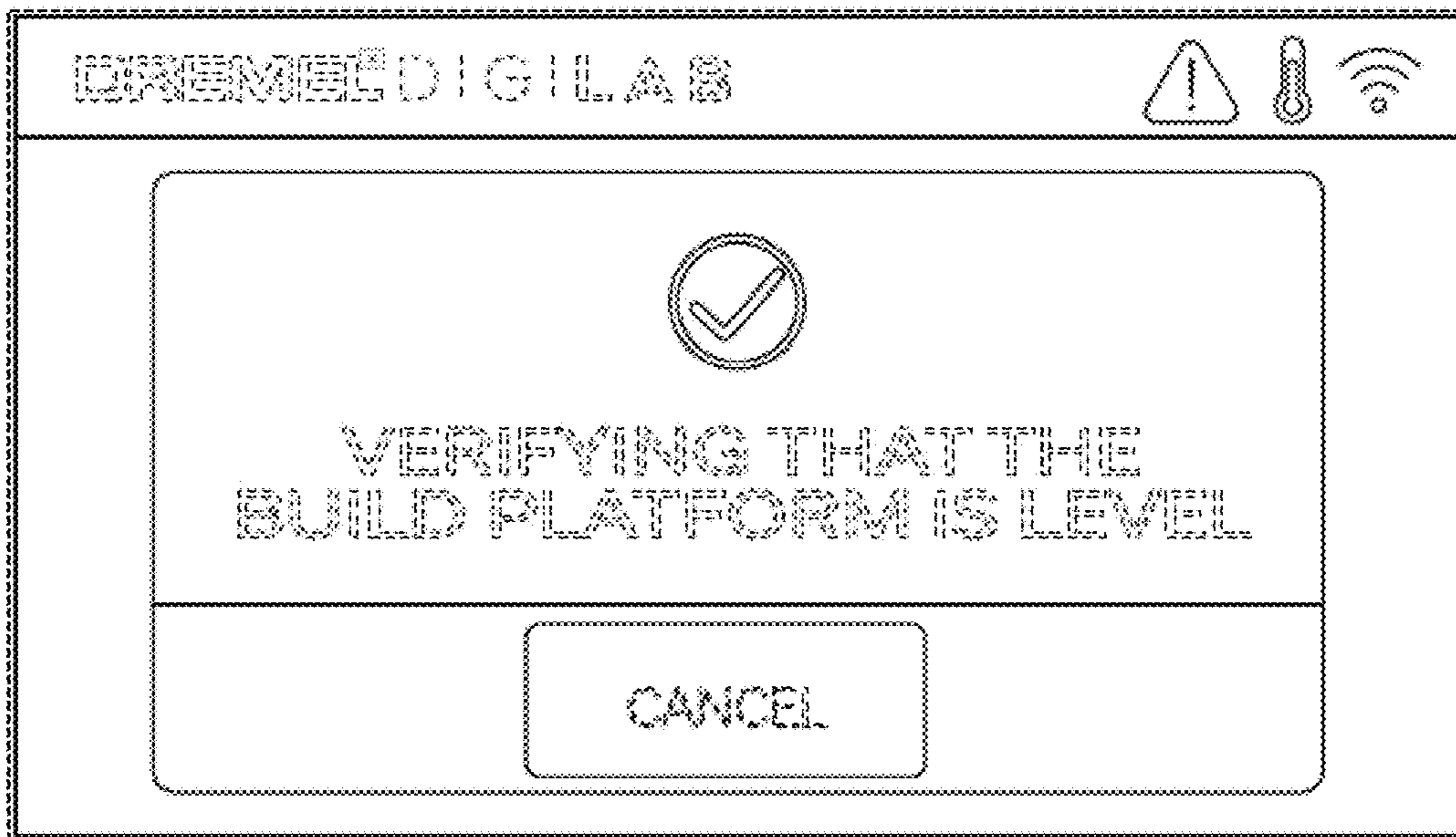
