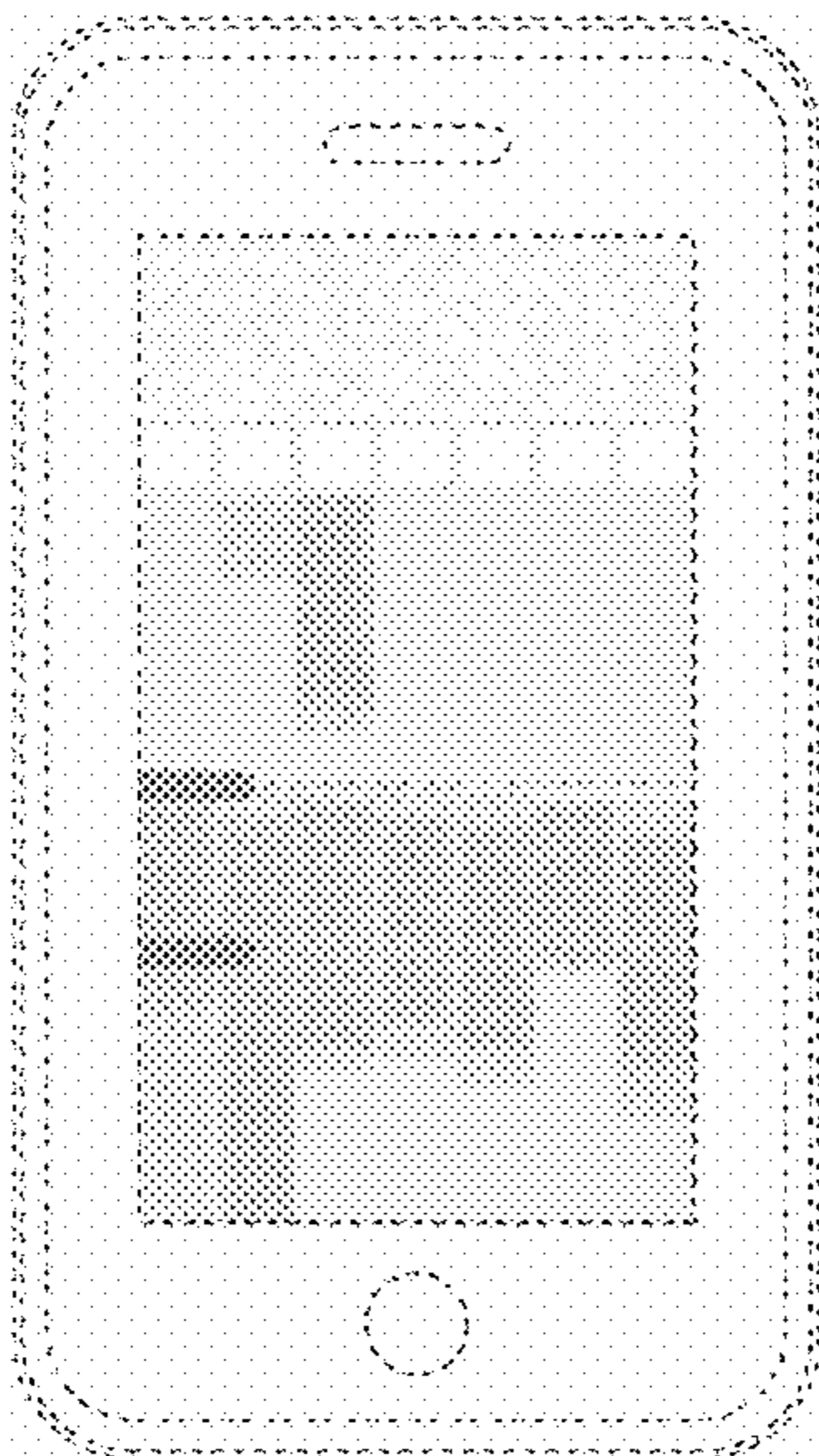
The ornamental design for a computer screen with graphical user interface, as shown and described.

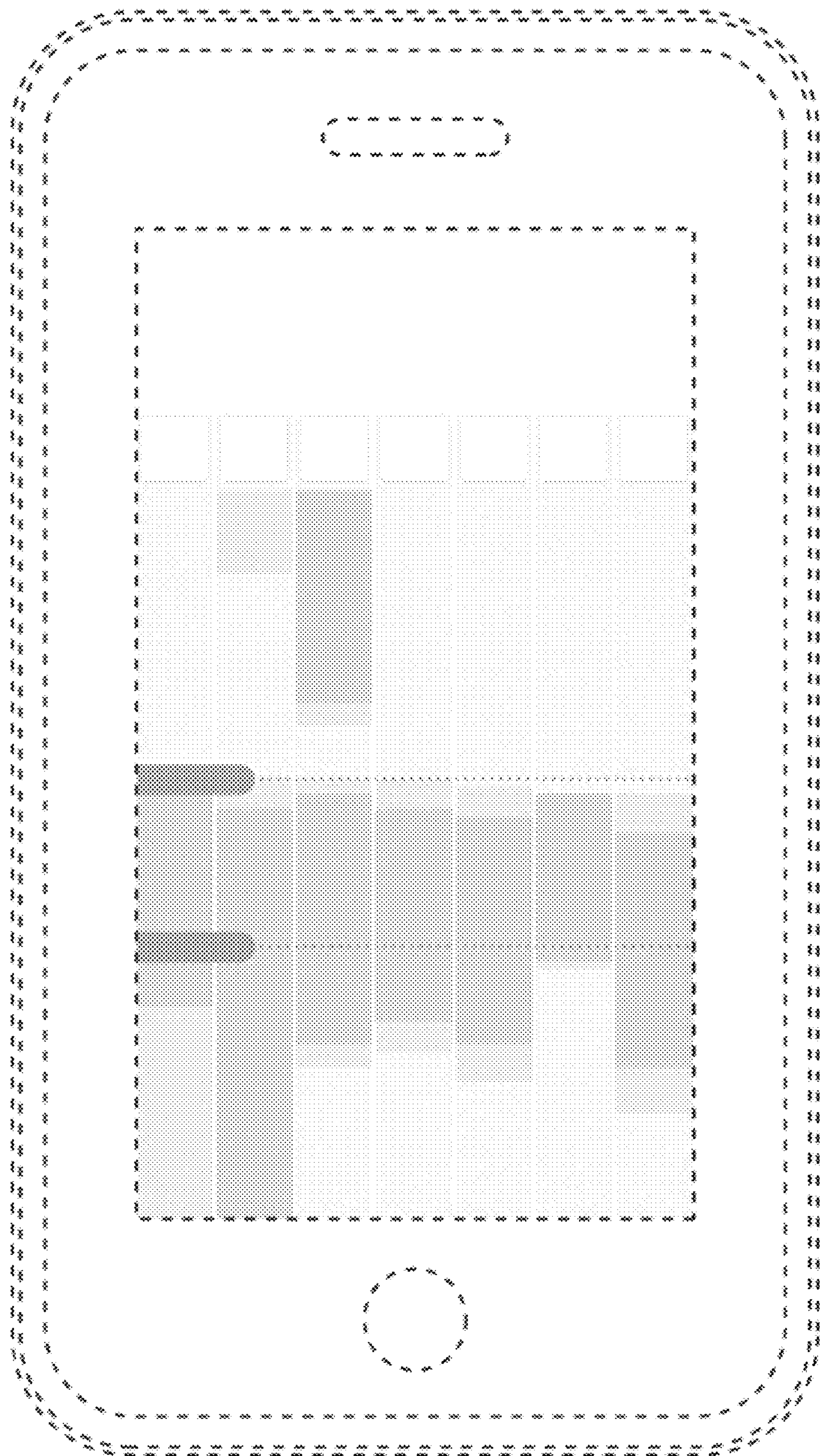

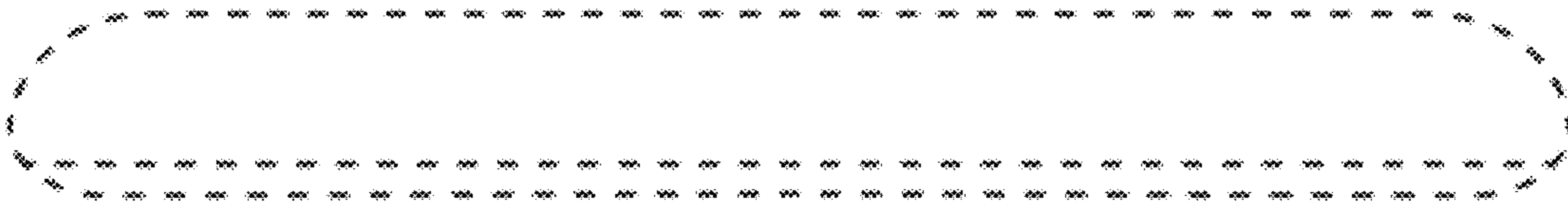
