**DESCRIPTION**

FIG. 1 is a perspective view of a stand for dental instrument showing the claimed design;

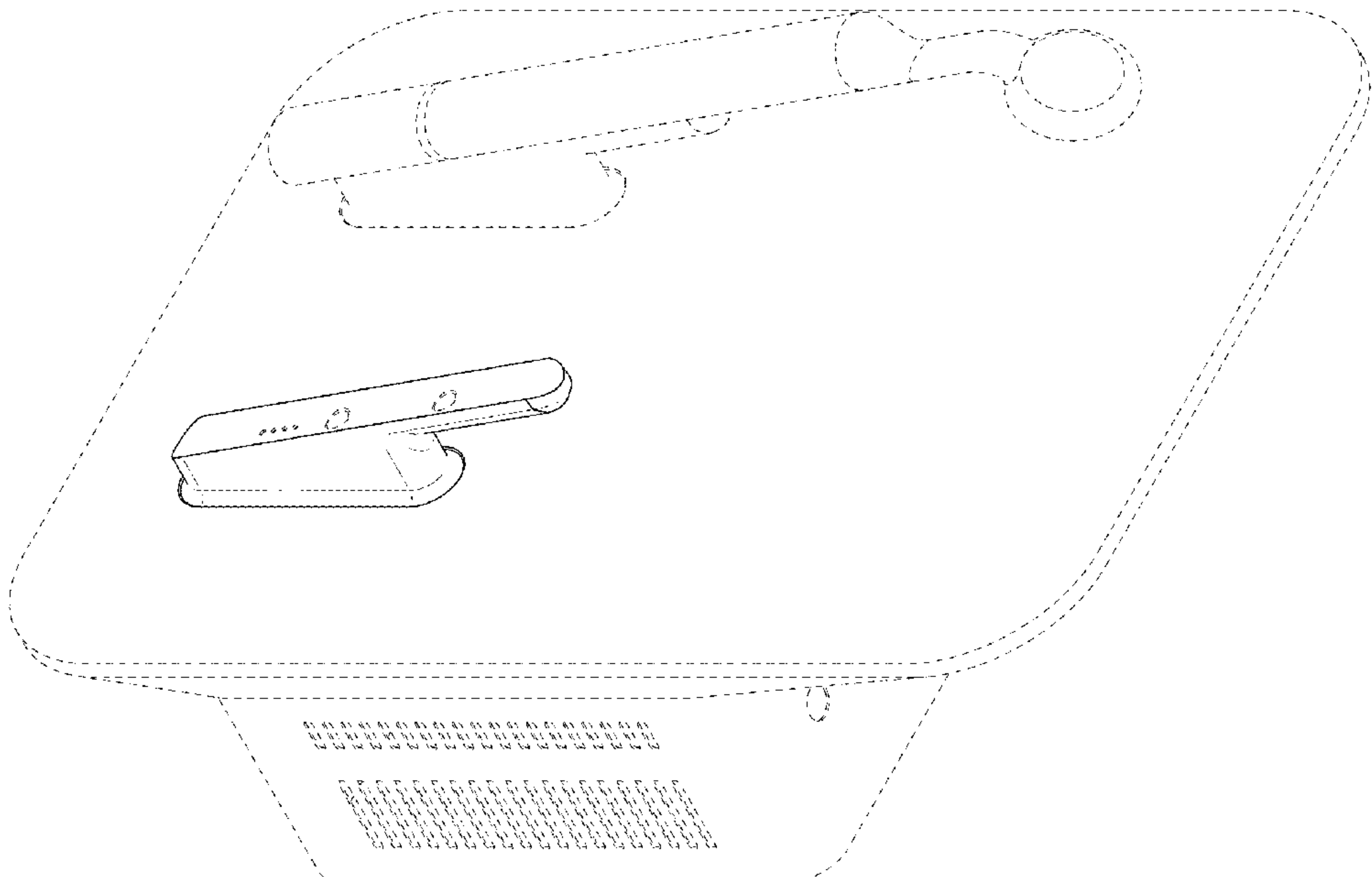

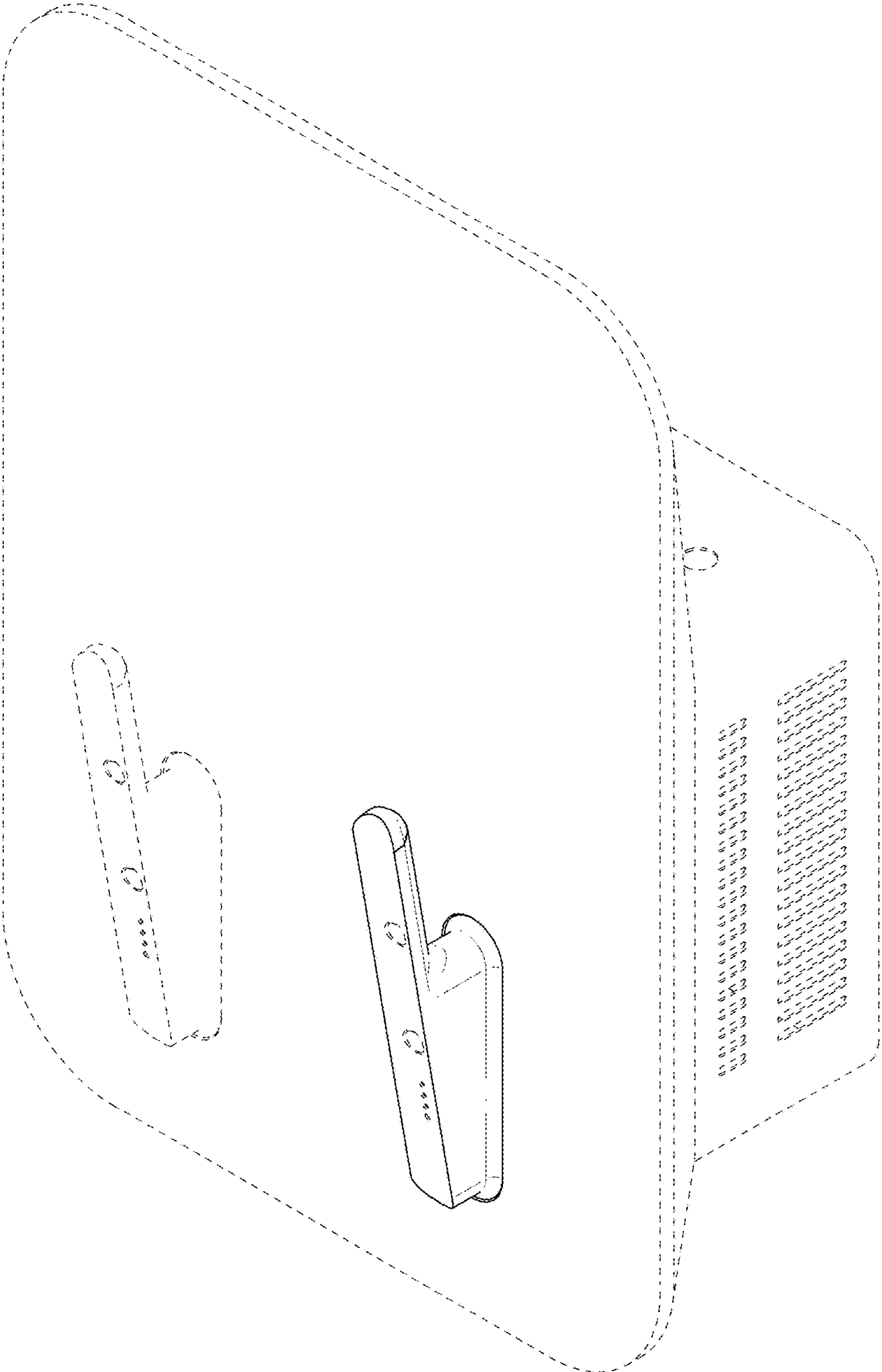

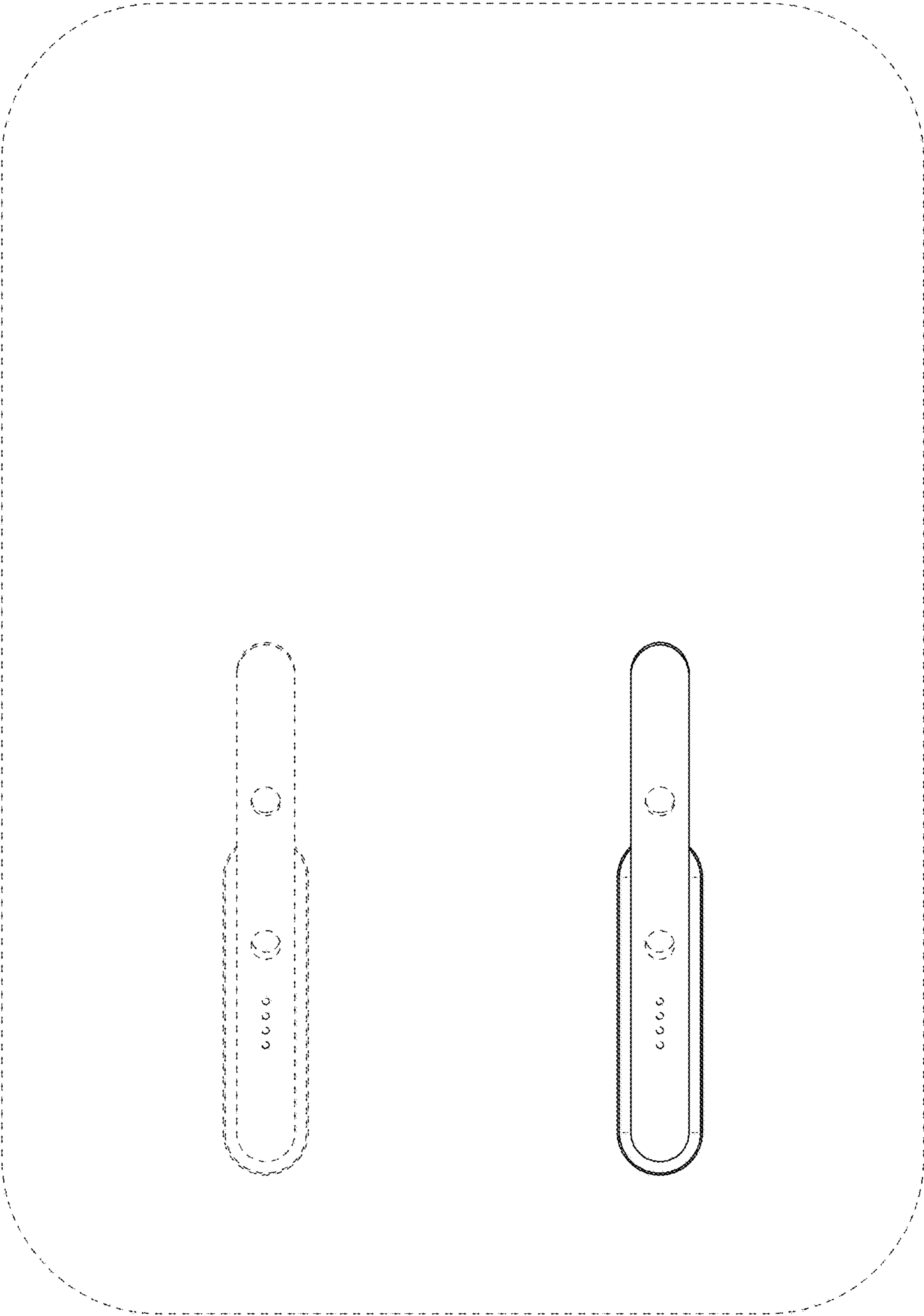

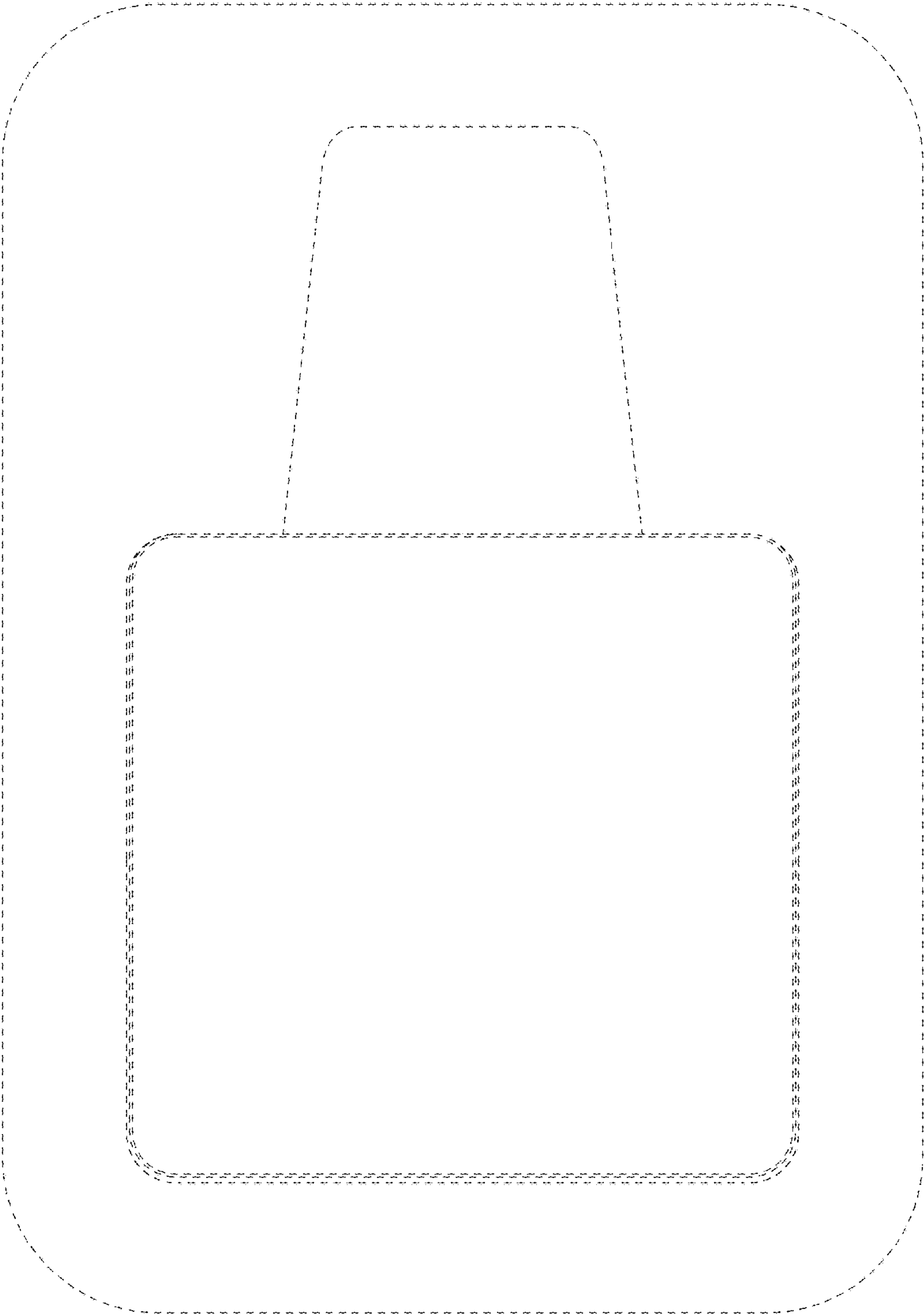

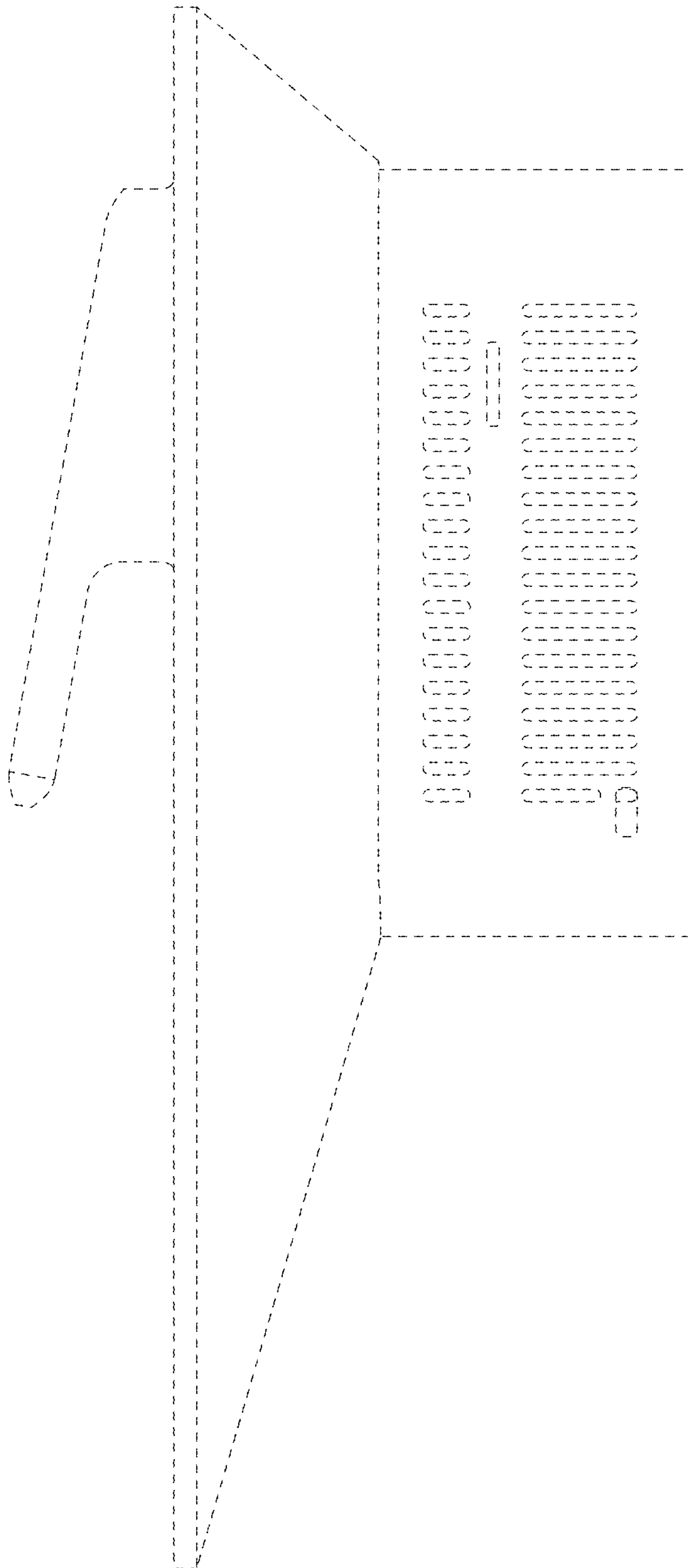

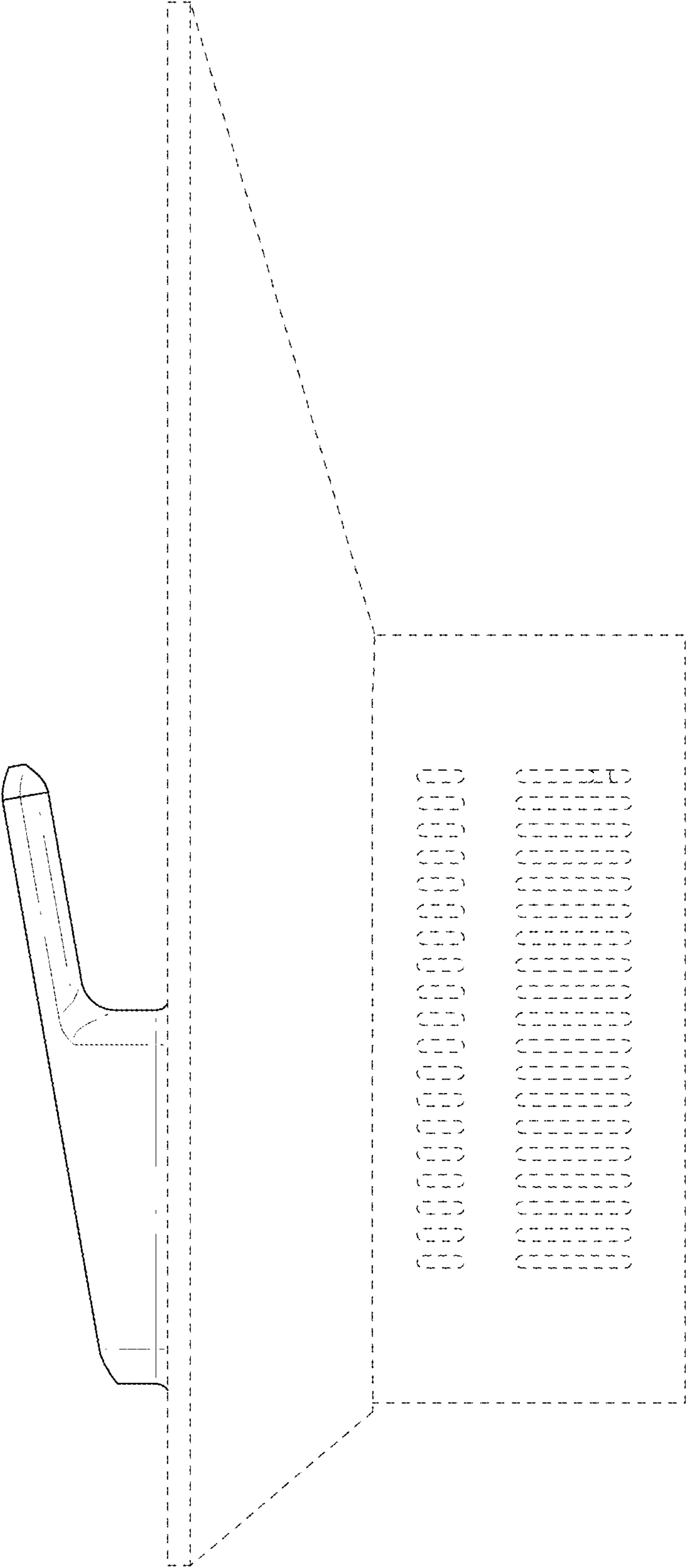
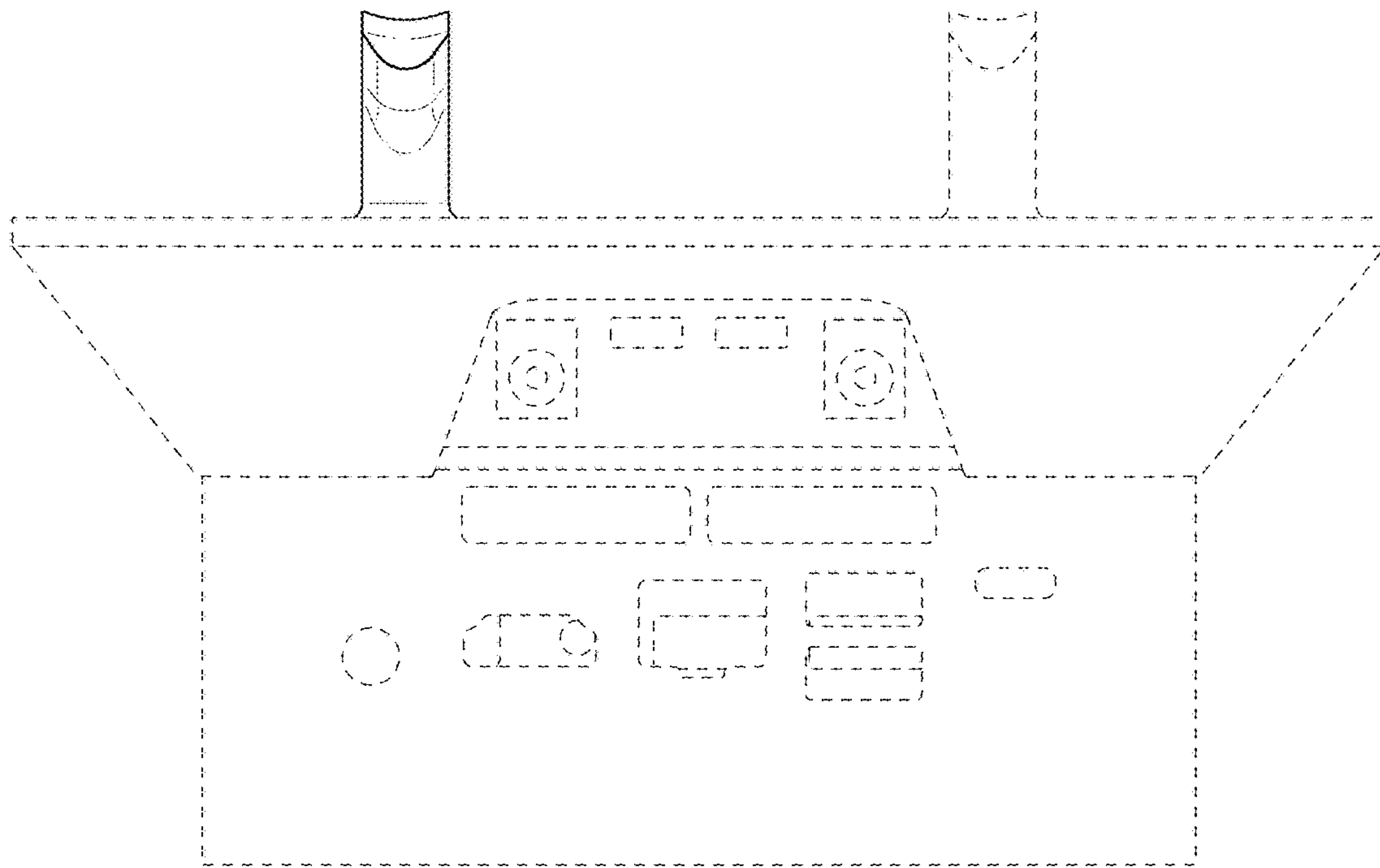
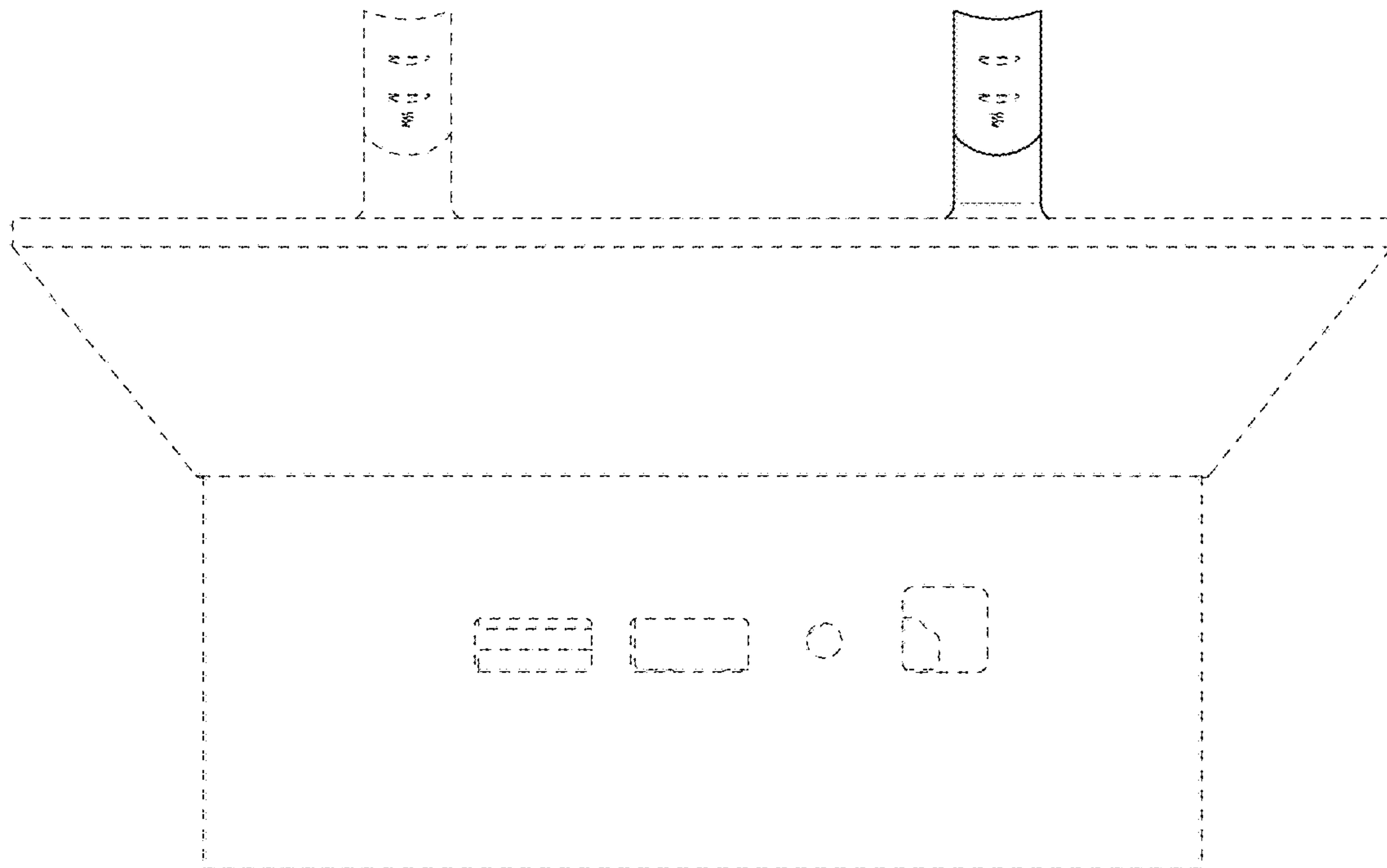

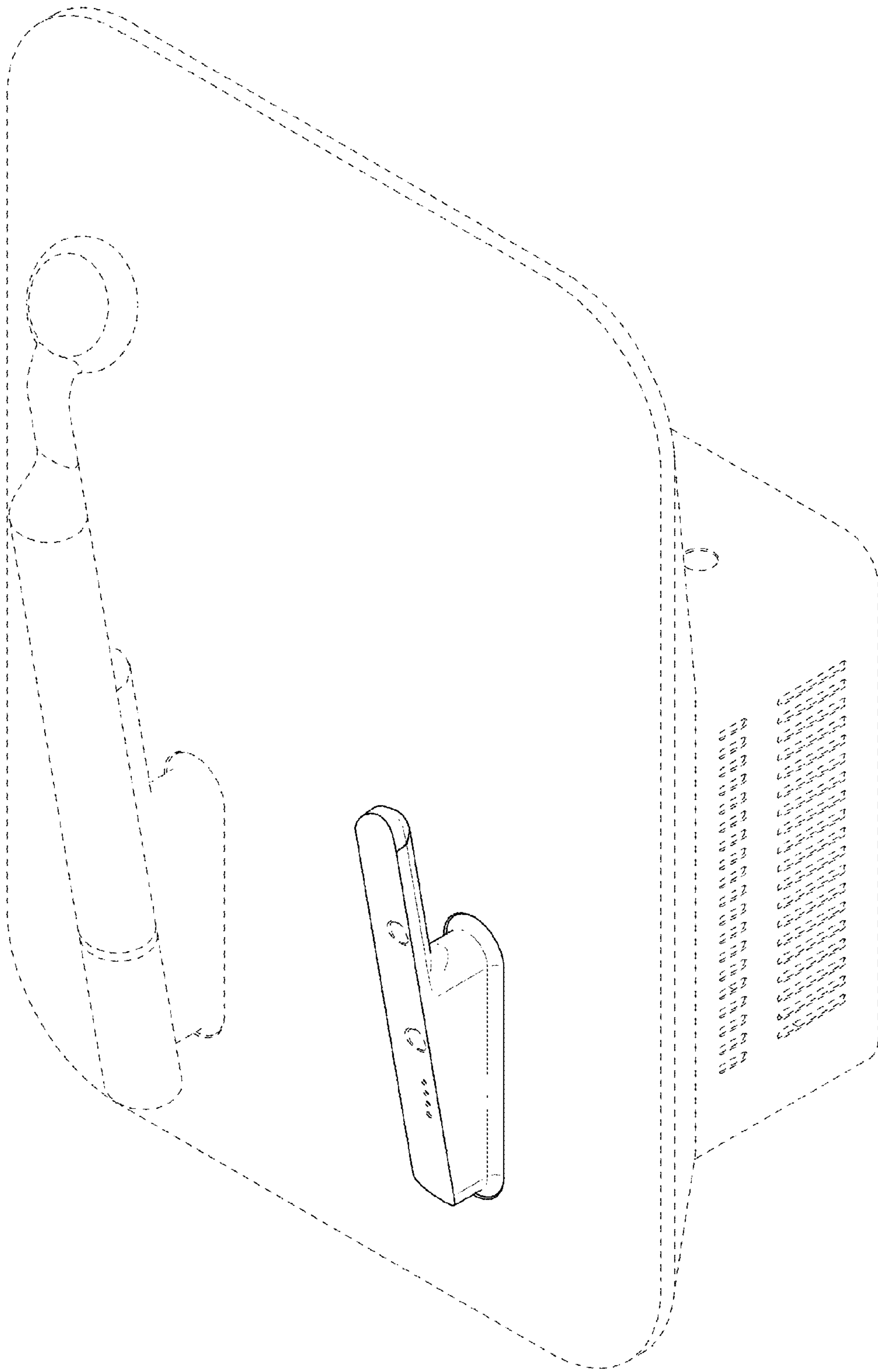
