**DESCRIPTION**

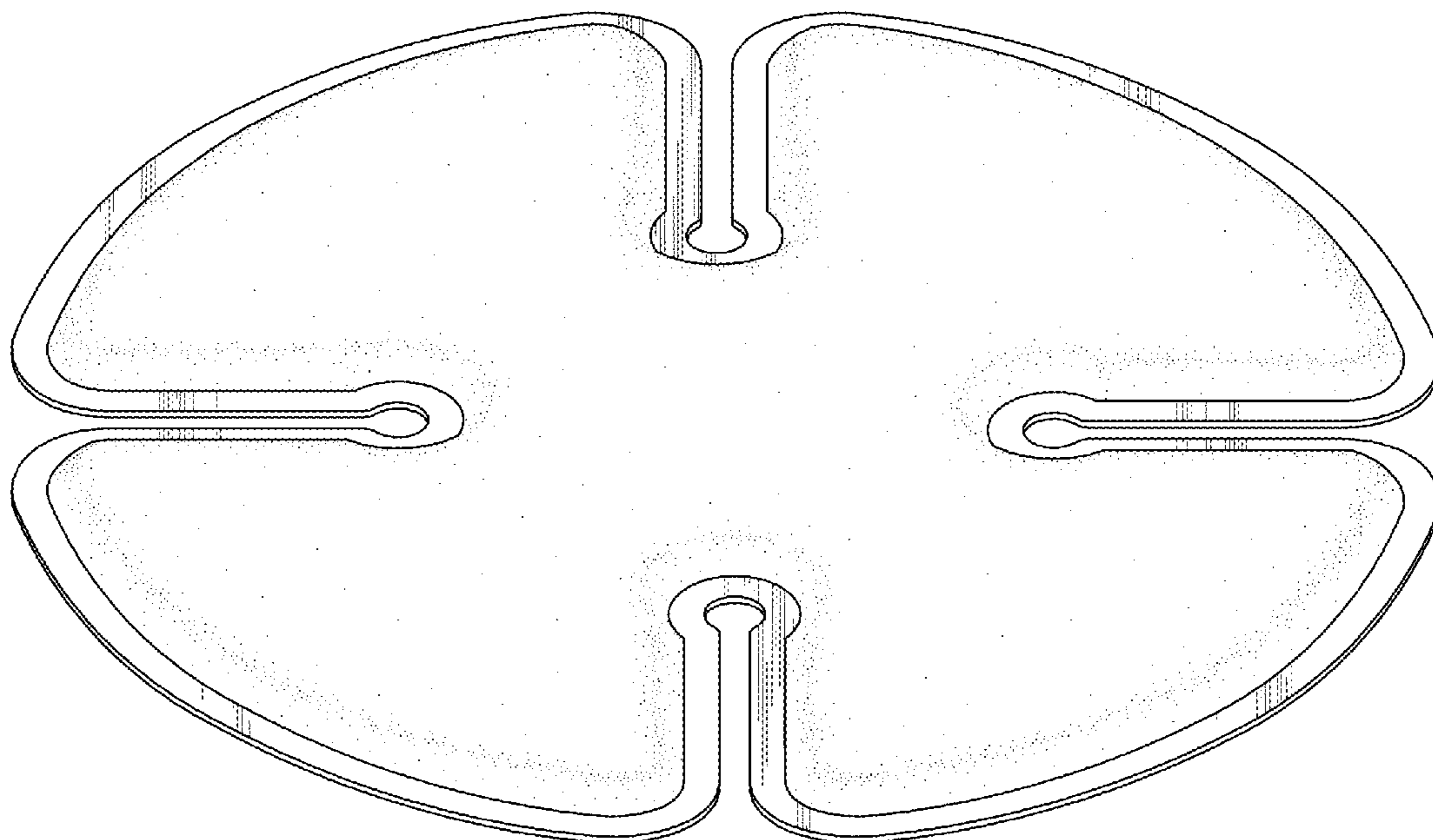
FIG. 1 is a perspective view of a thermal pack according to my design;

 The rear elevation view is a mirror image of the front elevation view. The right side elevation view is a mirror image of the left side elevation view.

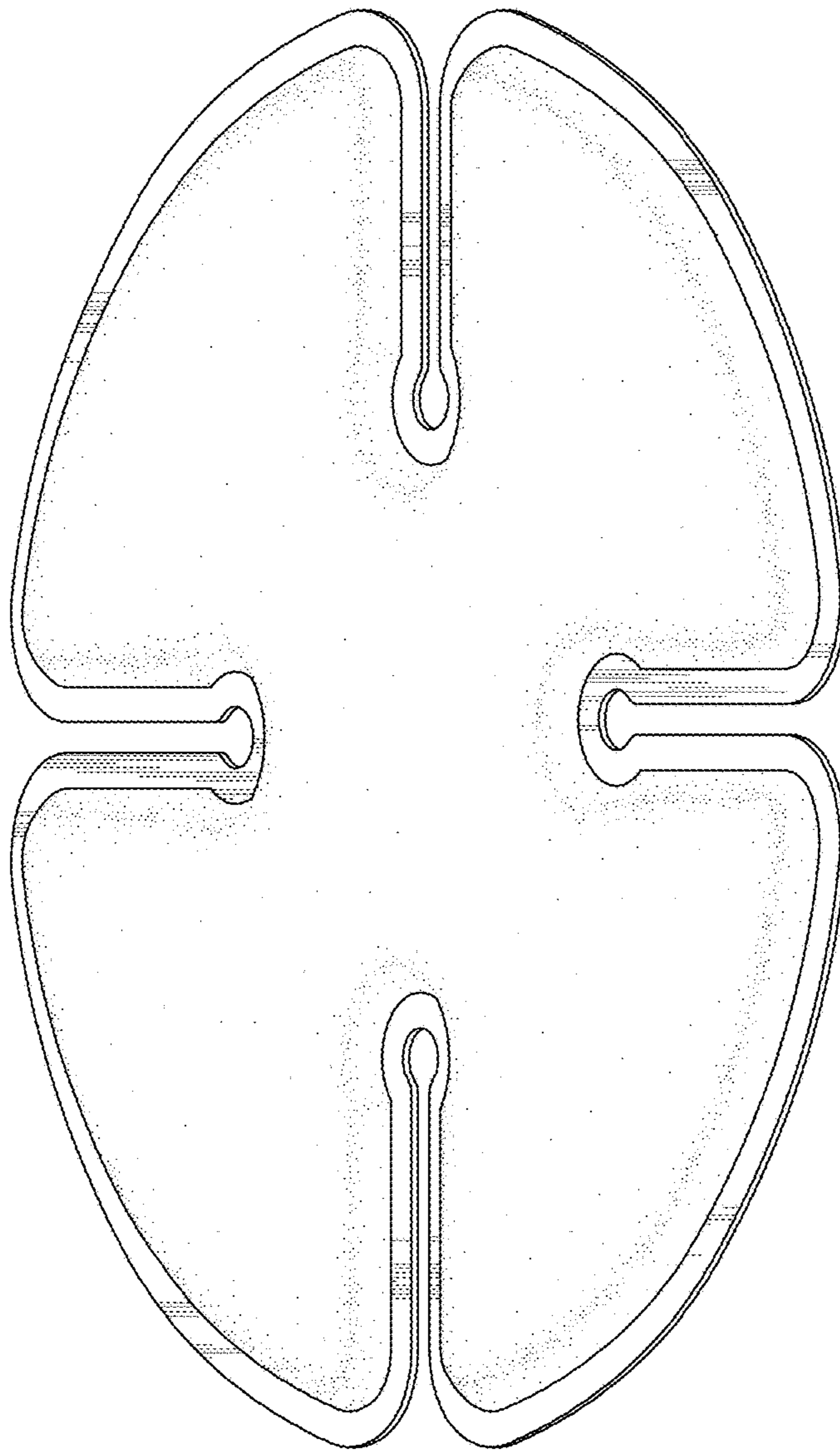

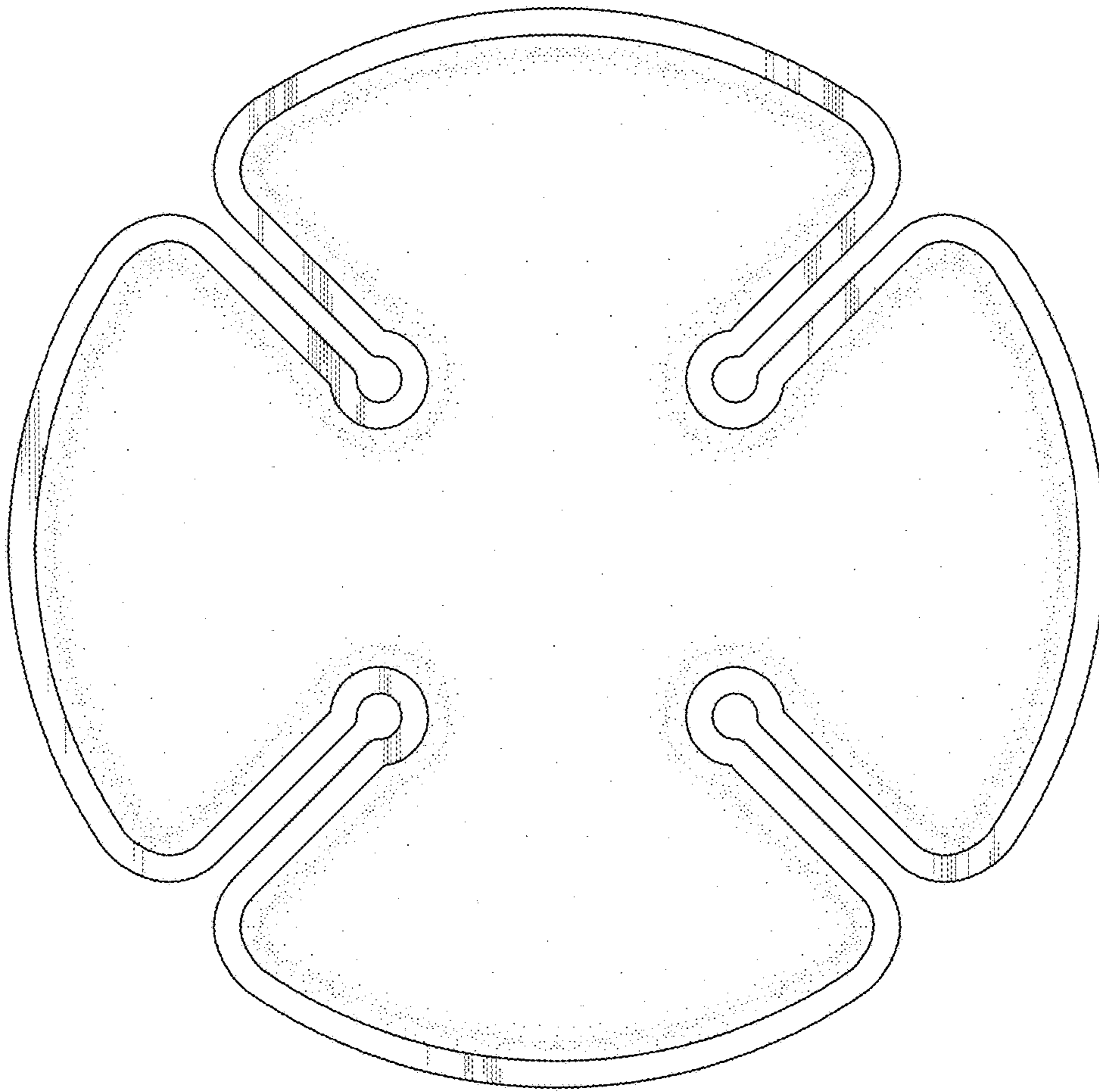
