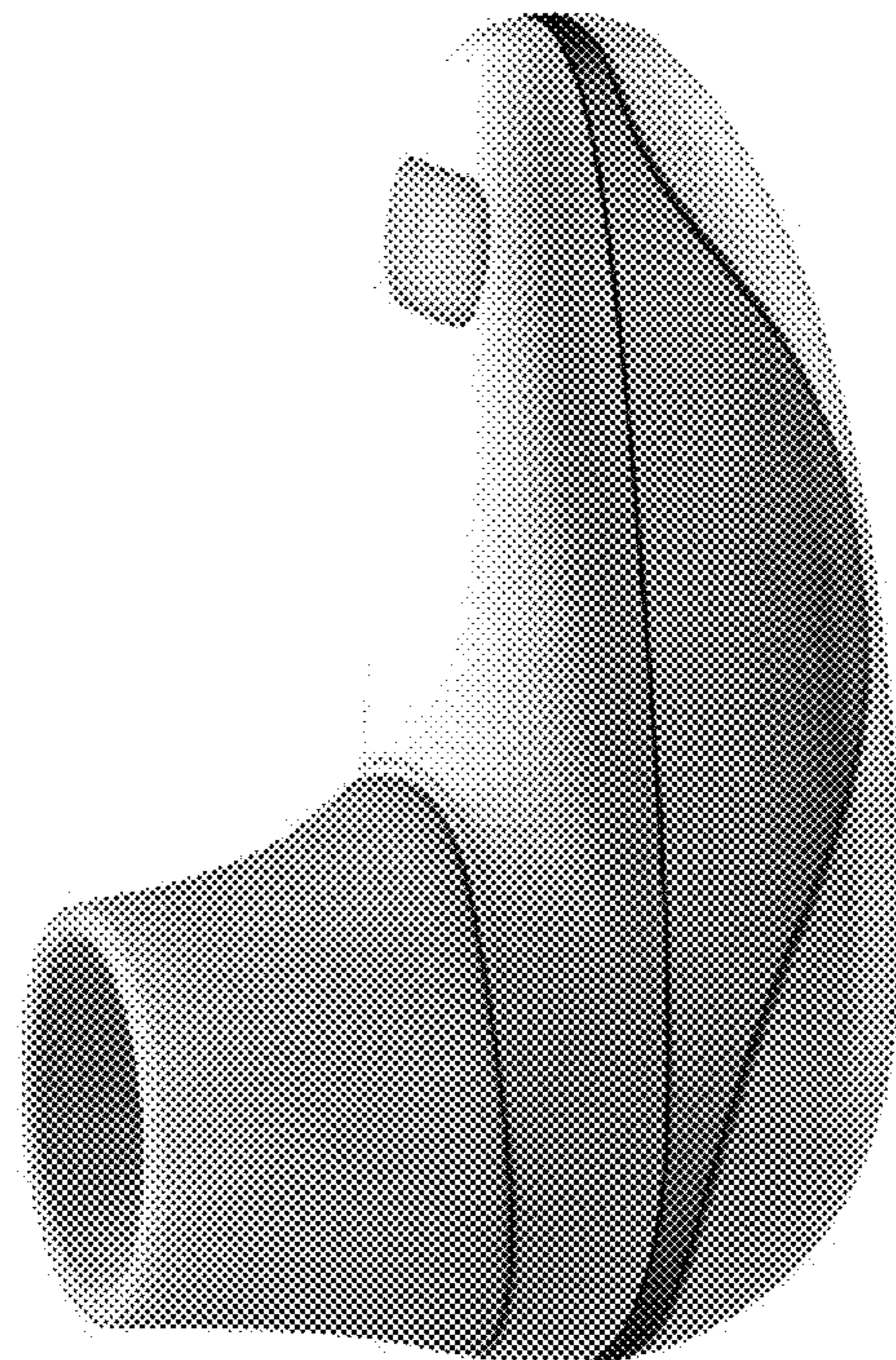
1.-2. Massage device

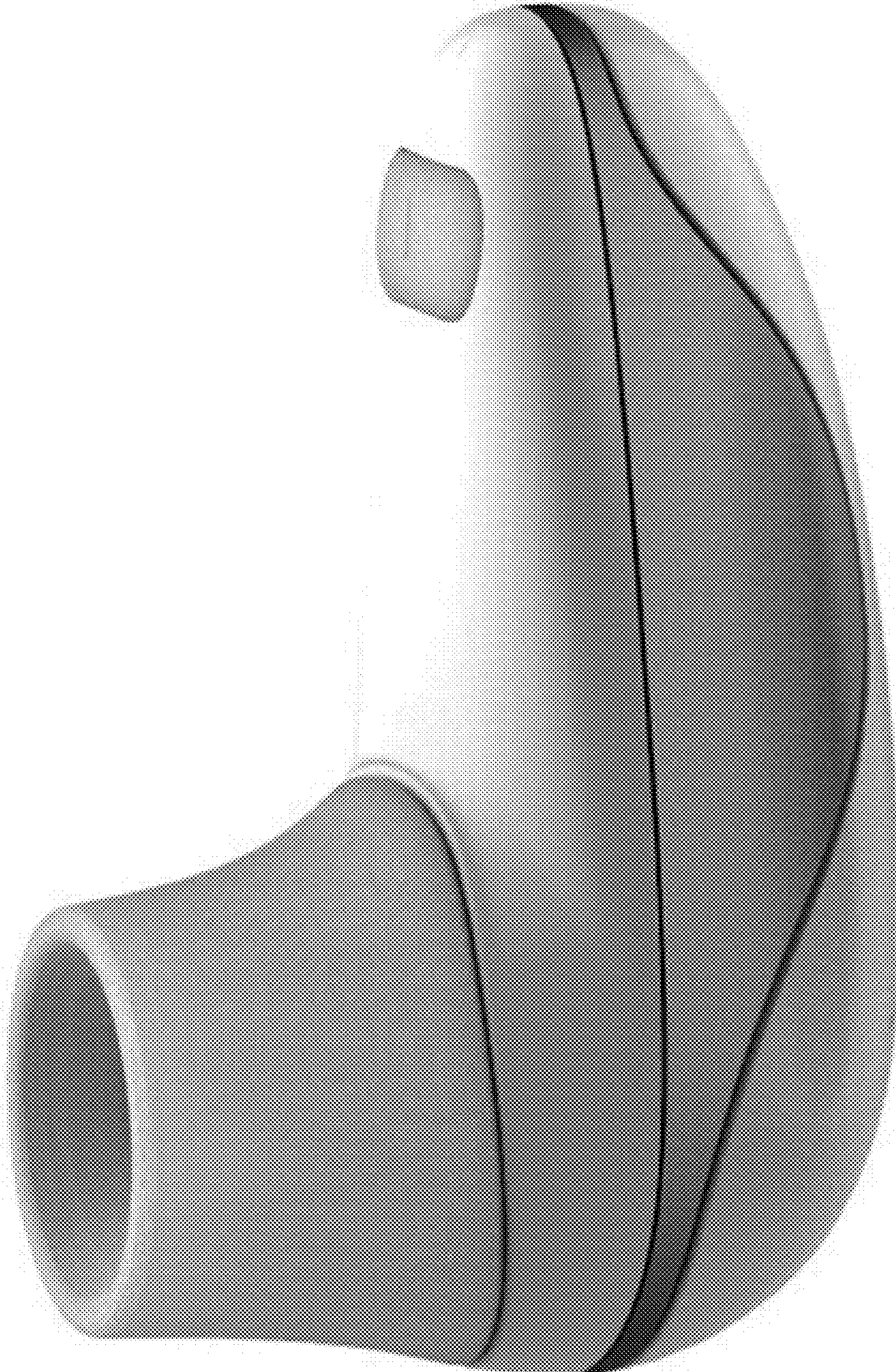
