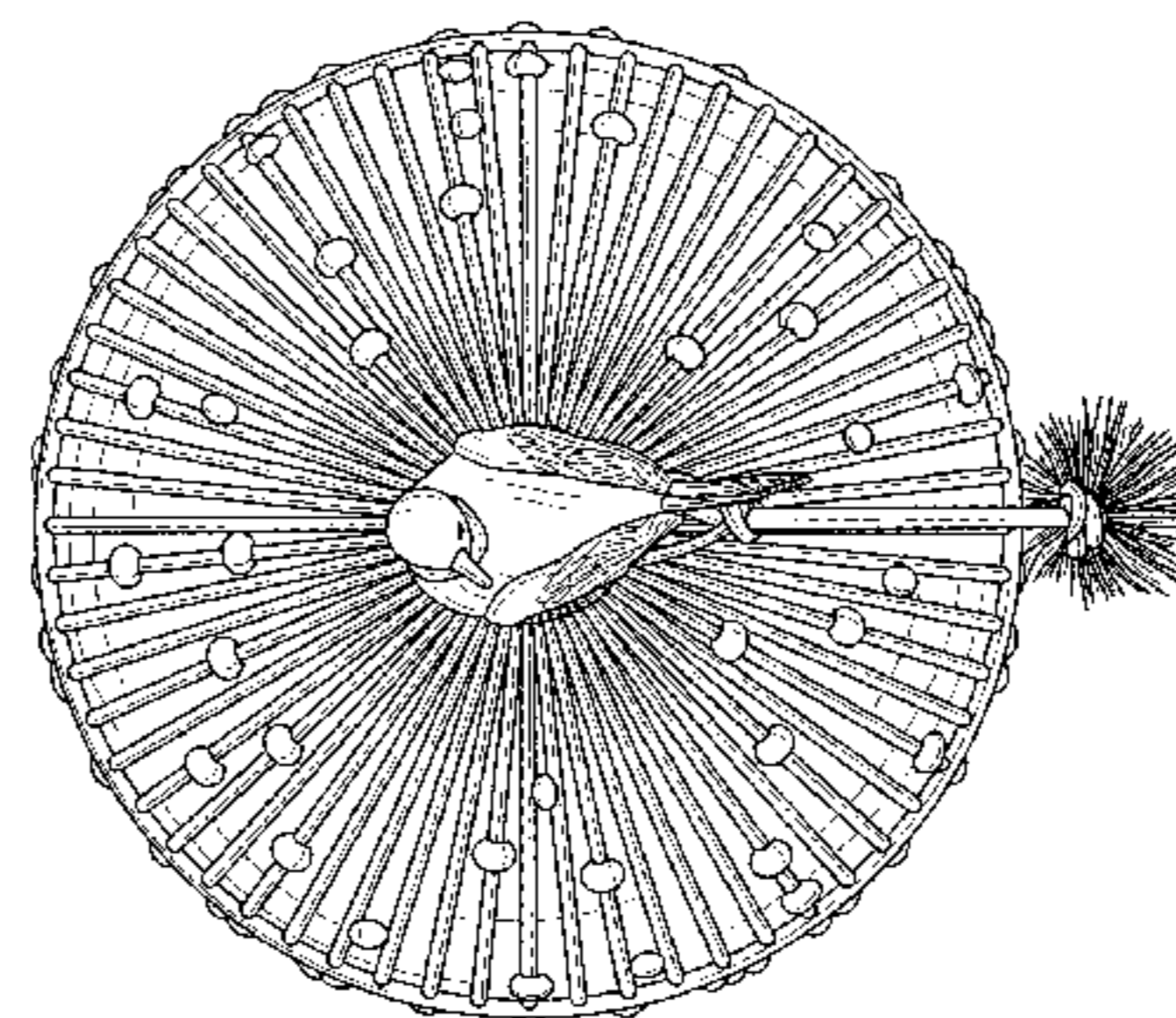
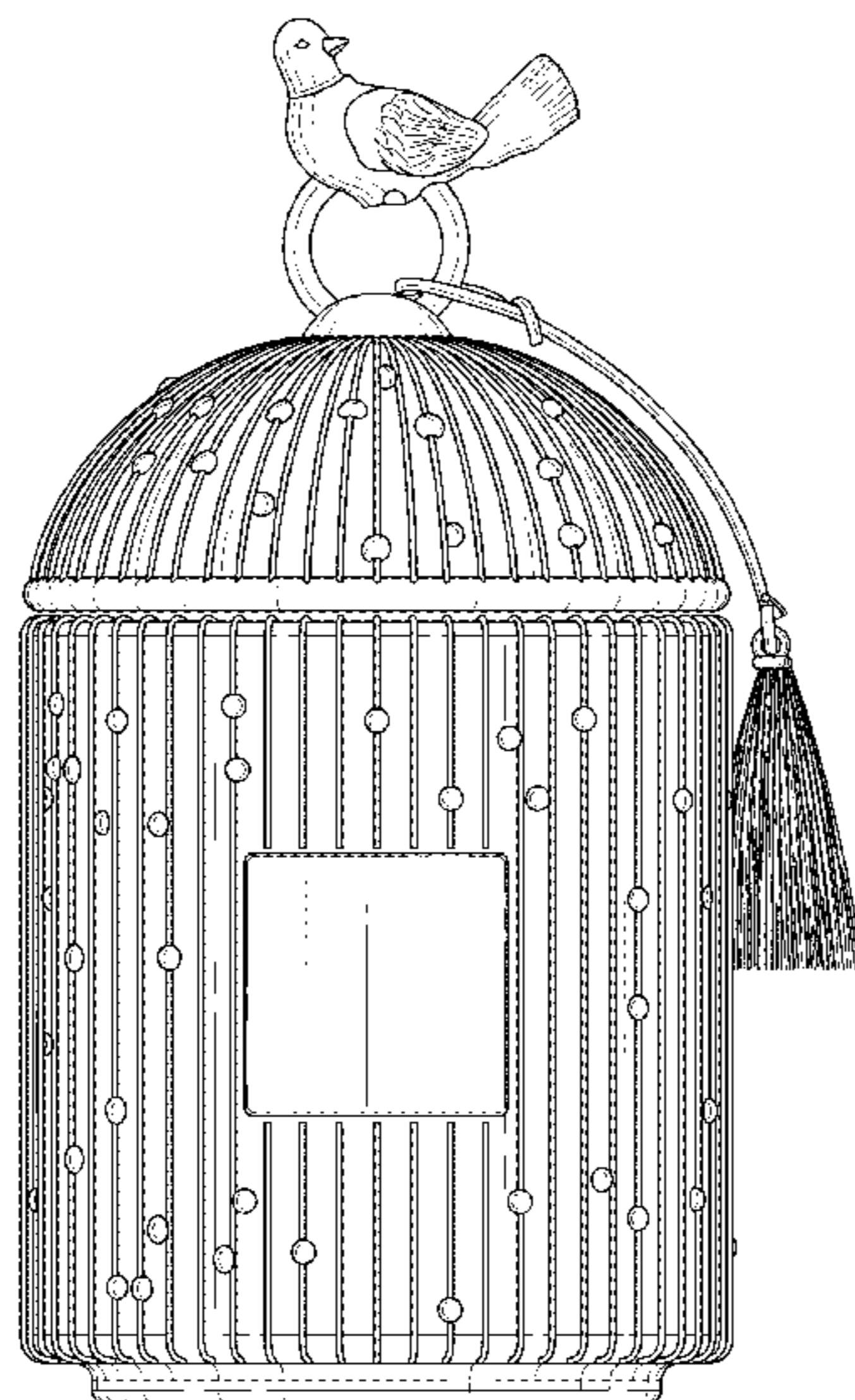
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a Perspective view of a candle stand showing my new design;

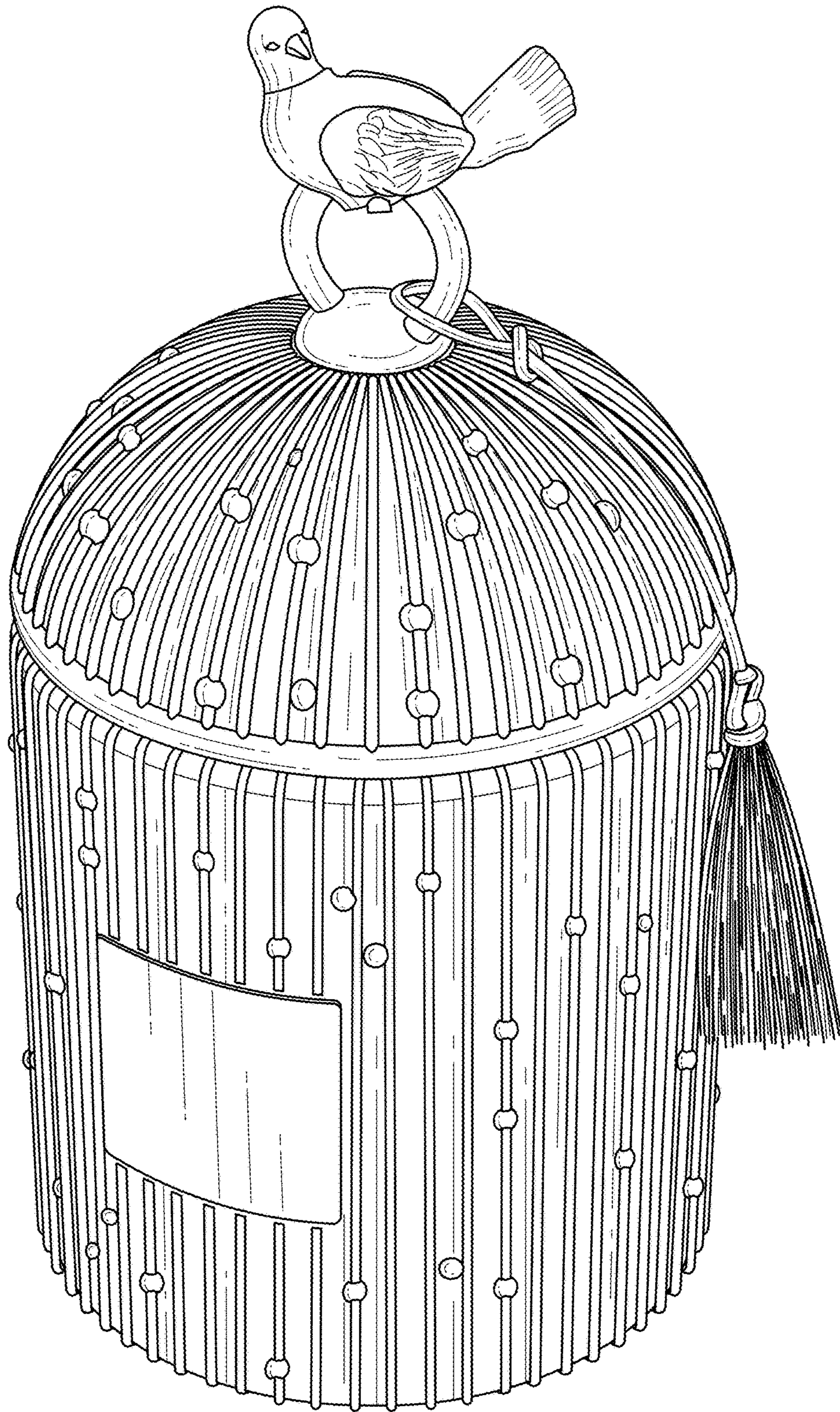

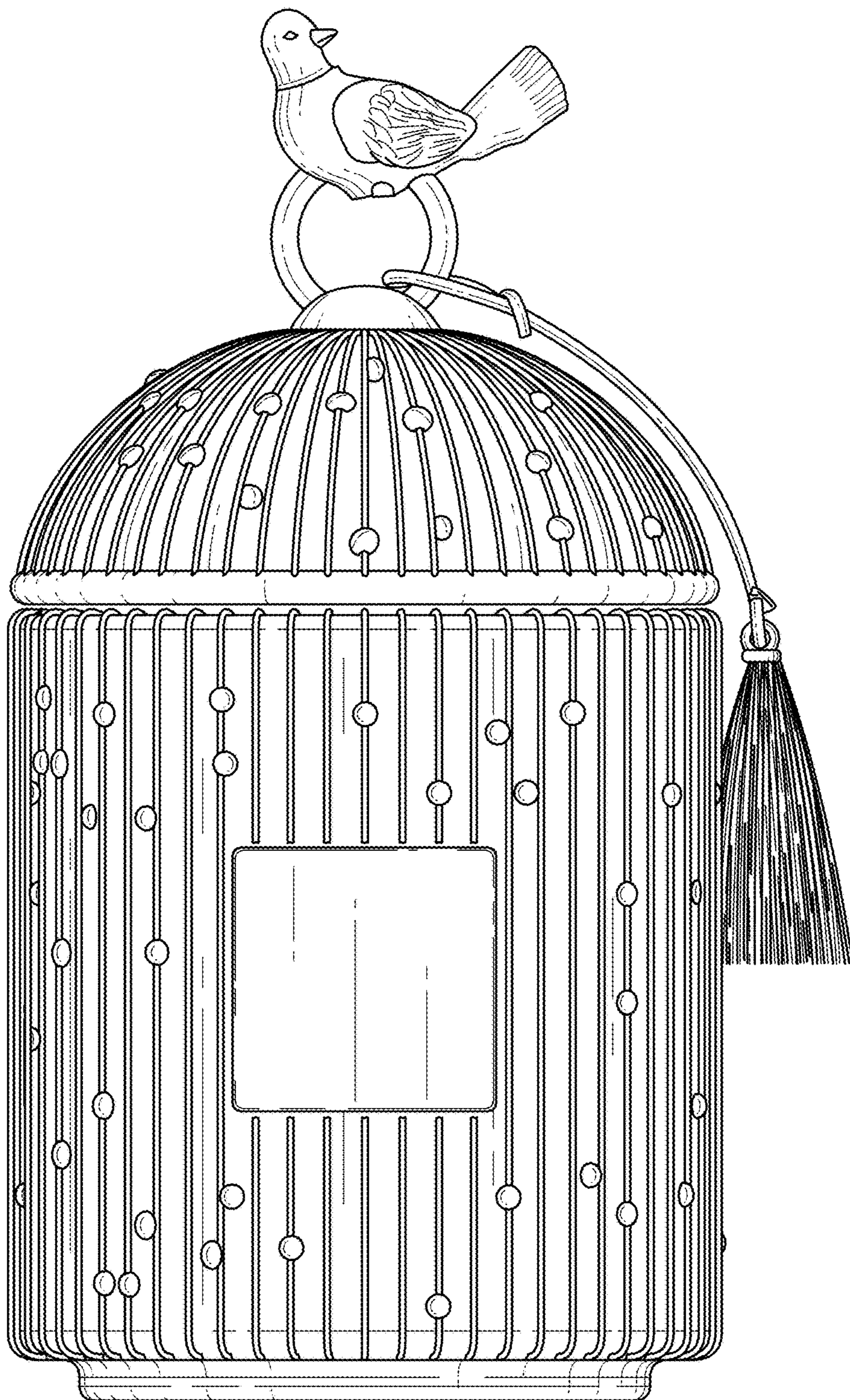

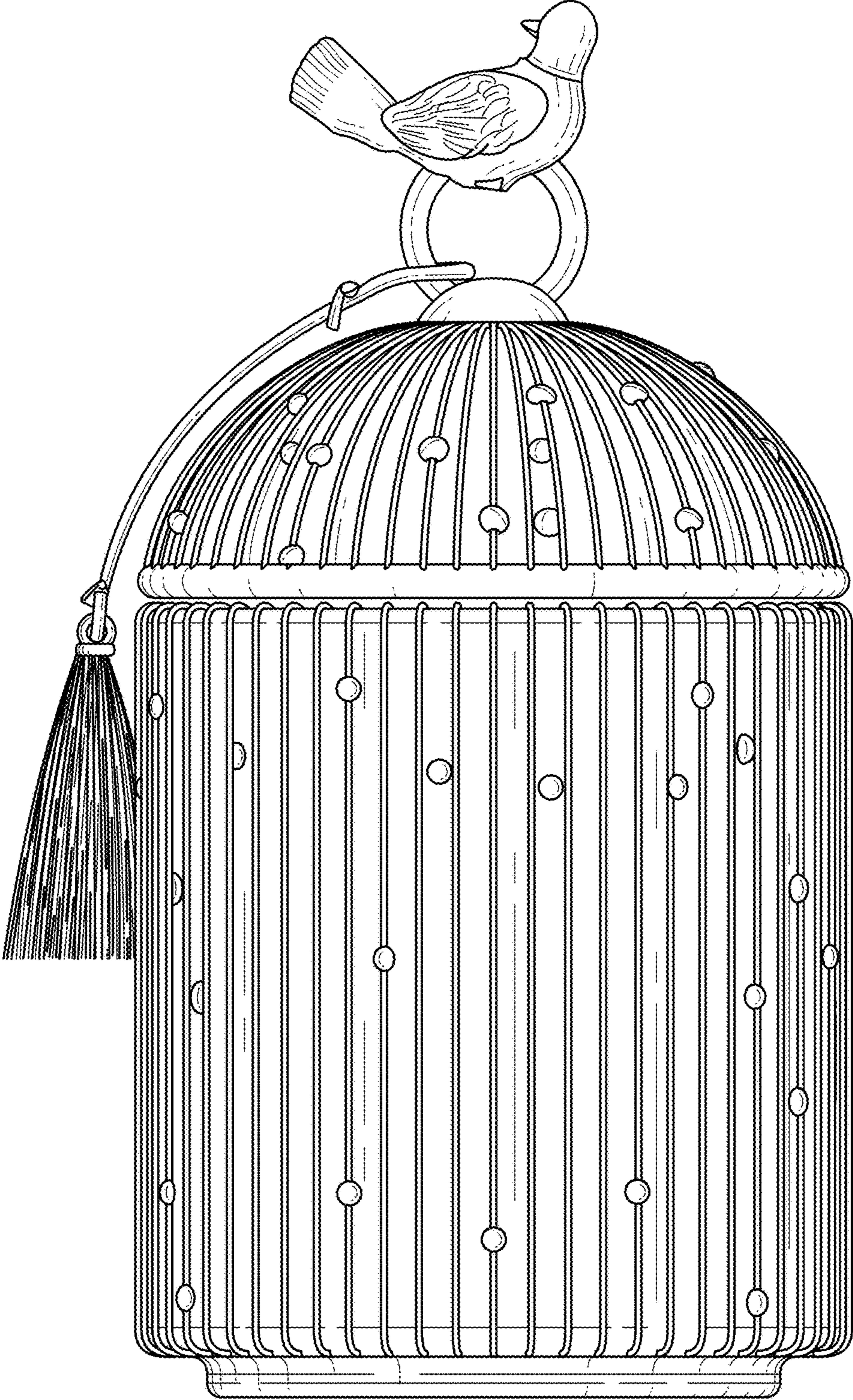

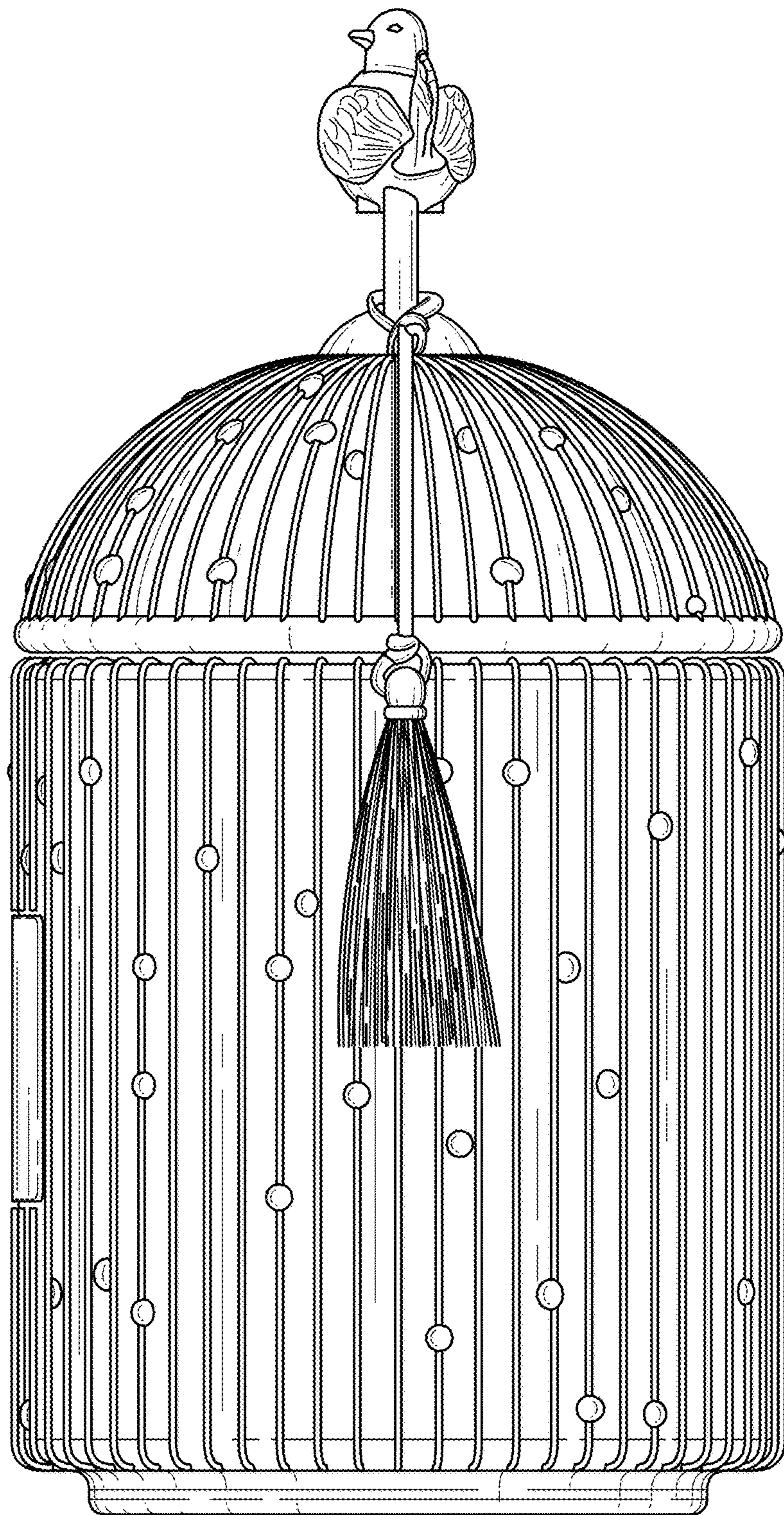

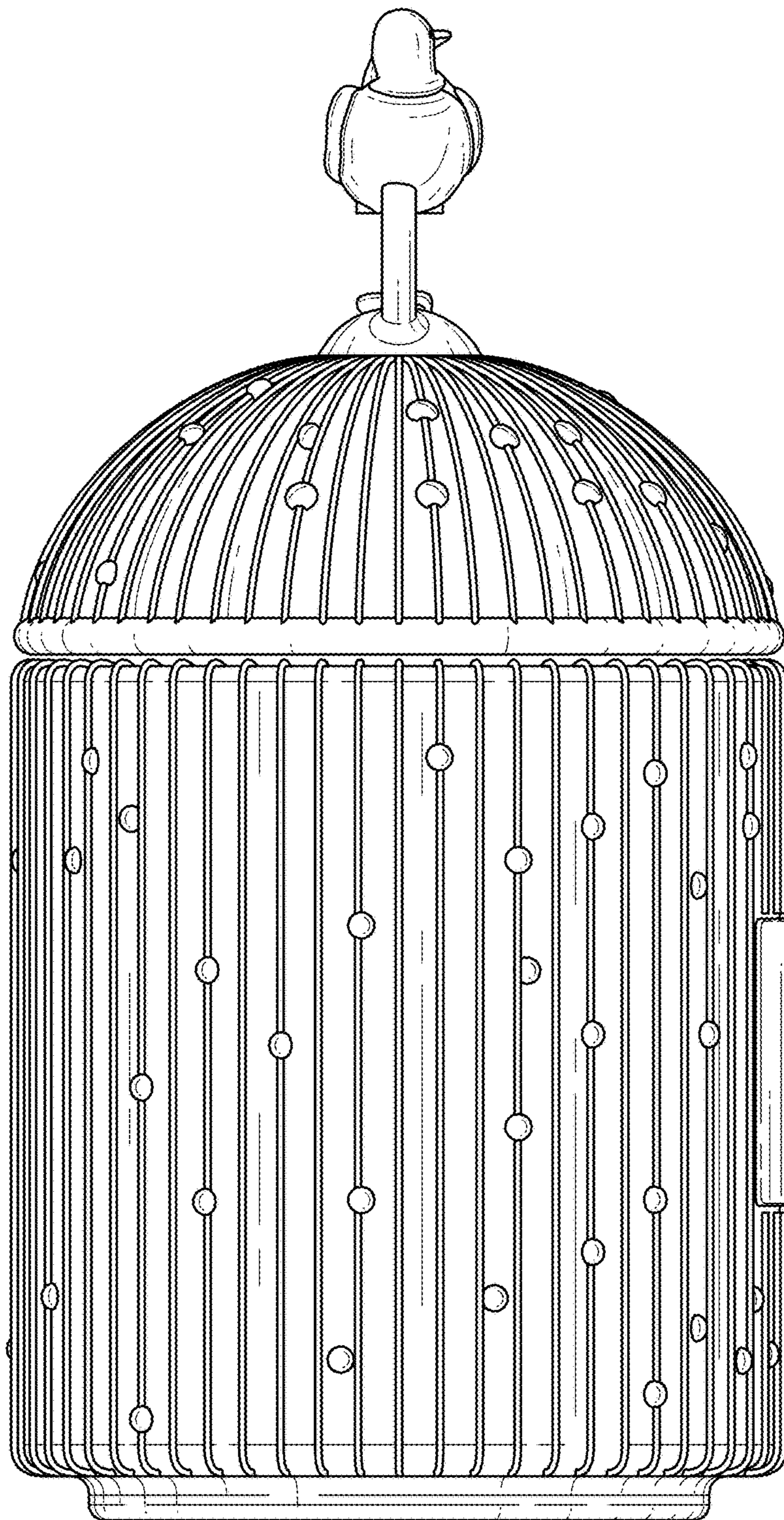

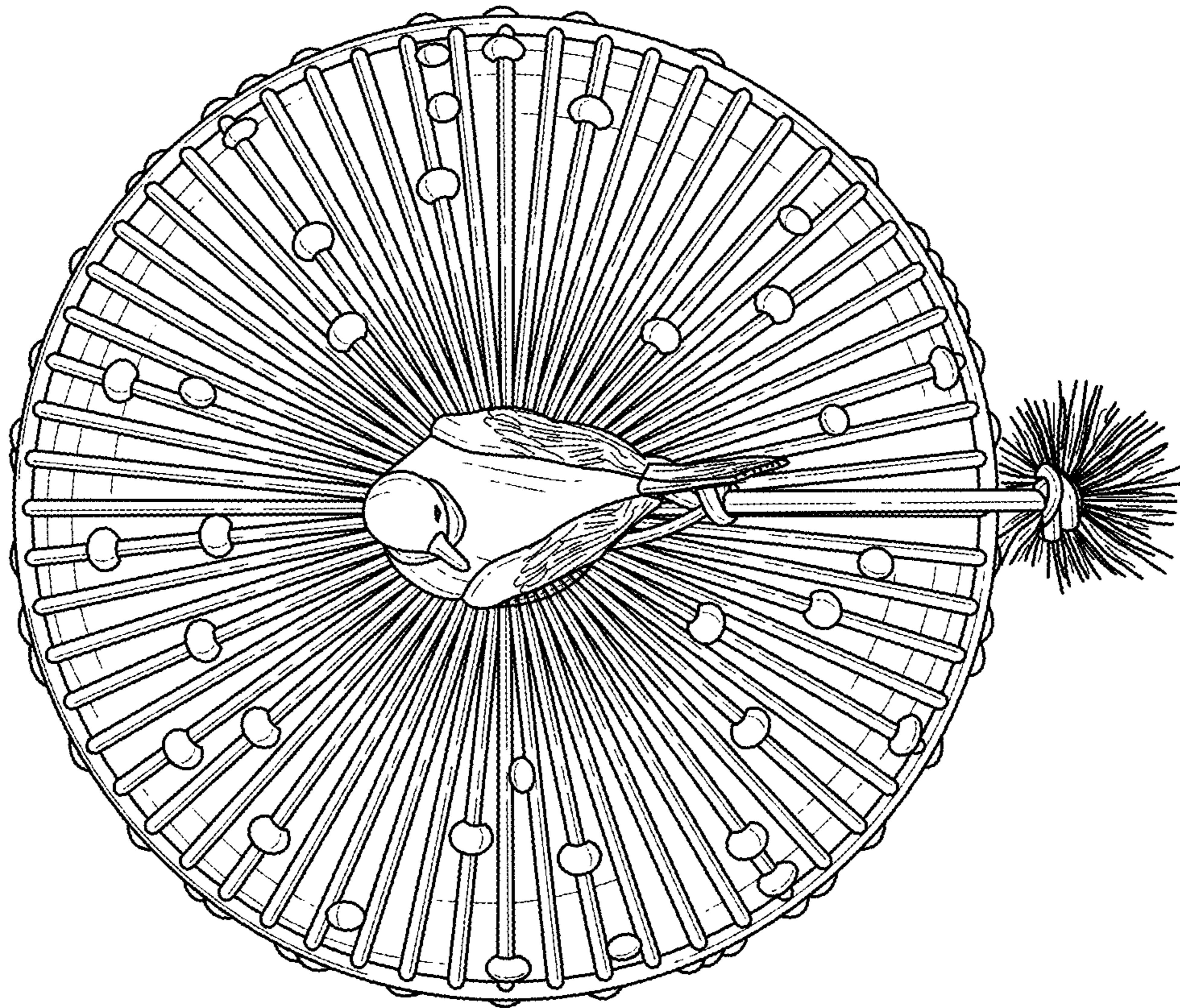

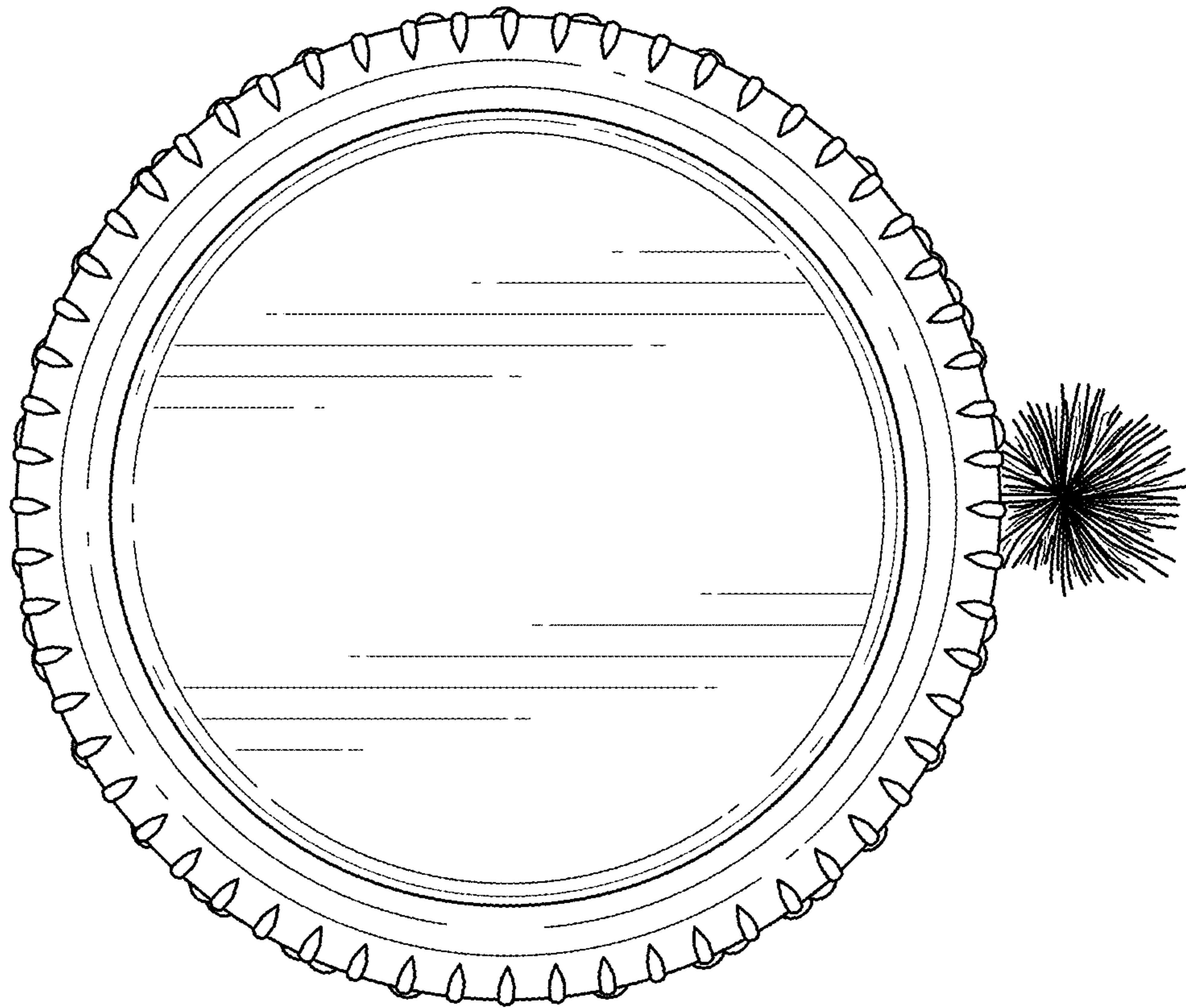
