DESCRIPTION

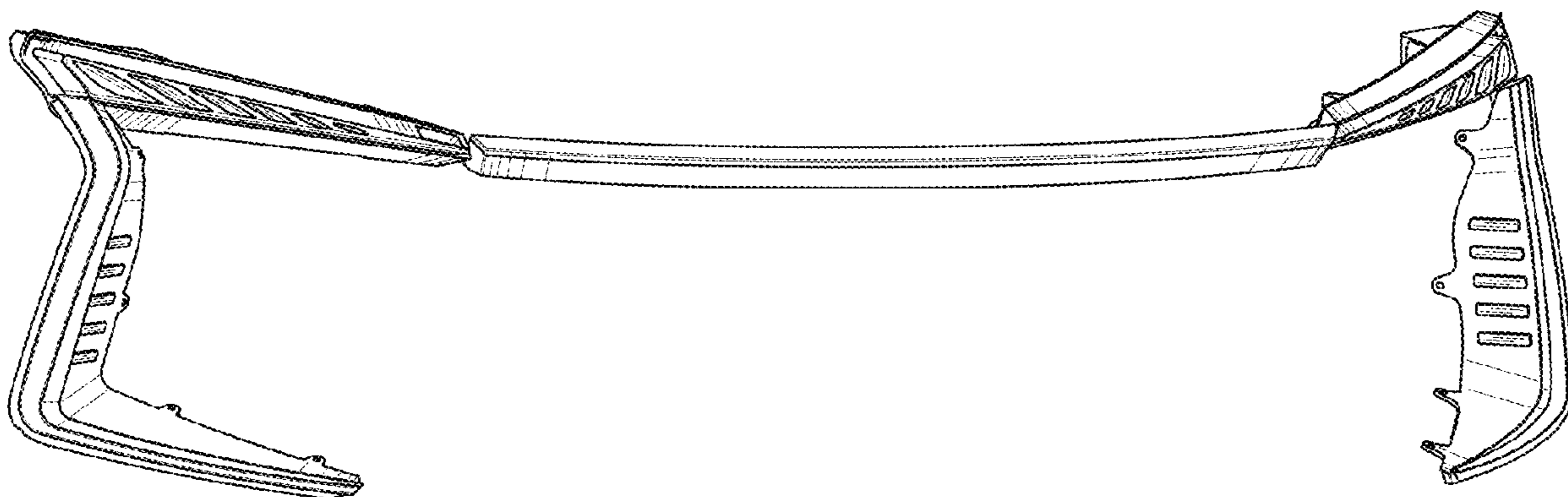
FIG. 1 is a perspective view of an automobile headlamp, showing our new design;

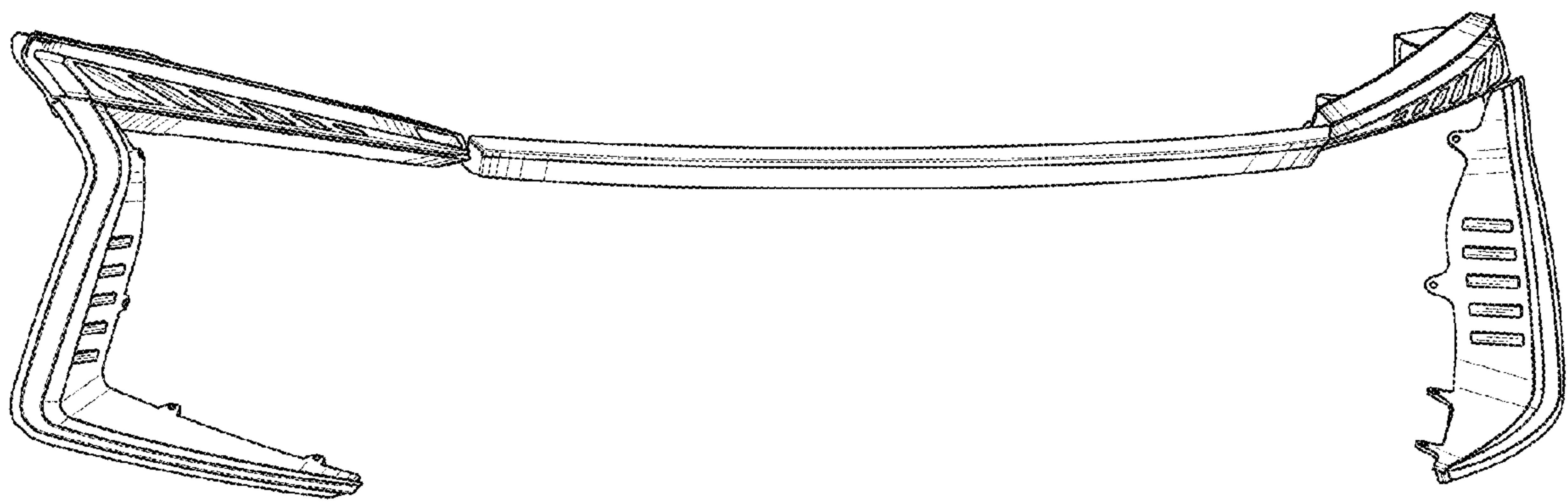

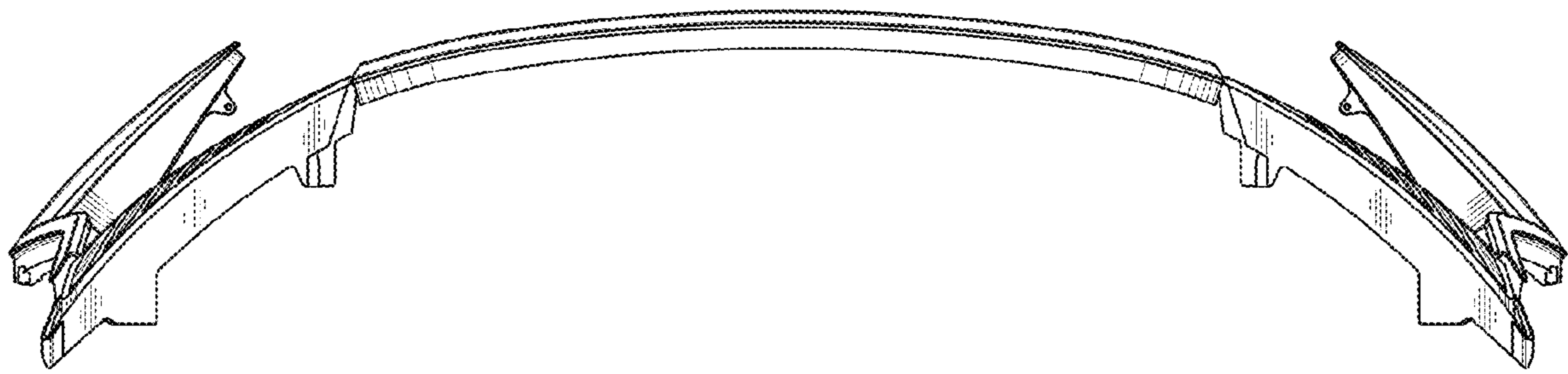

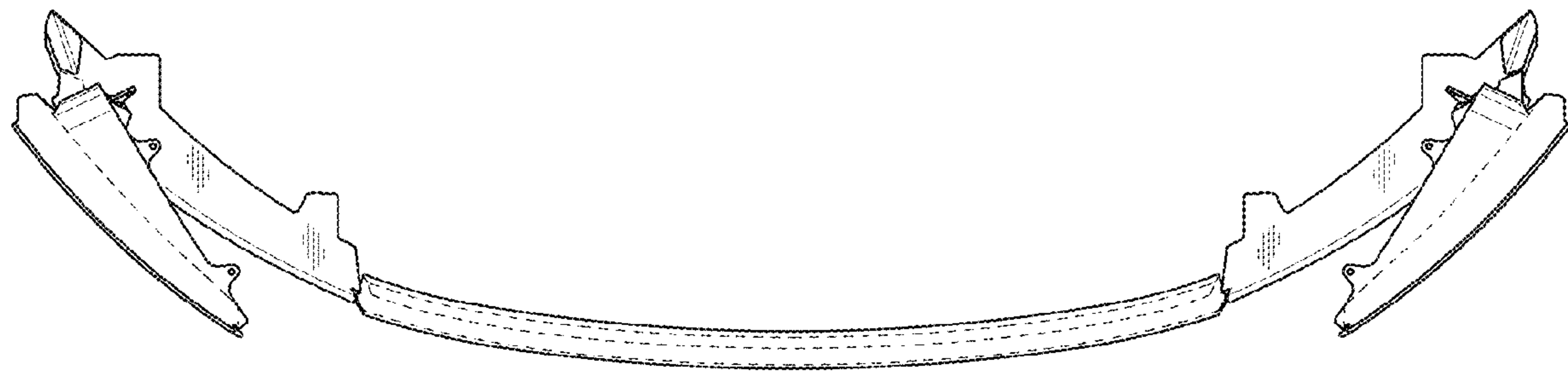

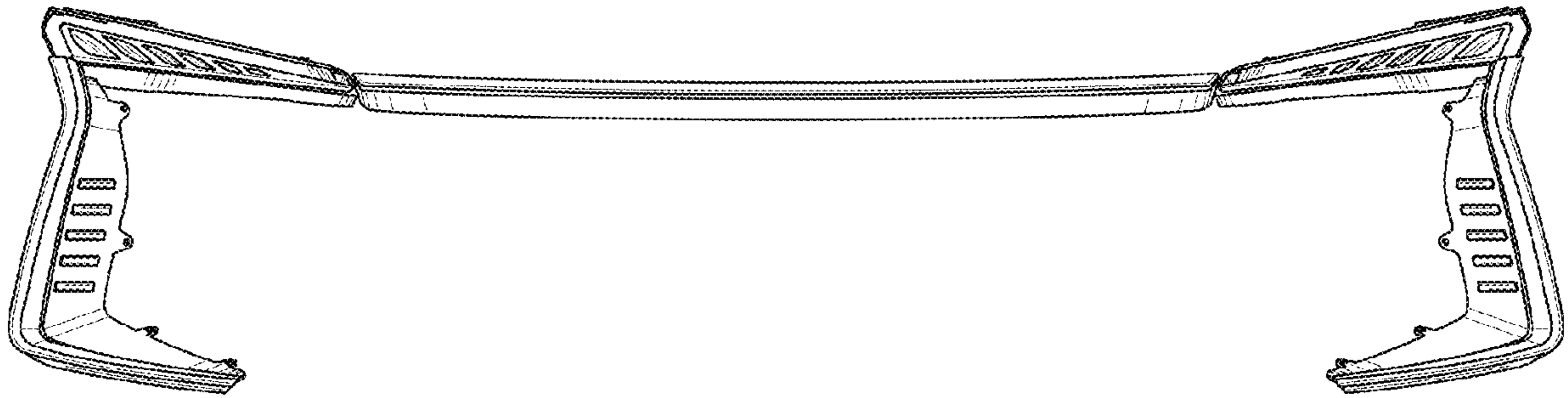

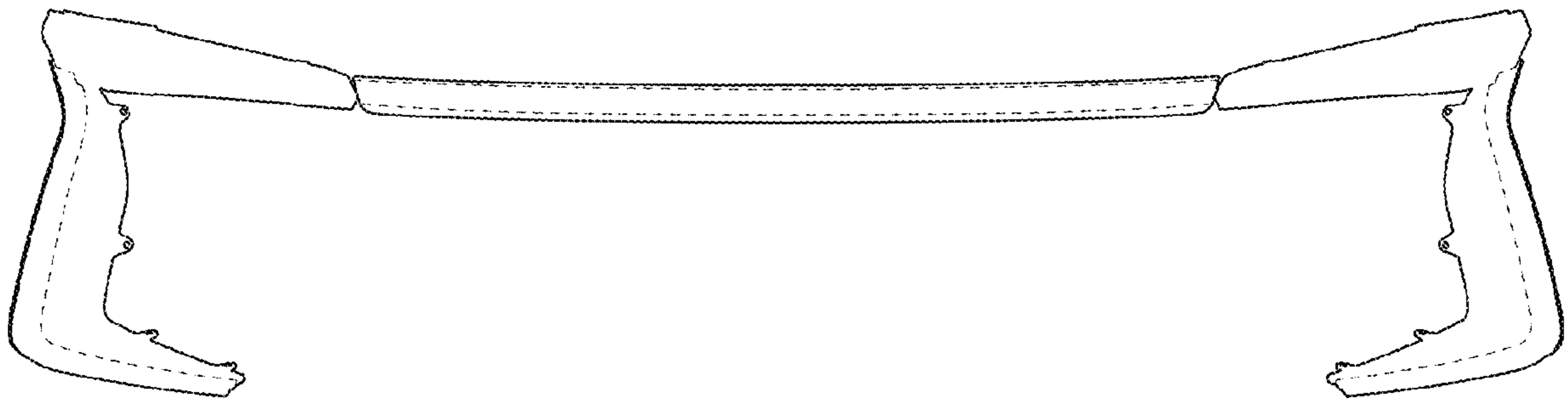

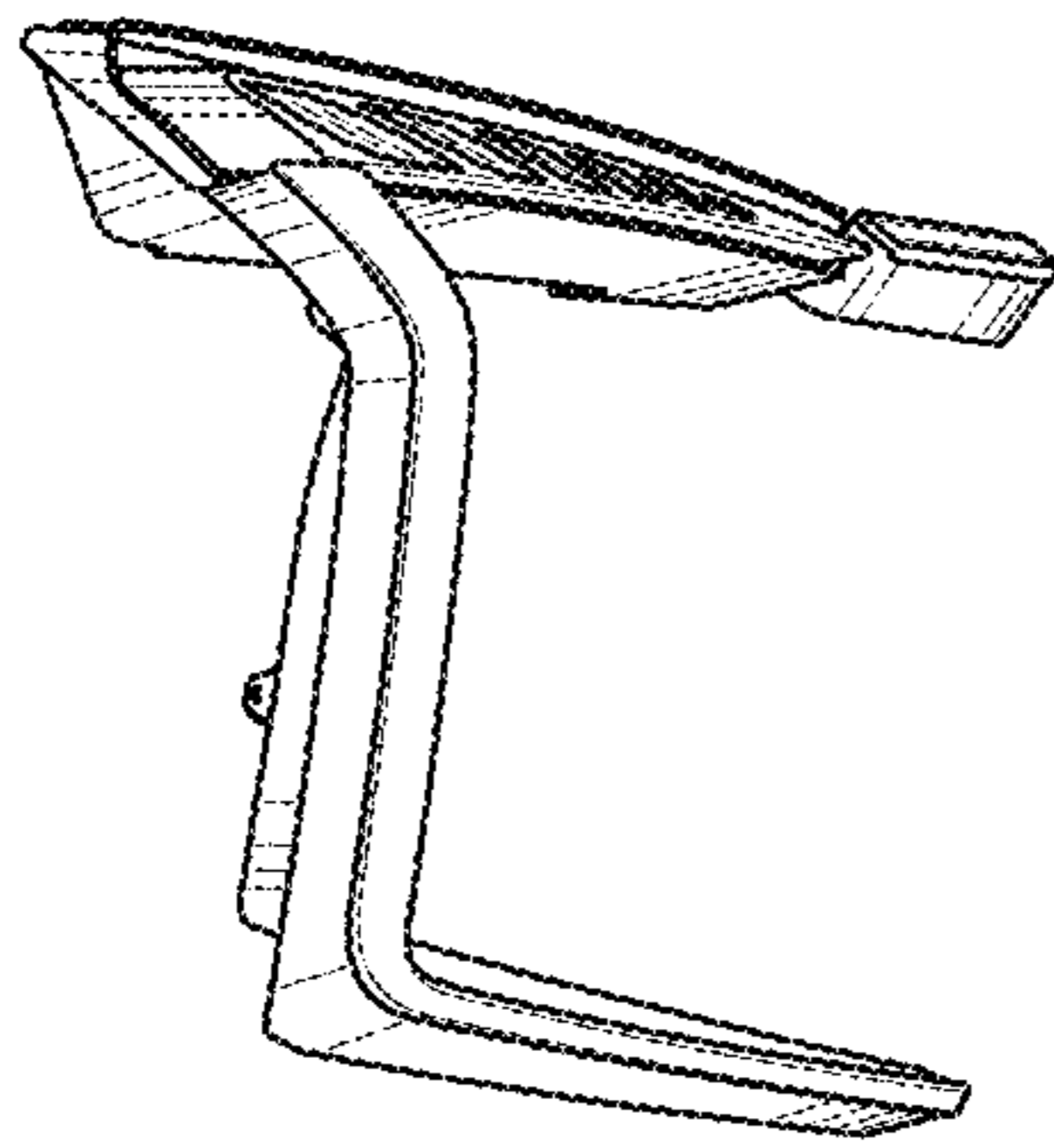

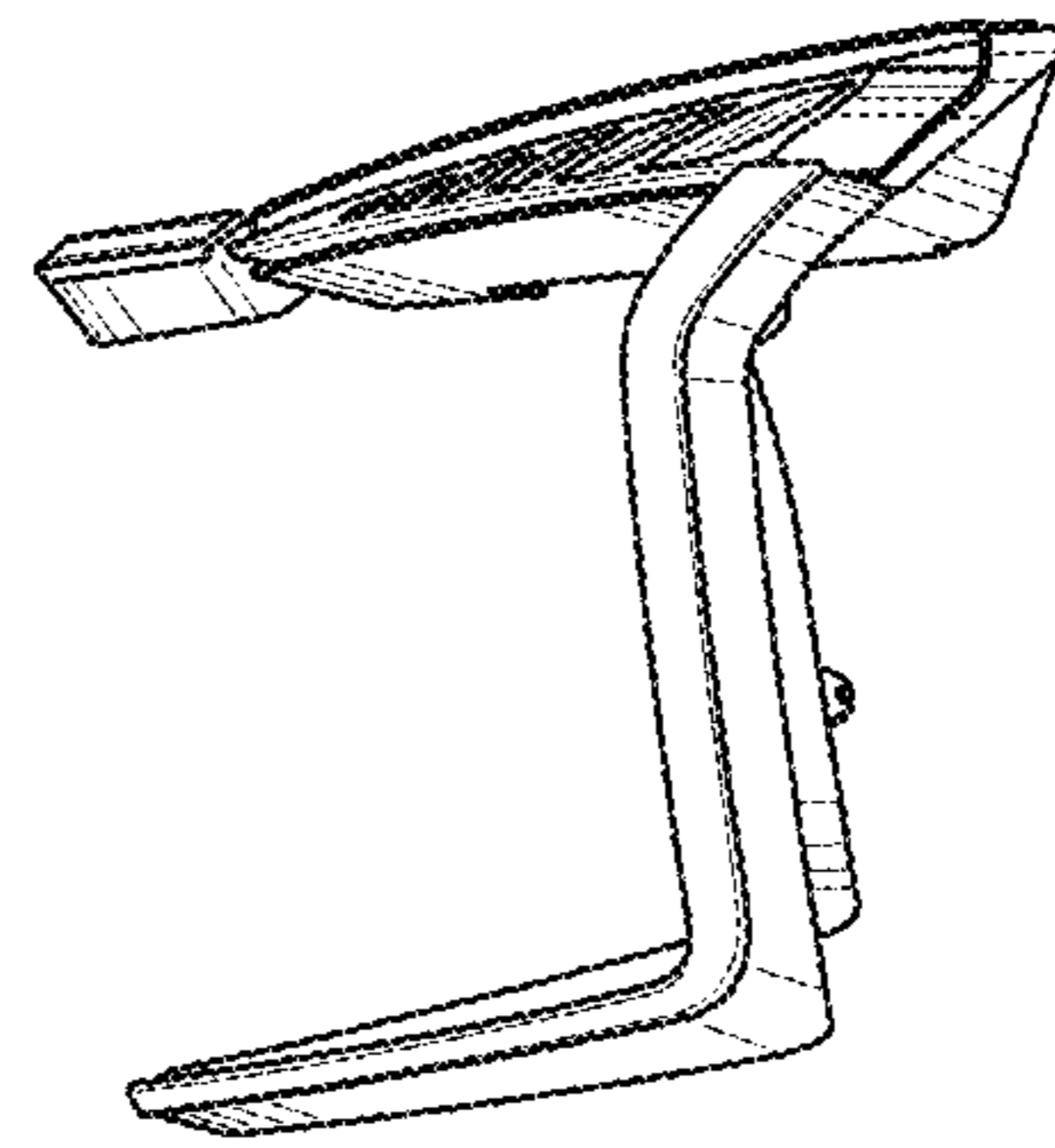
