DESCRIPTION

 FIG. 14 is a bottom plan view of FIG. 8.

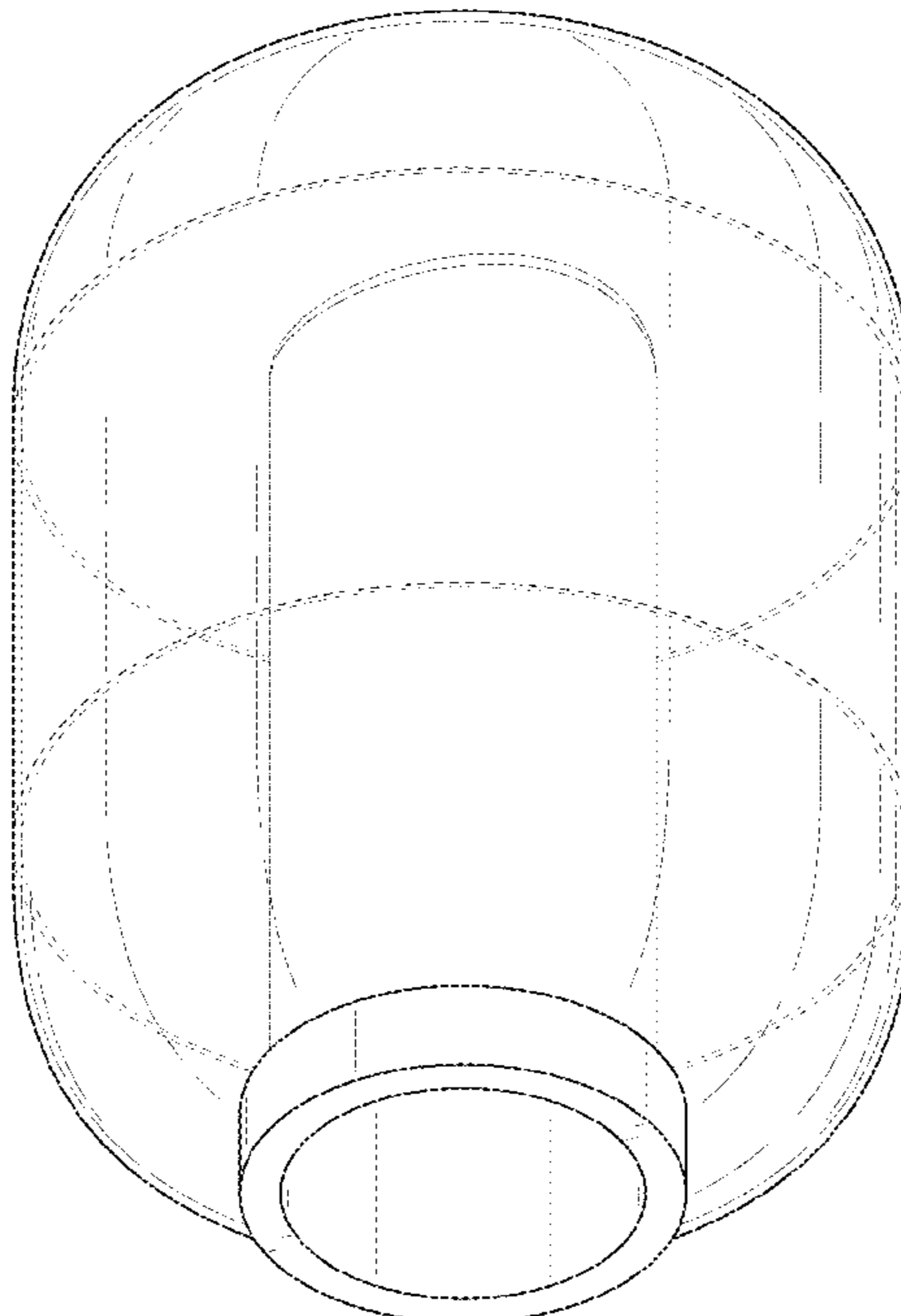
The broken lines shown in the drawings are included for the purpose of illustrating elements of the light trim that is attachable to a light fixture and form no part of the claimed design.

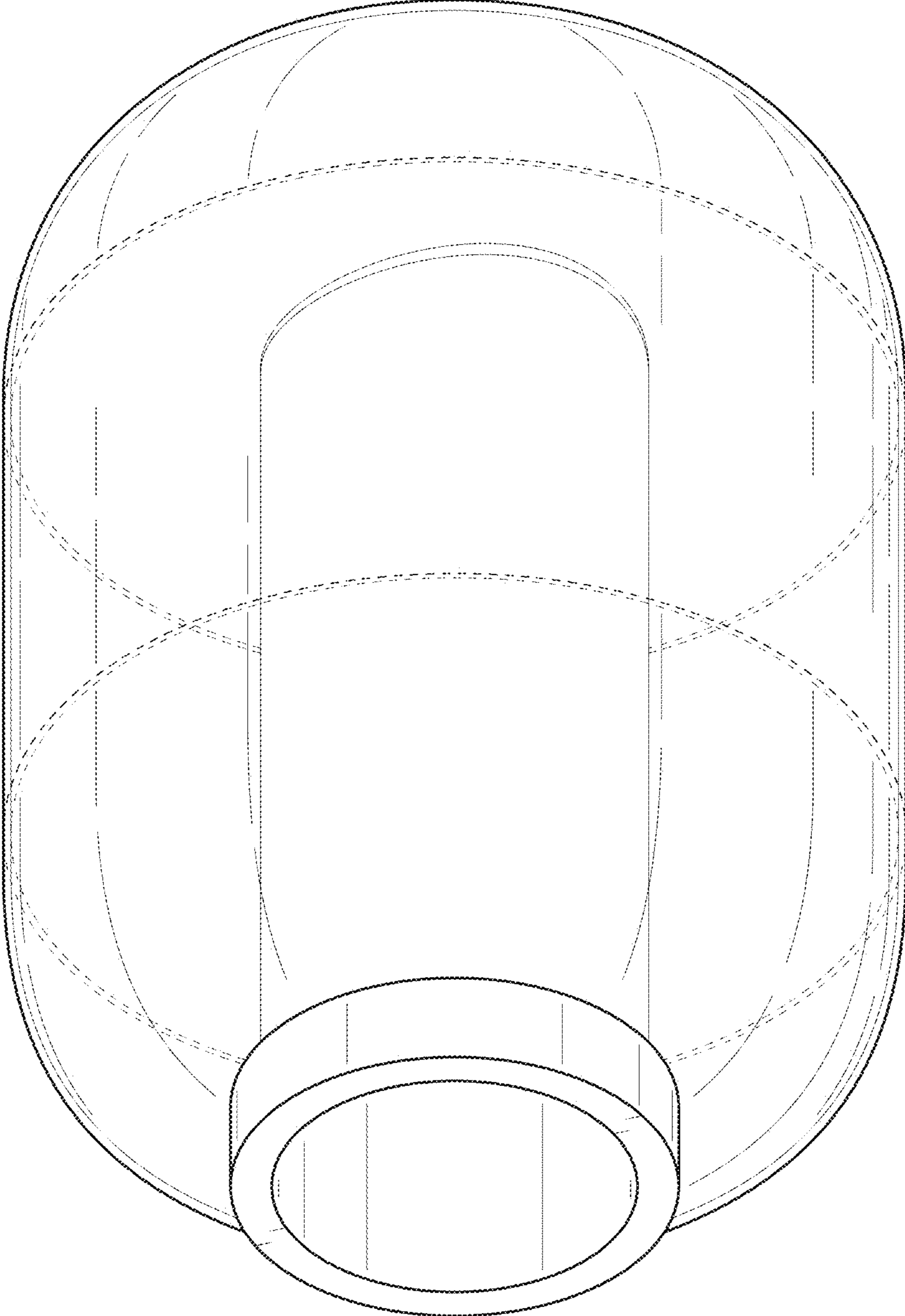

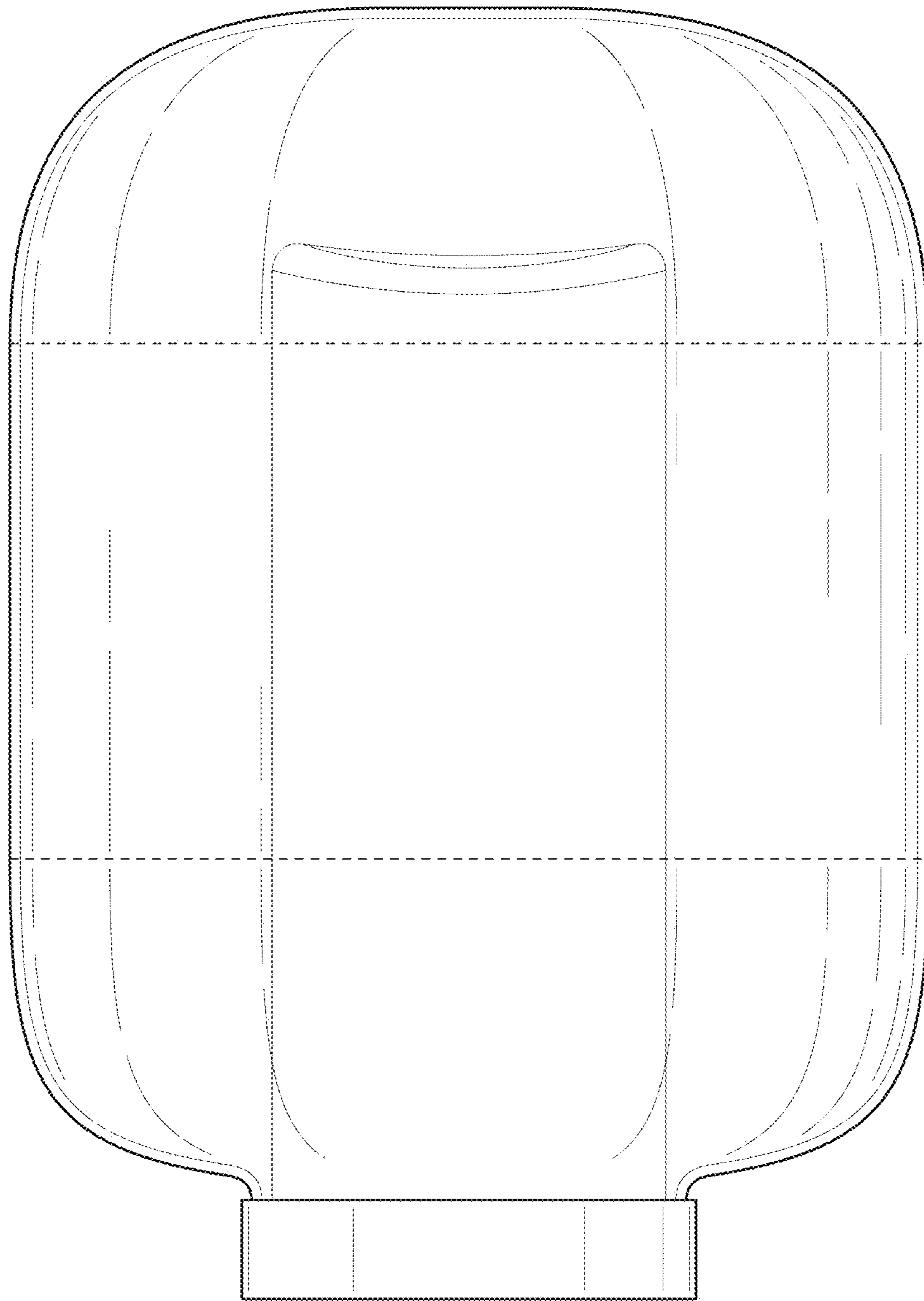

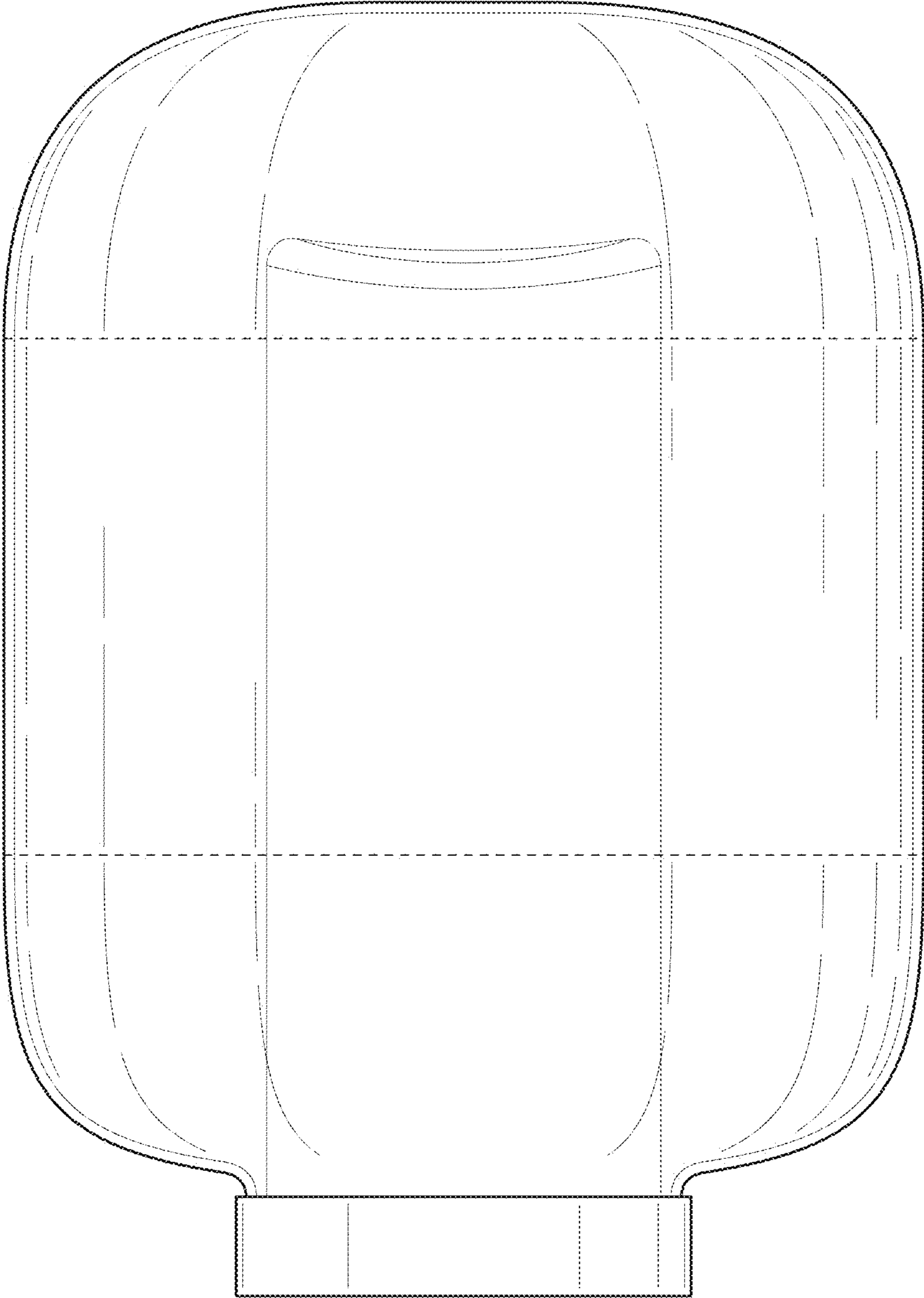

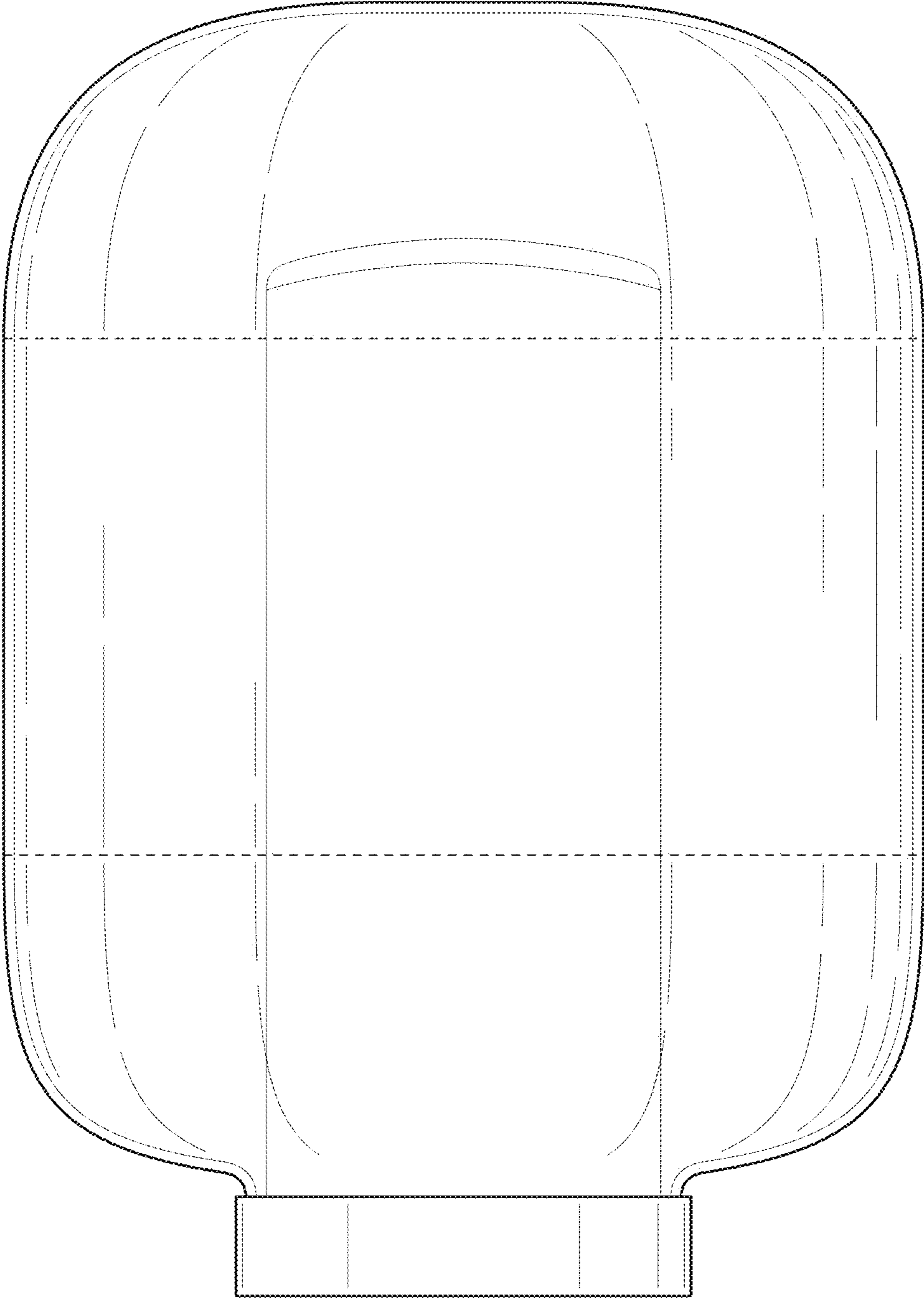

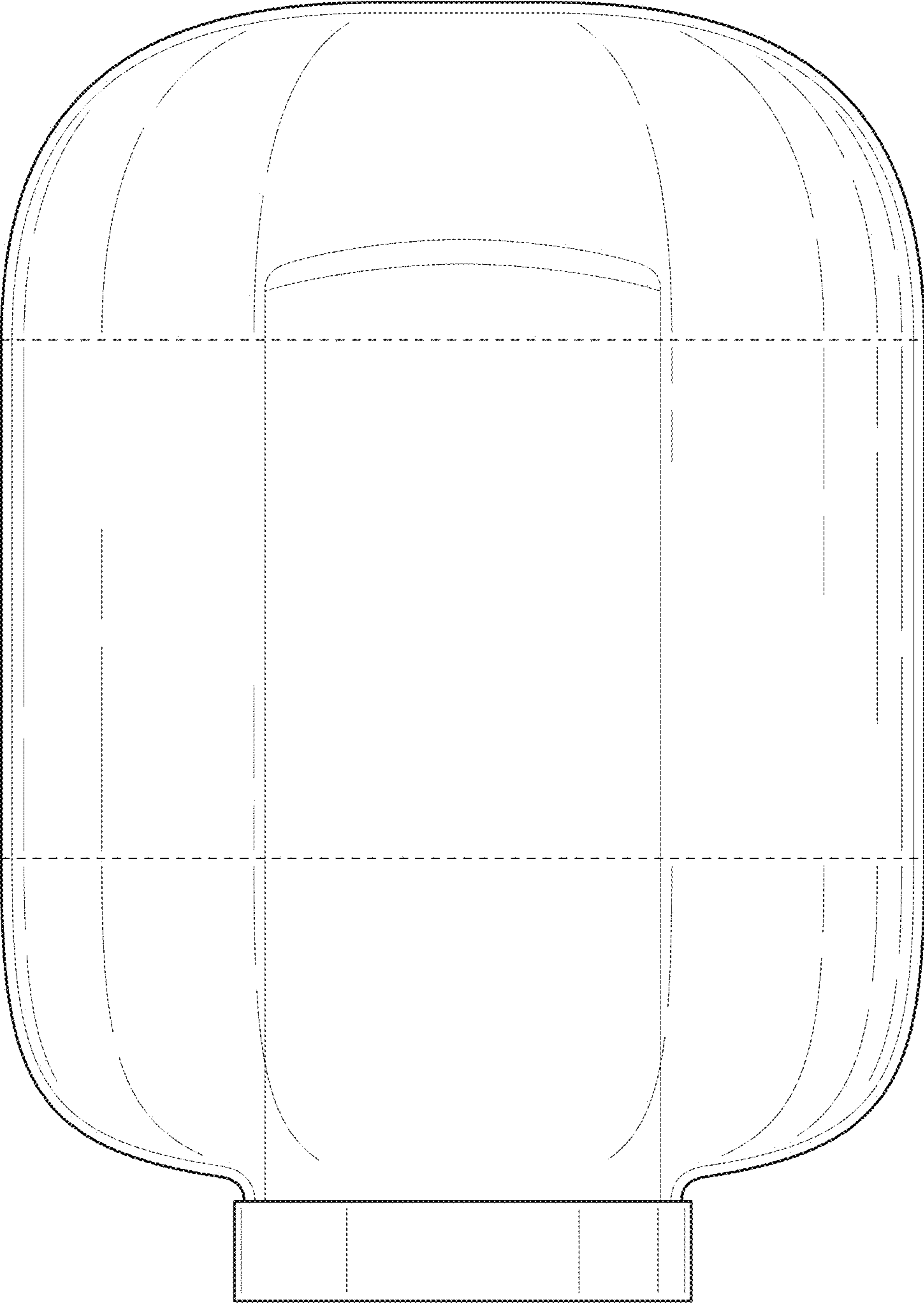

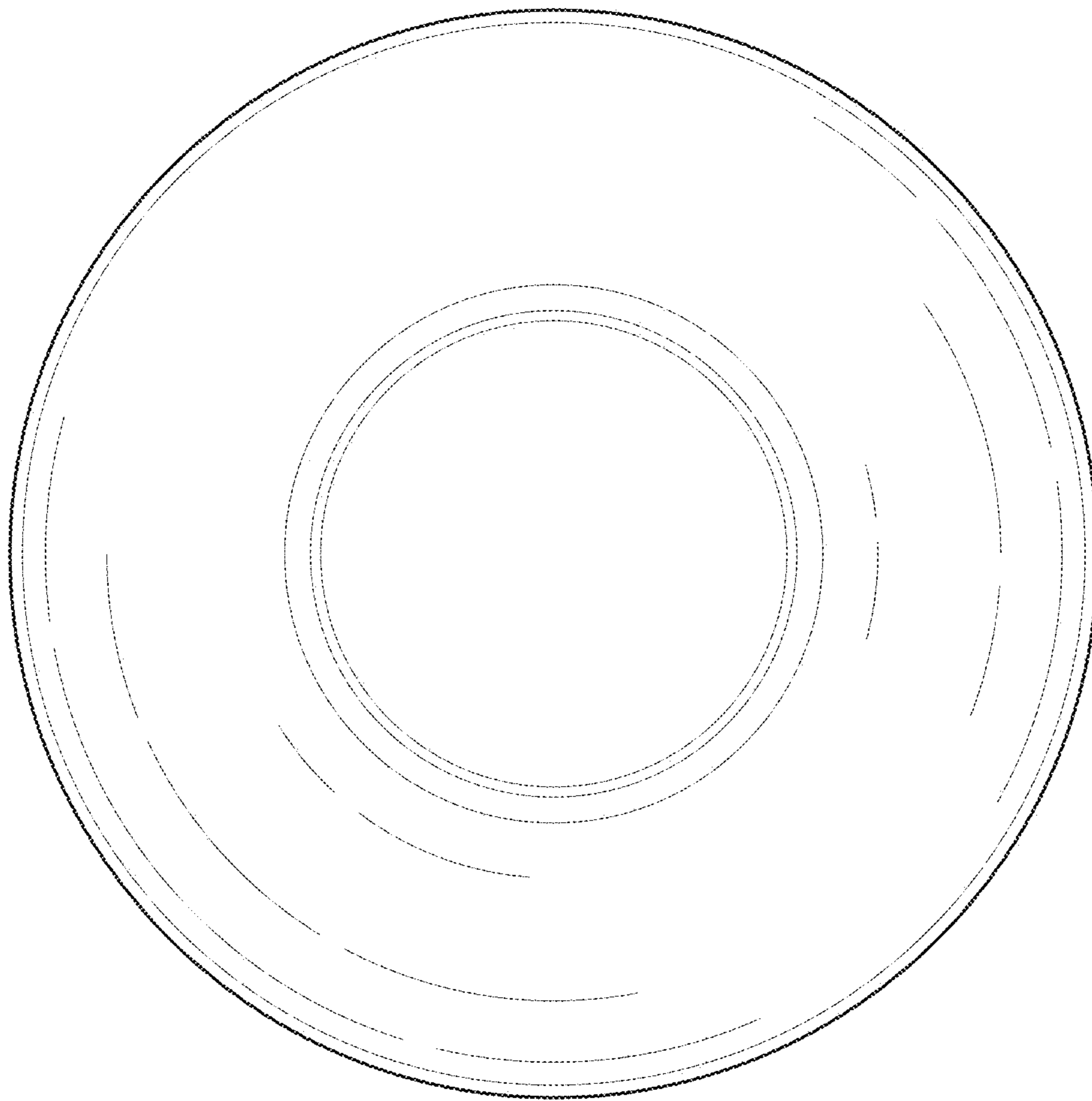

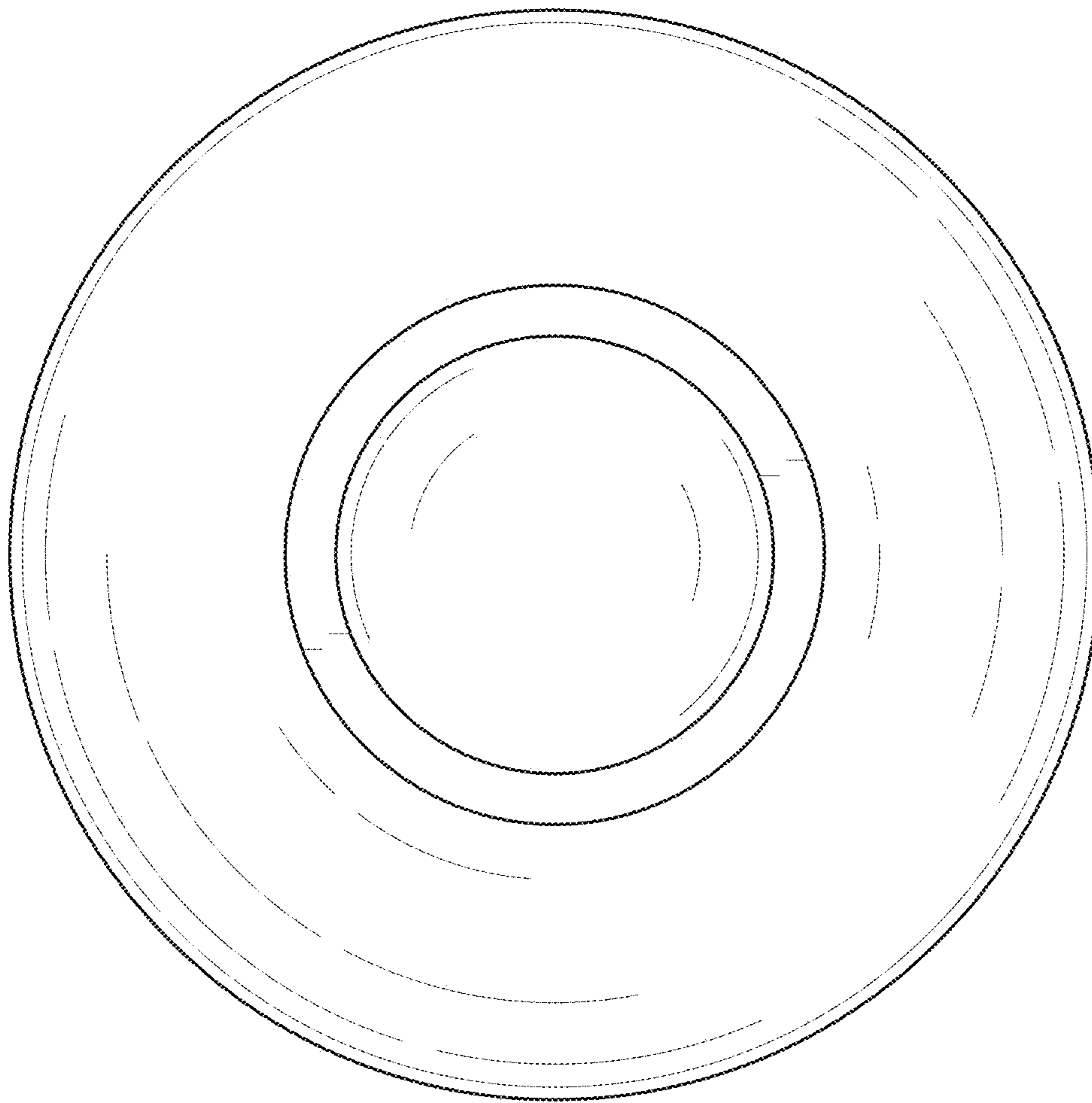

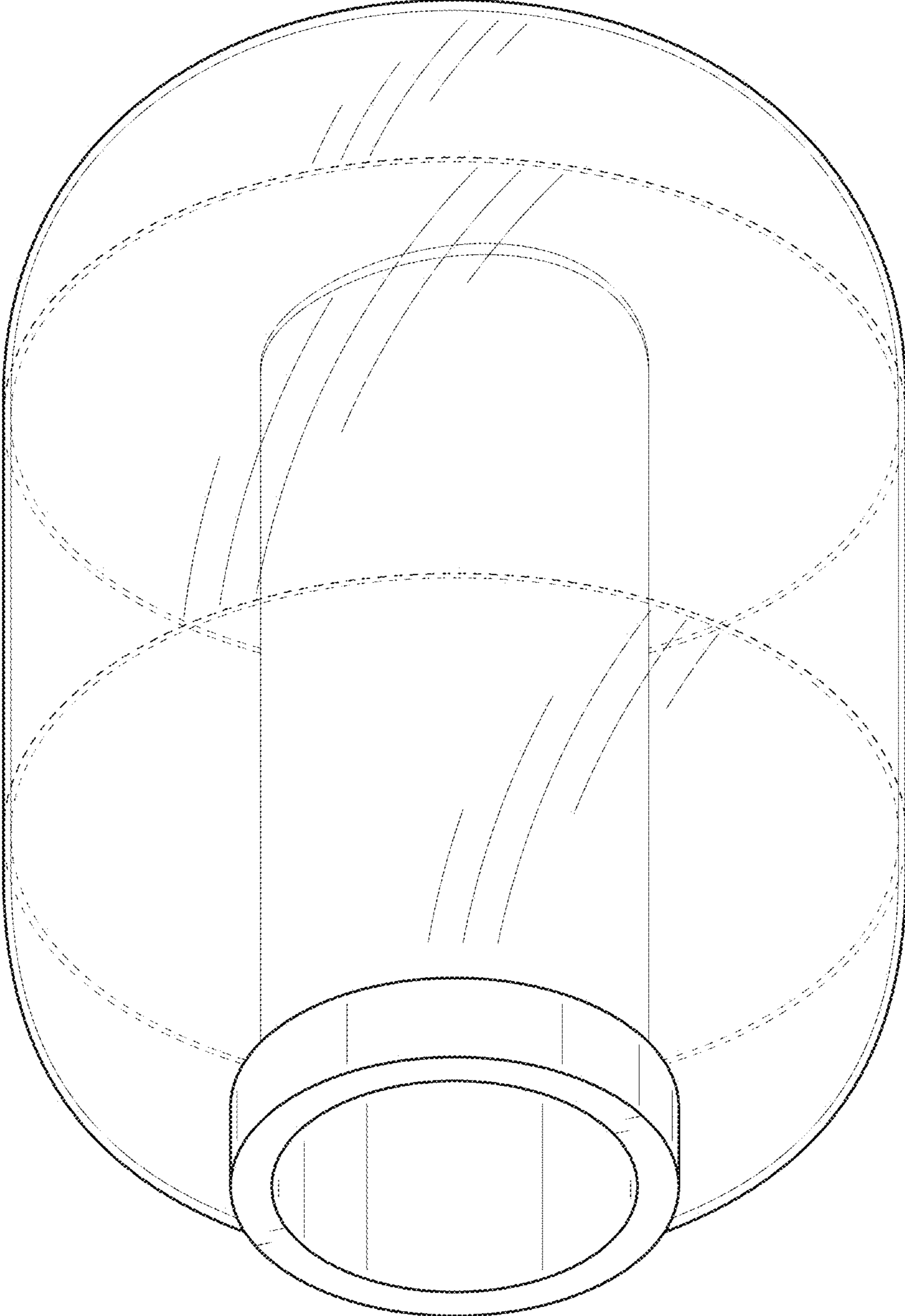

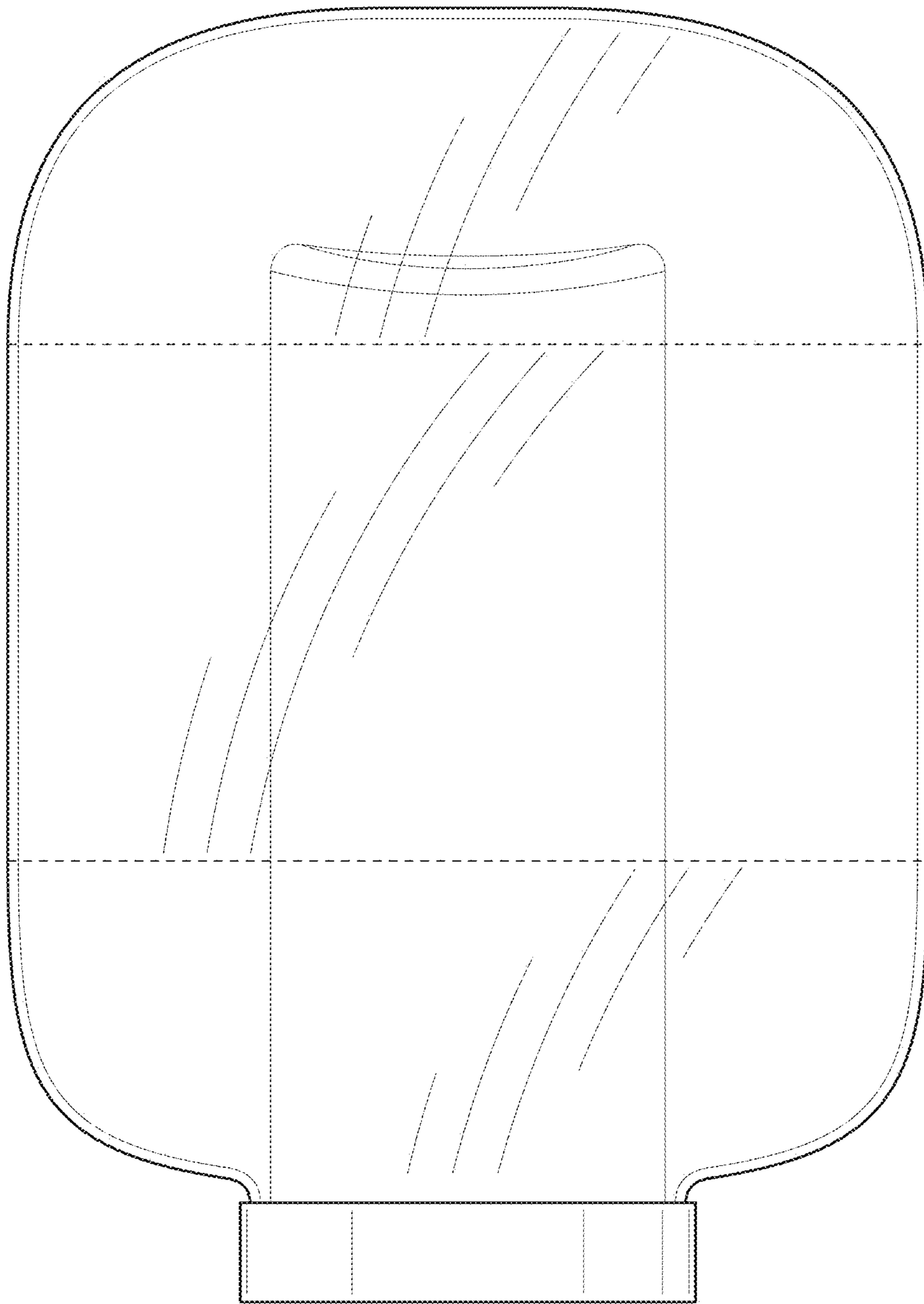

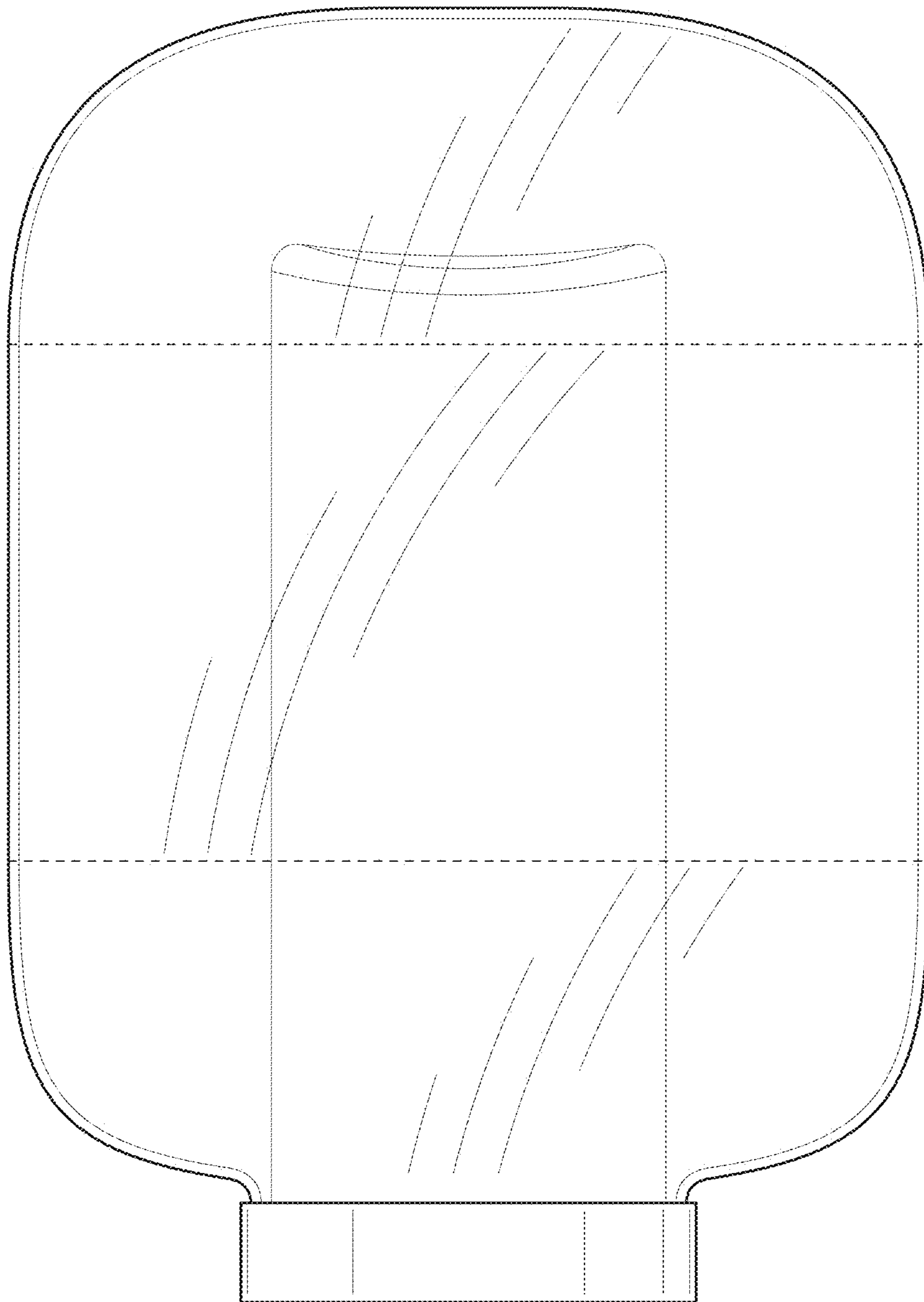

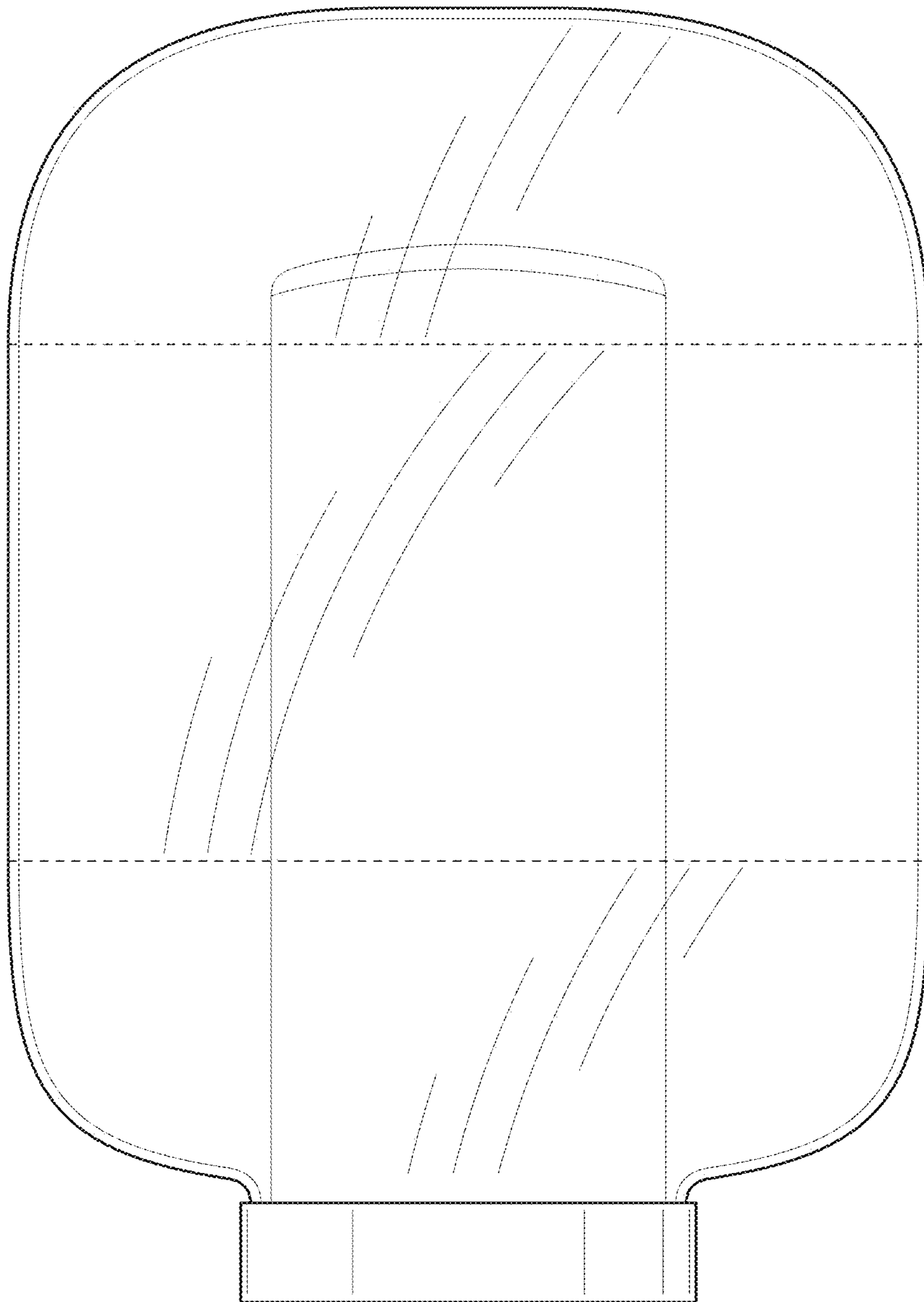

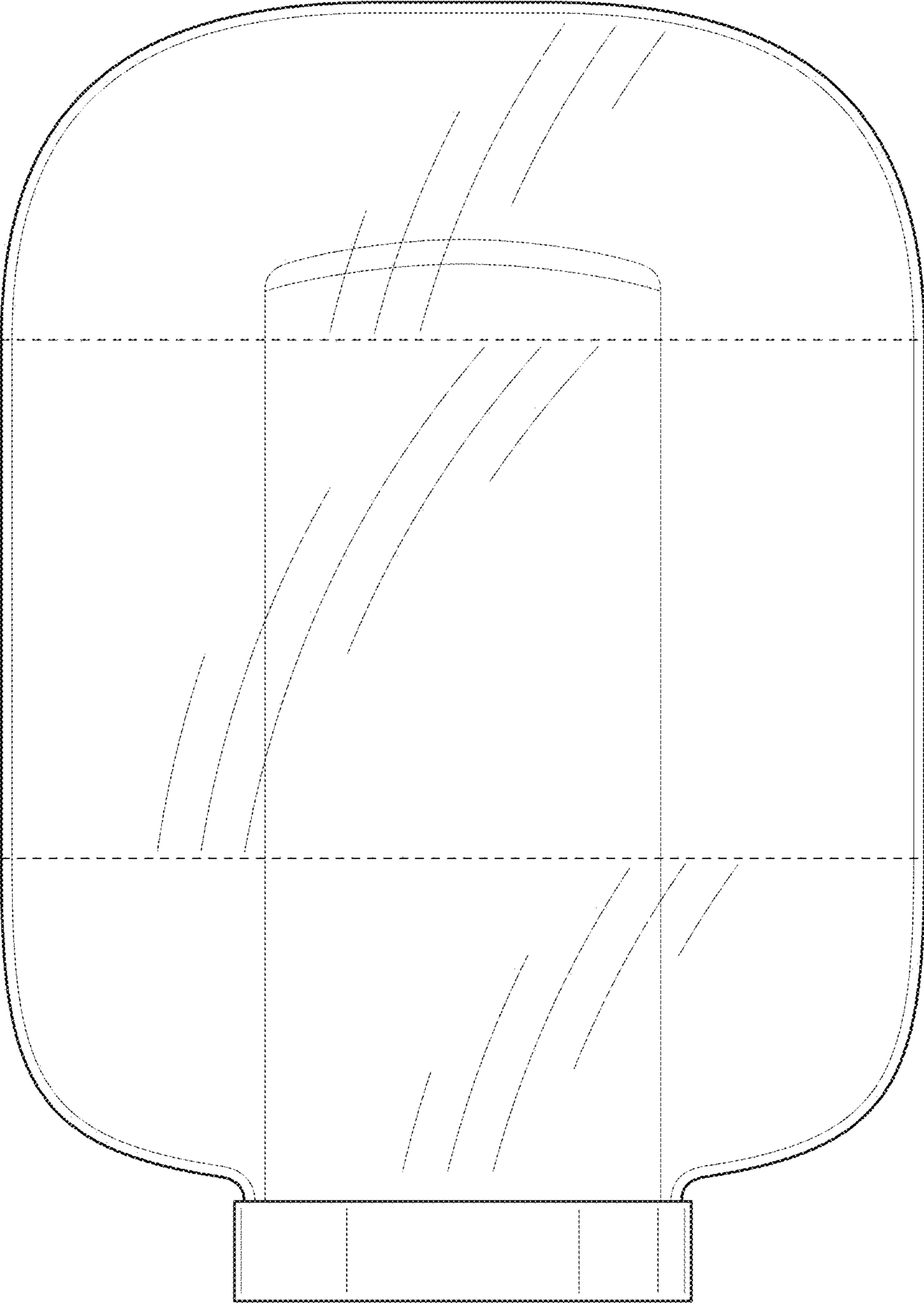

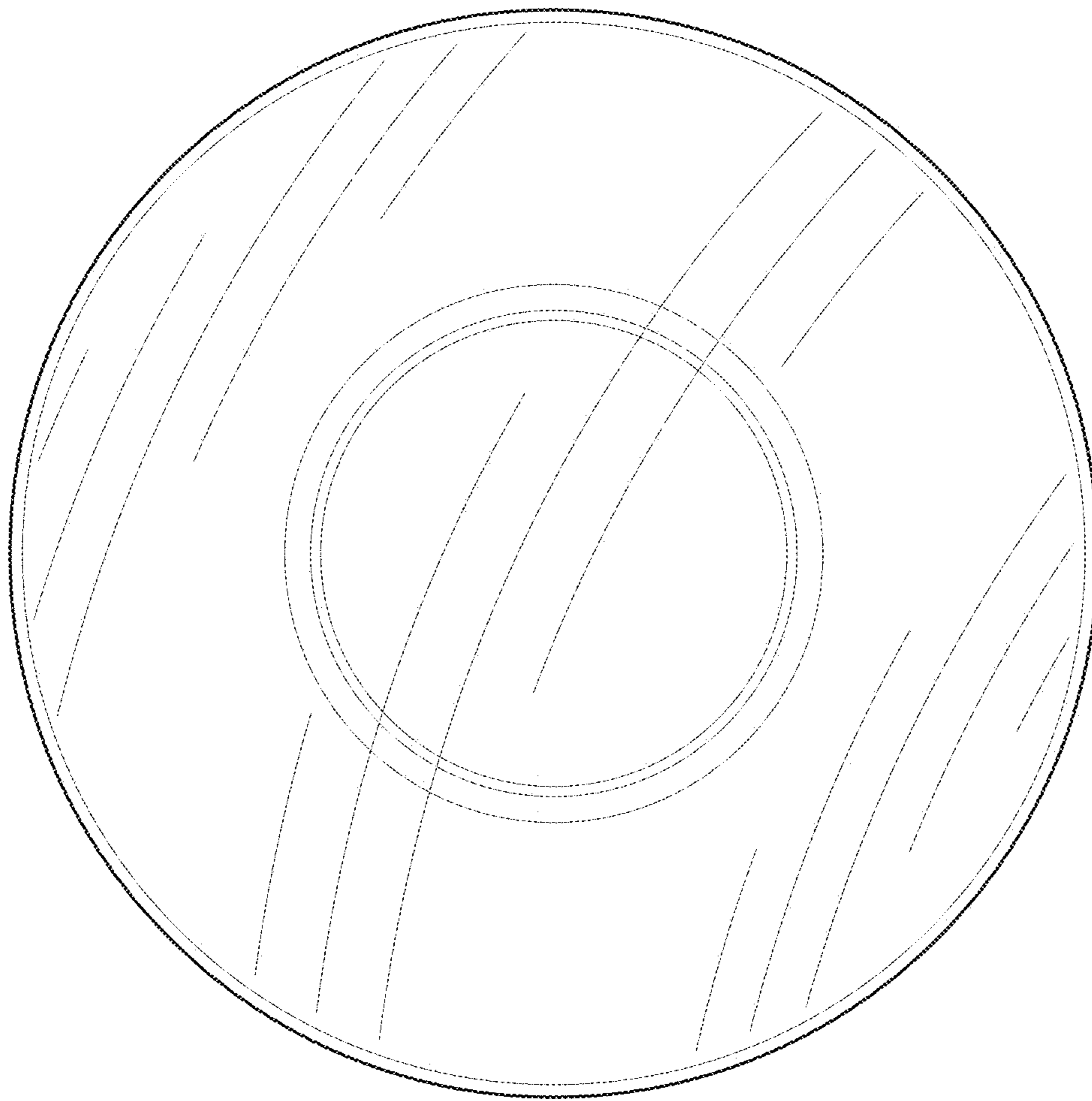

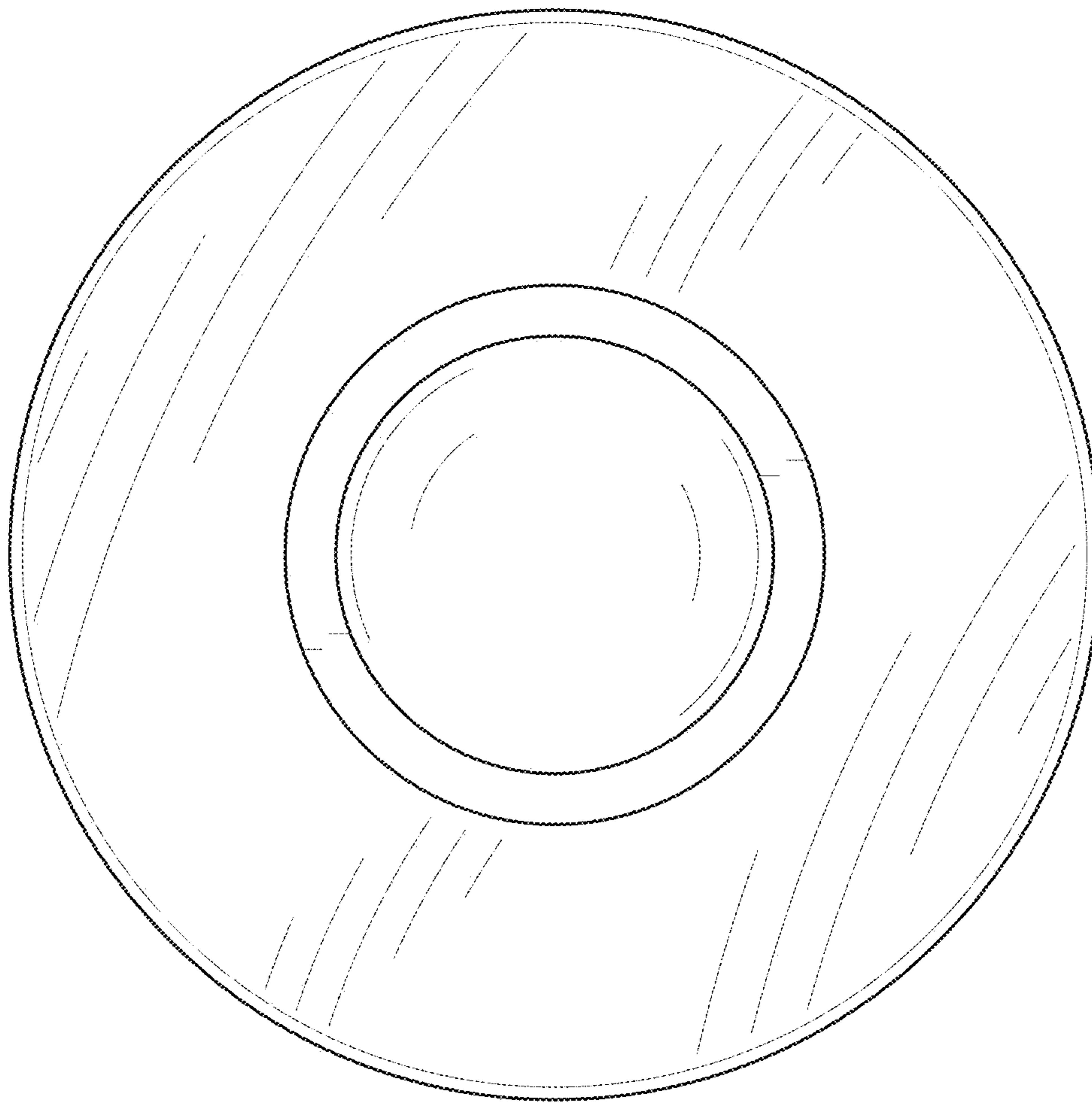
