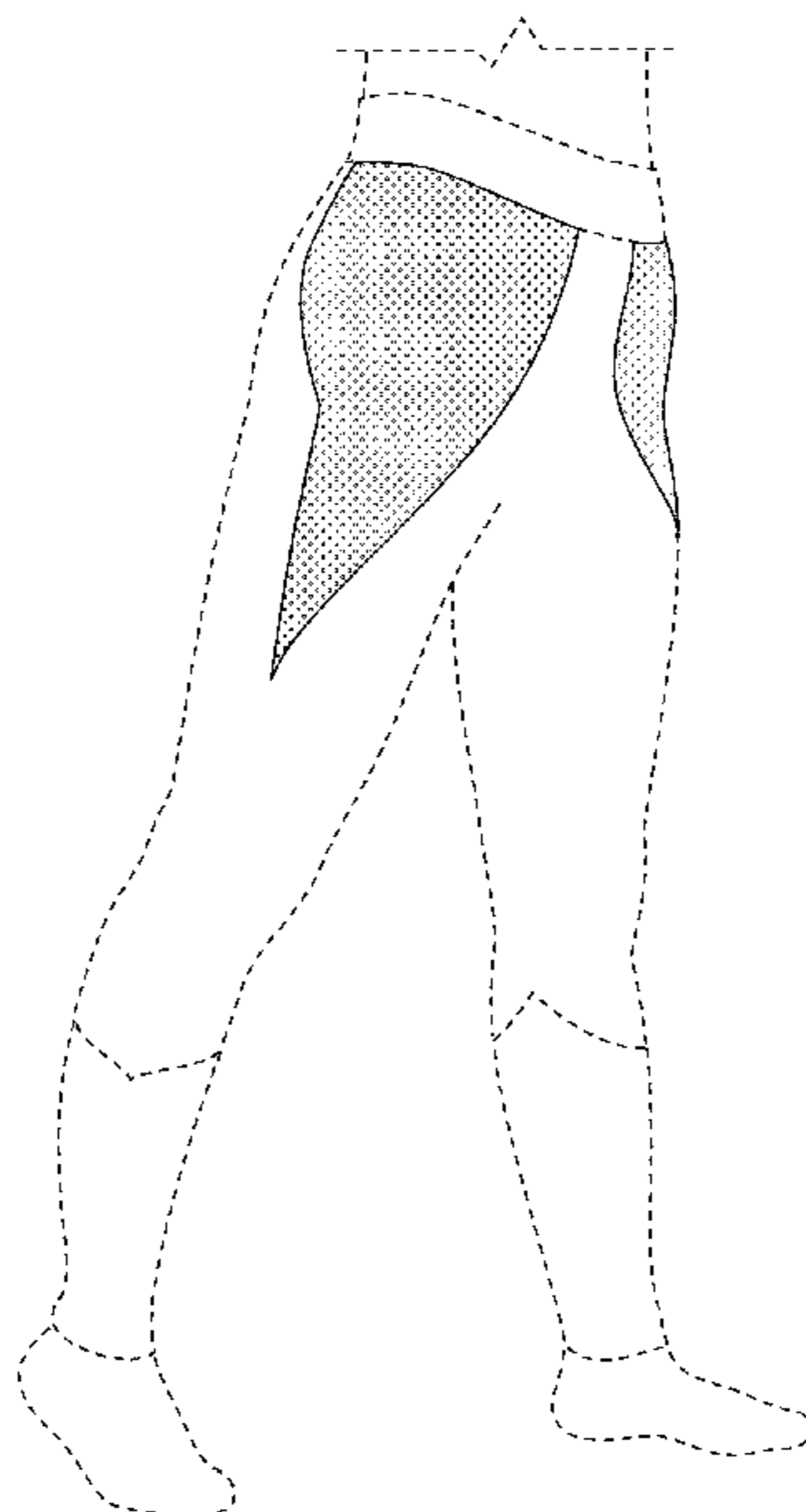
(57) **CLAIM**

The ornamental design for pants having targeted non-slip regions, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of pants having targeted non-slip regions in accordance with the new design; FIG. 2 is a front side elevation view of the pants of FIG. 1; FIG. 3 is a back side elevation view of the pants of FIG. 1; FIG. 4 is a right side elevation view of the pants of FIG. 1; and, FIG. 5 is a left side elevation view of the pants of FIG. 1. The broken lines in FIGS. 1-5 illustrate portions of the pants having targeted non-slip regions which form no part of the claimed design.

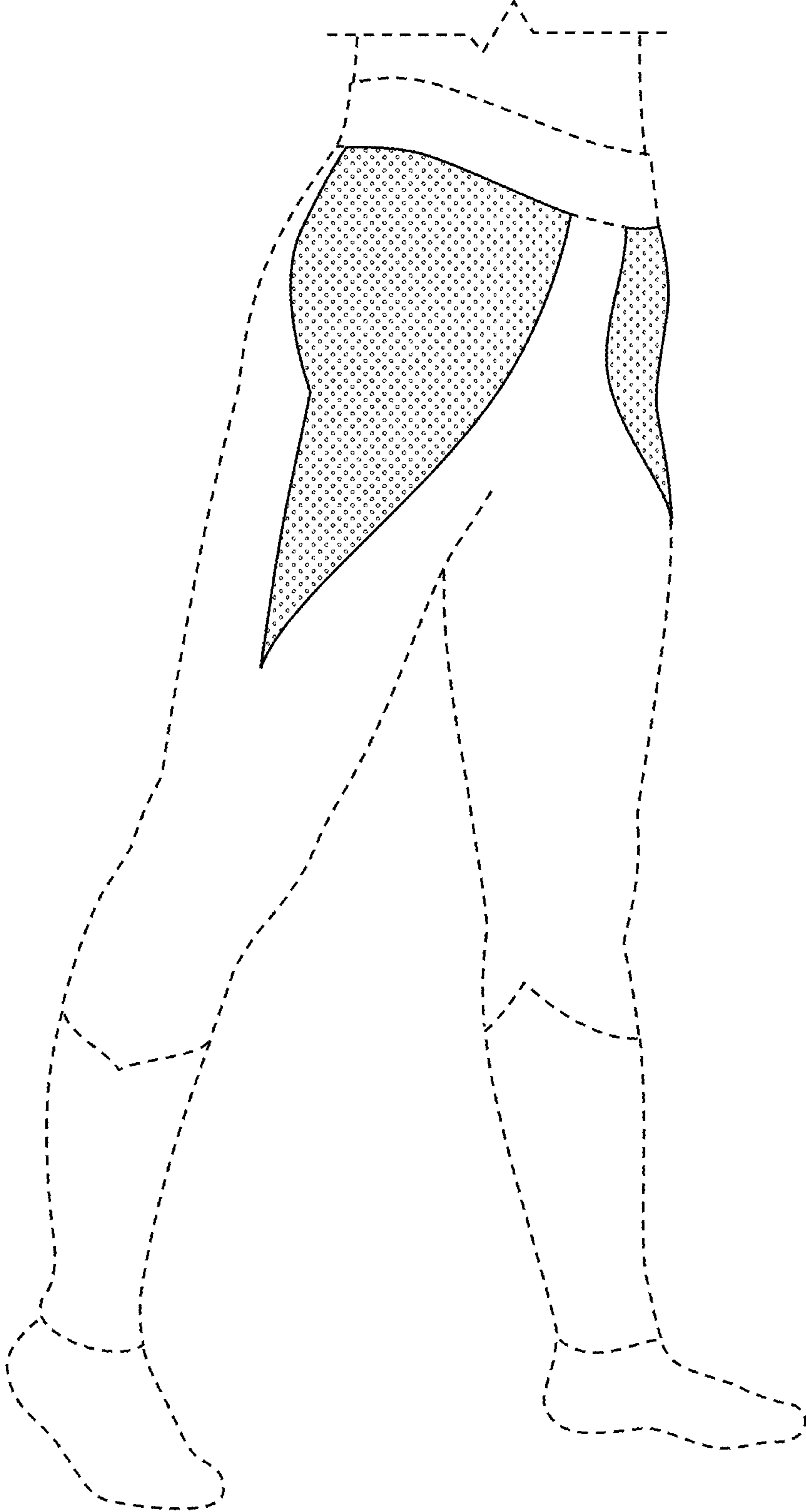

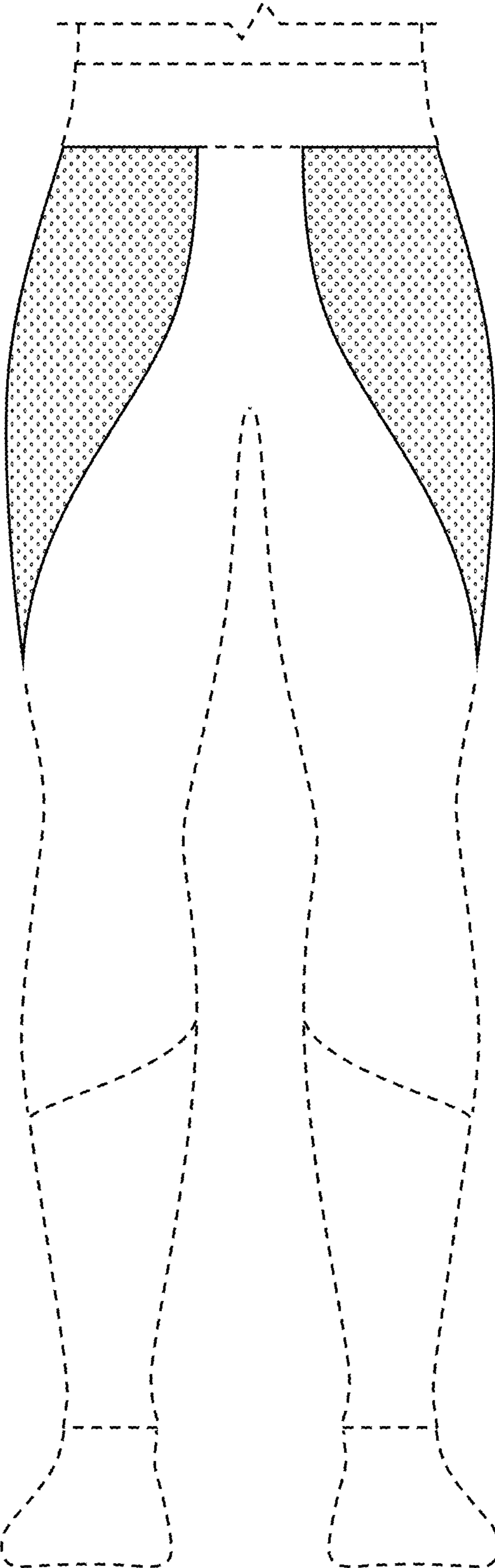

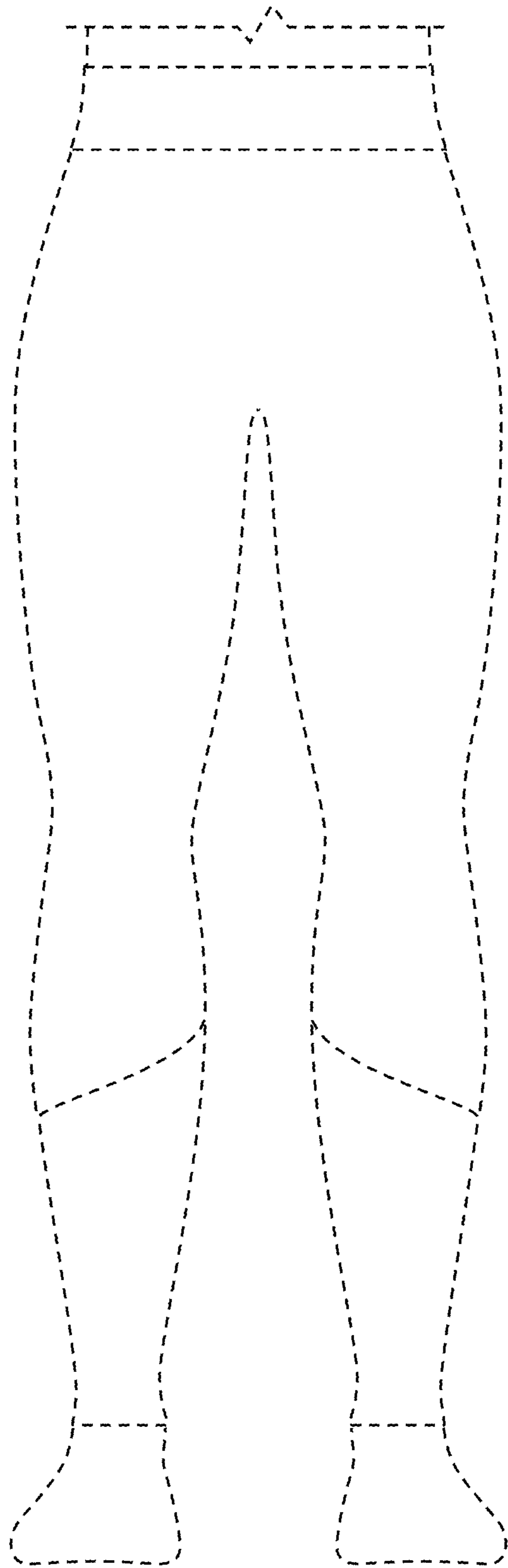

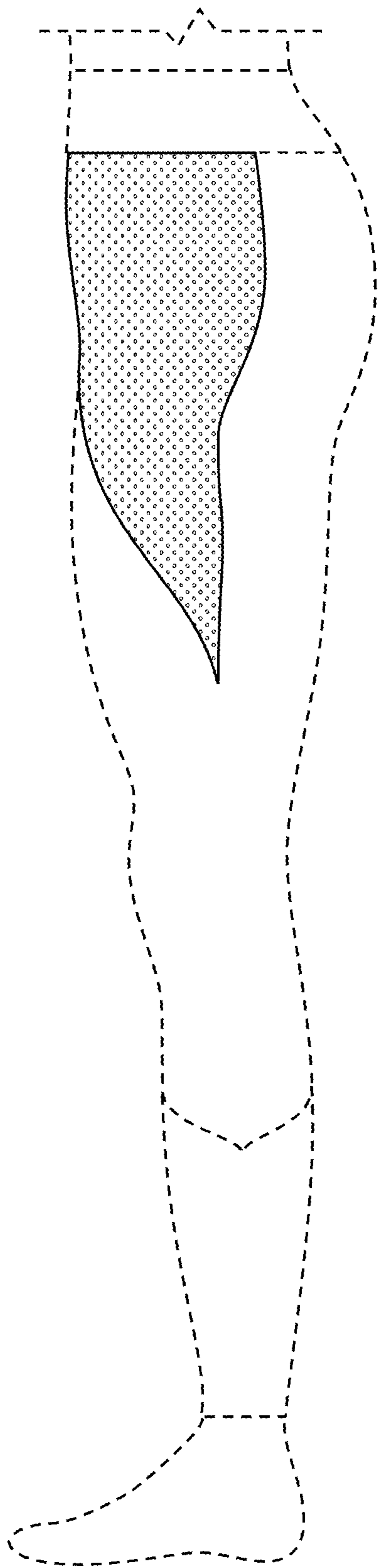

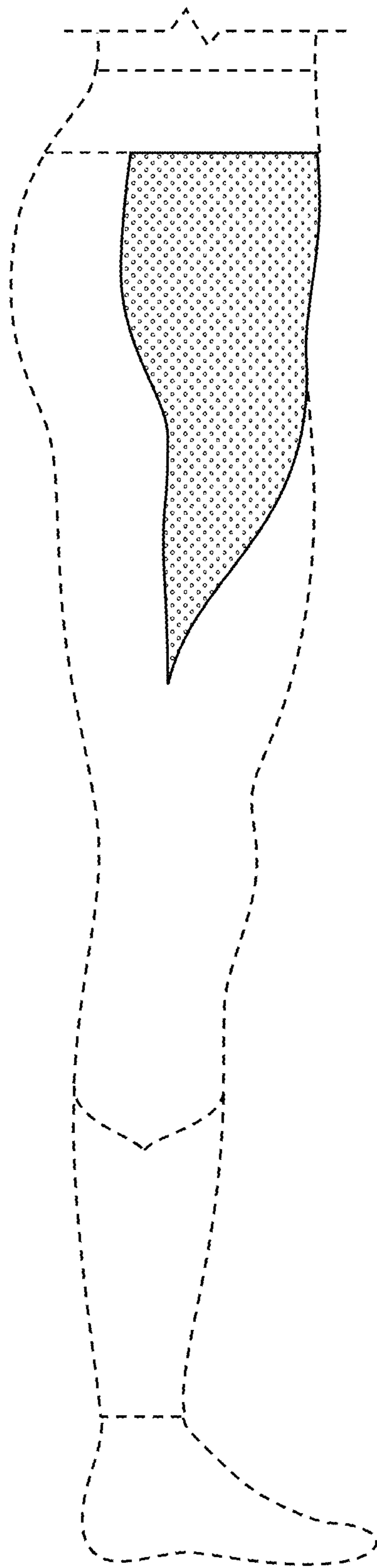
