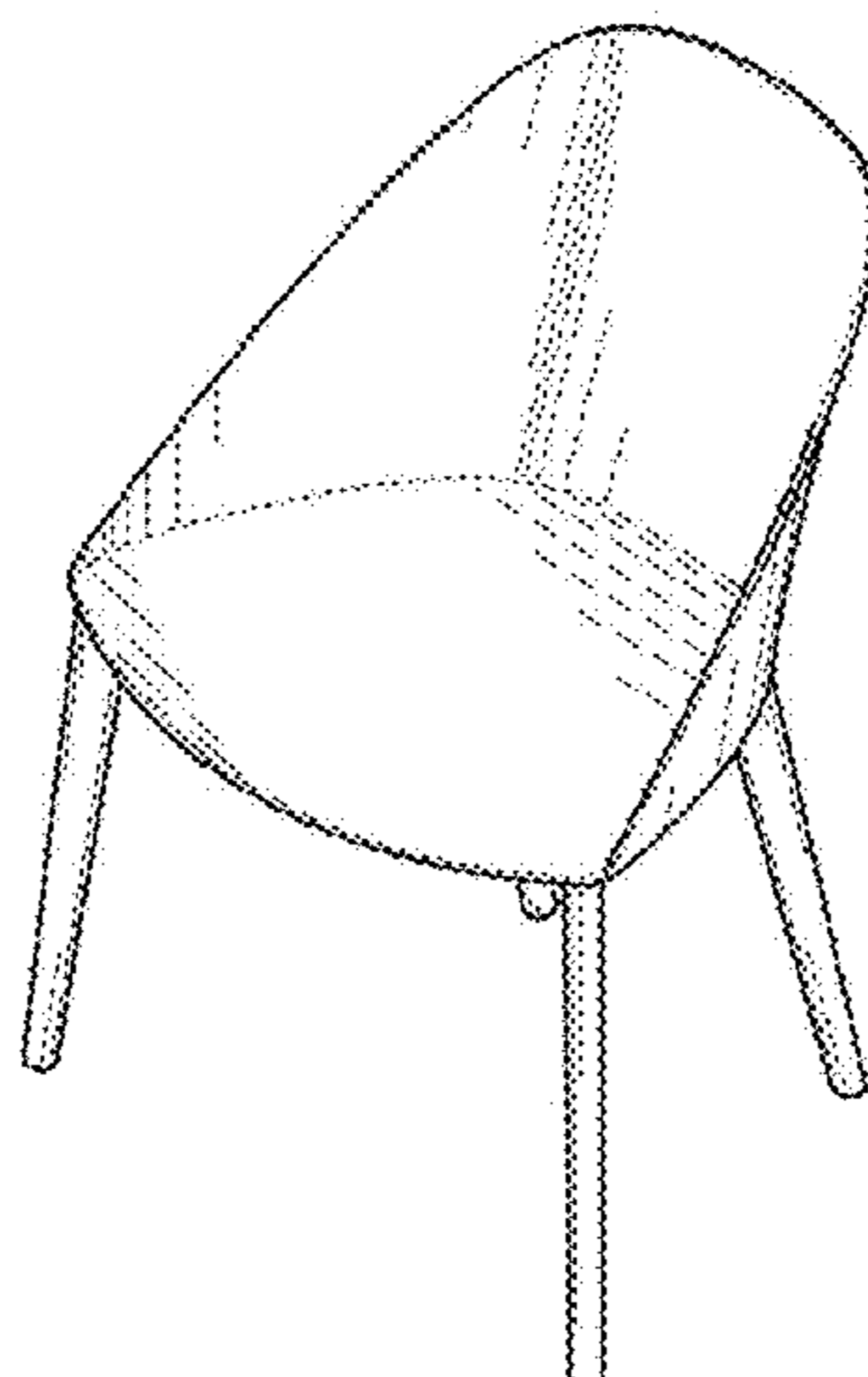
**DESCRIPTION**

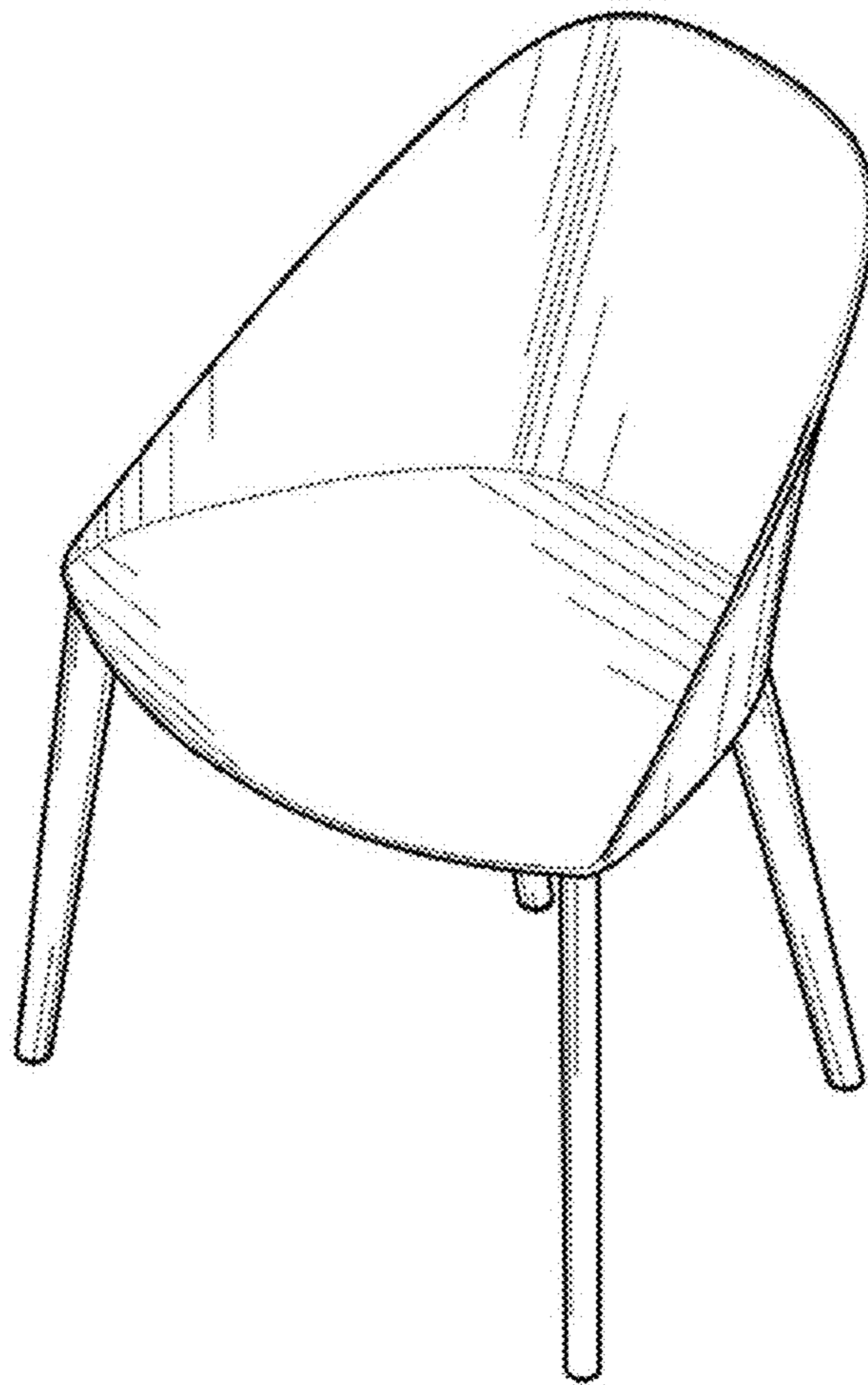

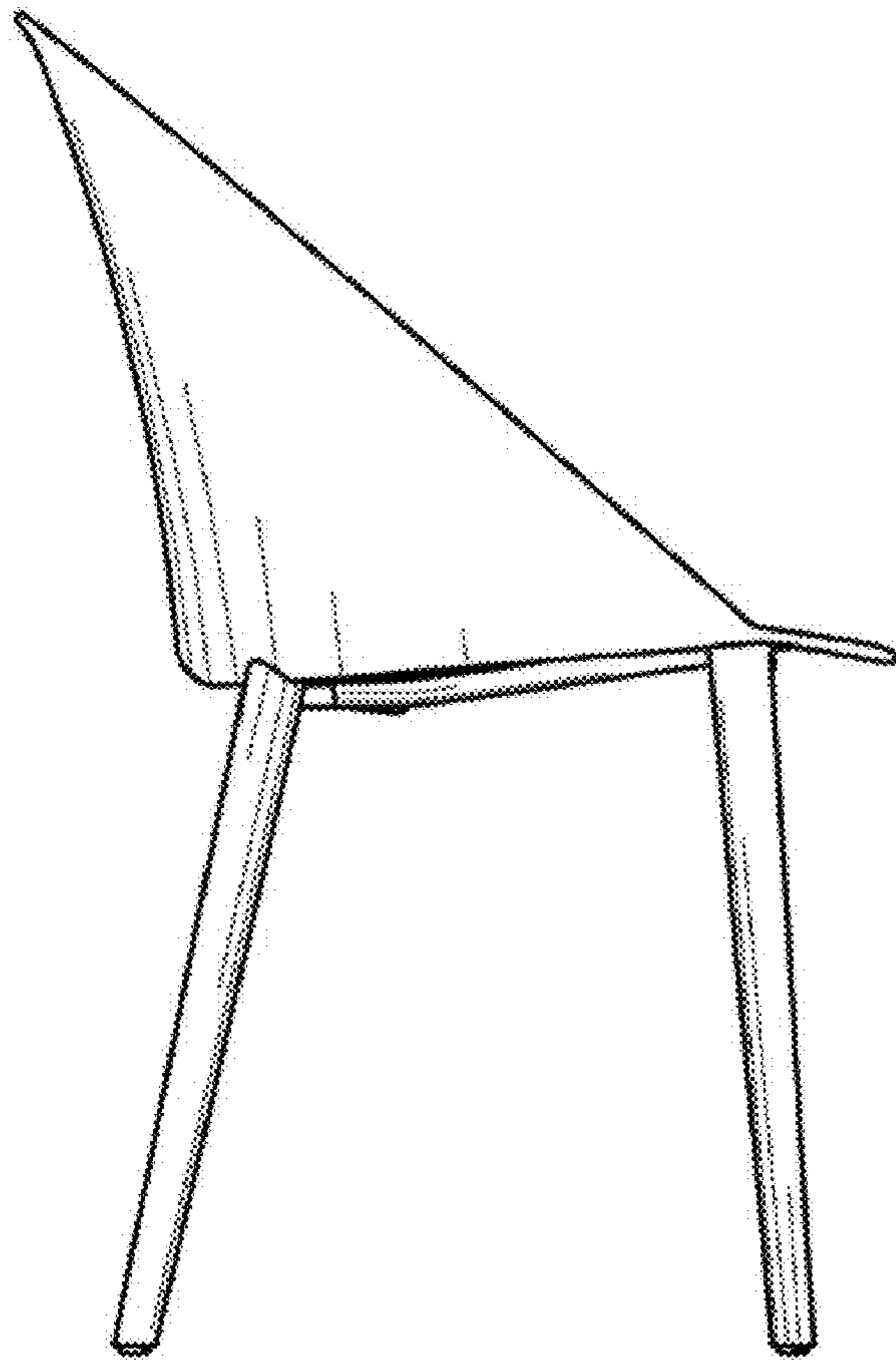

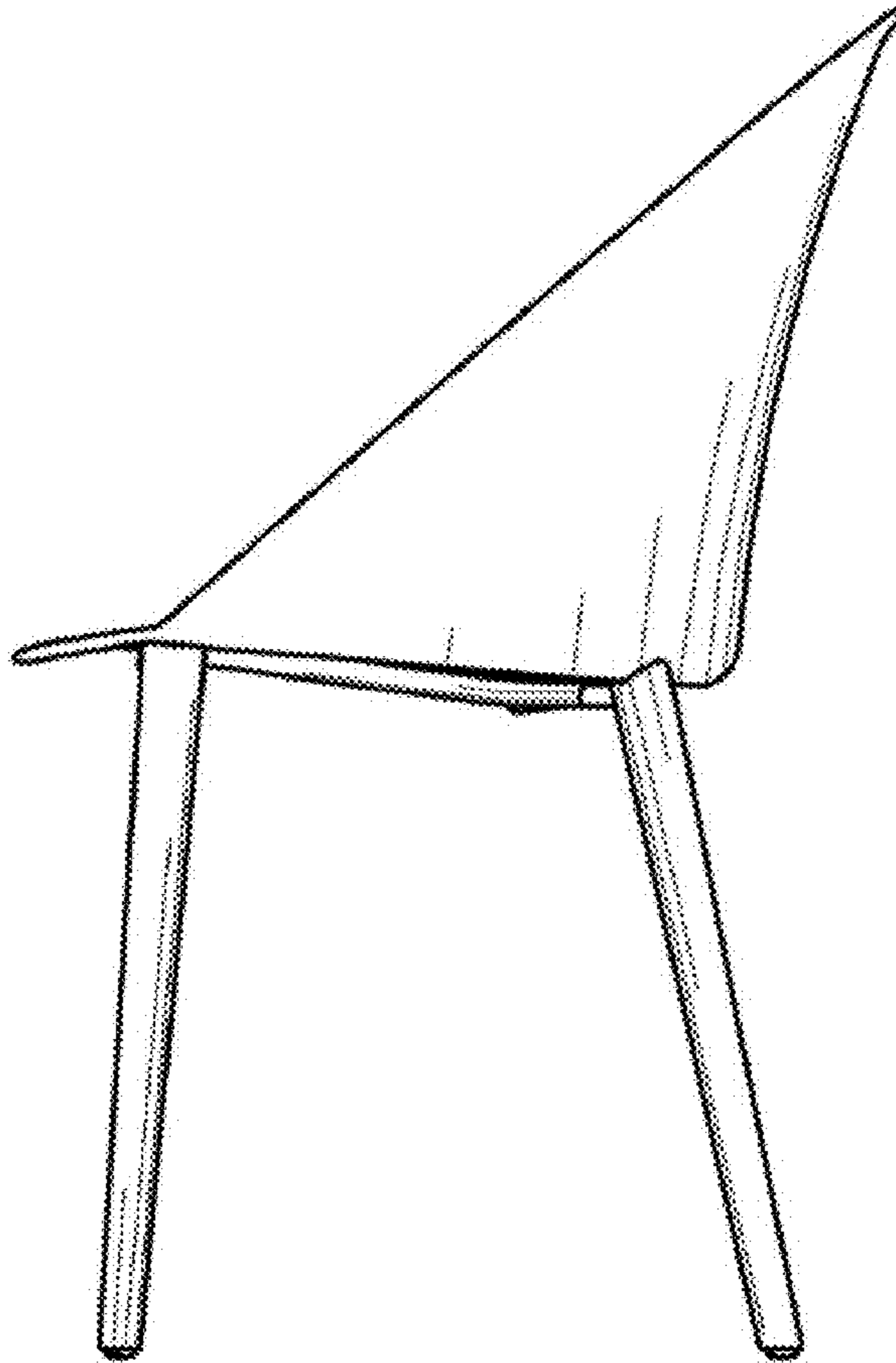

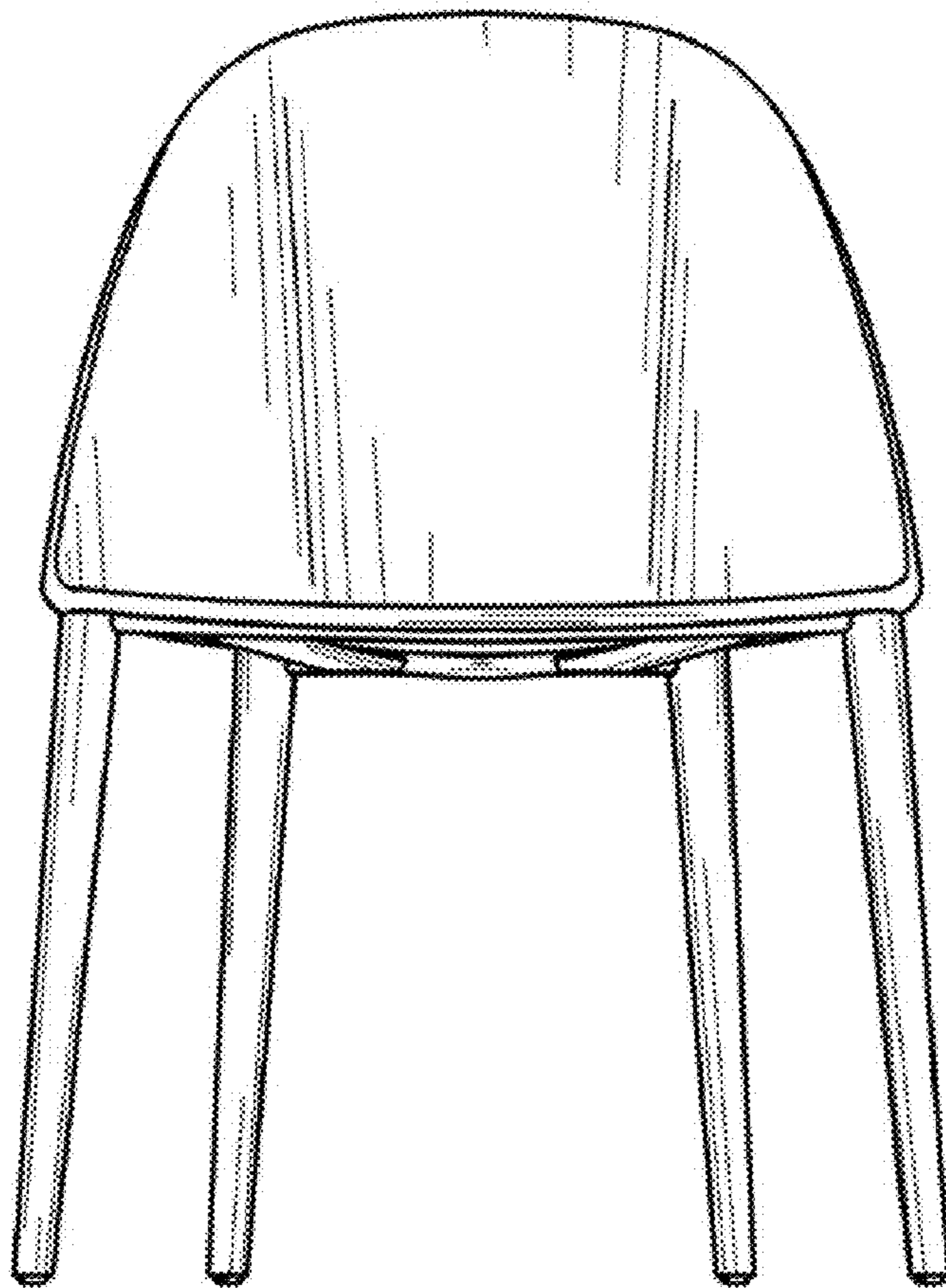

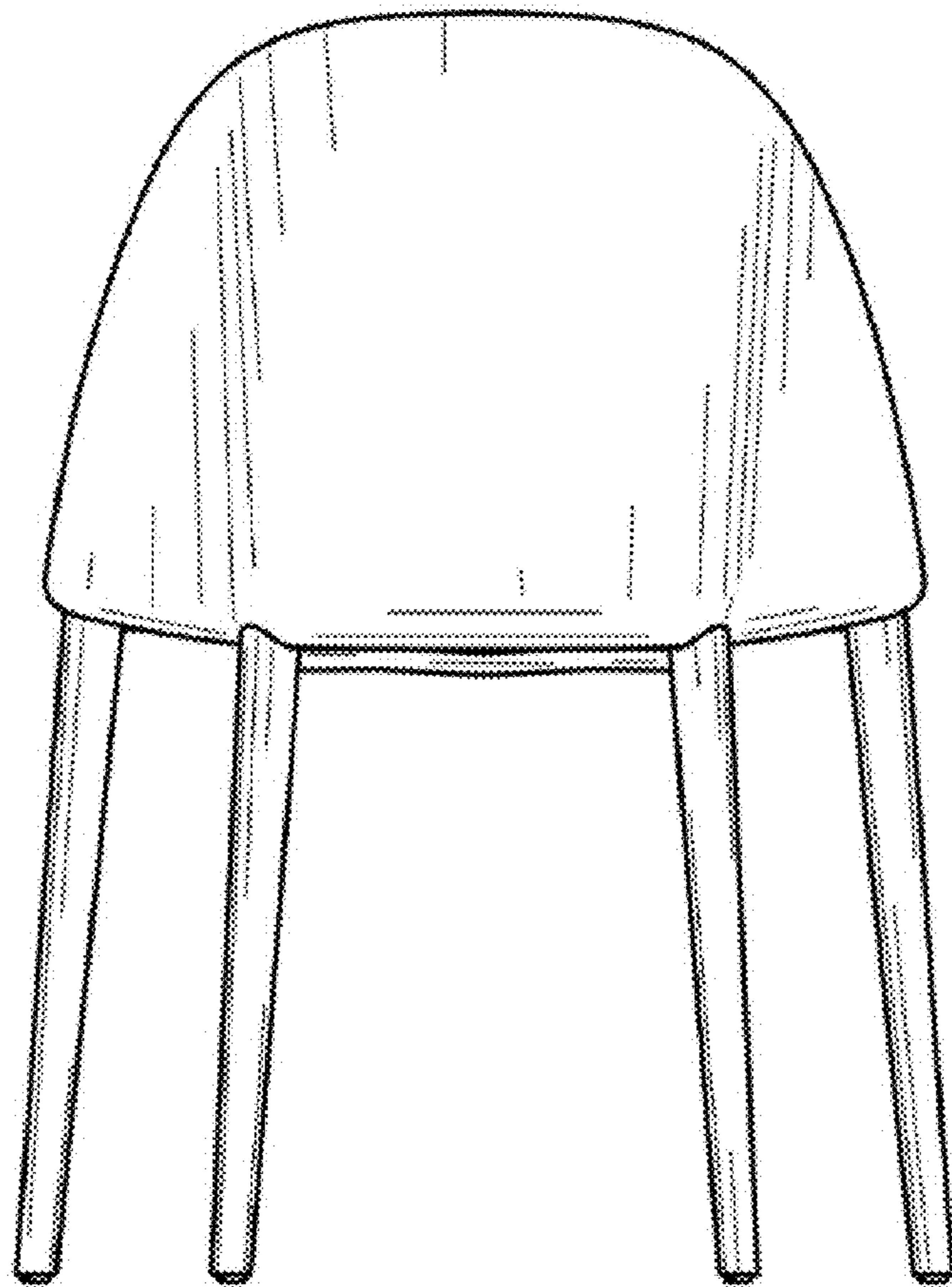

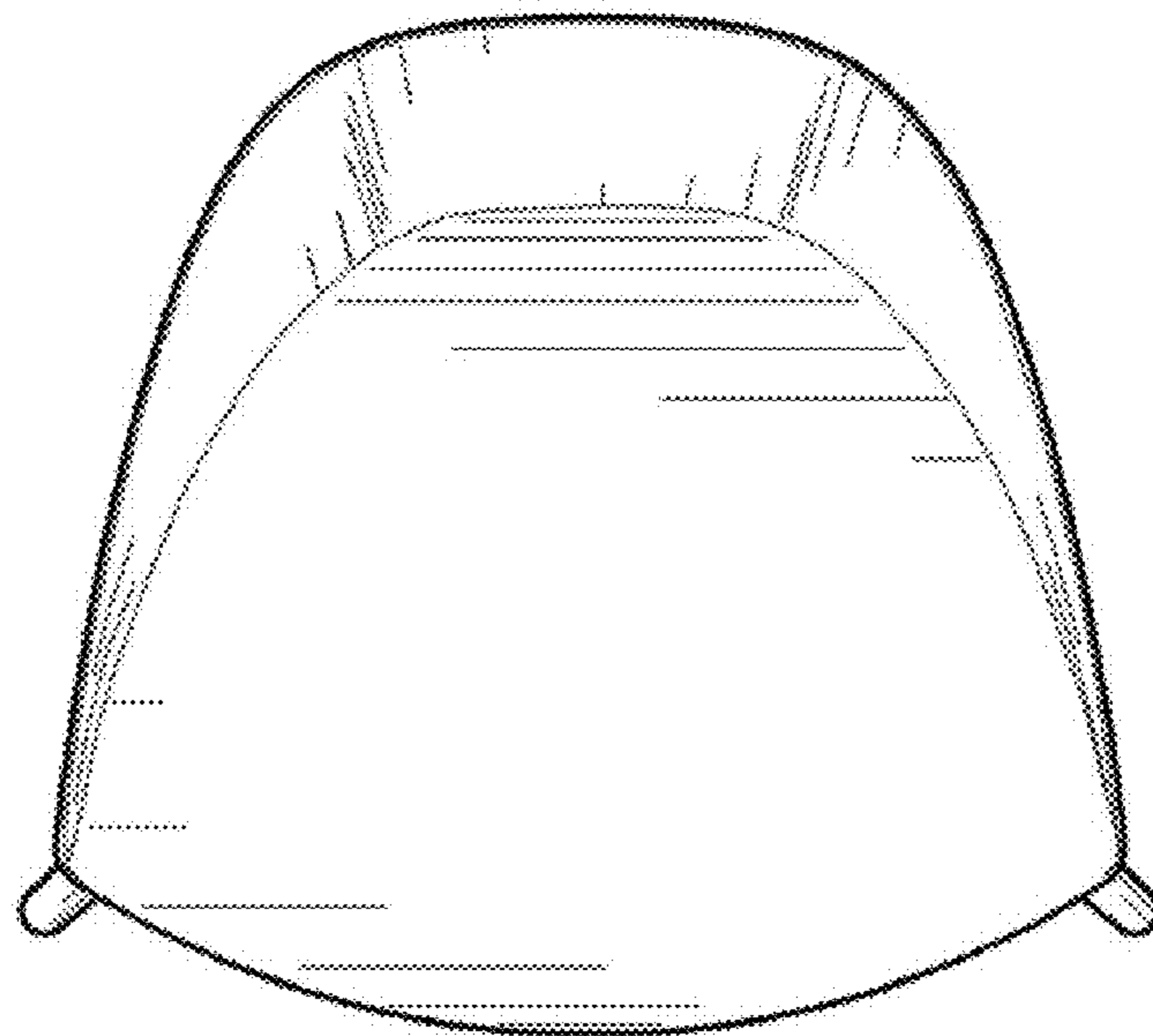
